FIG. 2 is a slightly enlarged side view of the chair of FIG. 1.

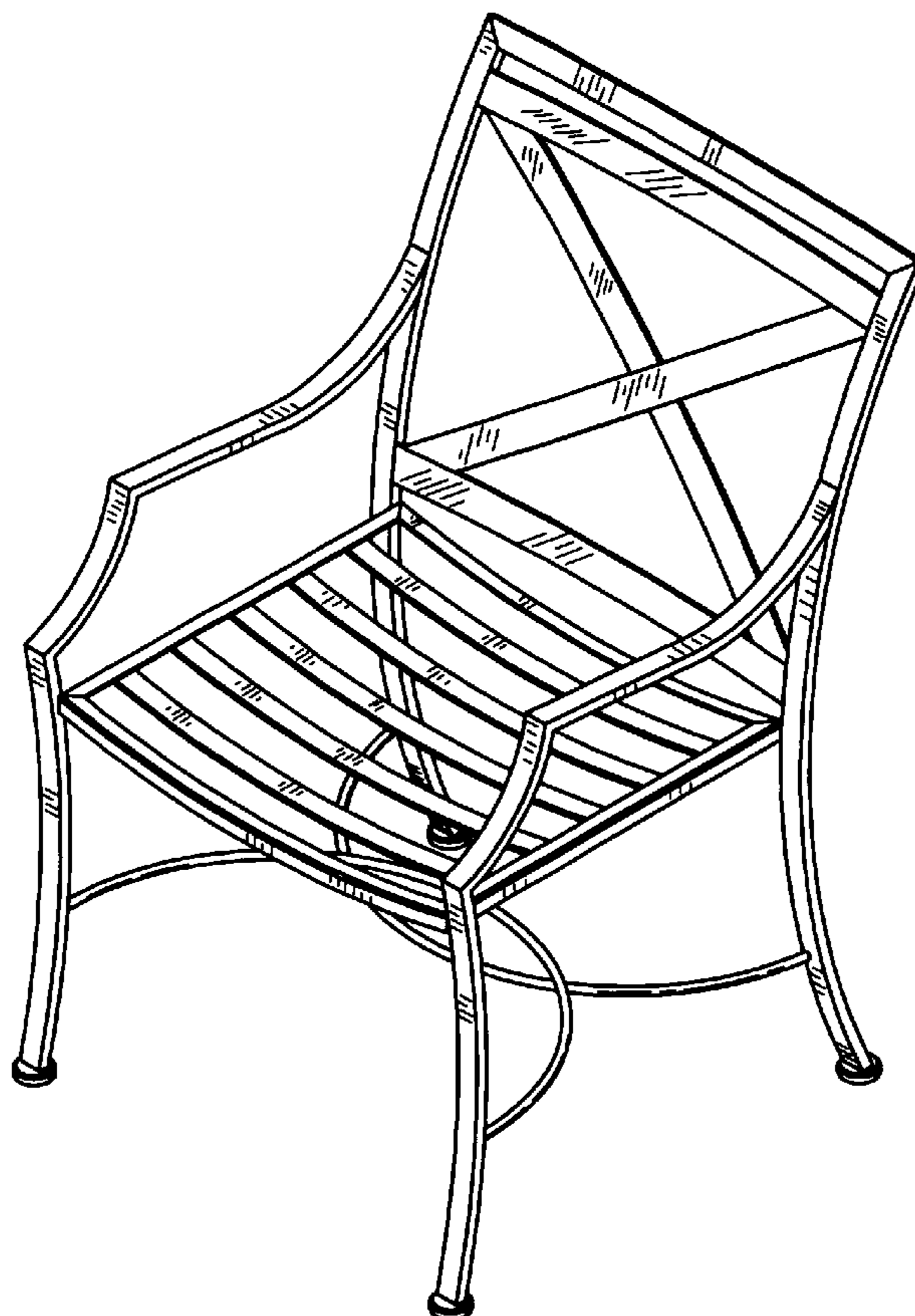
FIG. 3 is a slightly enlarged front of the chair of FIG. 1.

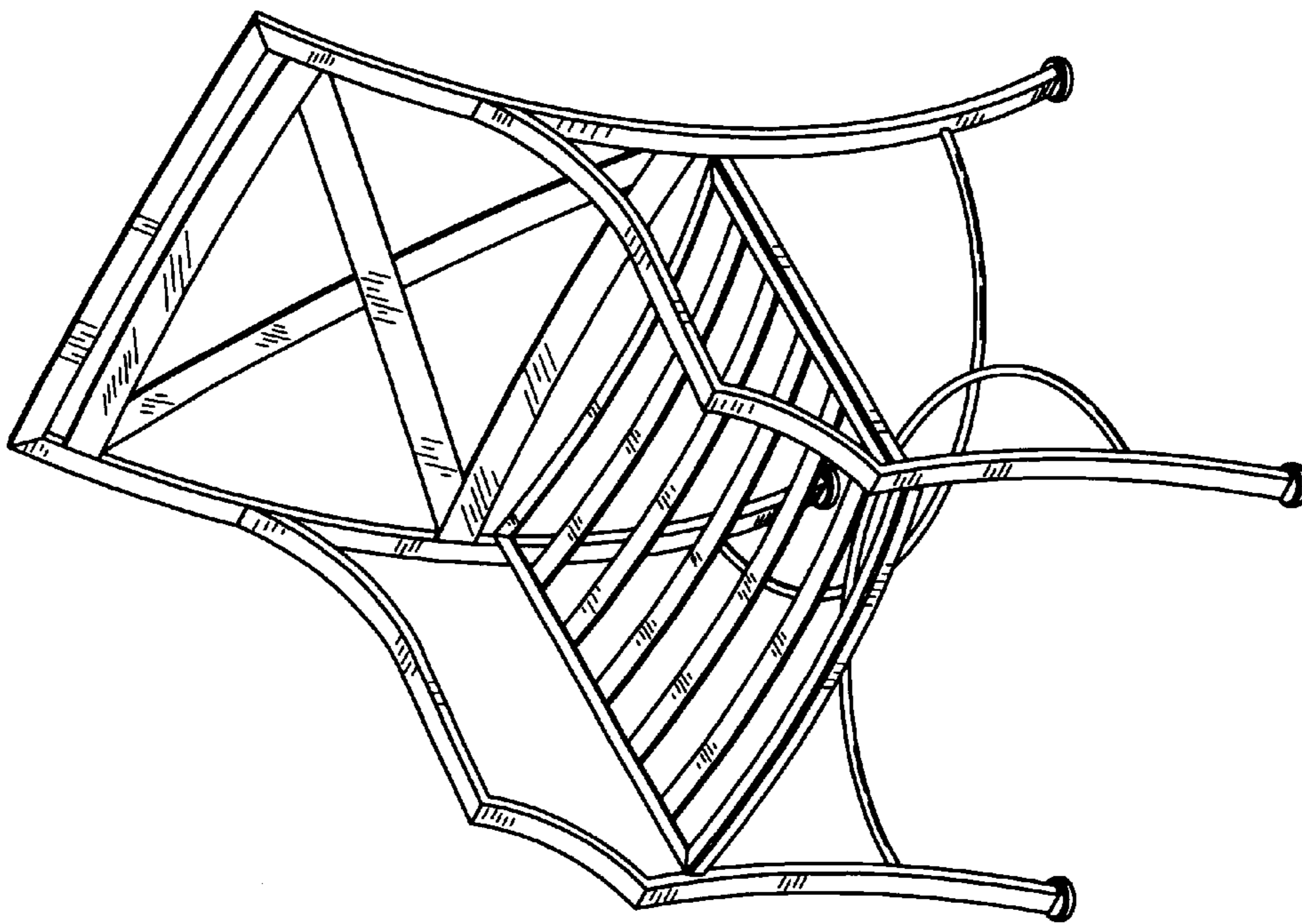

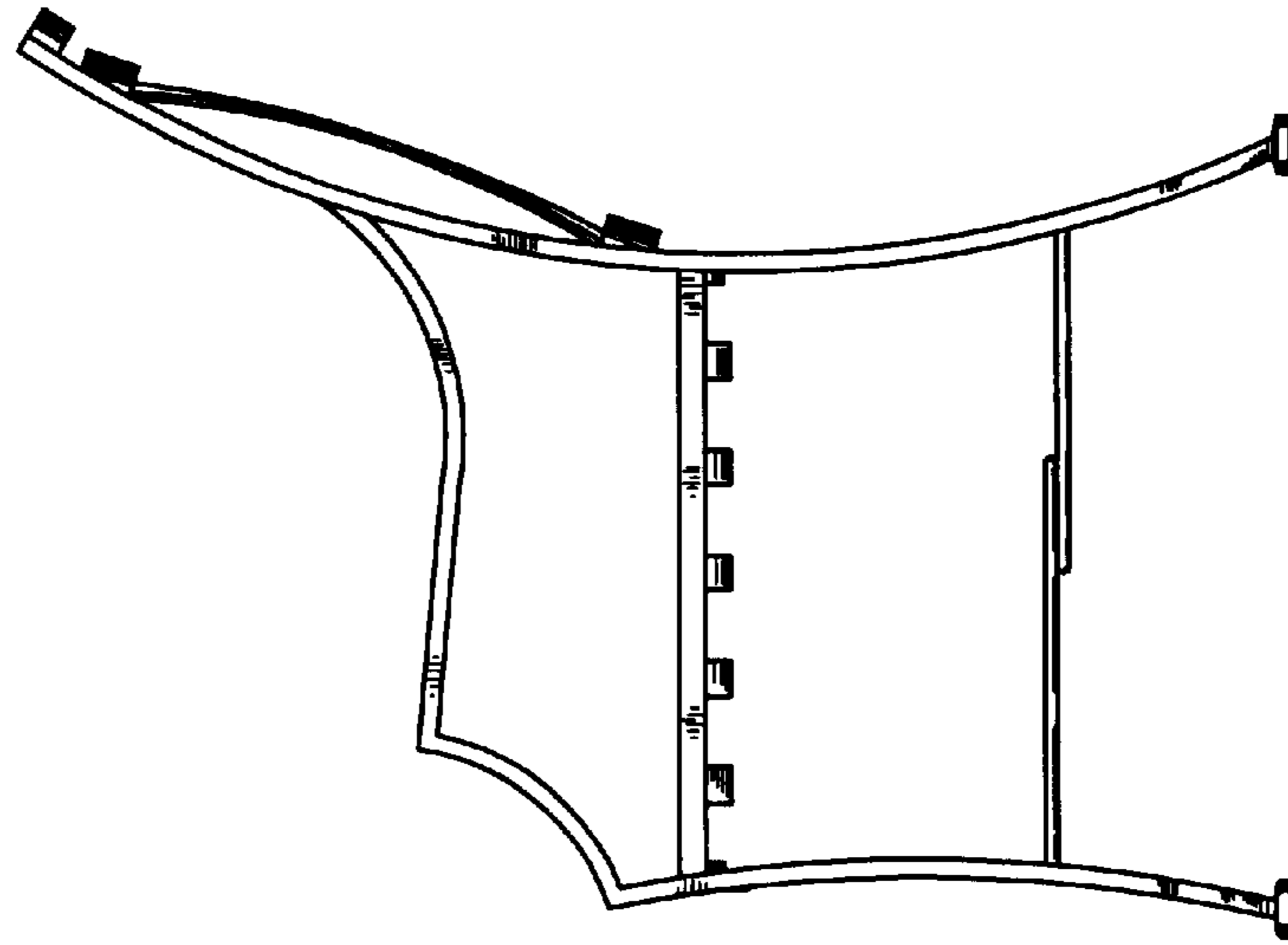

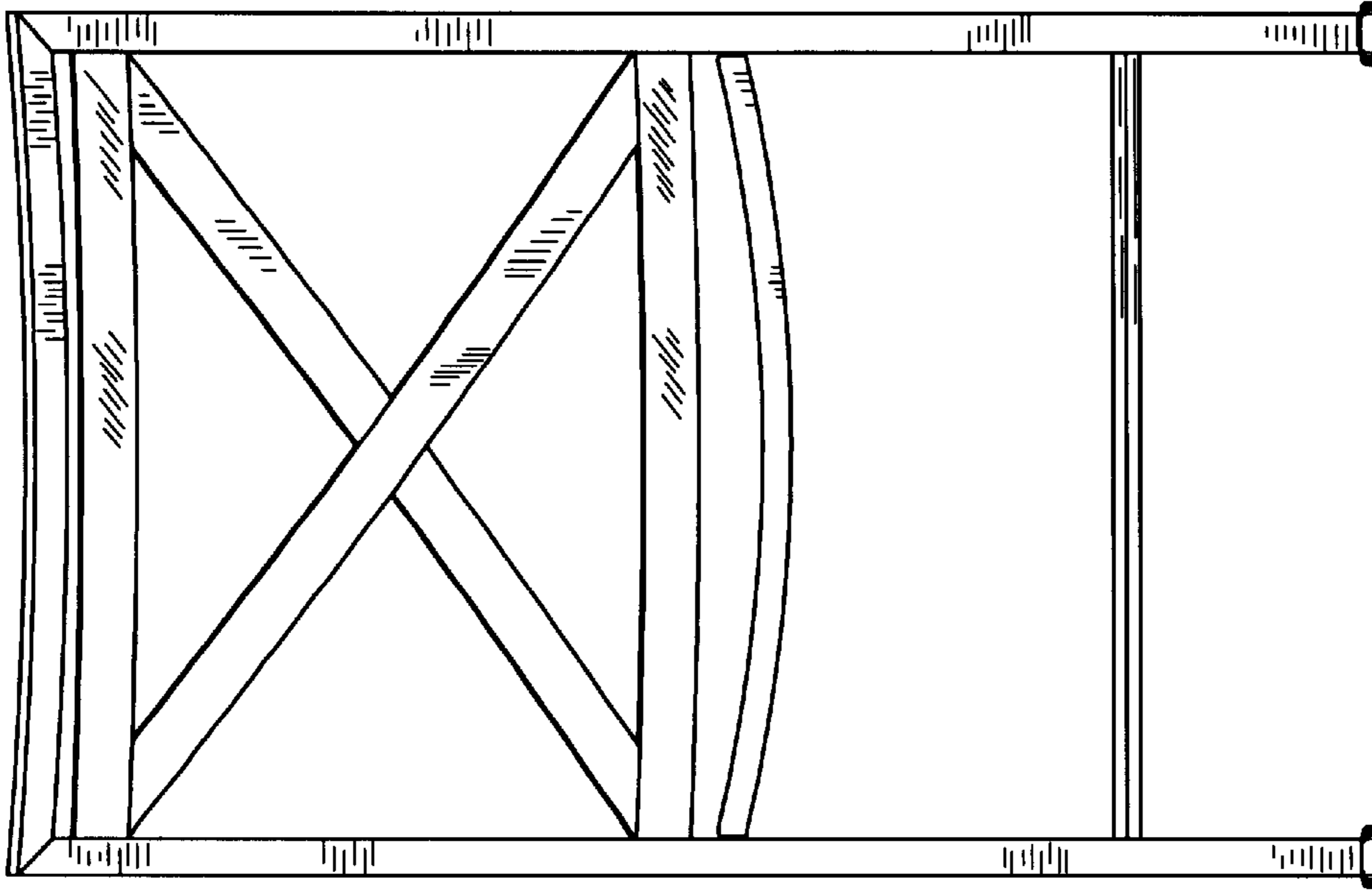

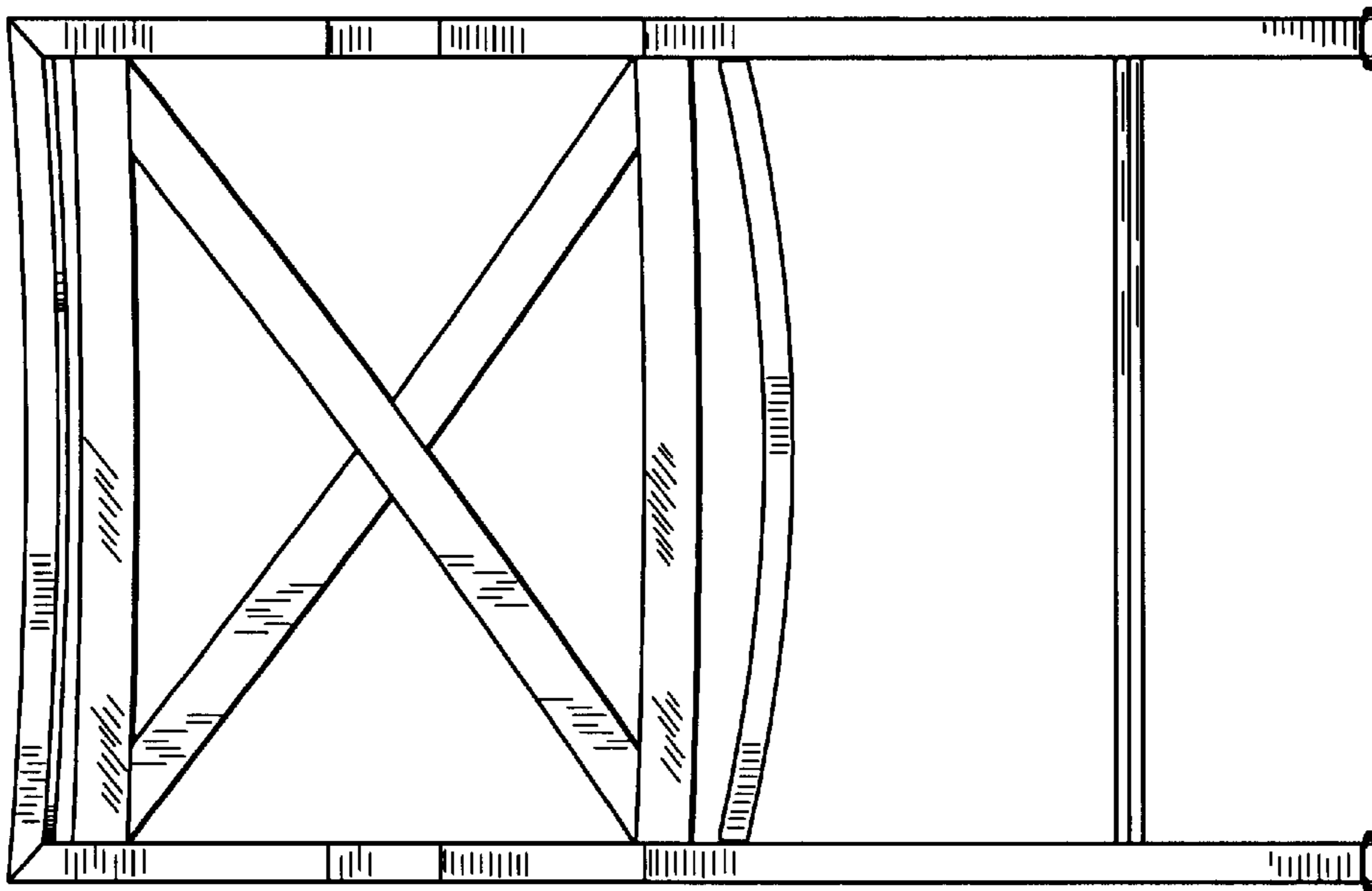

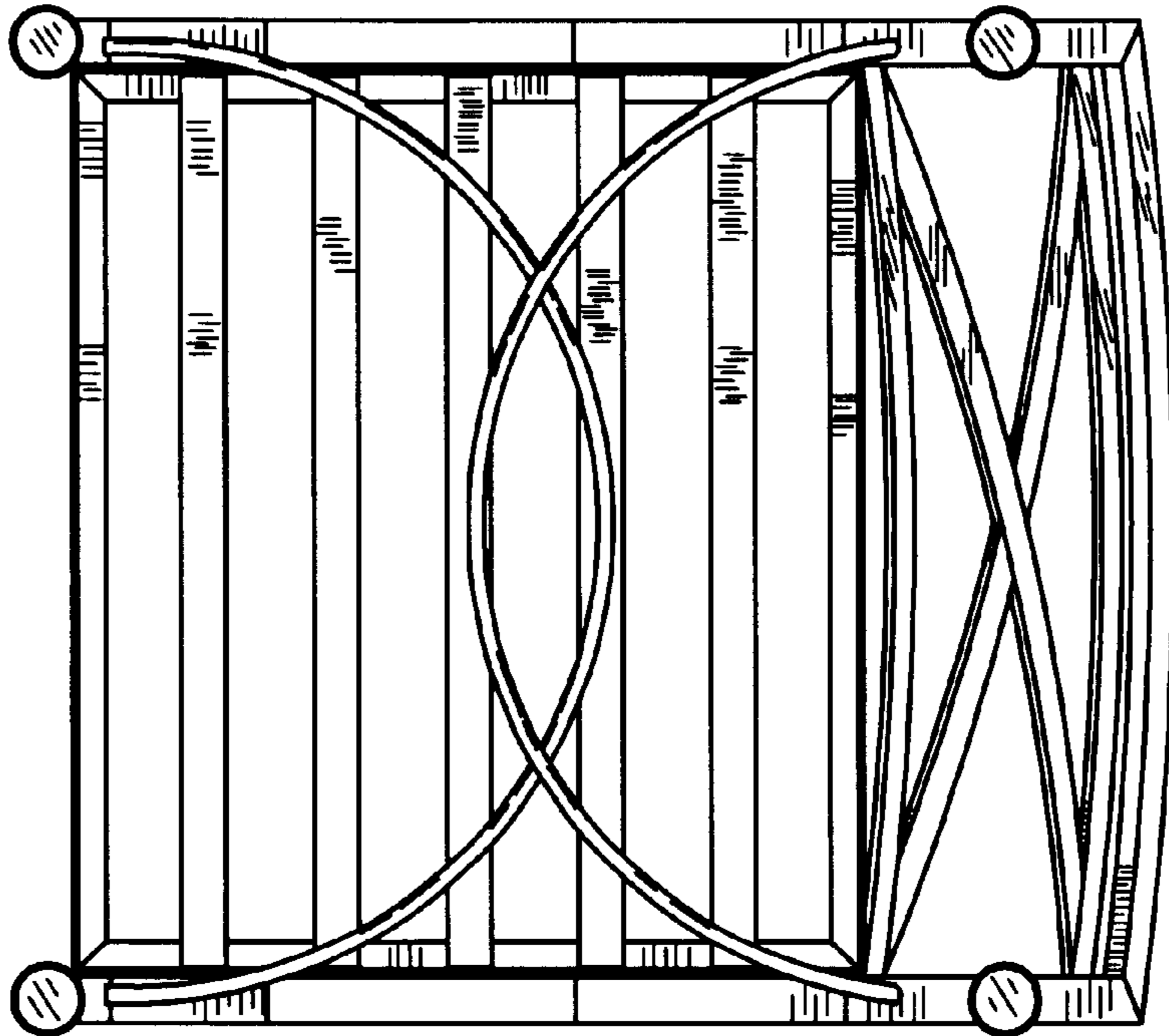

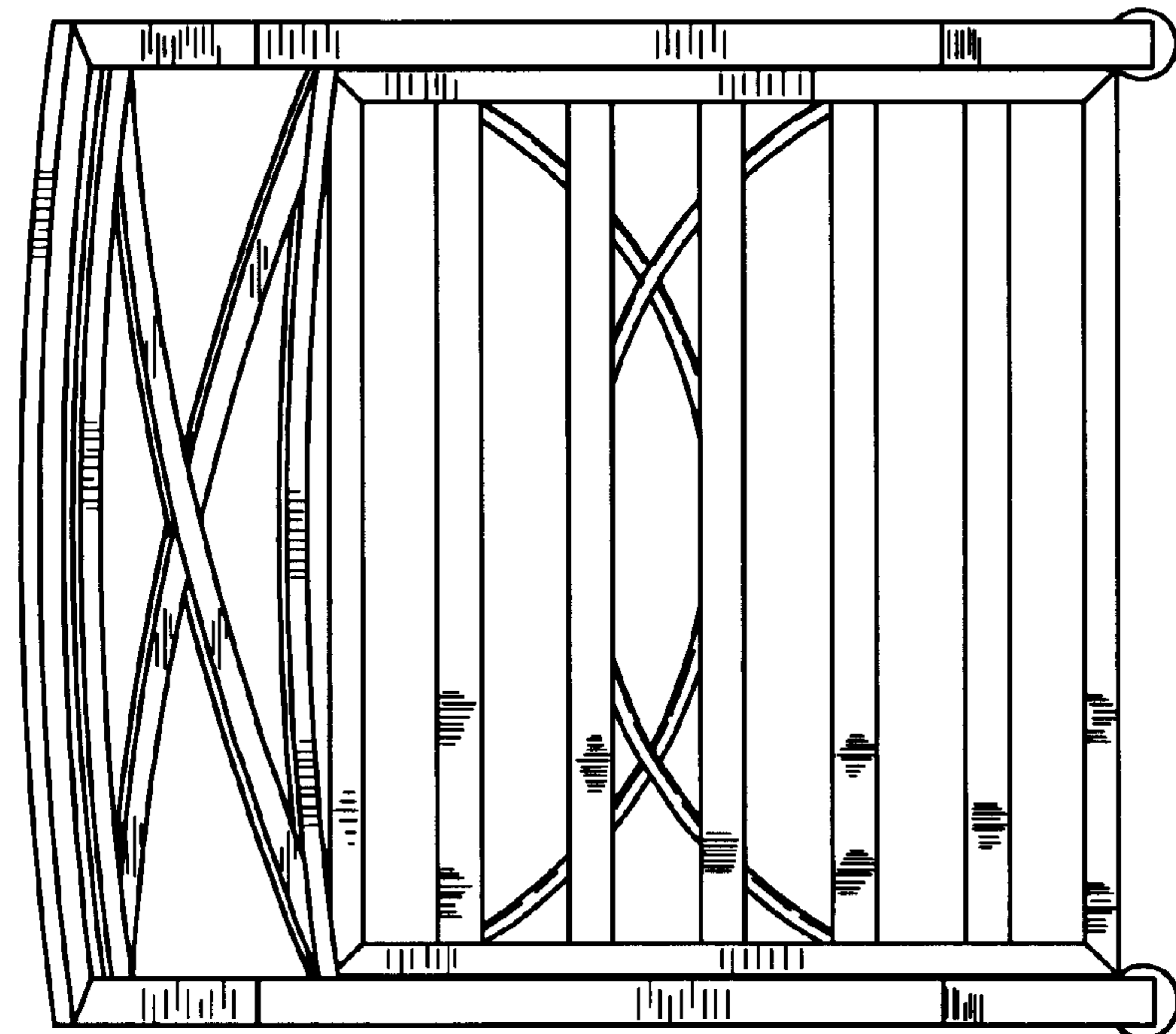
