The ornamental design for a decorative cover for a diaper receptacle, as shown and described.

FIG. 1 is a perspective view of a decorative cover for a diaper receptacle showing my new design.

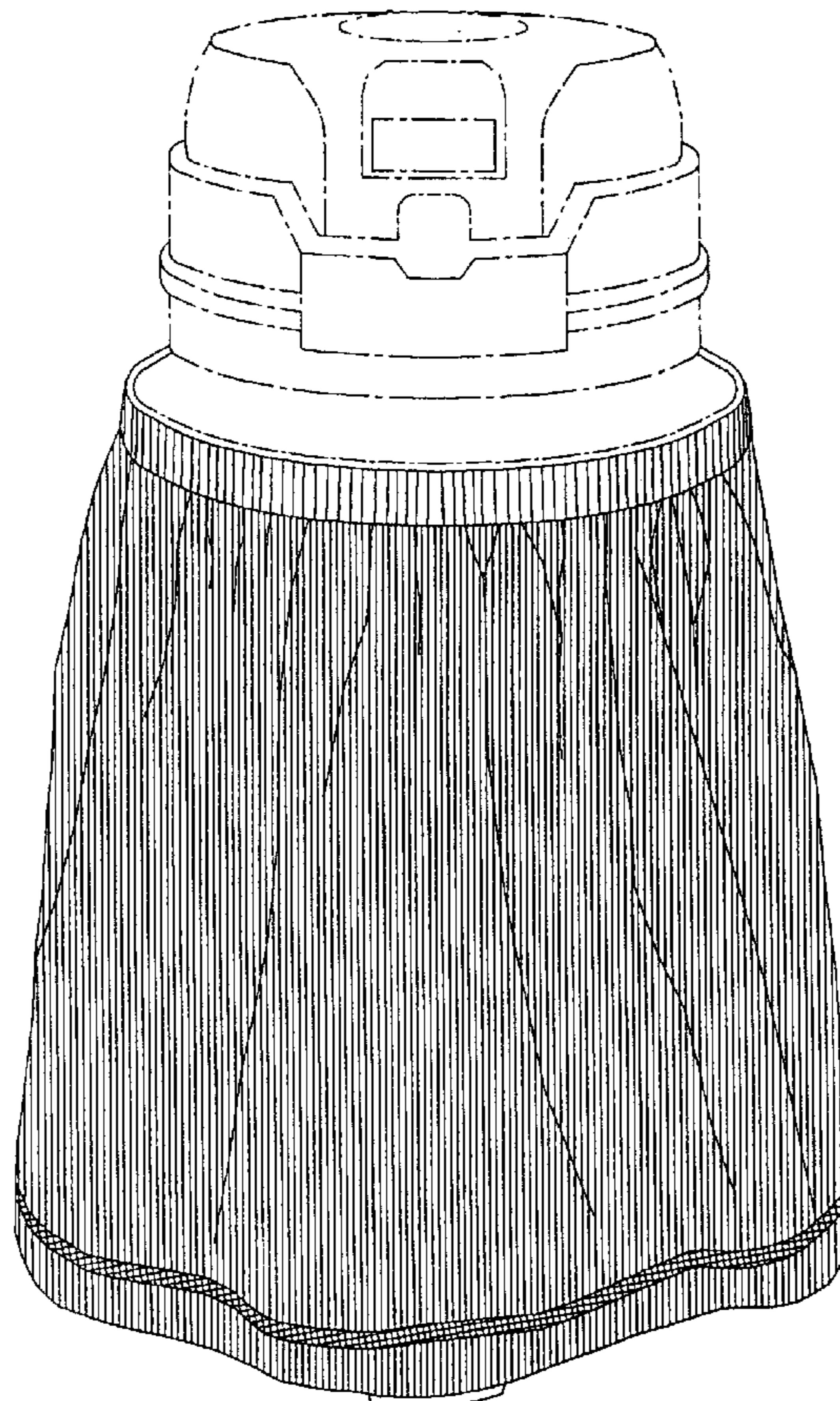
FIG. 2 is a side view of the decorative cover for a diaper receptacle of FIG. 1.

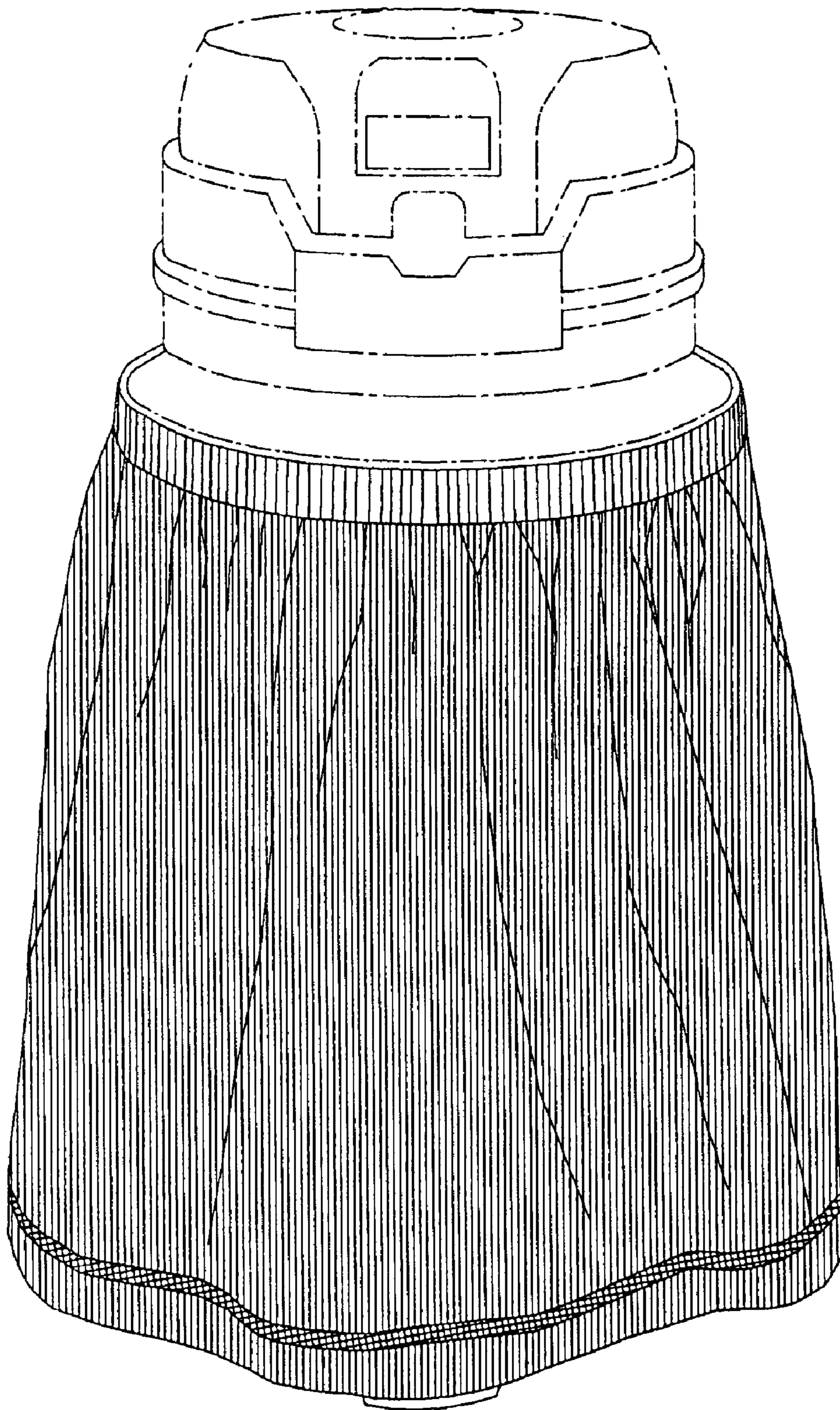

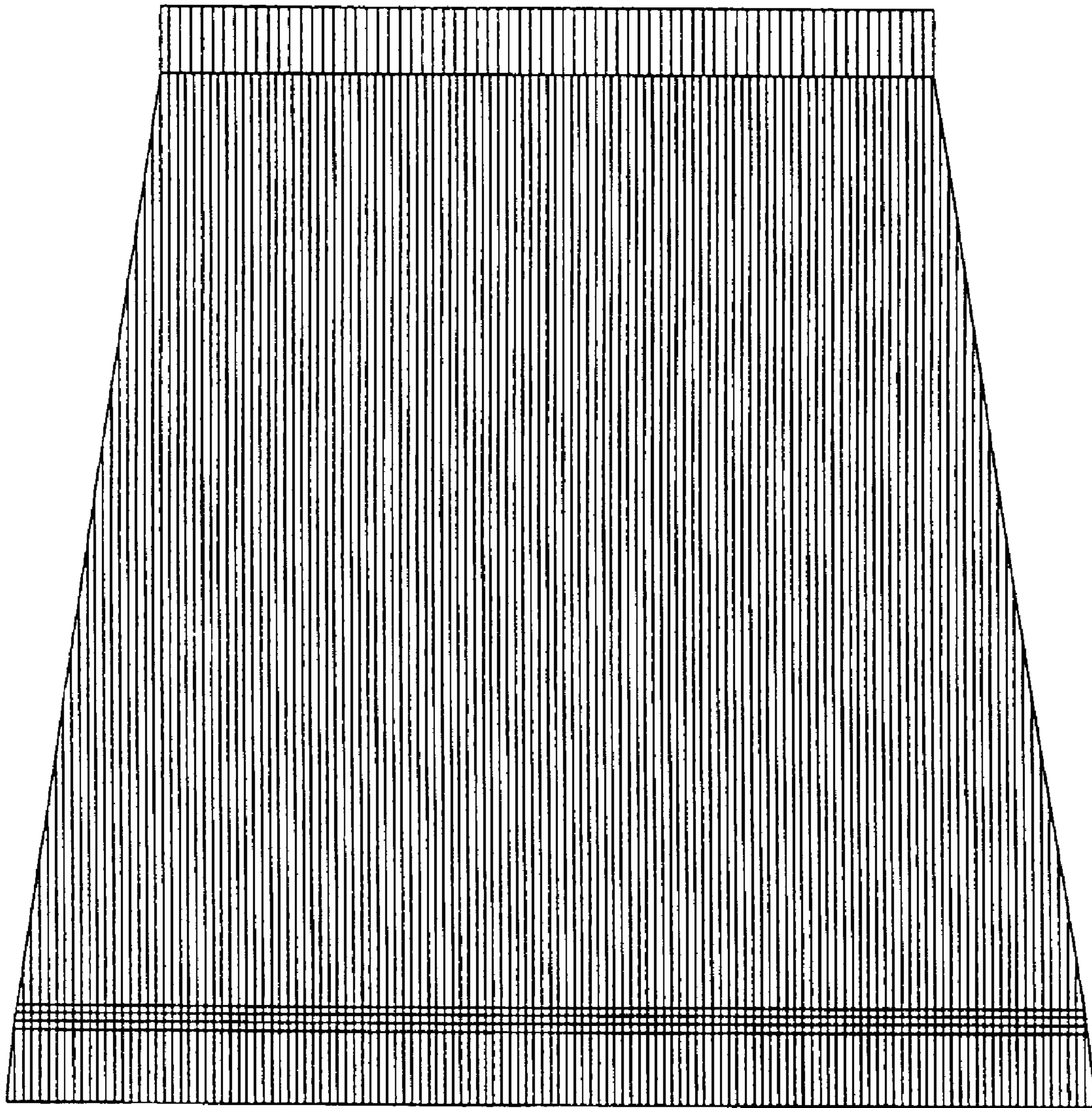

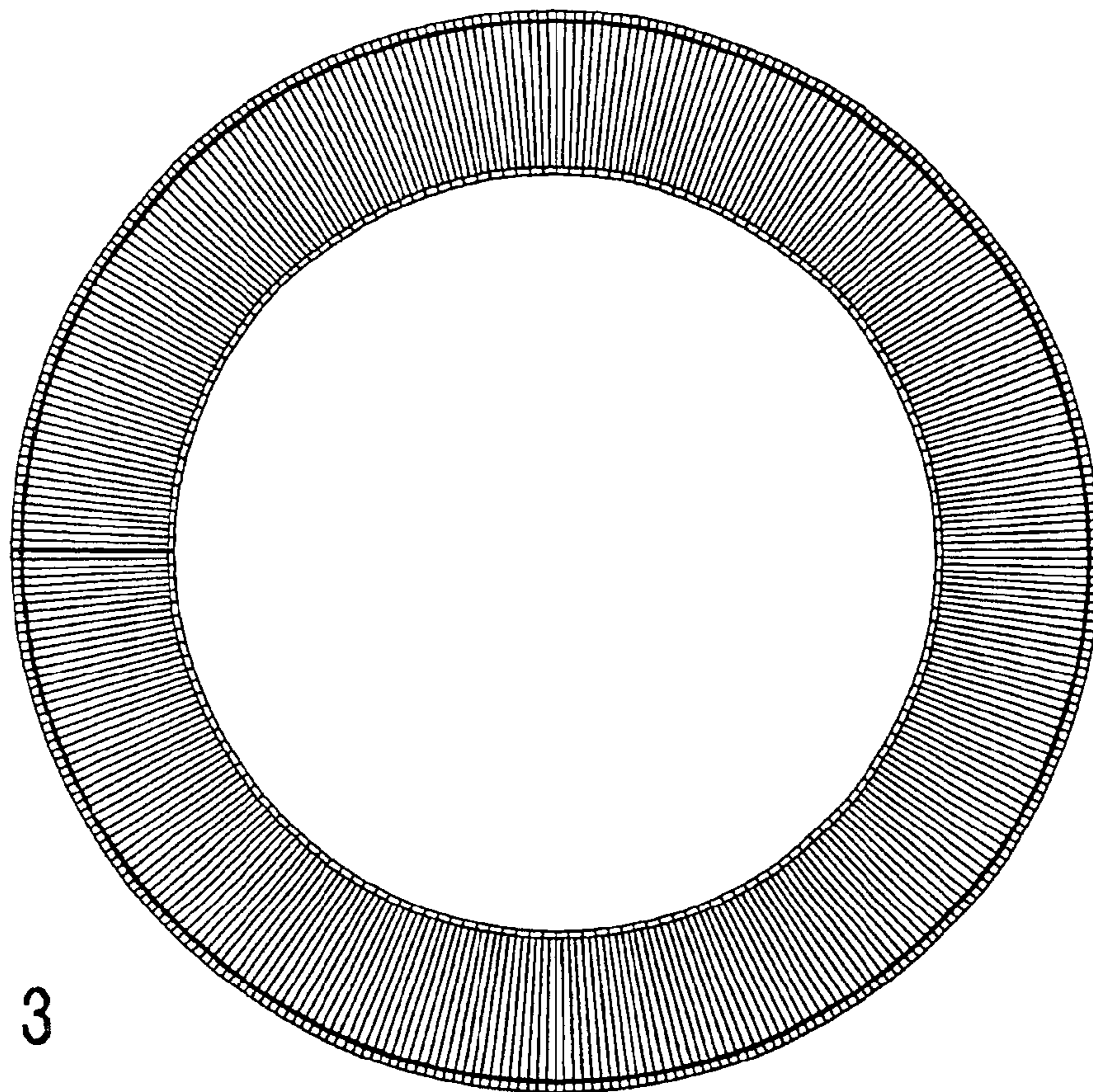

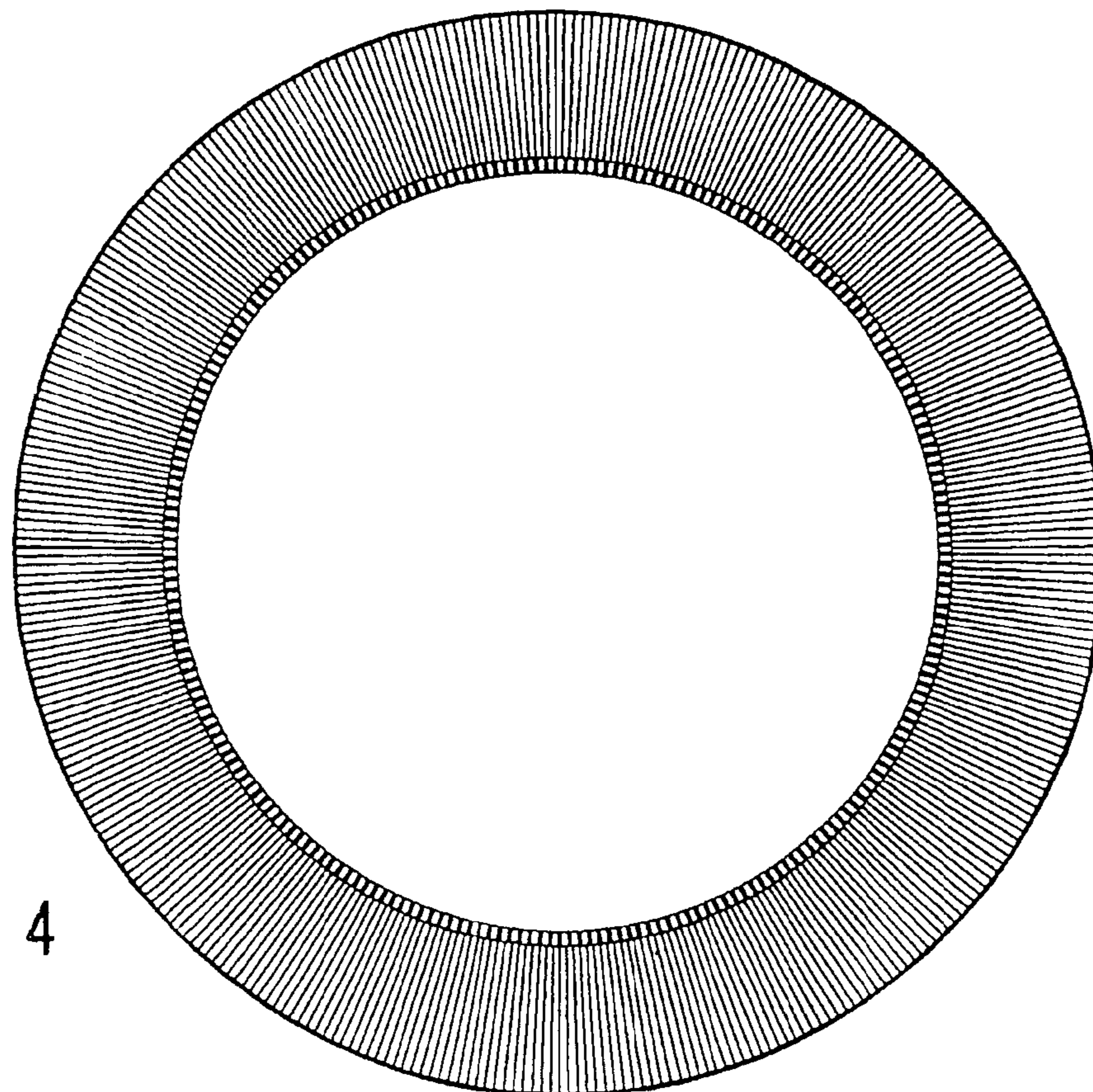
