I claim, the ornamental design for a surface pattern applied to a cup, as shown and described.

FIG. 4 is a left view thereof;

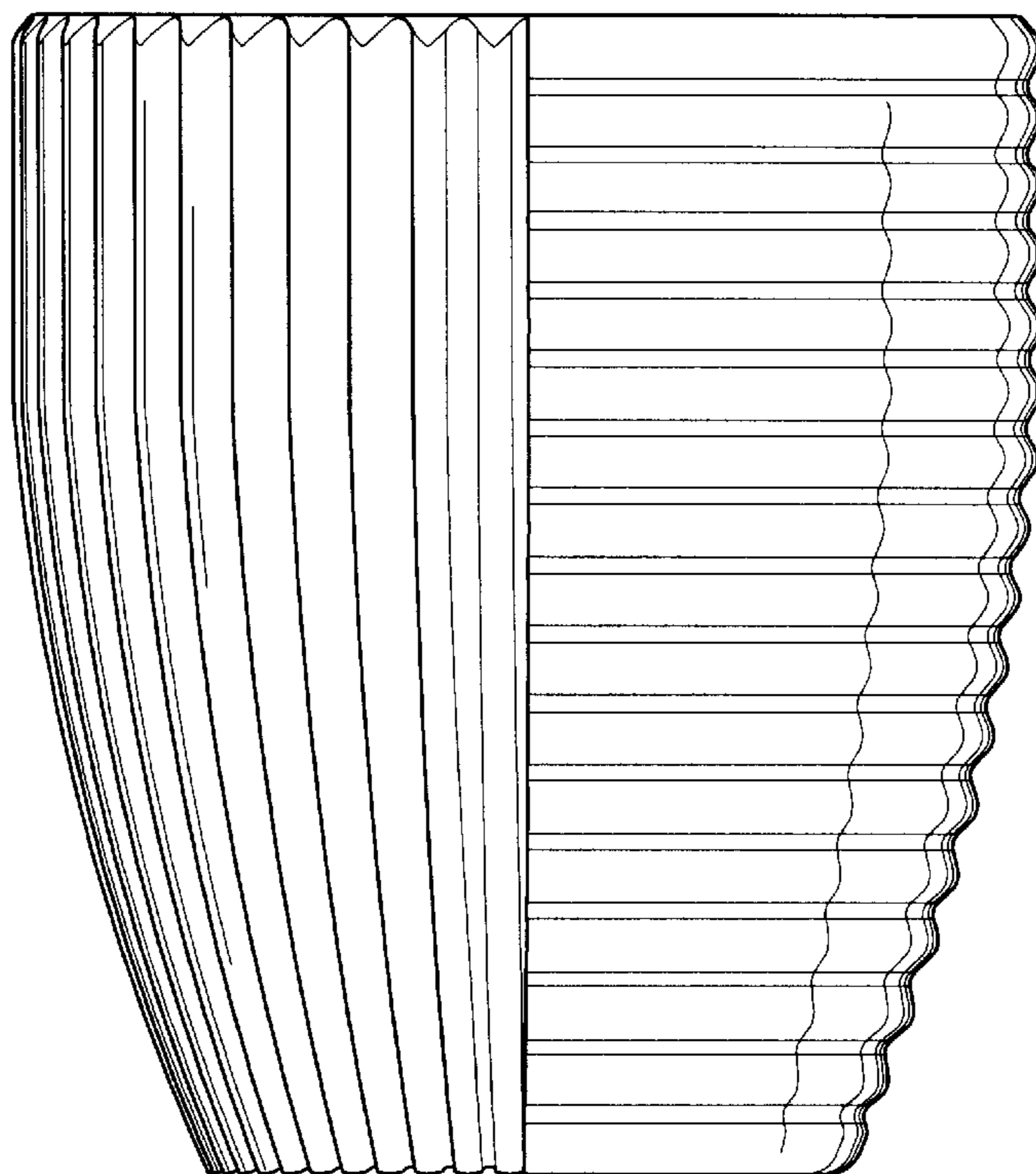
FIG. 5 is a right view thereof;

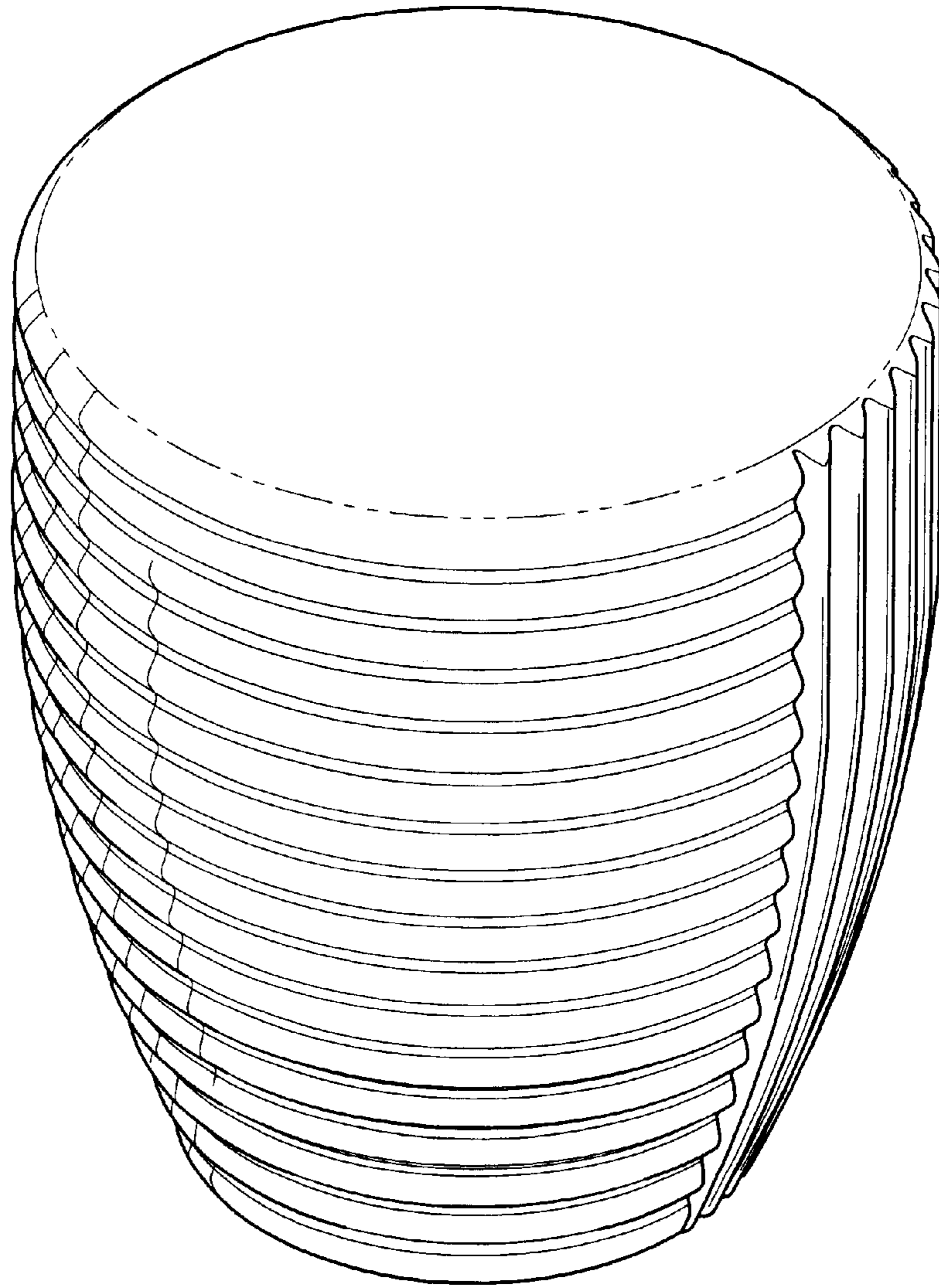

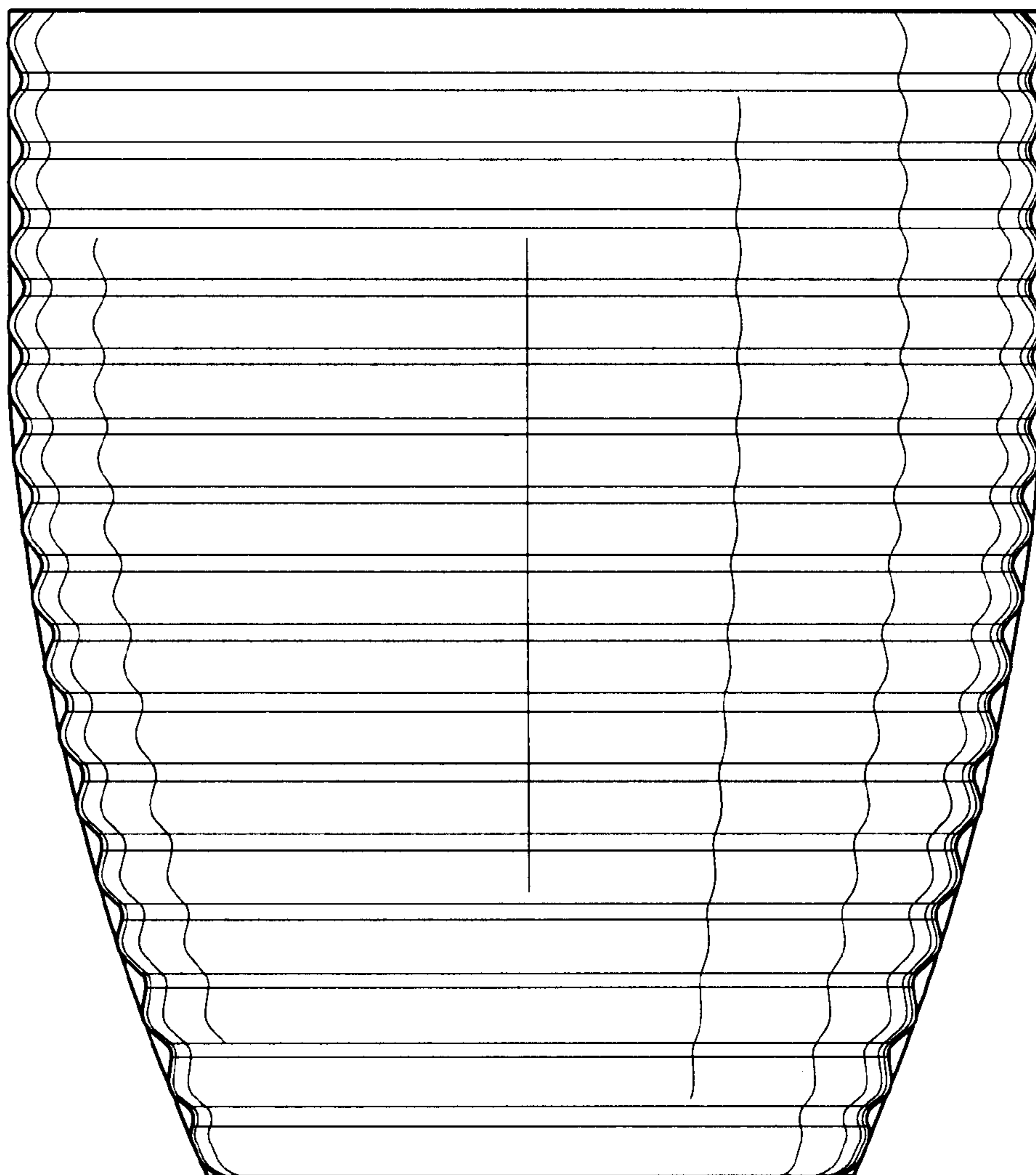

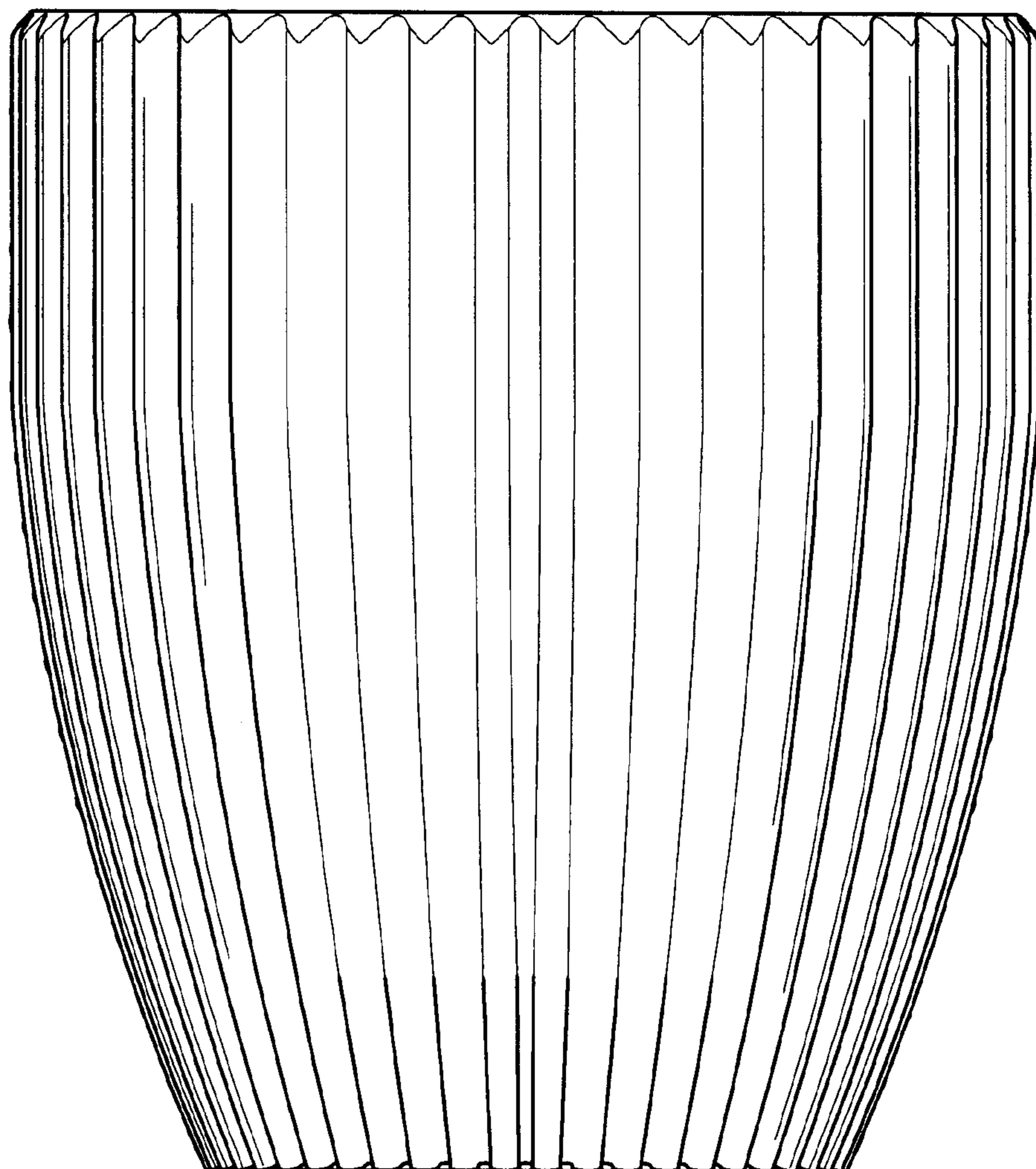

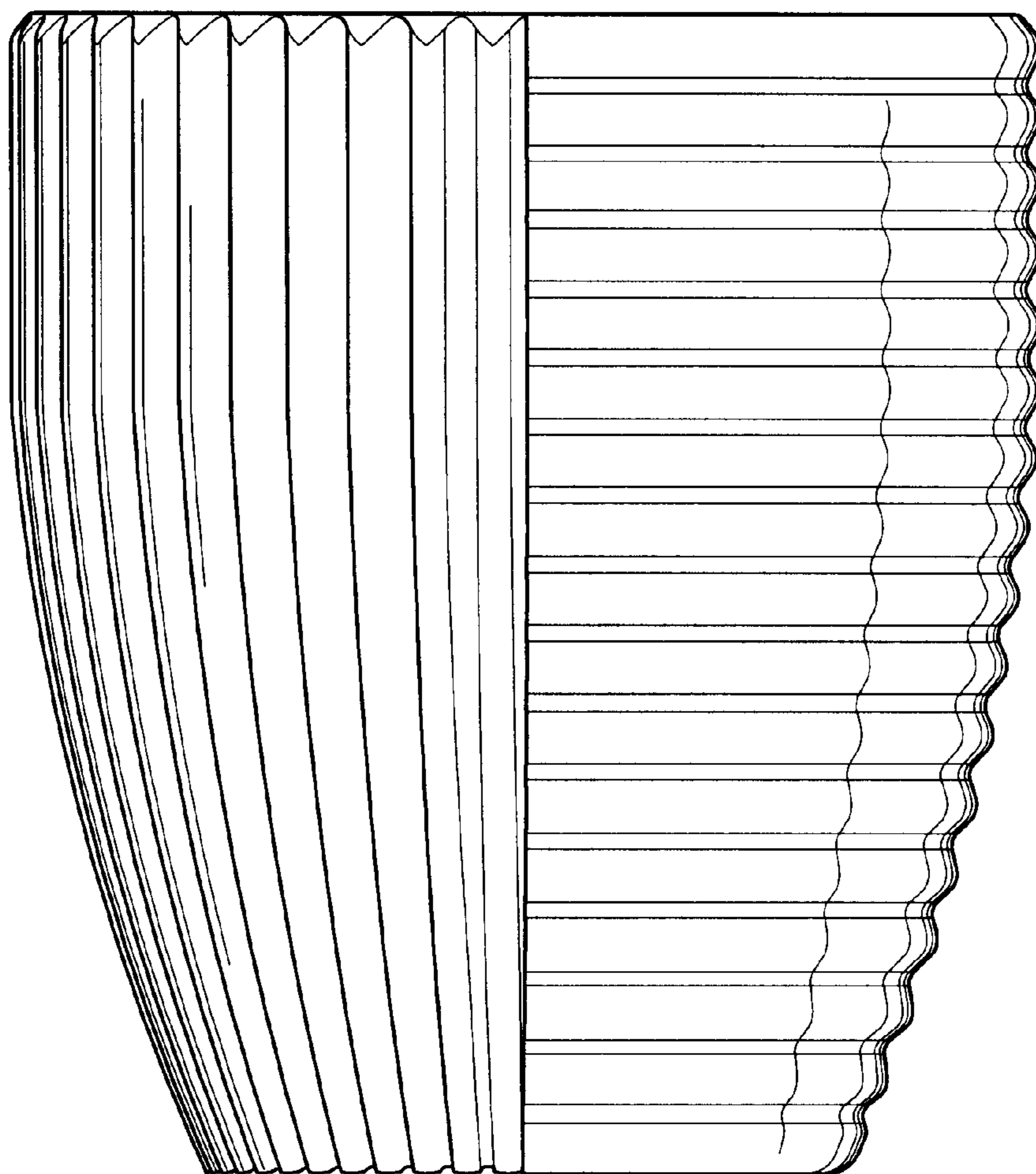

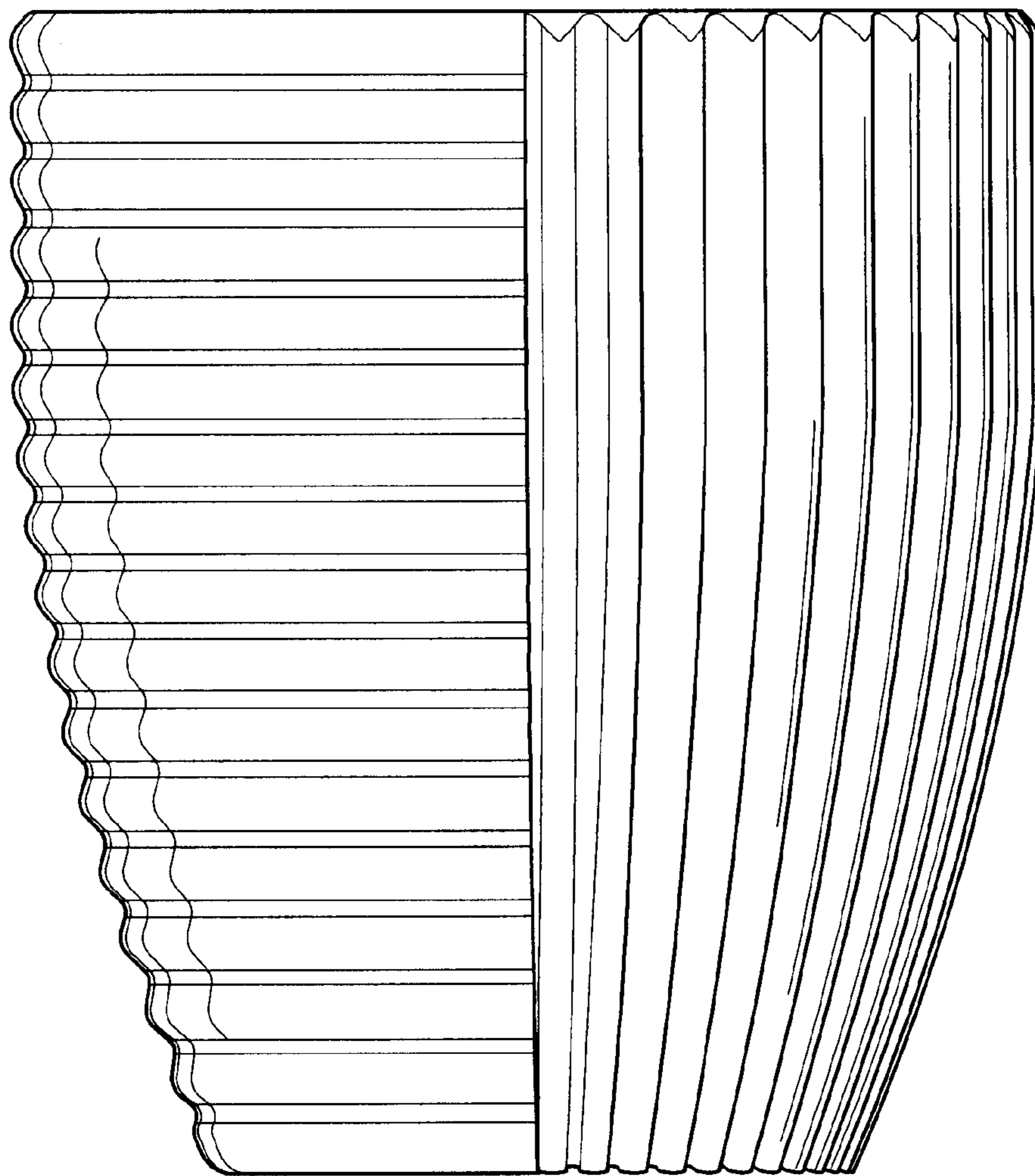

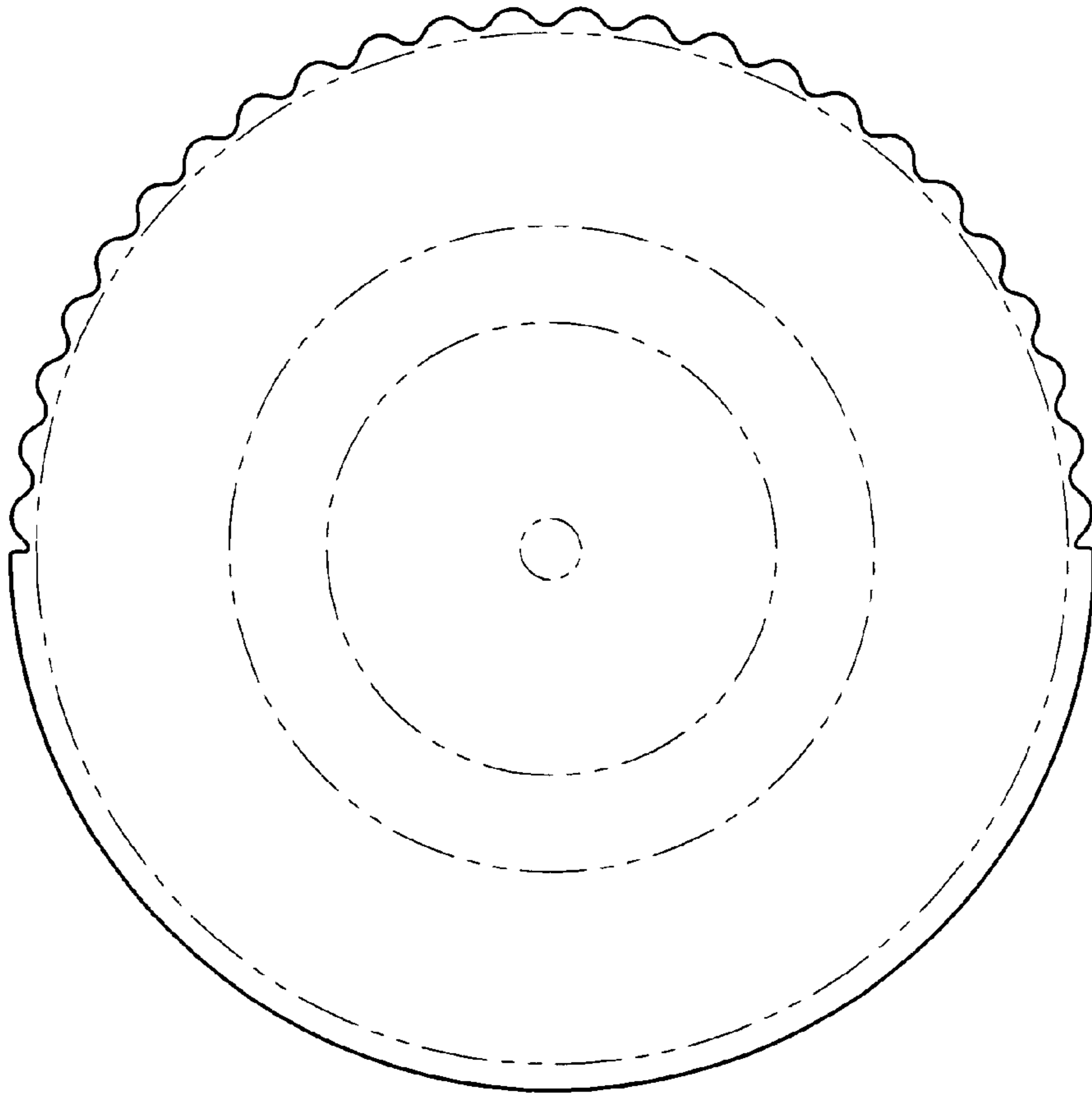

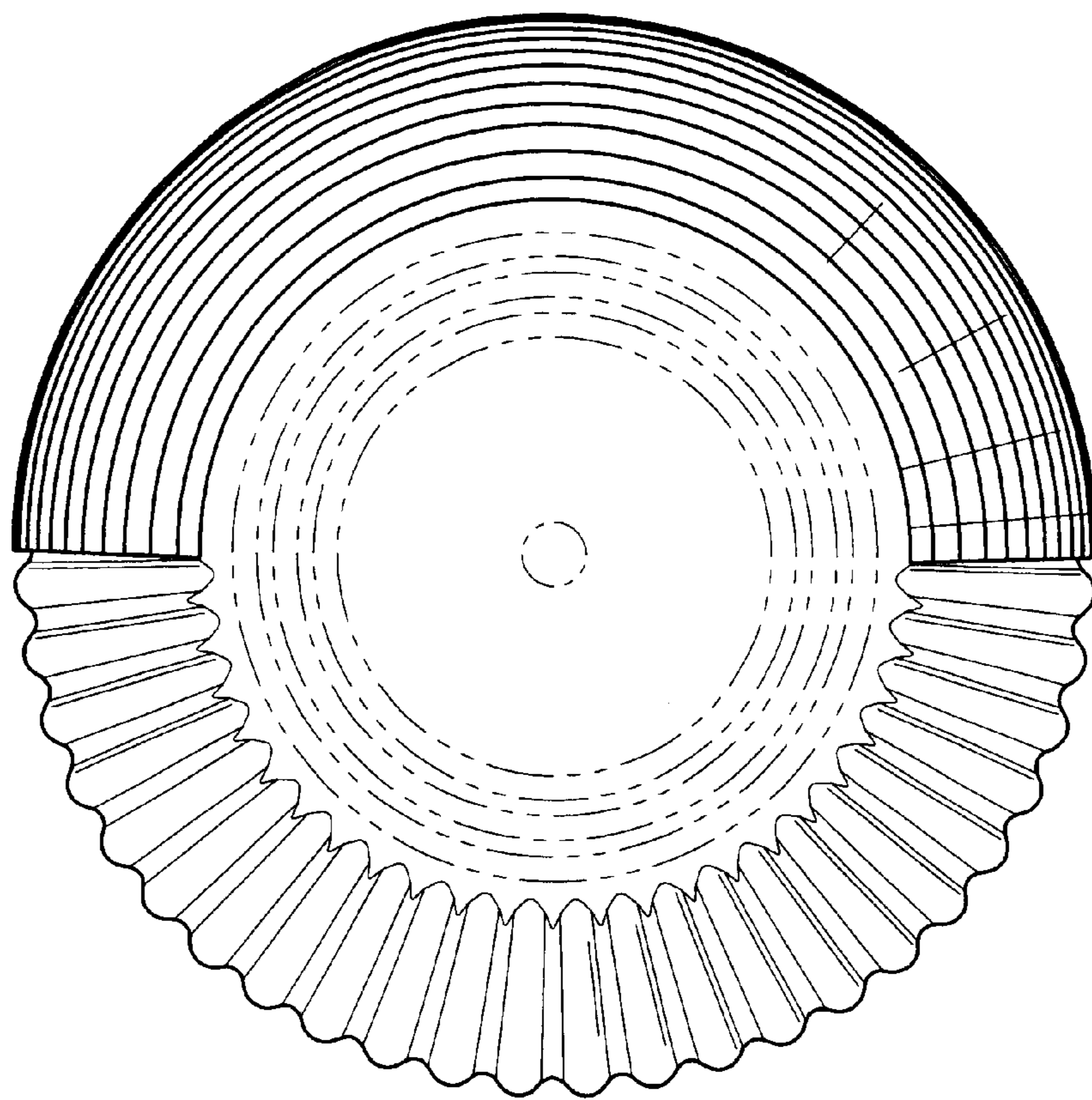
