FIG. 1 is a side perspective view thereof;

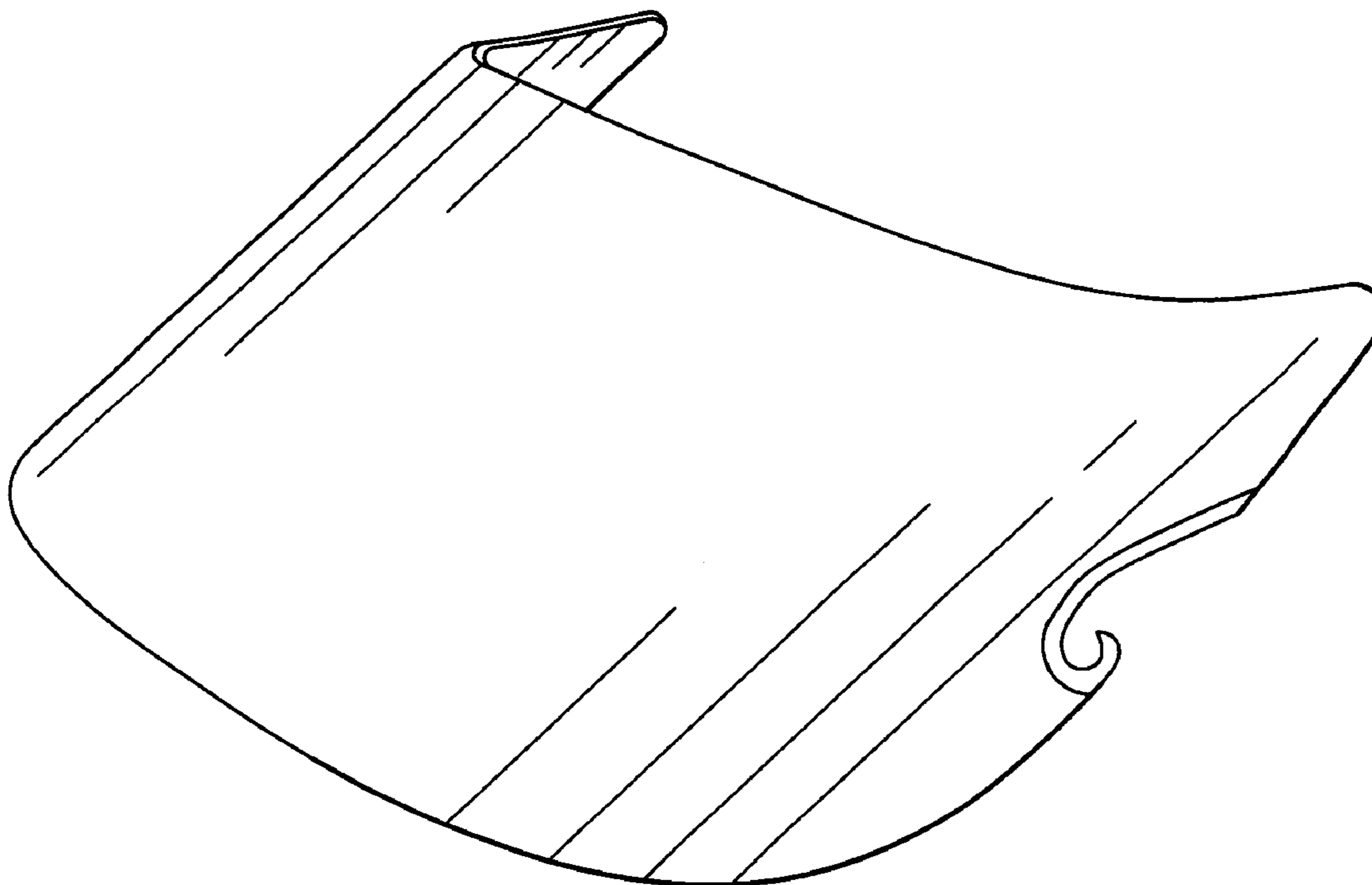
FIG. 2 is a front view thereof;

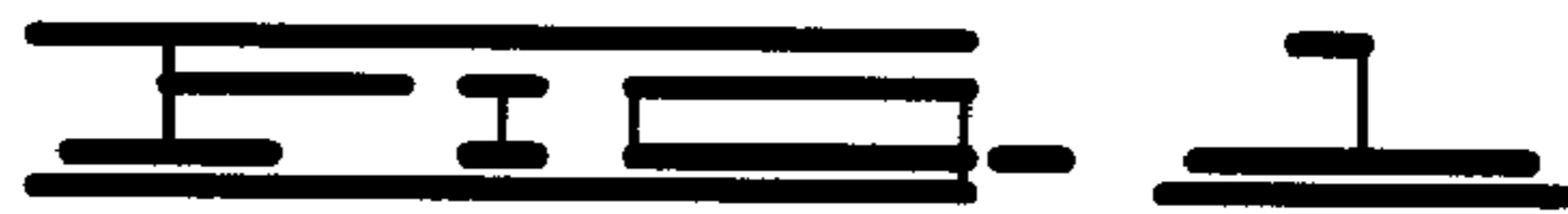
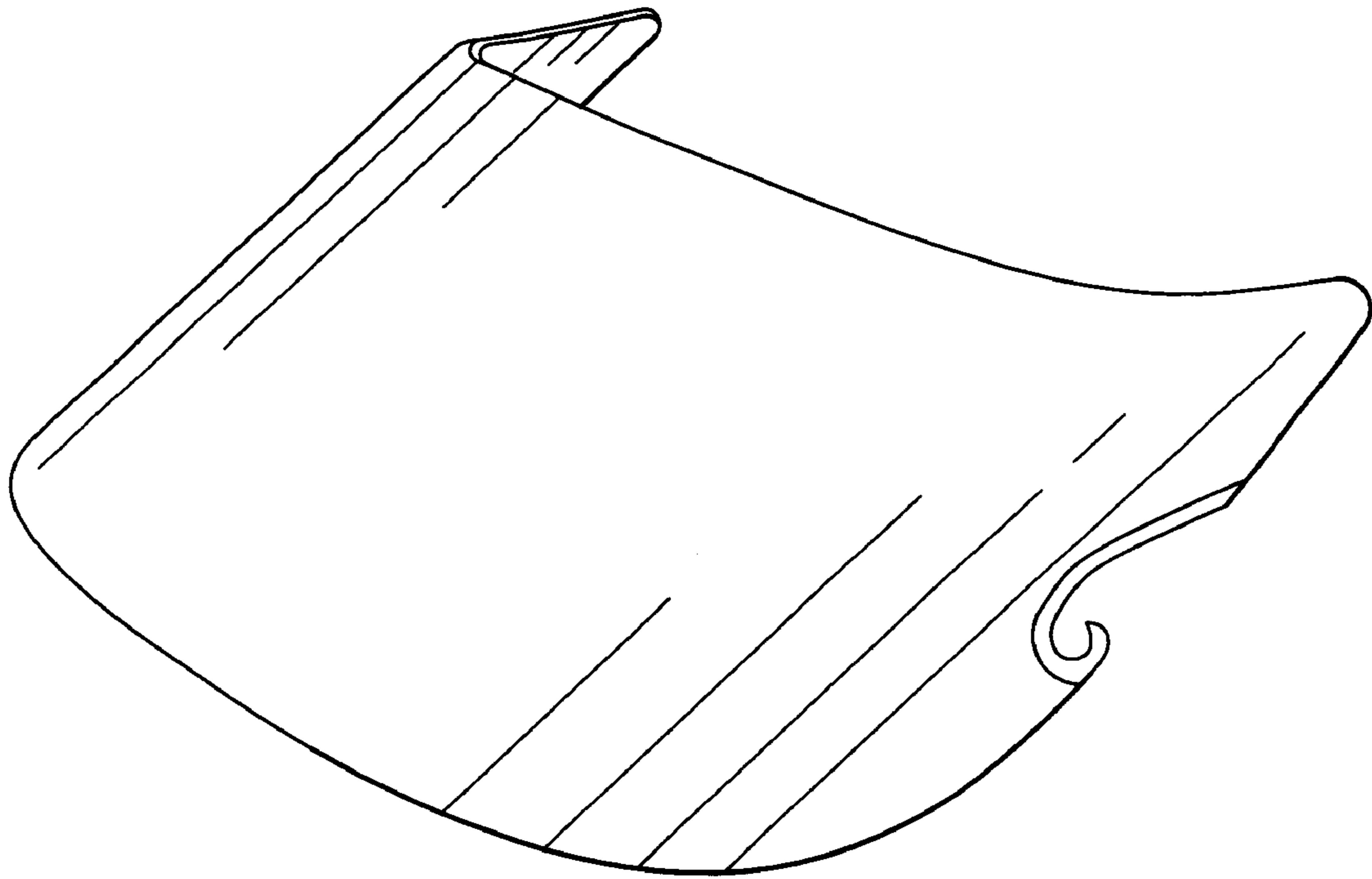
FIG. 3 is a side view thereof;

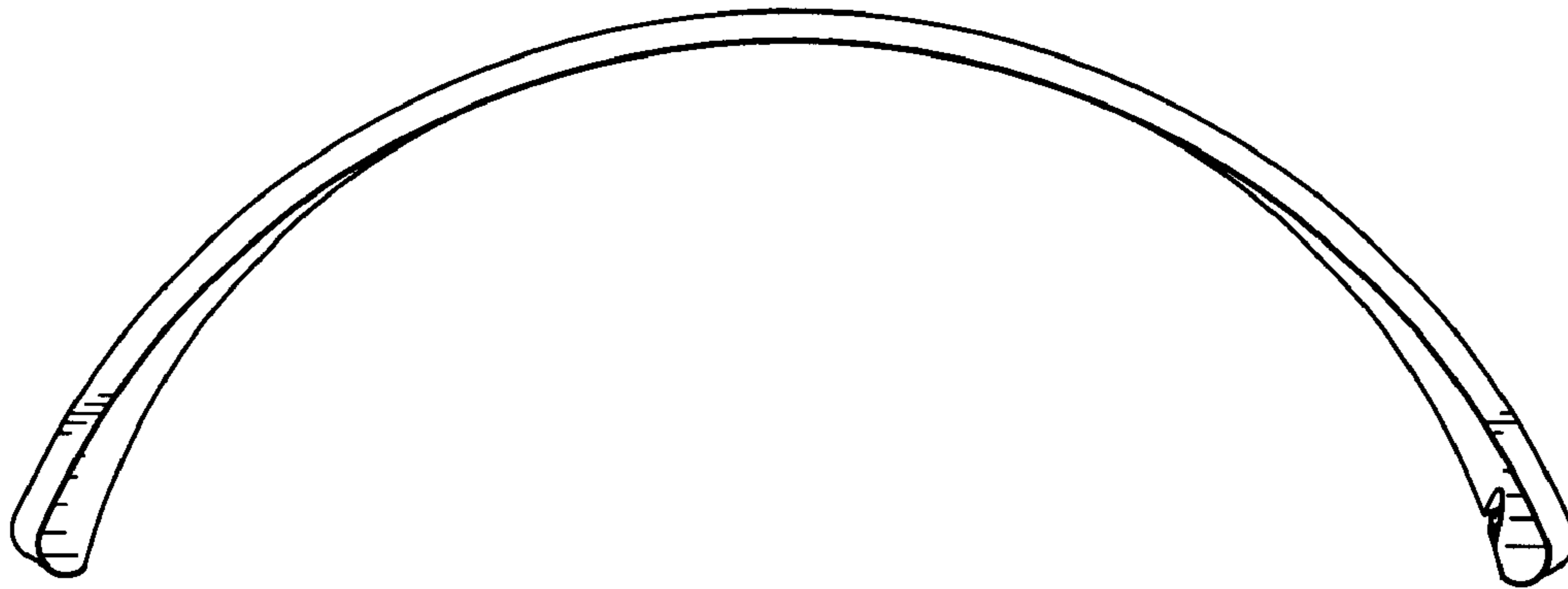

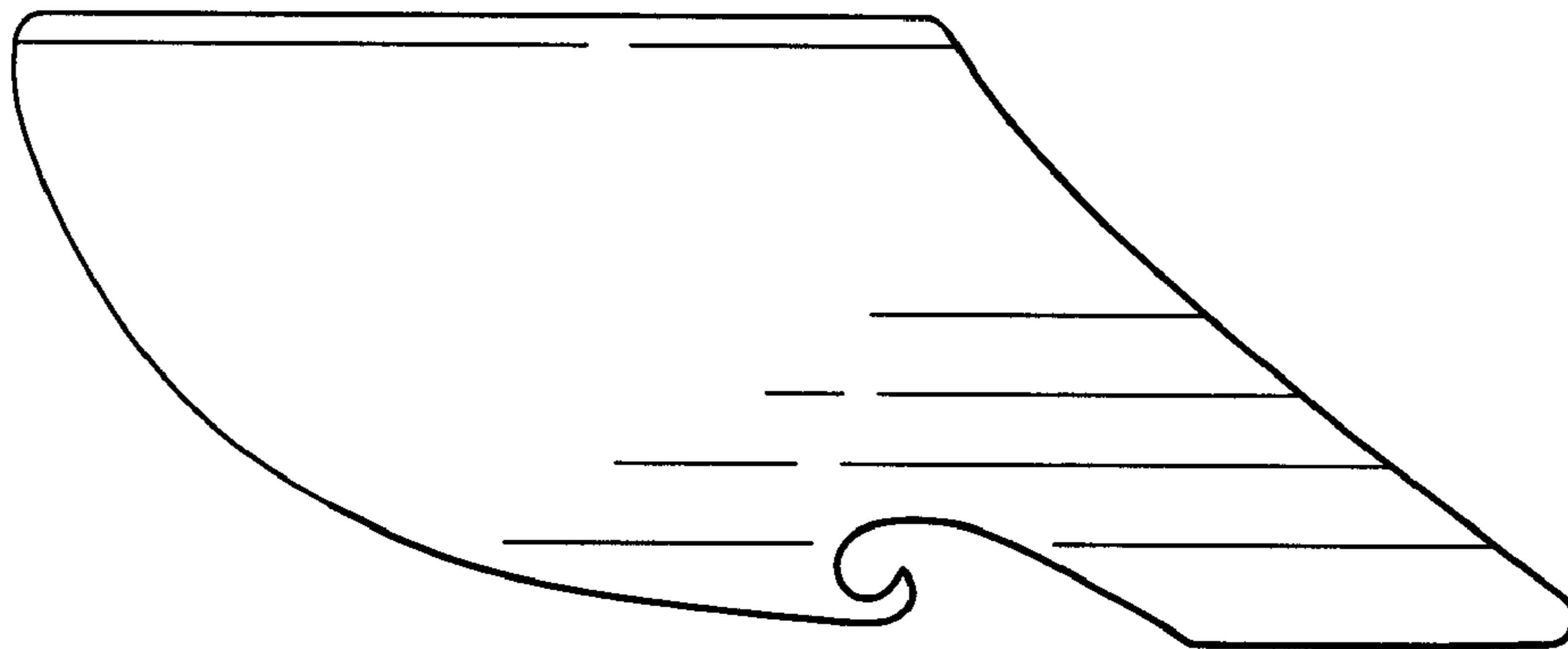

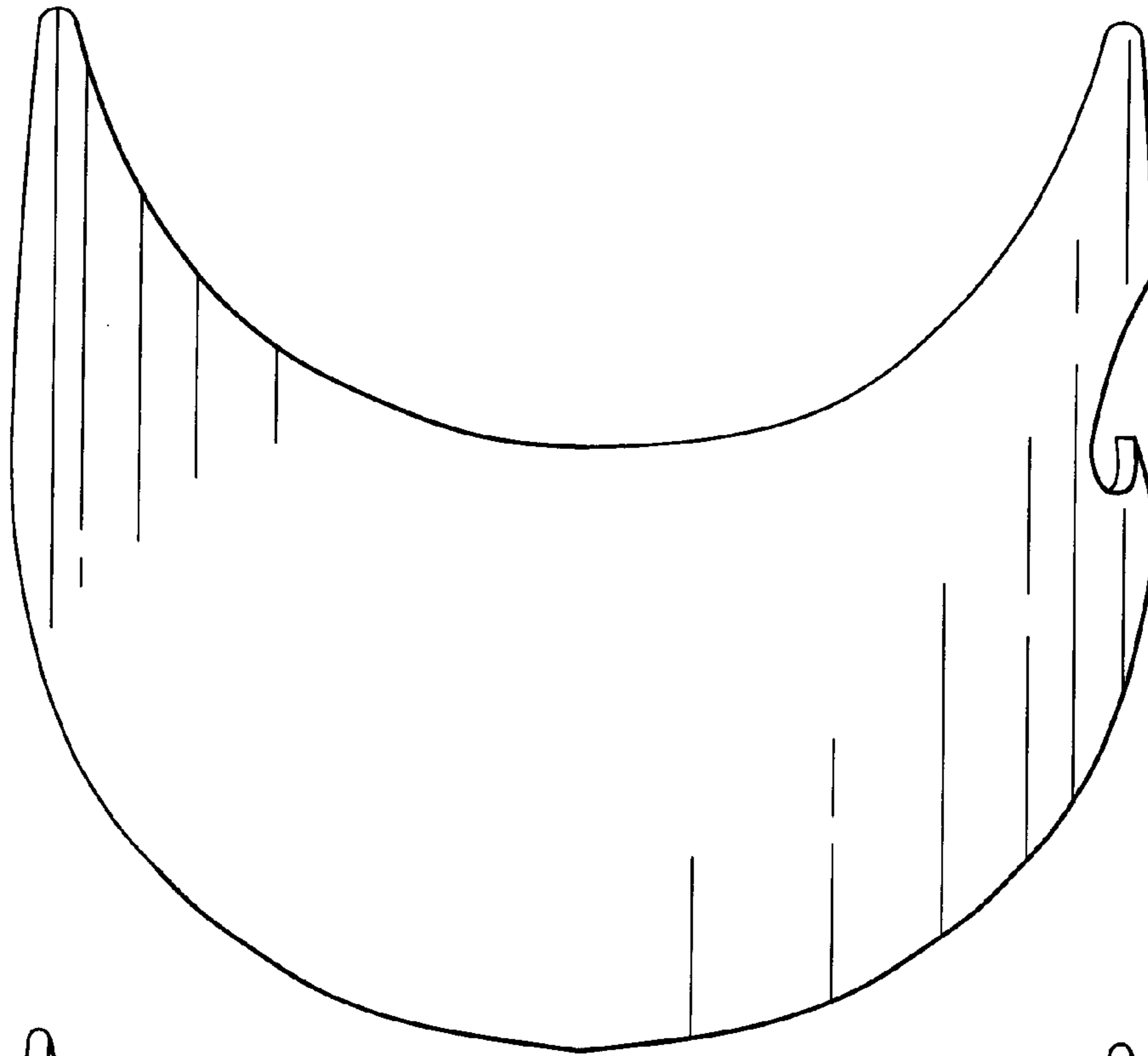

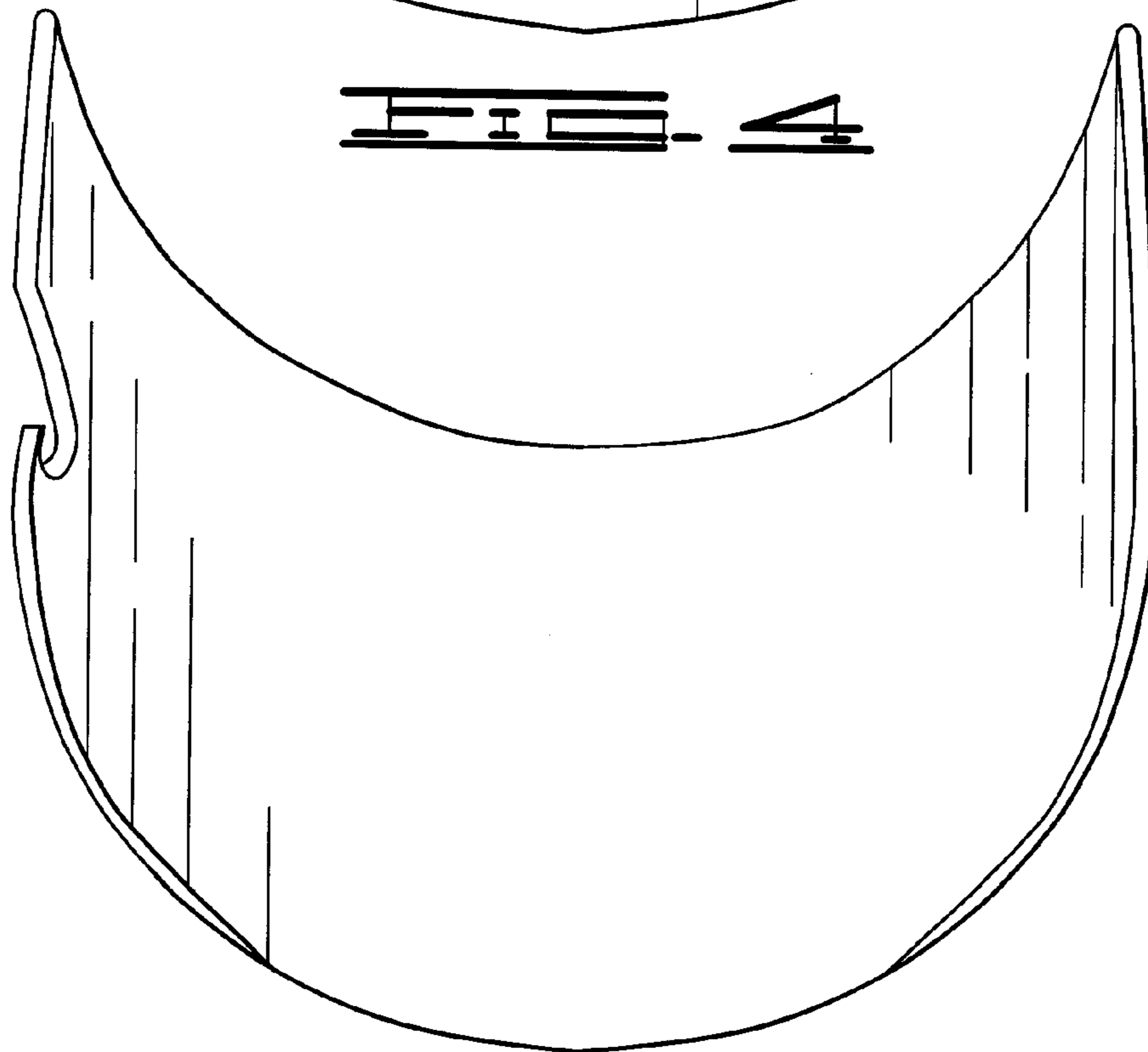
