FIG. 10 is a bottom plan view thereof;

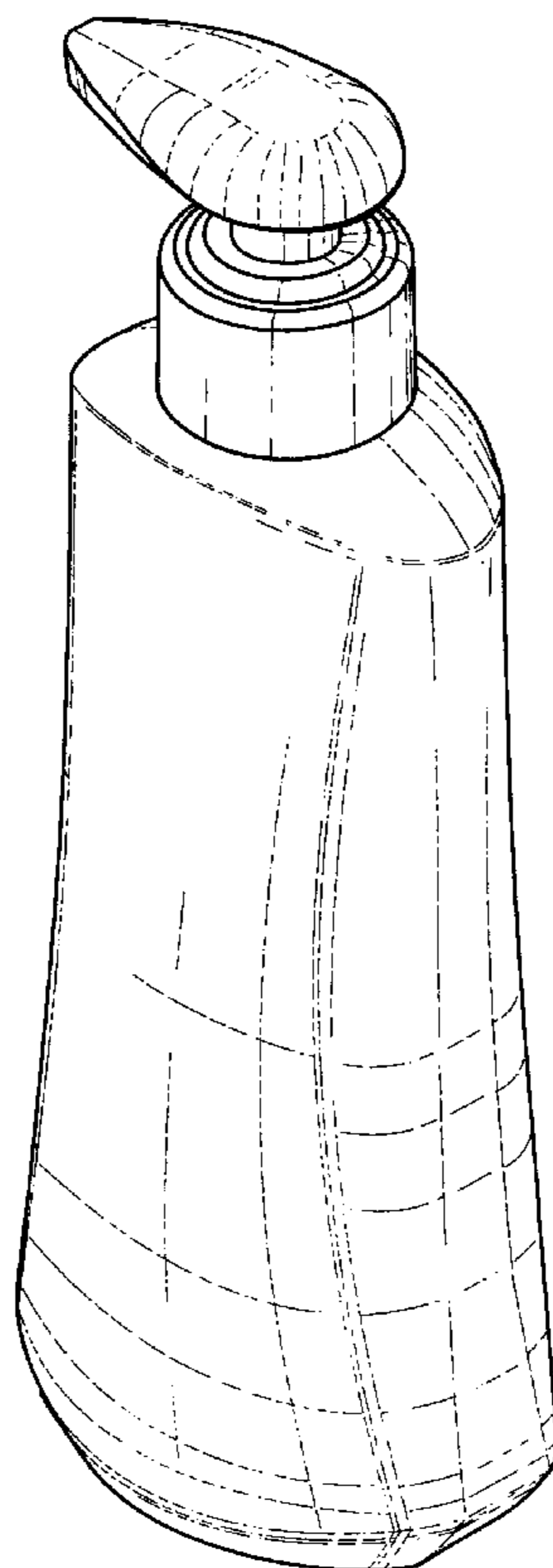
FIG. 11 is a front elevational view thereof;

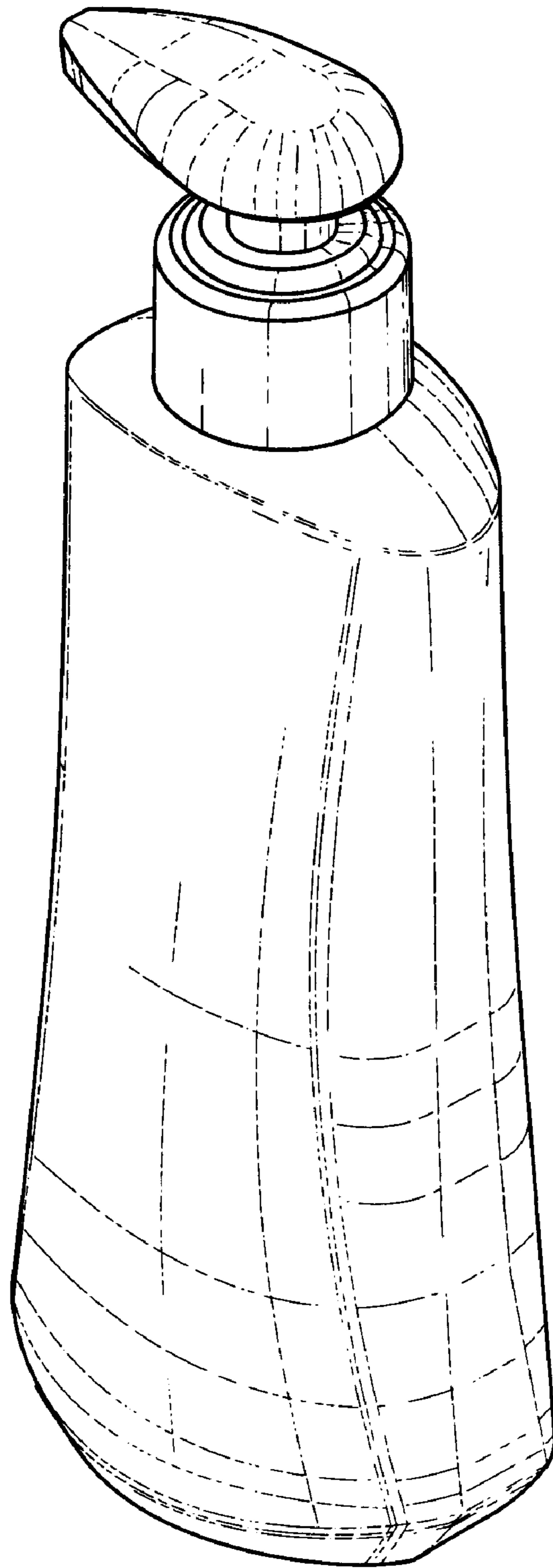

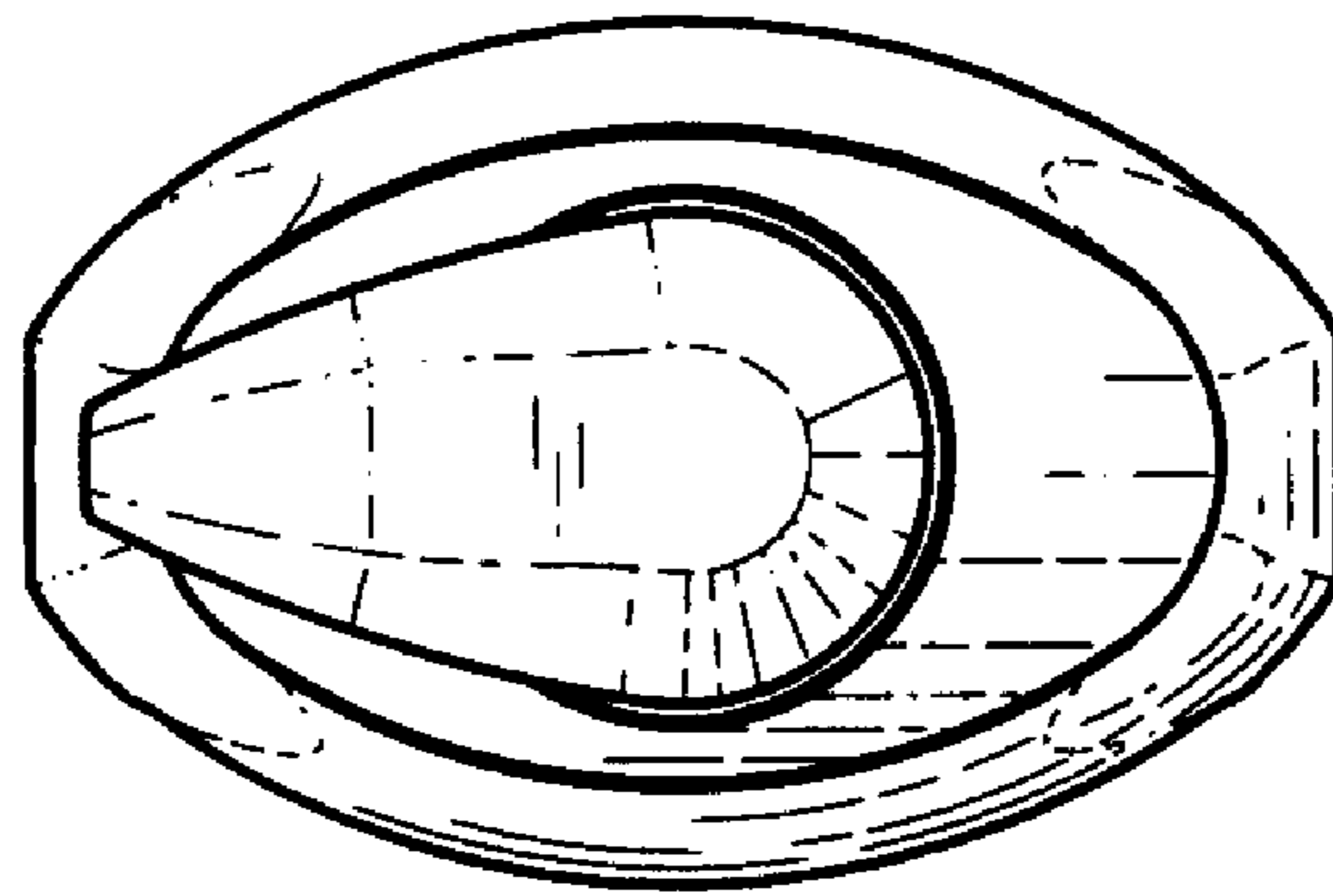

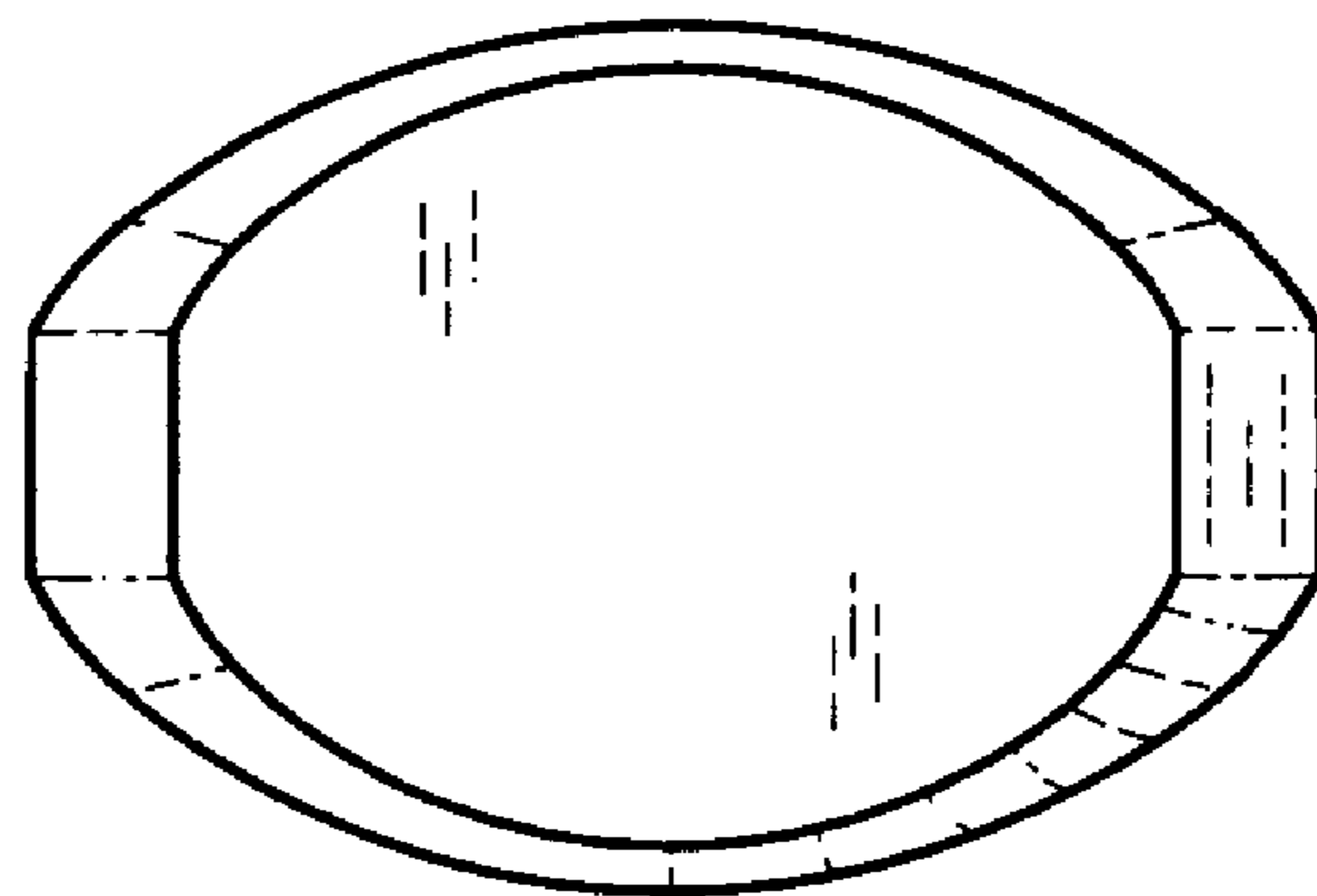

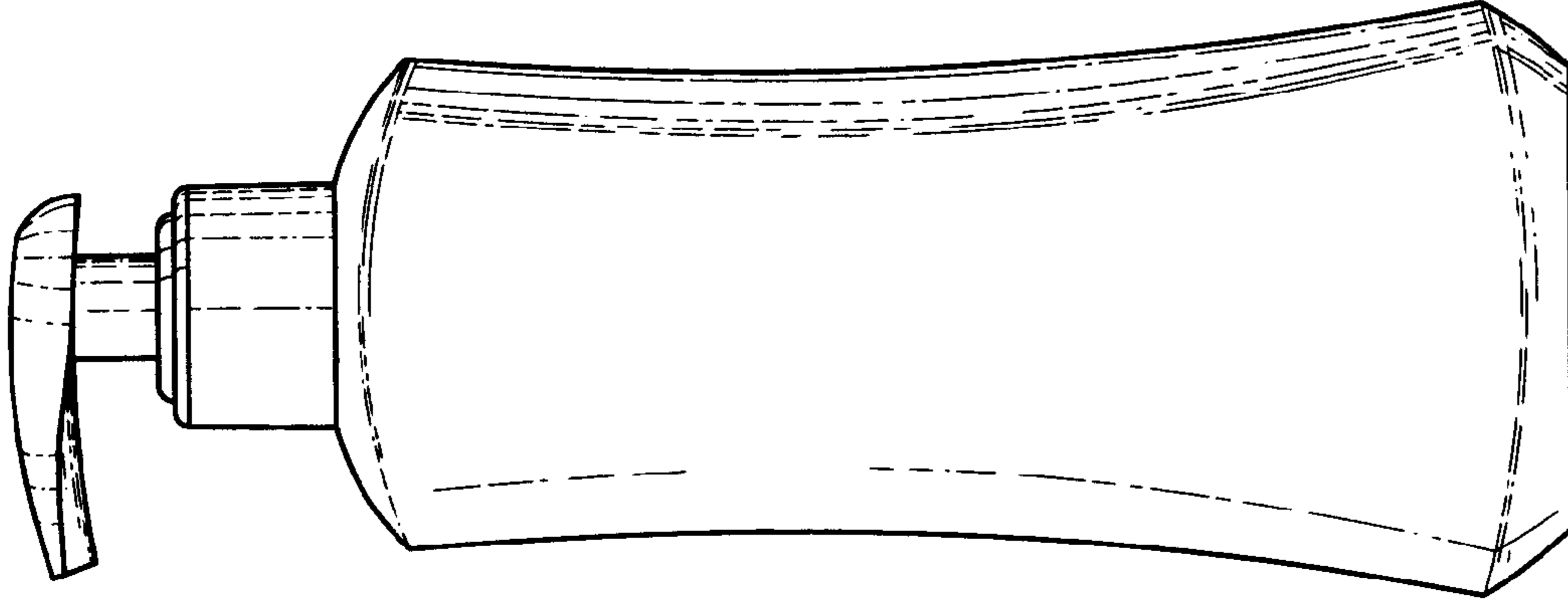

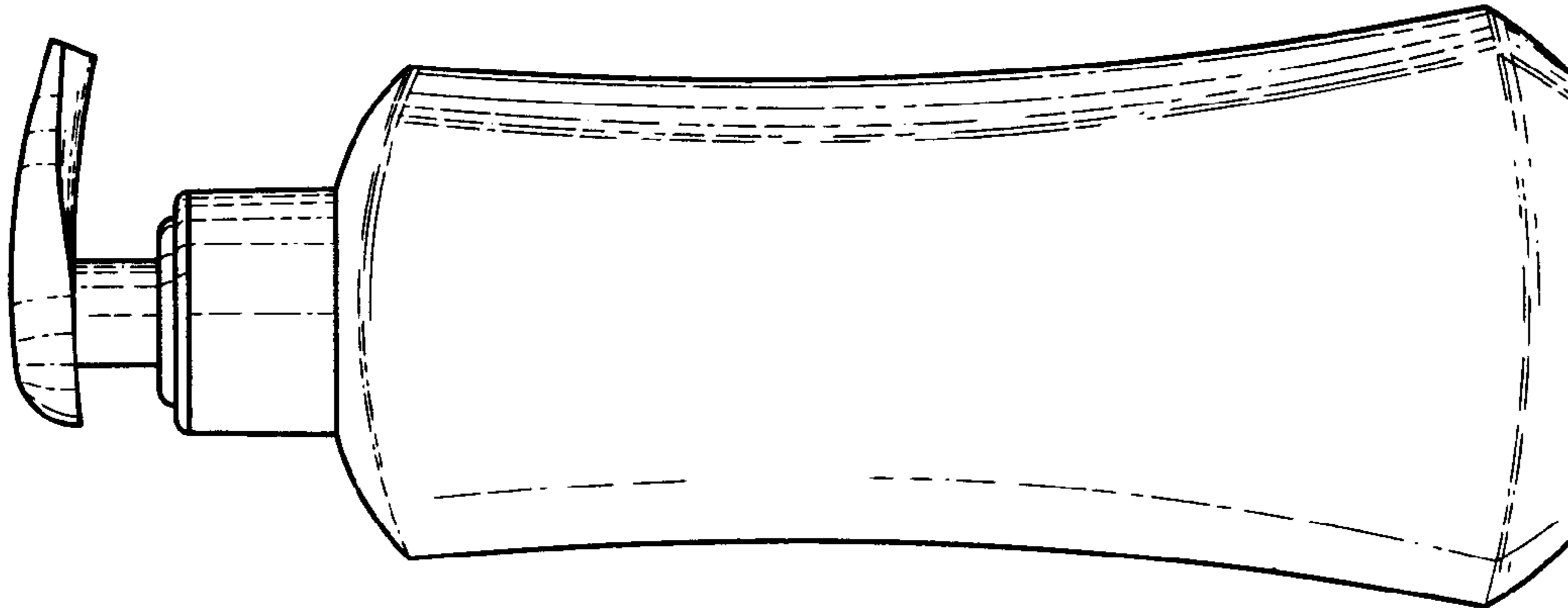

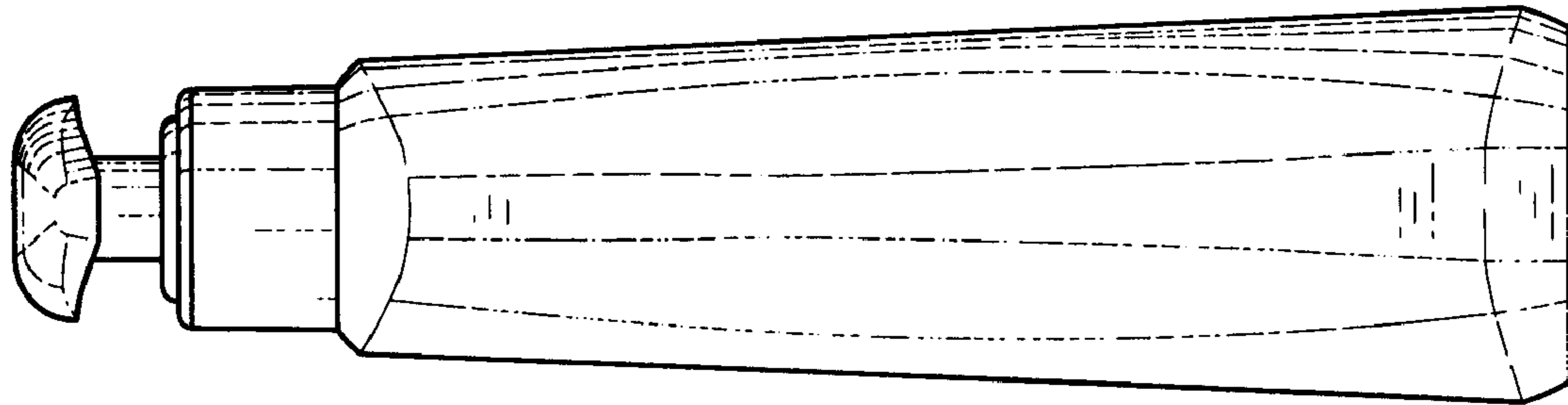

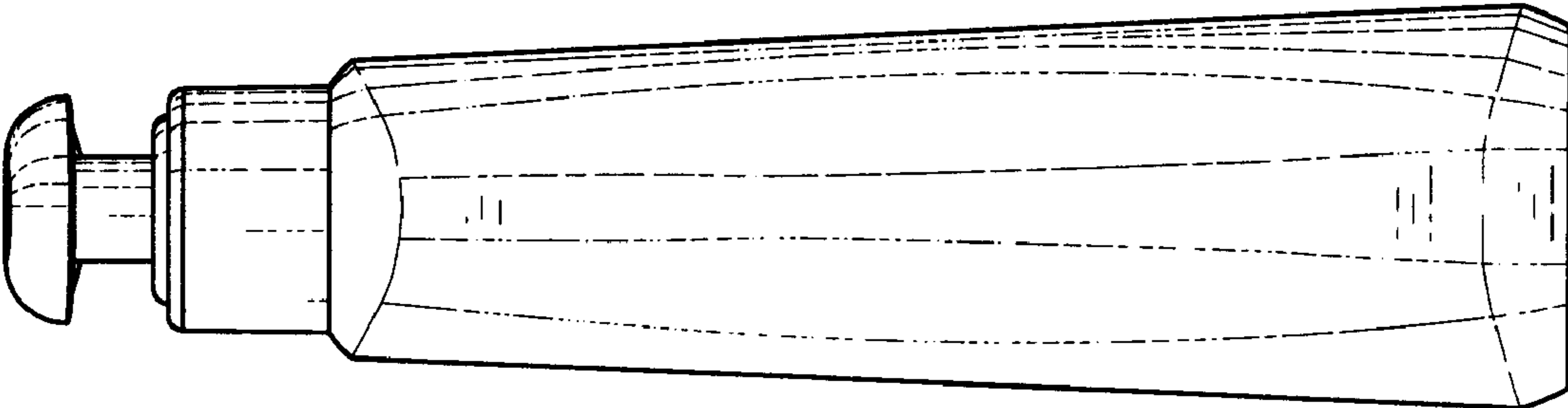

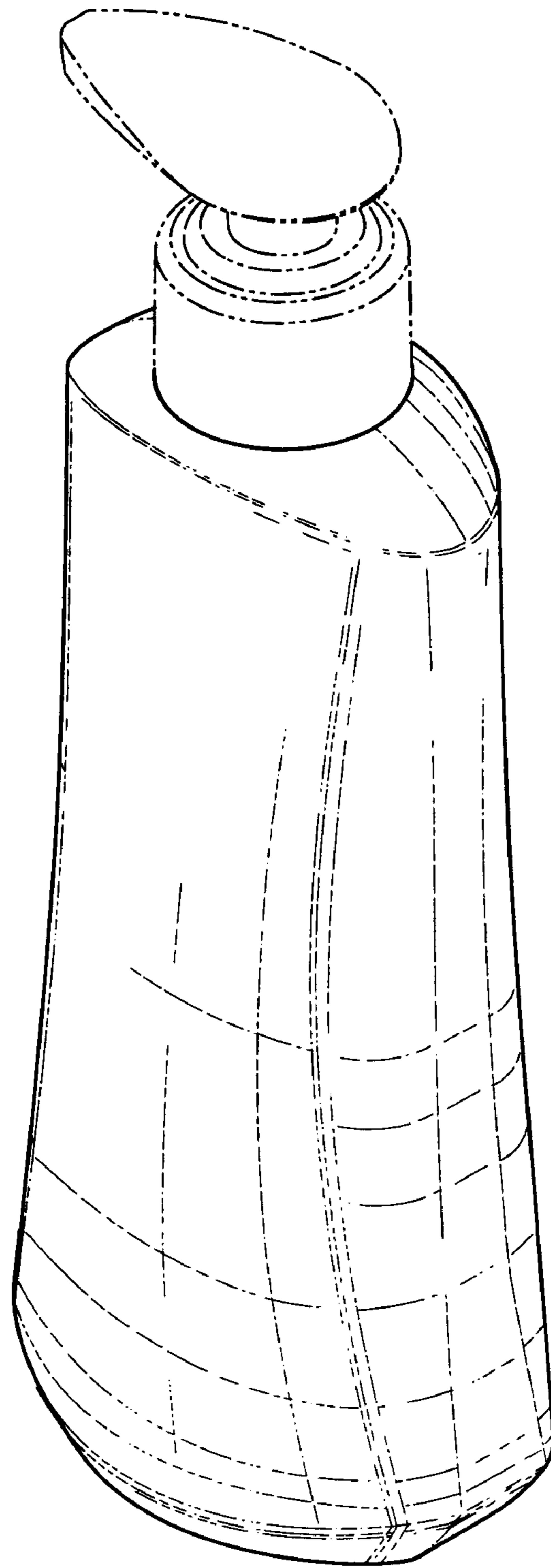

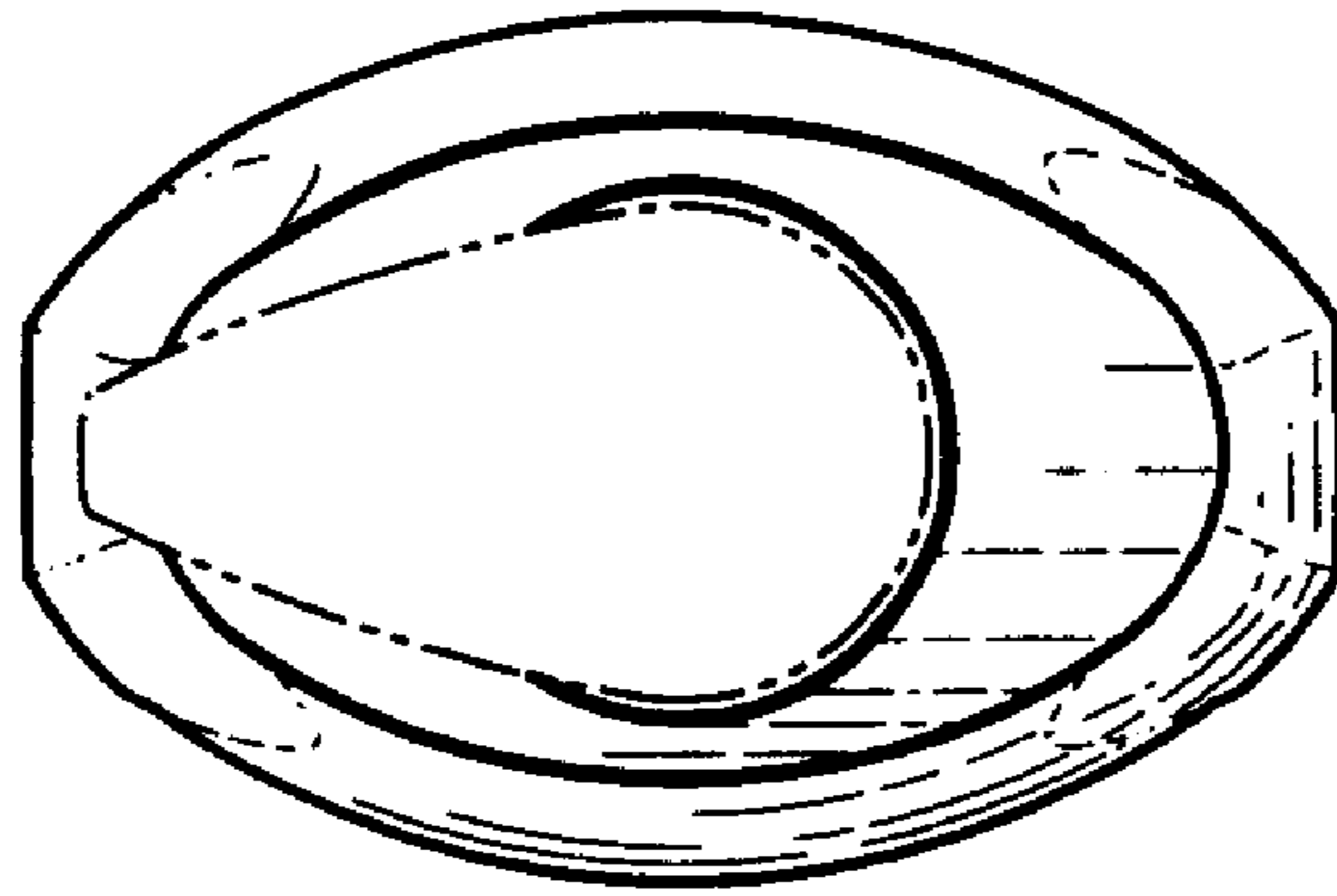

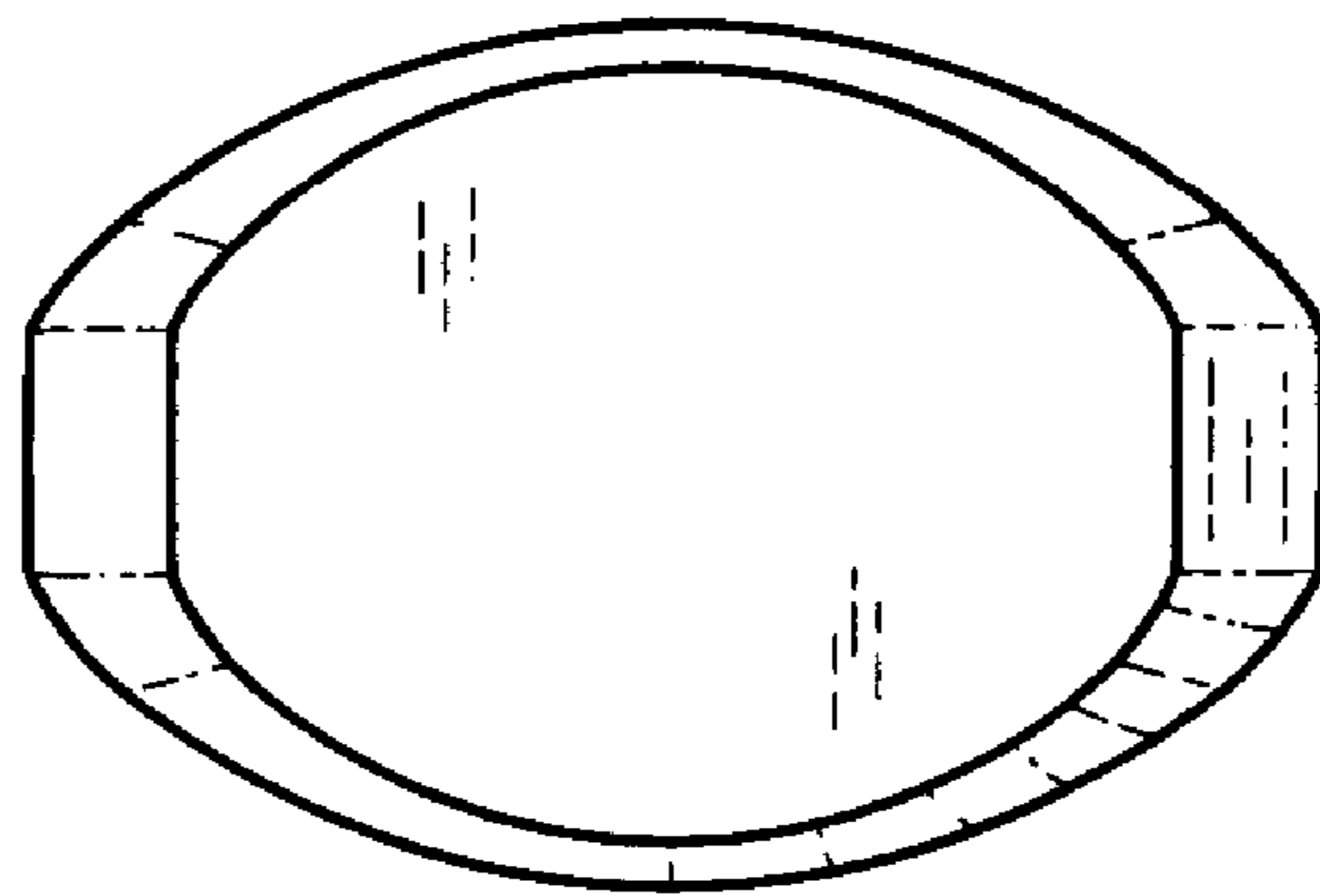

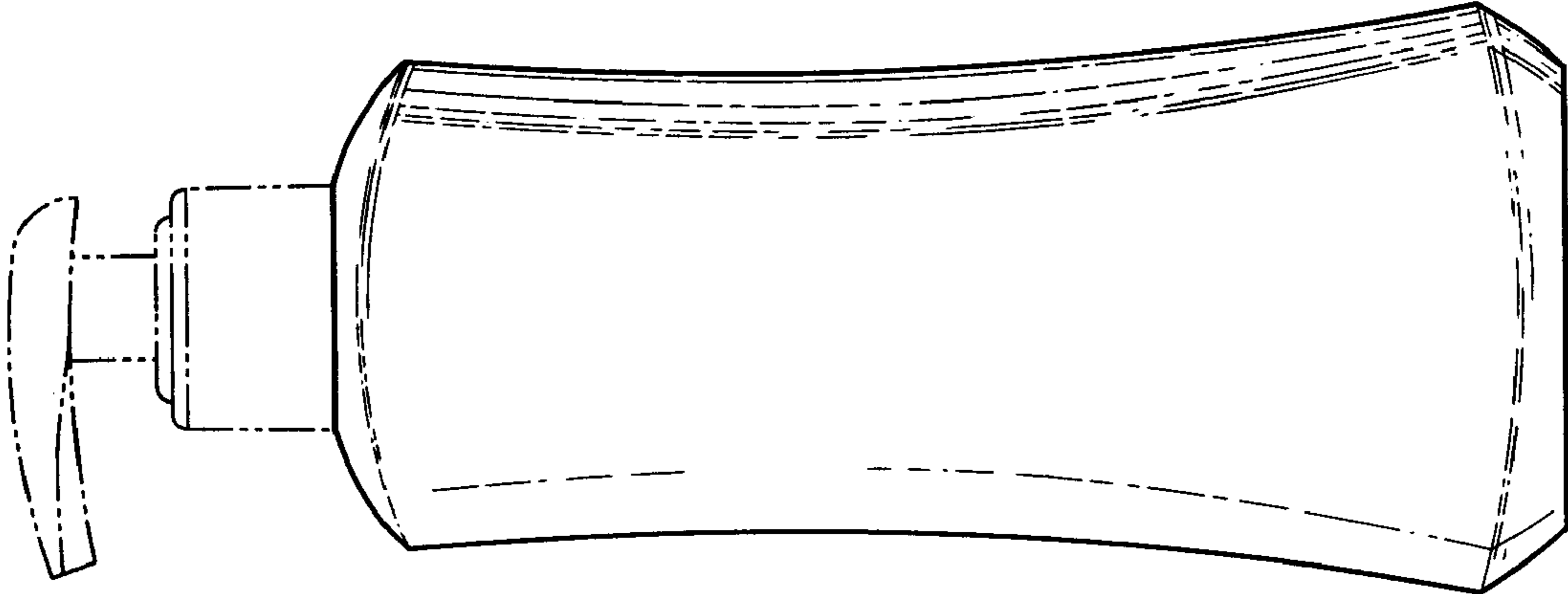
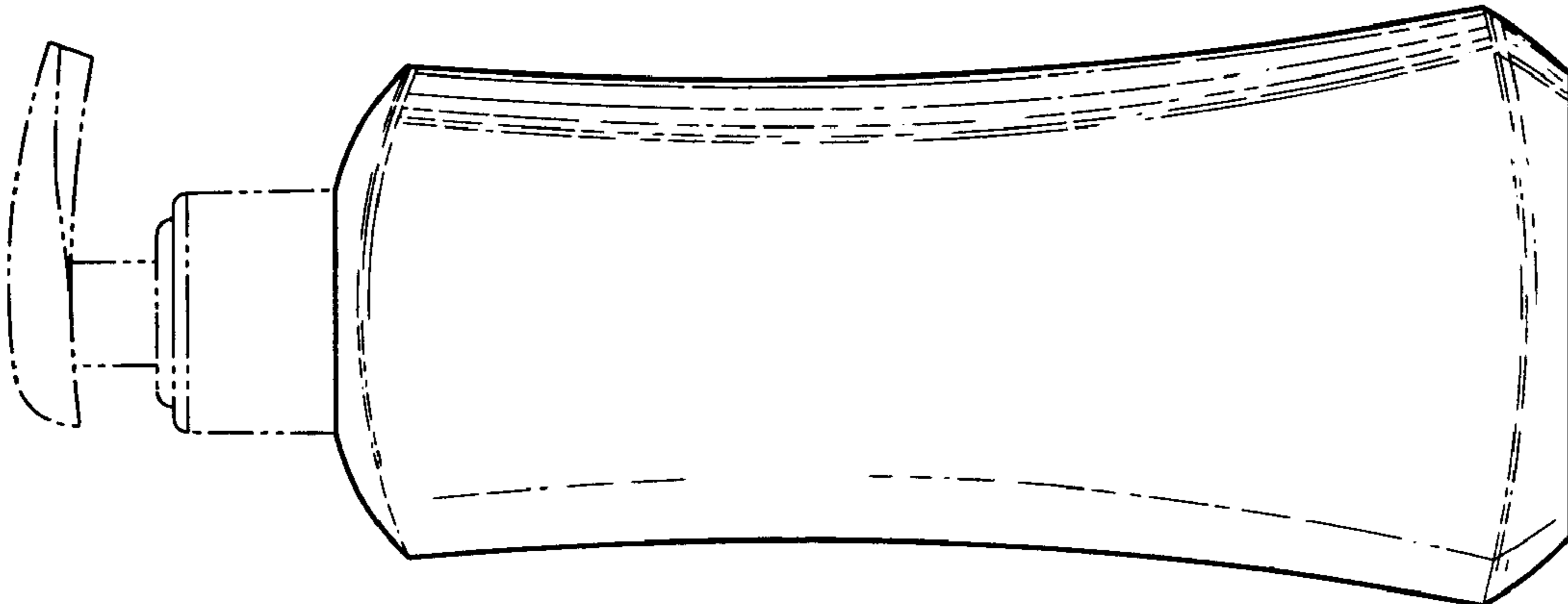

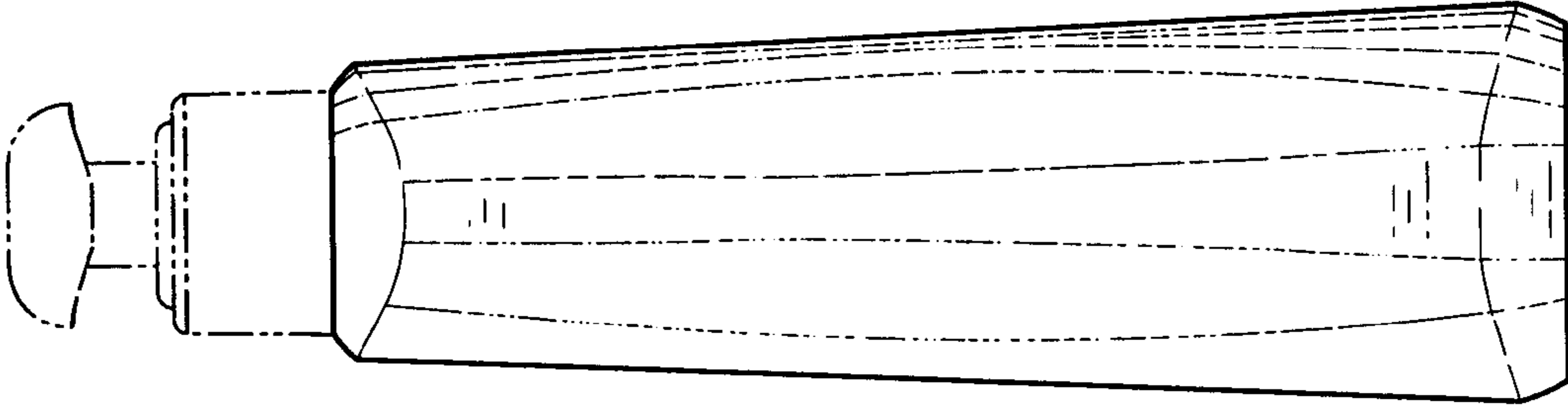
