(57) **CLAIM**

The ornamental design for a beverage container-shaped propel/repel applicator, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of the beverage container-shaped propel/repel applicator showing my new design;

FIG. 2 is a front elevational view of a second embodiment of FIG. 2;

FIG. 3 is a top plan view of FIG. 1 and FIG. 2;

FIG. 4 is a bottom plan view of FIG. 1 and FIG. 2;

FIG. 5 is a perspective view of FIG. 1;

FIG. 6 is a perspective view of FIG. 2;

FIG. 7 is an exploded bottom perspective view of FIG. 1; and,

FIG. 8 is exploded top perspective view of FIG. 1.

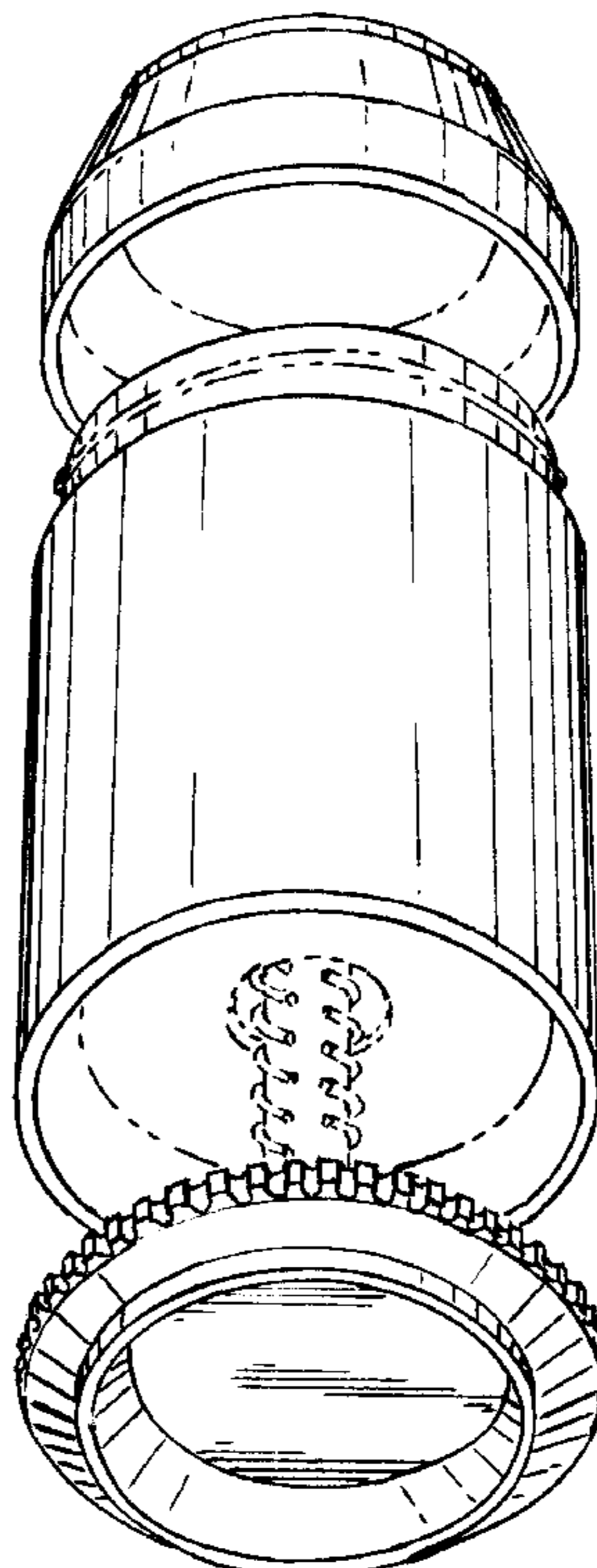
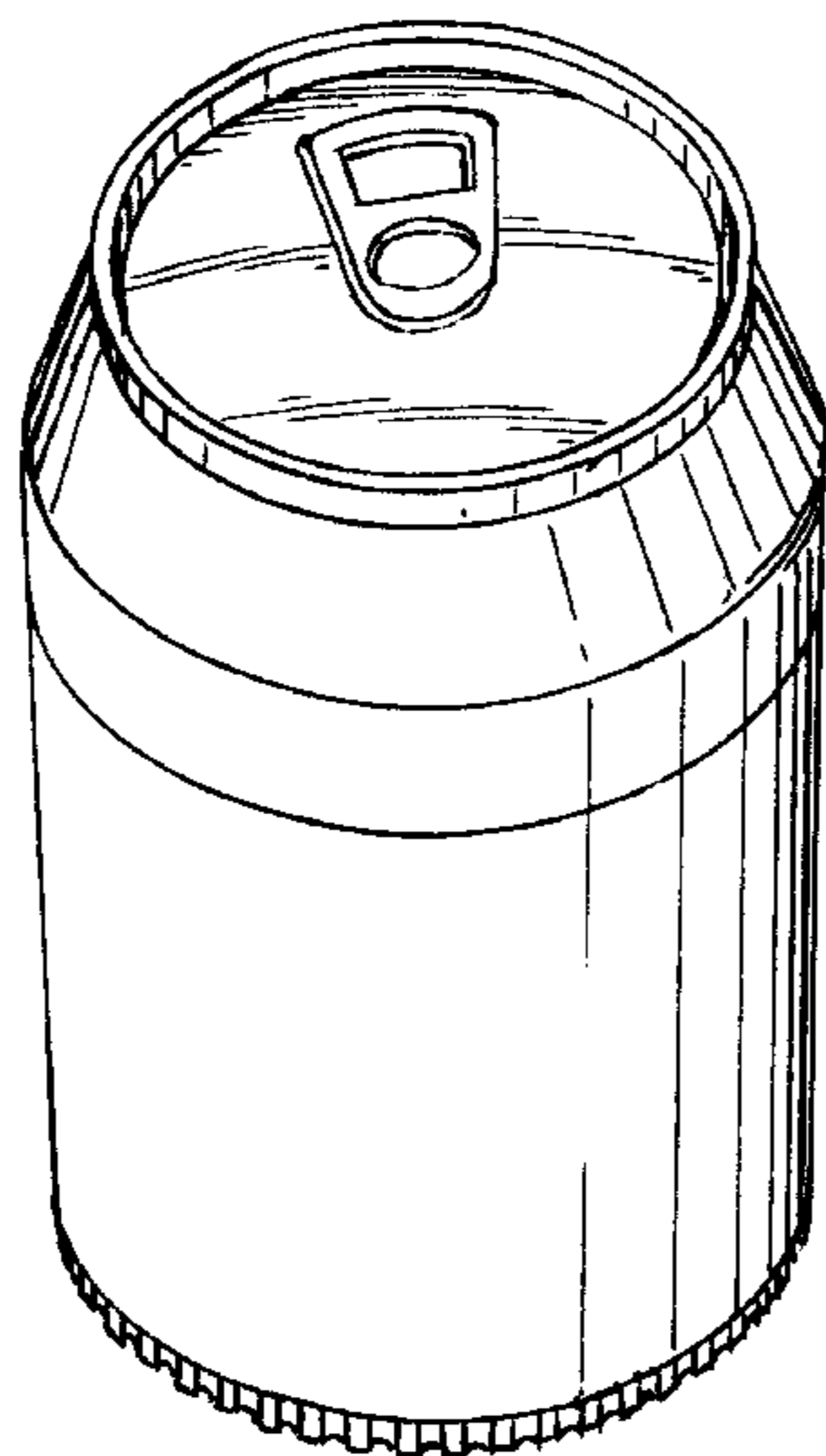

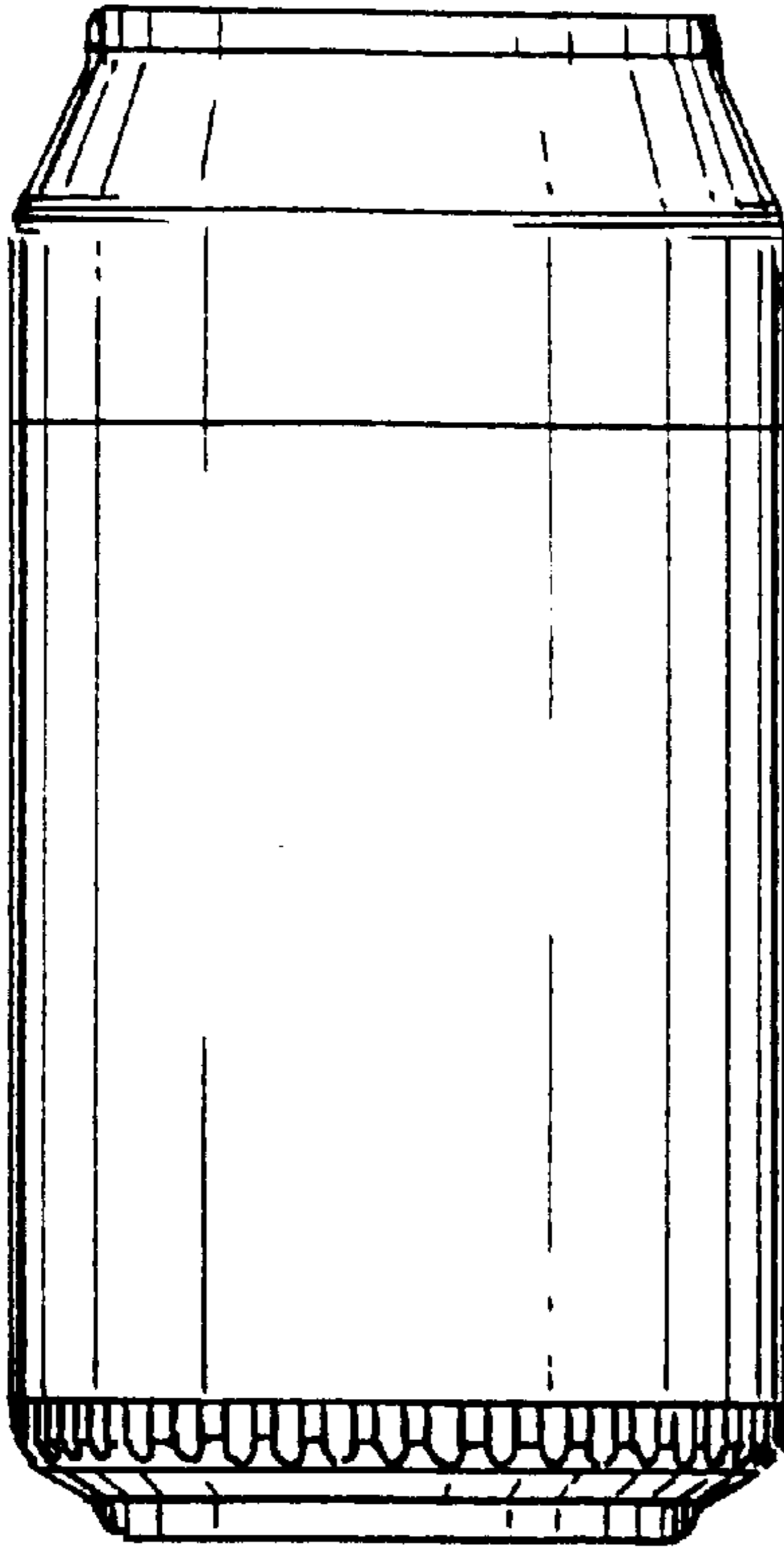

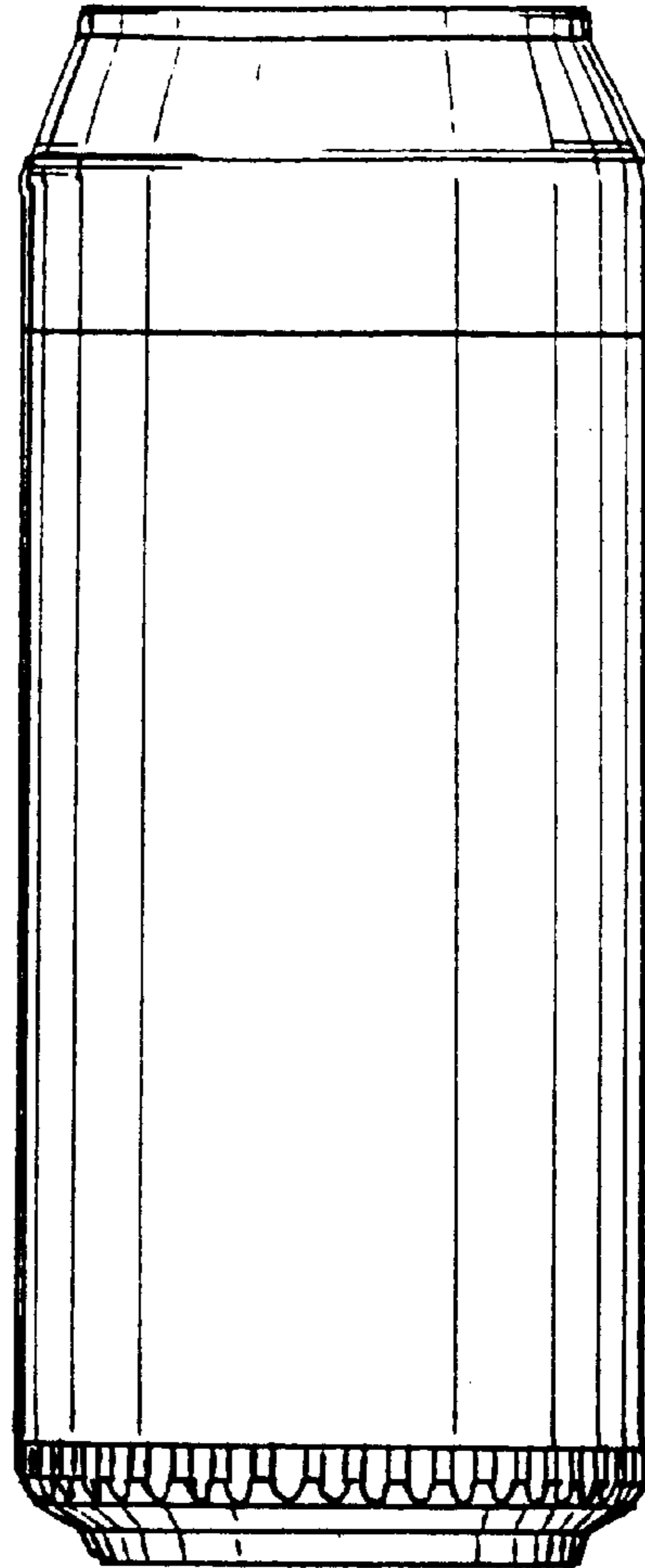

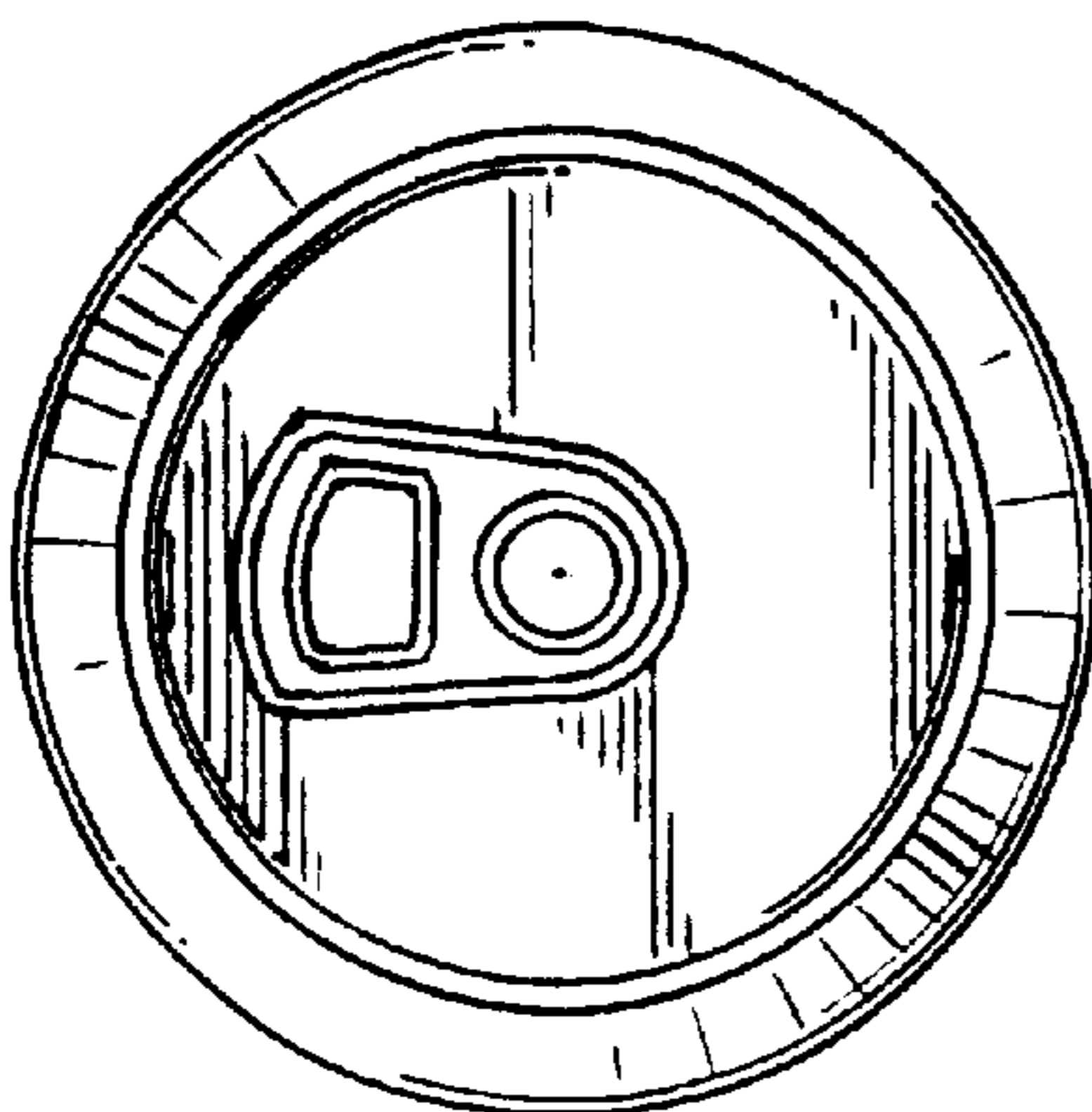

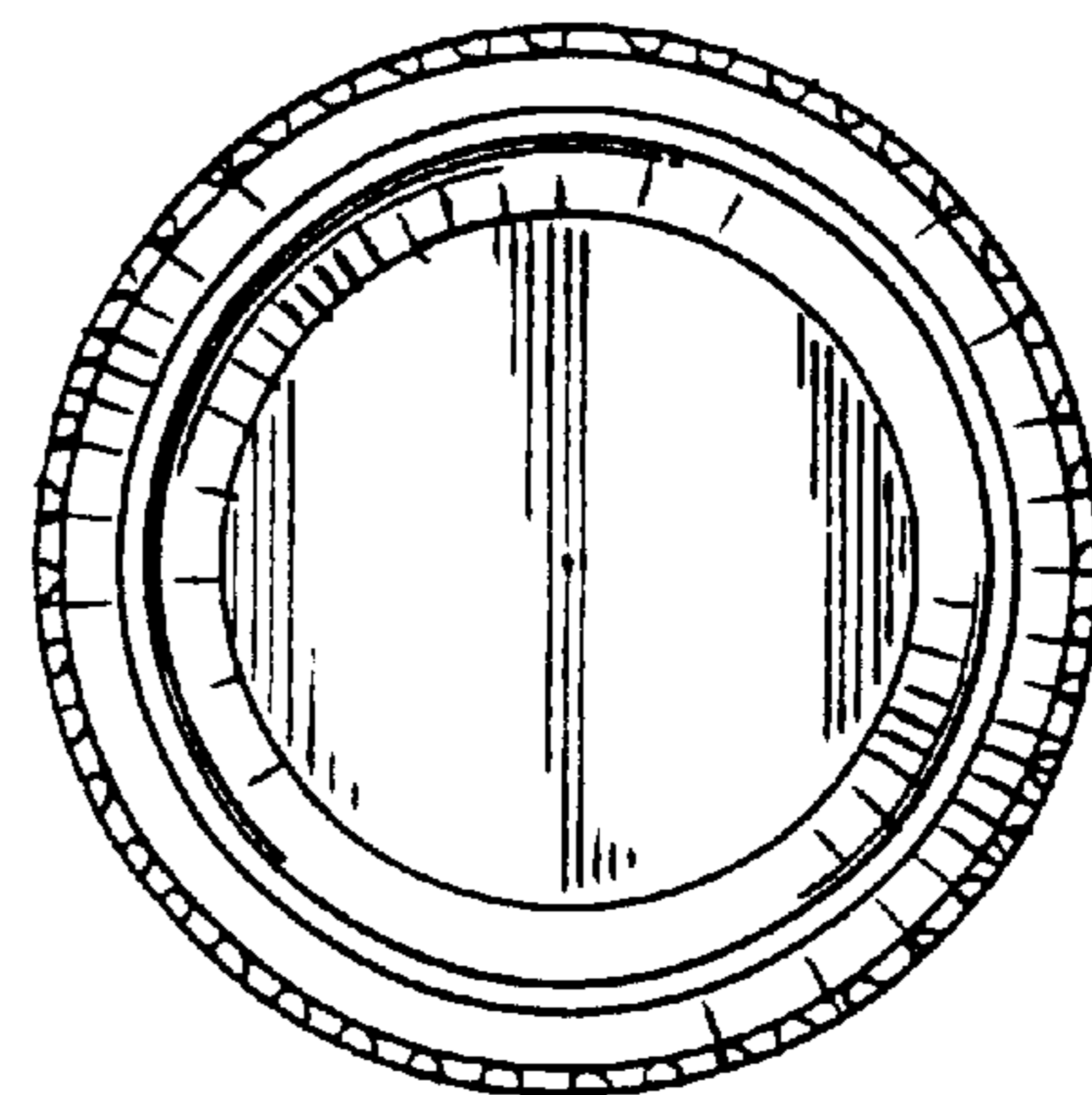

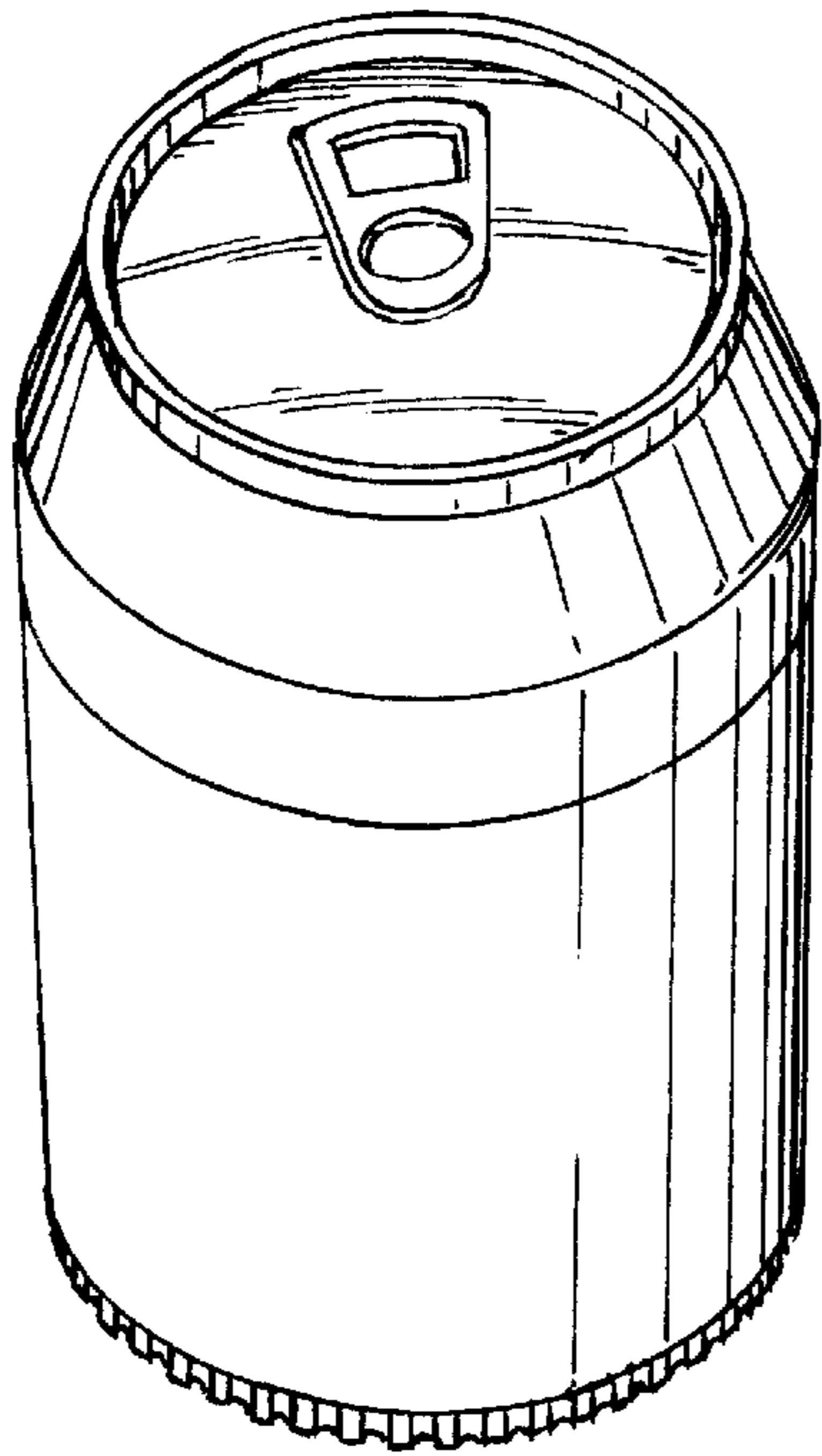

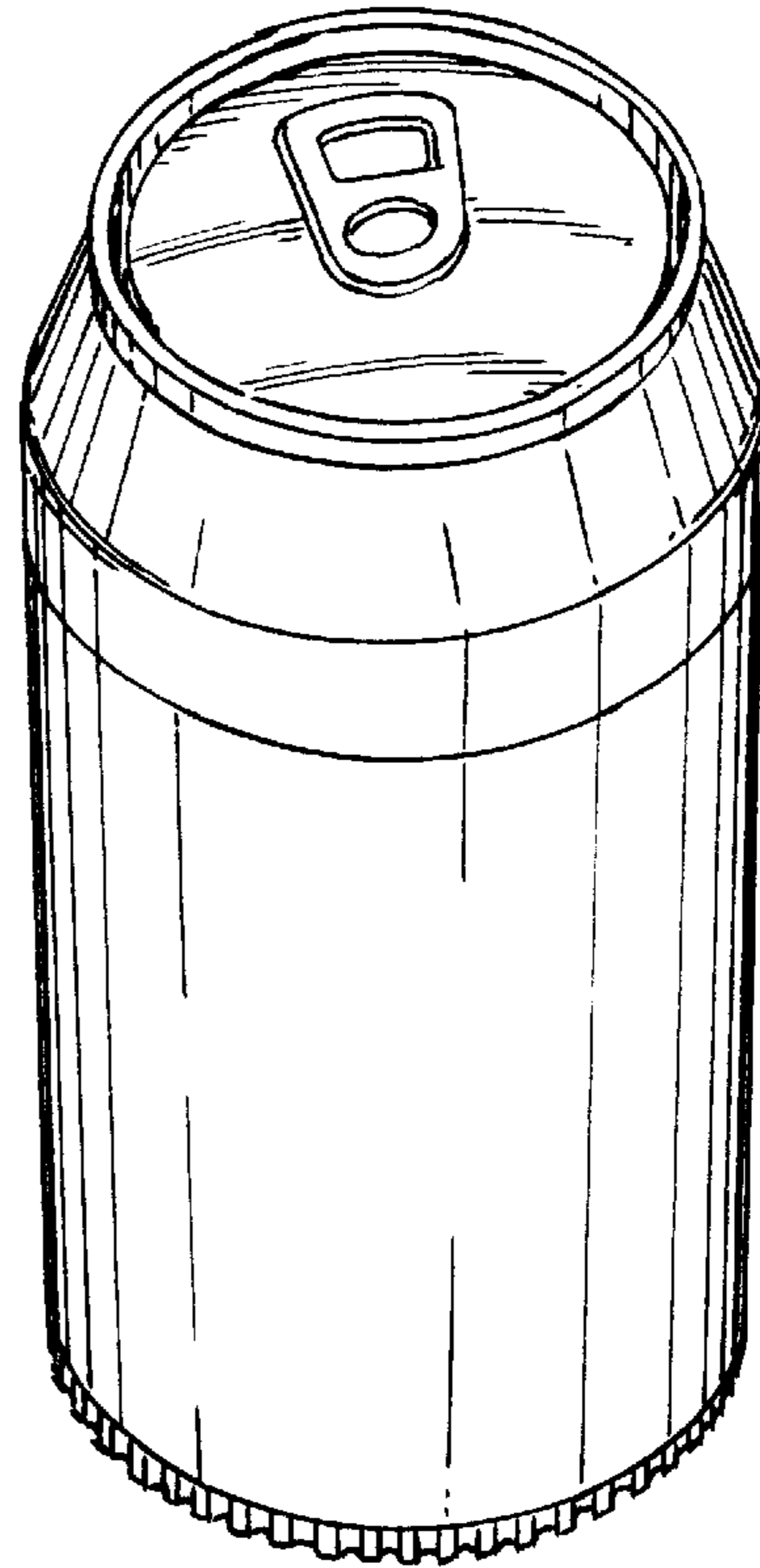

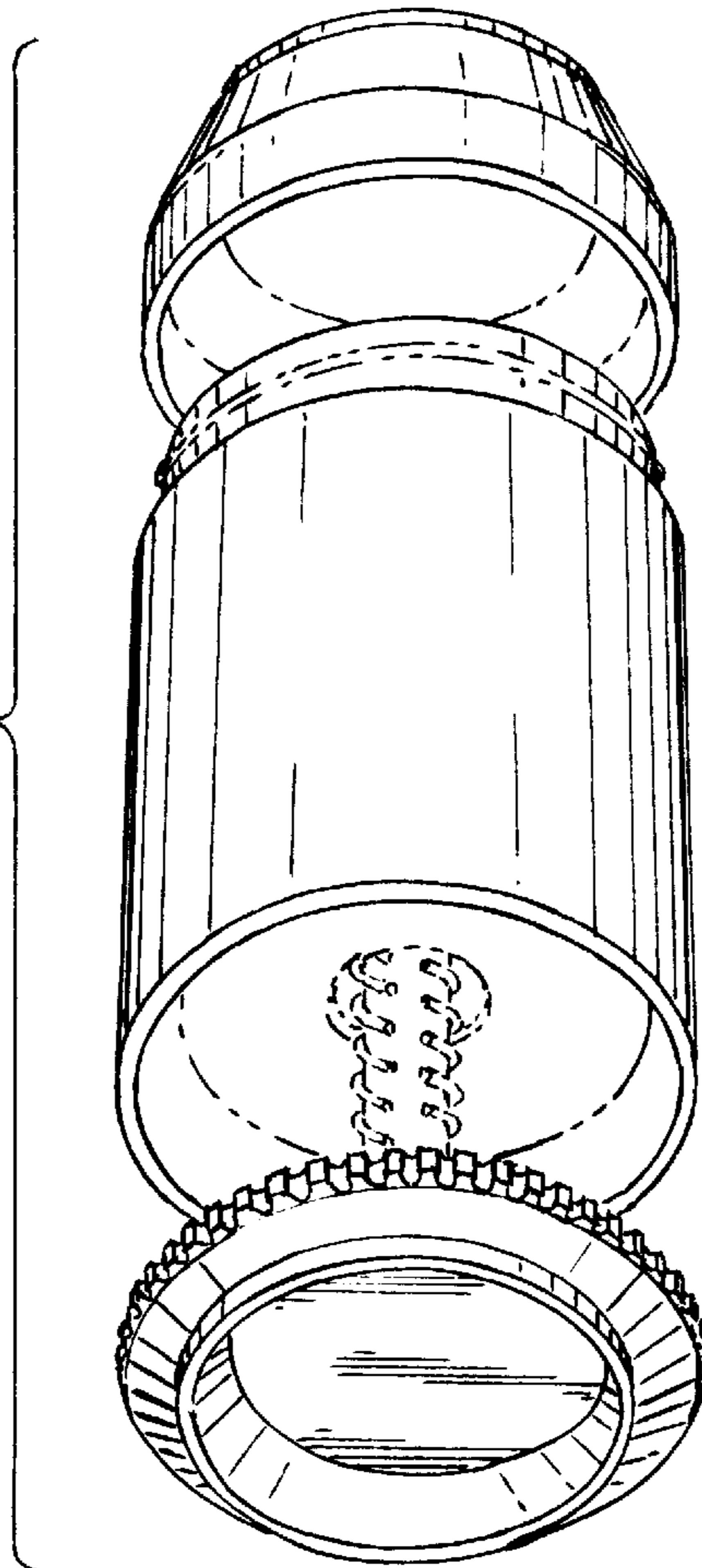
