(57) **CLAIM**

The ornamental design for a camper body, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevation view of our new design for a camper body.

FIG. 2 is a left side elevation view of the camper body shown in FIG. 1.

FIG. 3 is a front elevation view of the camper body shown in FIG. 1, wherein the dotted lines show an outline of the interior of the camper body which is for illustrative purposes only and is not part of the claimed design.

FIG. 4 is a rear elevation view of the camper body shown in FIG. 1.

FIG. 5 is a top plan view of the camper body shown in FIG. 1.

FIG. 6 is a bottom plan view of the camper body shown in FIG. 1.

FIG. 7 is a right side elevation view of the camper body shown in FIG. 1 illustrating the camper body mounted on a truck, shown in dotted lines, which is for illustrative purposes only and is not part of the claimed design.

FIG. 8 is a right side elevation view of a second embodiment our new design for a camper body.

FIG. 9 is a left side elevation view of the camper body shown in FIG. 8.

FIG. 10 is a front elevation view of the camper body shown in FIG. 8, wherein the dotted lines show an outline of the interior of the camper body which is for illustrative purposes only and is not part of the claimed design.

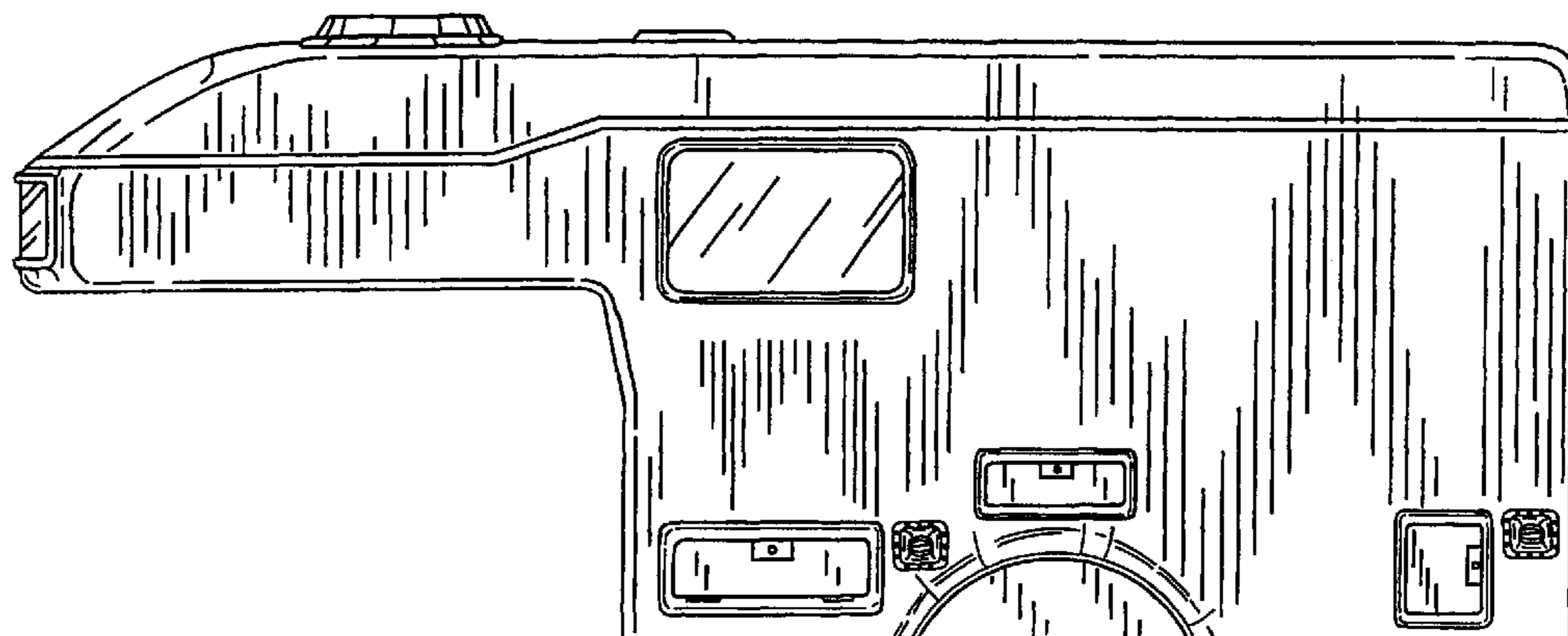
FIG. 11 is a rear elevation view of the camper body shown in FIG. 8.

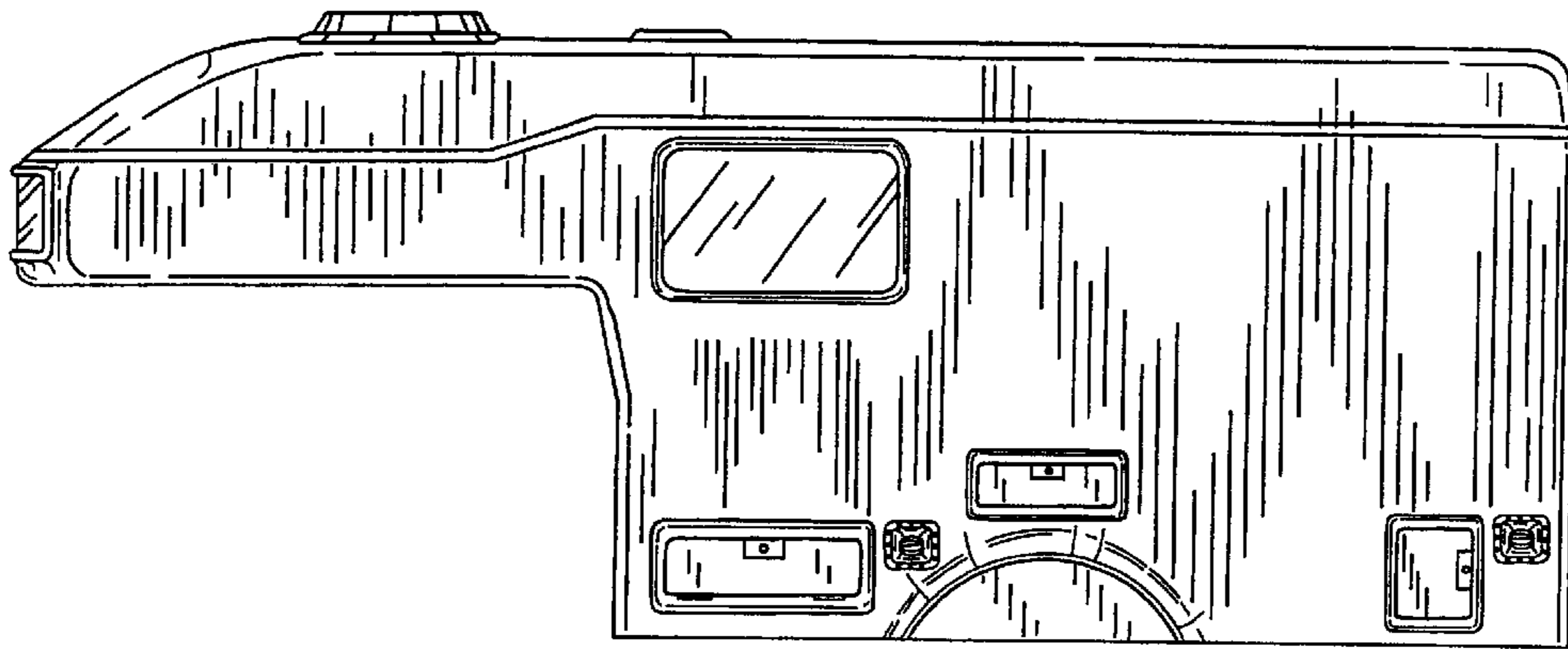

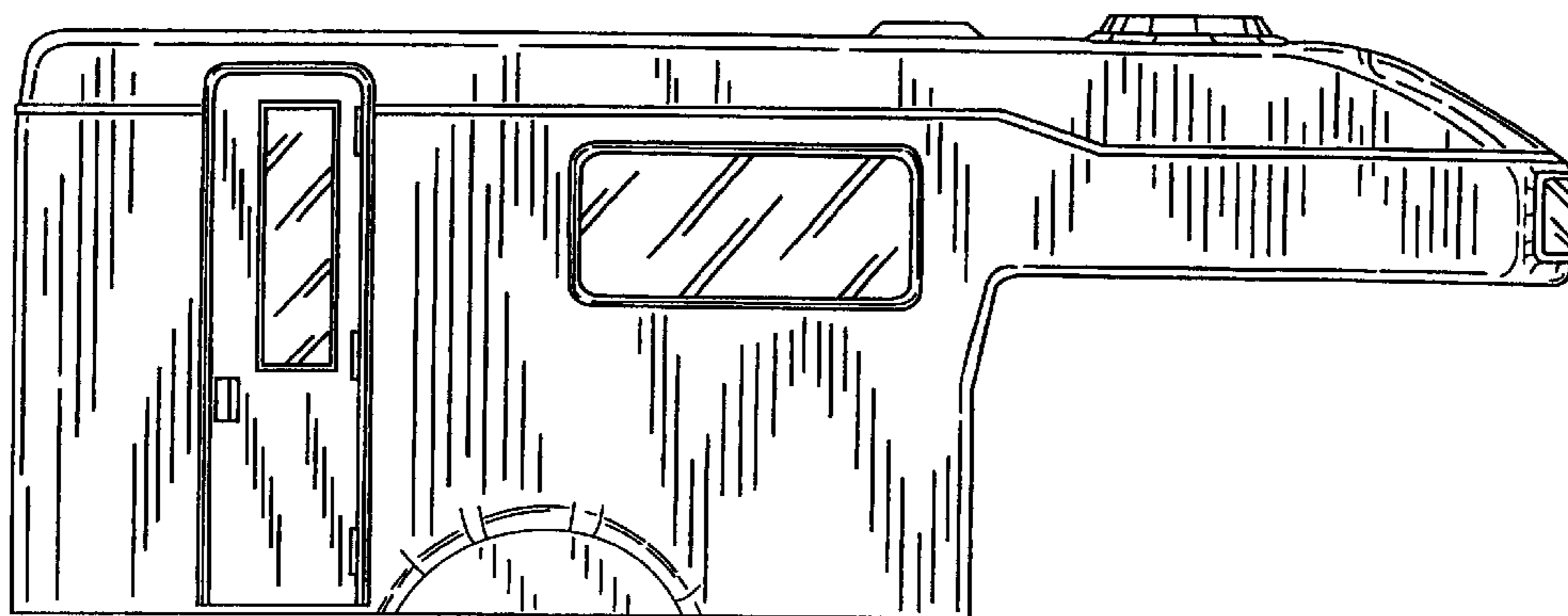

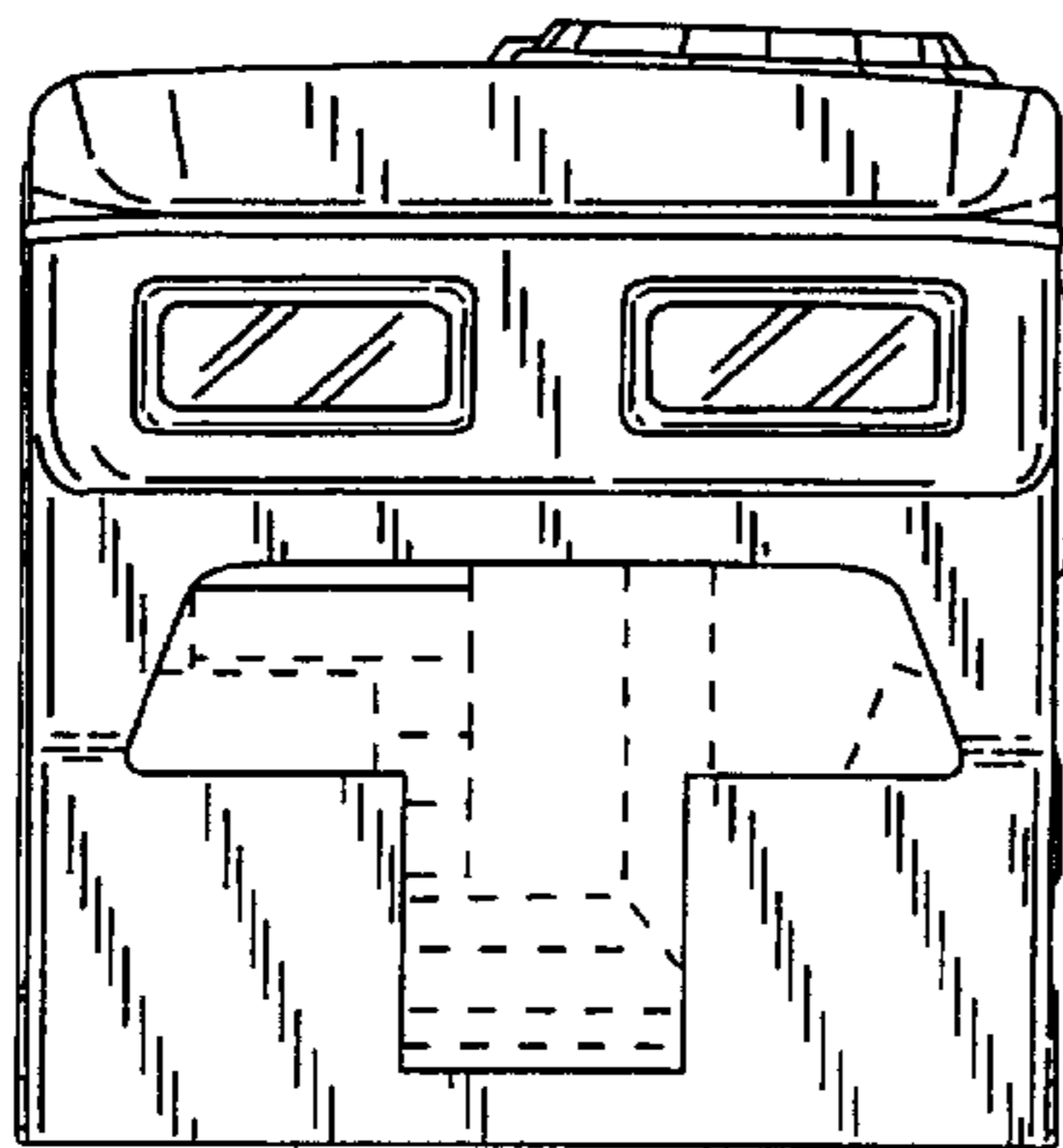

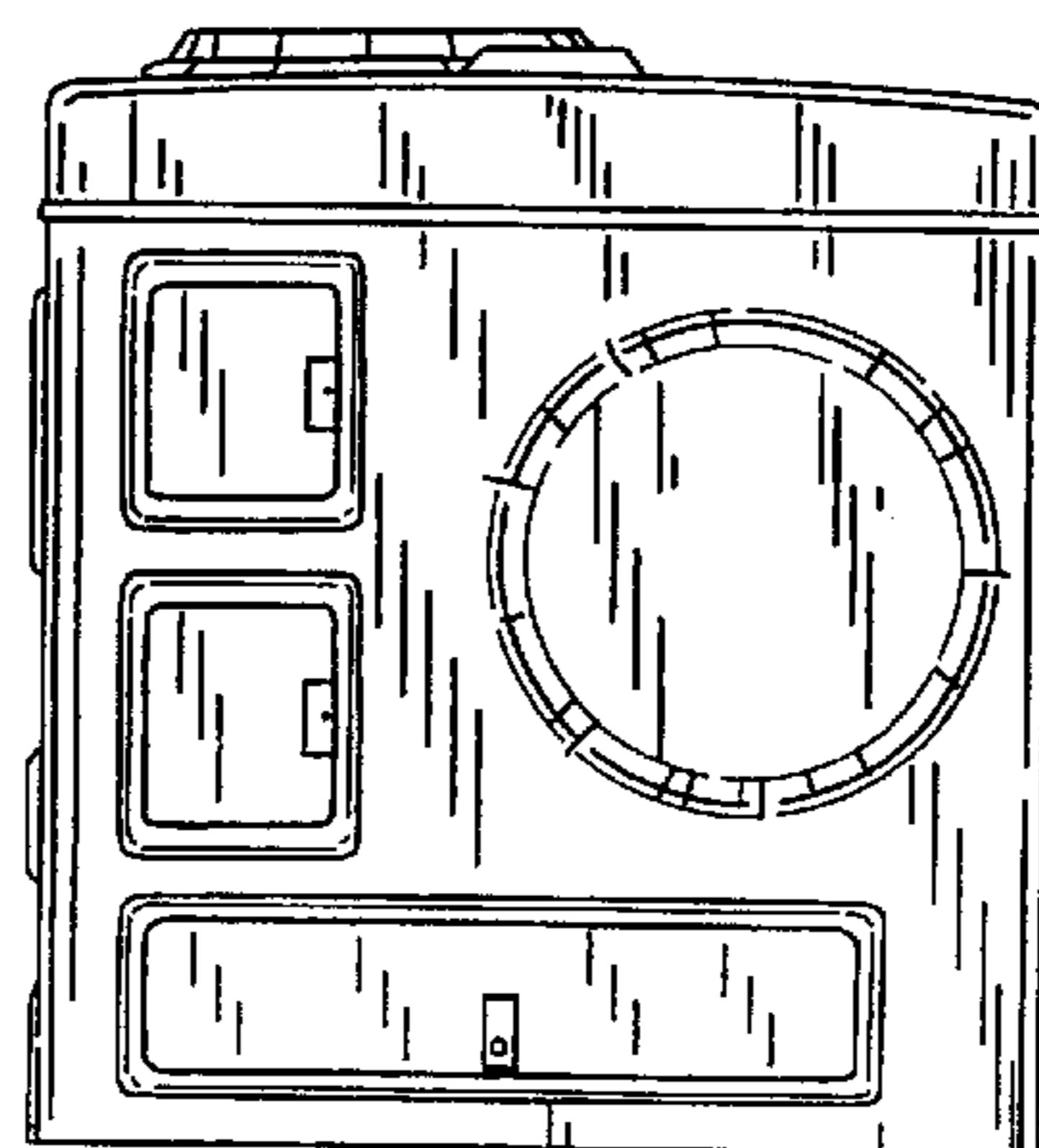

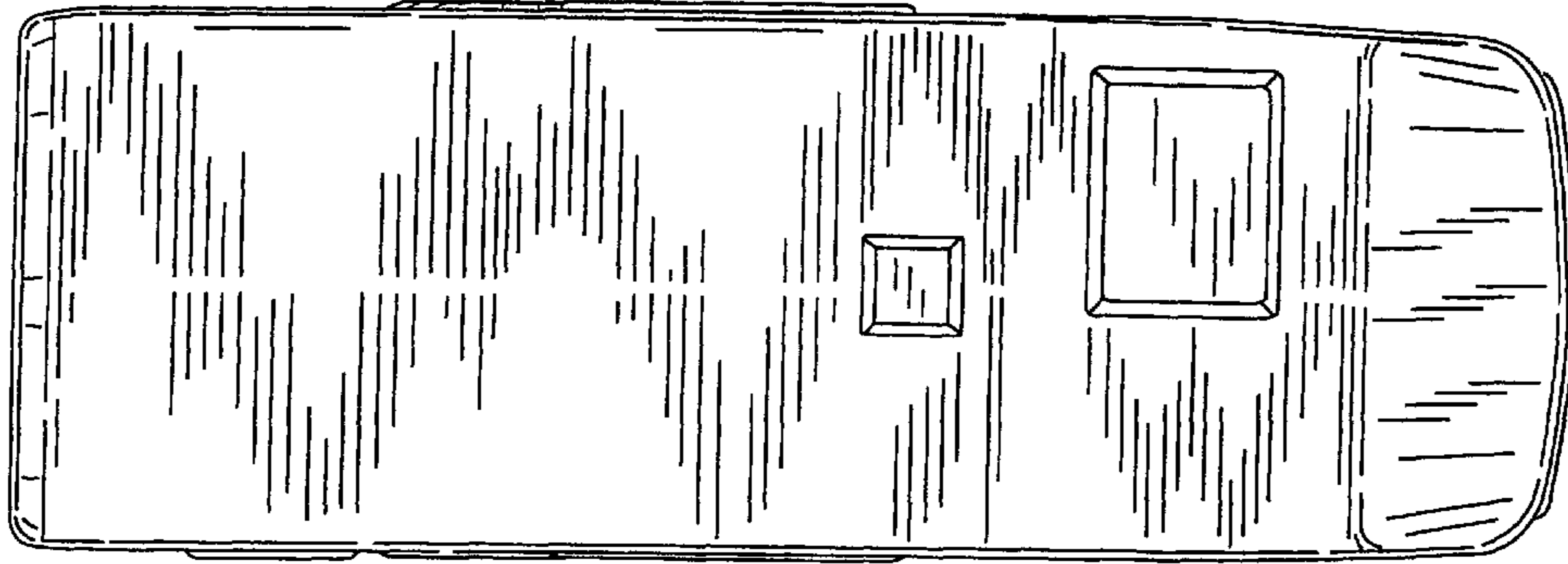

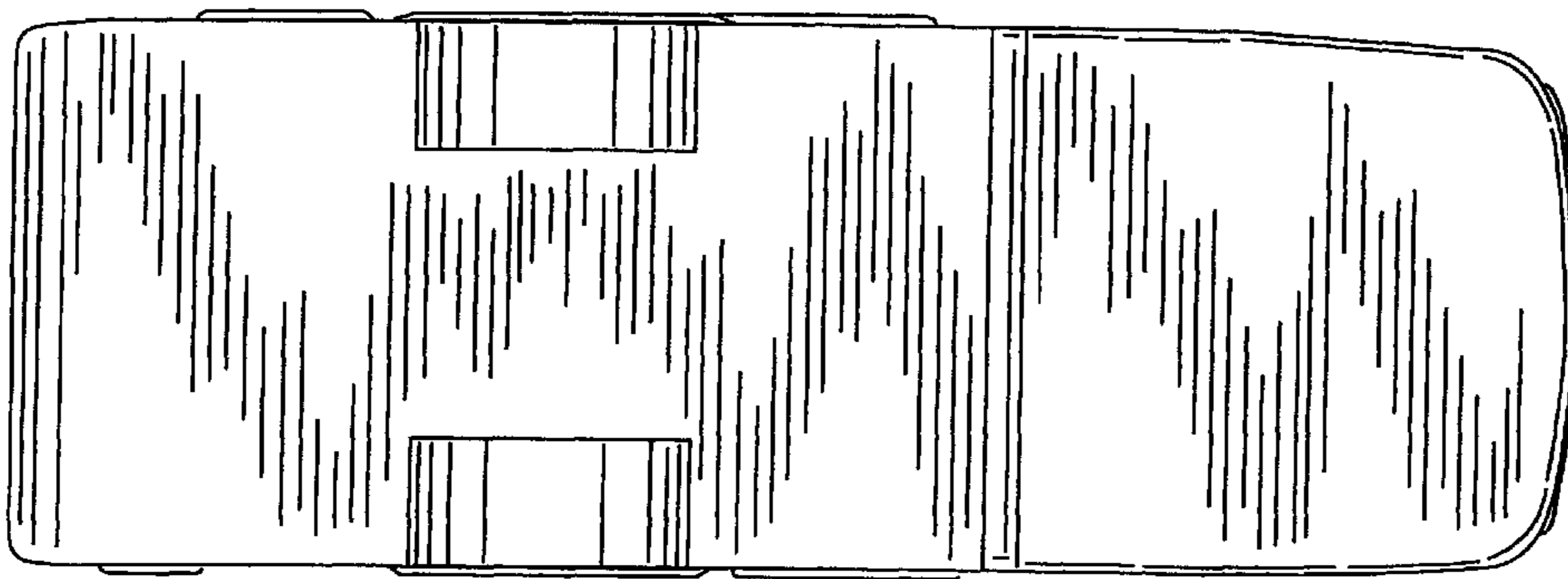

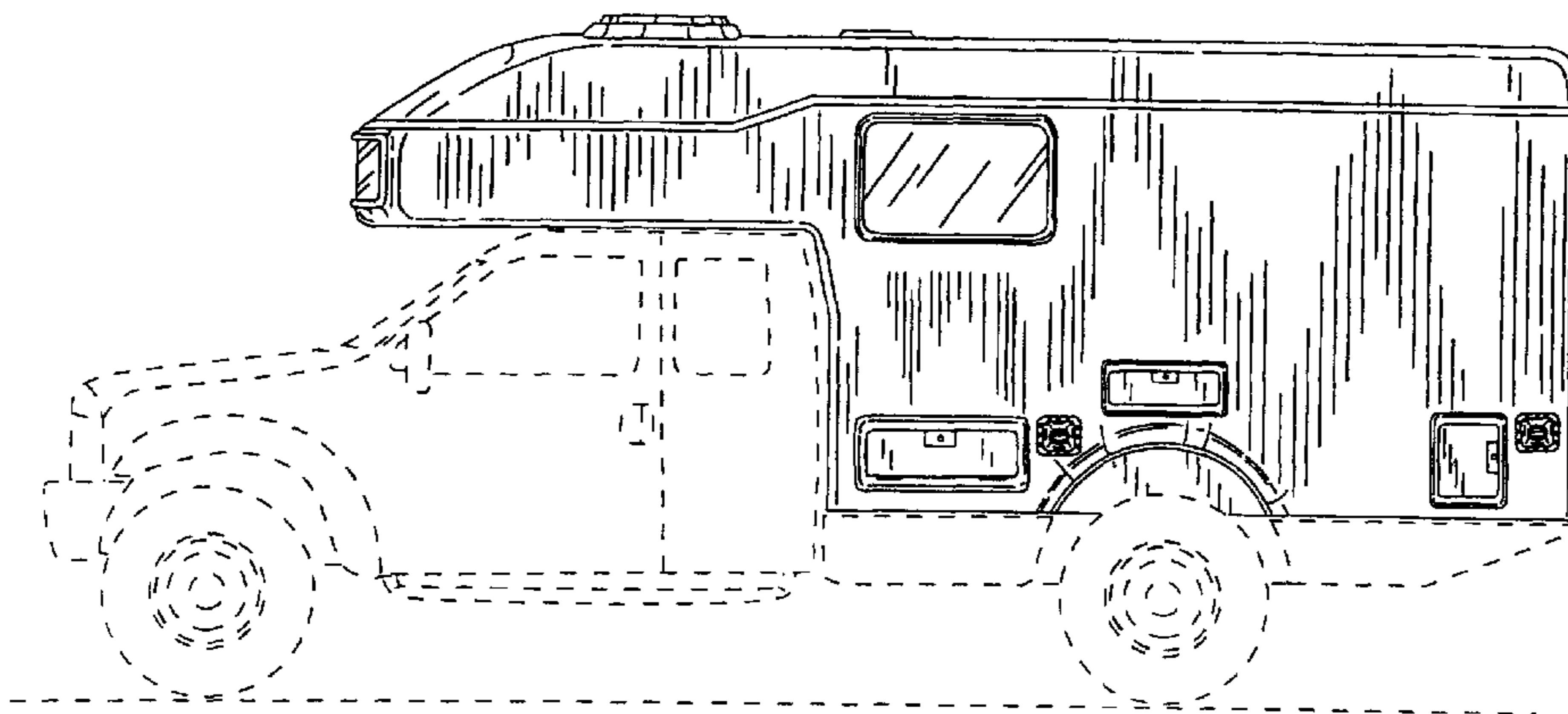

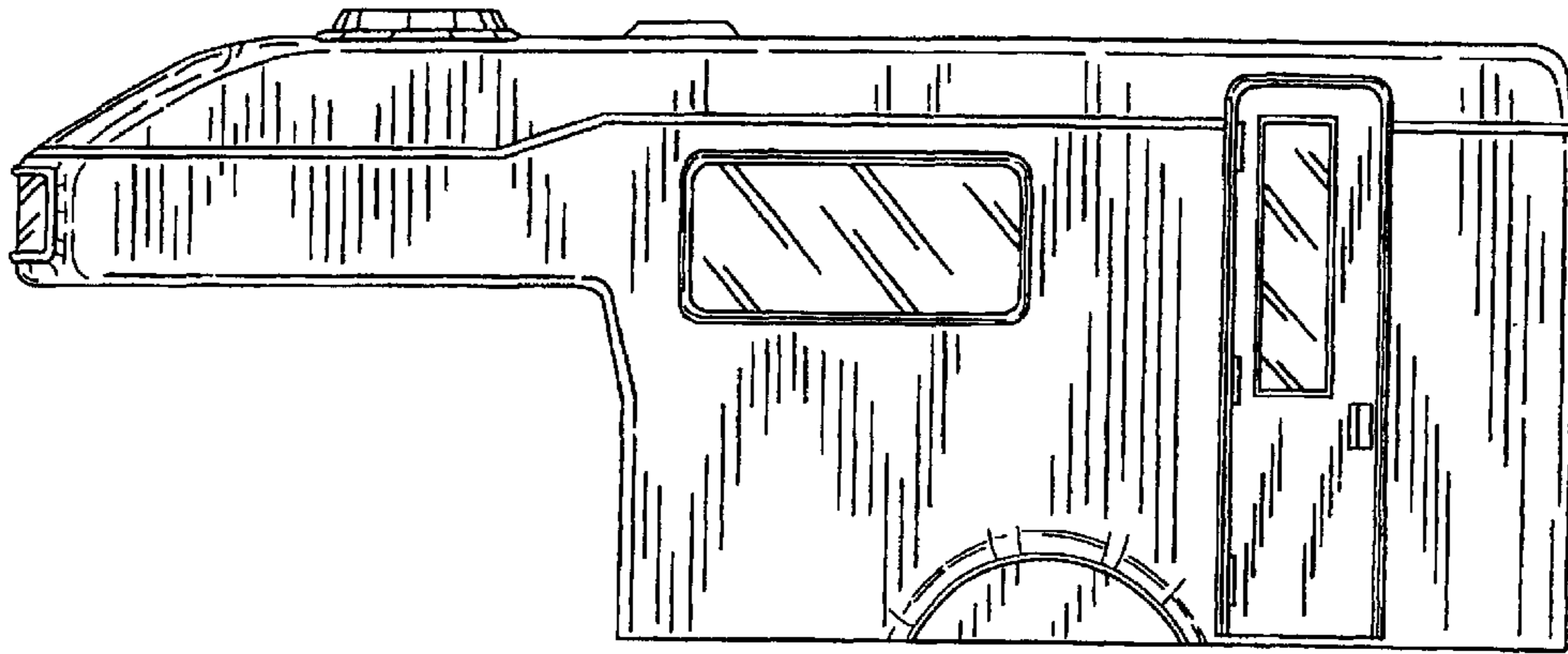

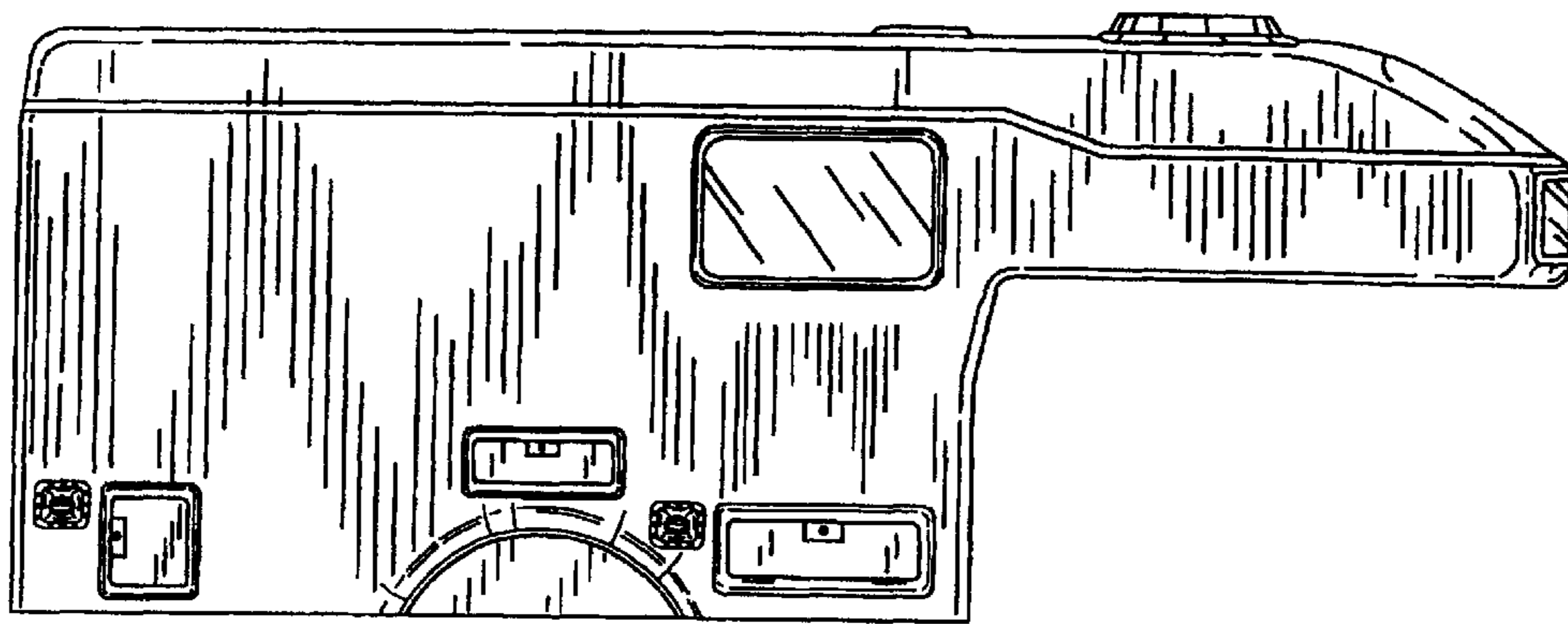

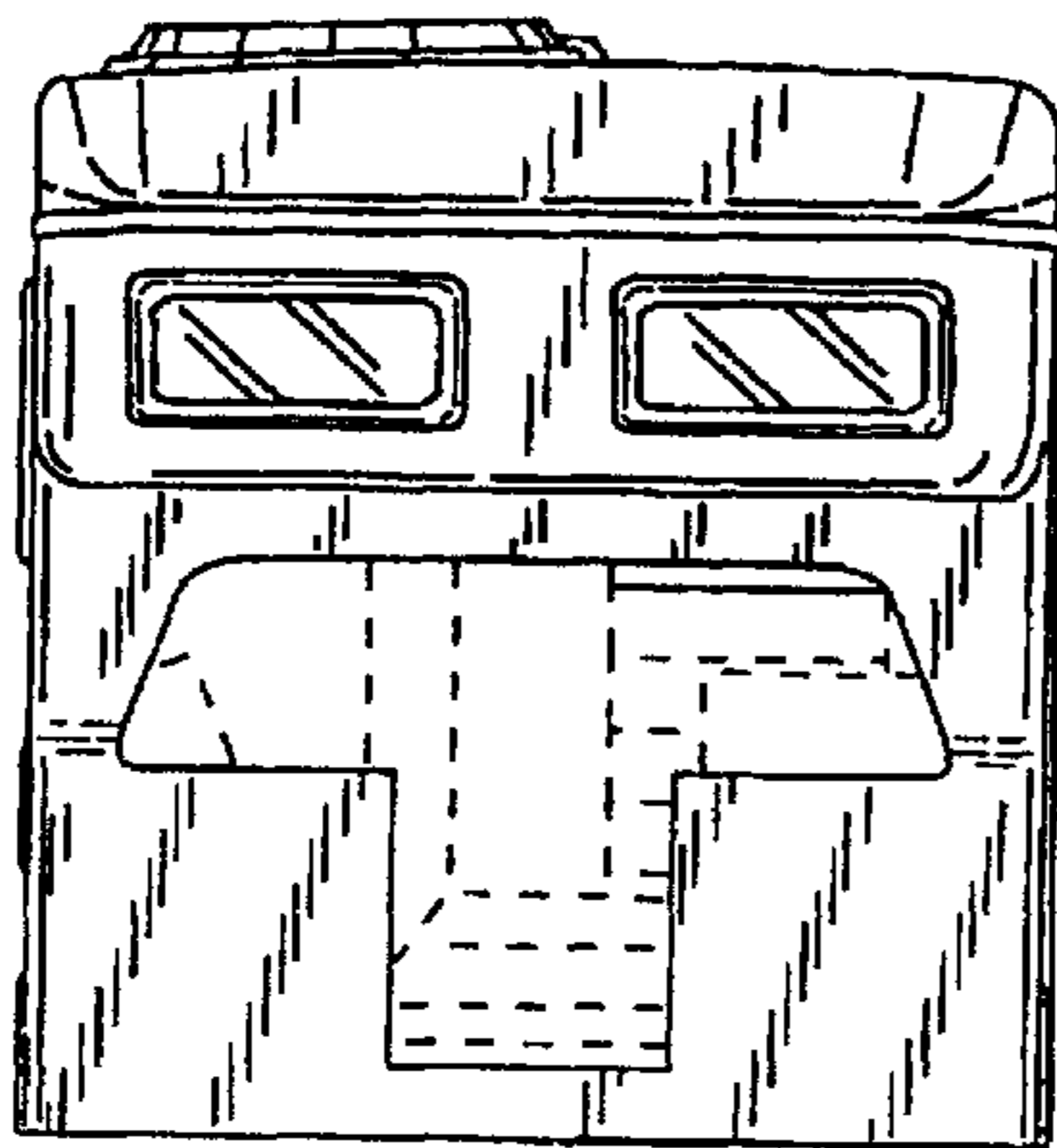

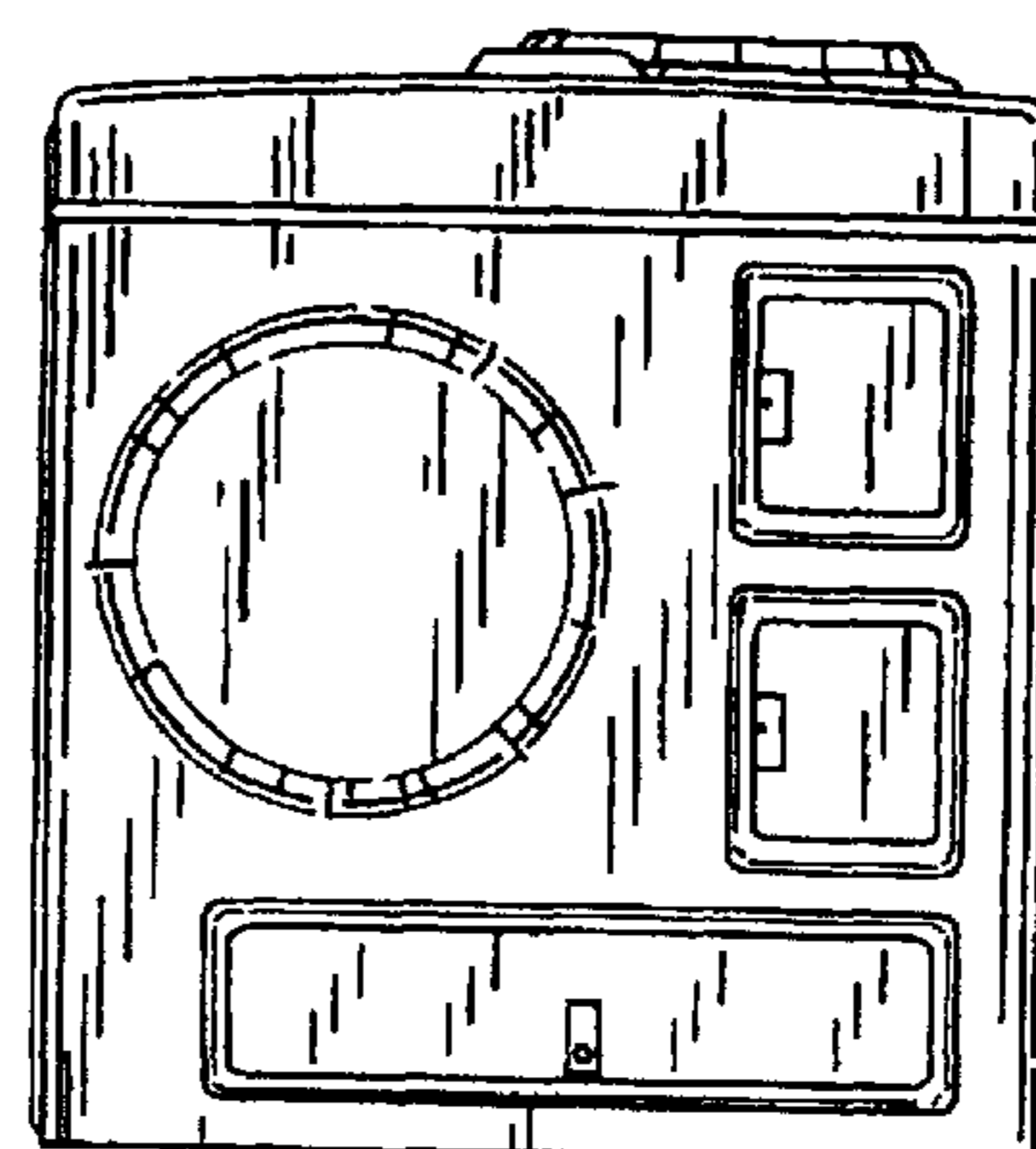

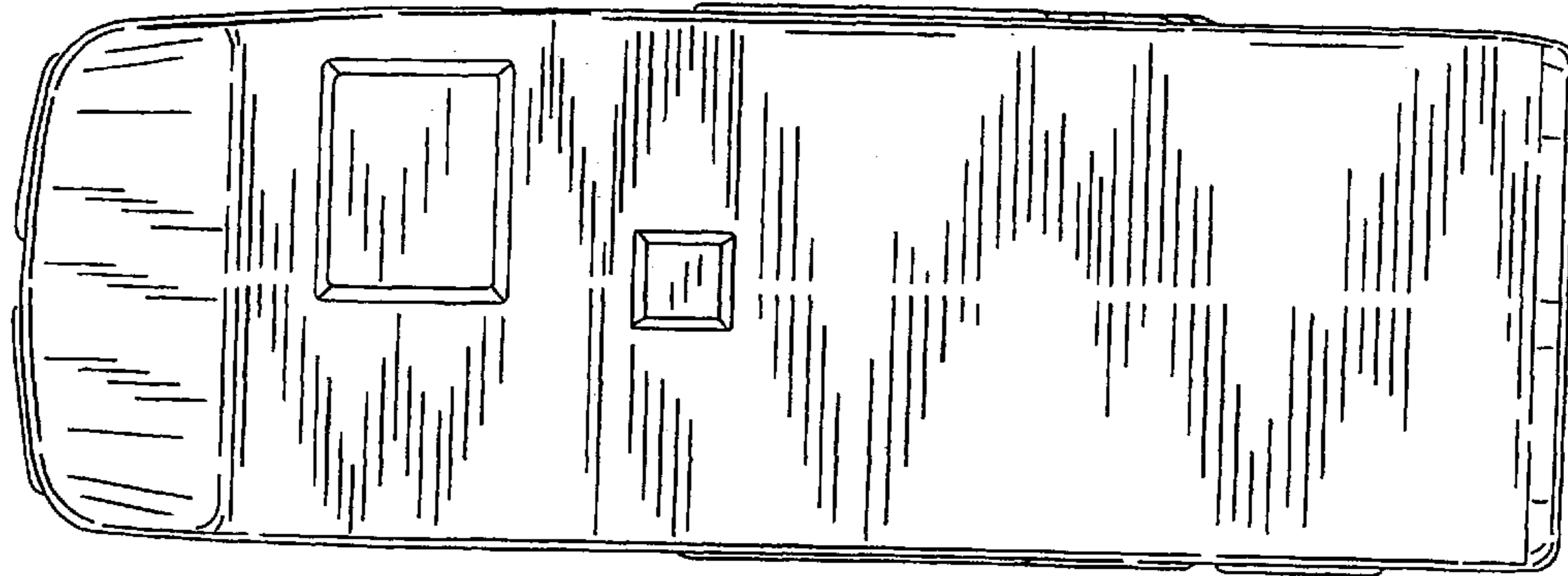

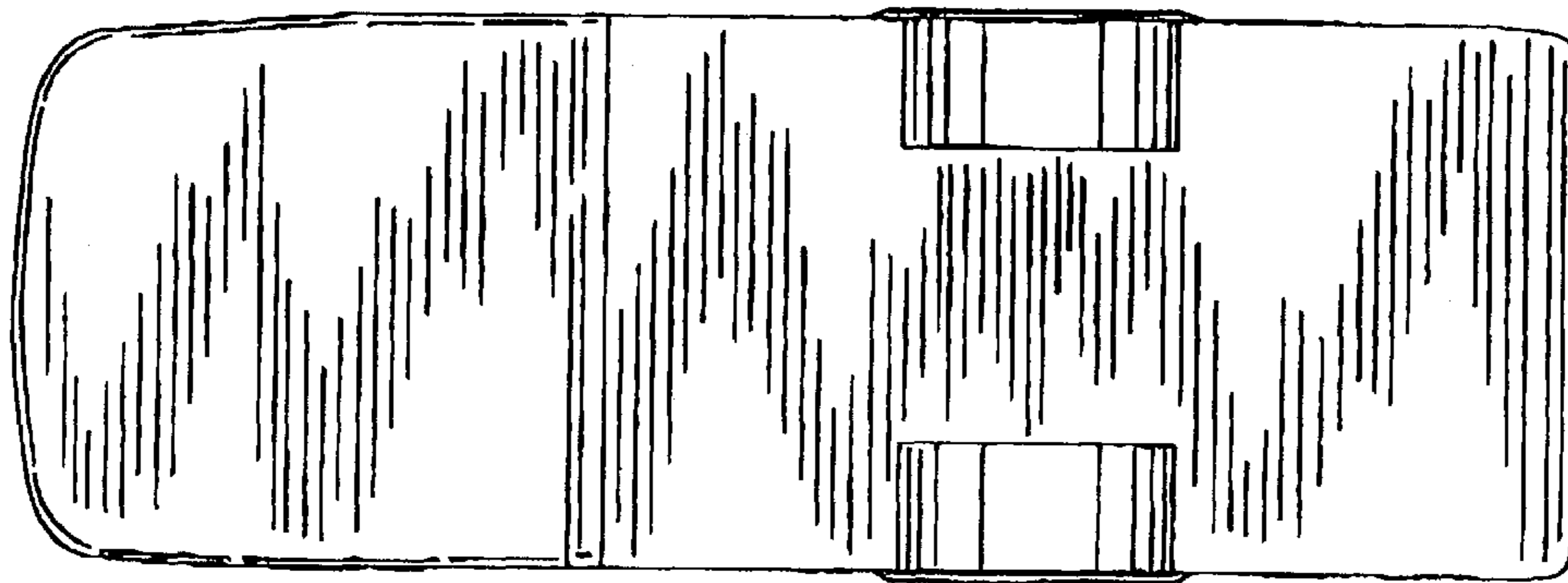

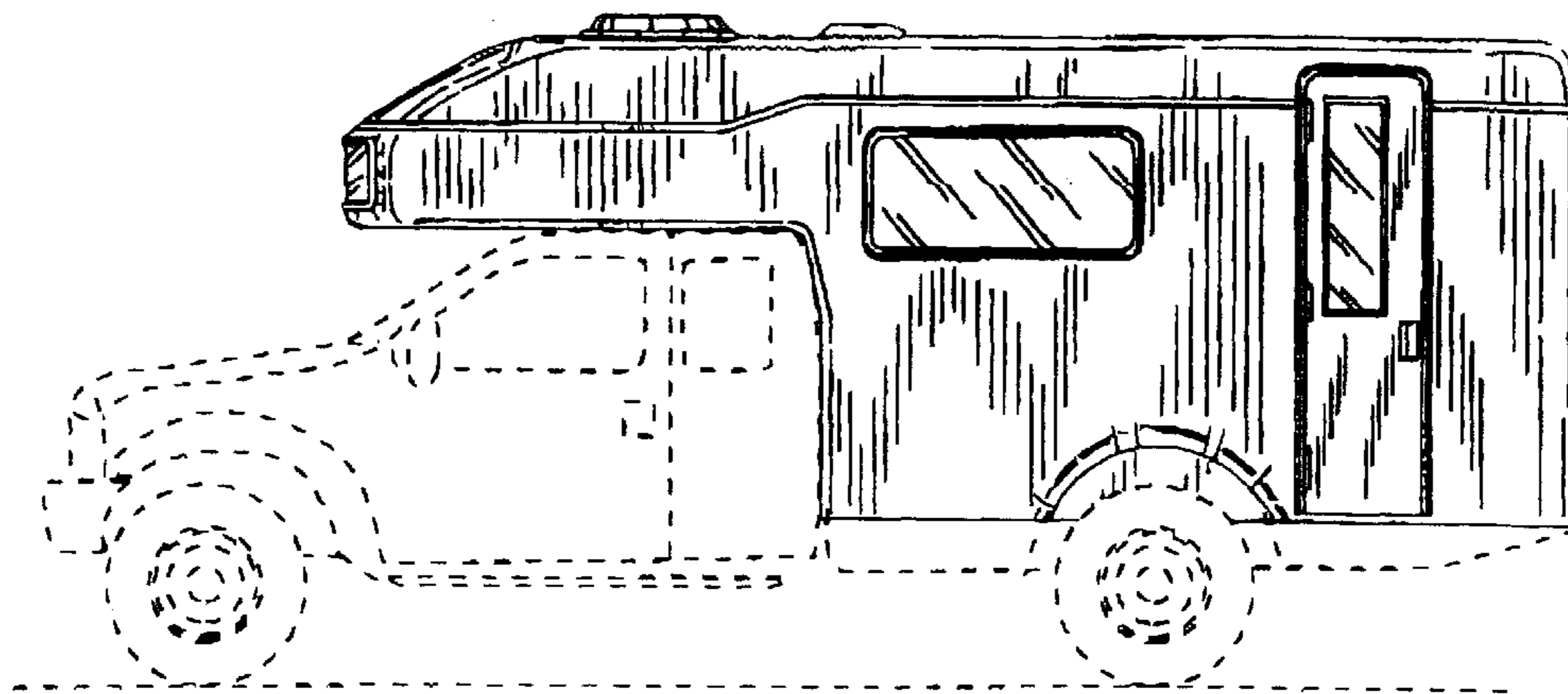
