**DESCRIPTION**

FIG. 11 is a front view thereof.

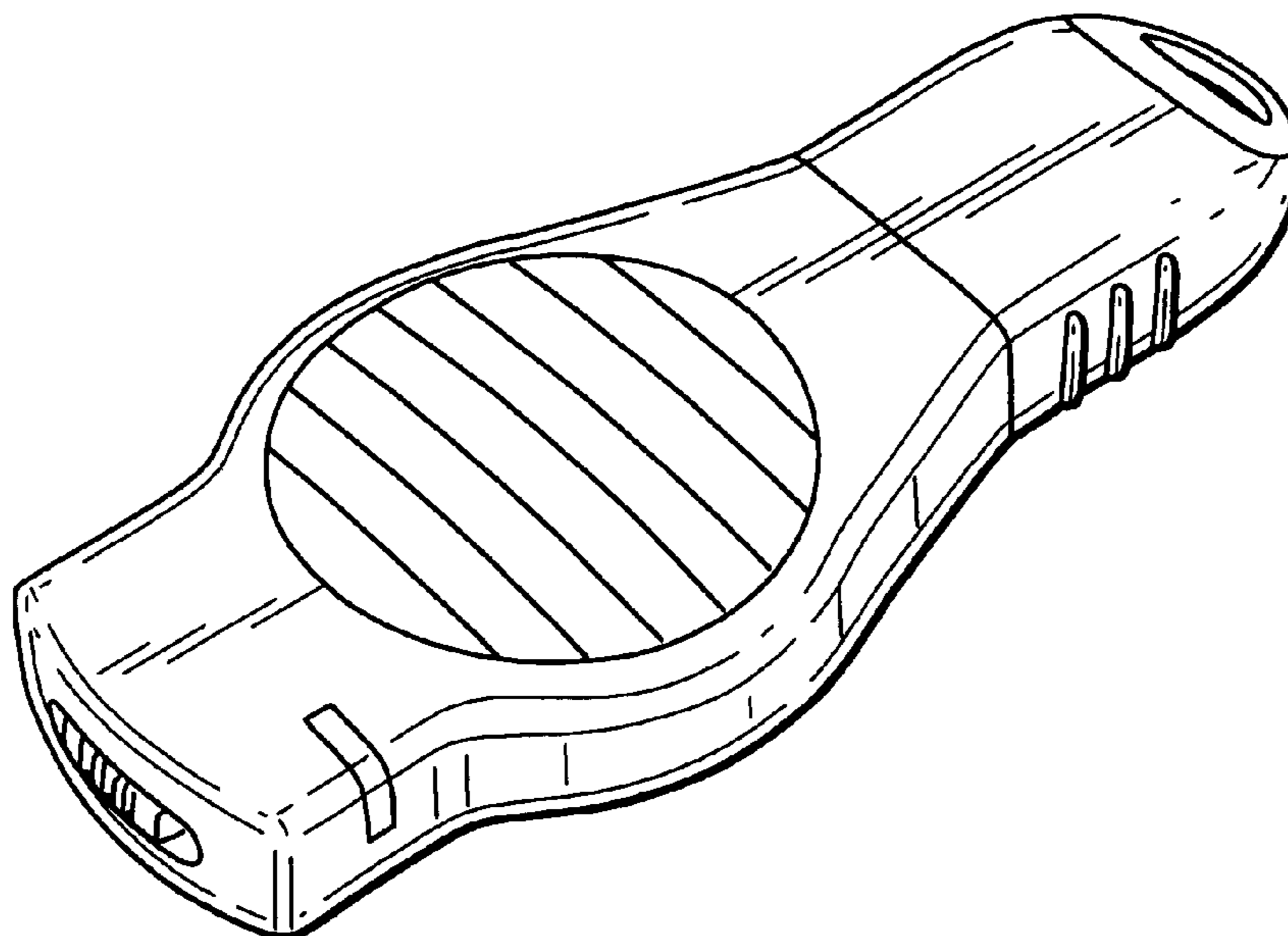
FIG. 12 is a top view of the third embodiment of a thumbdrive;

FIG. 13 is a right side view thereof;

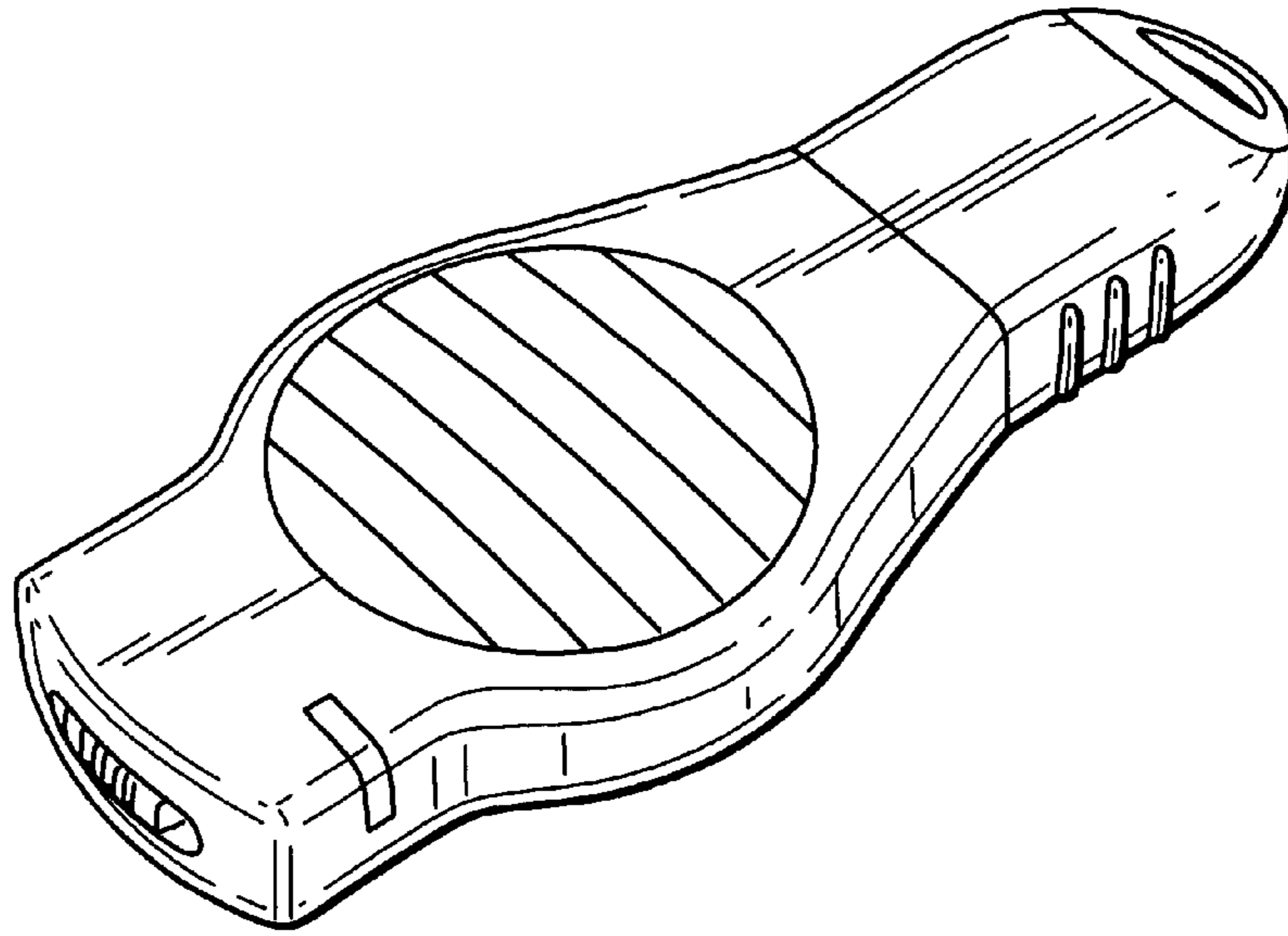
FIG. 14 is a back view thereof; and,

FIG. 15 is a front view thereof.

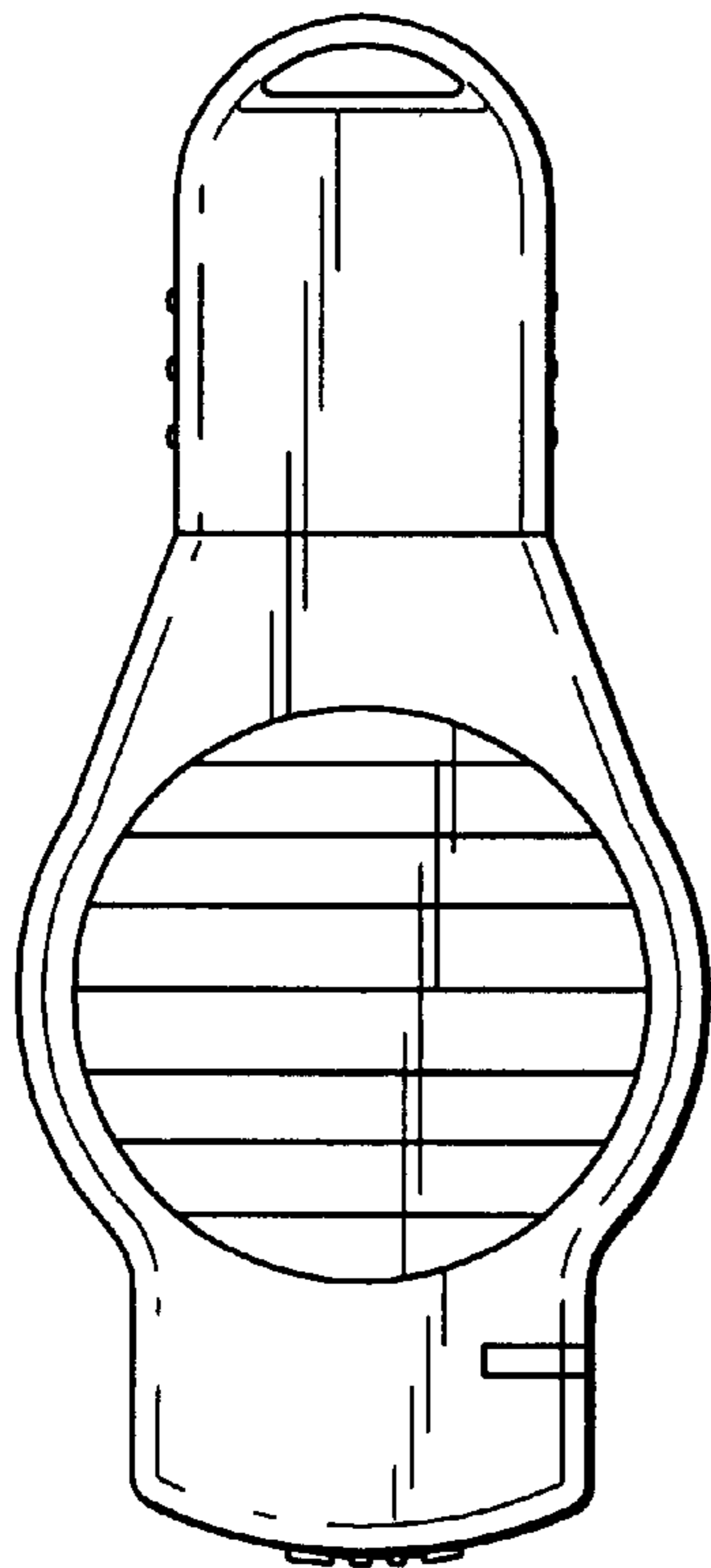

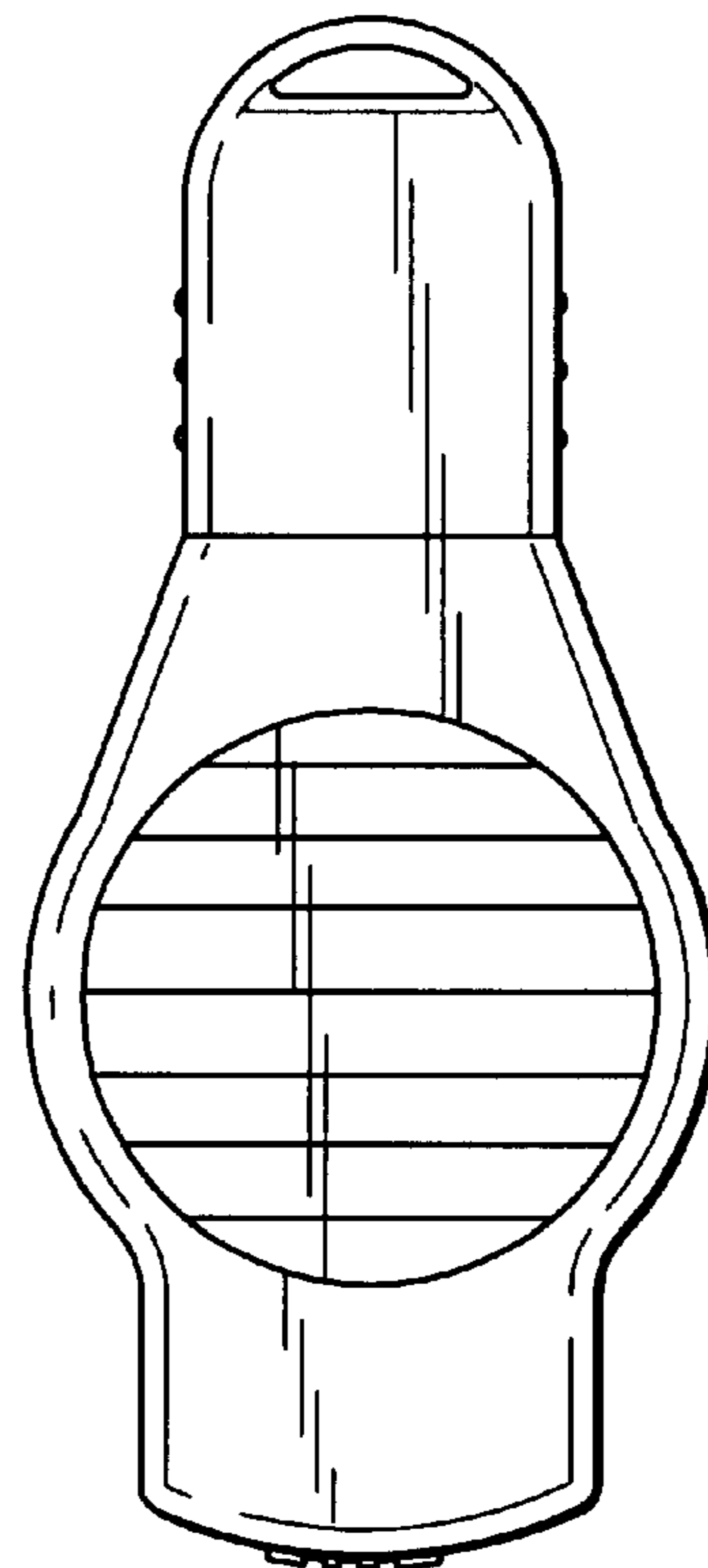

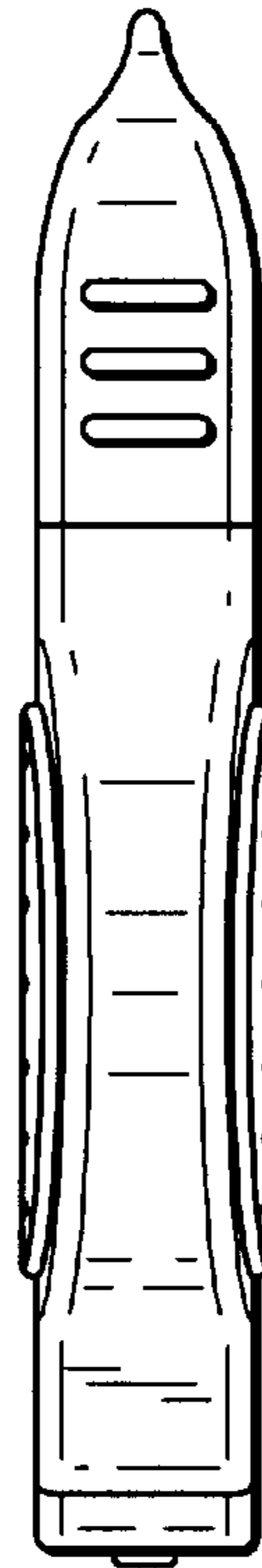

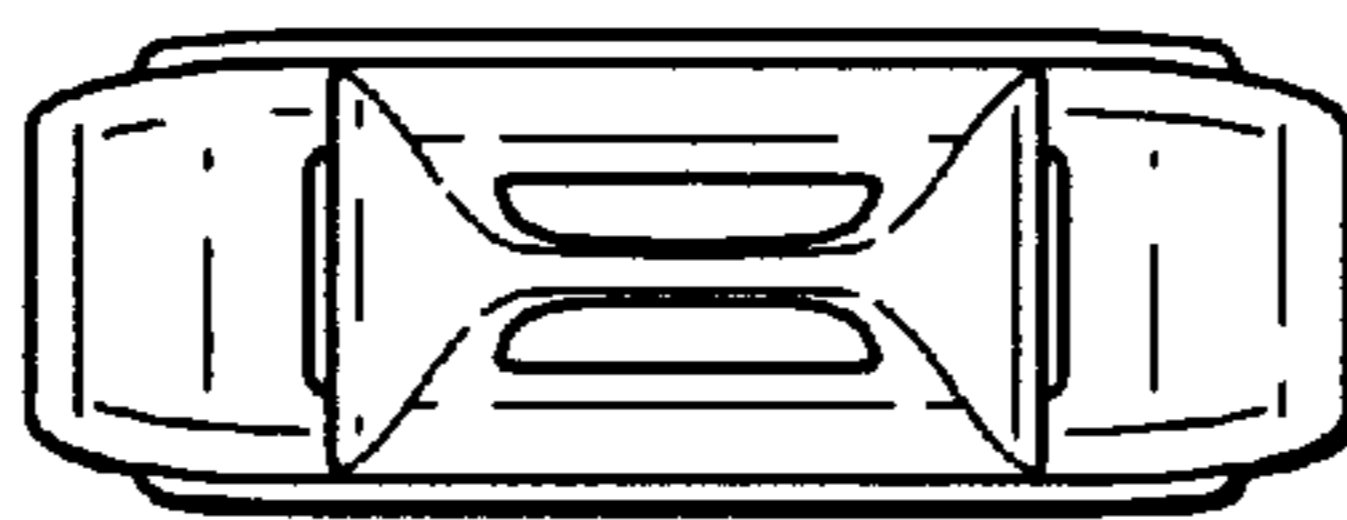

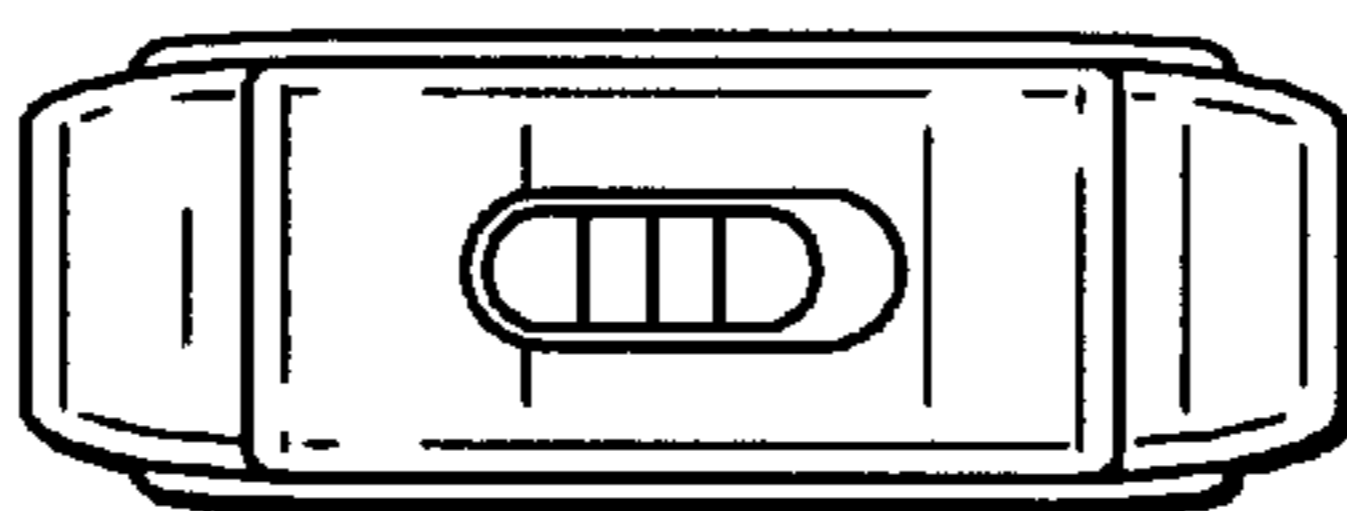

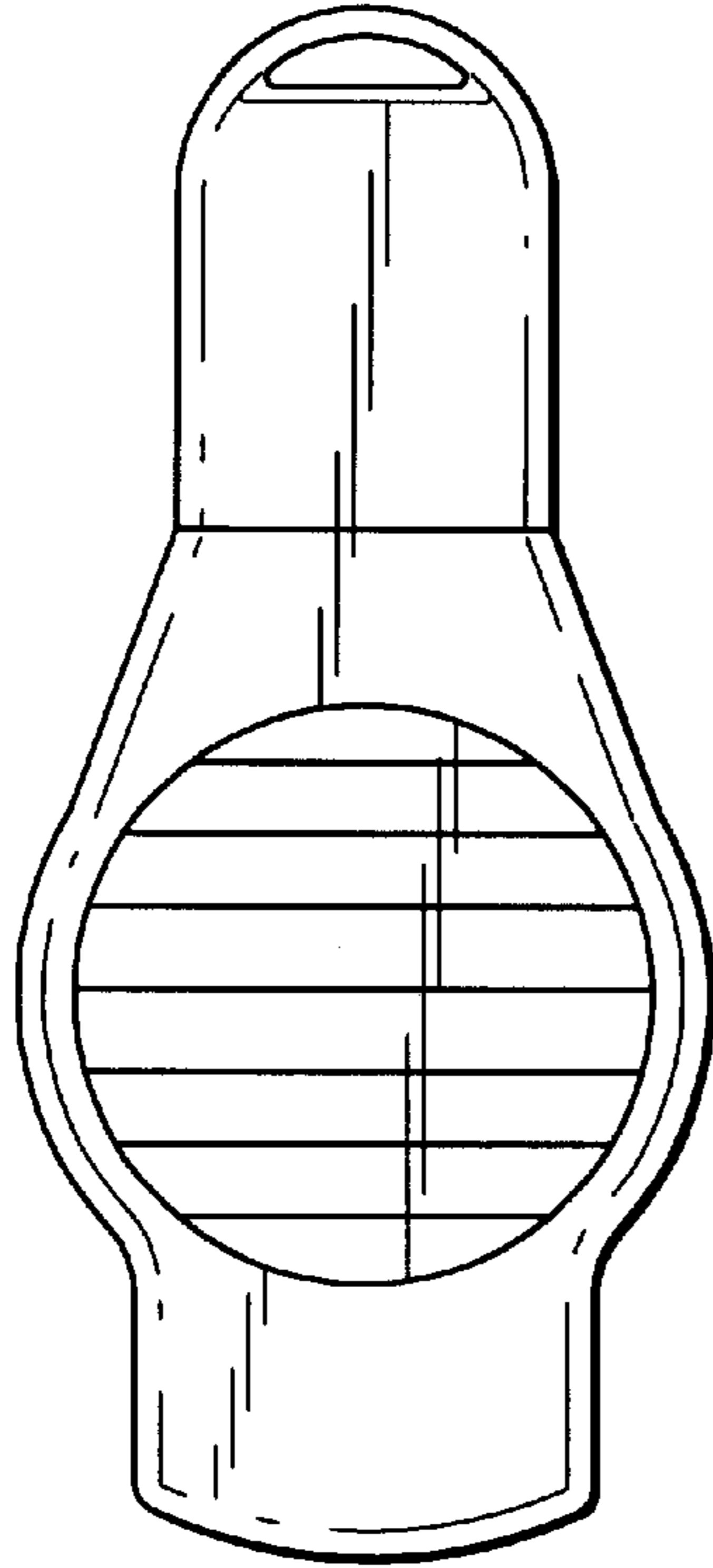

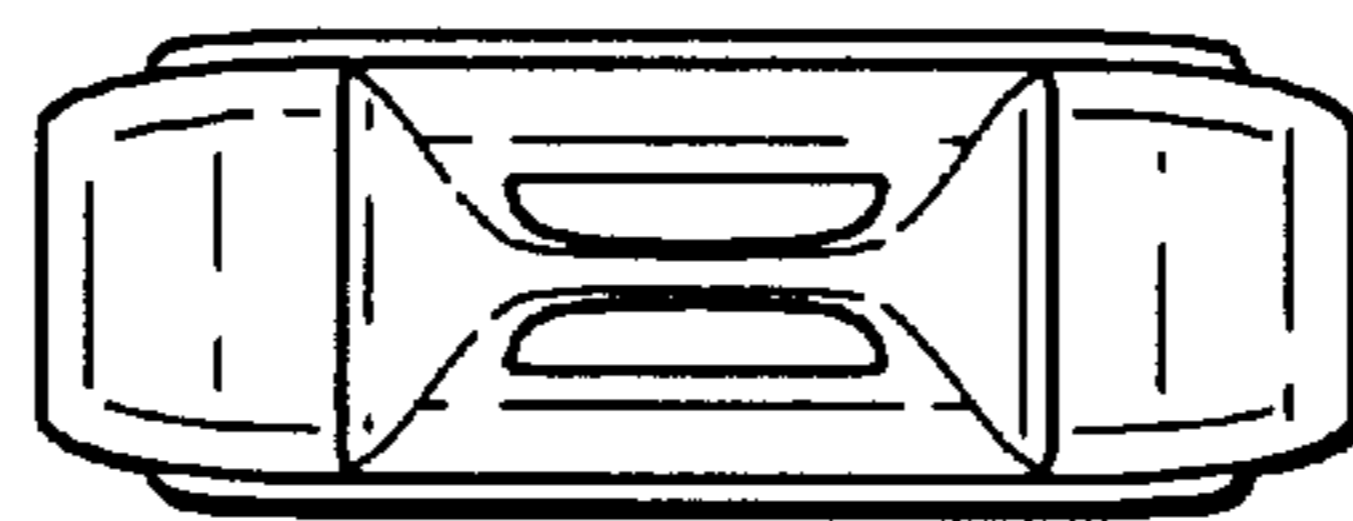

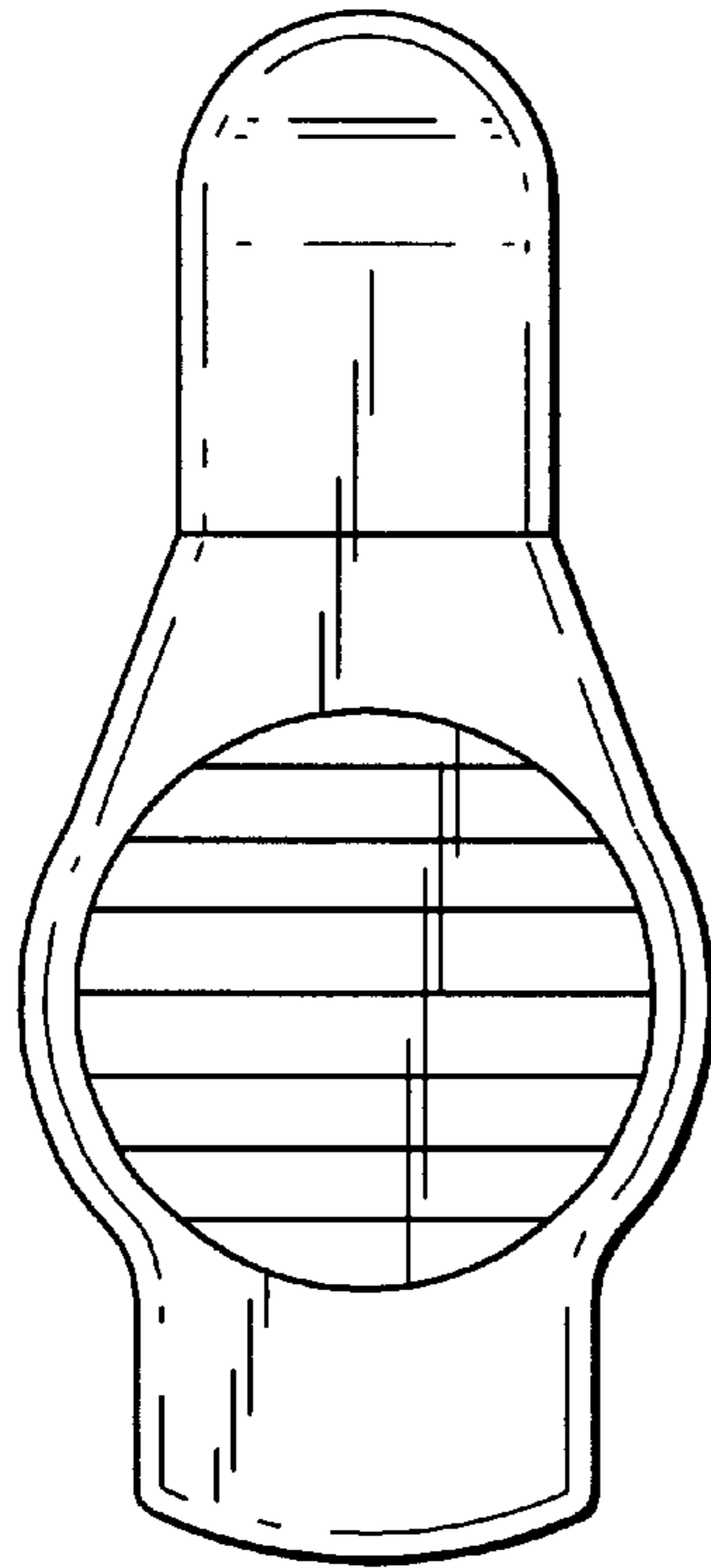

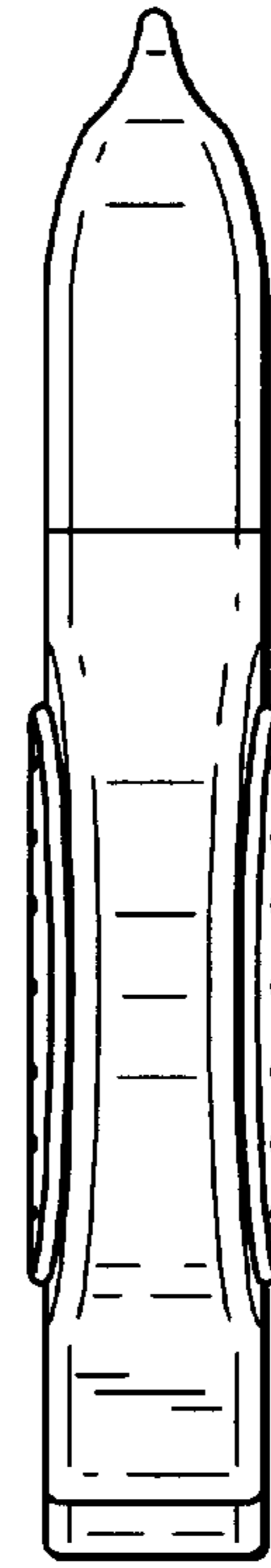

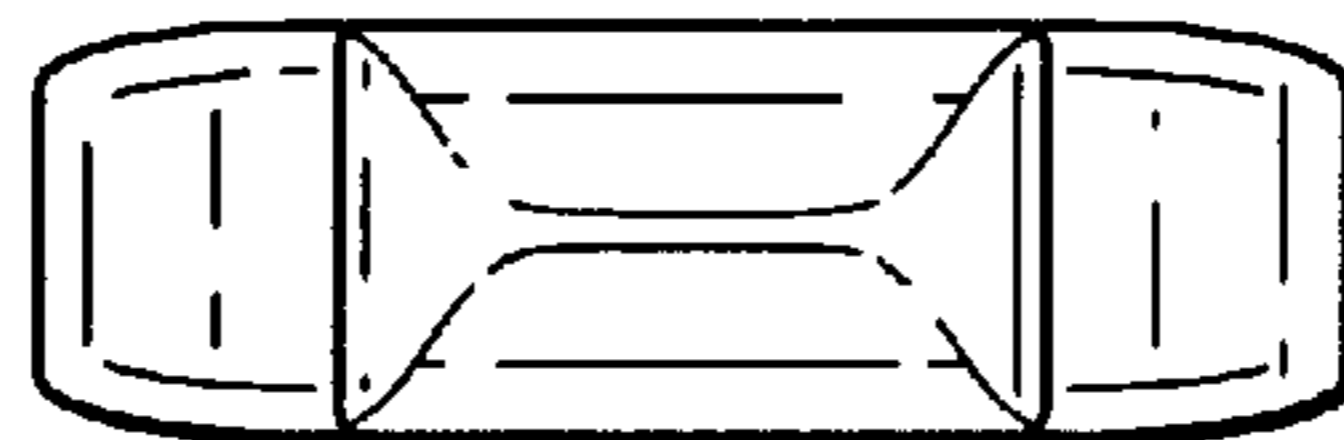
