(57) **CLAIM**

The ornamental design for a digital camera, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, right, and top sides of a digital camera showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a right side elevational reference view thereof showing a fully extended position of a zoom lens of the digital camera; and,

FIG. 9 is a front elevational reference view thereof in a condition of a case cover being placed on the digital camera.

In FIG. 9, the case cover is shown in broken lines for illustrative purposes only and forms no part of the claimed design.

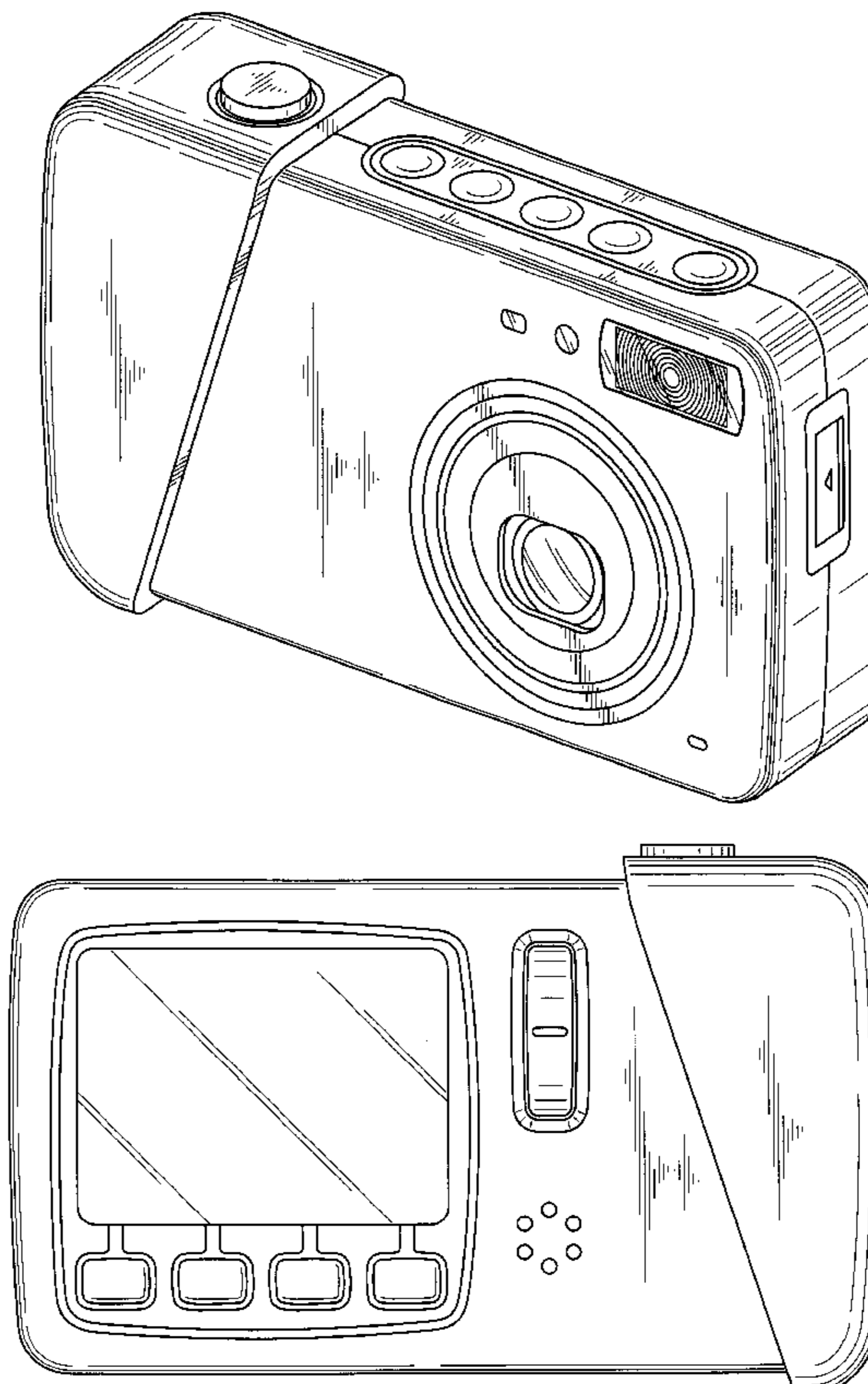

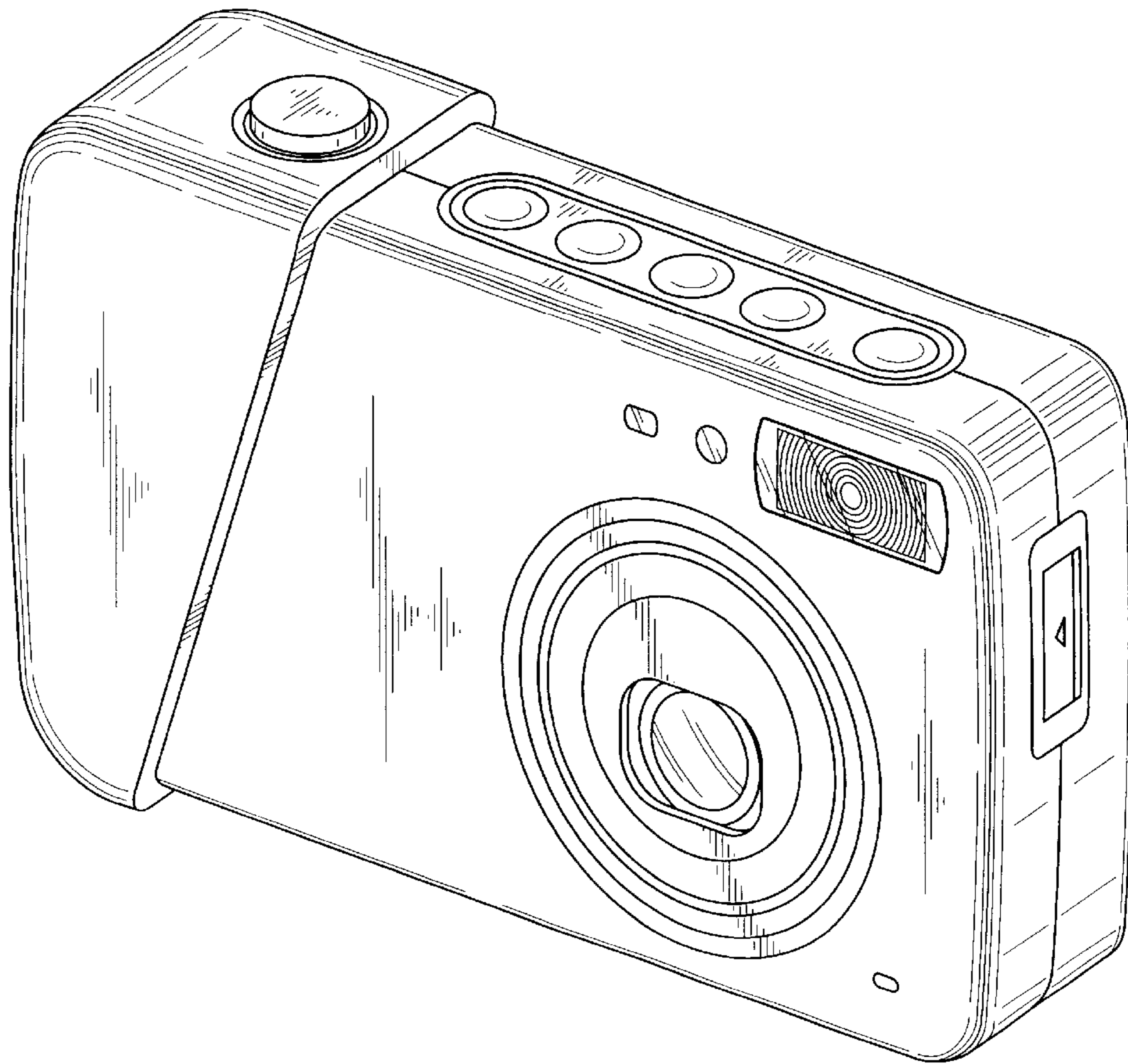

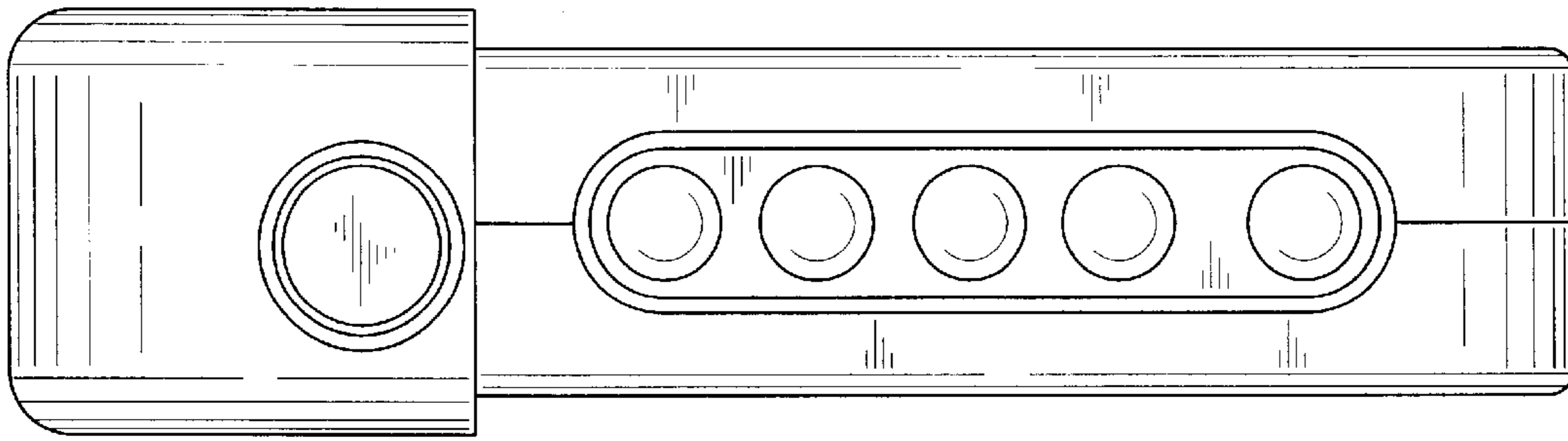

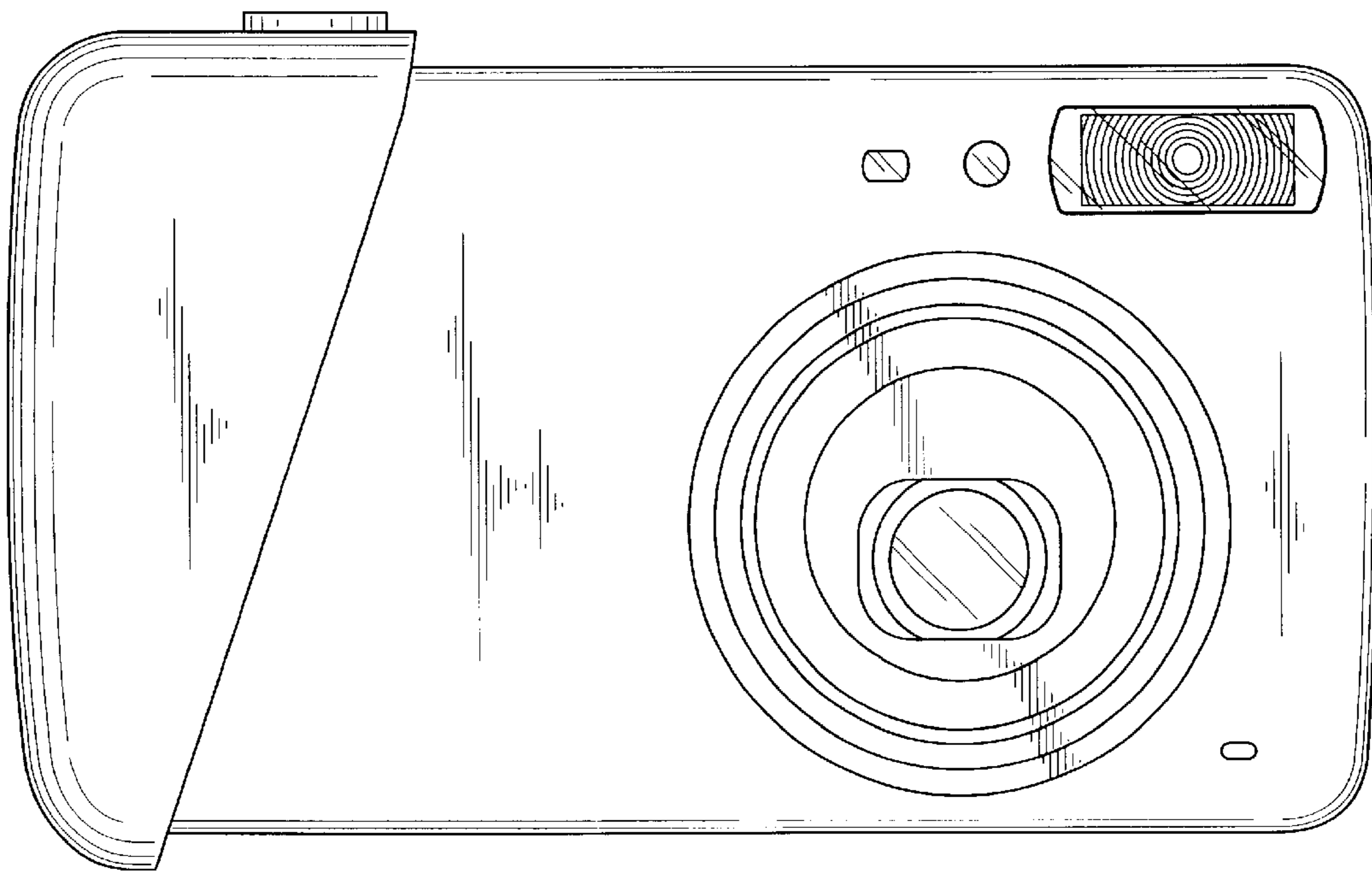

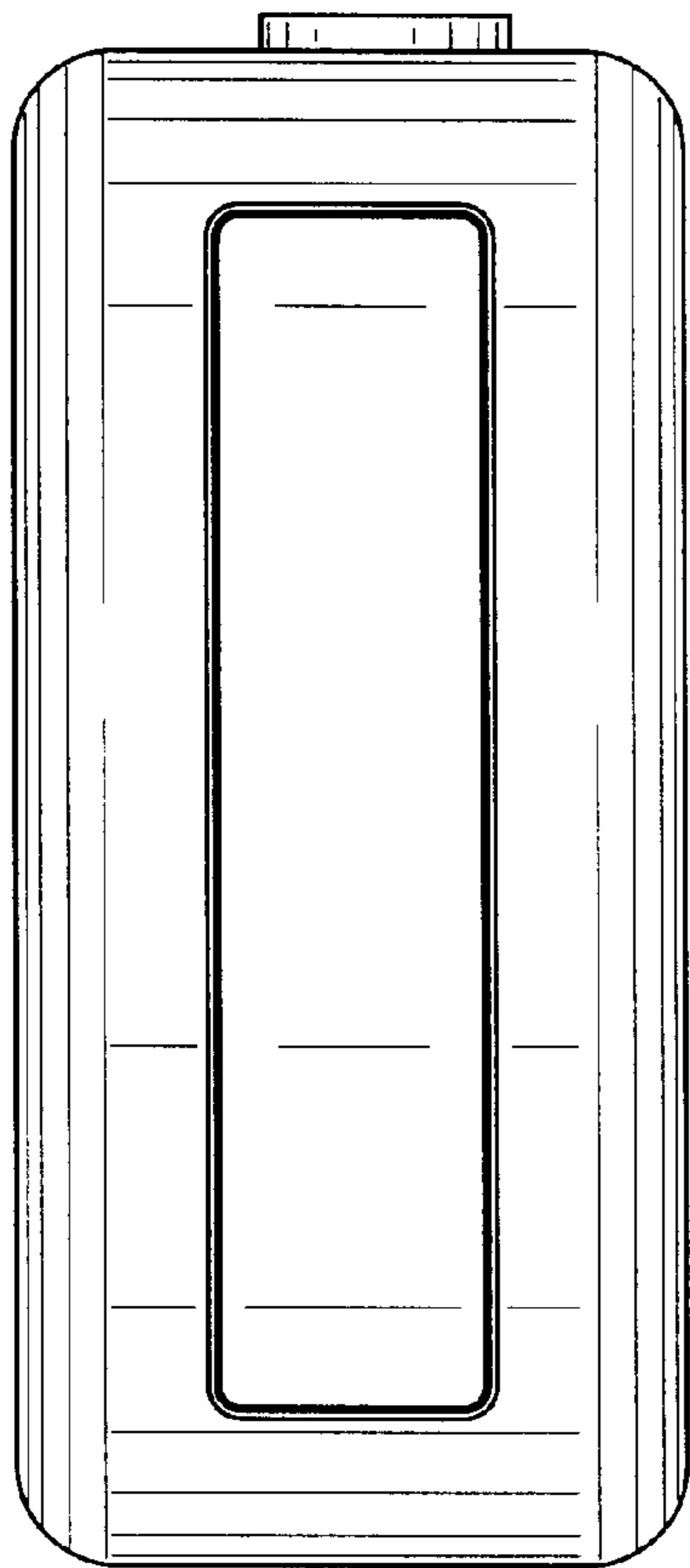

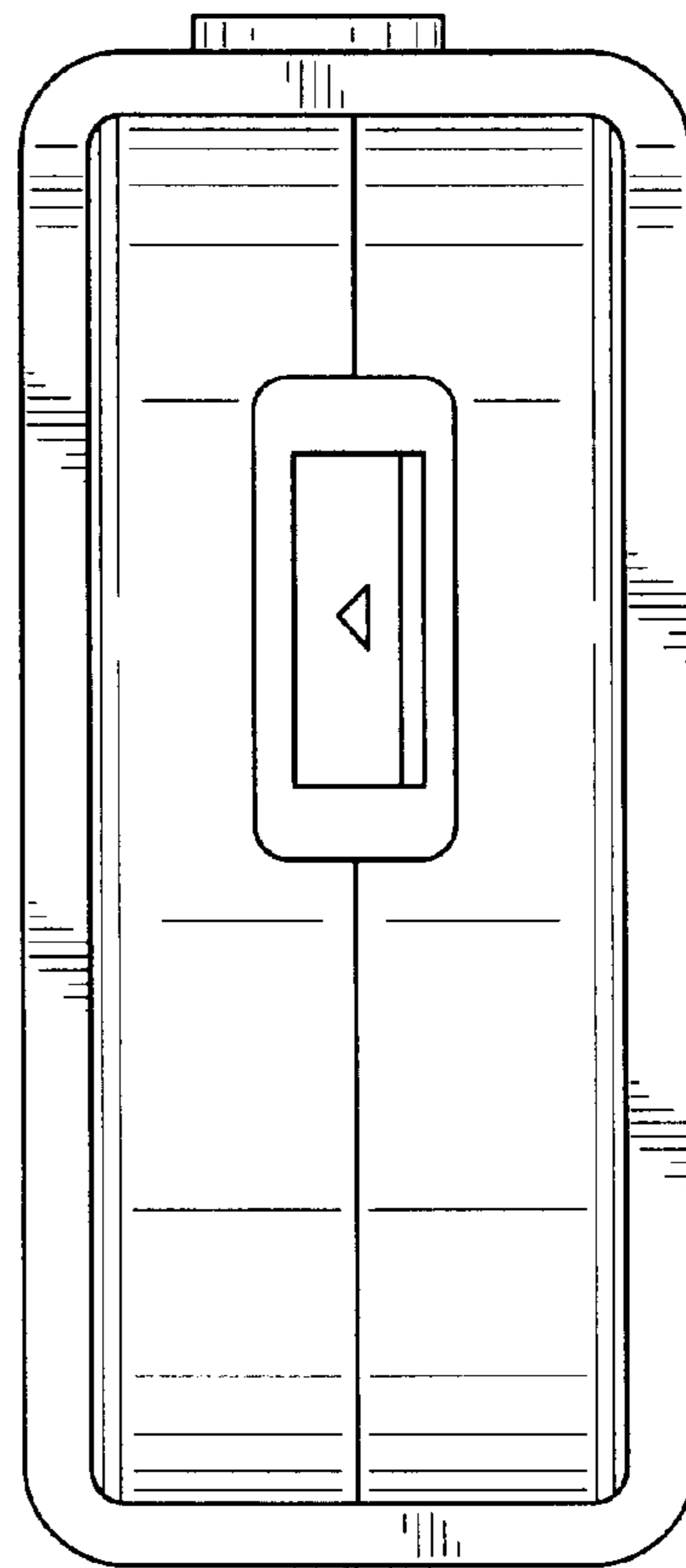

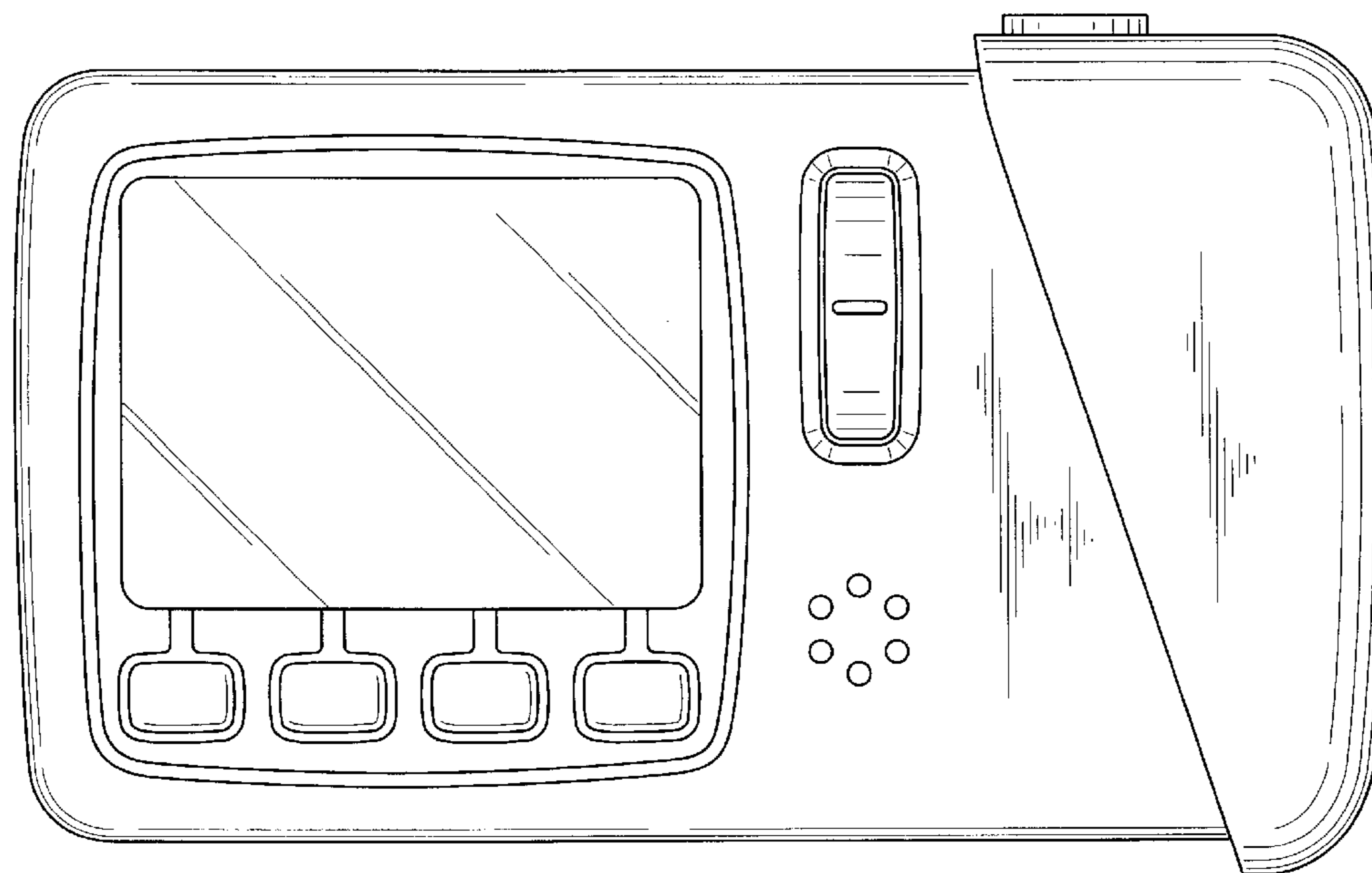

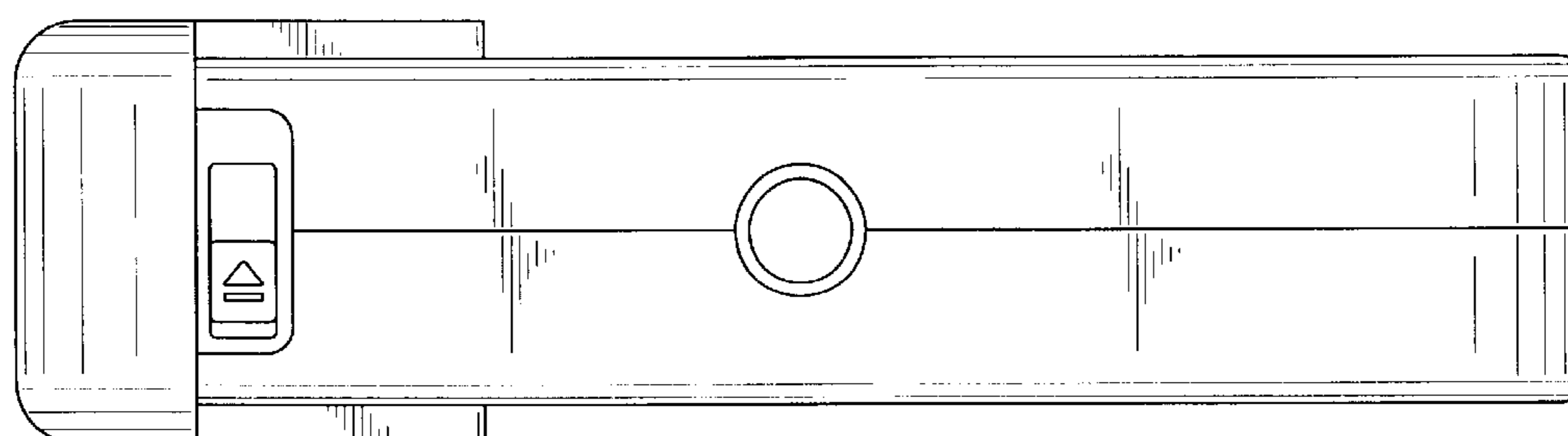

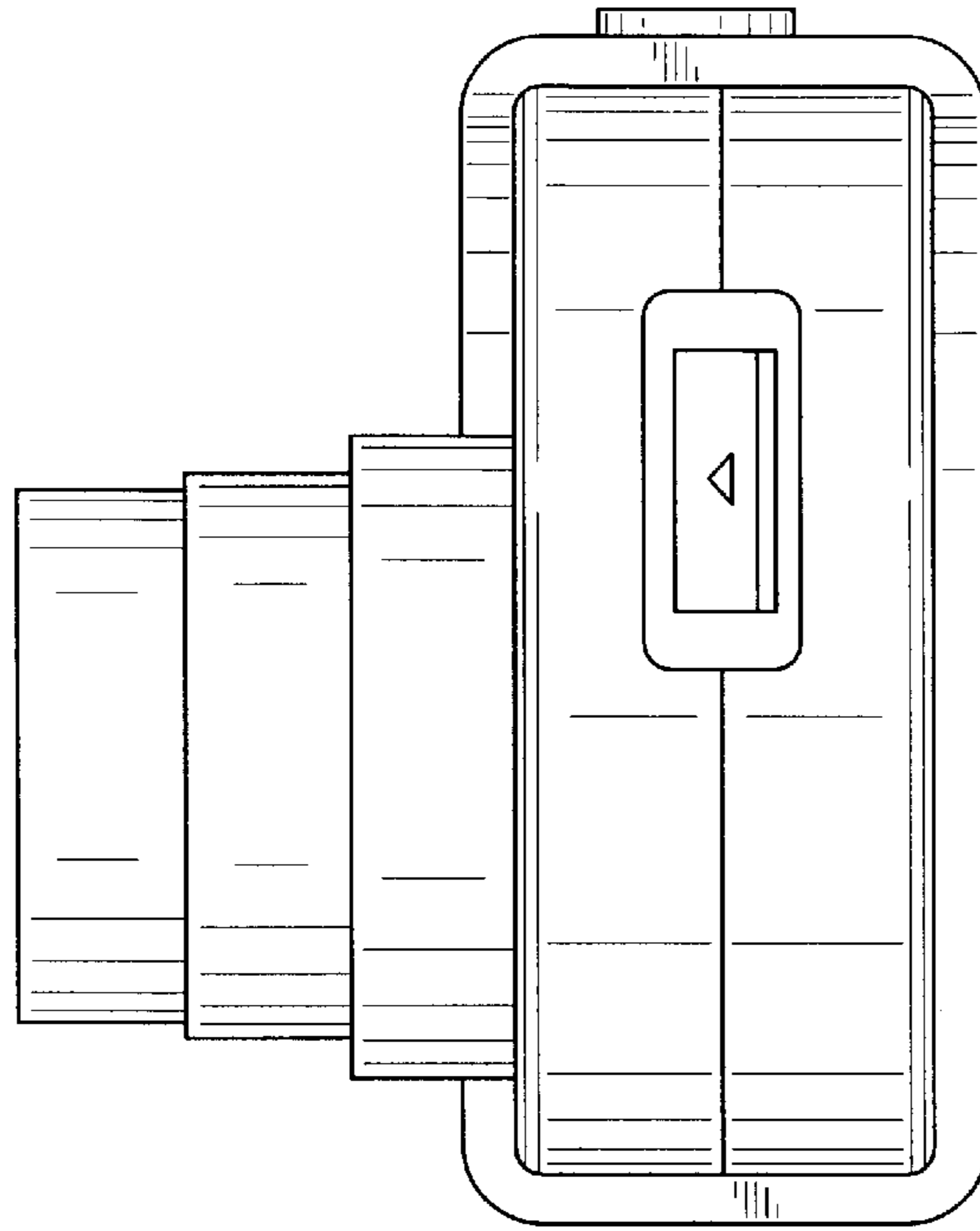
