(57) **CLAIM**

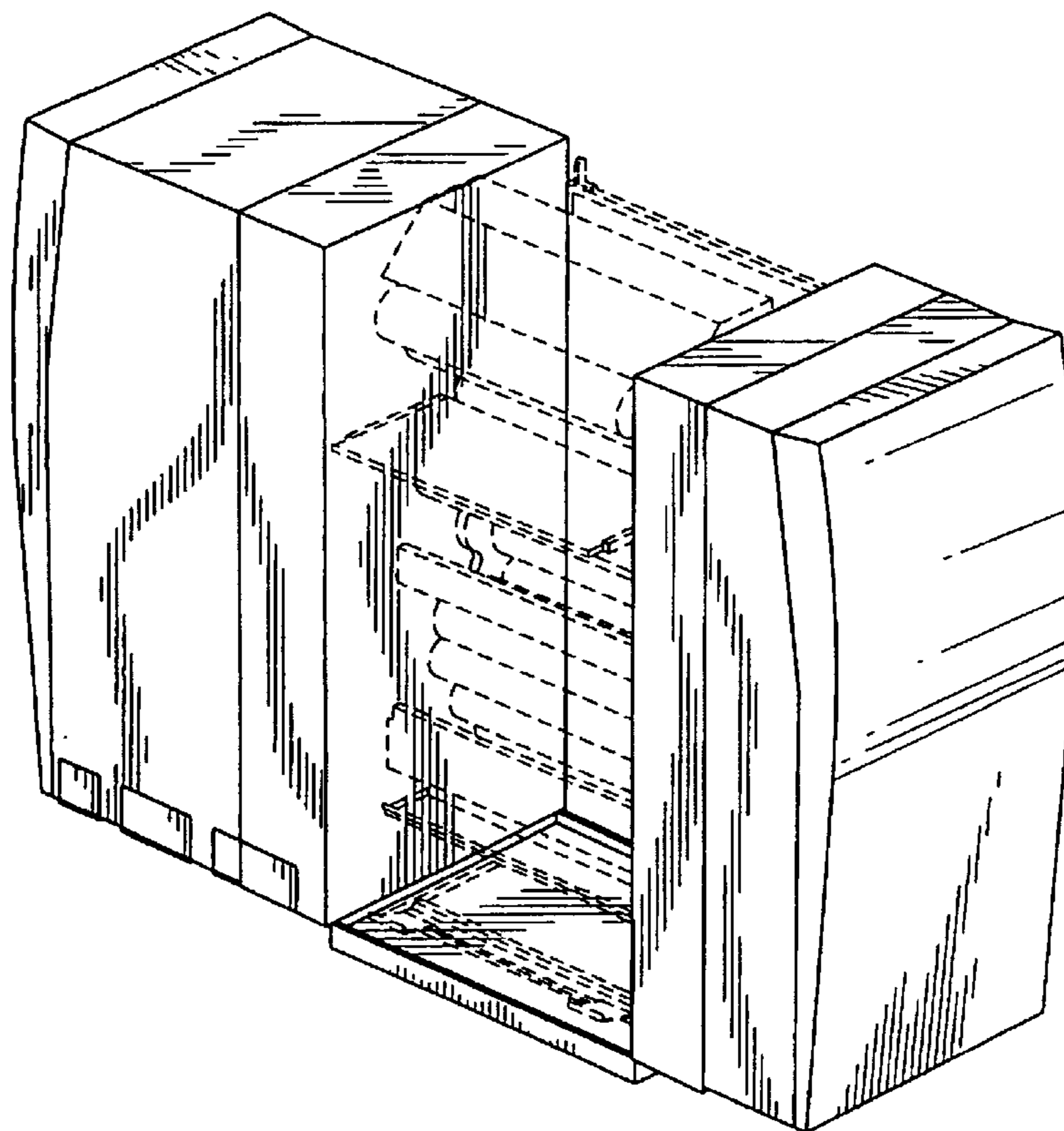
The ornamental design for a printing unit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a printing unit in accordance with the present invention;
FIG. 2 is a right side view of the printing unit;
FIG. 3 is a rear elevation view of the printing unit in accordance with the present invention;
FIG. 4 is a left side view of the printing unit;
FIG. 5 is a front elevation view of the printing unit;

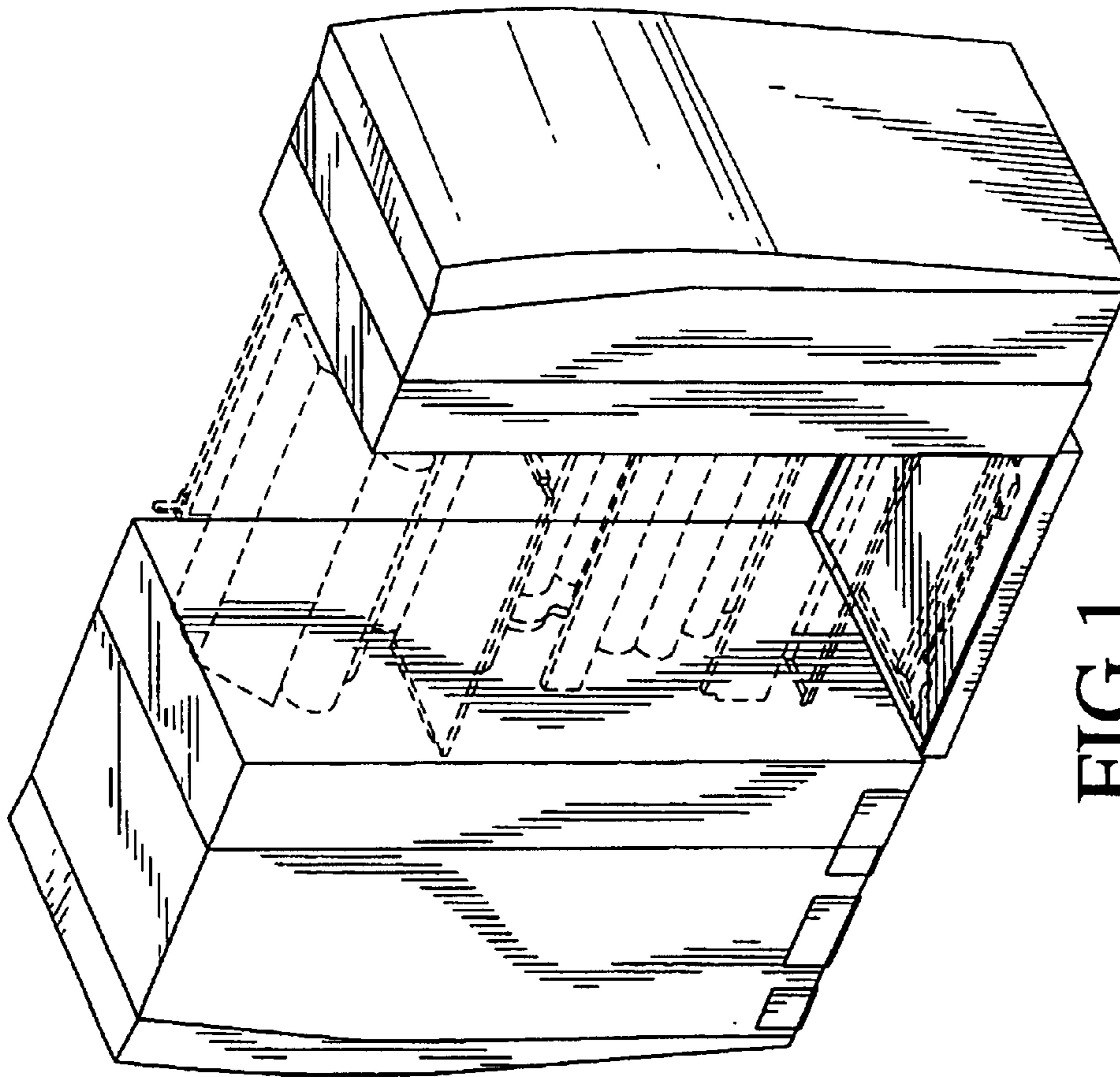

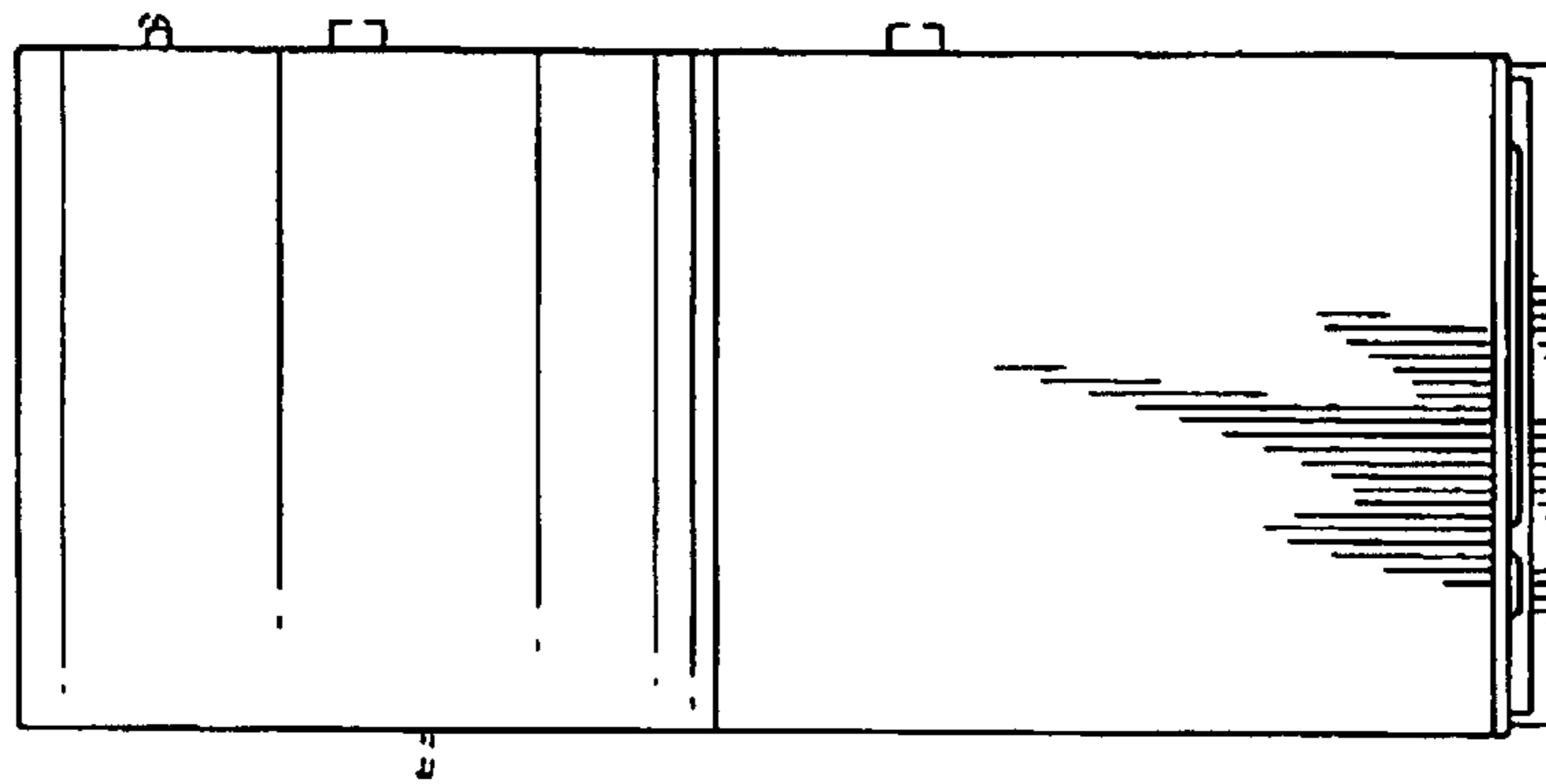

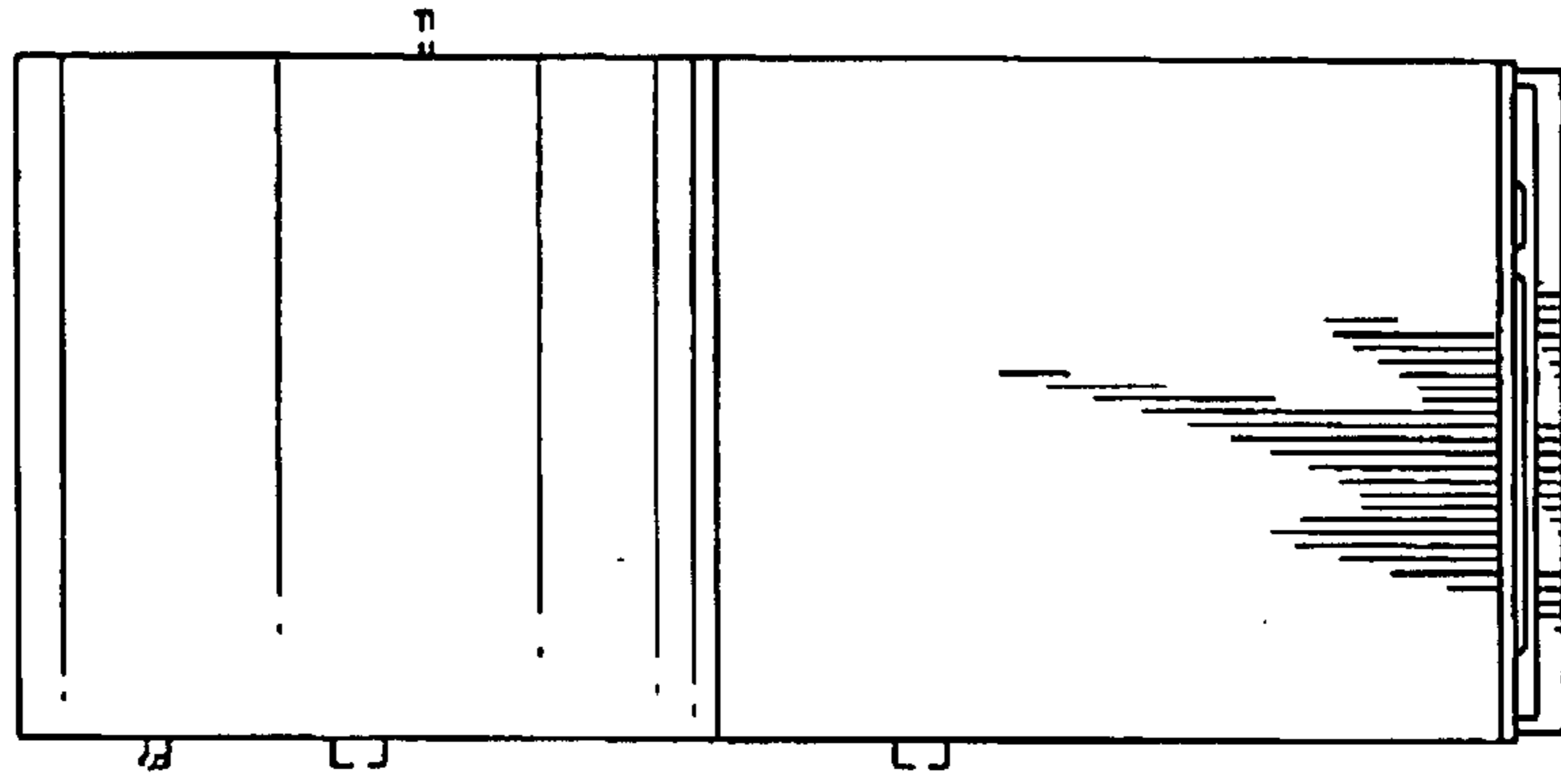

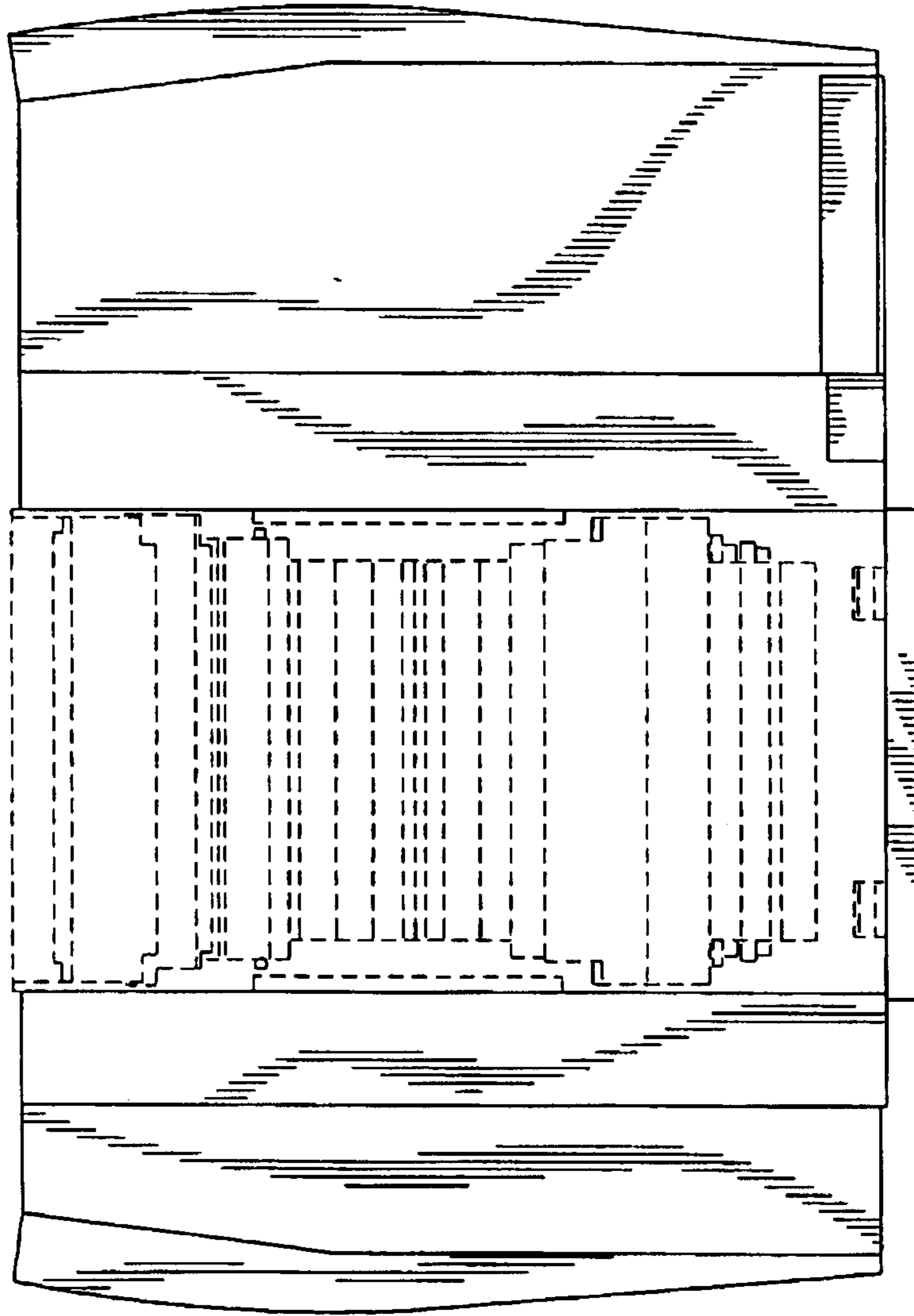

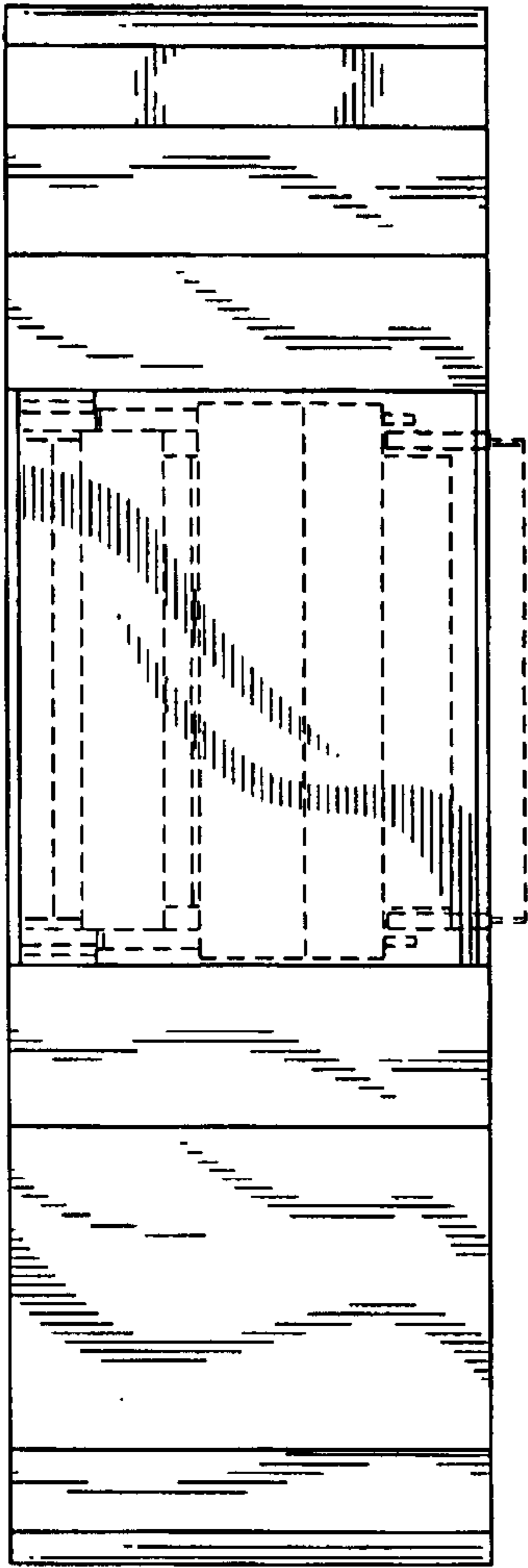

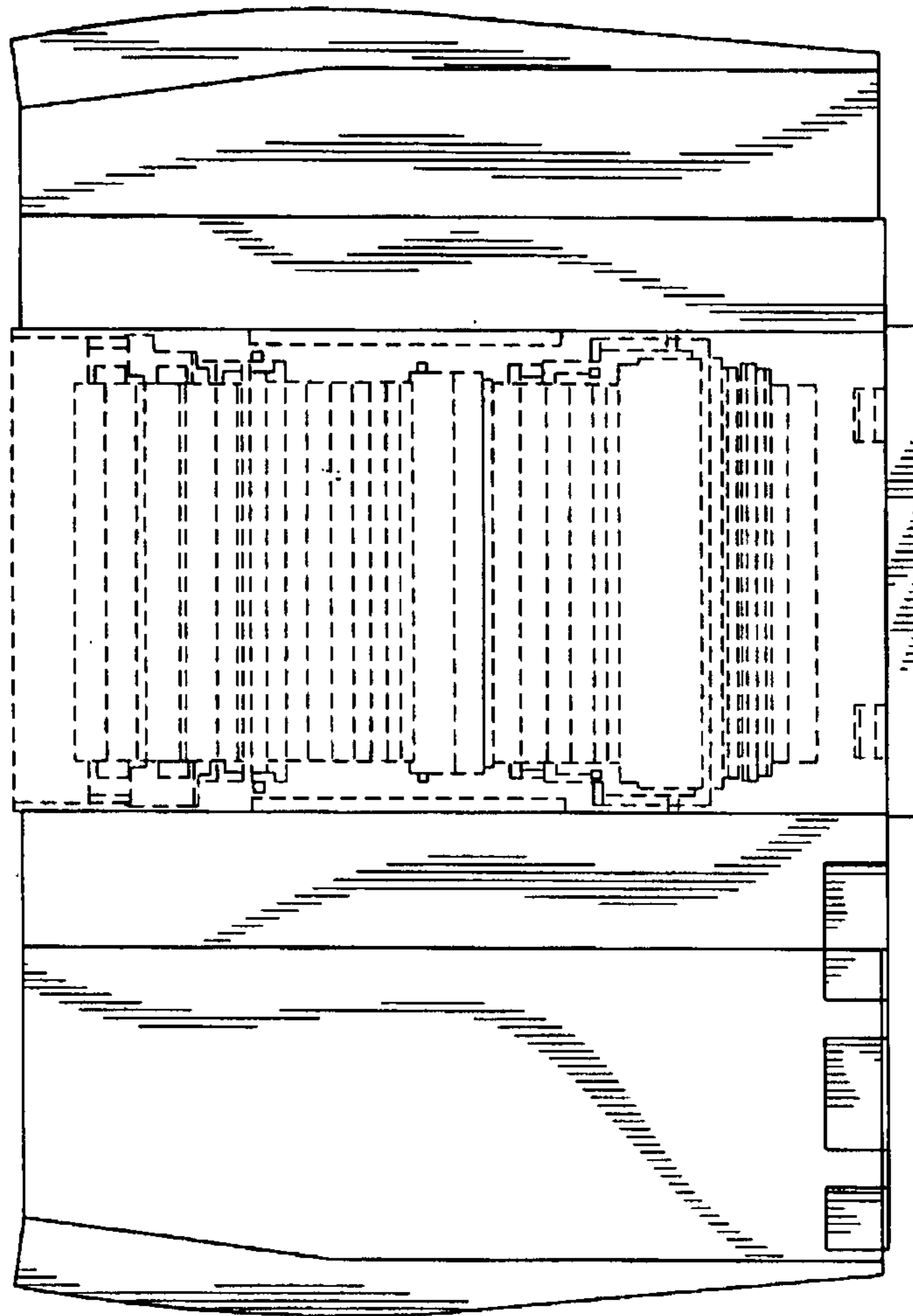

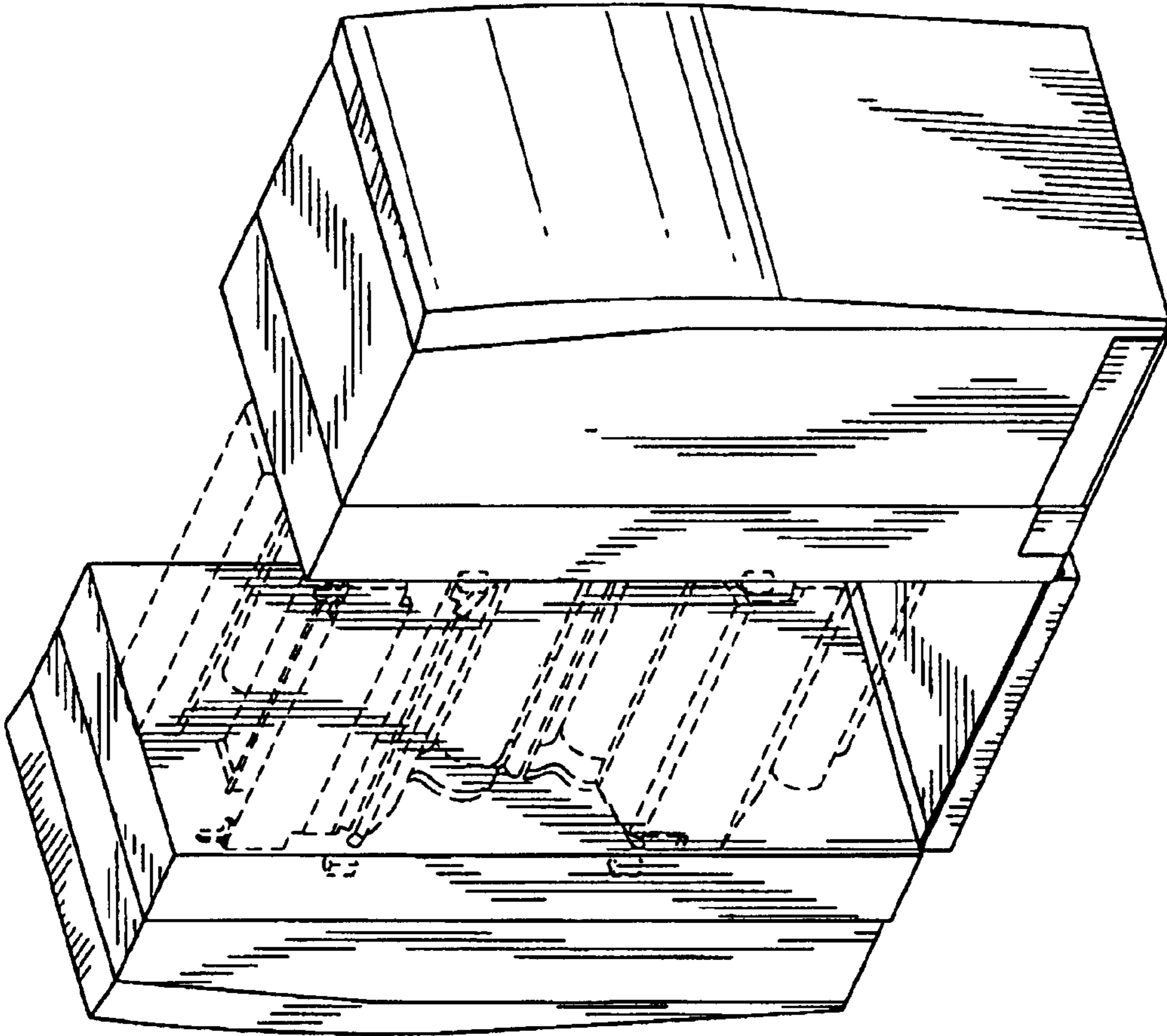
