FIG. 8 is a front elevational view of a golf ball showing a third embodiment of my new design;

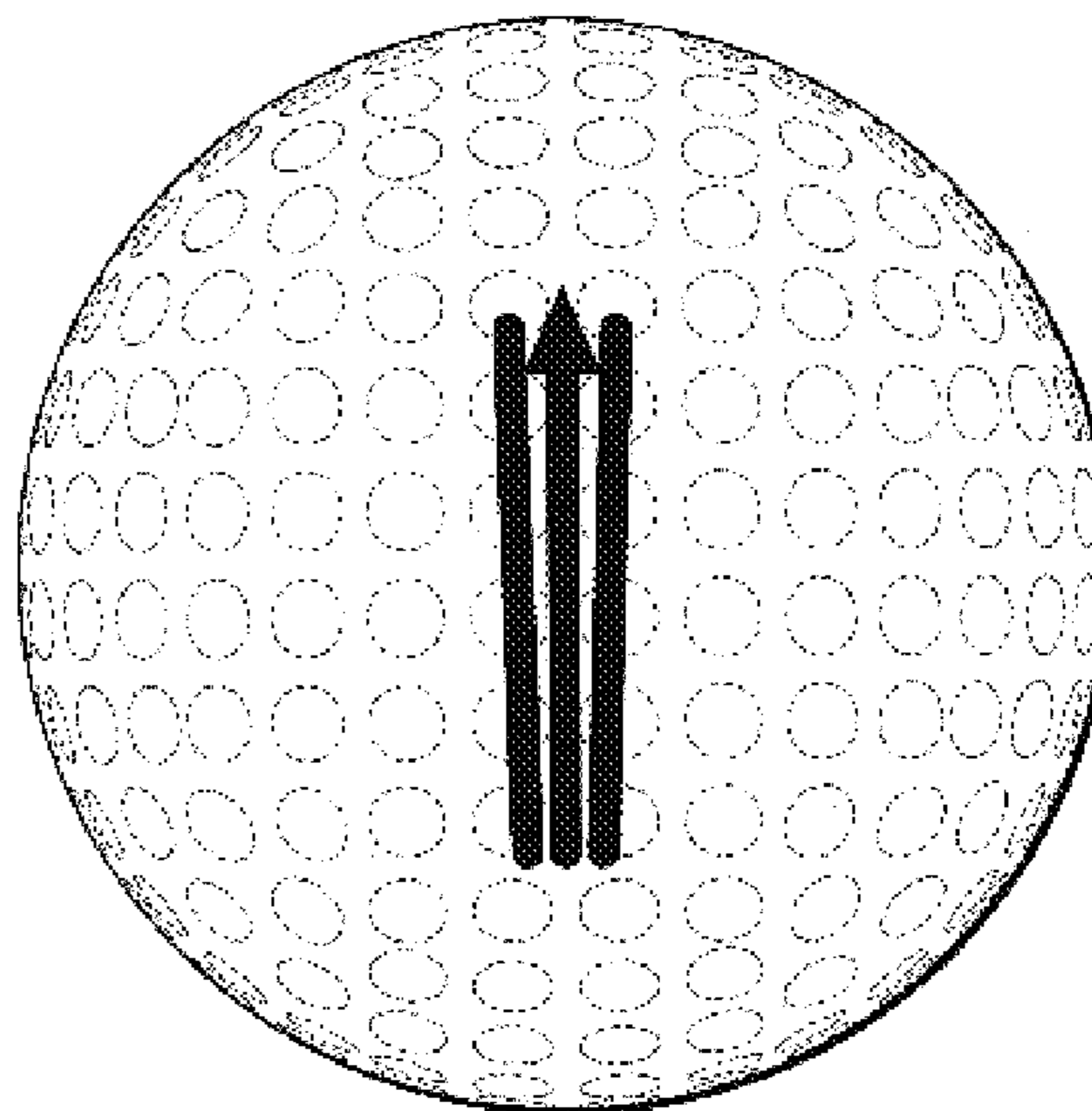
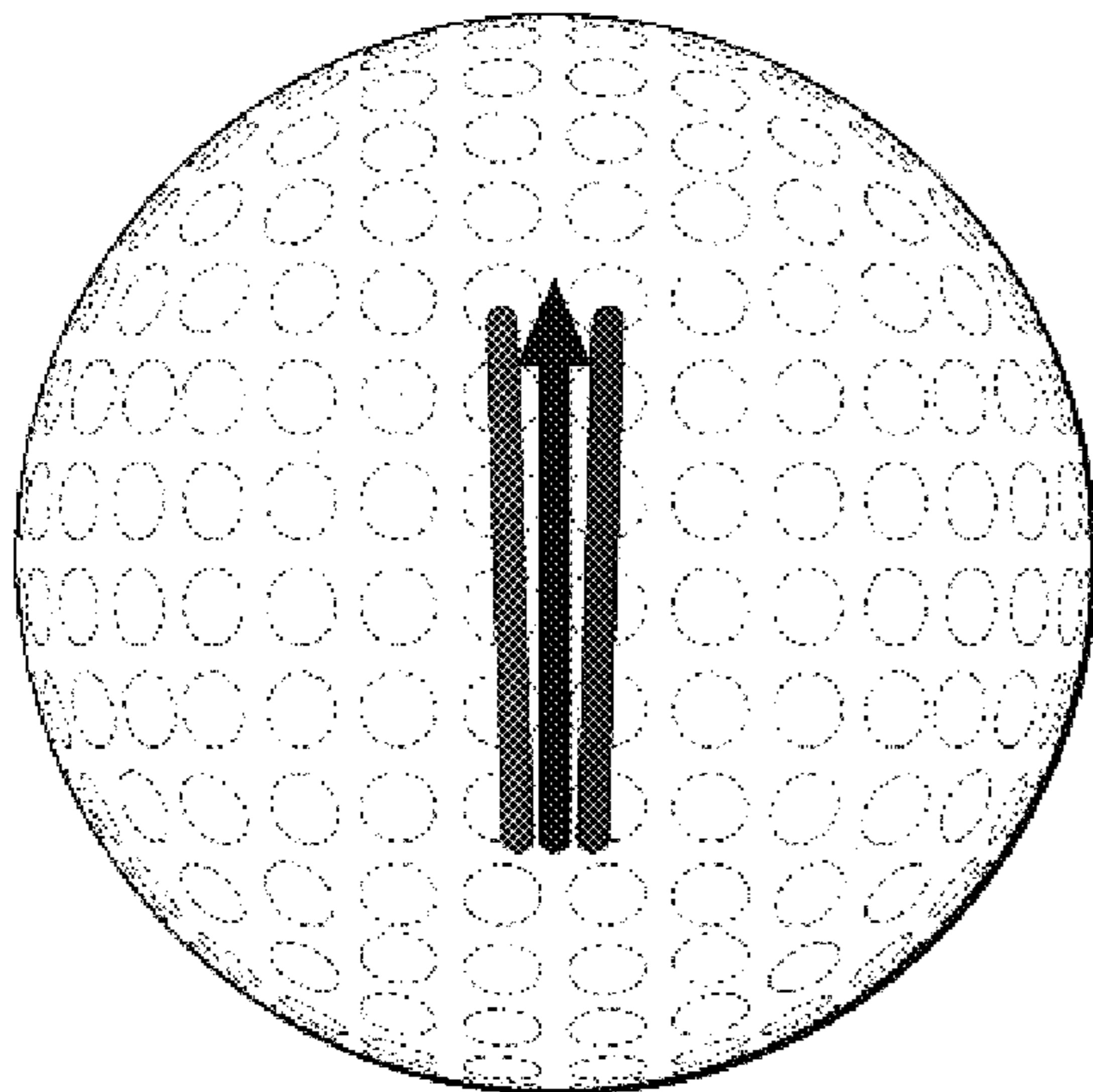
FIG. 9 is a front elevational view of a golf ball showing a fourth embodiment of my new design; and,

FIG. 10 is a front elevational view of a golf ball showing a fifth embodiment of my new design.

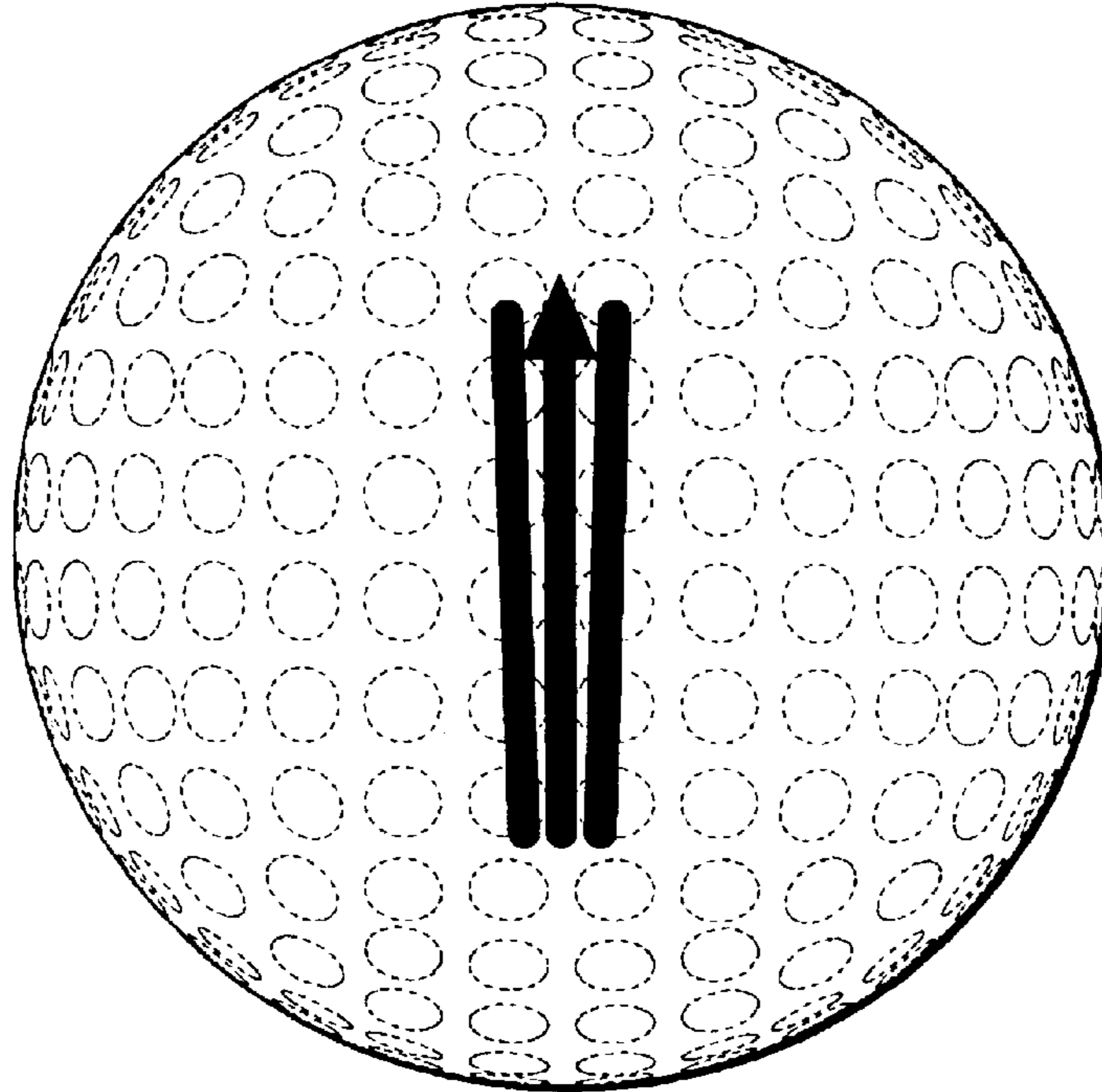
The broken line showing of golf ball dimples is for illustrative purposes only and forms no part of the claimed design.

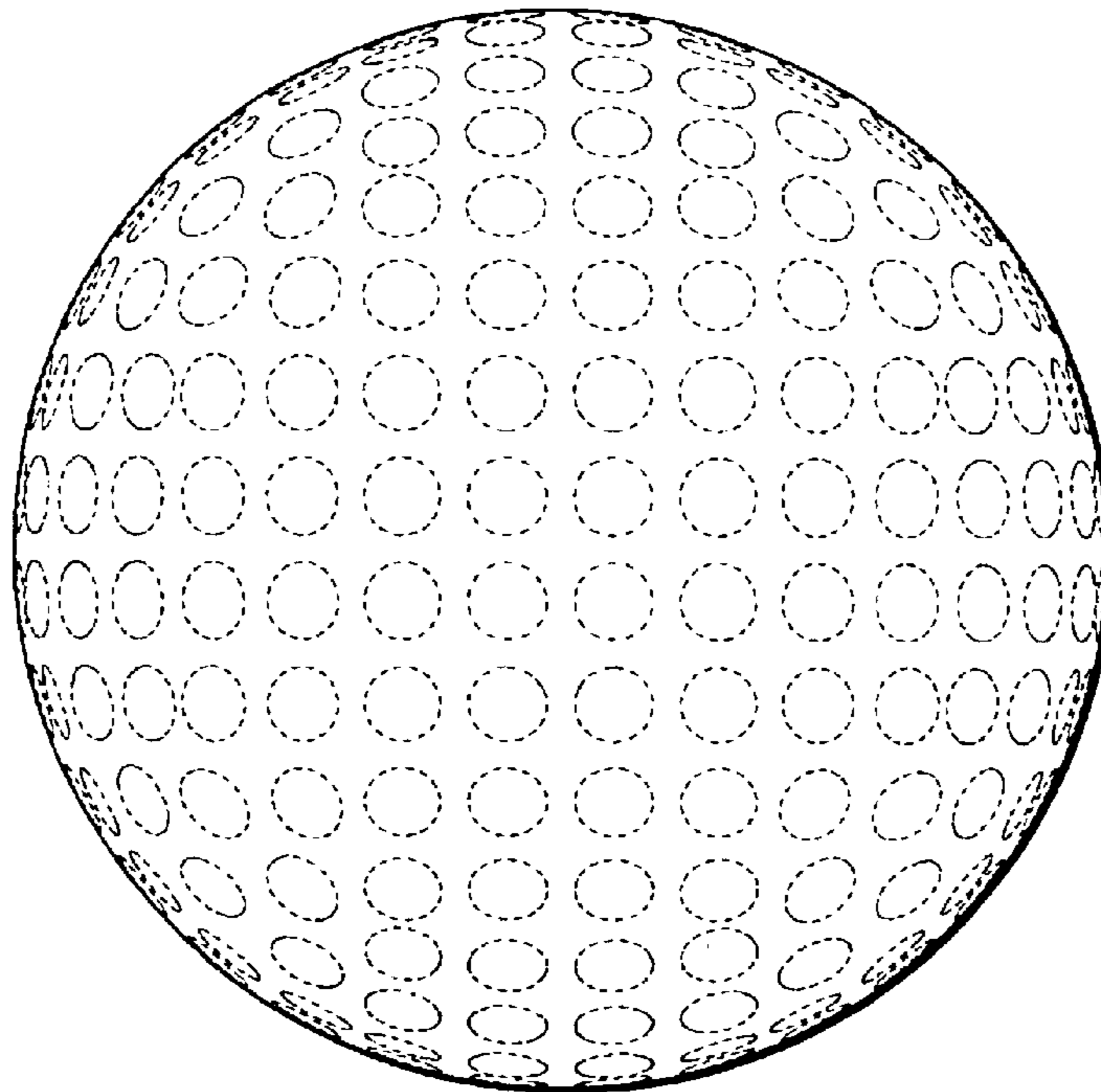

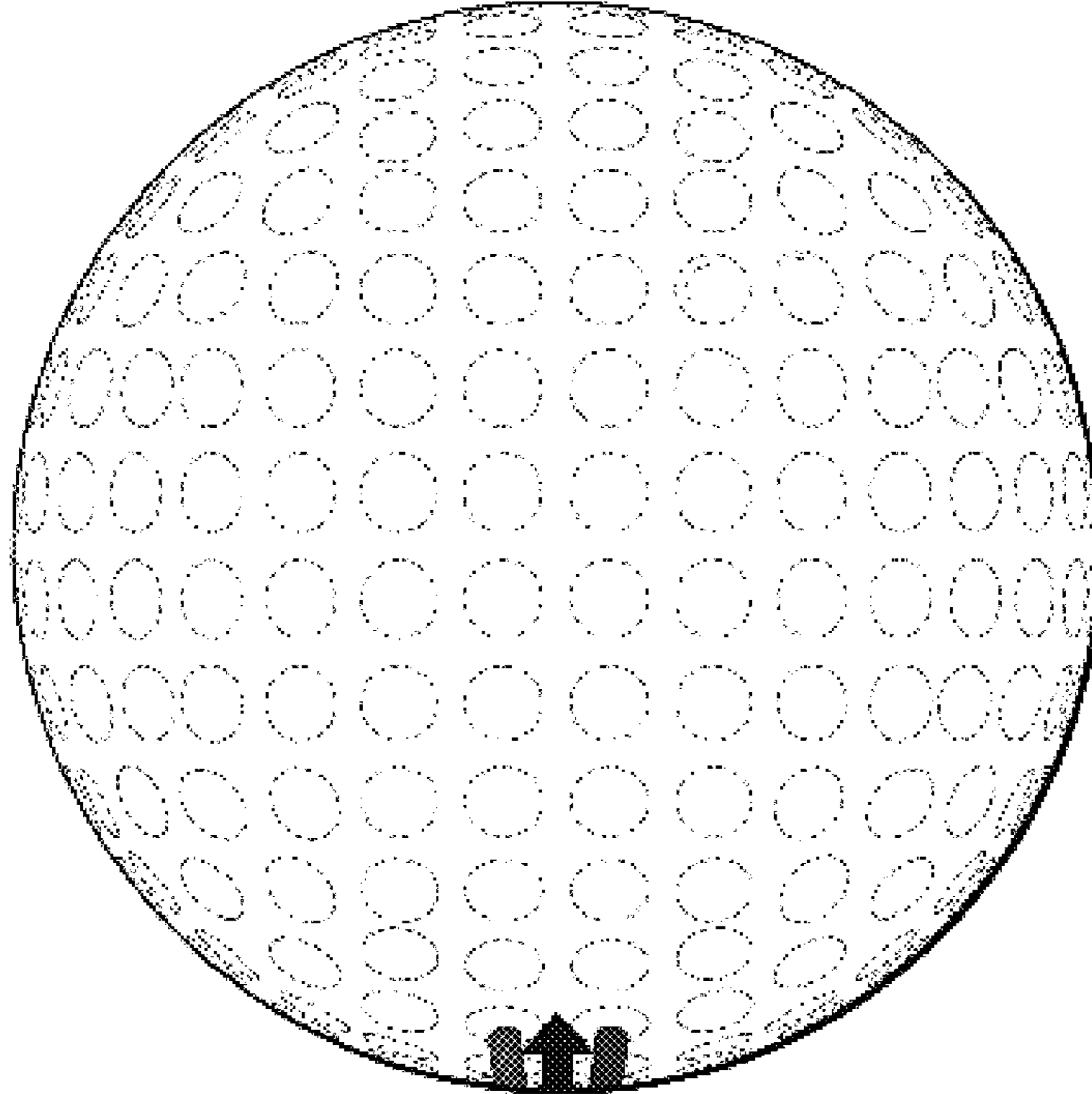

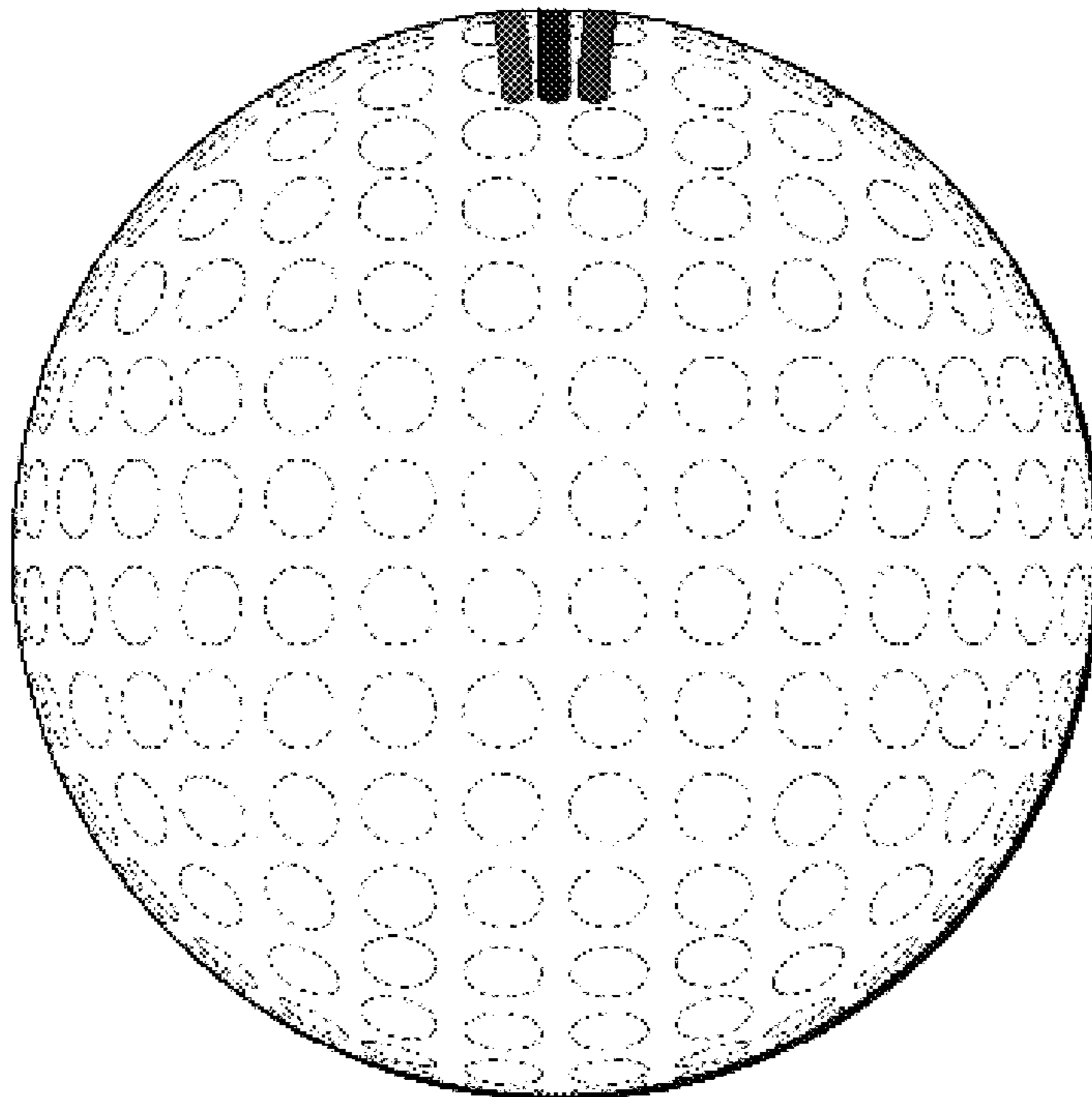

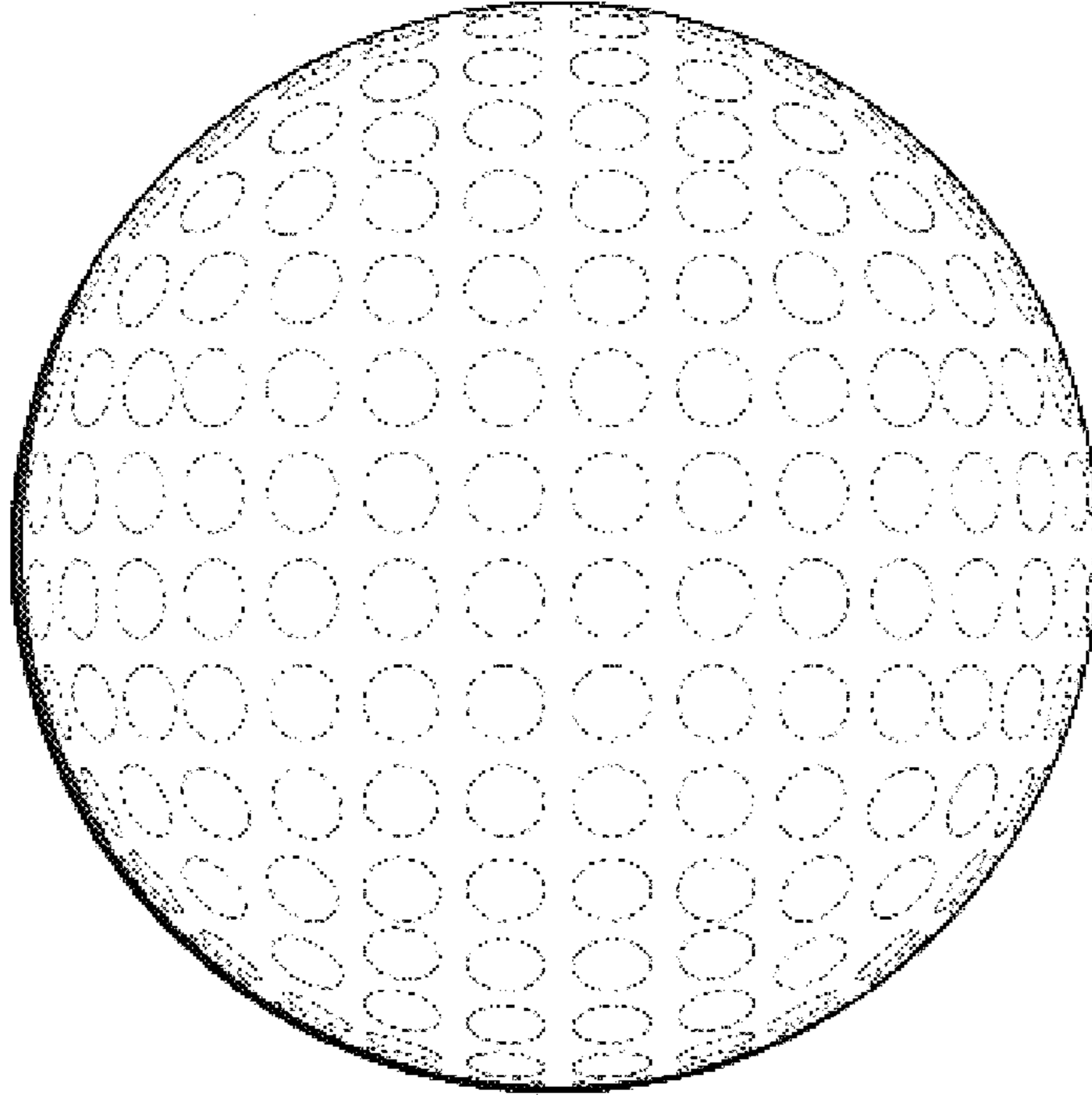

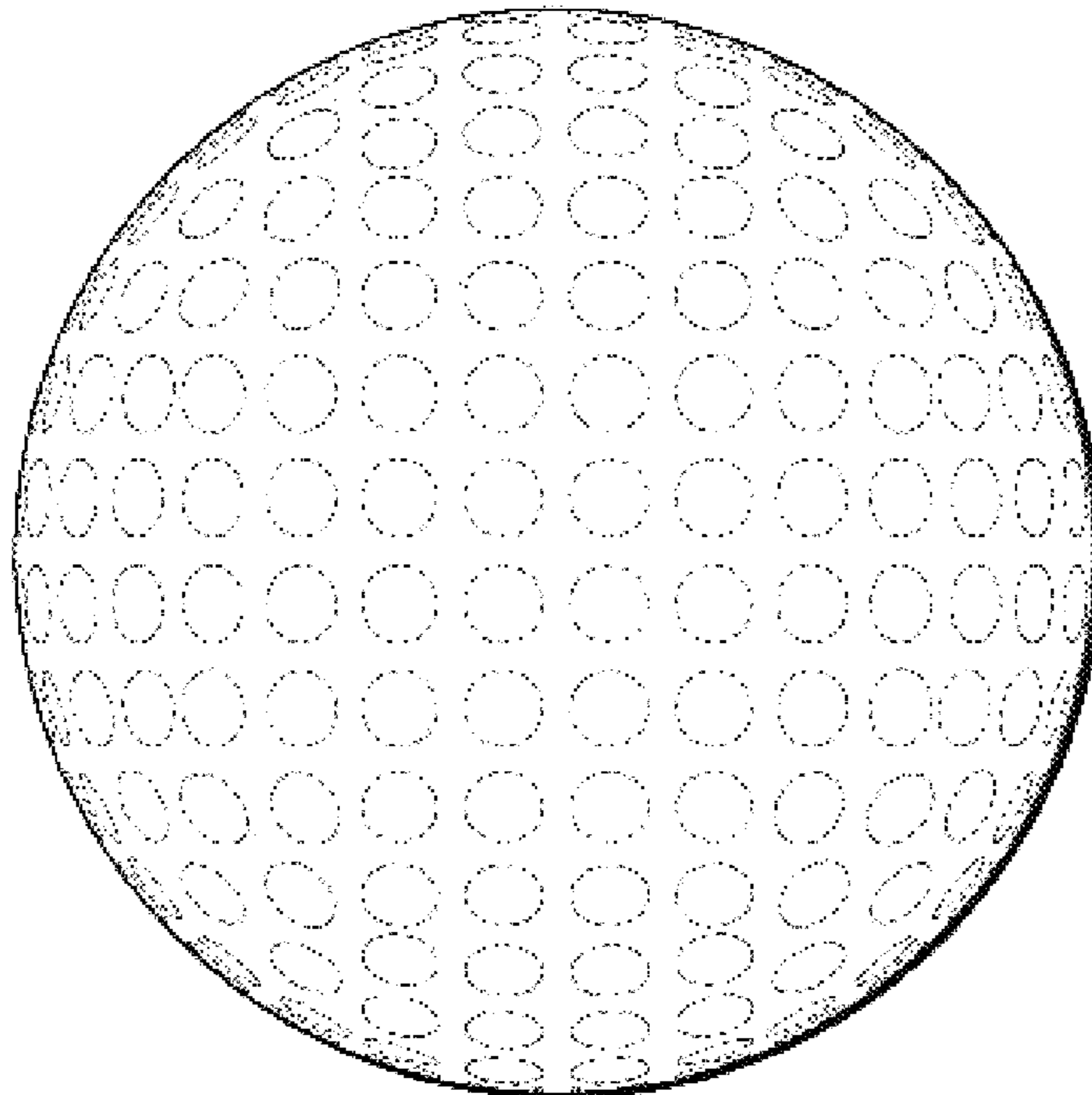

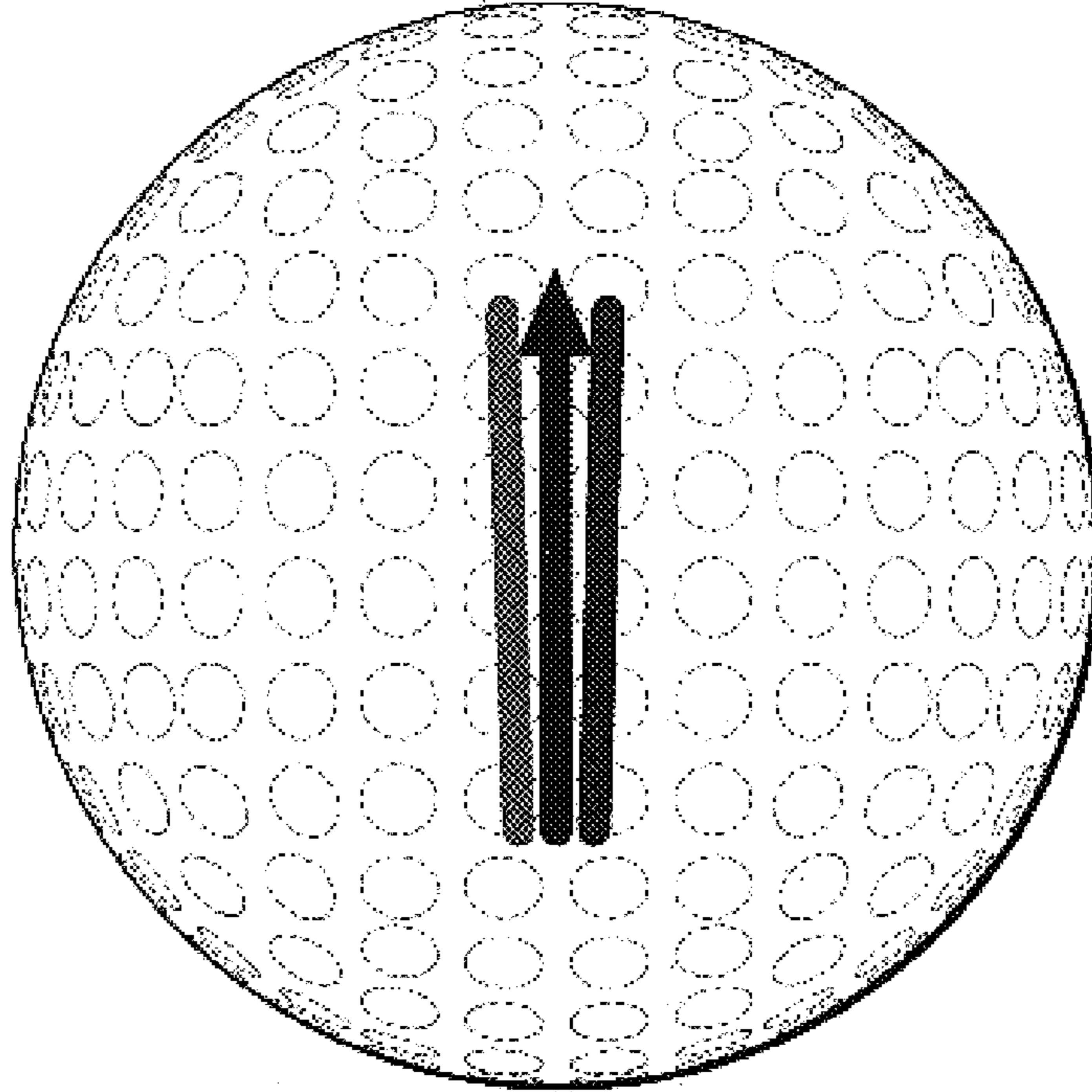

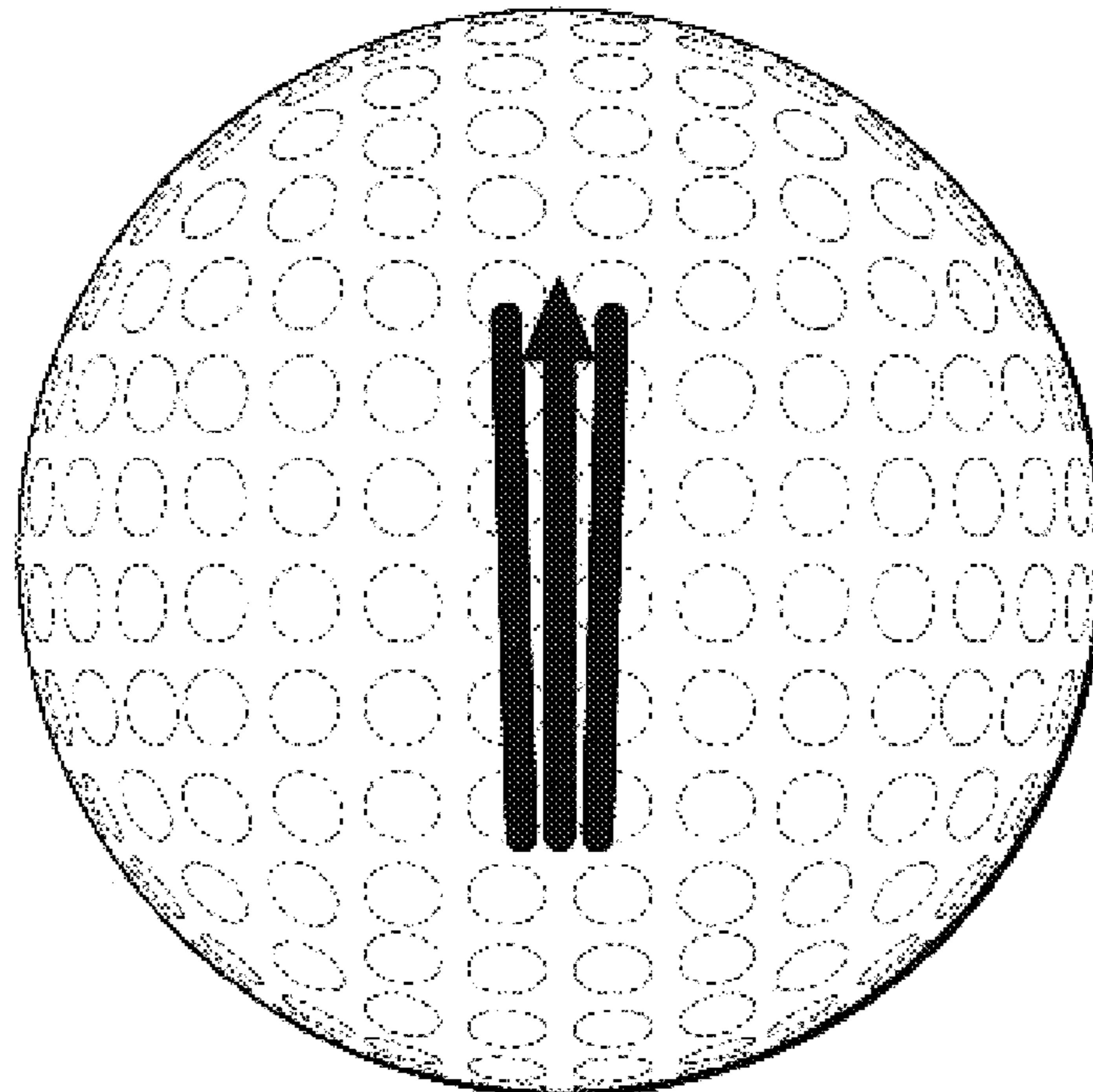

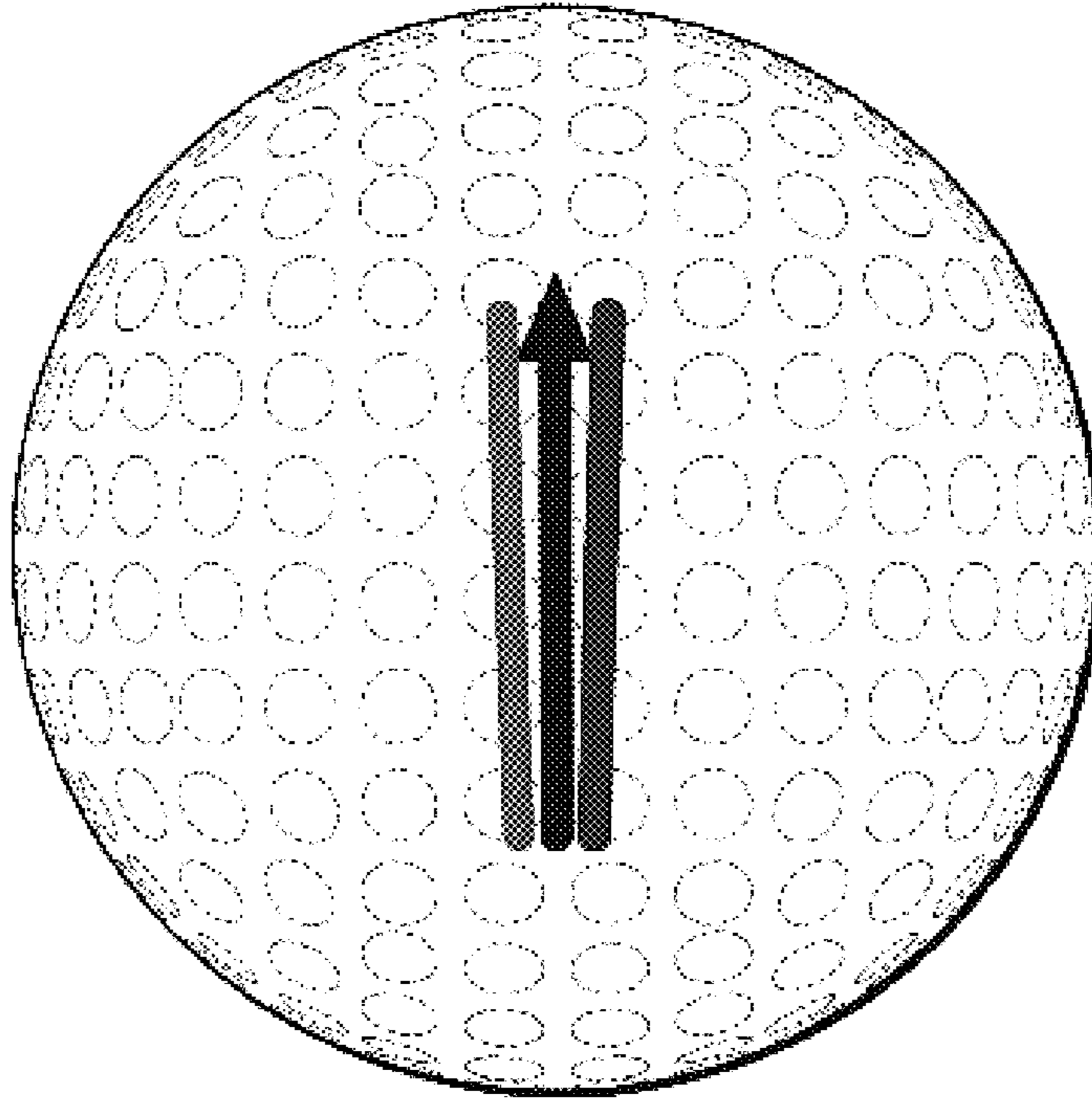
