FIG. 1 is a perspective view of a bat handle end cap showing our new design, The broken line showing is for illustrative purposes only and forms no part of the claimed design.

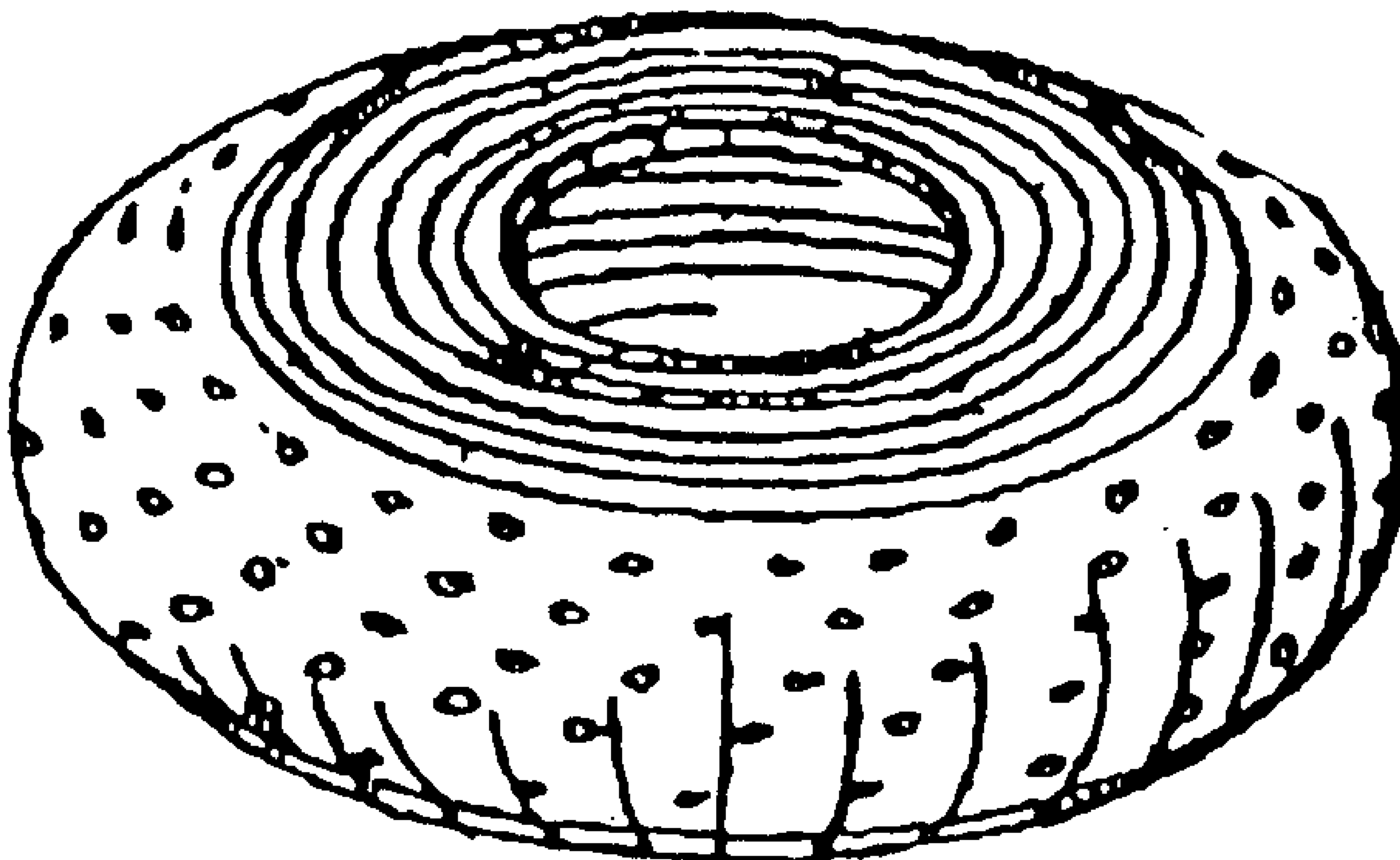
FIG. 2 is an isometric view thereof;

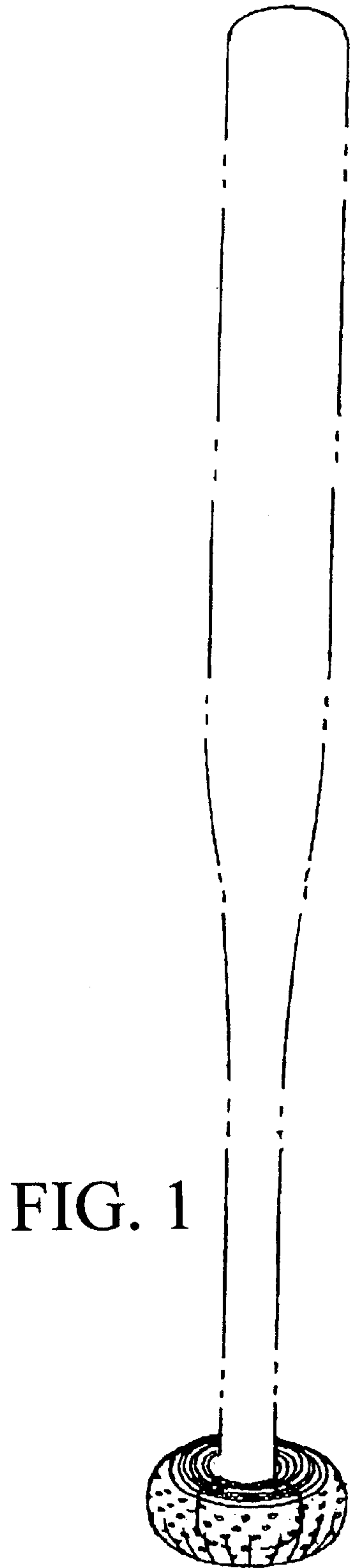

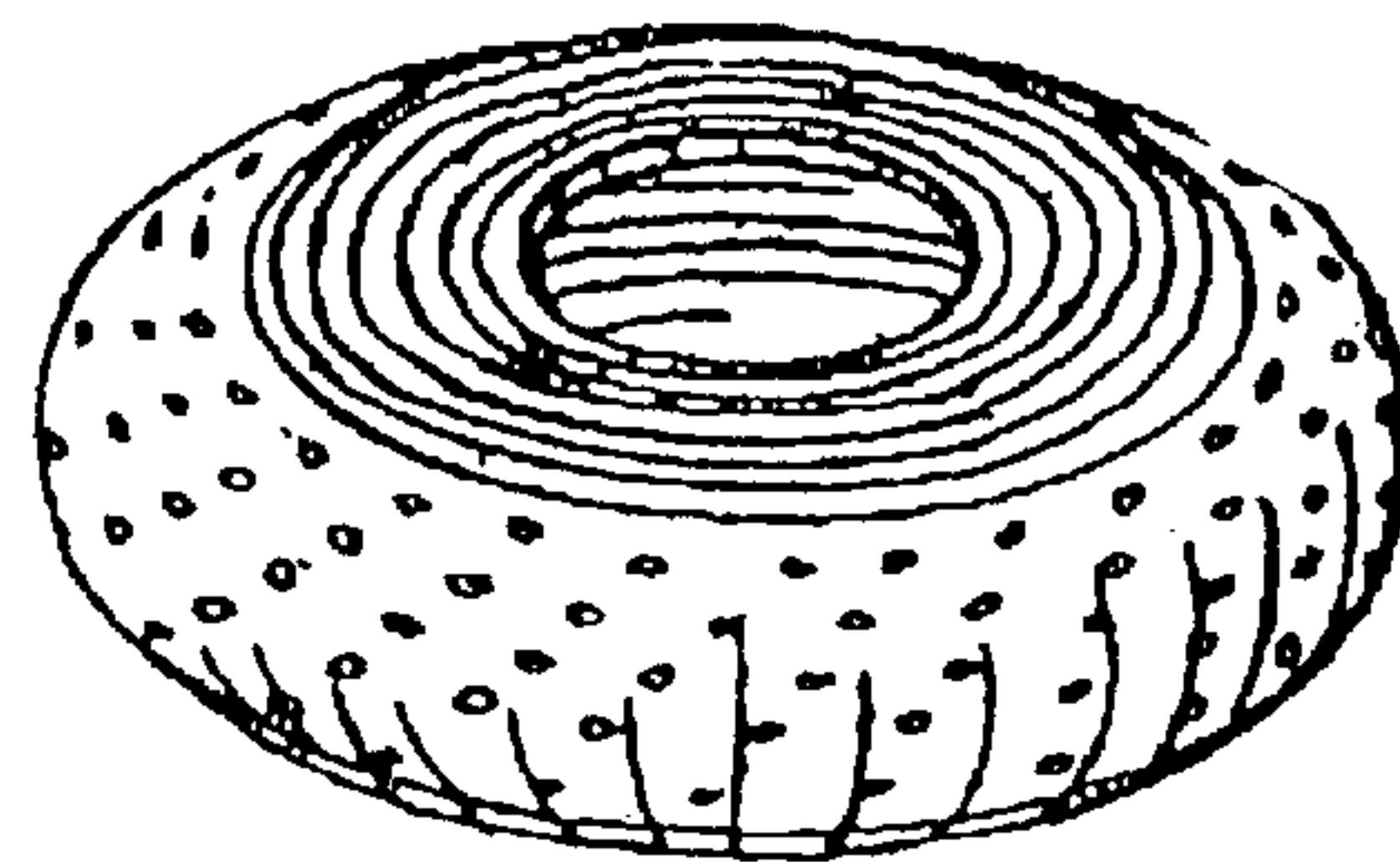

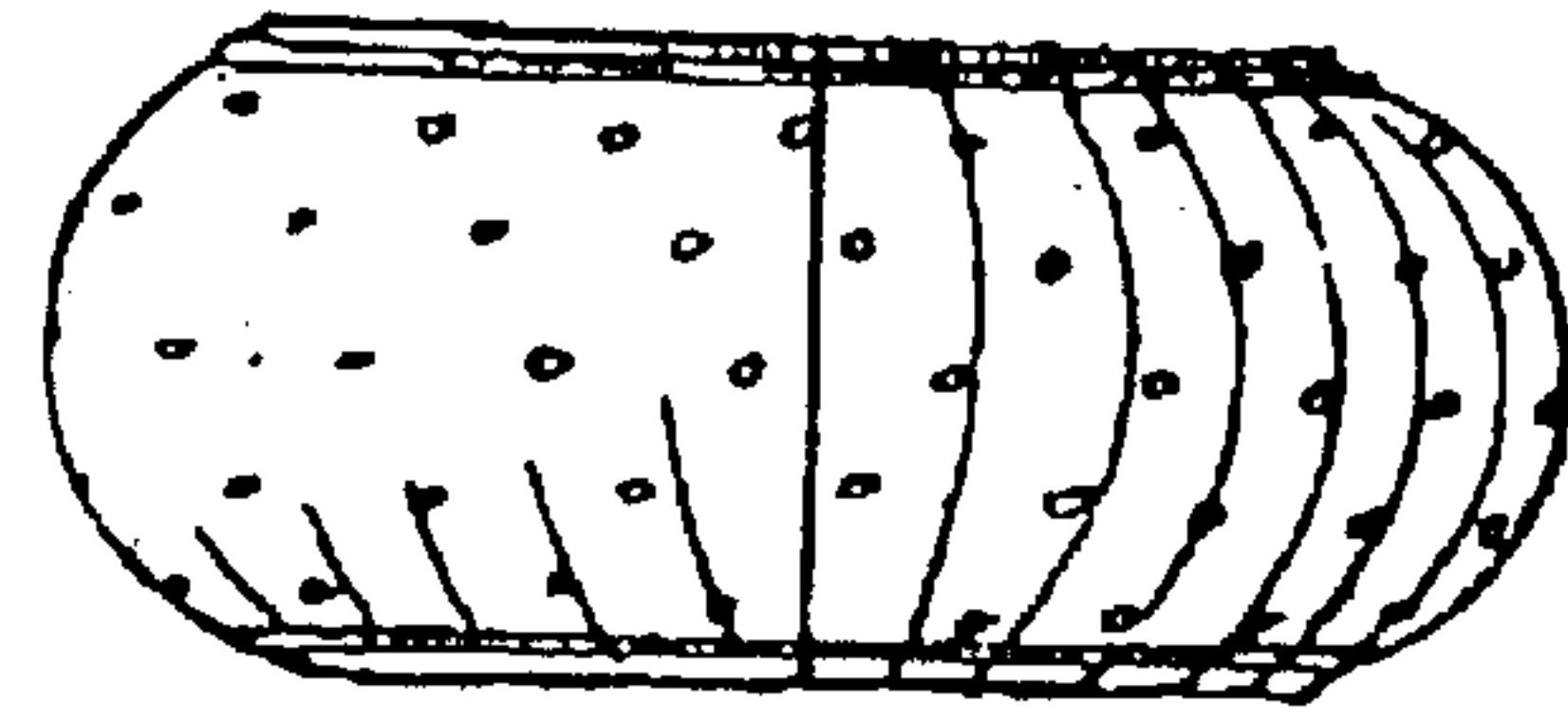

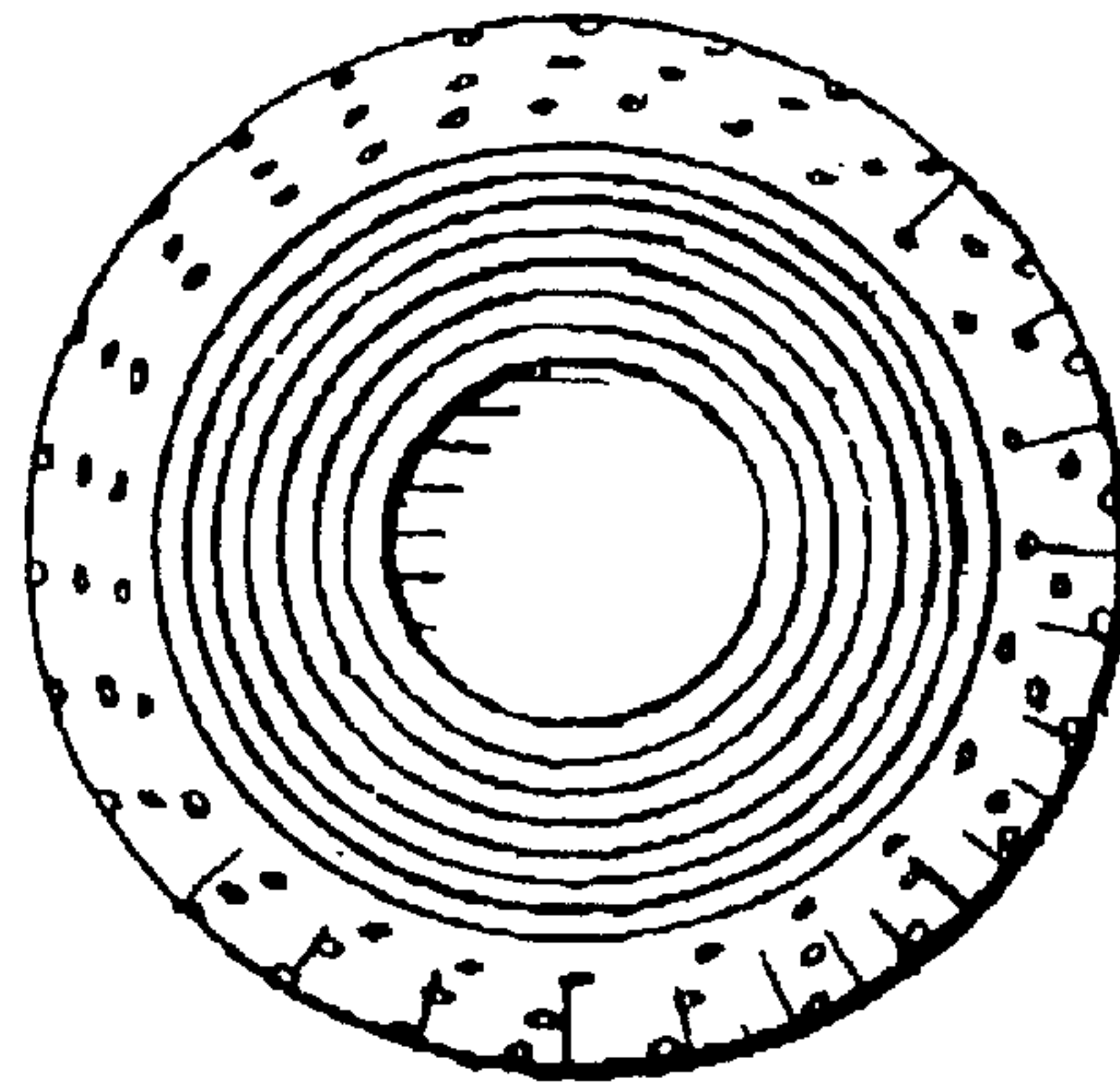
