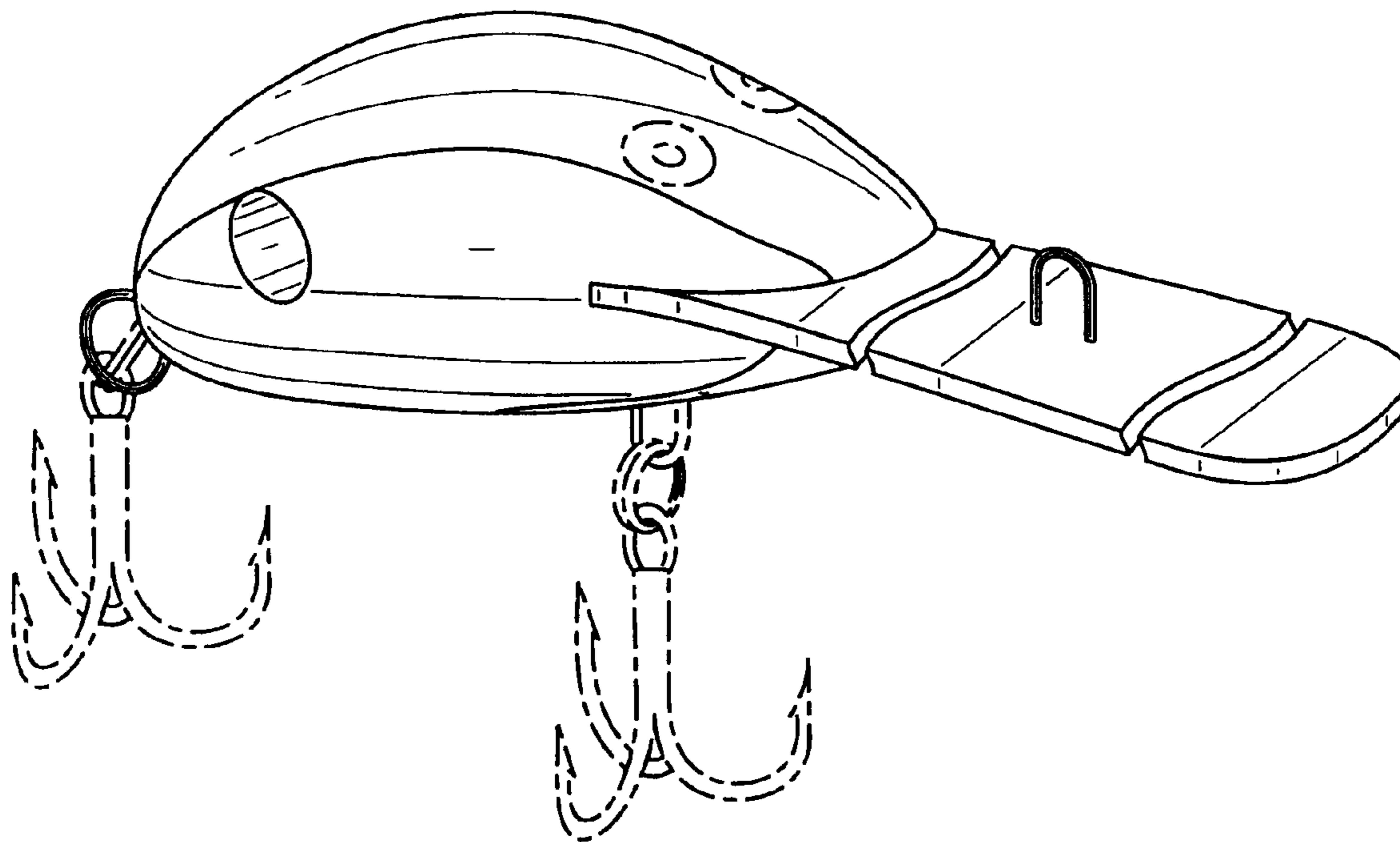
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of an artificial lure.  
 FIG. 2 is a front elevation view of an artificial lure.  
 FIG. 3 is a rear elevation view of an artificial lure.  
 FIG. 4 is a right side view of an artificial lure.  
 FIG. 5 is a left side view of an artificial lure.  
 FIG. 6 is a top plan view of an artificial lure; and,  
 FIG. 7 is a bottom plan view of an artificial lure.  
 The lip is shown broken away to indicate indeterminate length.

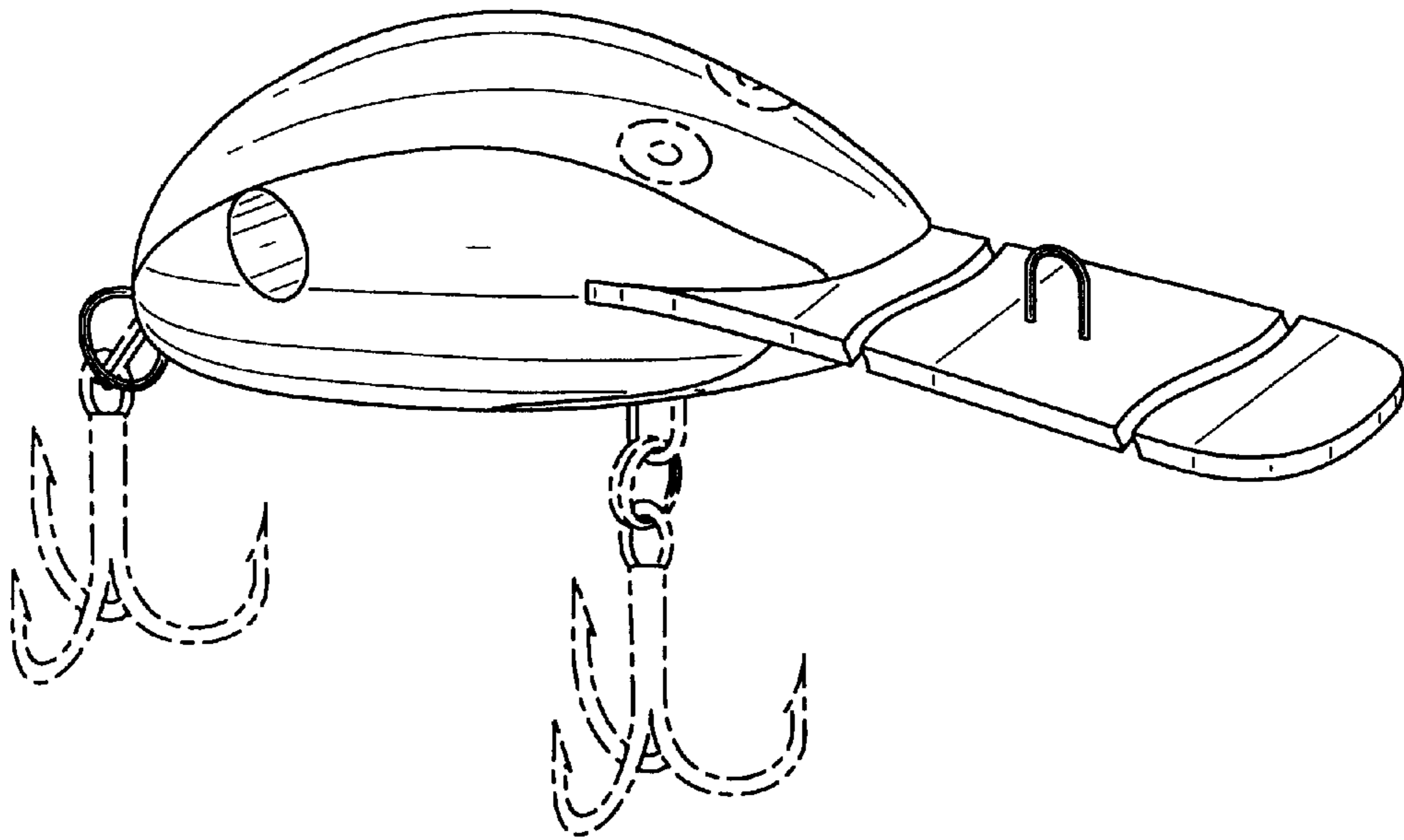

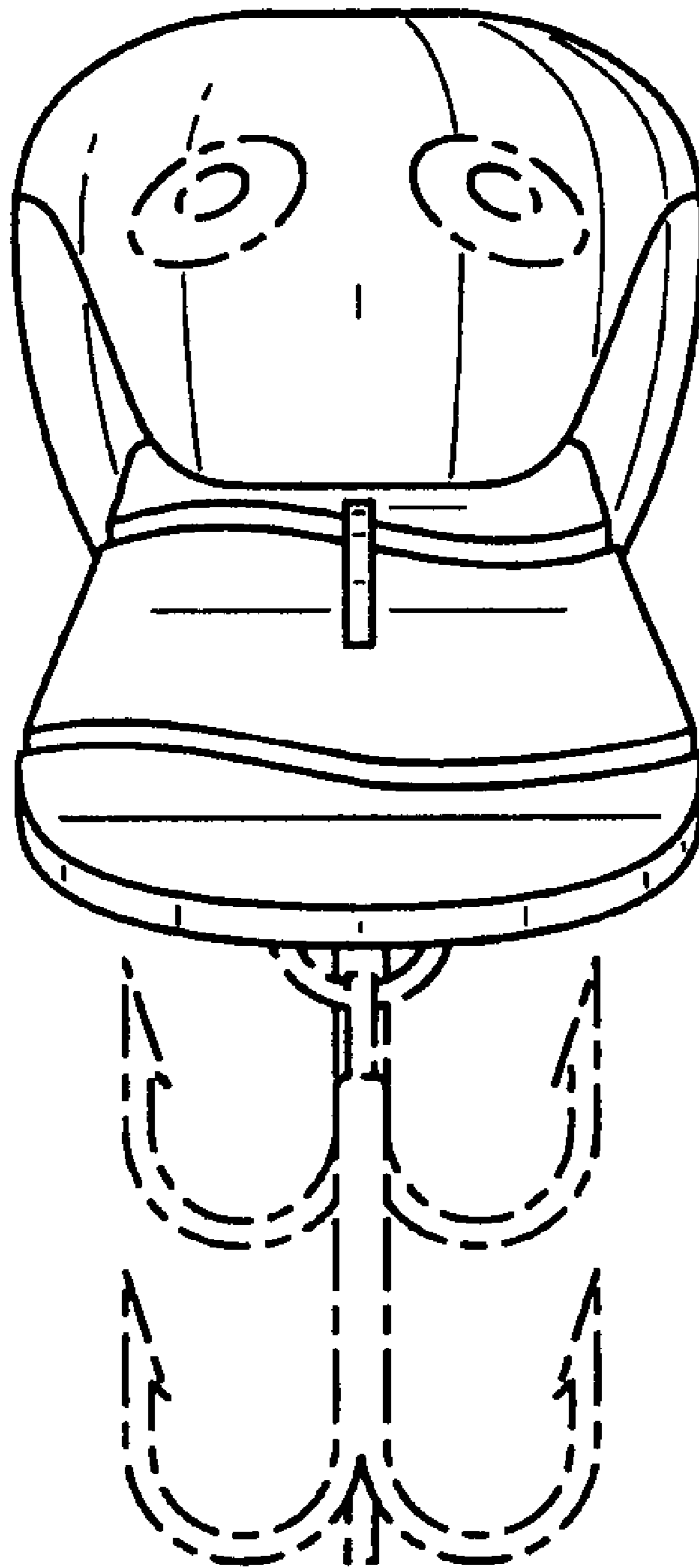

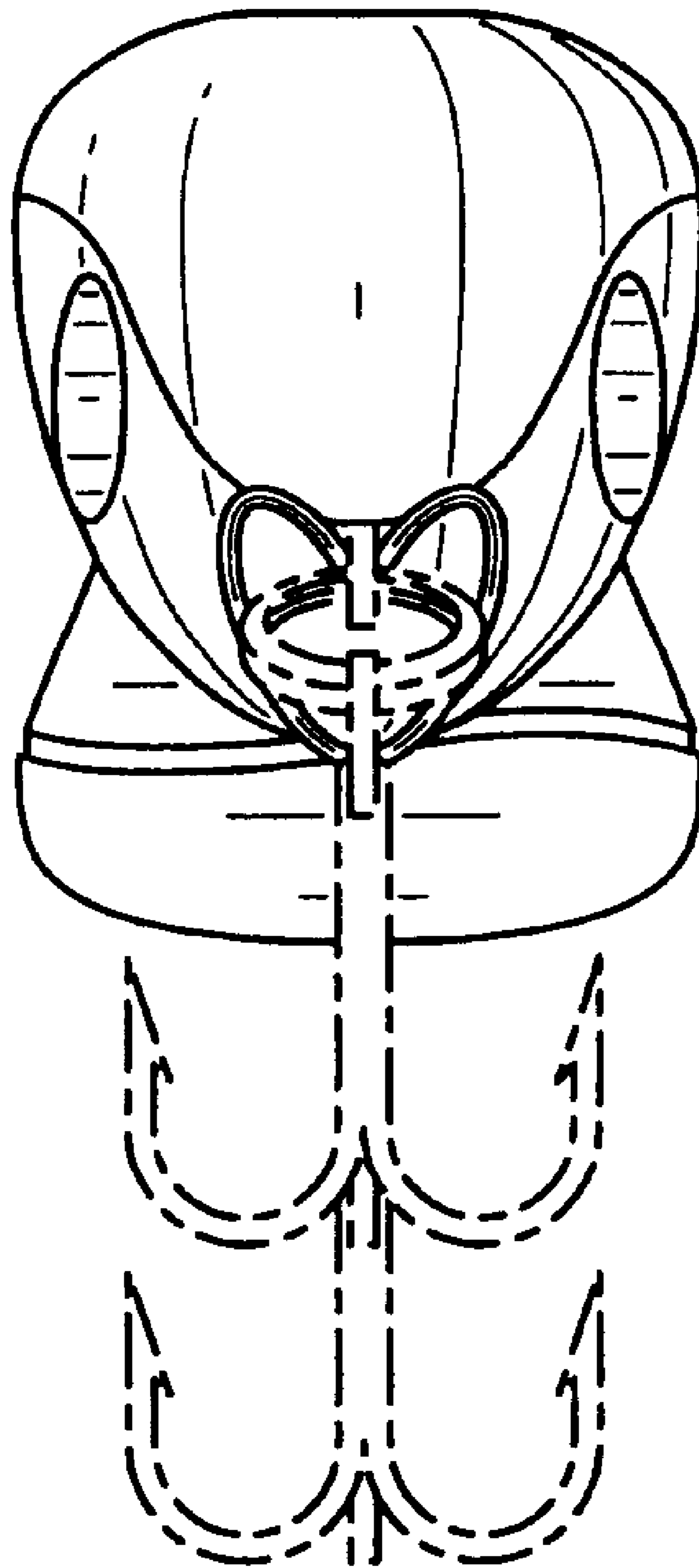

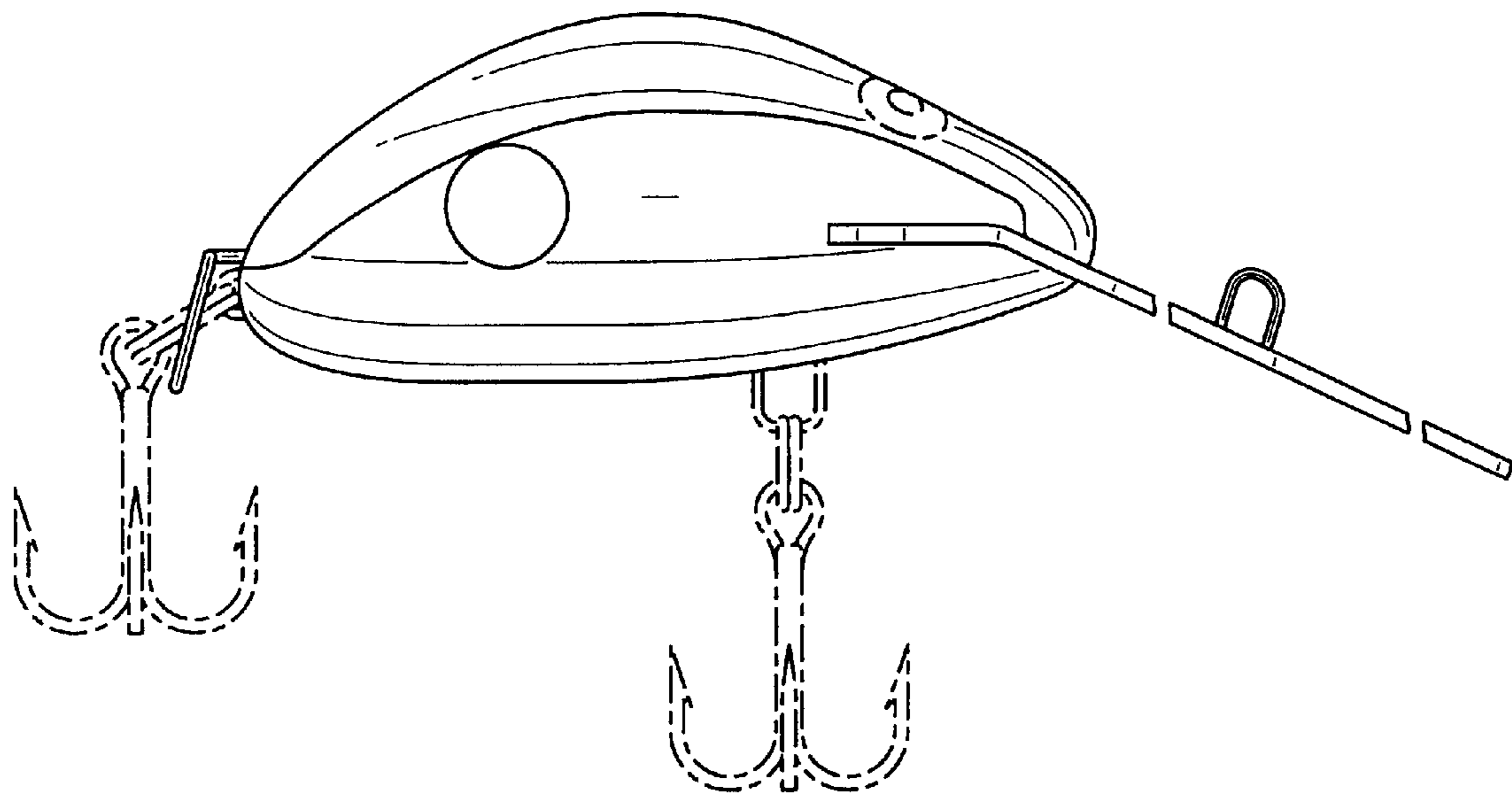

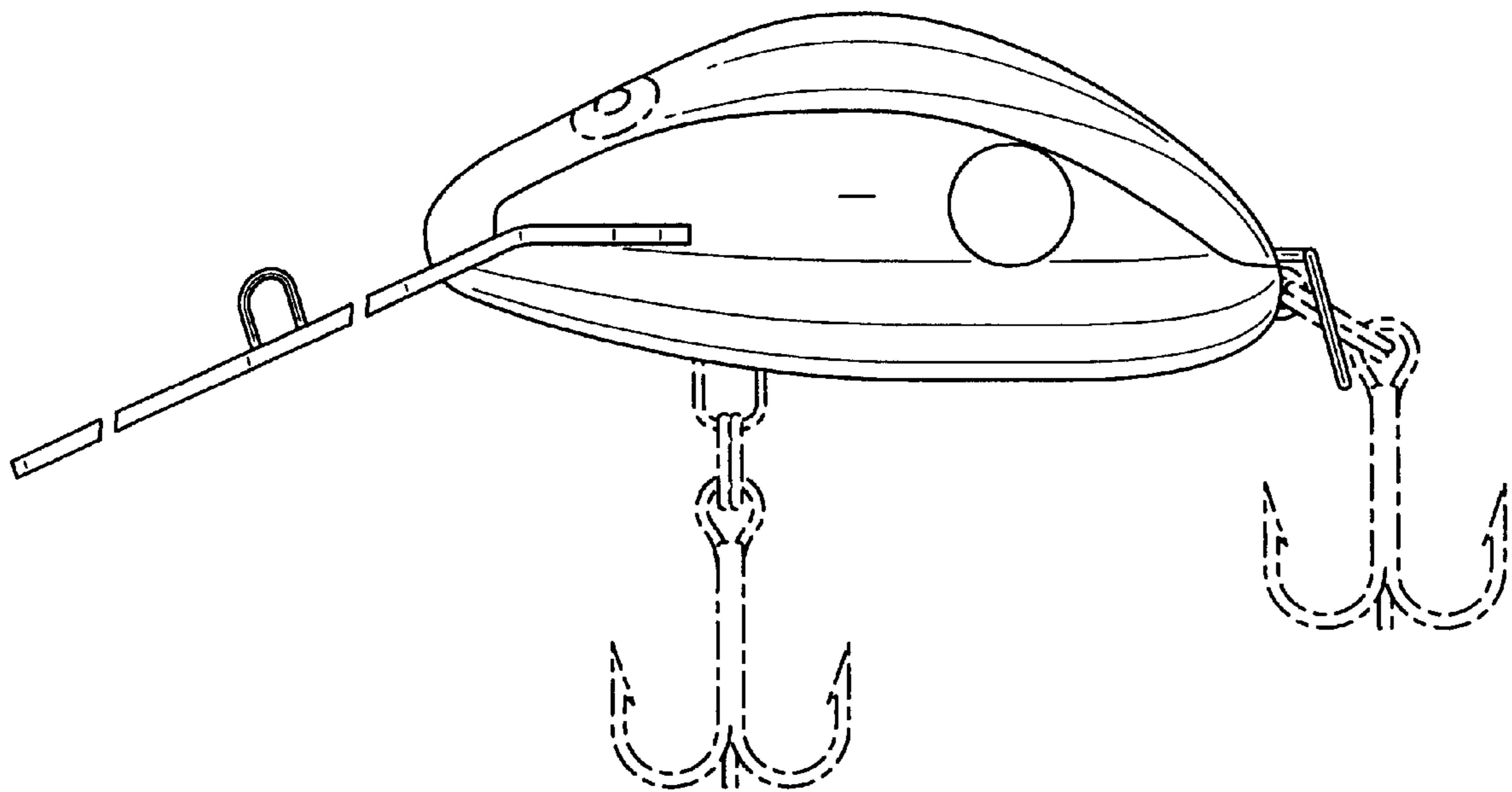

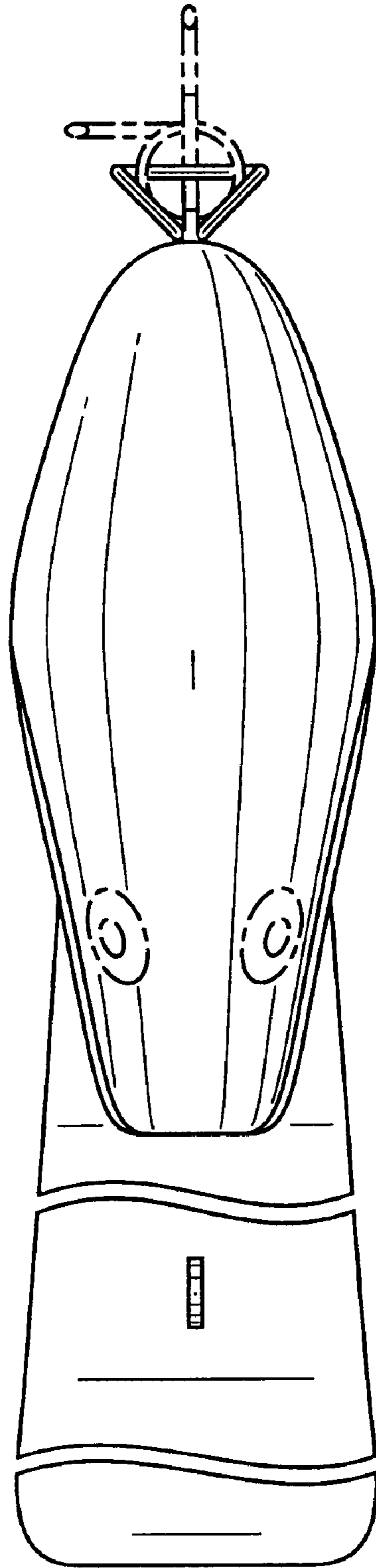

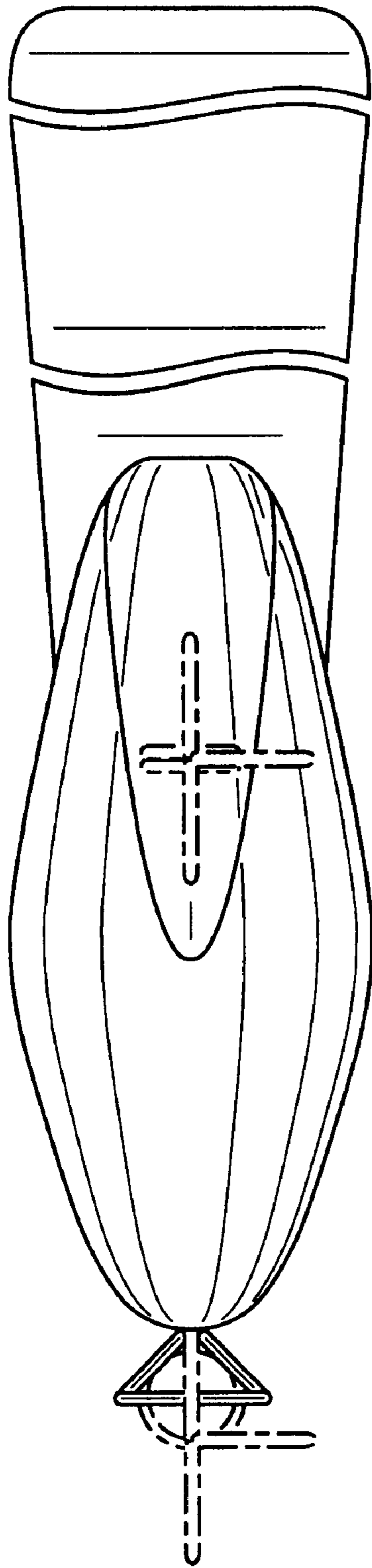
