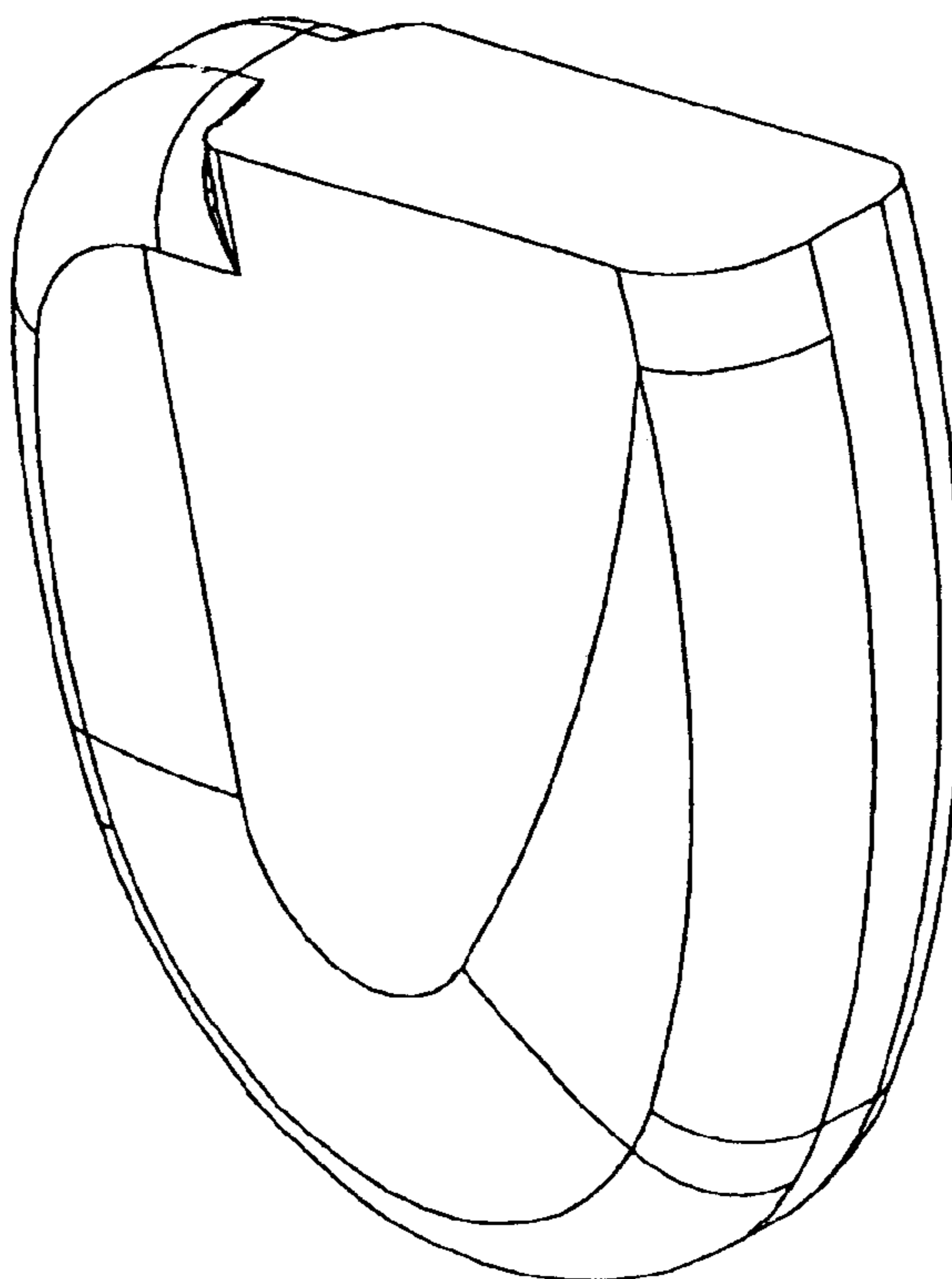
(57) **CLAIM**

The ornamental design for an implantable medical device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and front perspective view of an implantable medical device showing our new design;  
FIG. 2 is another top perspective view thereof;  
FIG. 3 is a left side perspective view thereof;  
FIG. 4 is an end perspective view thereof;  
FIG. 5 is an end perspective view thereof taken from the end opposite that shown in FIG. 4;

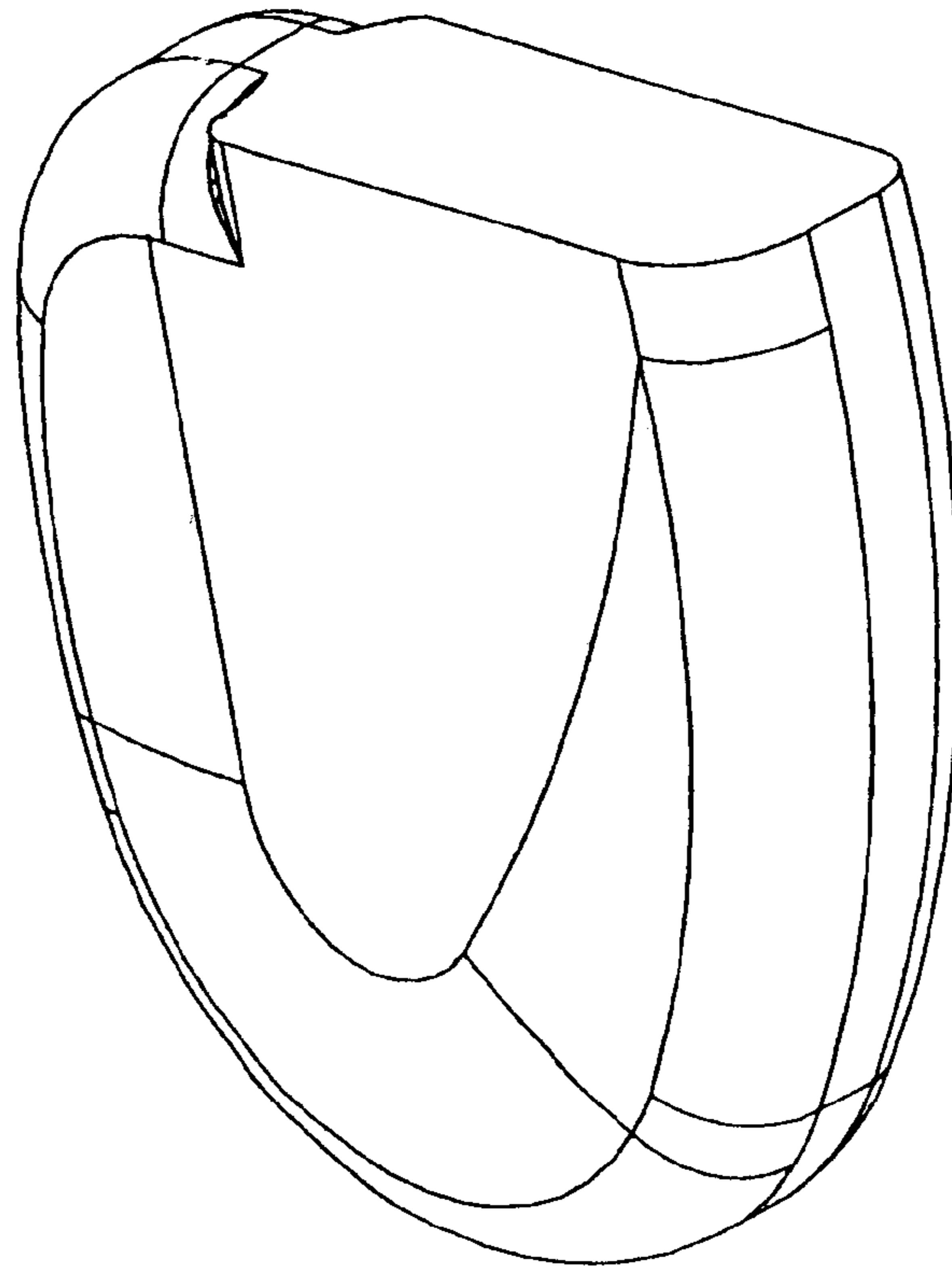

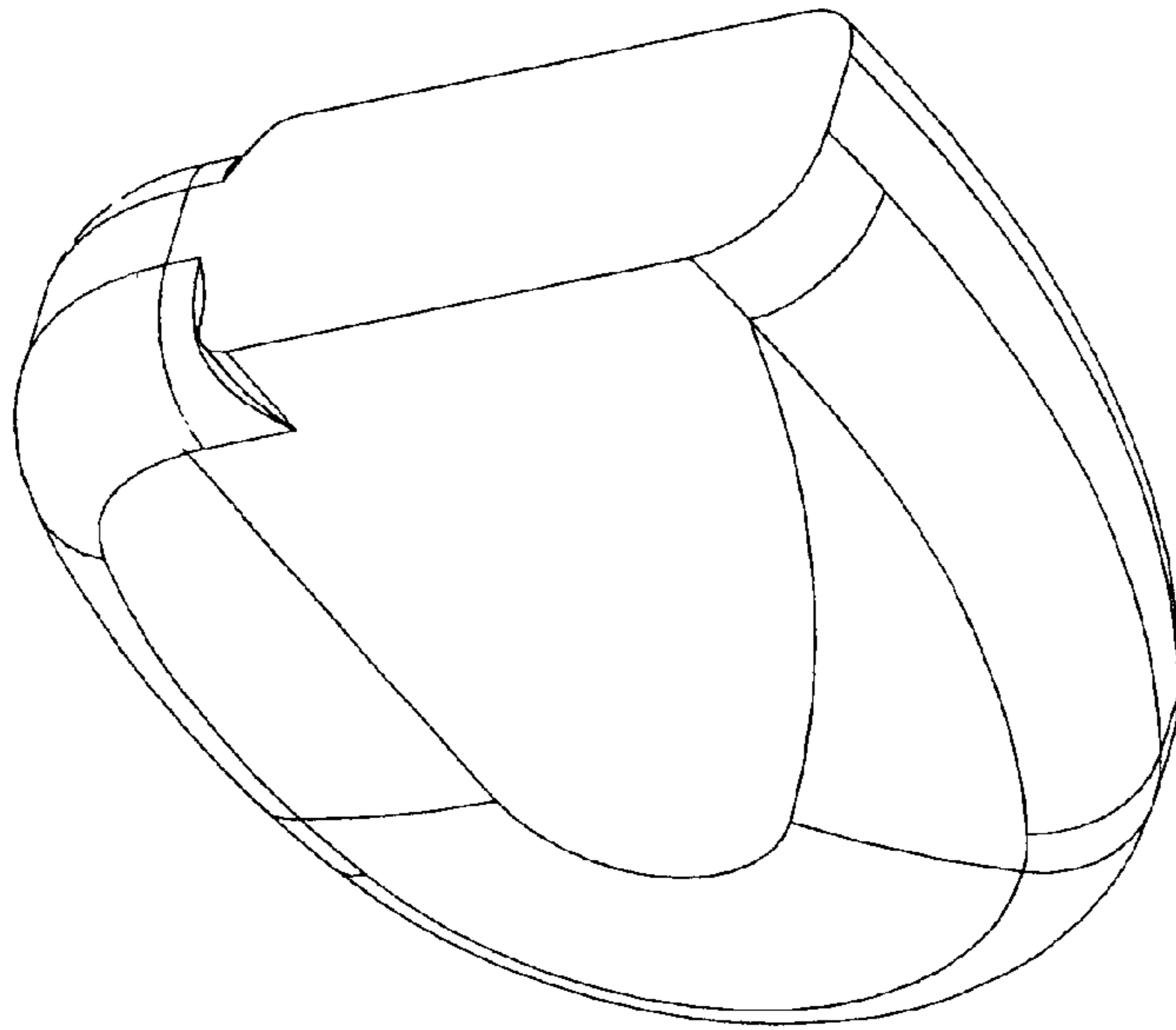

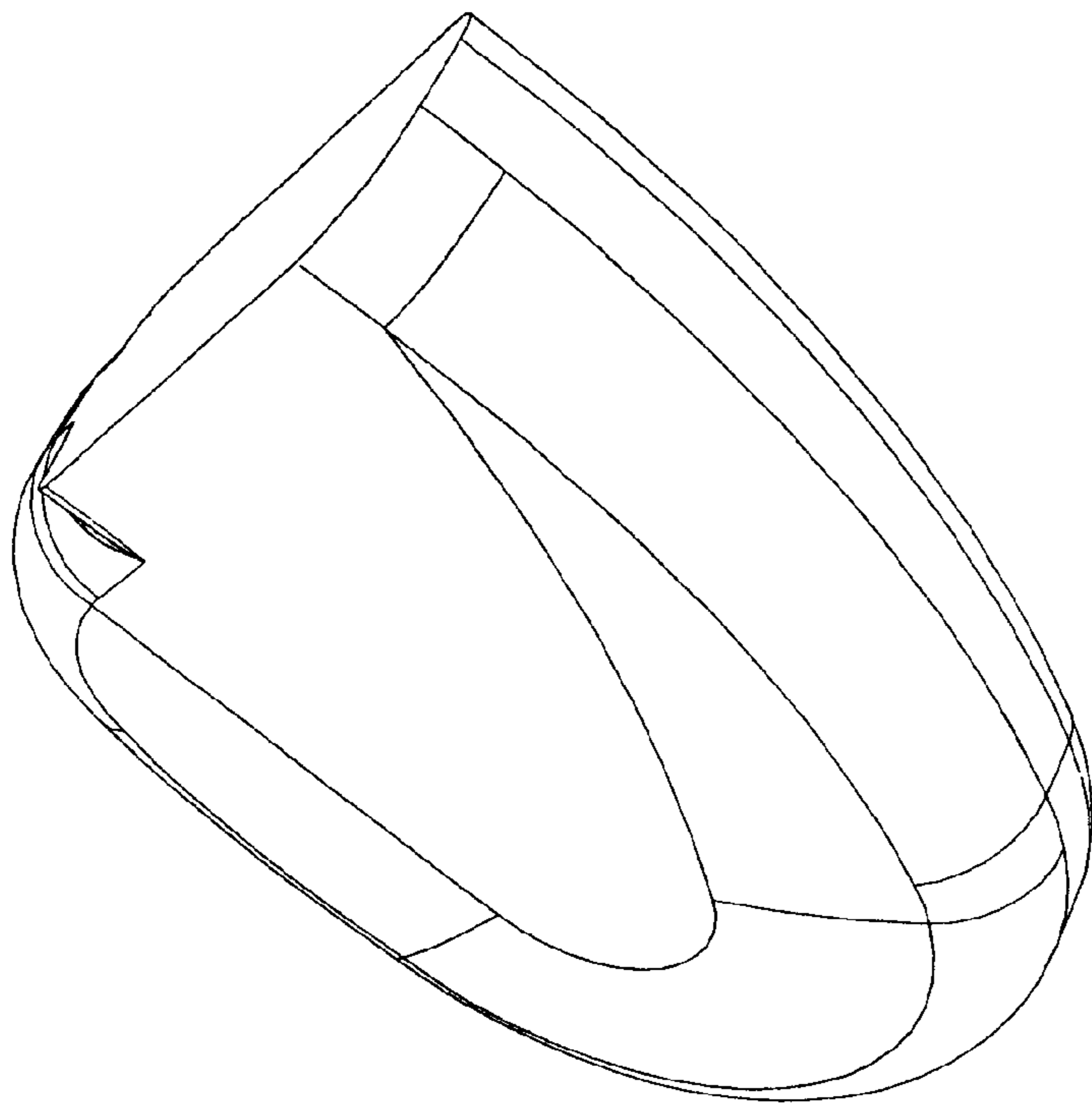

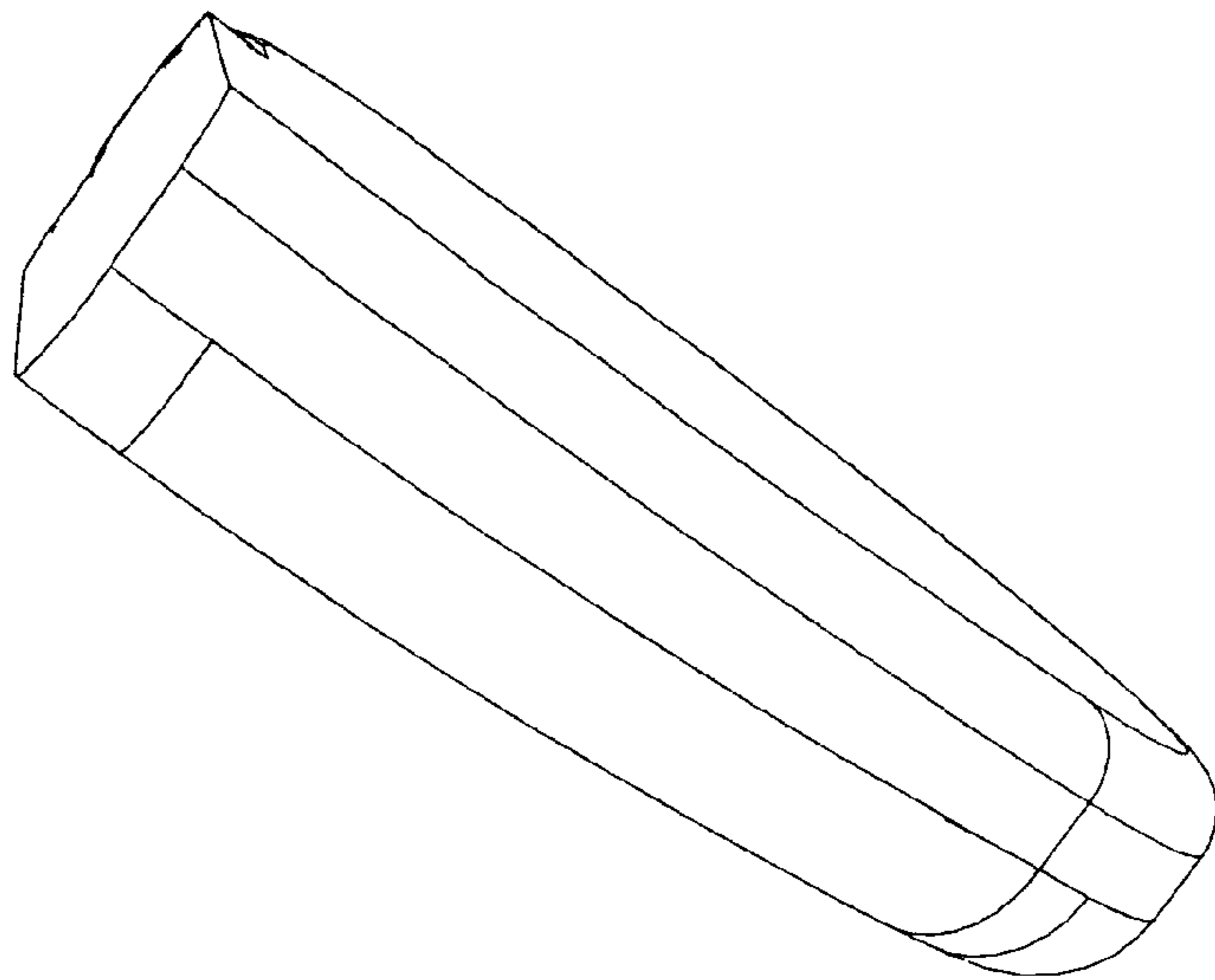

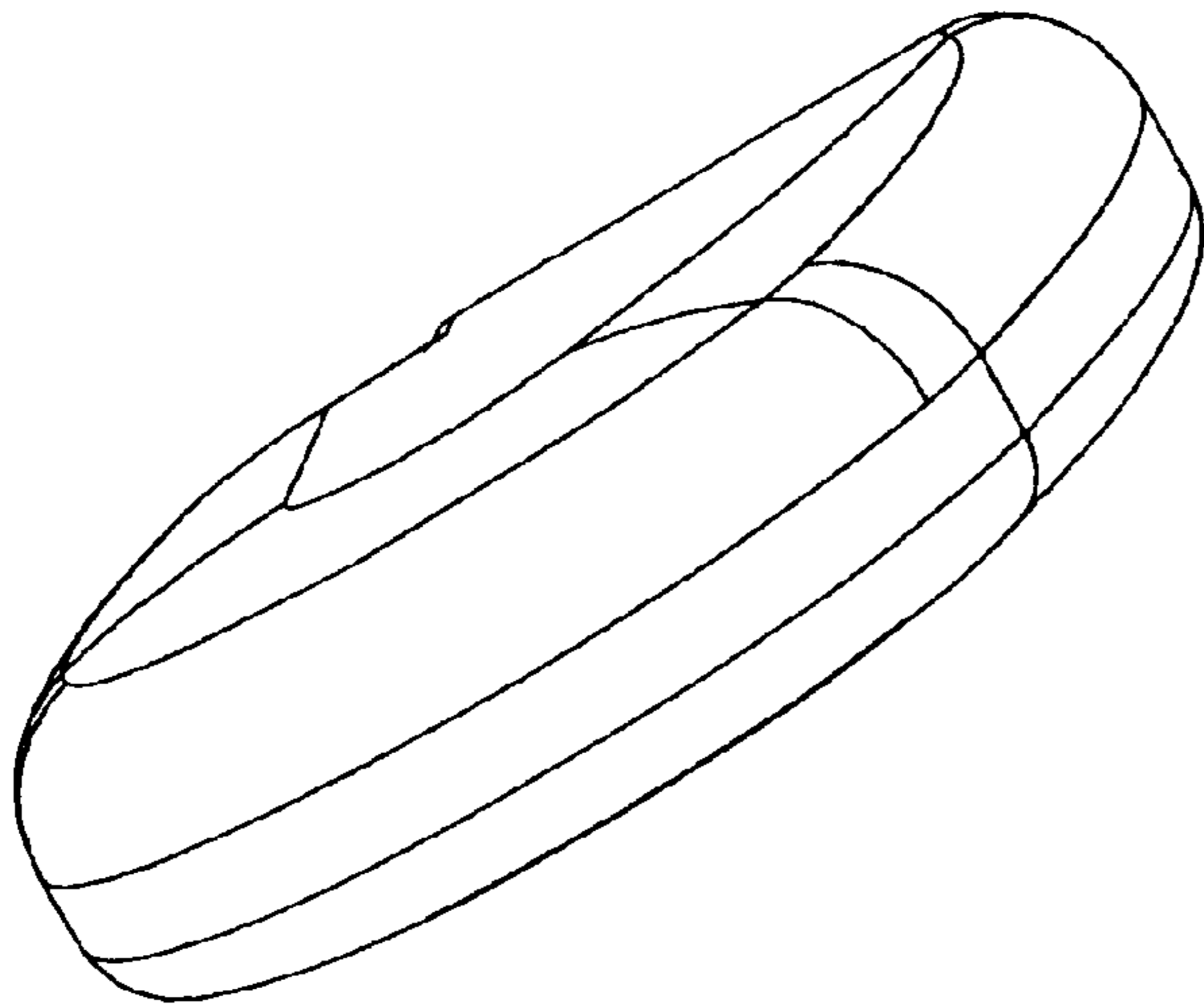

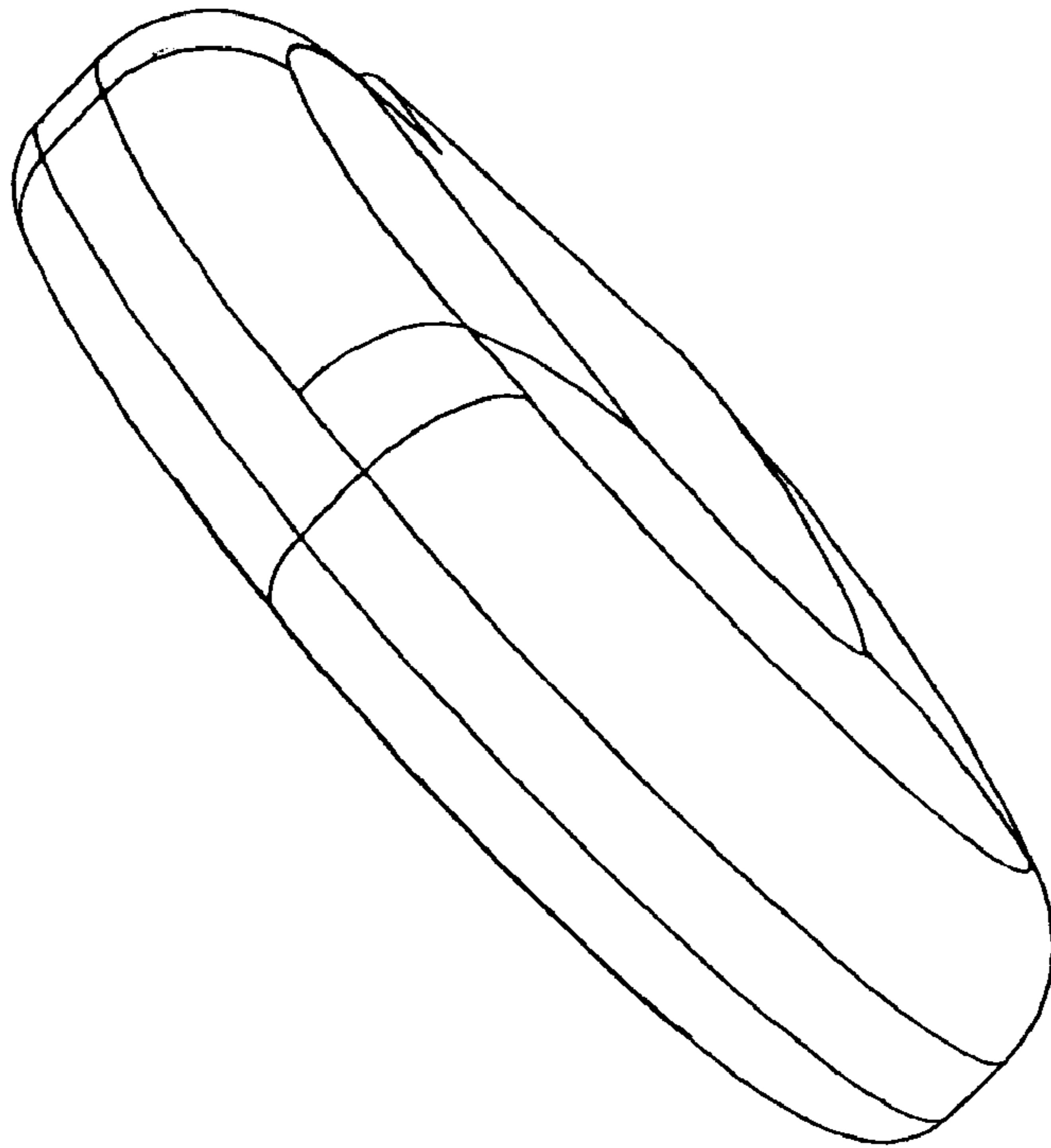

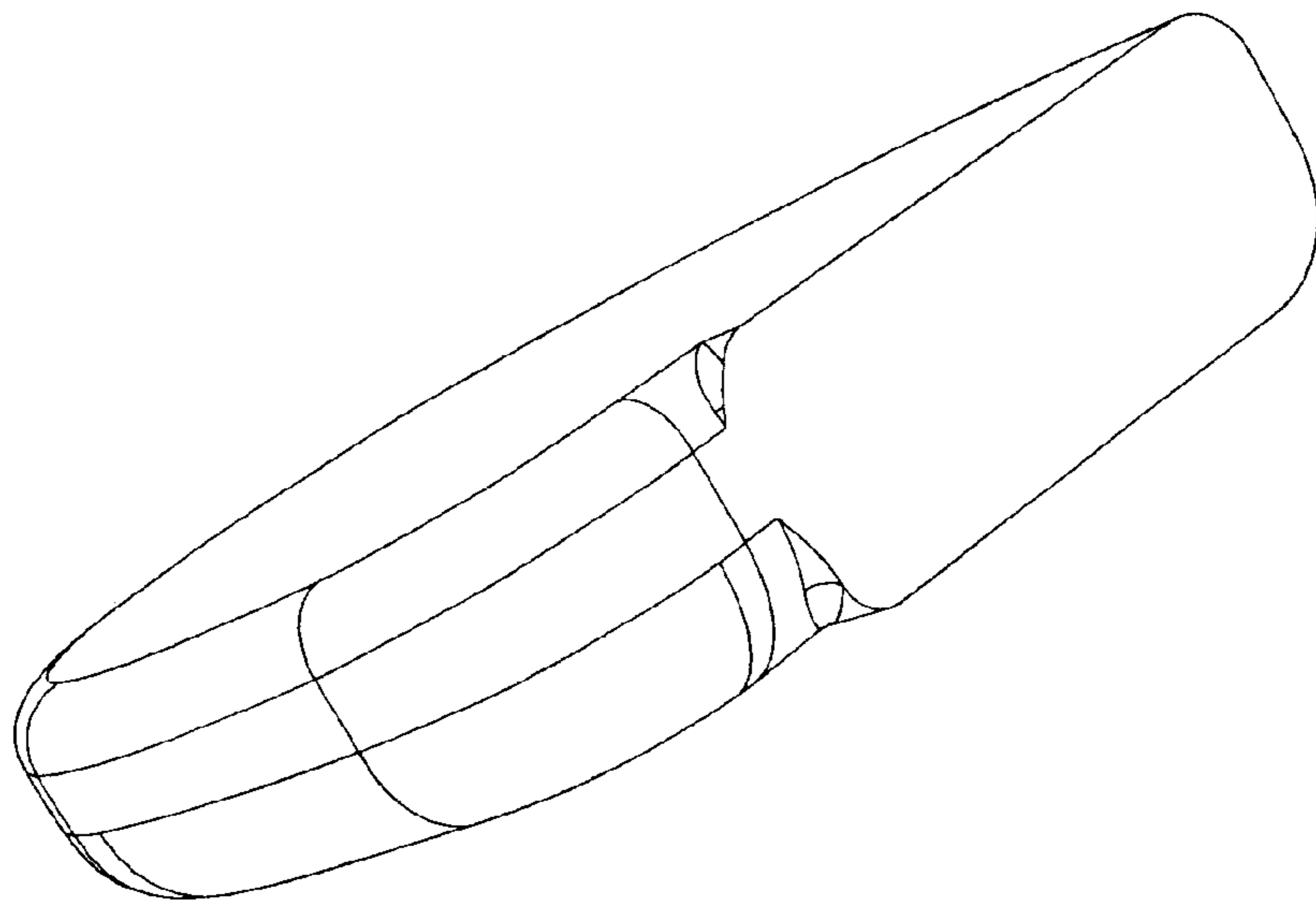

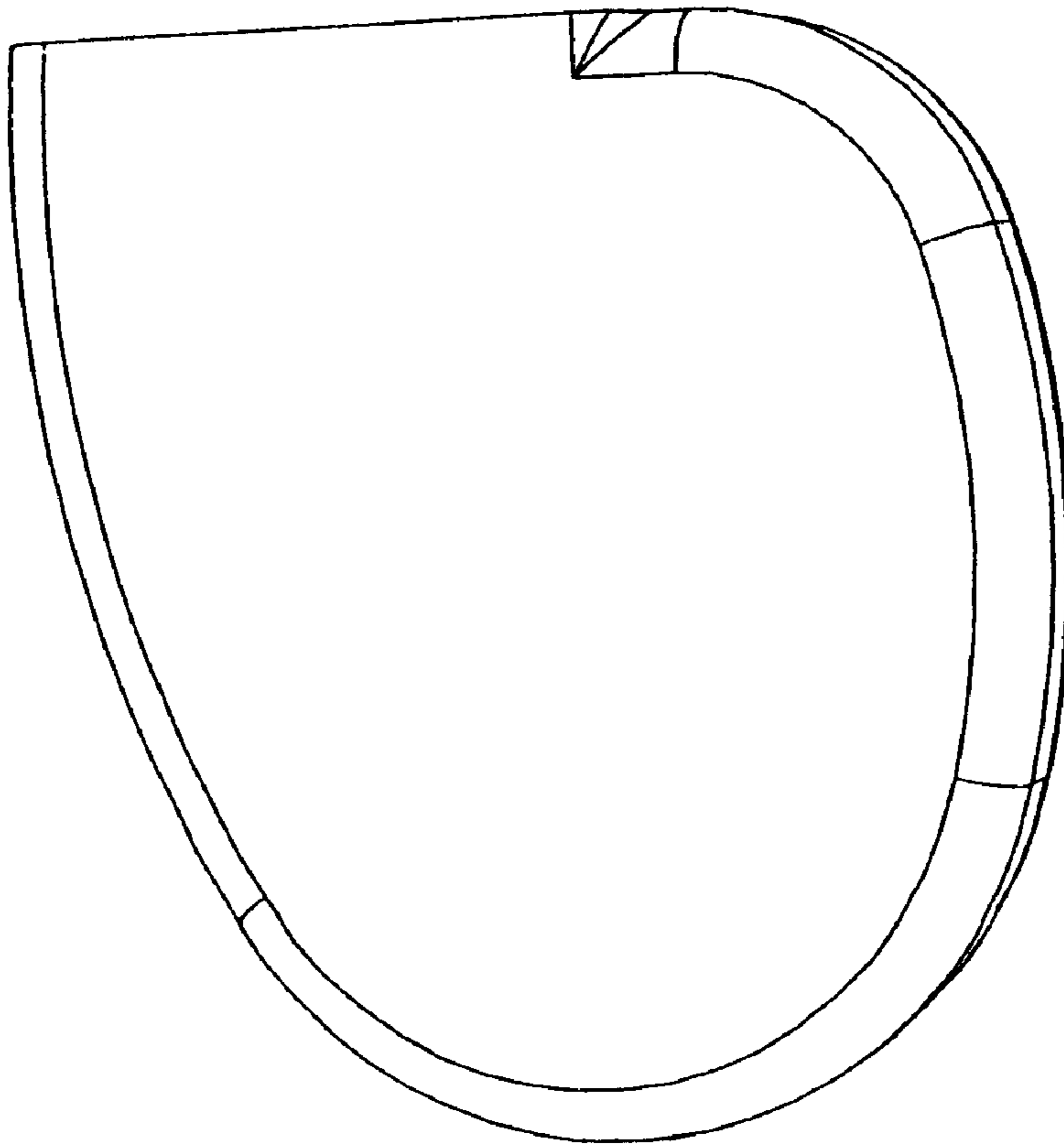
