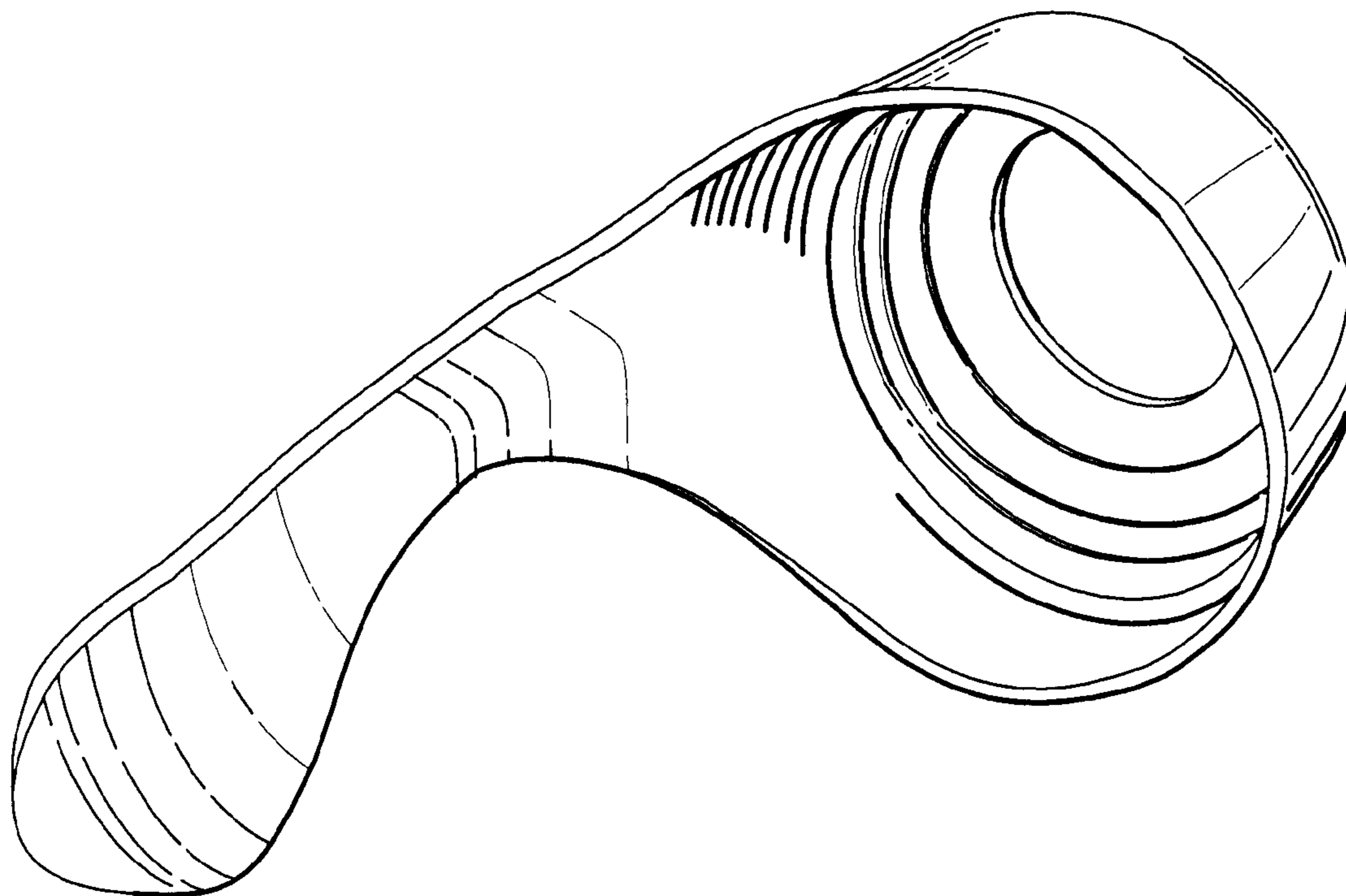
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a handle for baby bottle in accordance with our design;

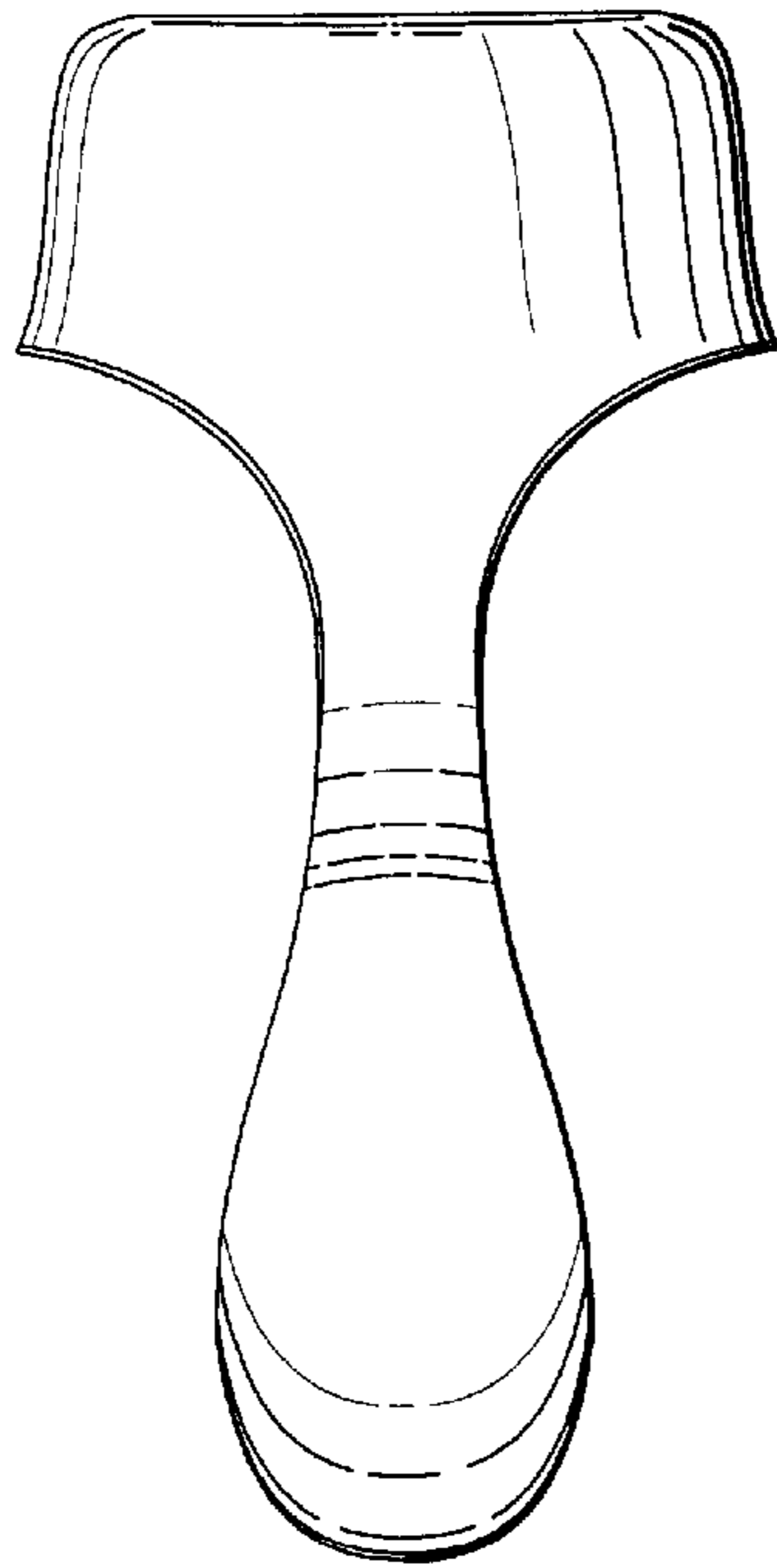

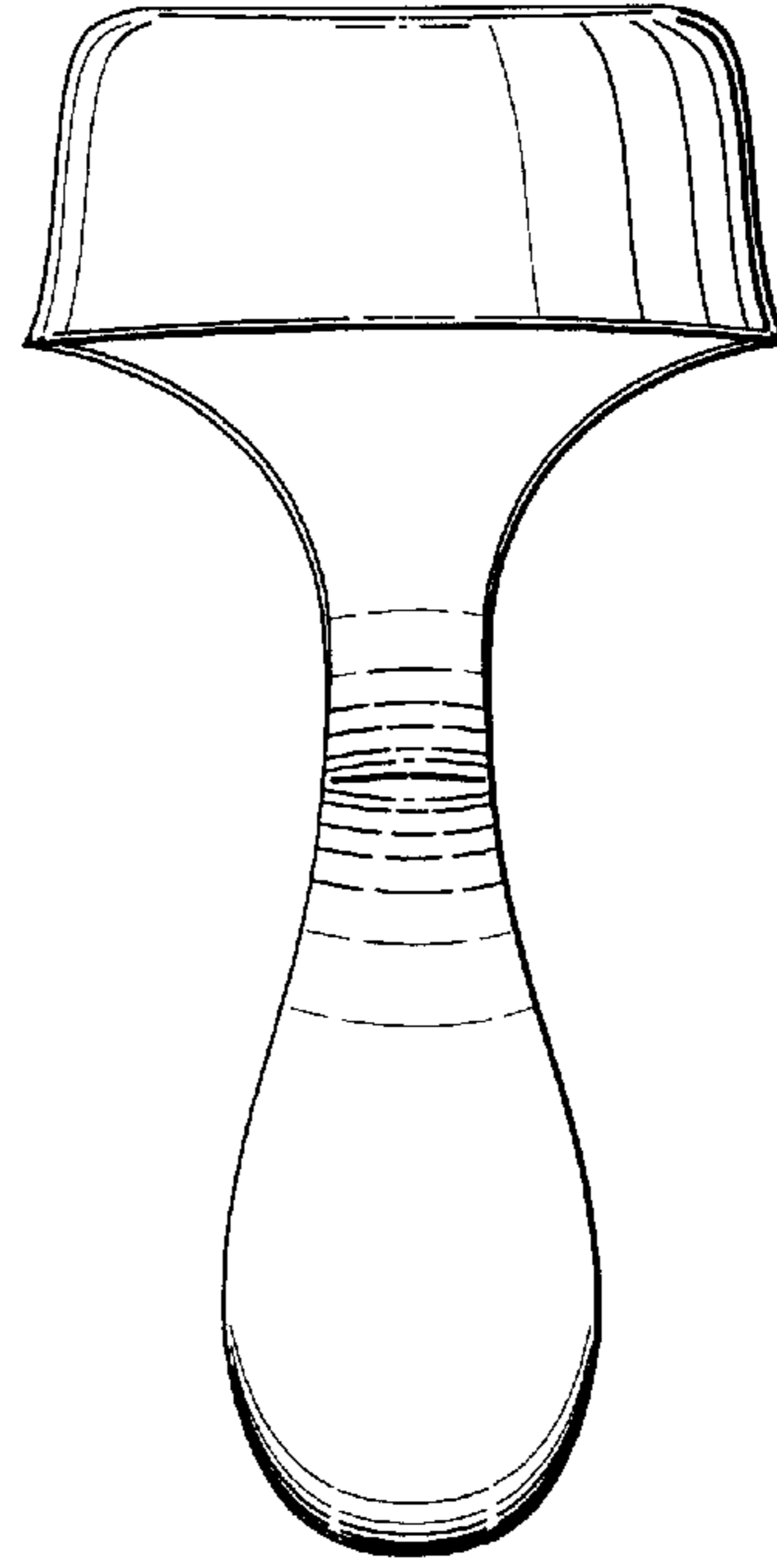

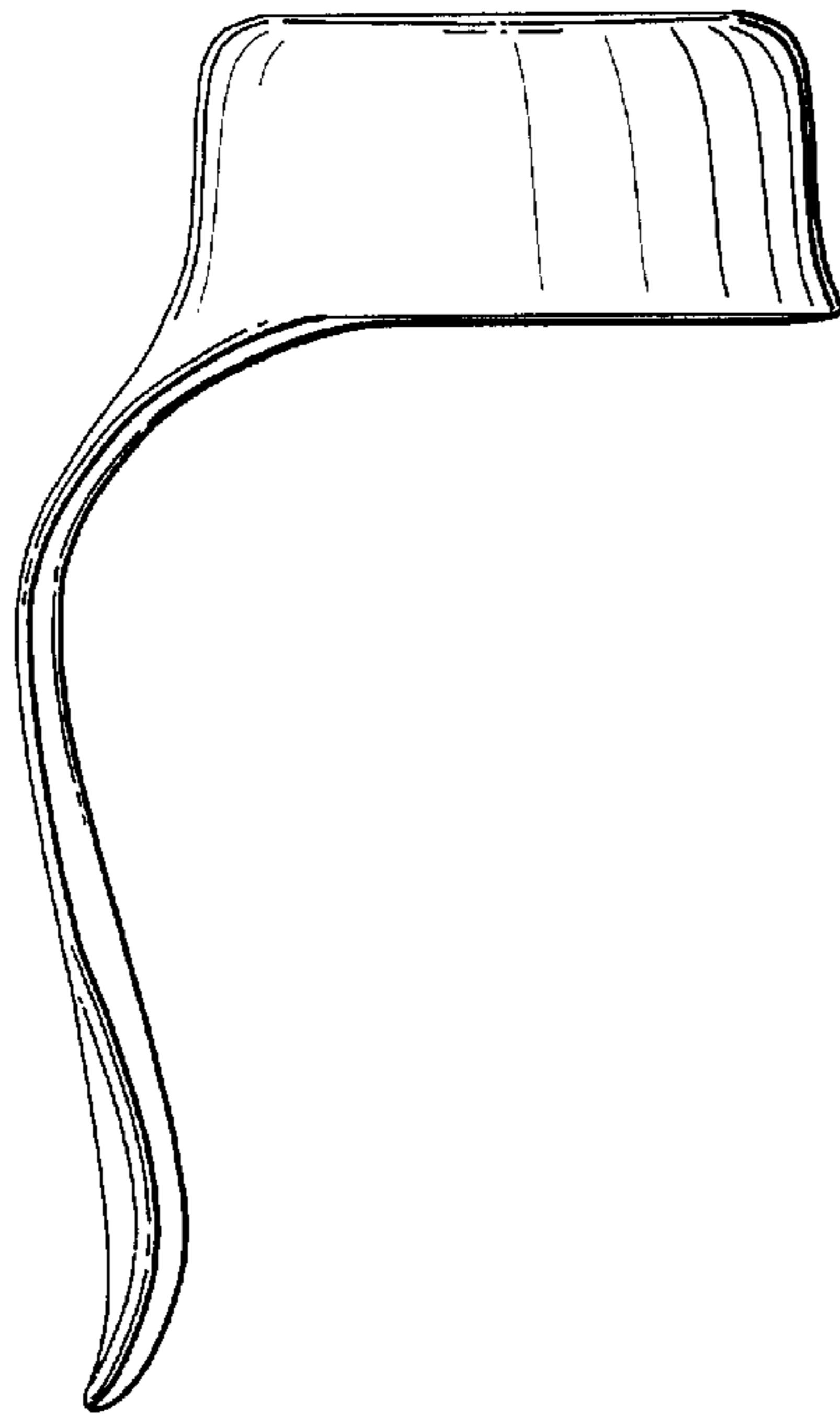

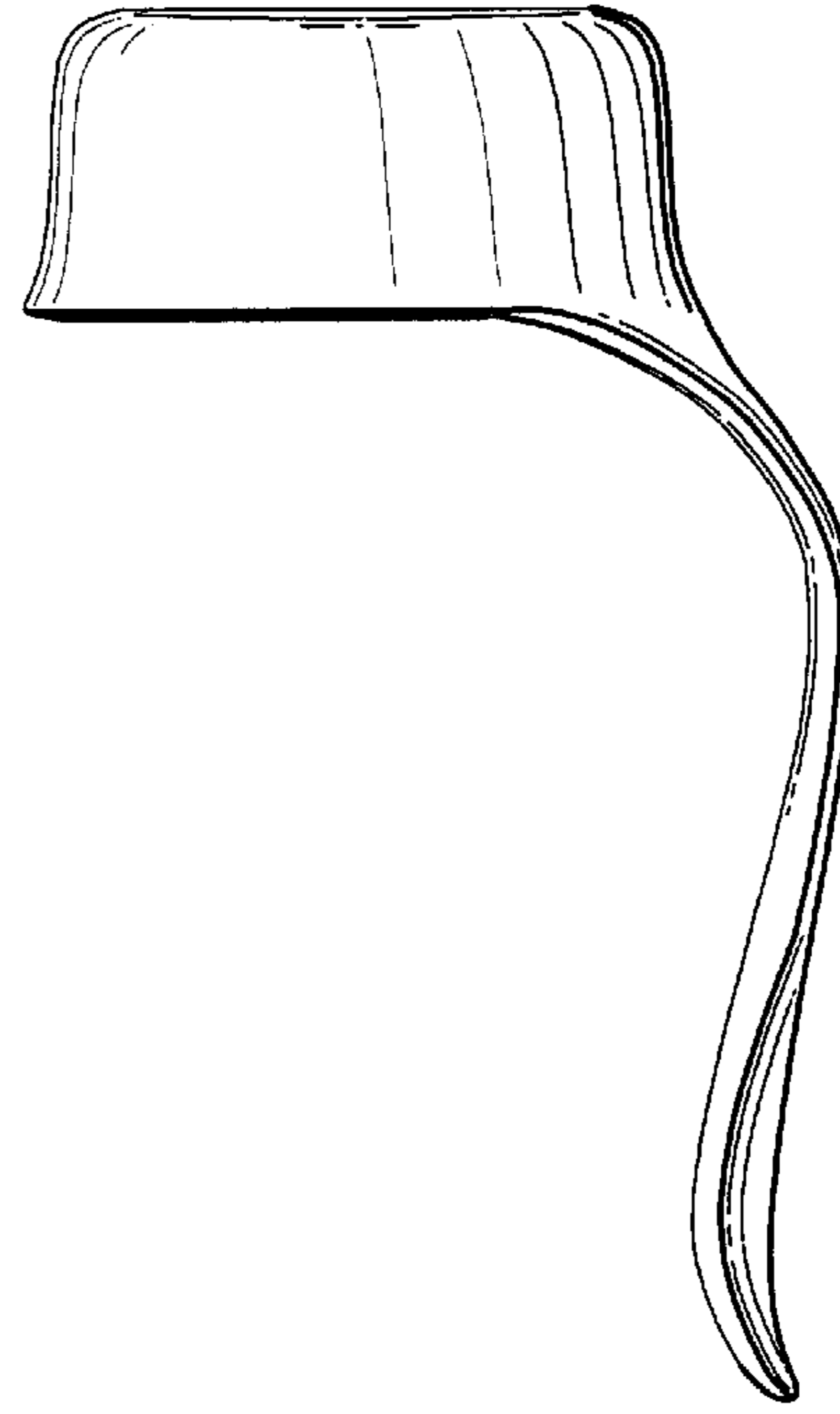

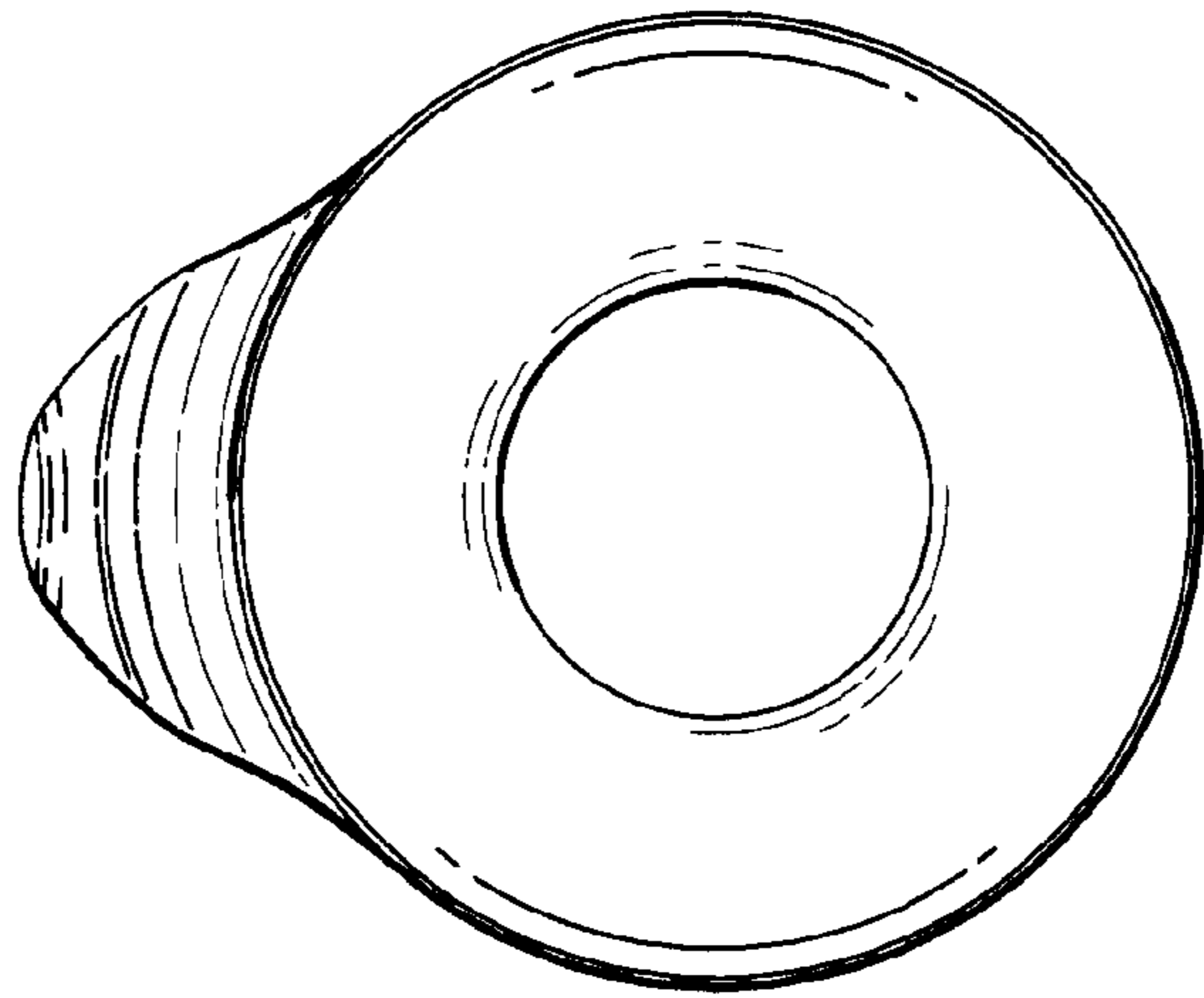

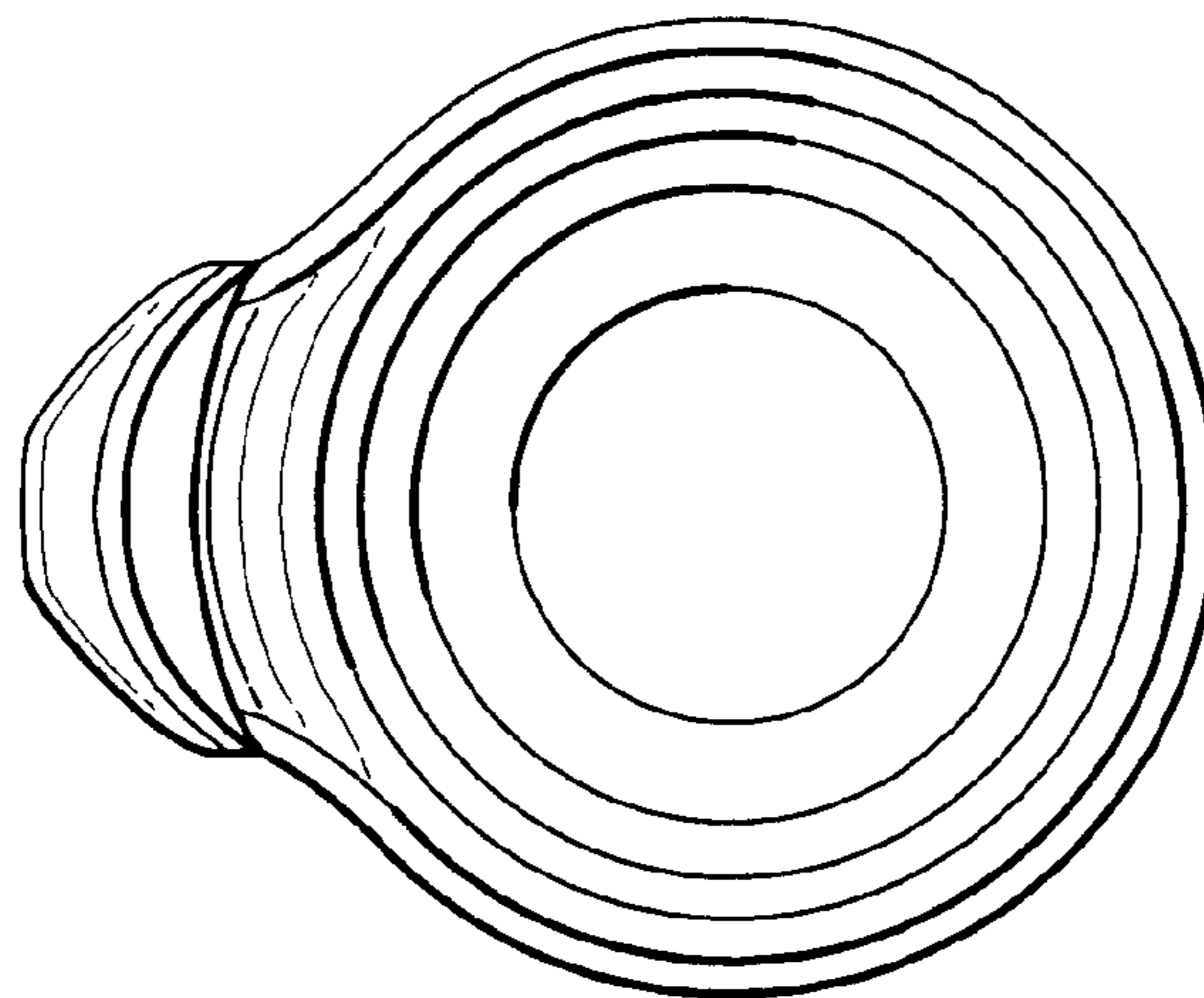

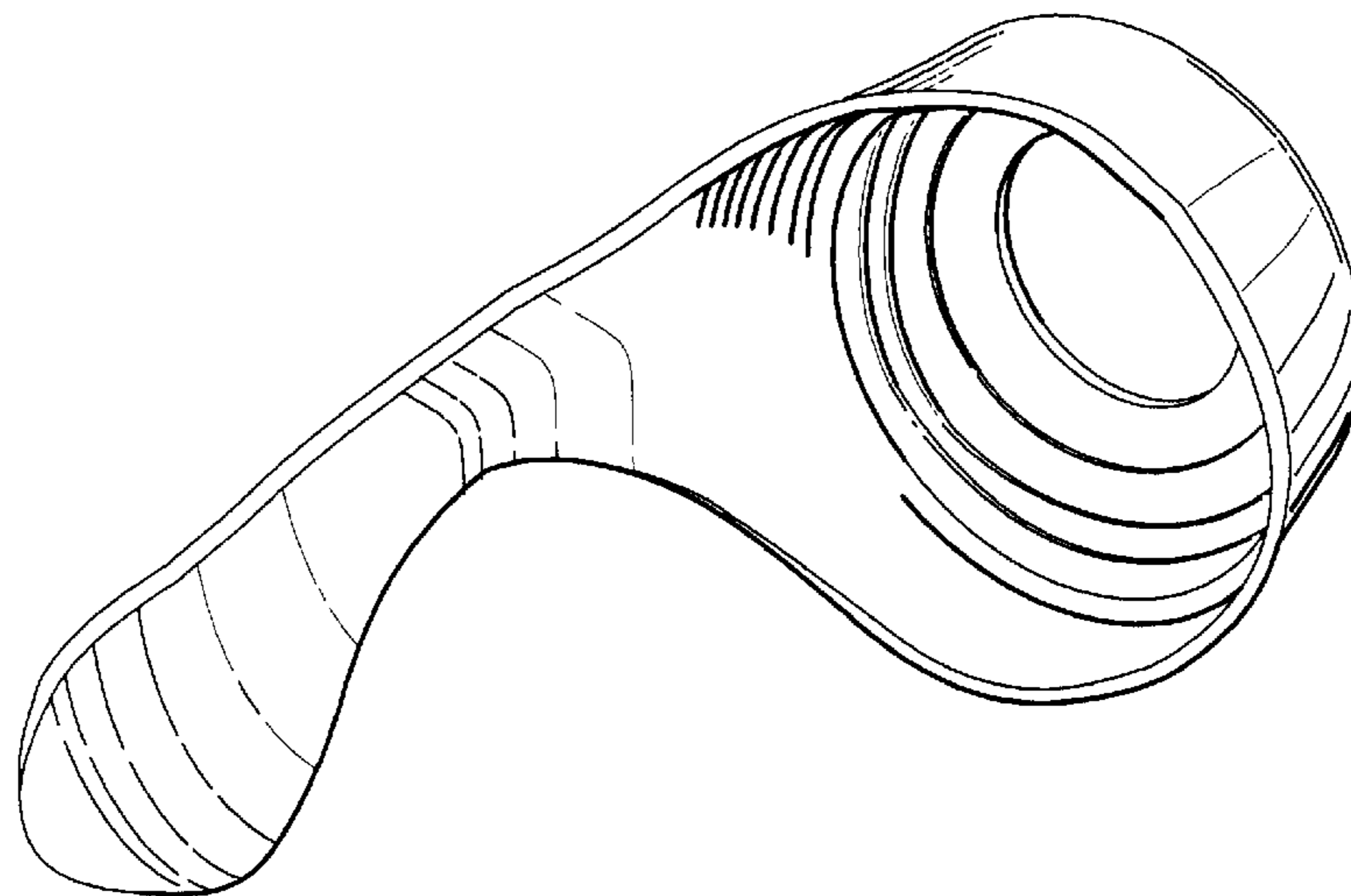

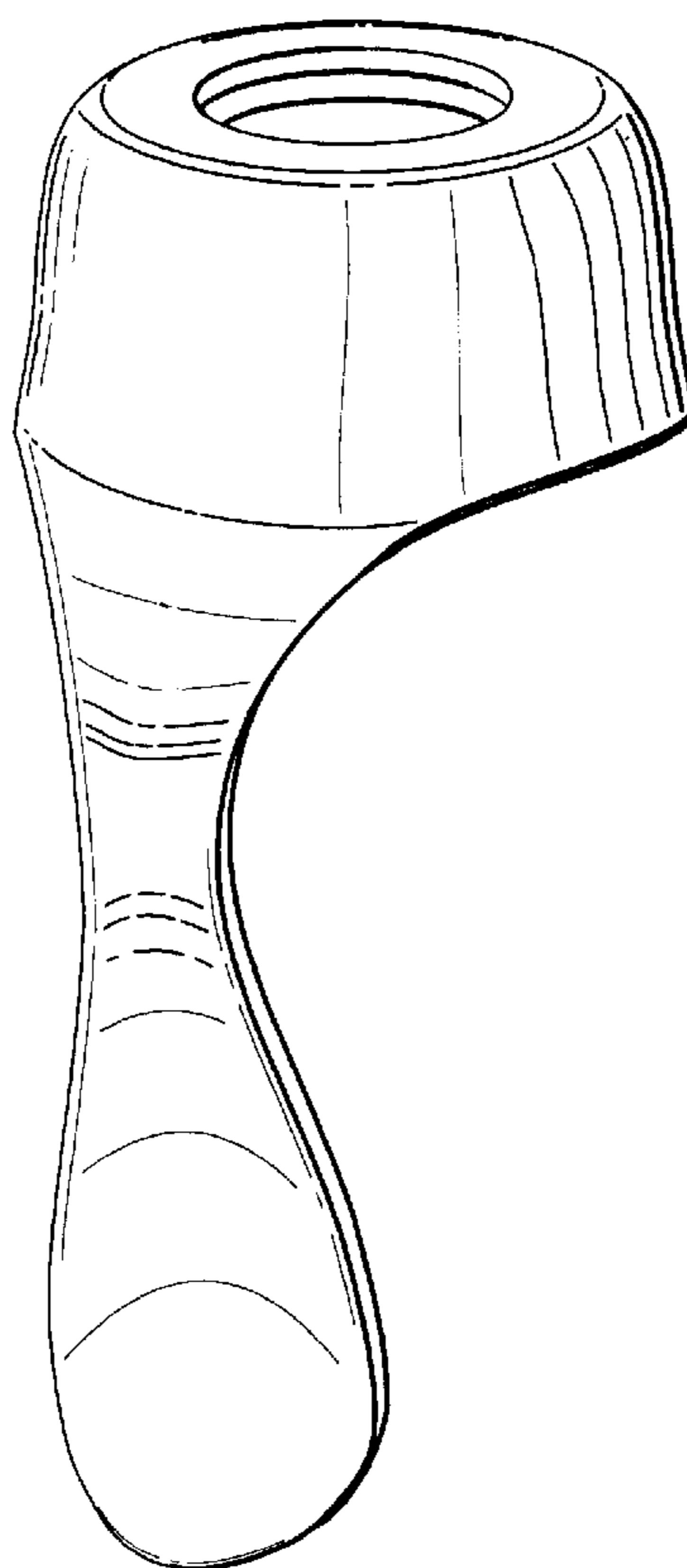
