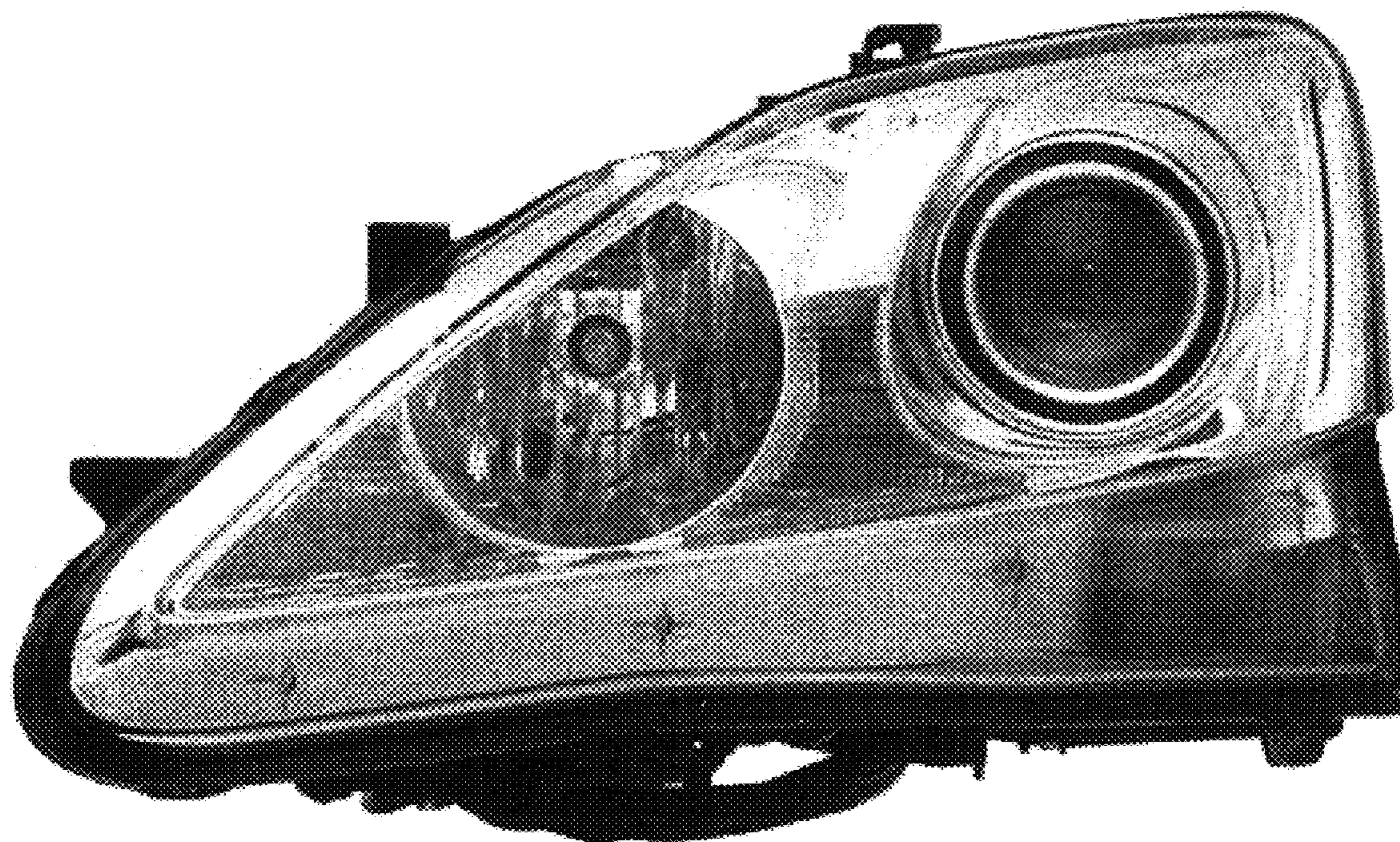
FIG. 1 is a front view of a front combination lamp for automobile of our new design;

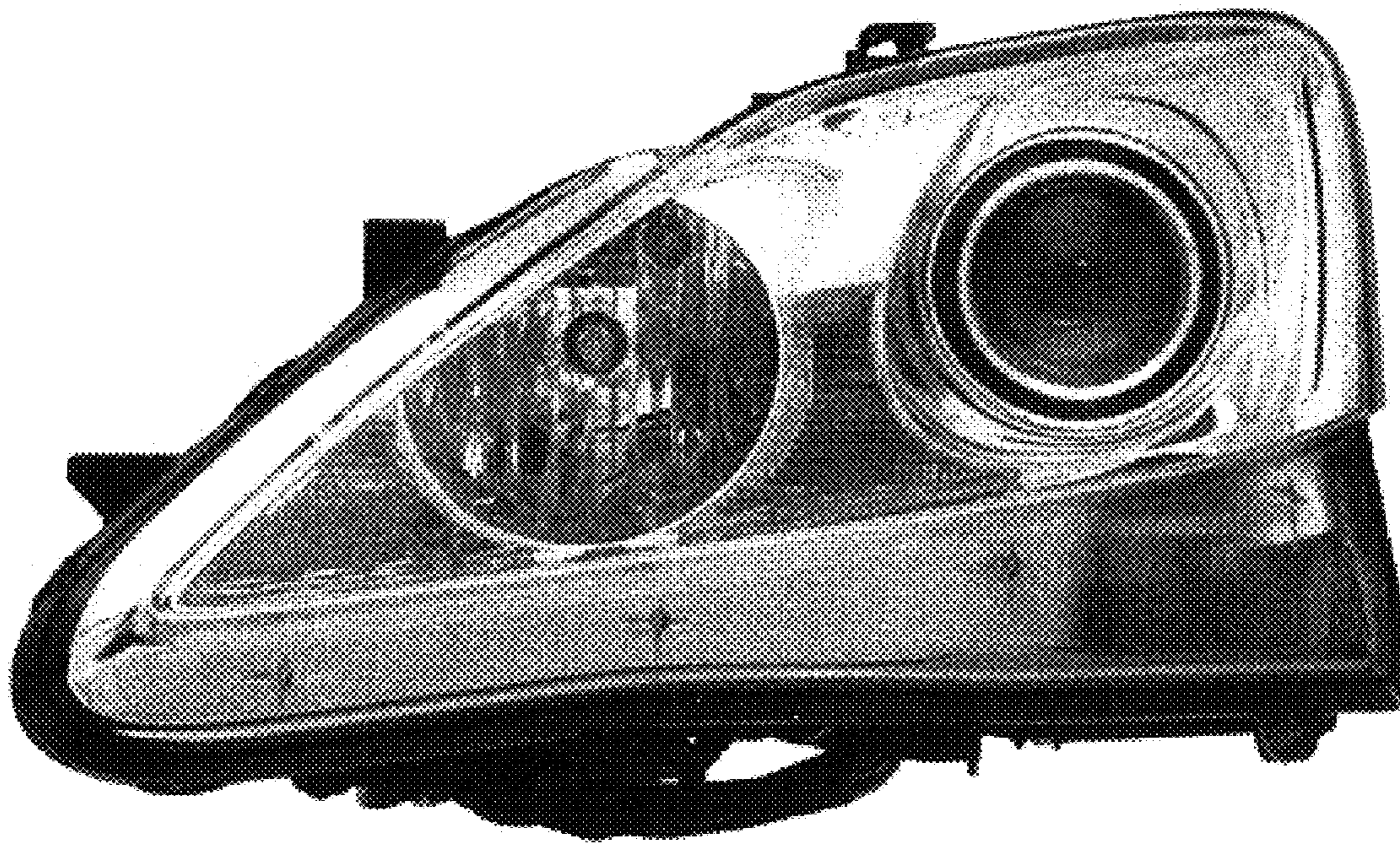

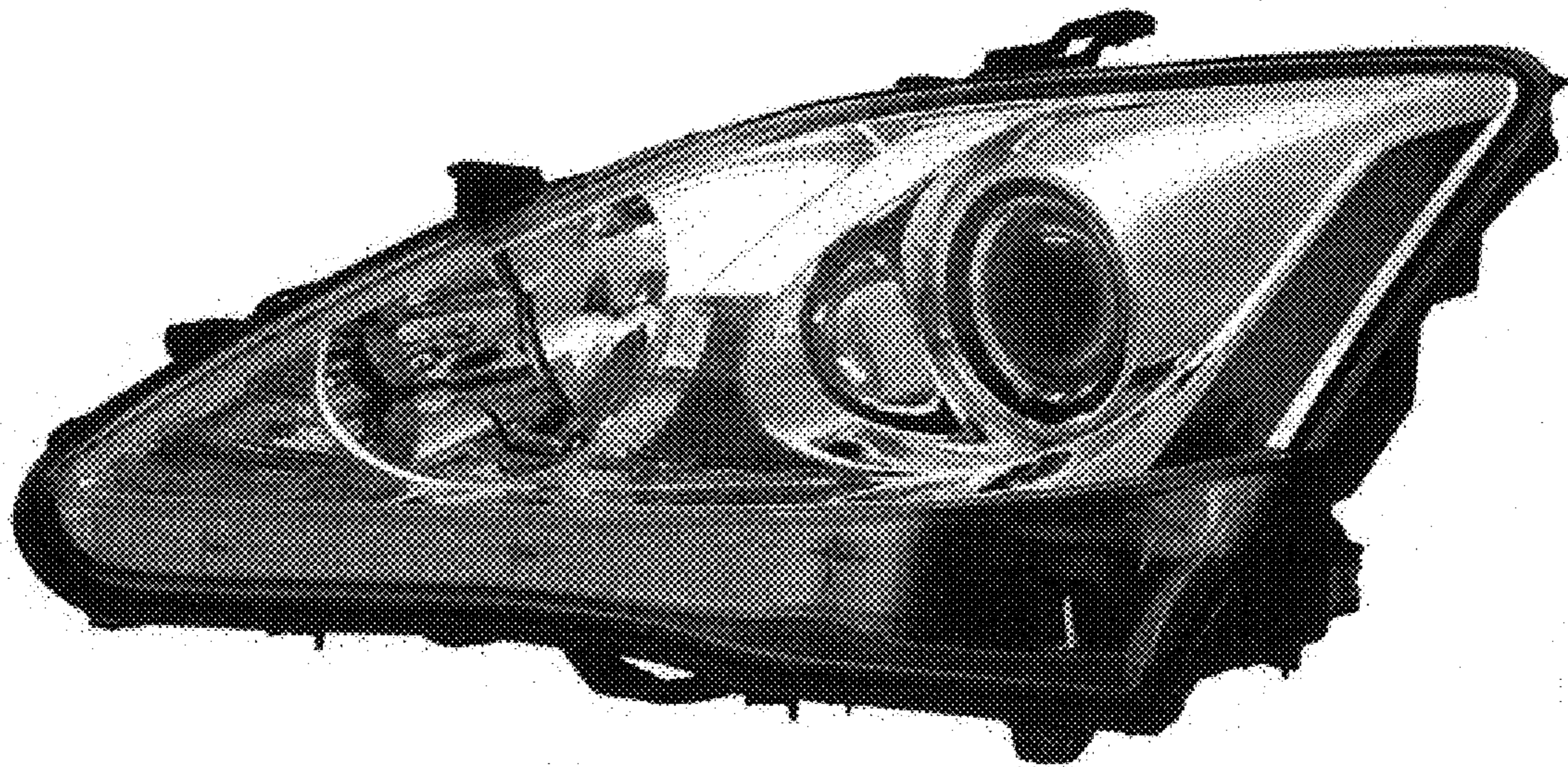

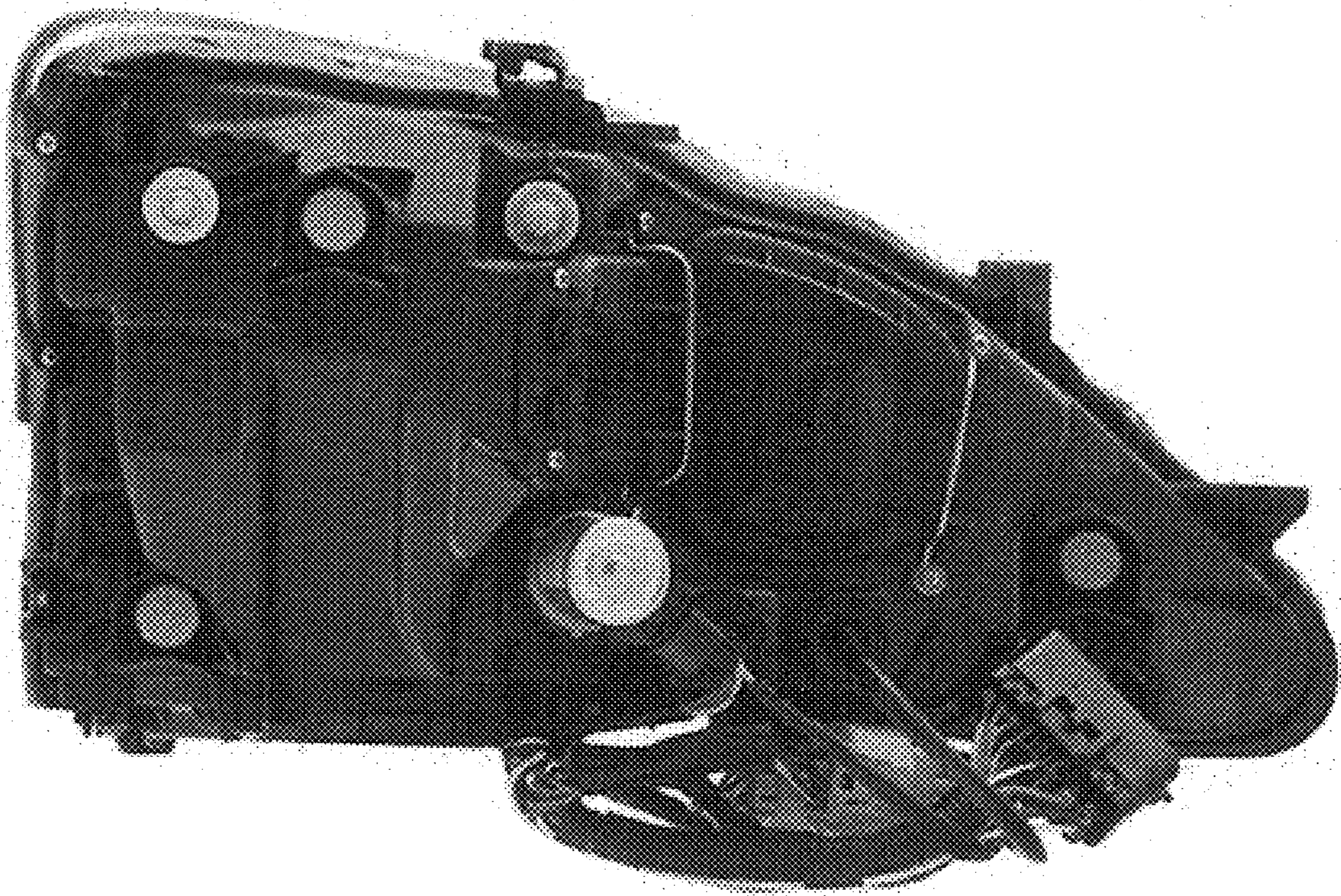

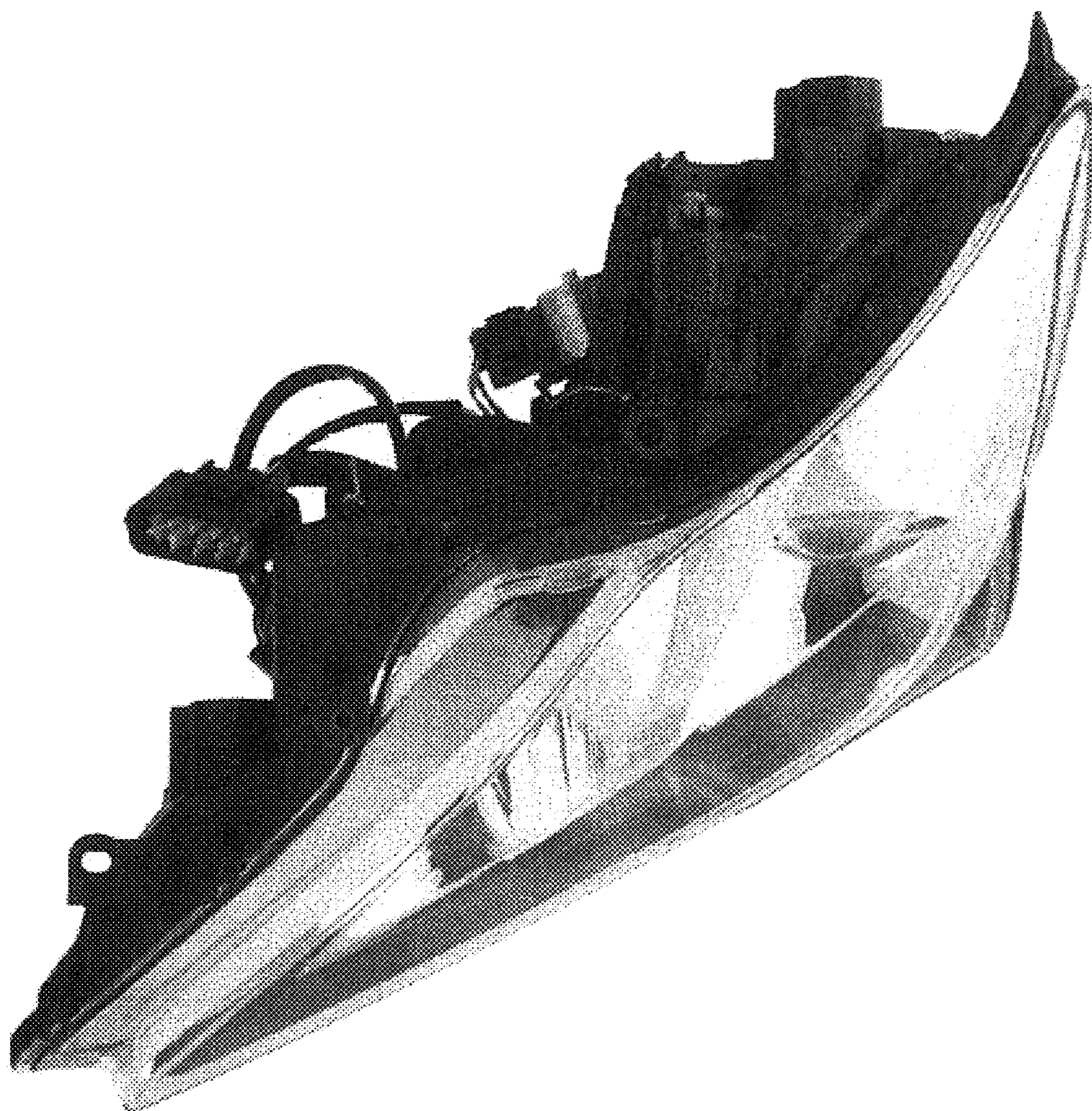

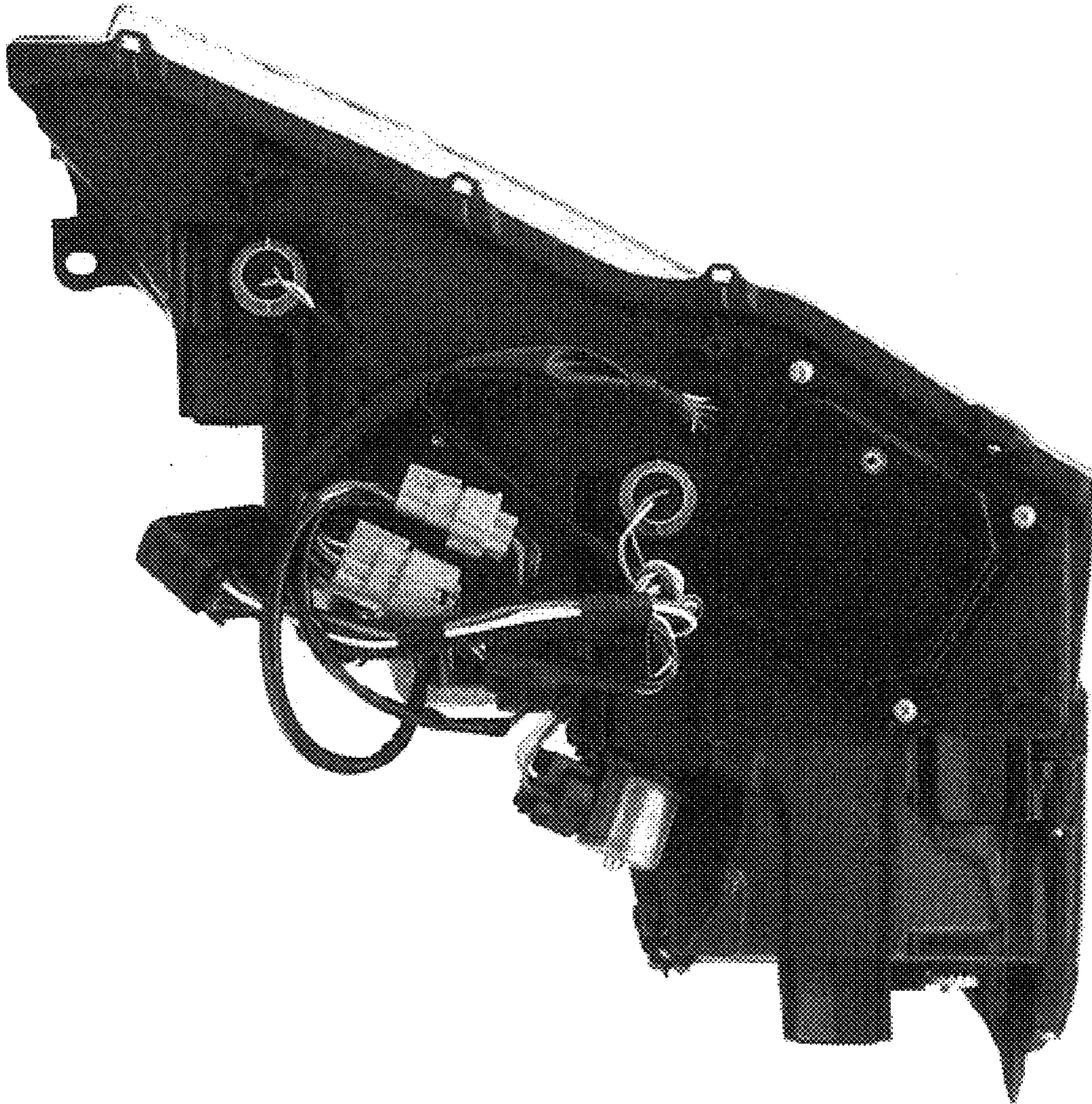

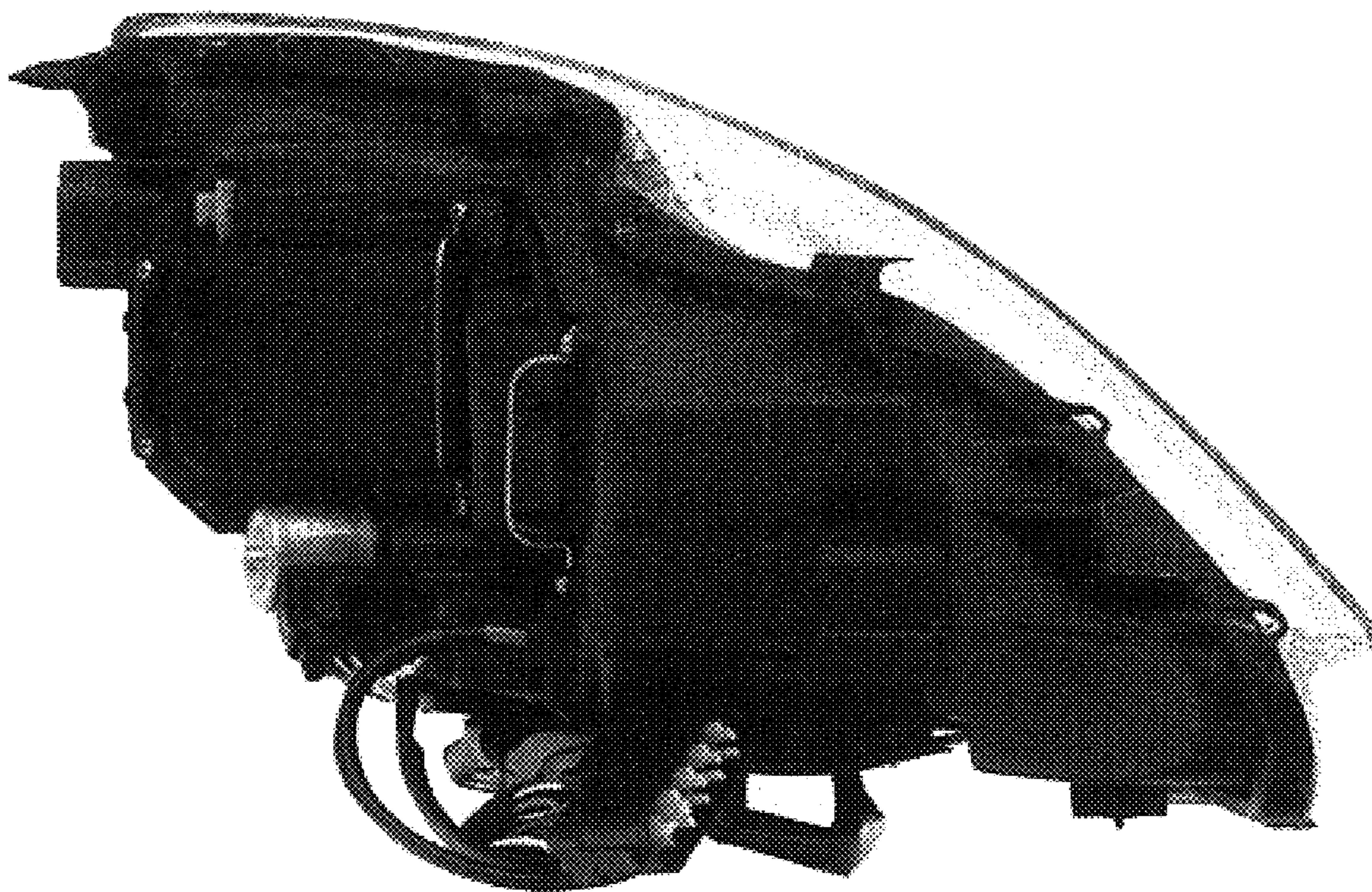

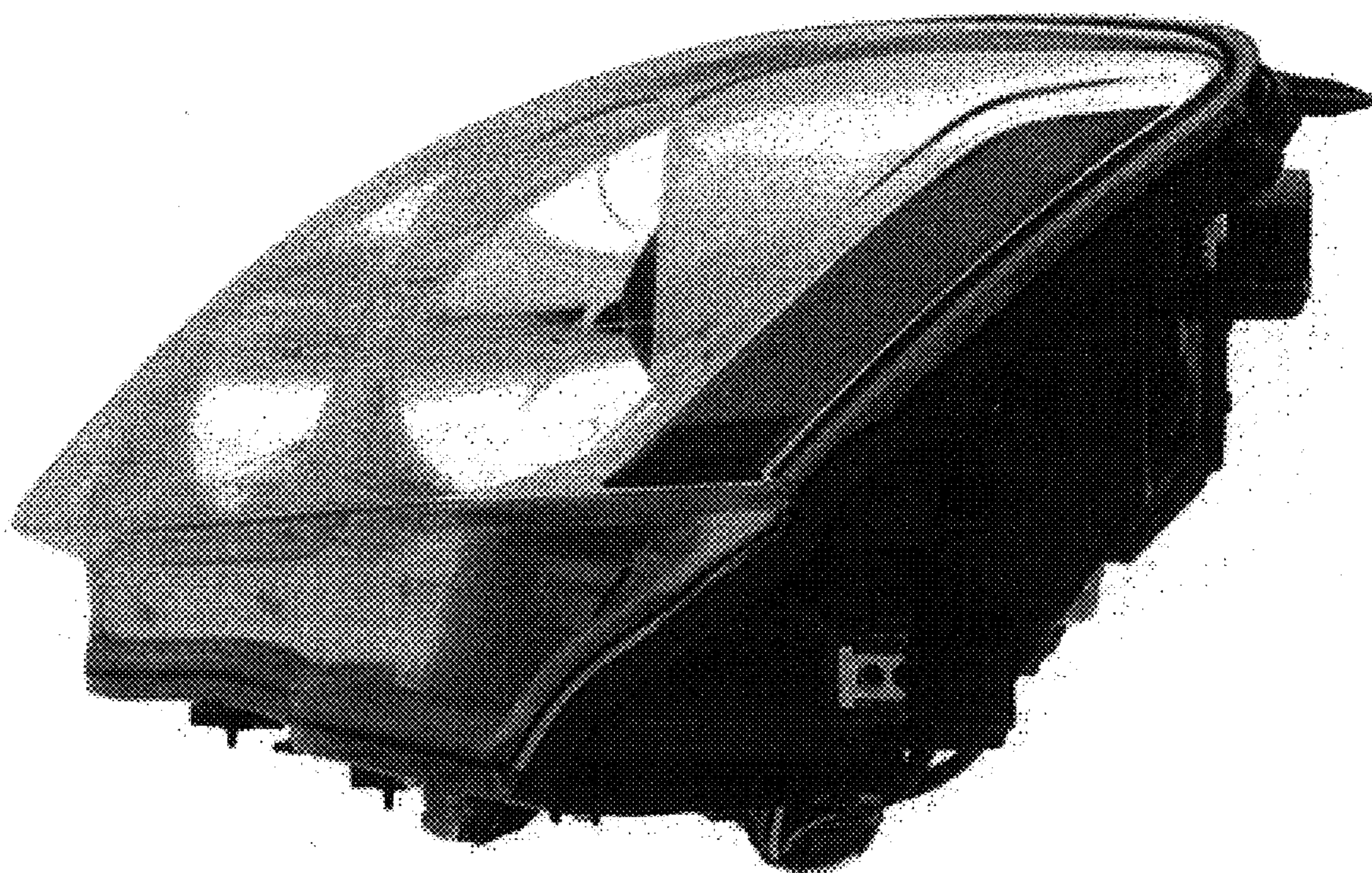

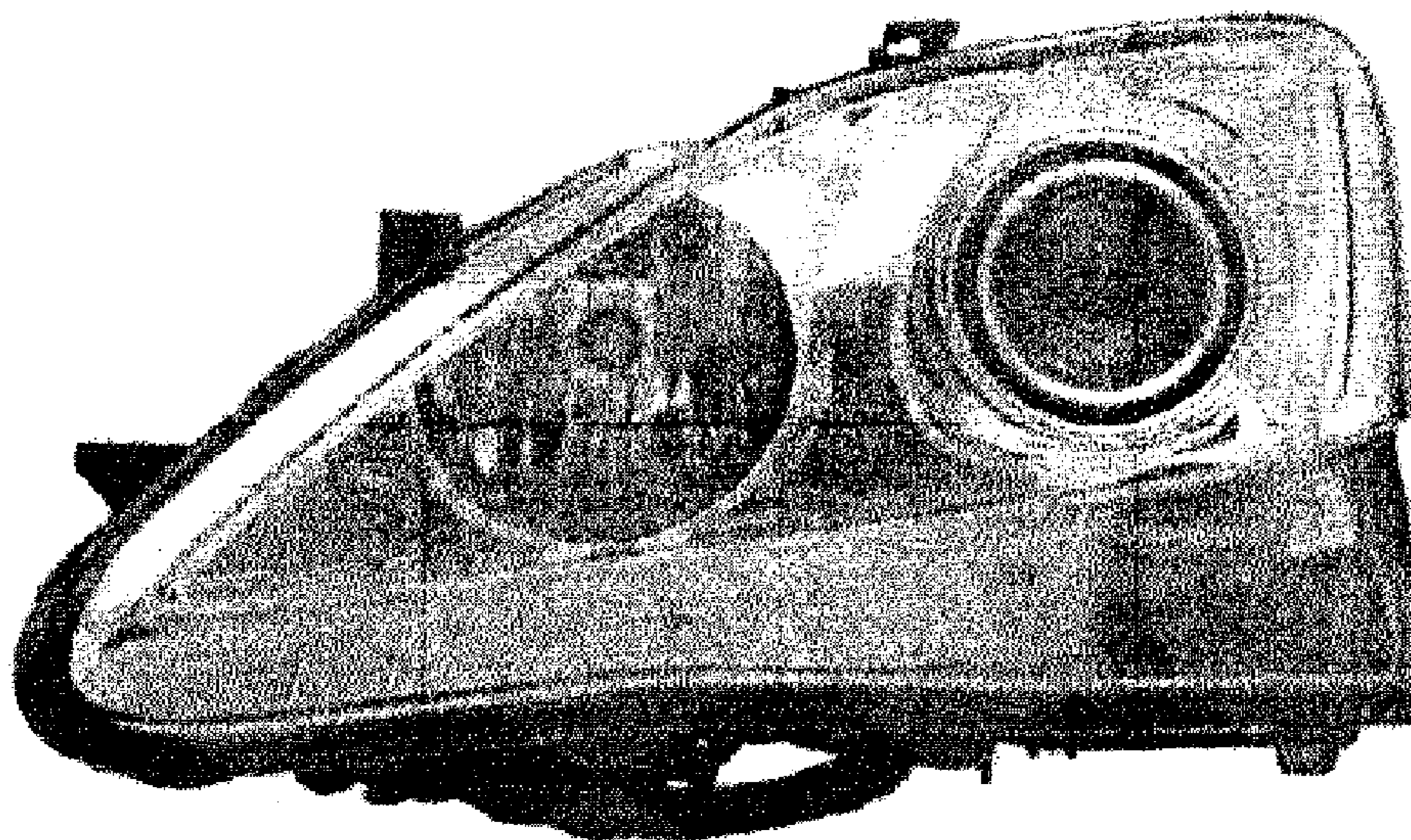

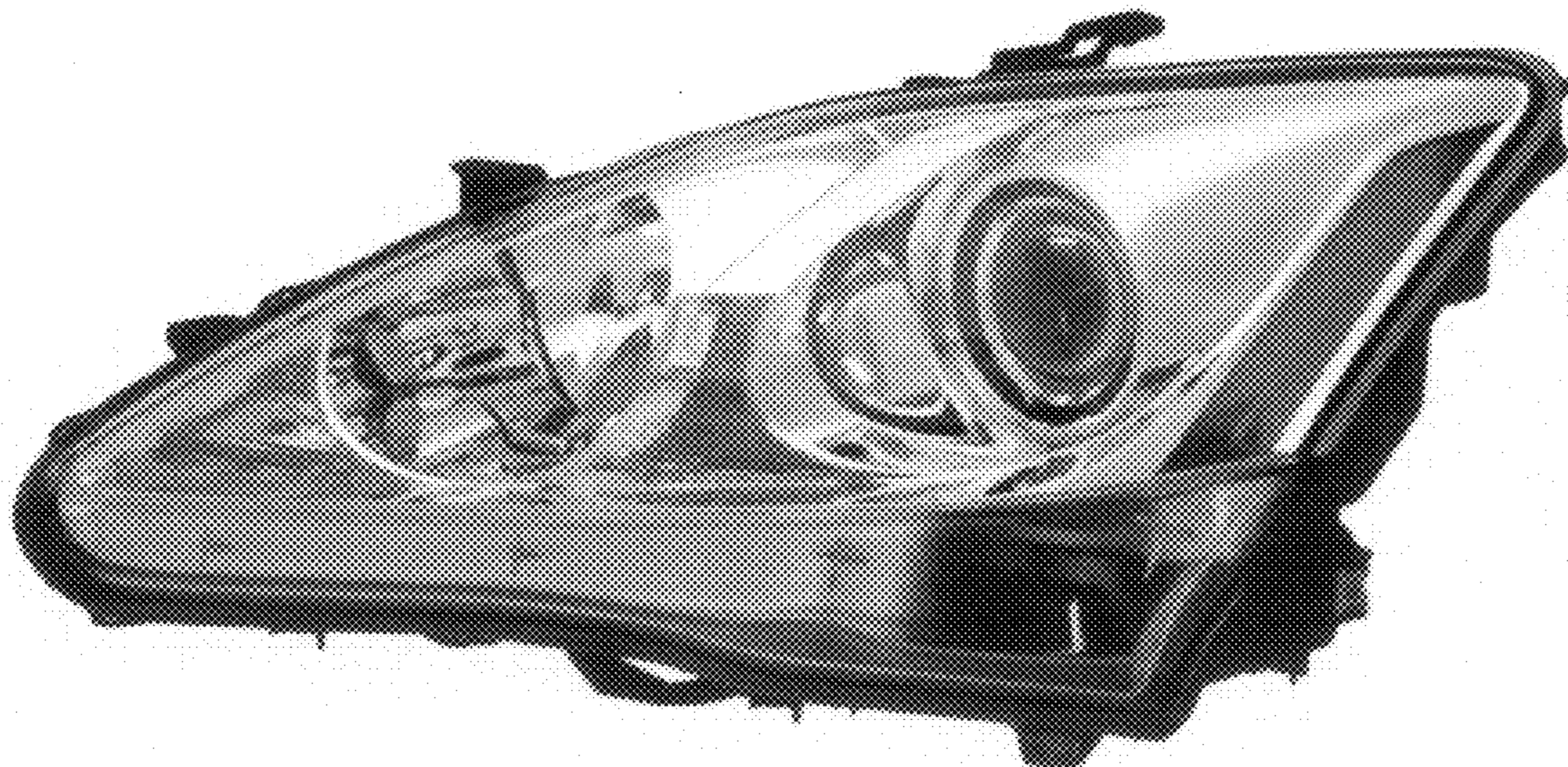

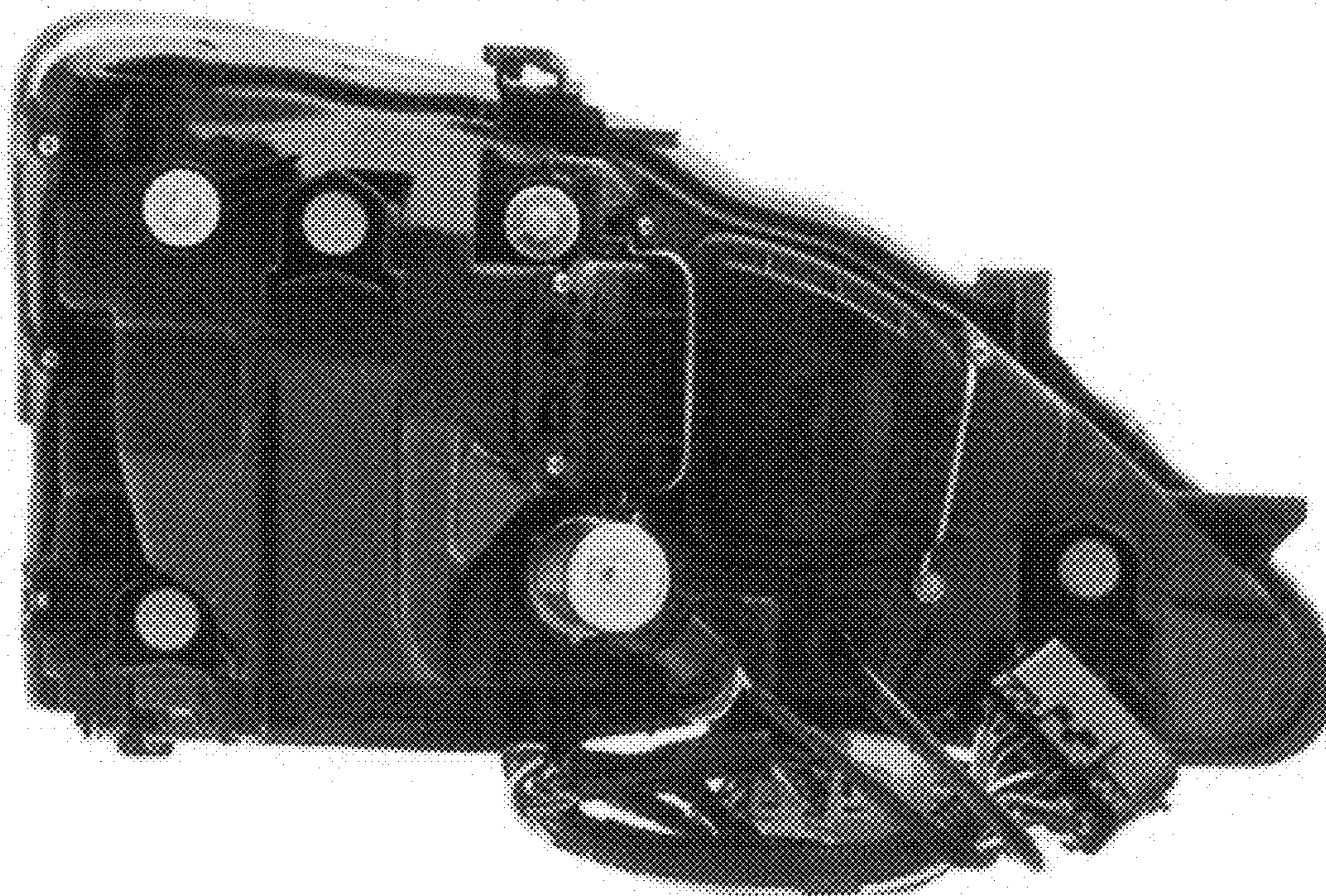

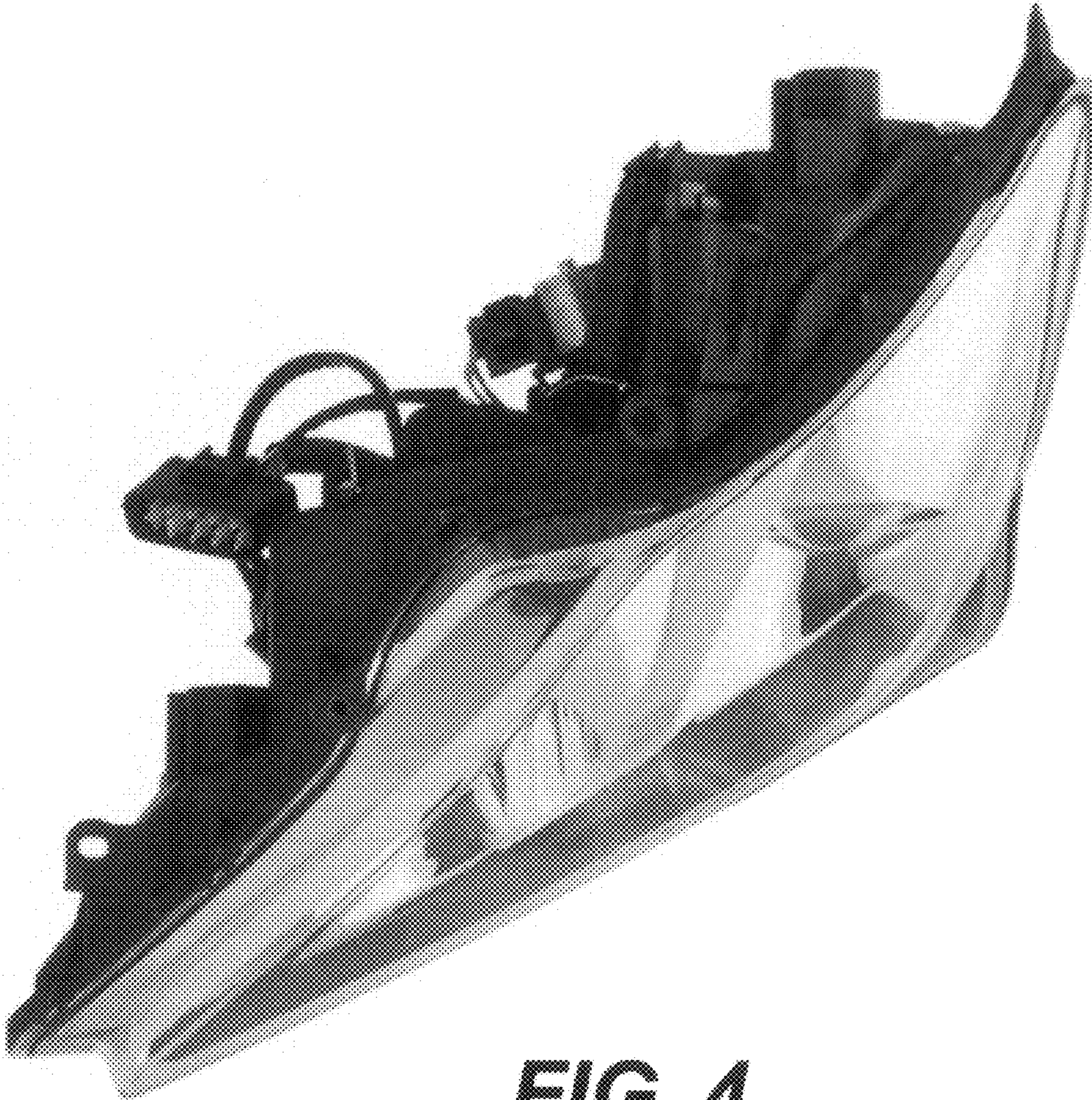

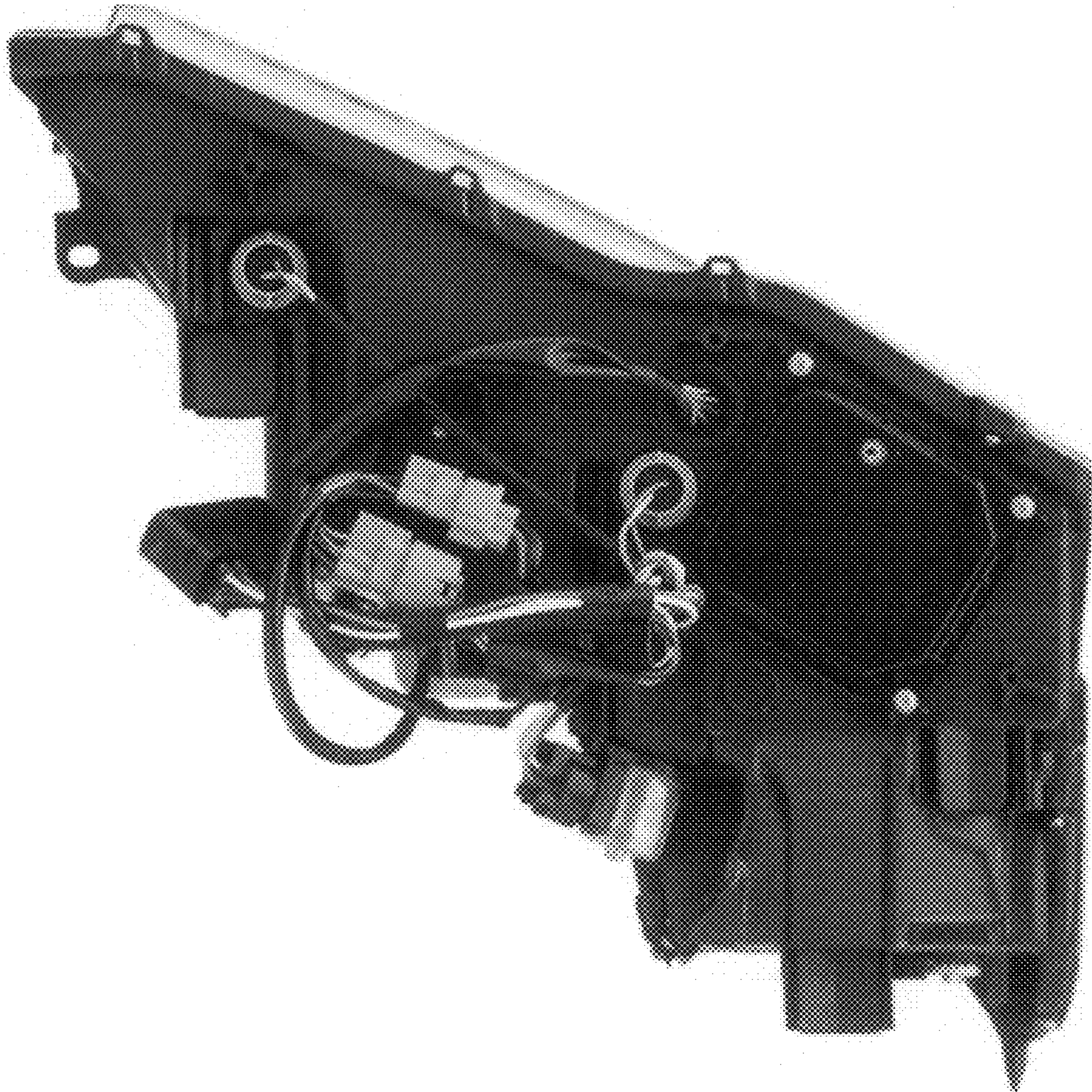

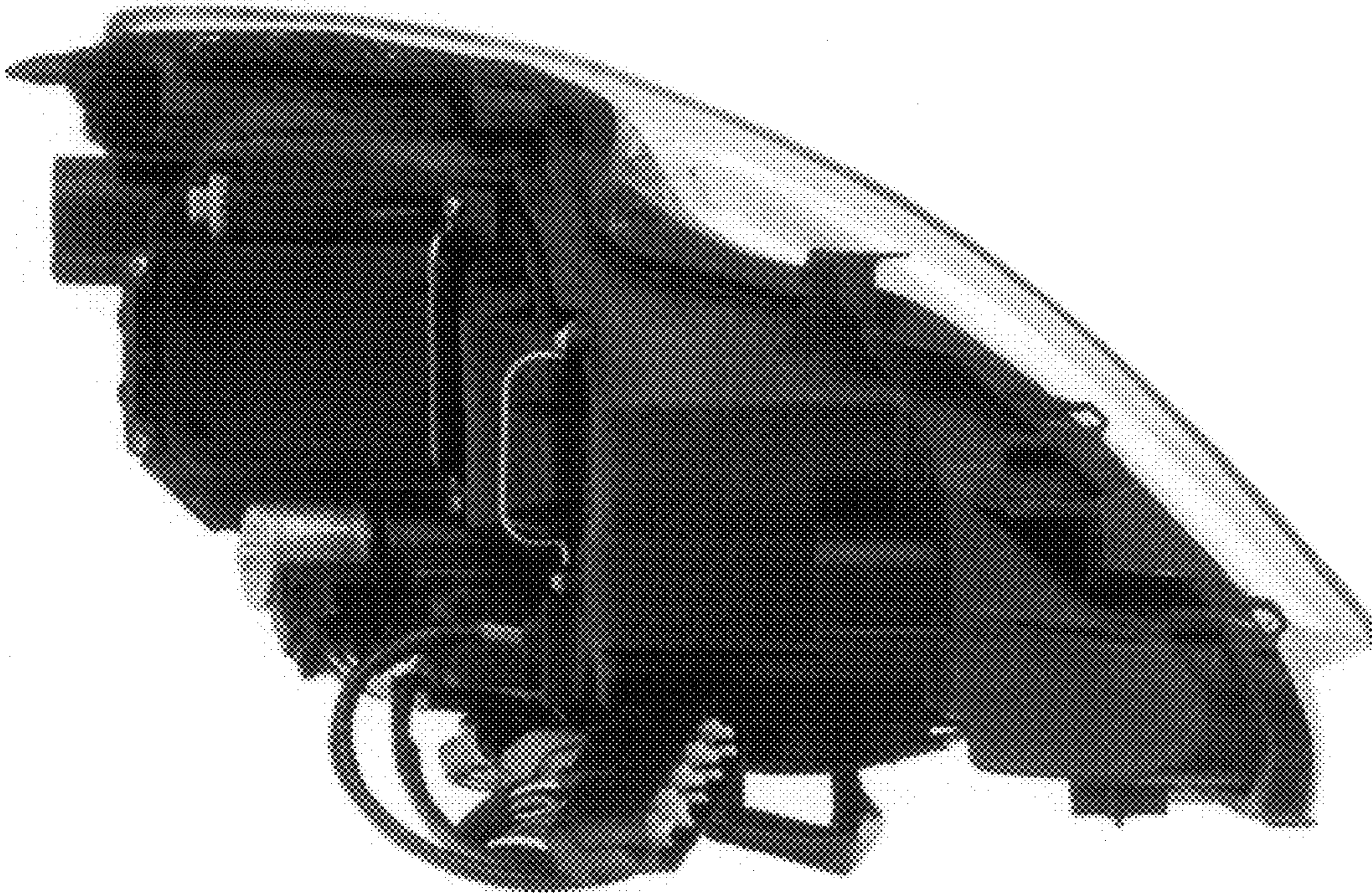

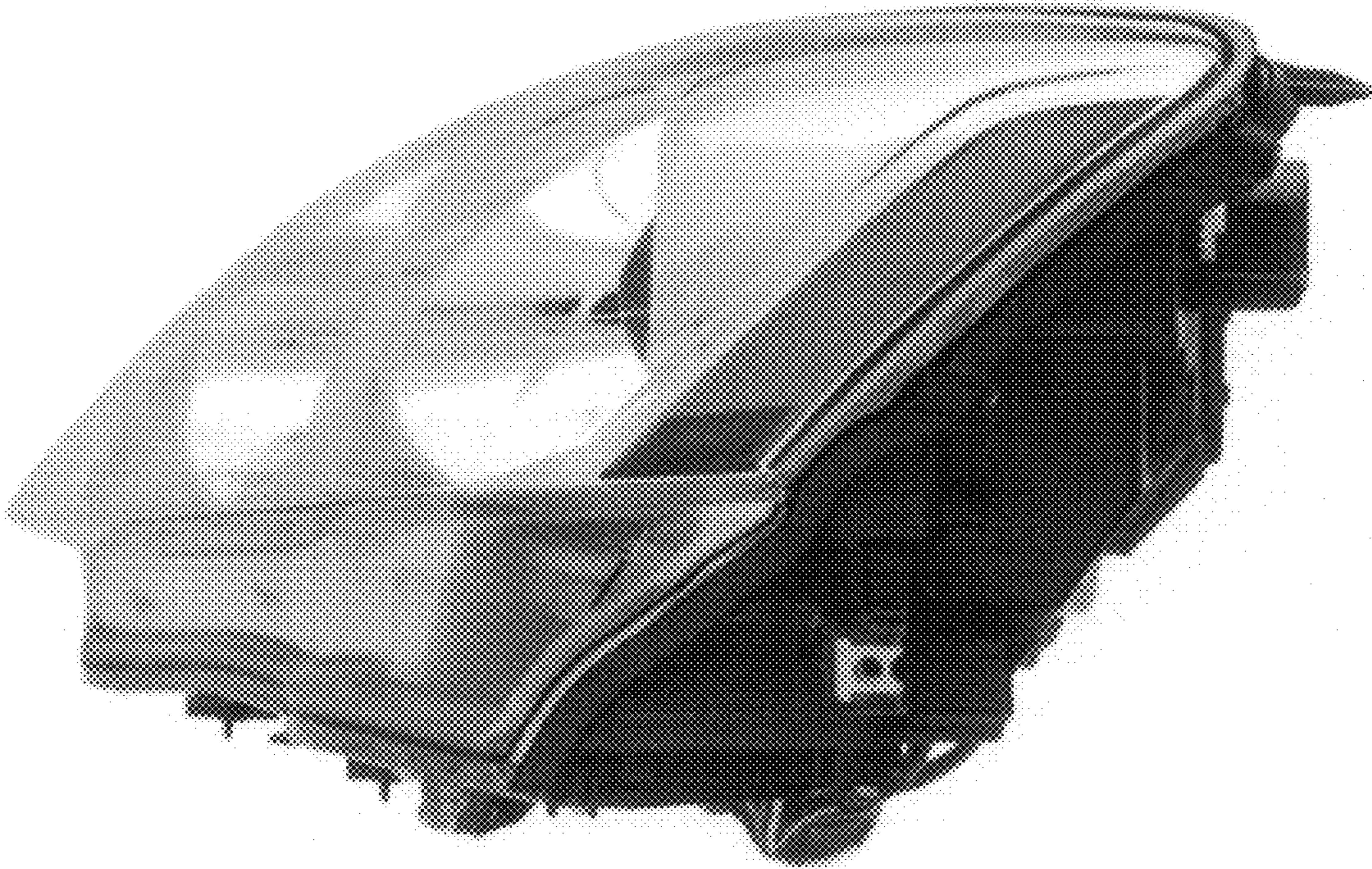
