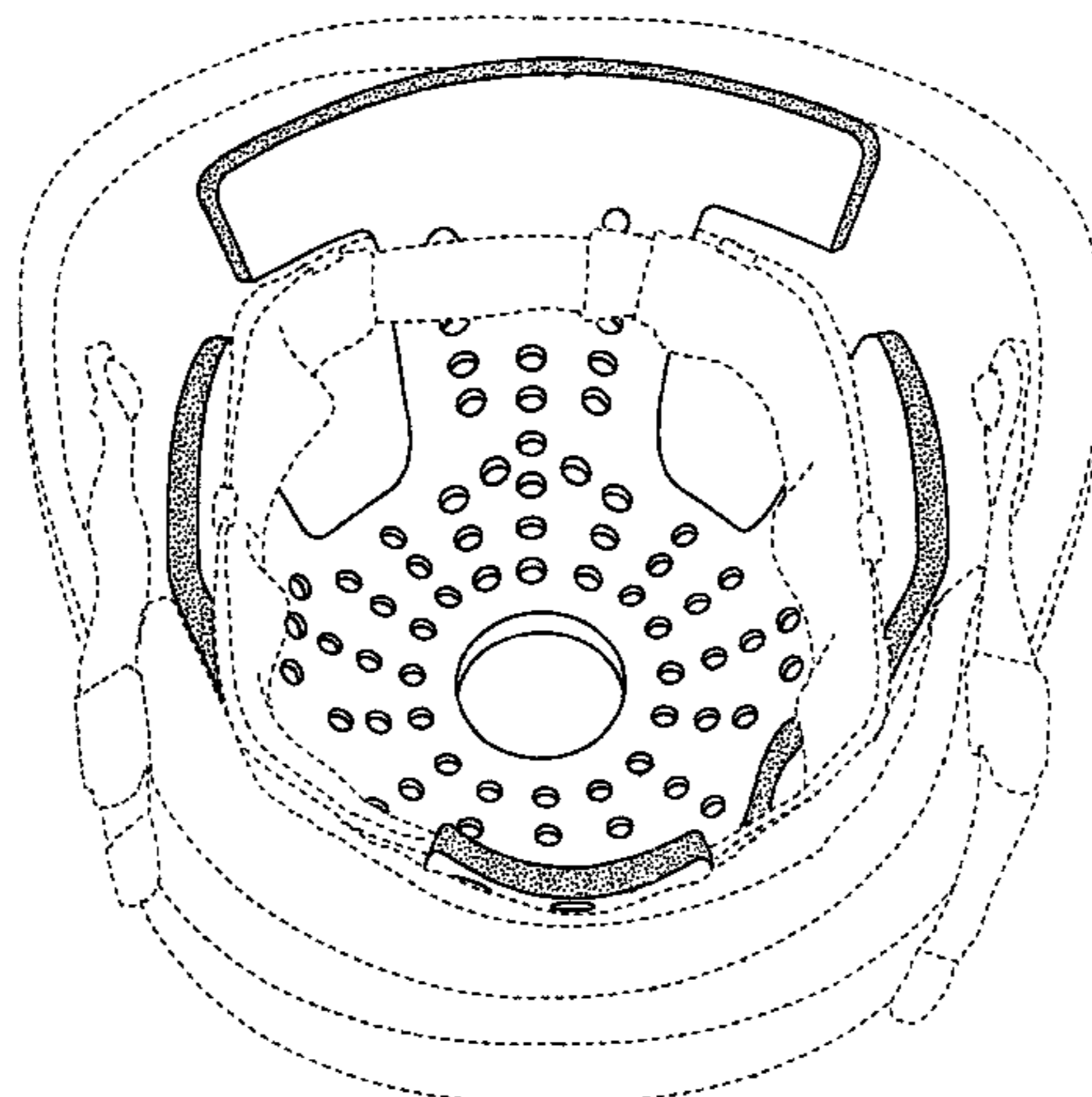
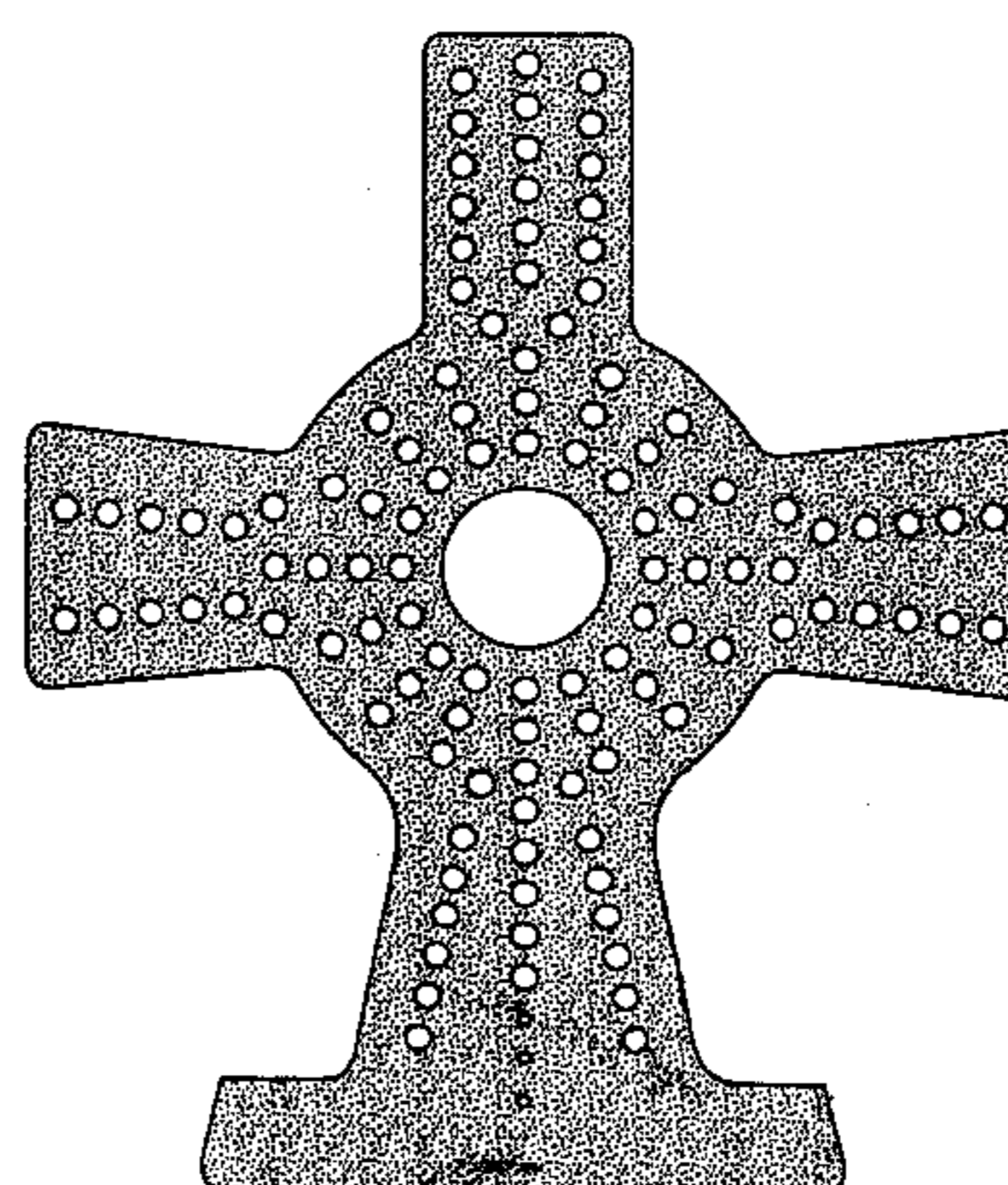
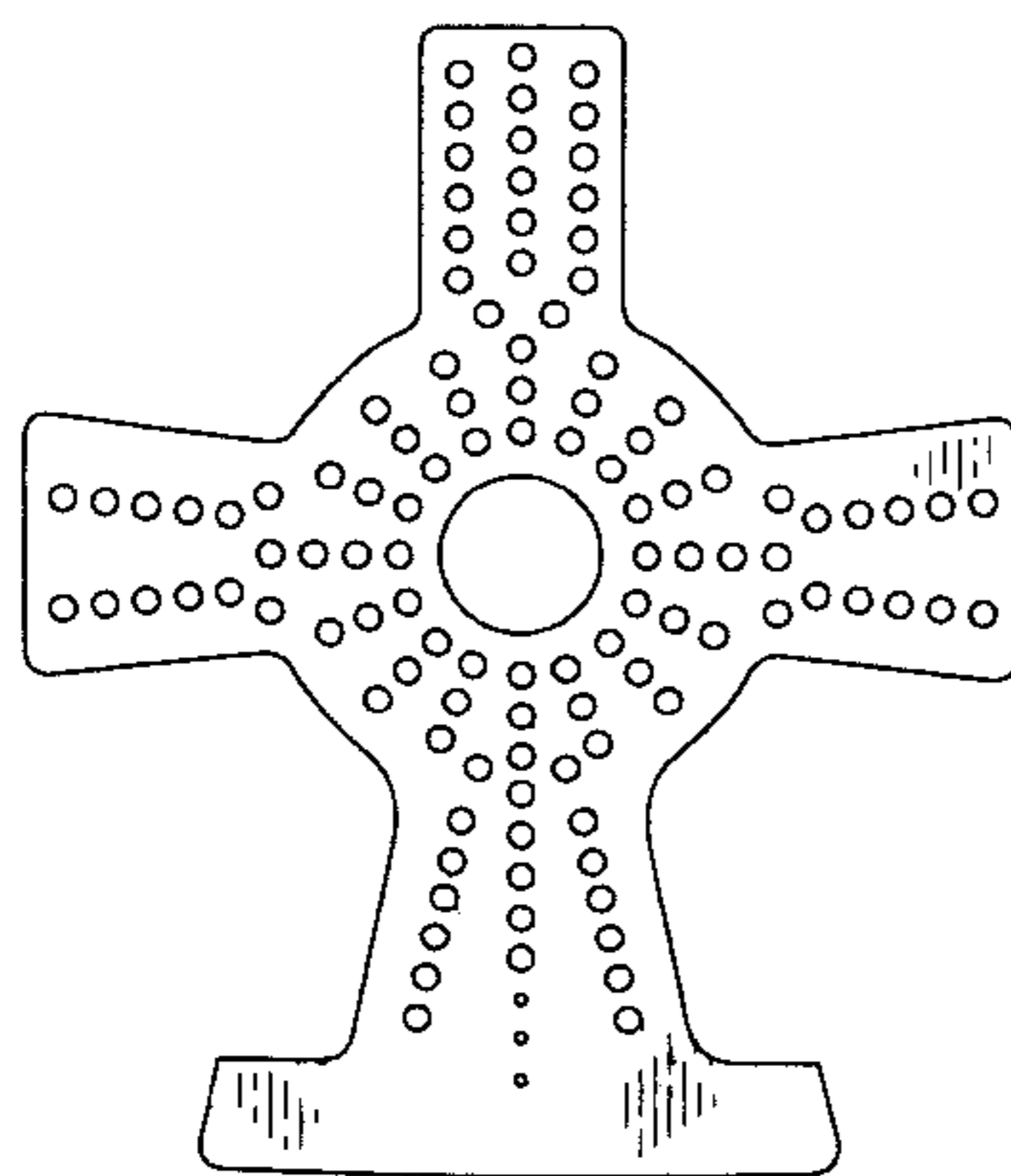
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a comfort military helmet liner showing my new design, the bottom view being identical; FIG. 2 is a top plan view of a second embodiment thereof, the bottom view being identical to FIG. 1; and, FIG. 3 is a bottom perspective view of both embodiments, the environmental matter shown in broken lines is for illustrative purposes only and forms no part of the claimed design.

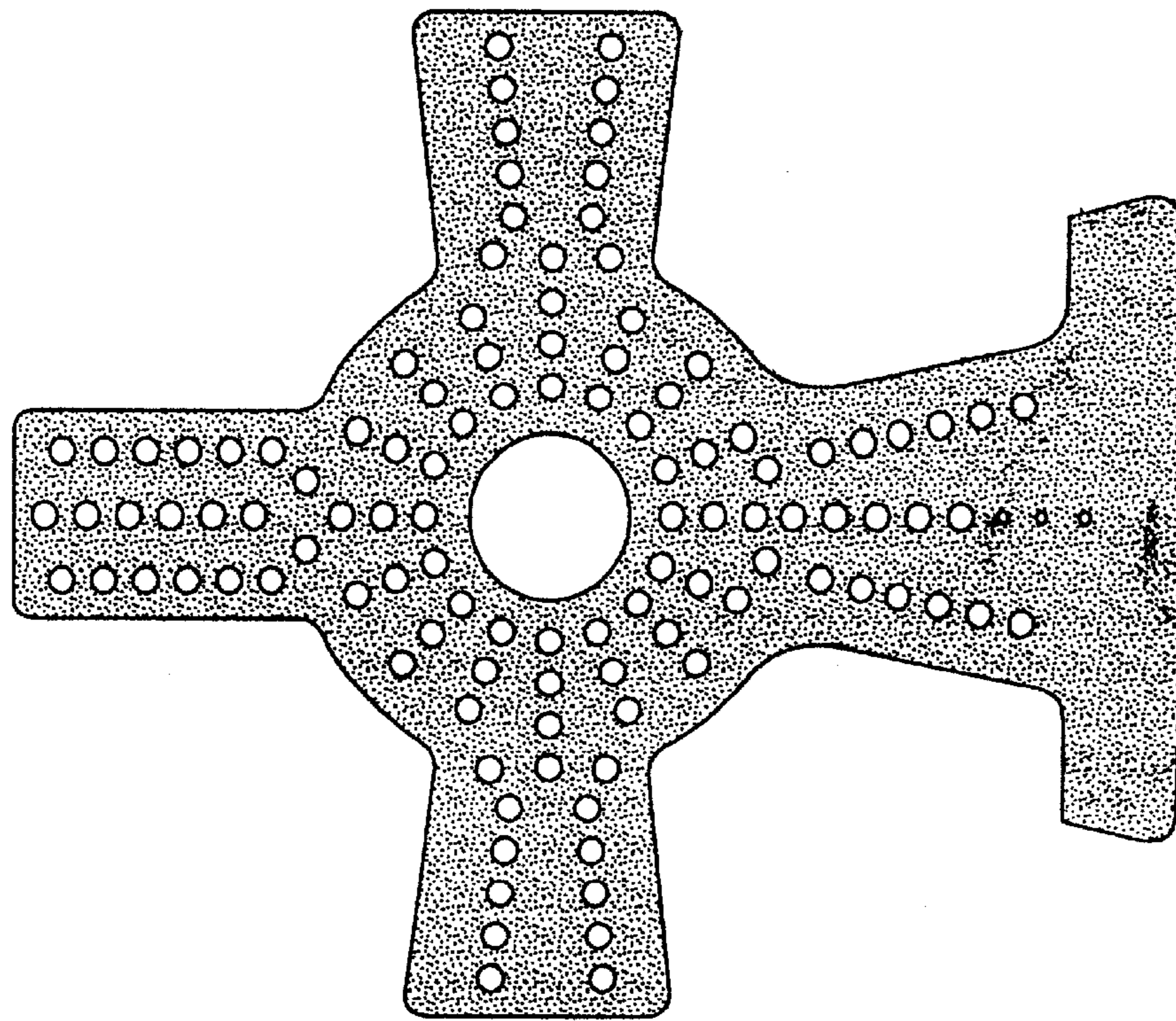

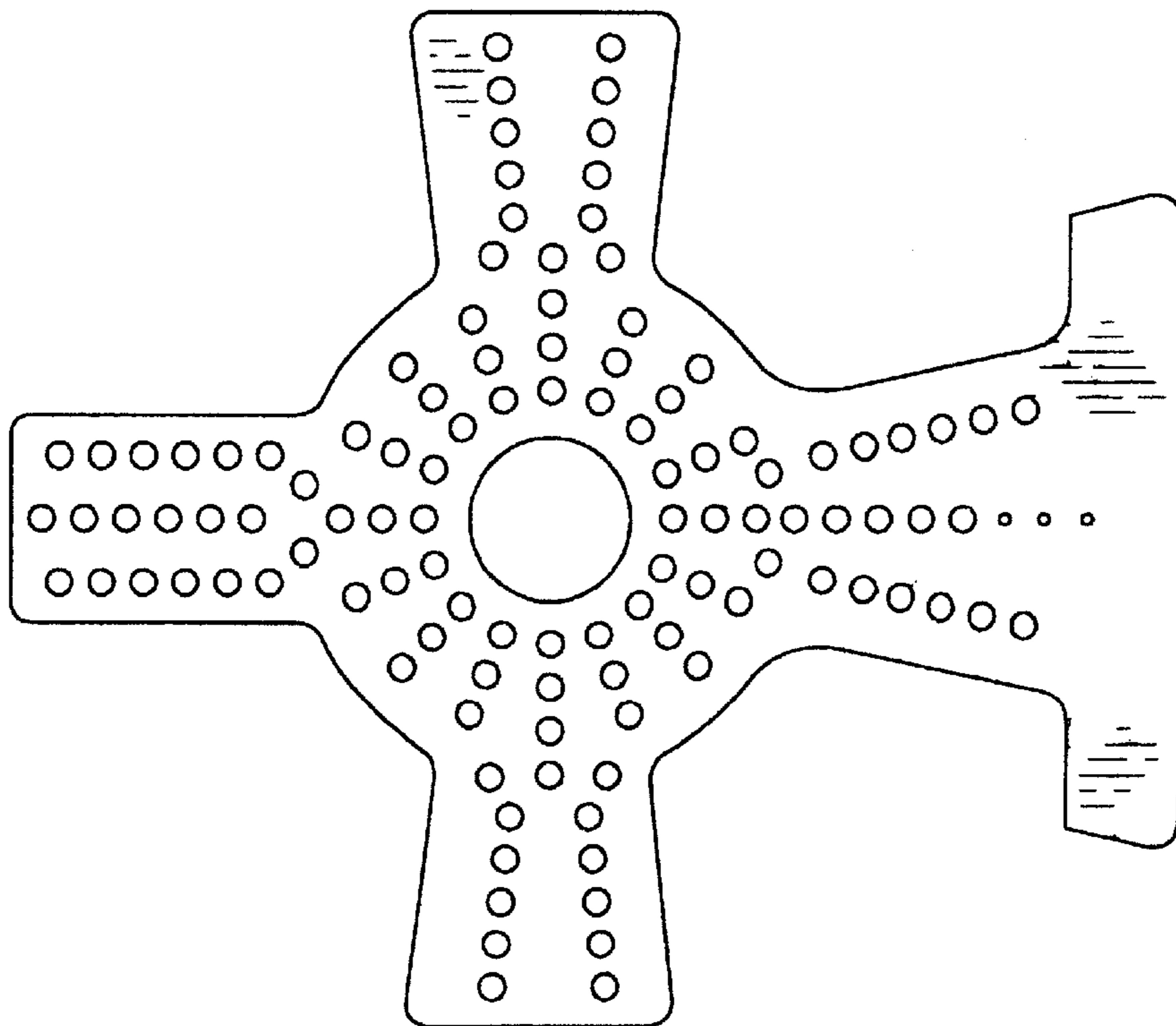

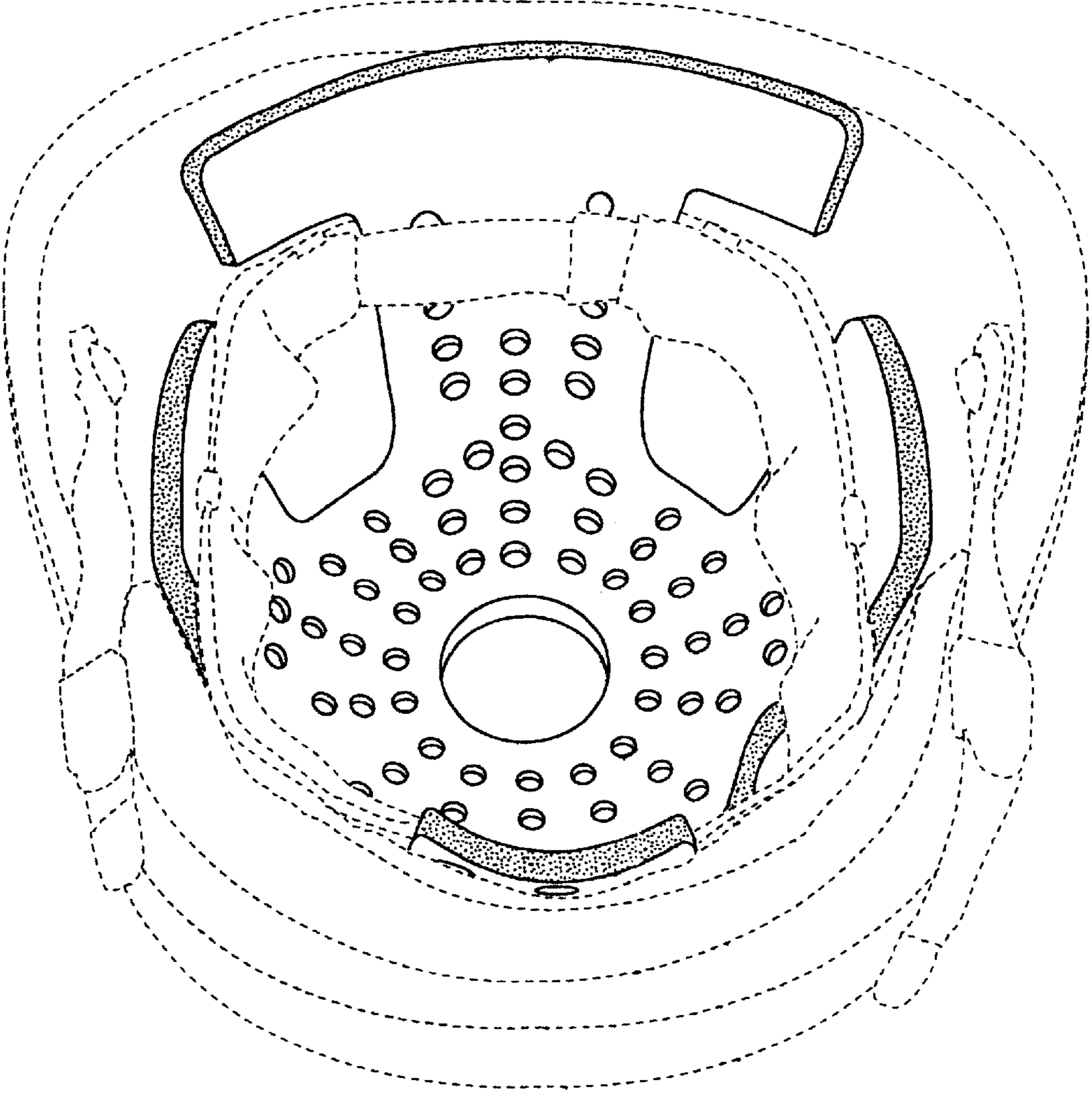
