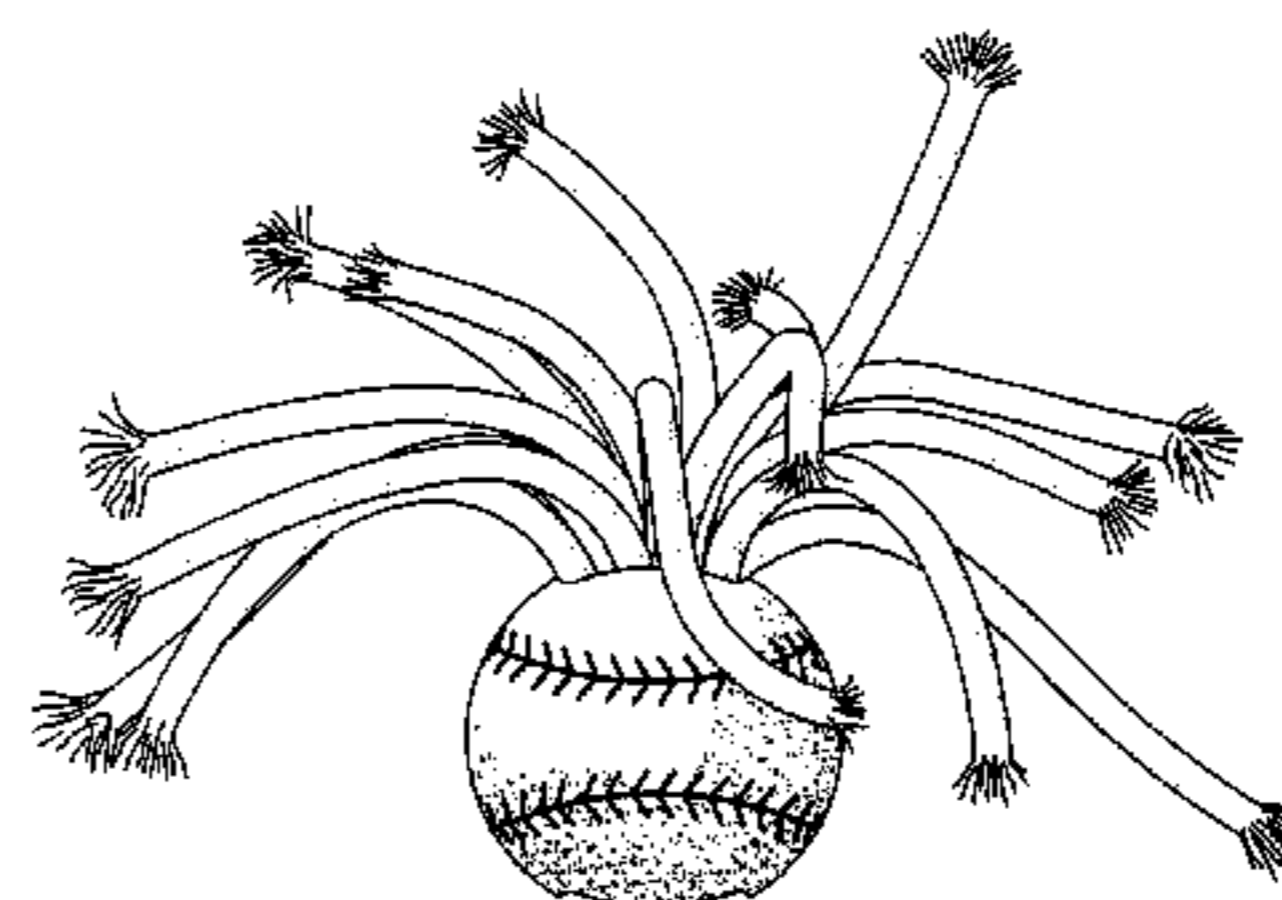
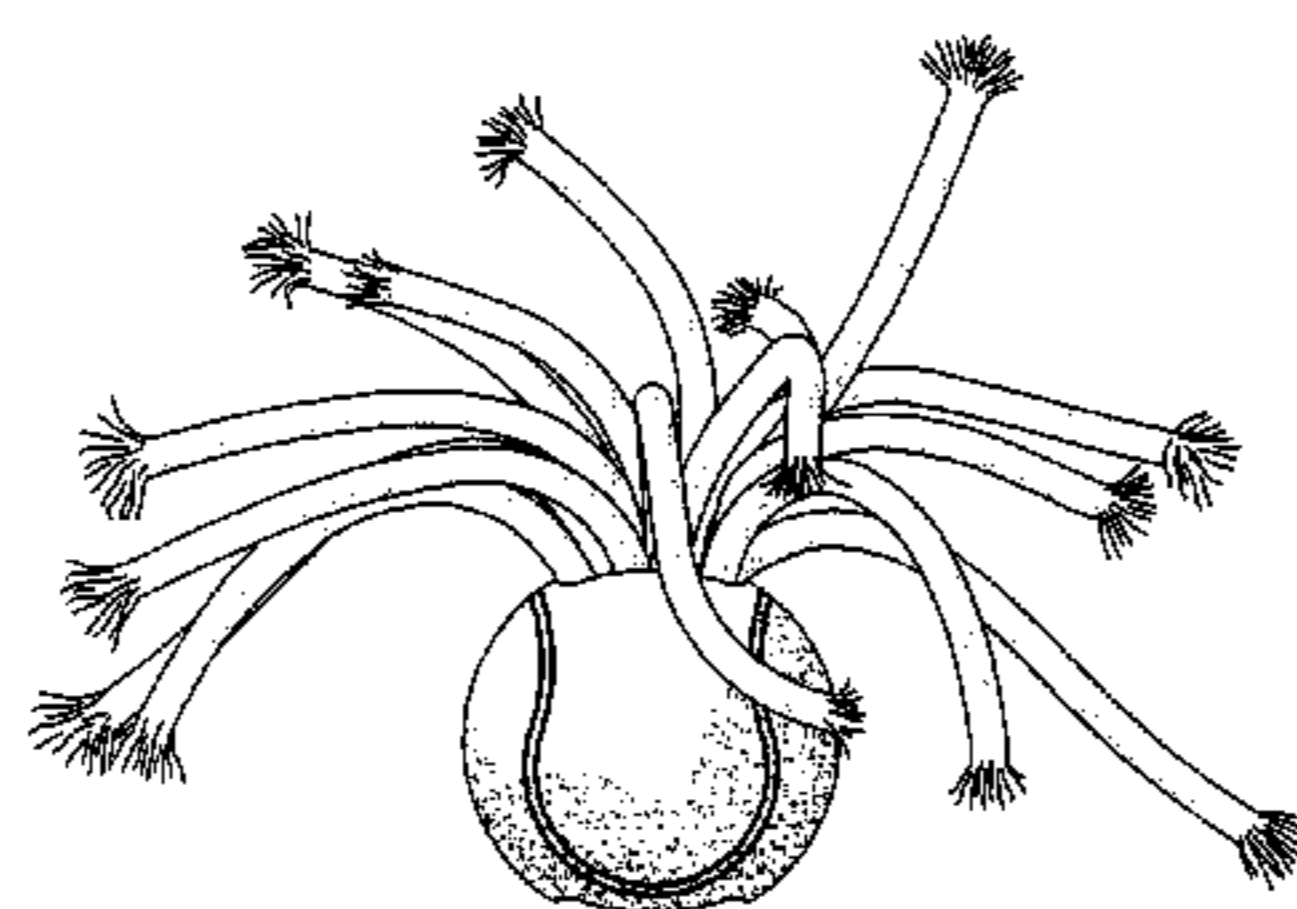
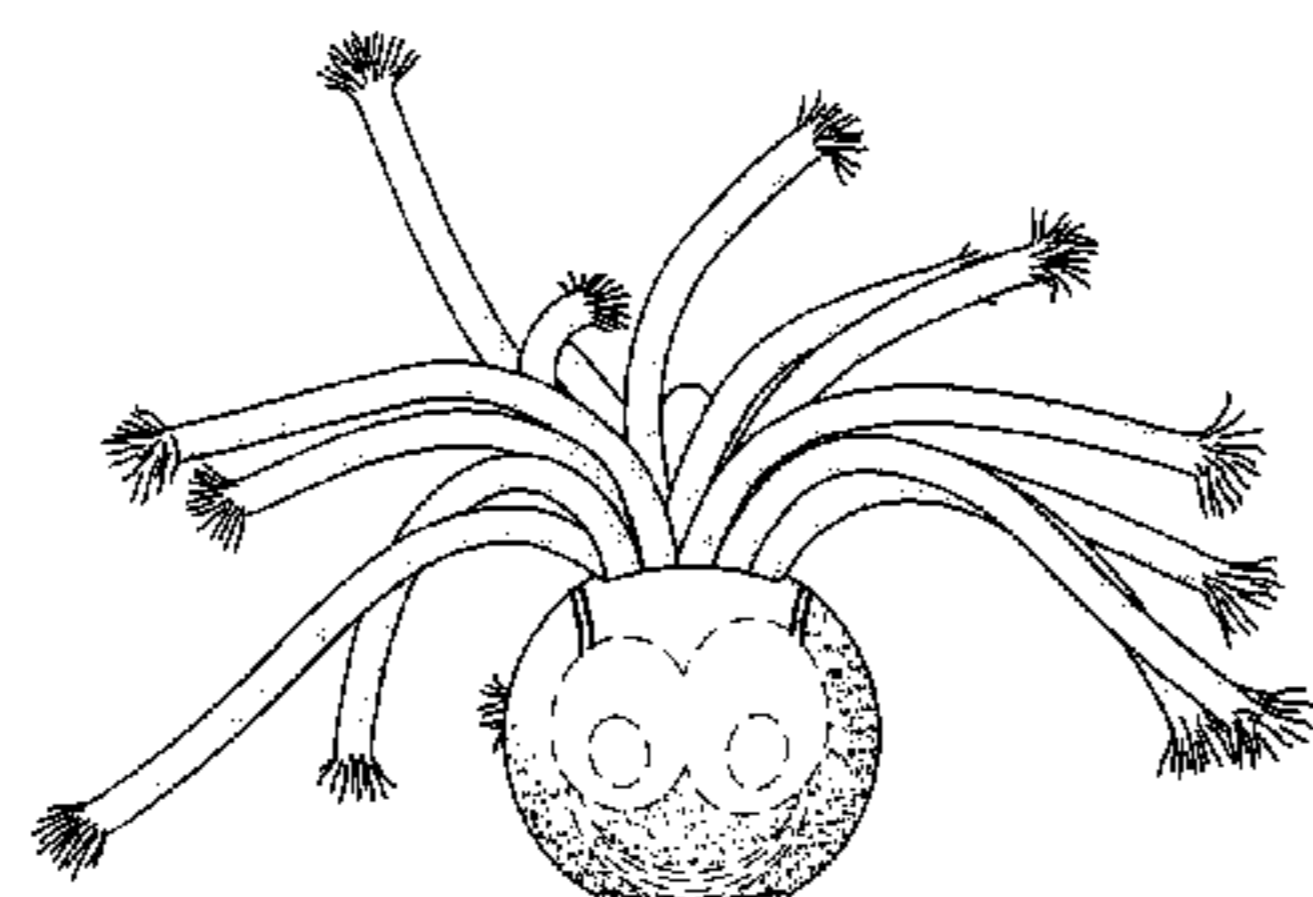
(57) **CLAIM**

I claim the original design for a ball fetch toy, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the invention;
FIG. 2 is a back view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front view of a second embodiment of FIG. 1;

FIG. 10 is a left side view of FIG. 7;
FIG. 11 is a top plan view of FIG. 7; and,

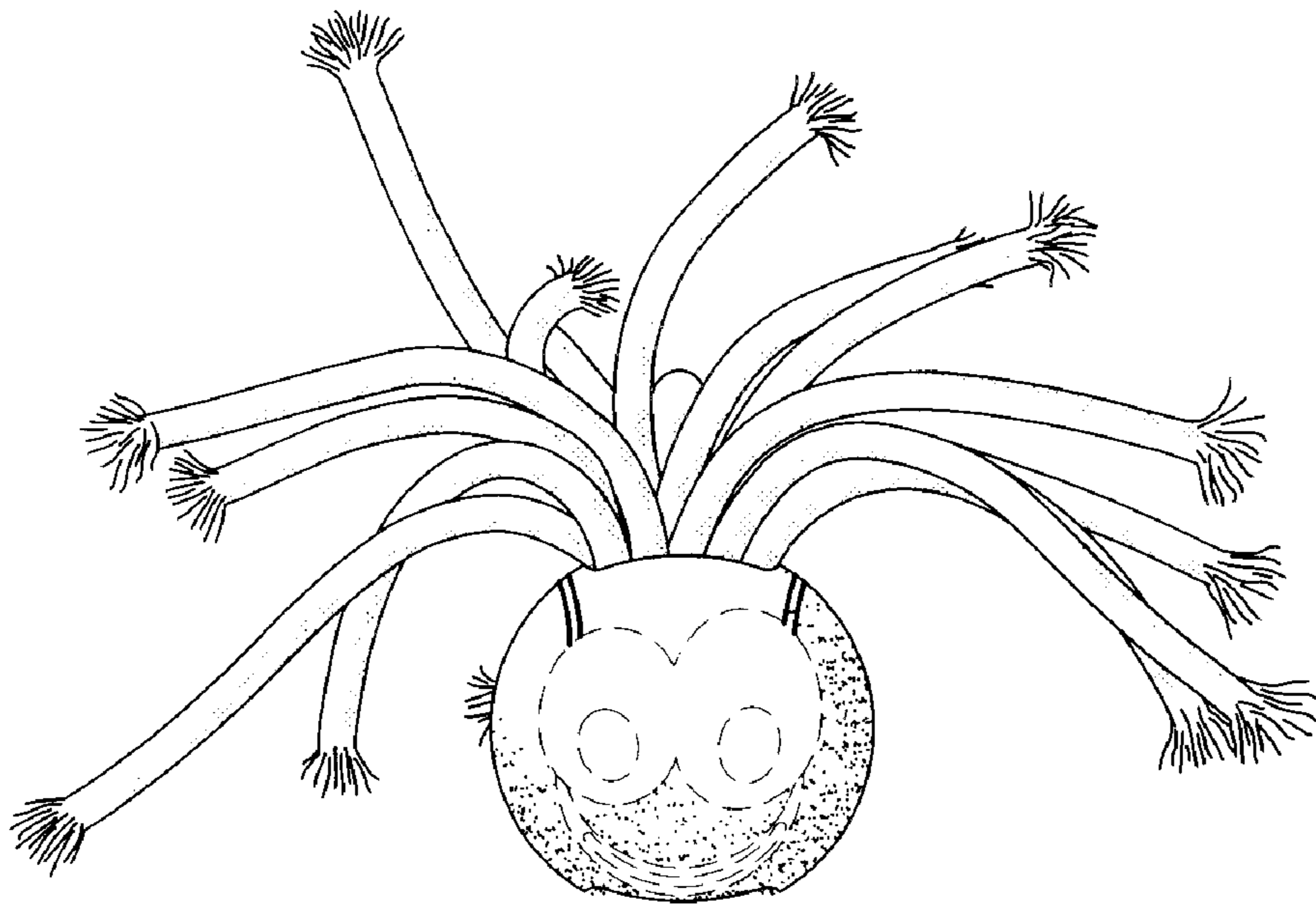

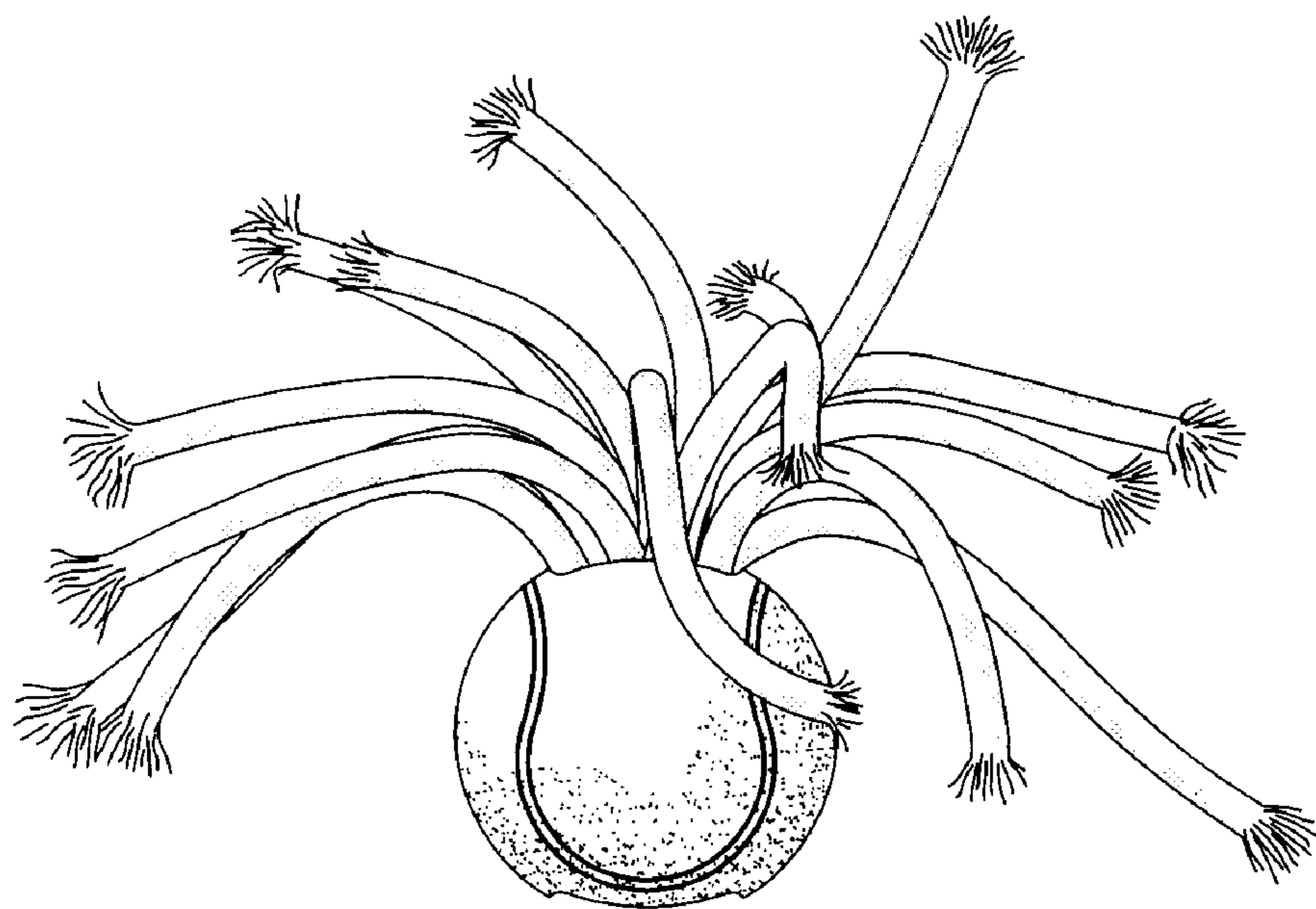

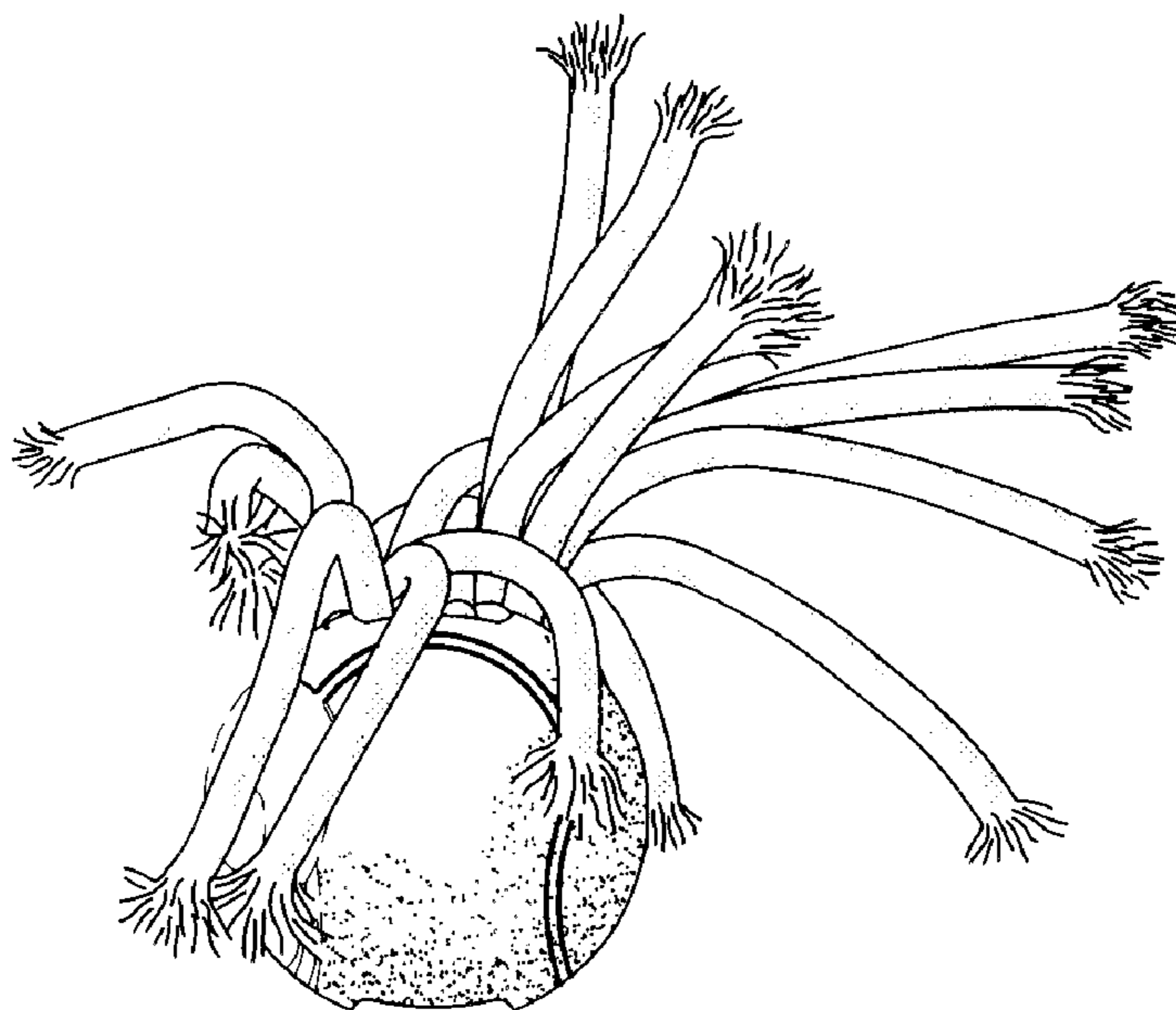

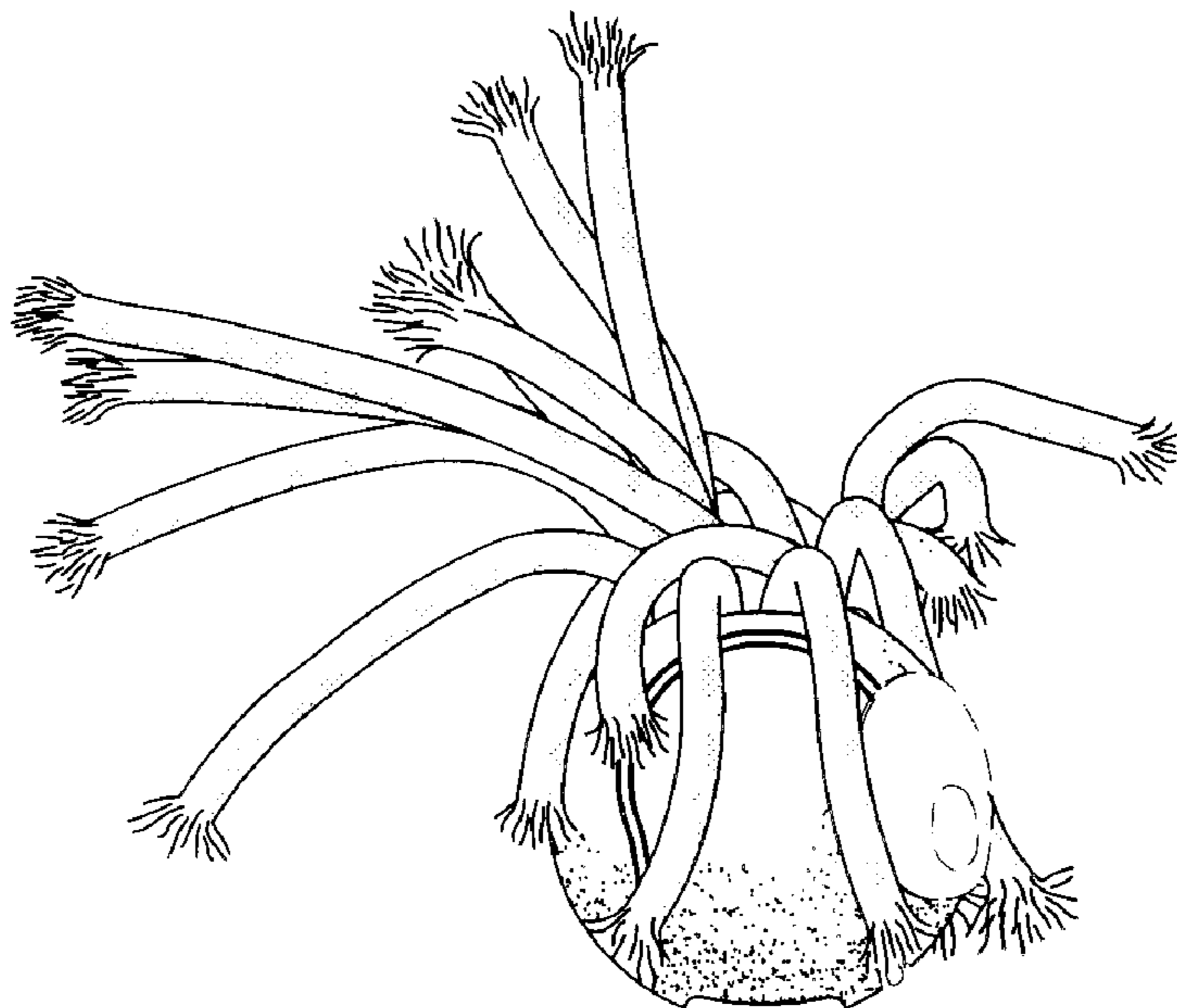

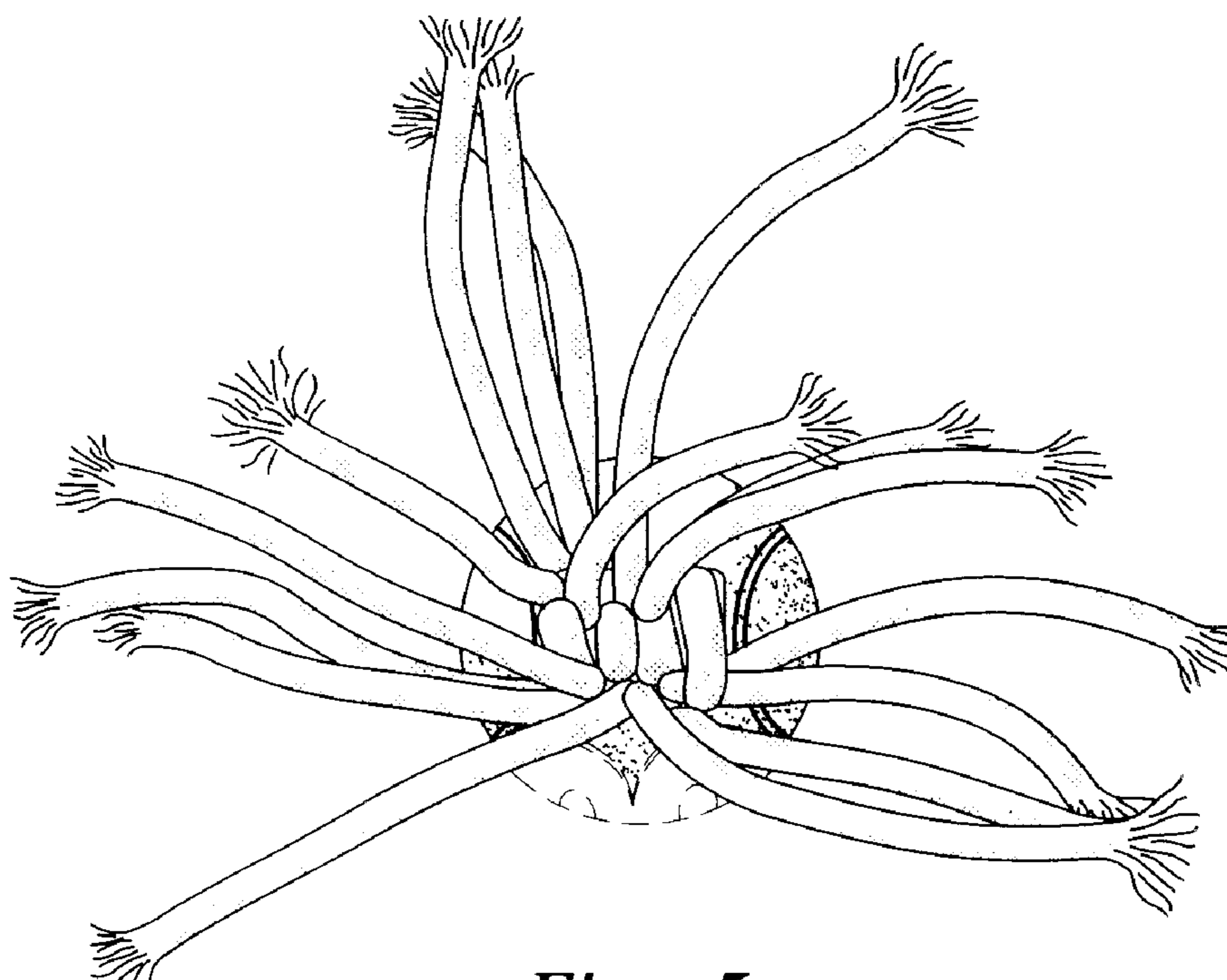

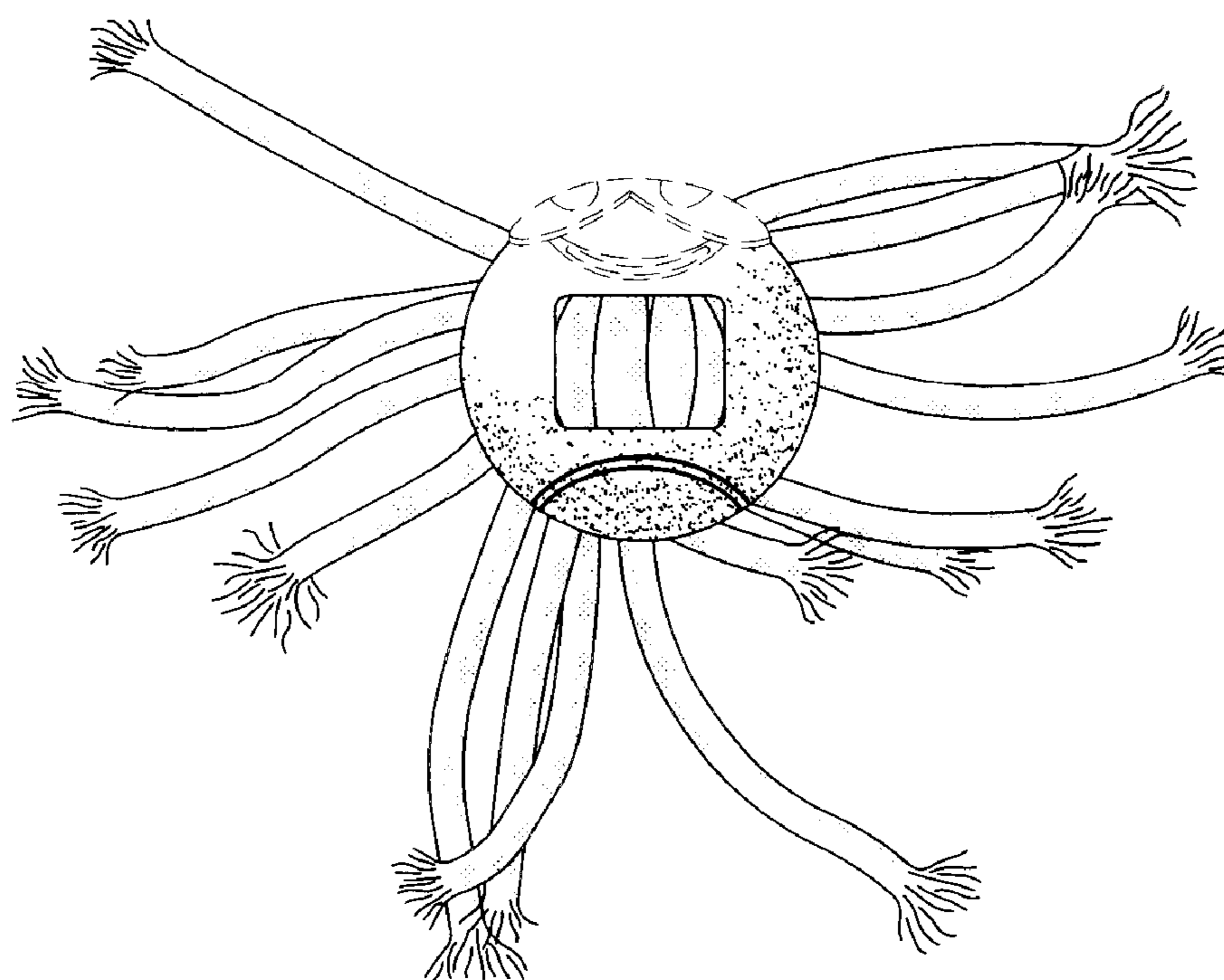

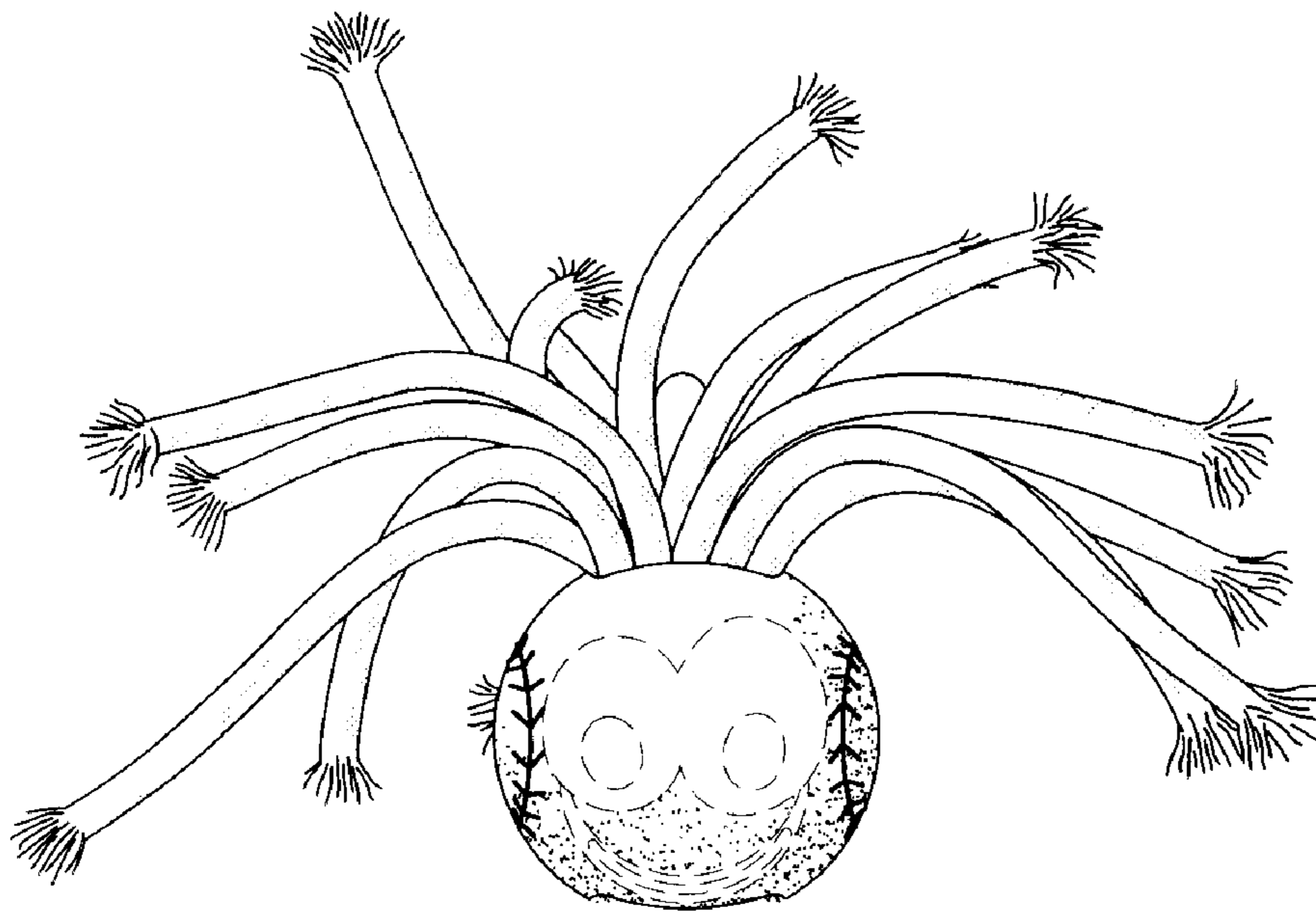

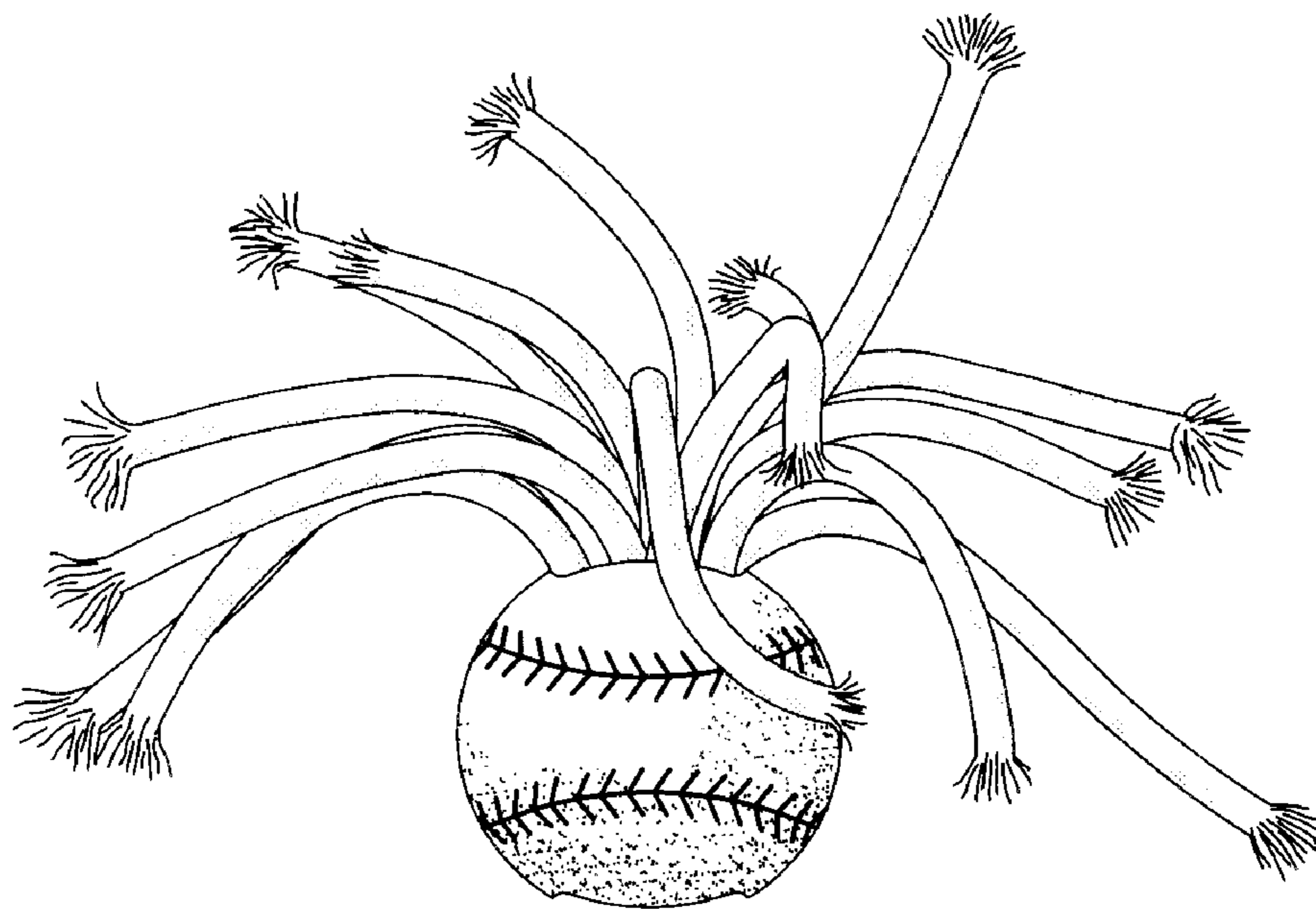

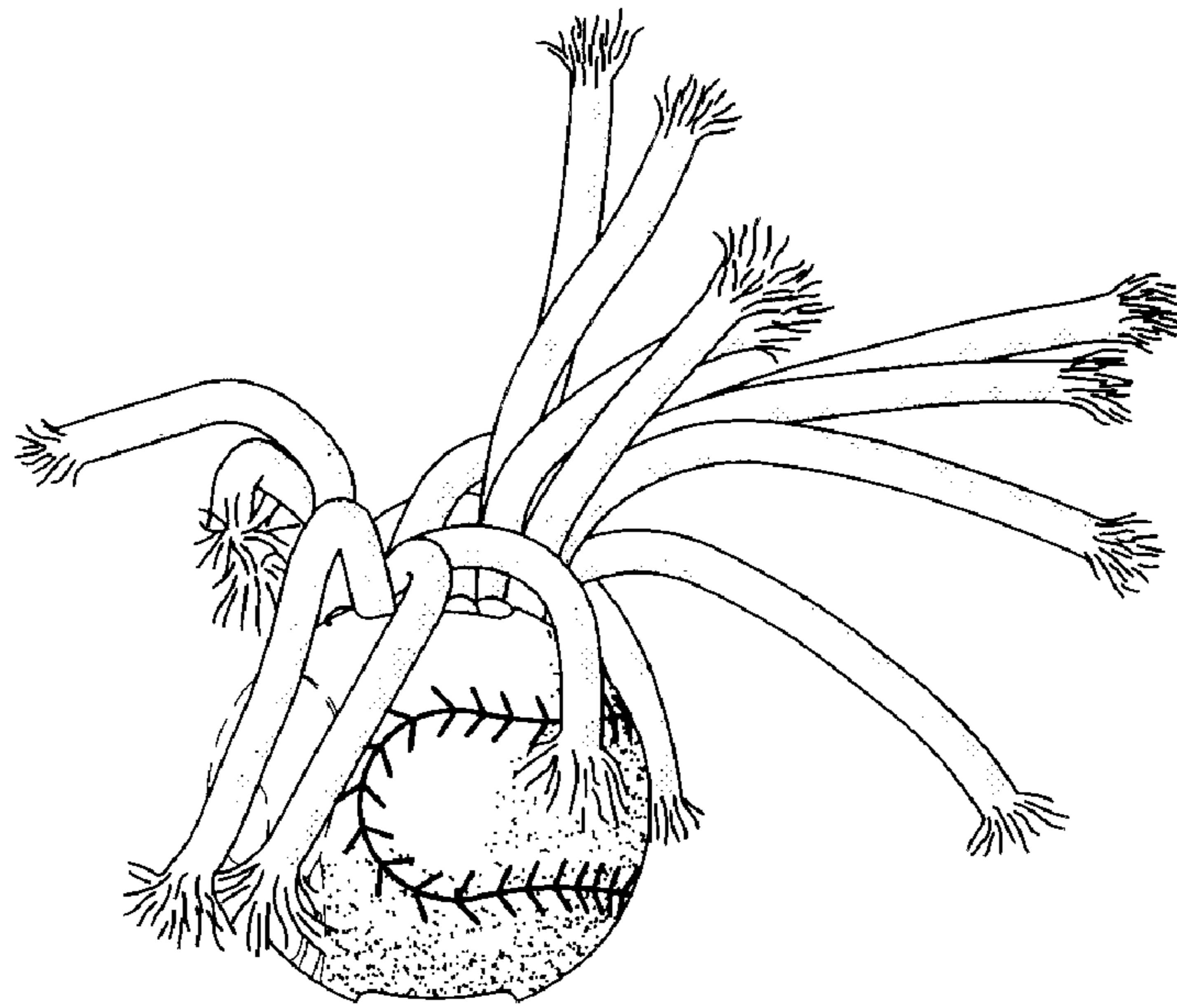

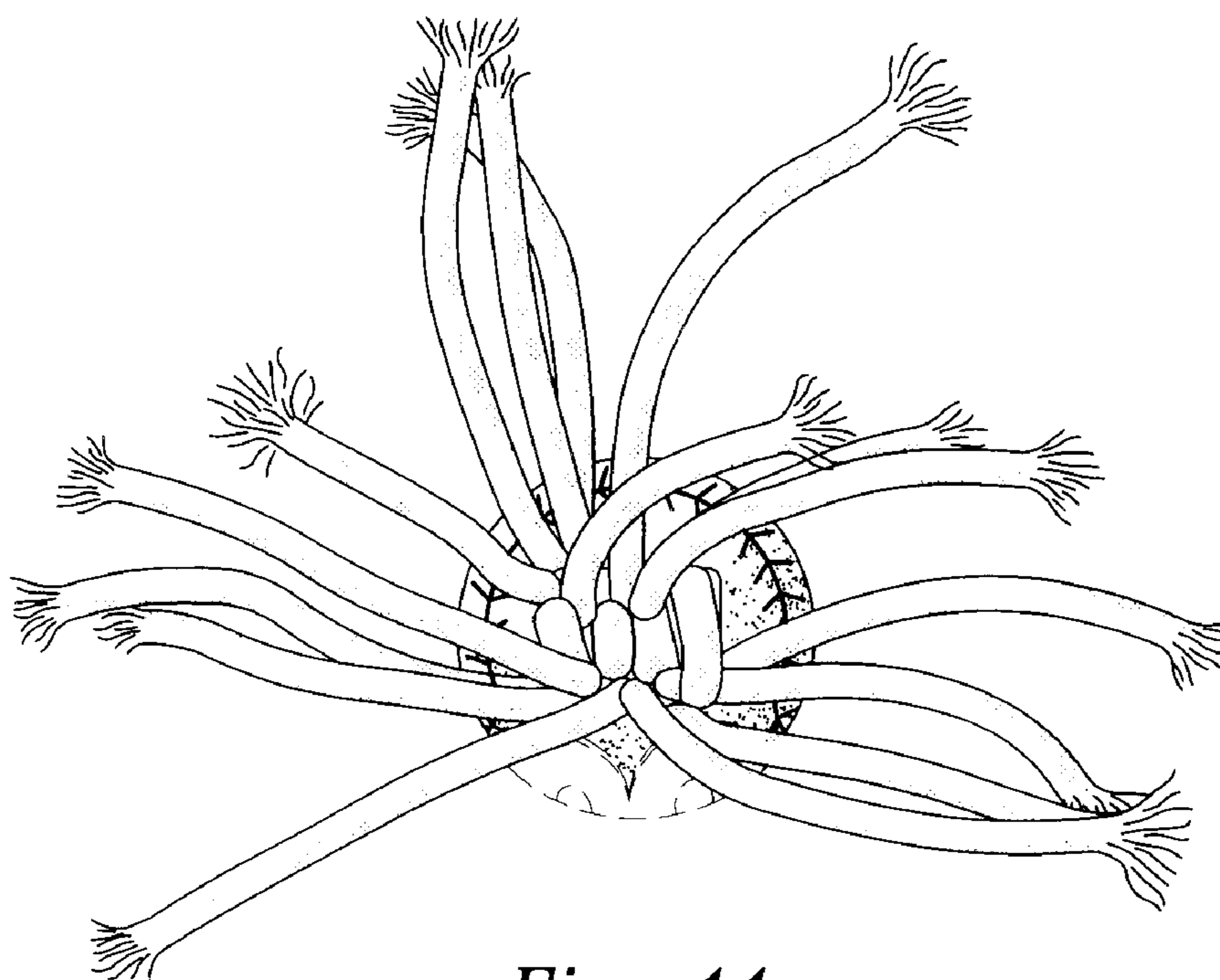

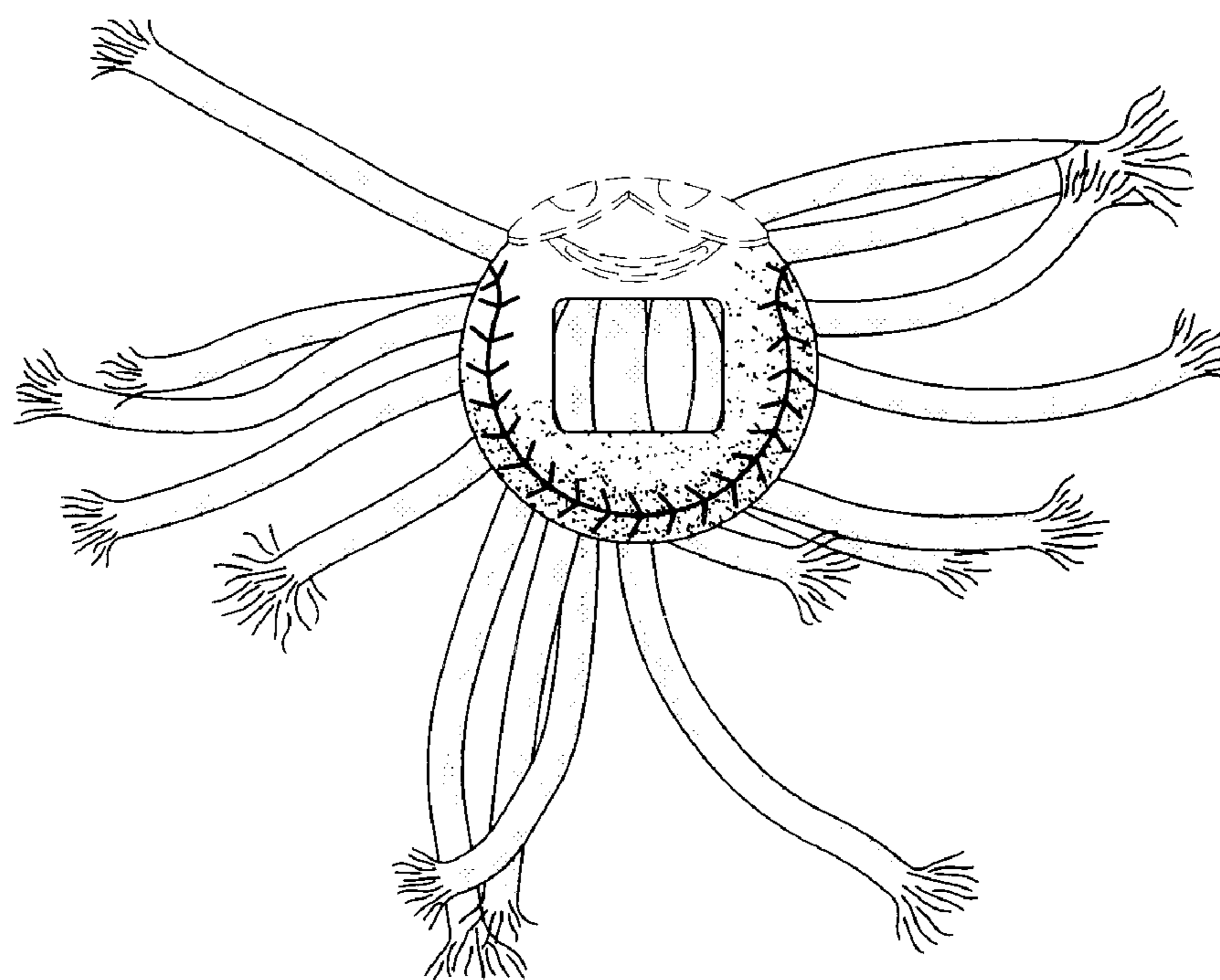
