FIG. 2 is a top view thereof.

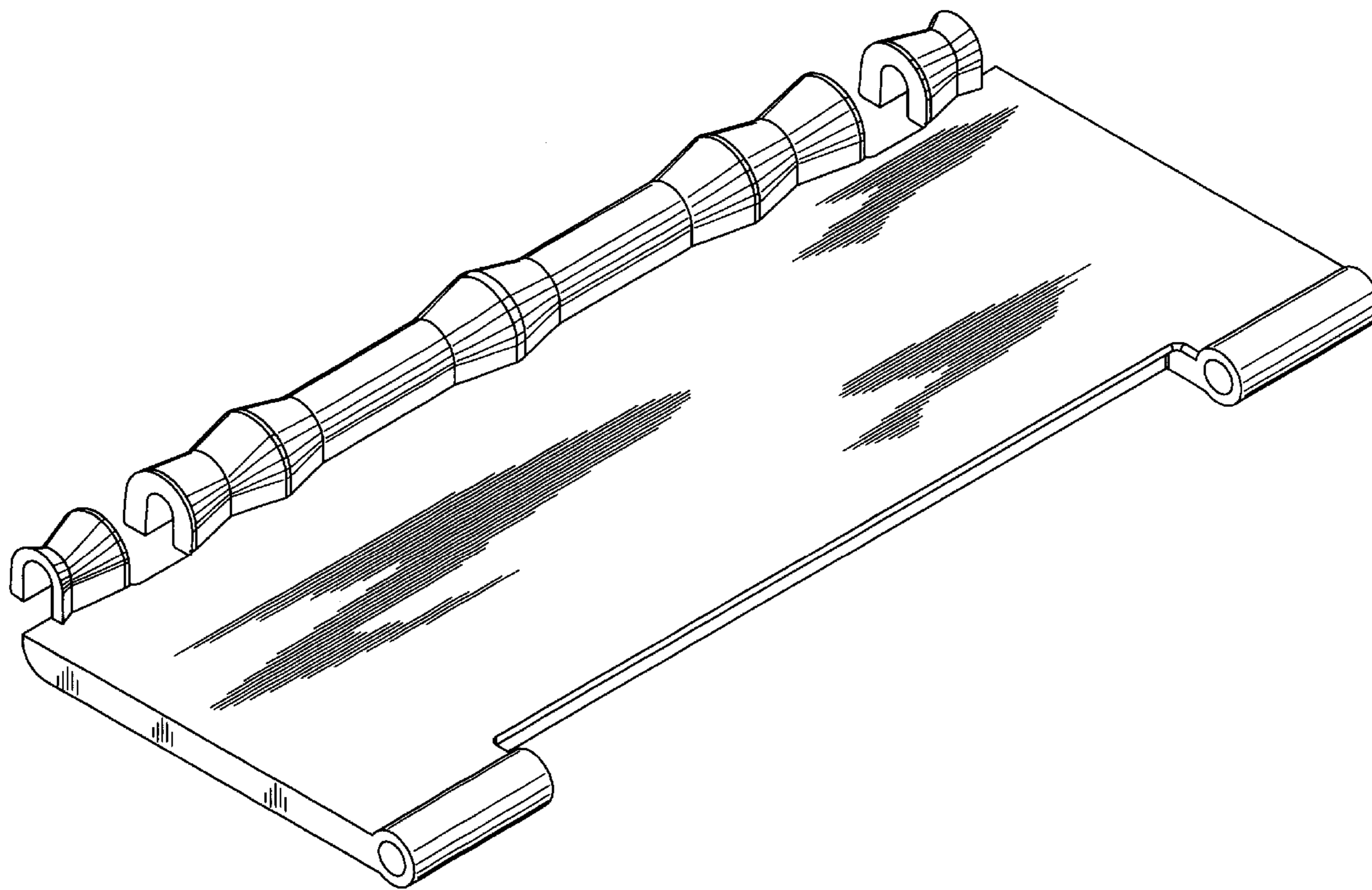
FIG. 3 is a right side elevational view thereof, the left side being a mirror image thereof.

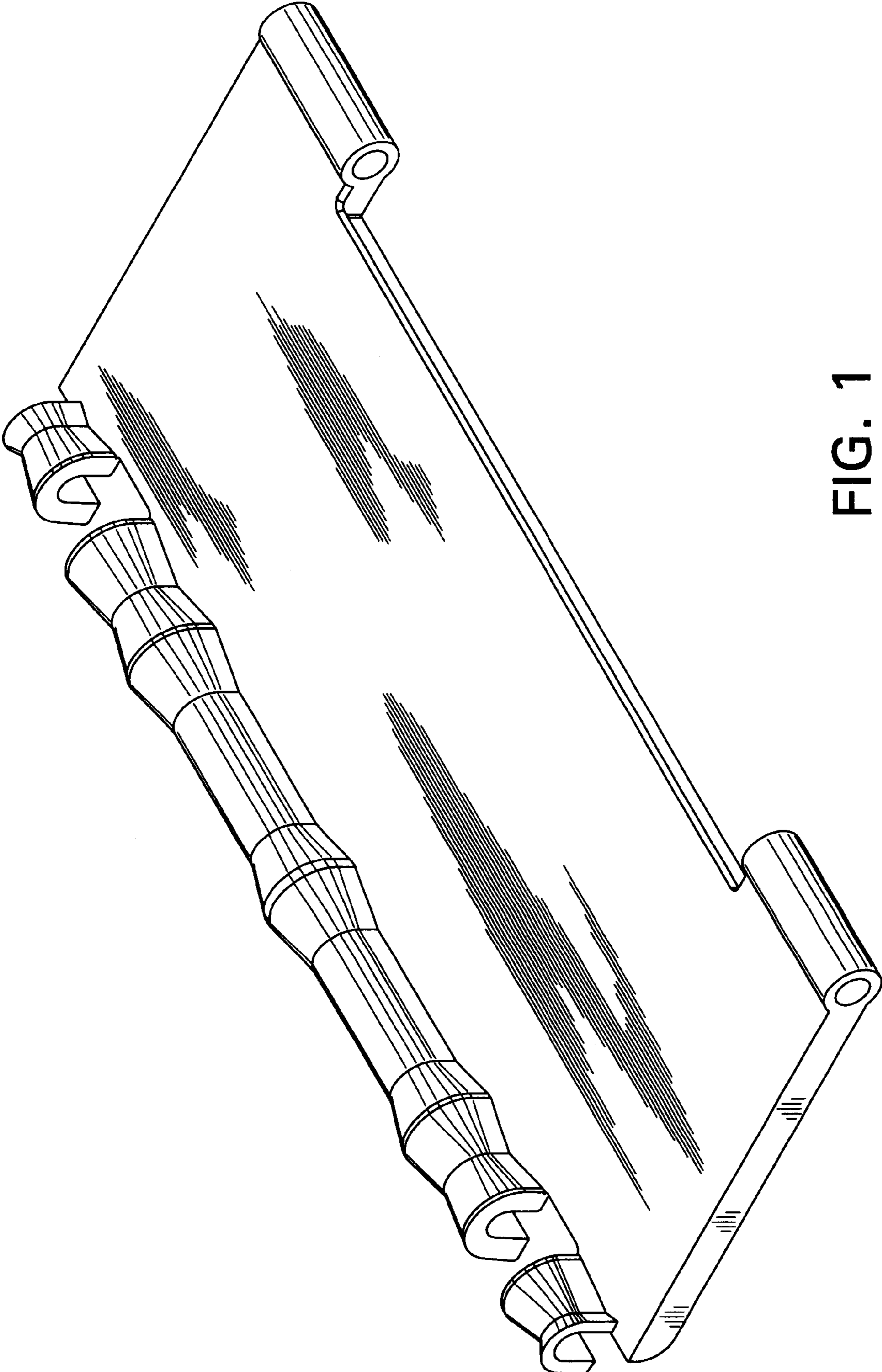

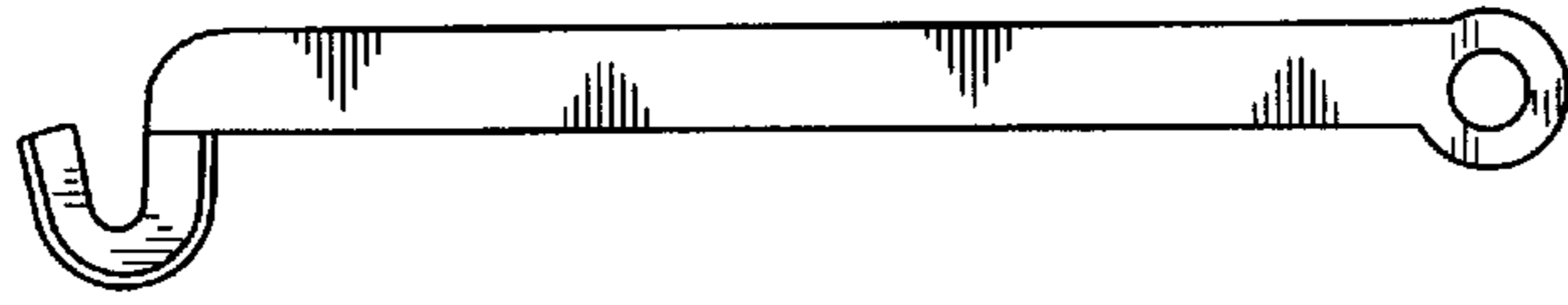

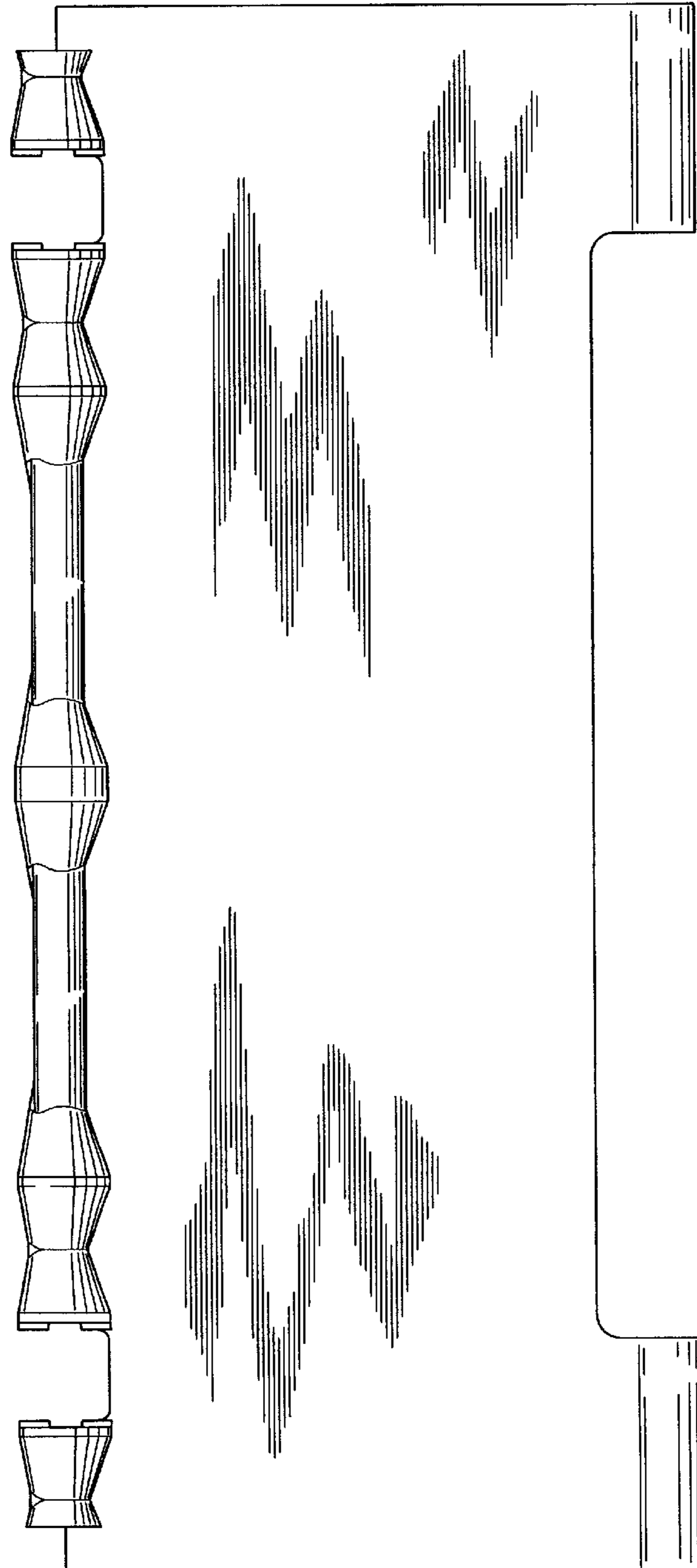

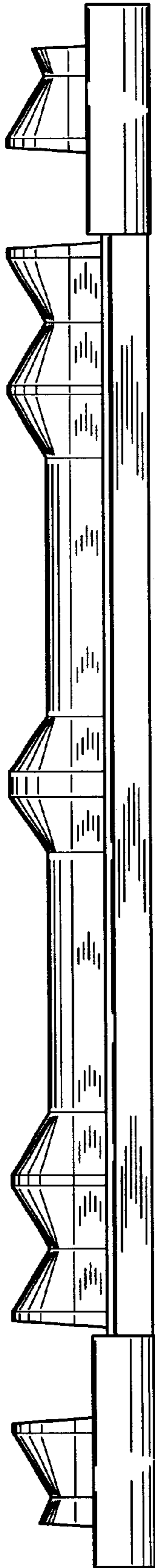

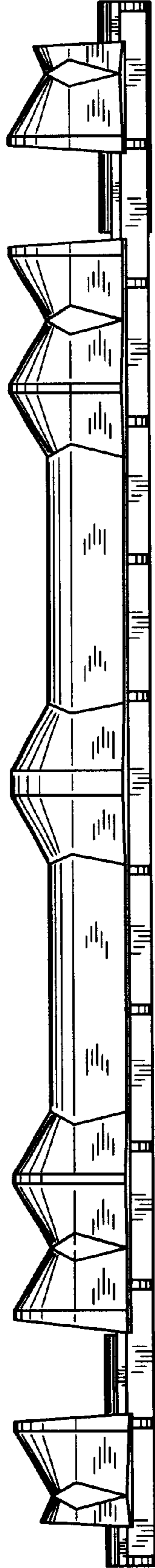

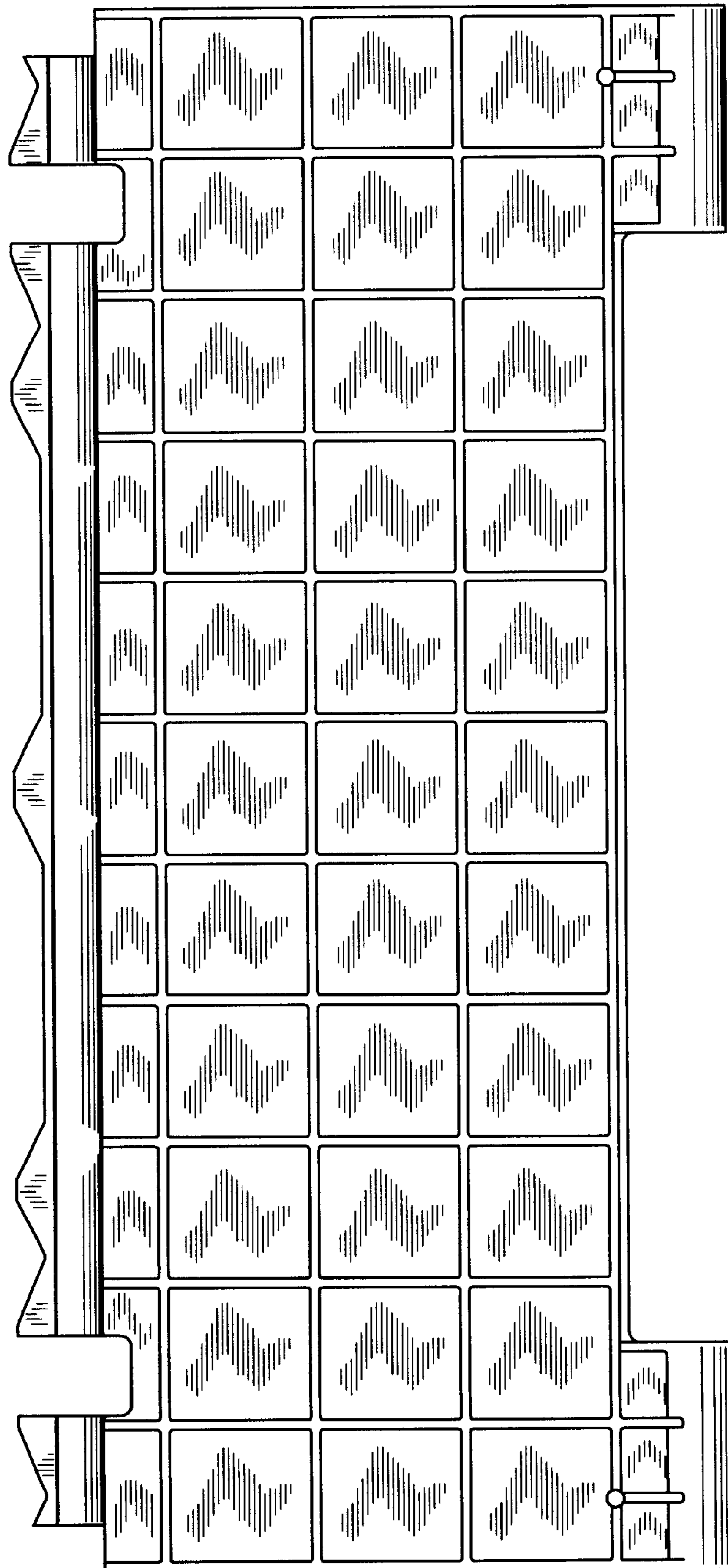
