(57) **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design;  
FIG. 2 is a side elevational view thereof;  
FIG. 3 is a rear perspective view thereof; and,  
FIG. 4 is an enlarged view of the portion shown in FIG. 1. The uneven broken line immediately adjacent to the shaded area represents an unclaimed boundary of the design. The uneven broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

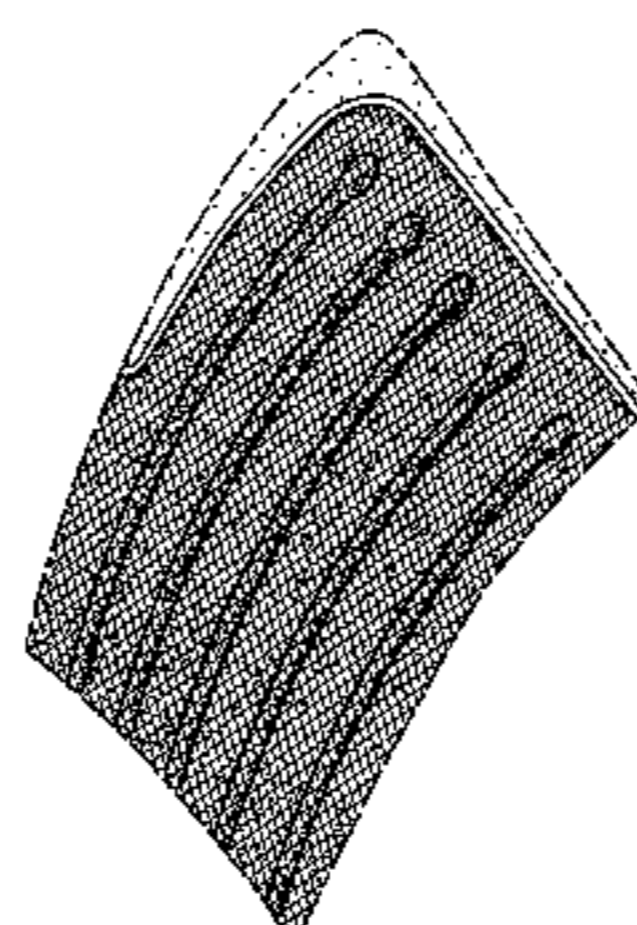
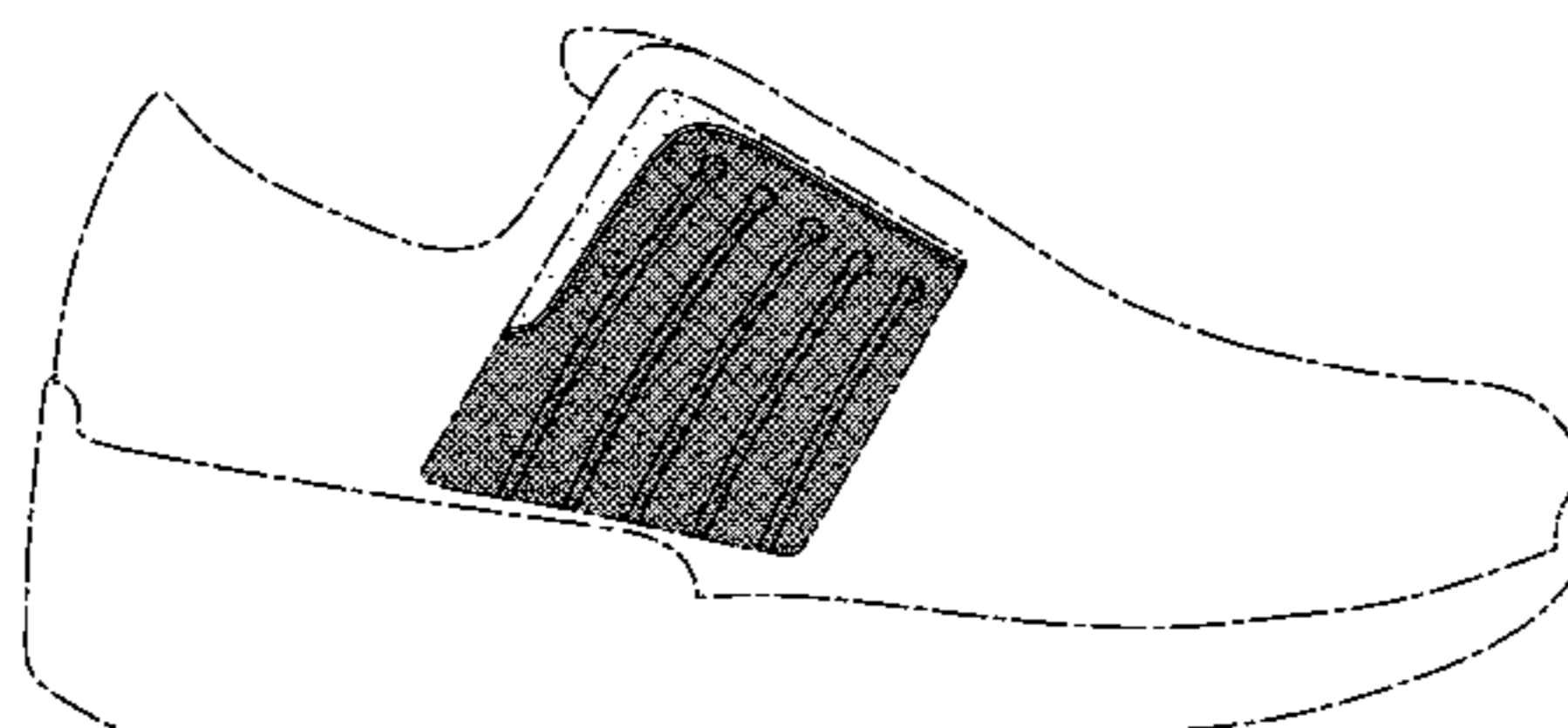

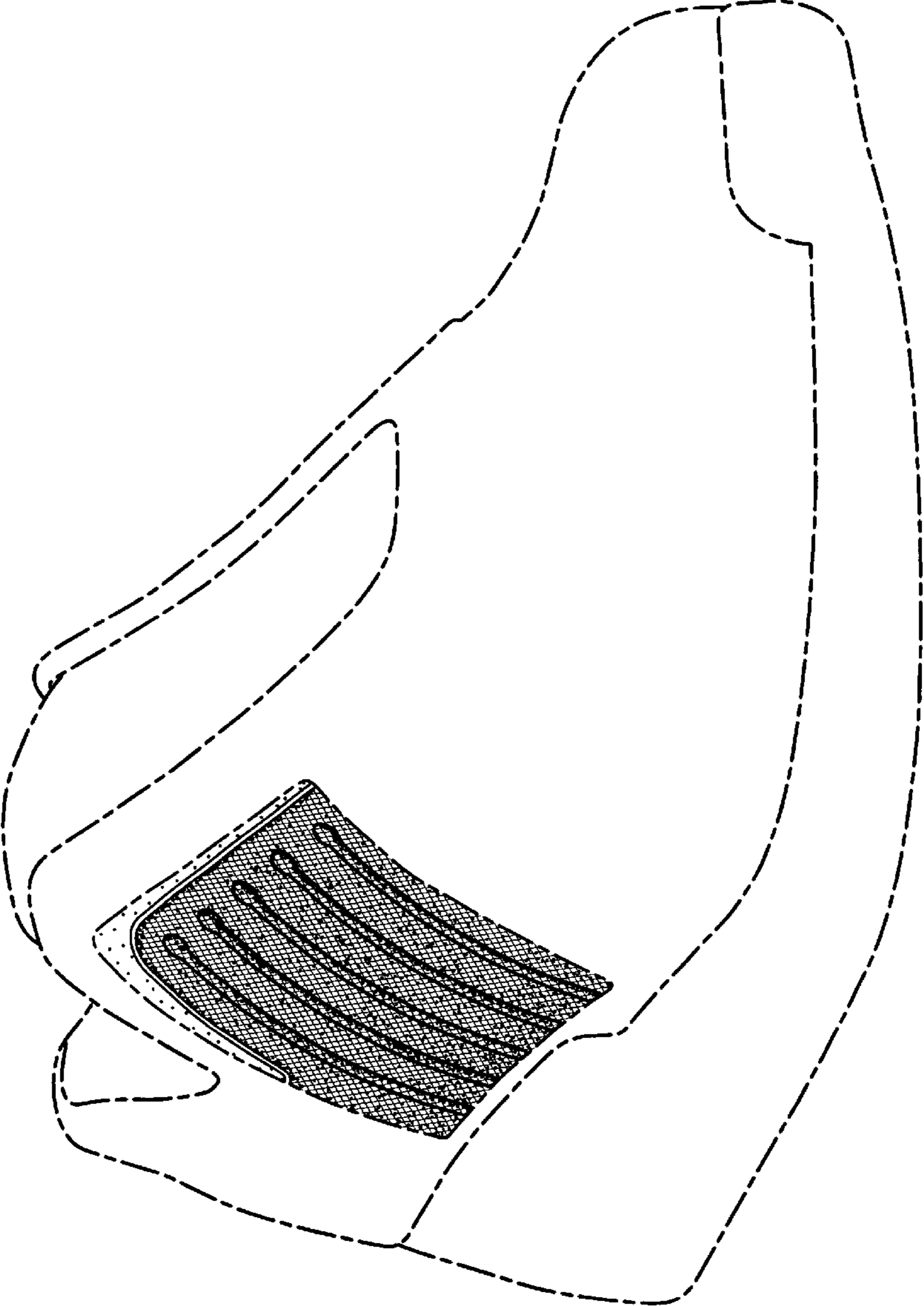

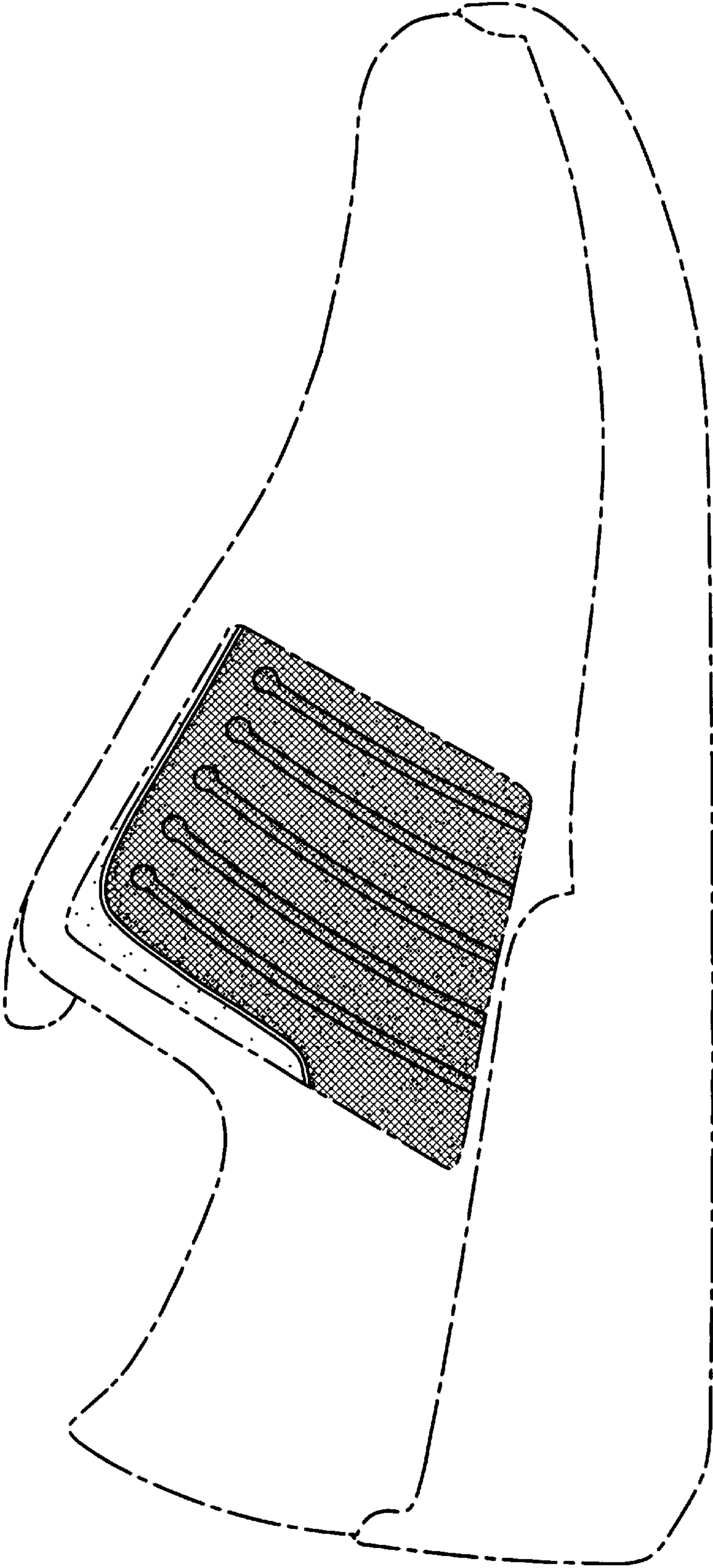

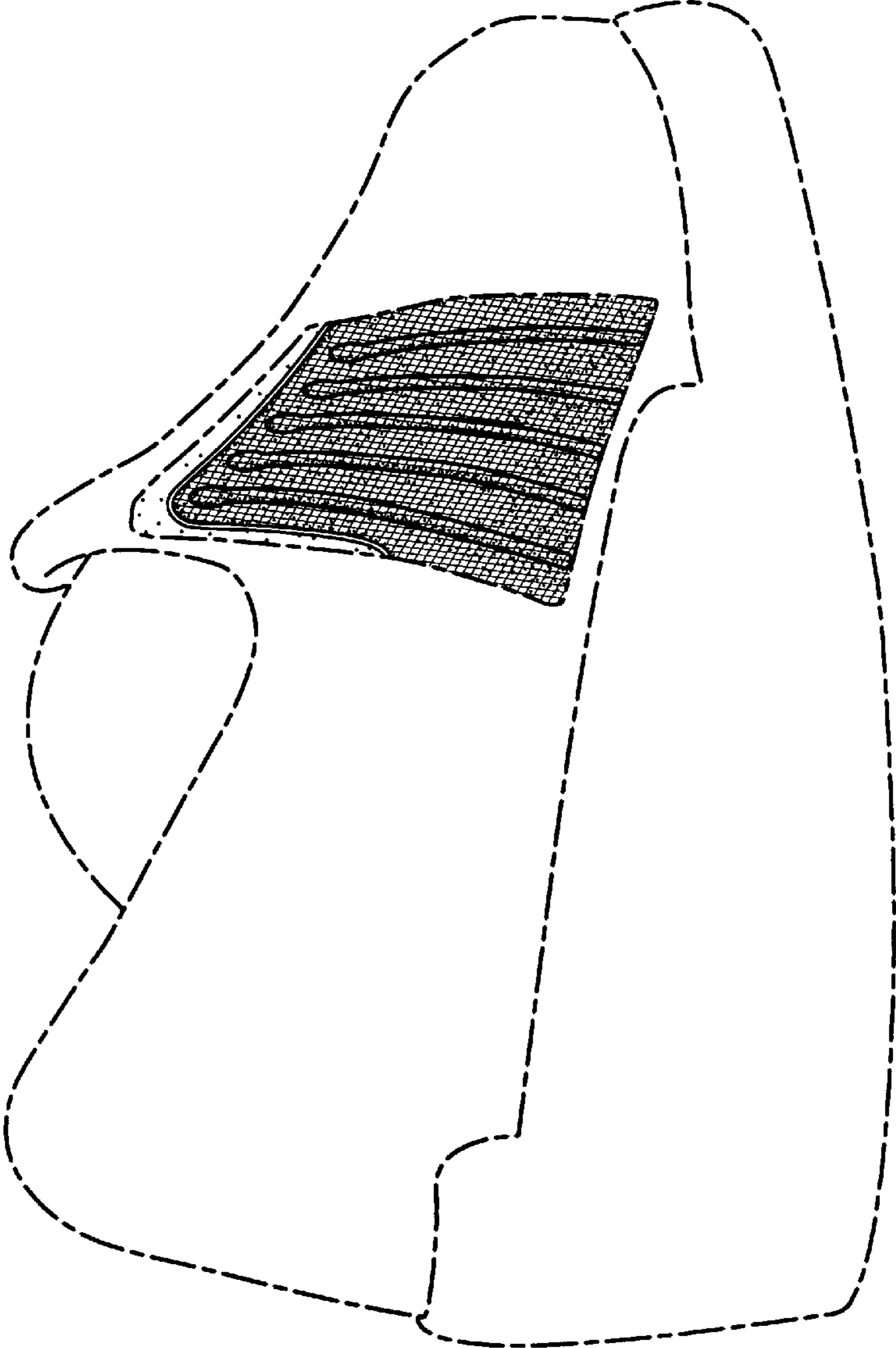
