**DESCRIPTION**

FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design;

FIG. 3 is a side view of one side thereof;

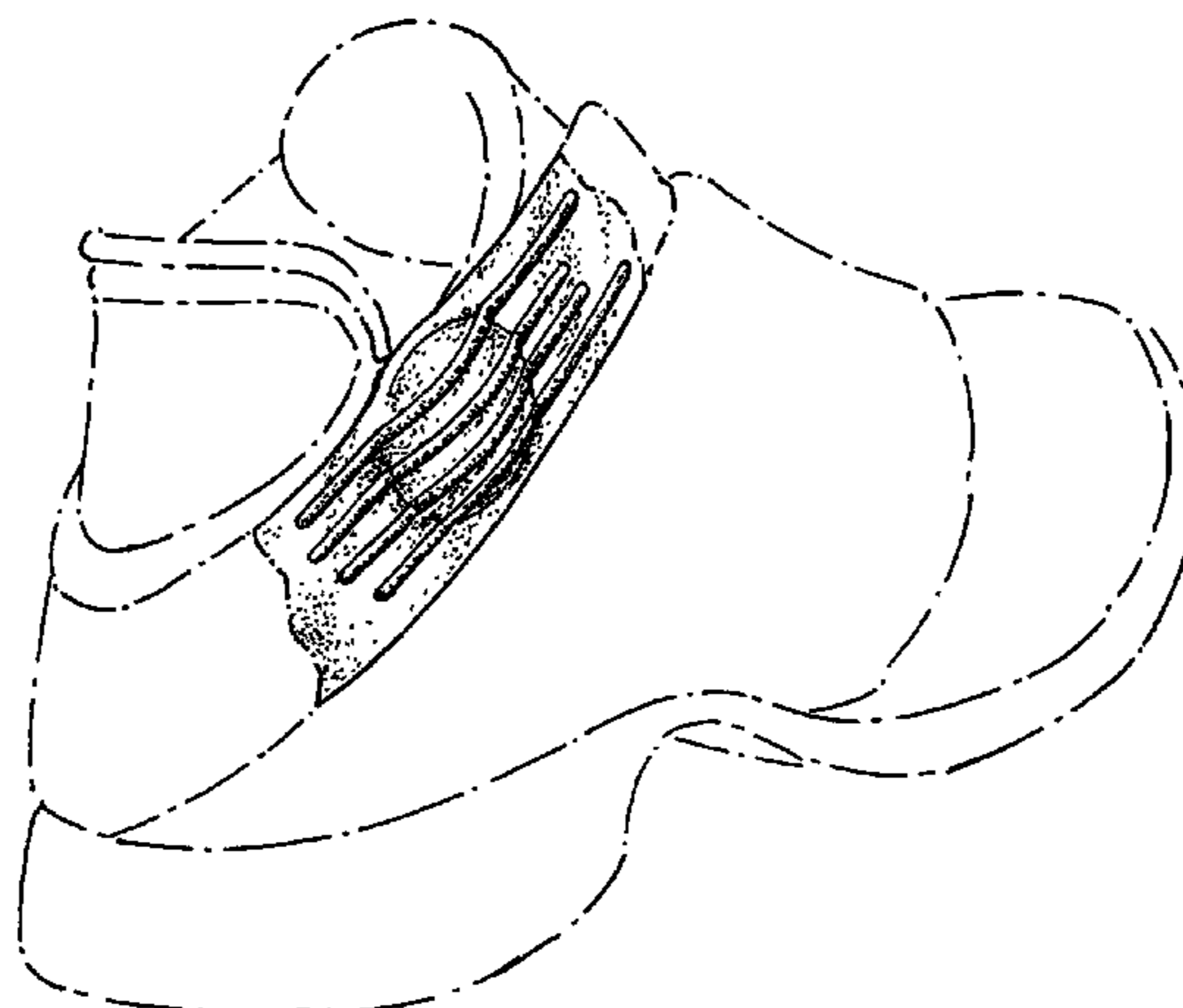
FIG. 4 is a front view thereof;

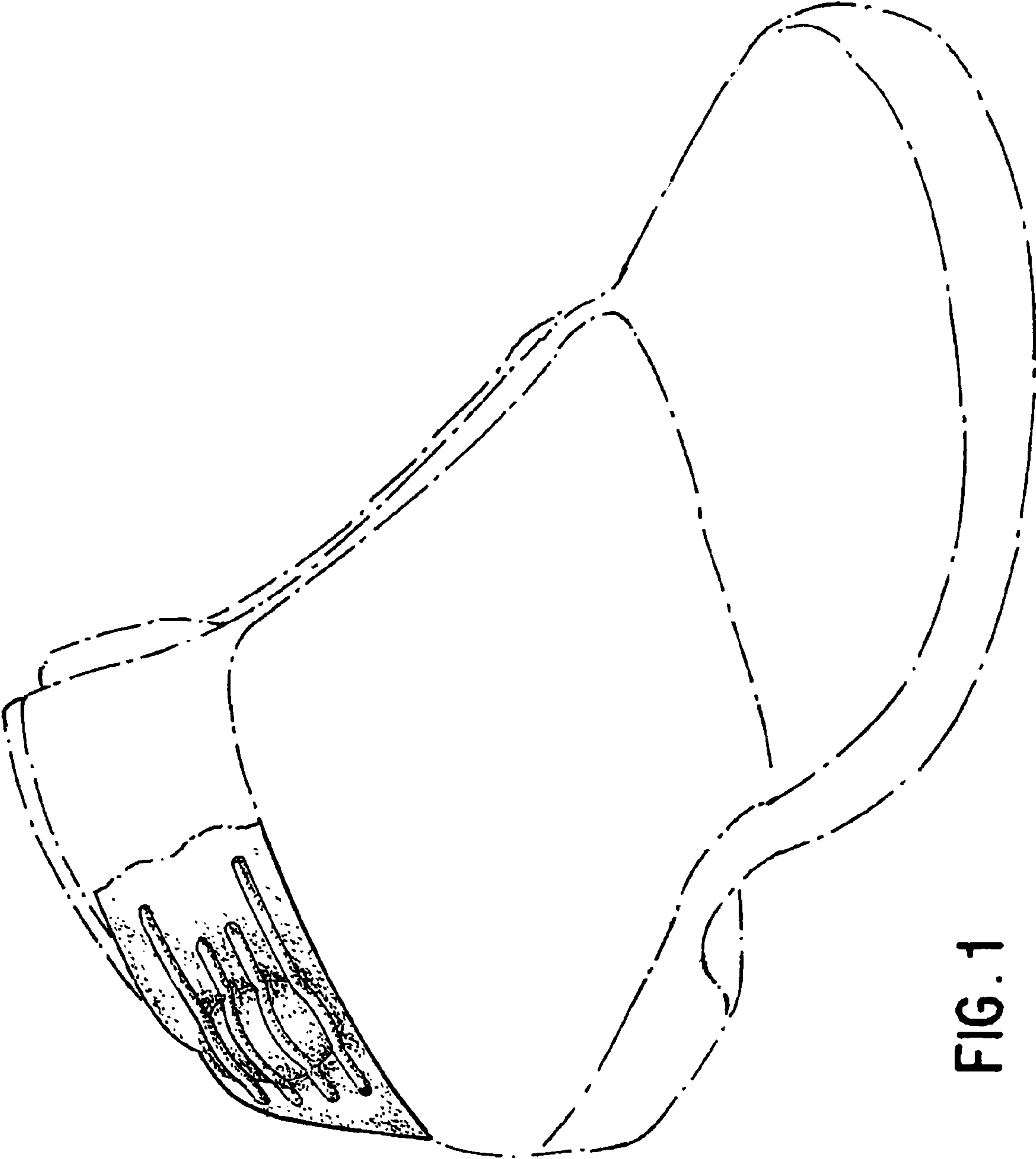

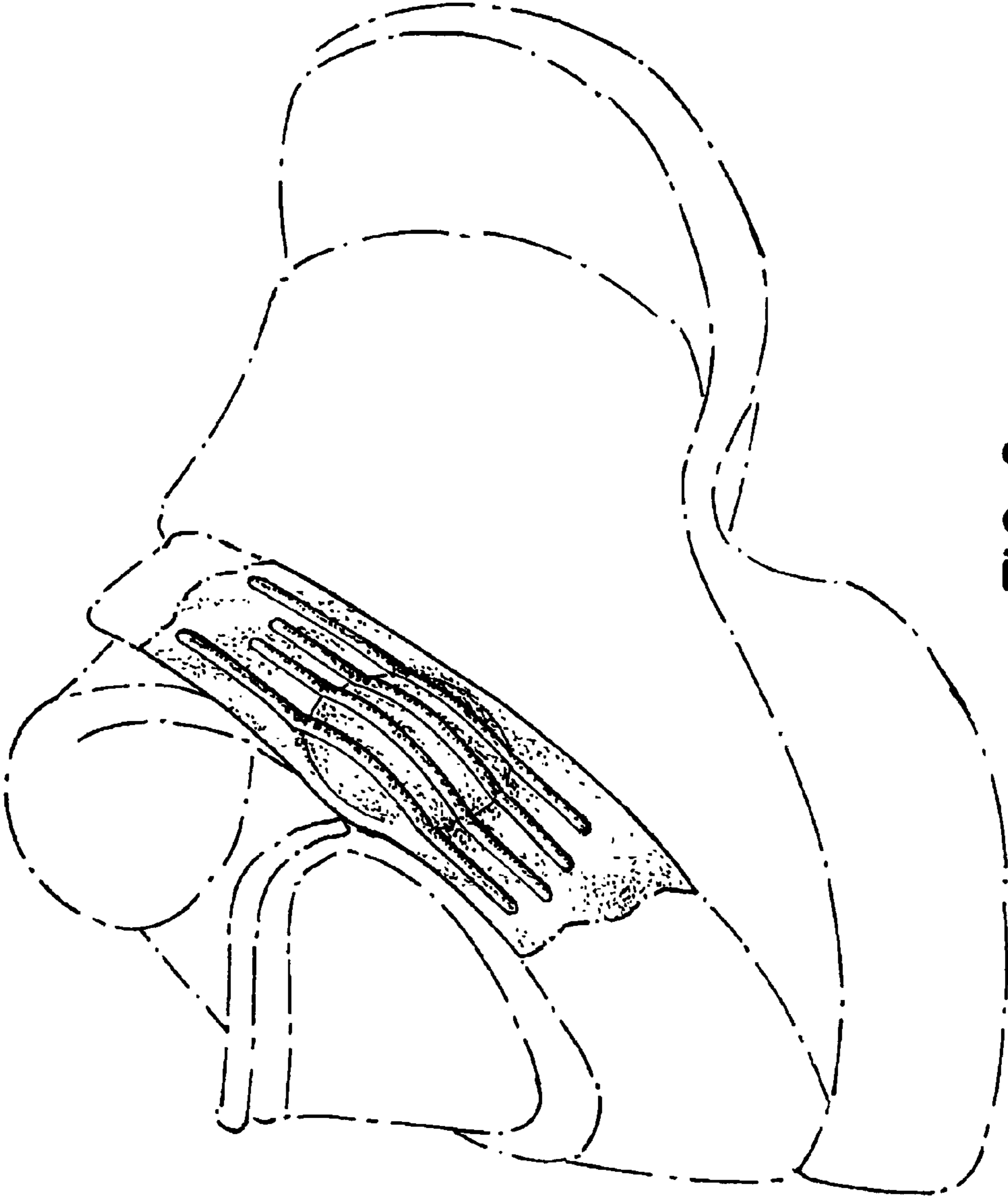

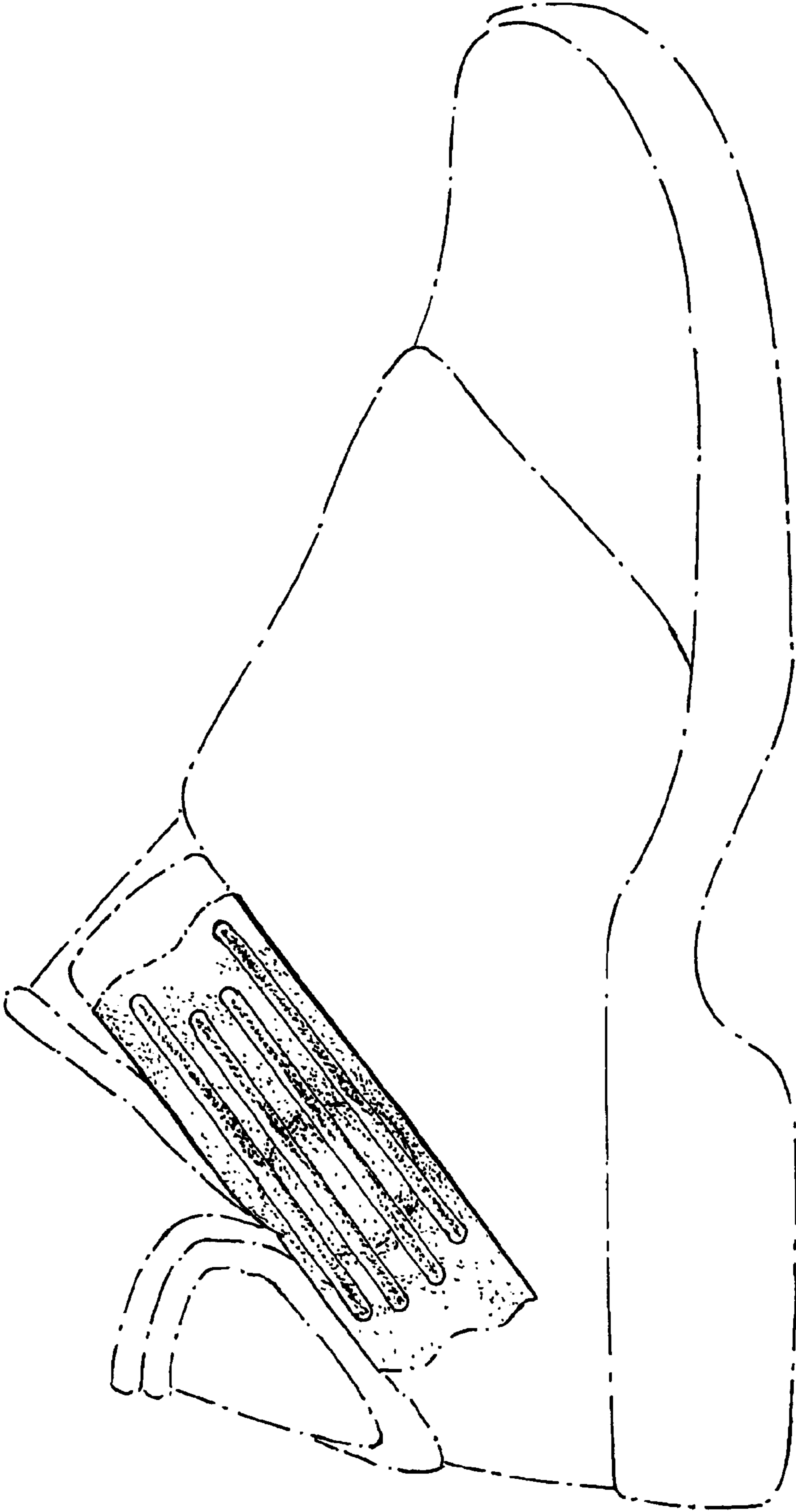

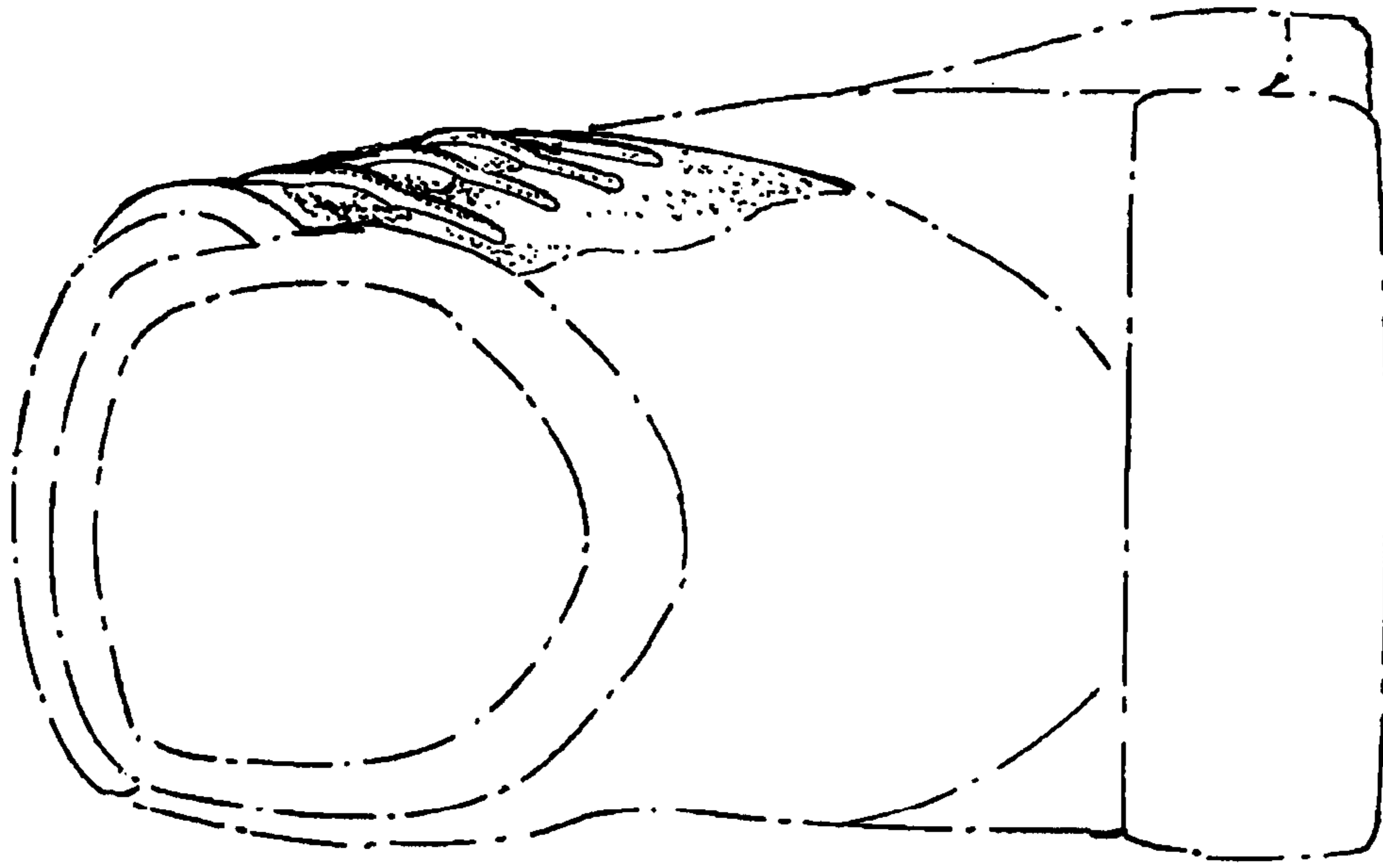

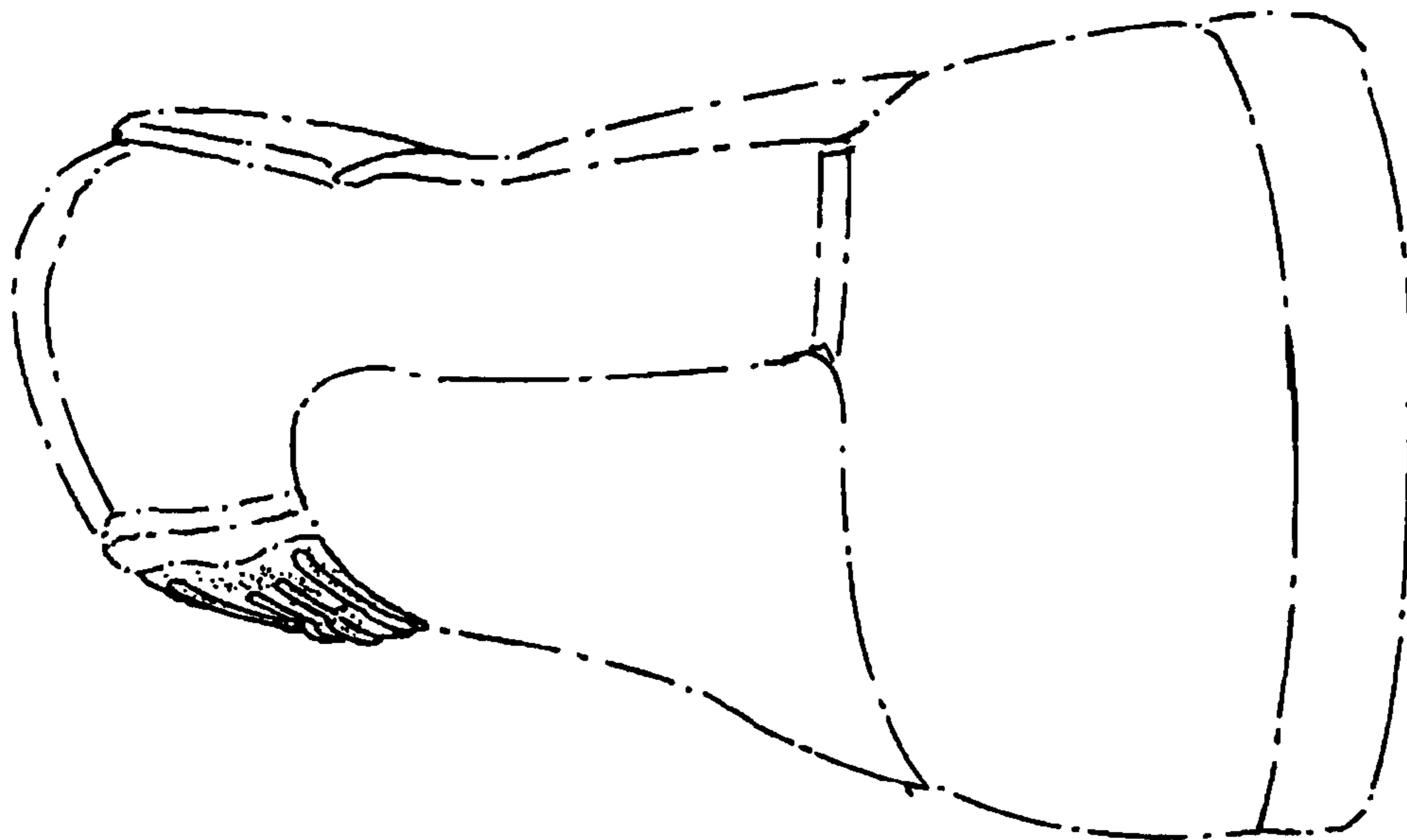

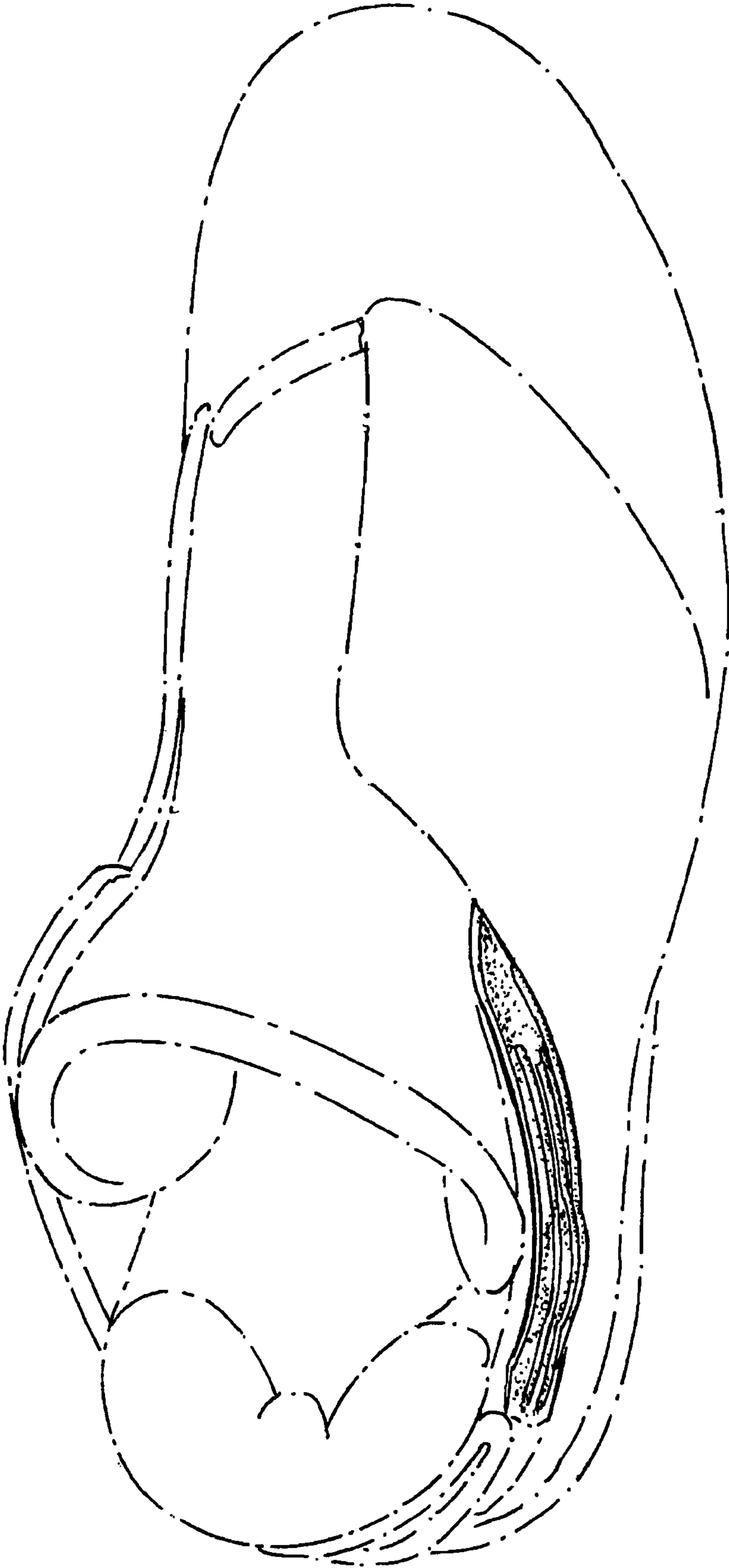
