(57) **CLAIM**

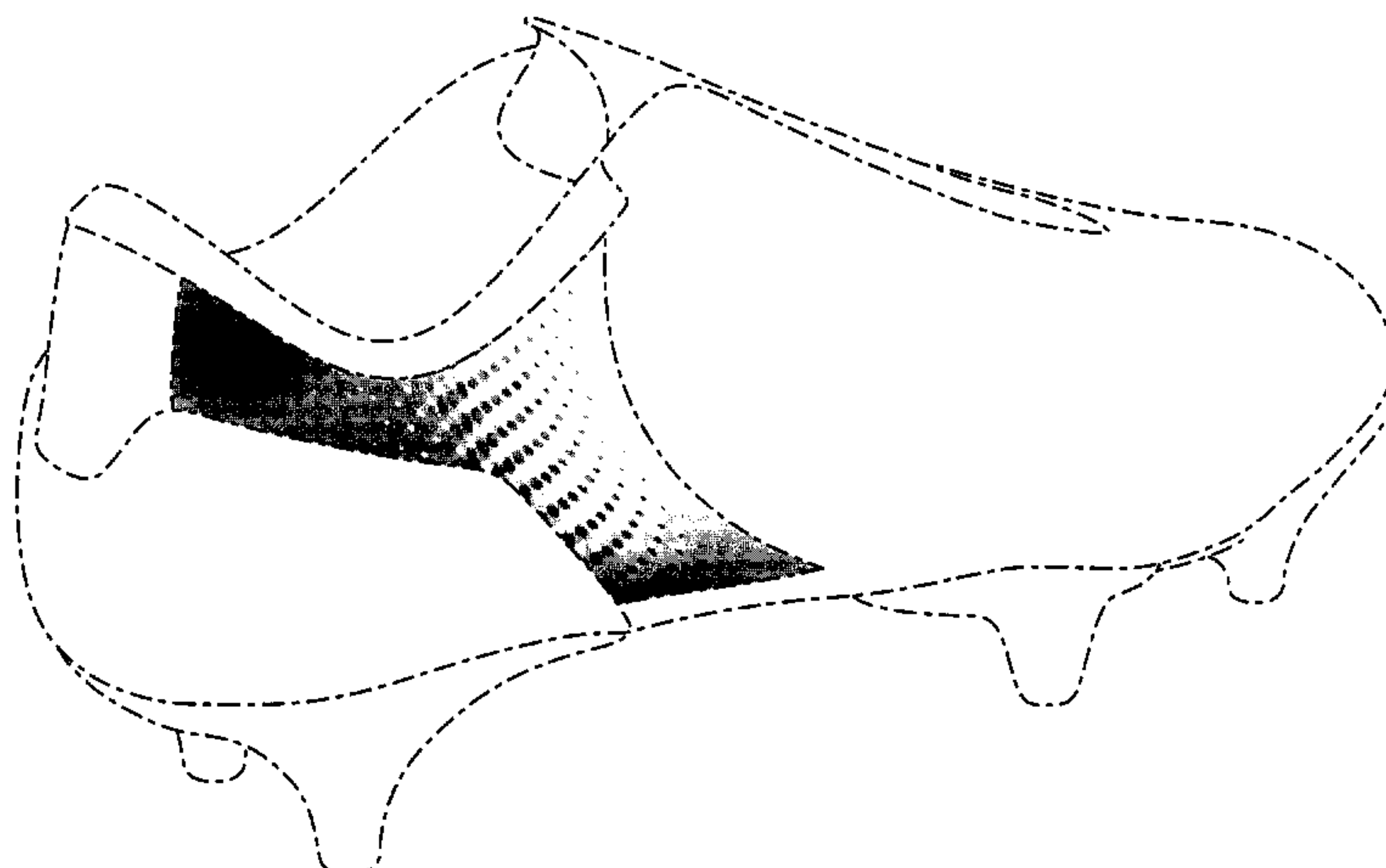
The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a portion of a shoe upper showing my new design;
FIG. 2 is a second perspective thereof;
FIG. 3 is a side view thereof; and,
FIG. 4 is a rear view thereof.

The uneven broken line immediately adjacent to the shaded area represents an unclaimed boundary of the design. The uneven broken line through the shaded area is for illustrative purposes and forms no part of the claimed design. The uneven broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

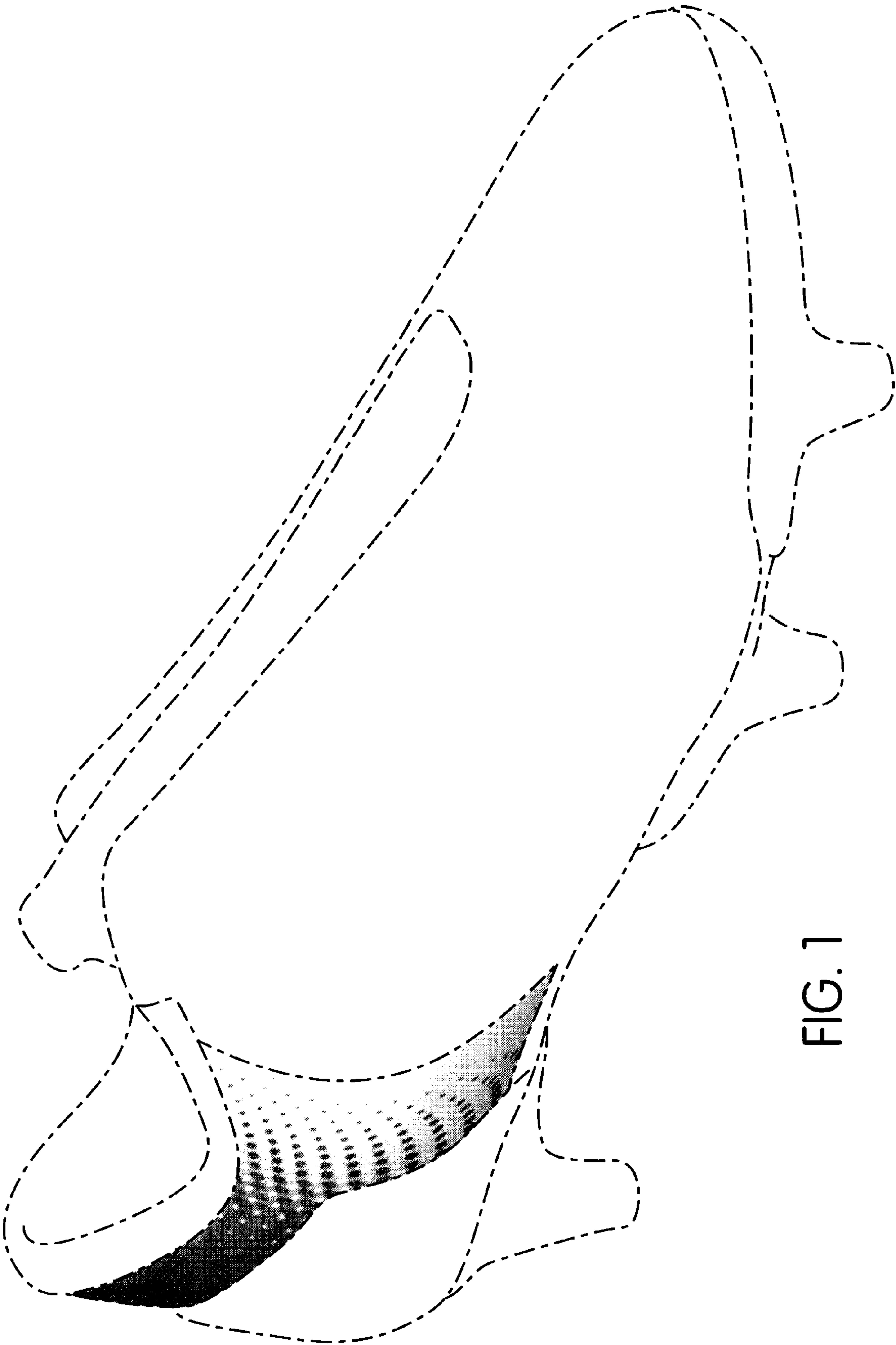

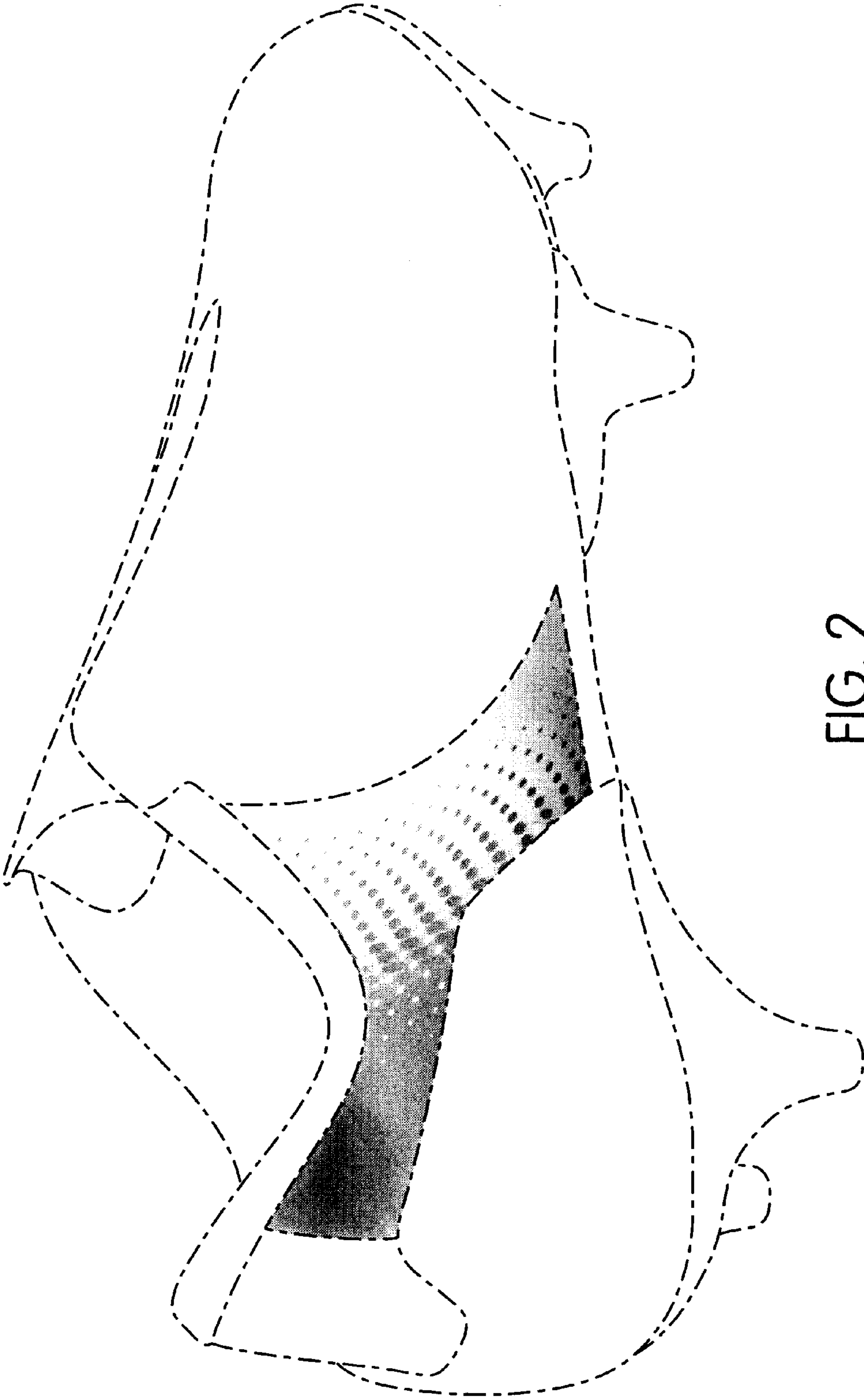

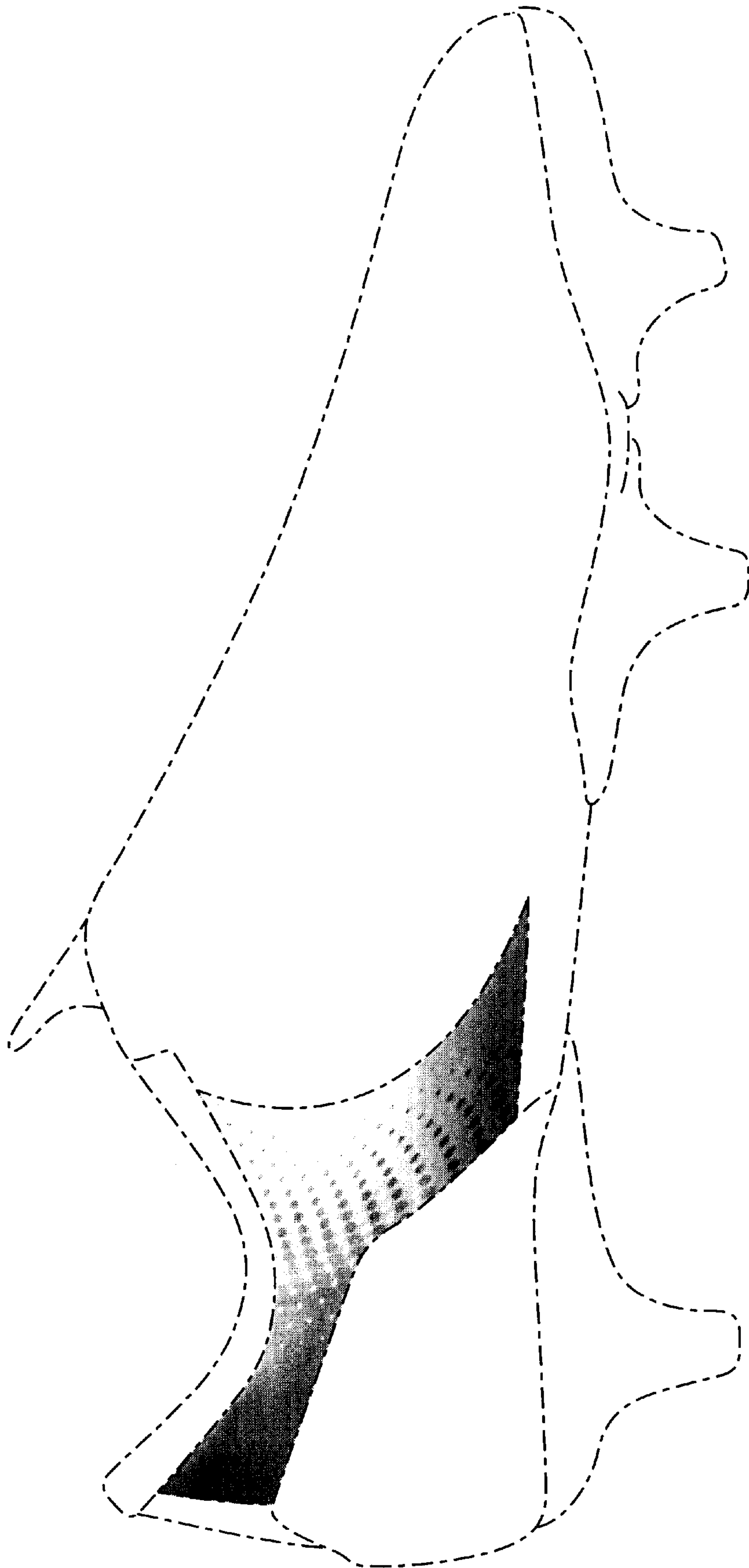

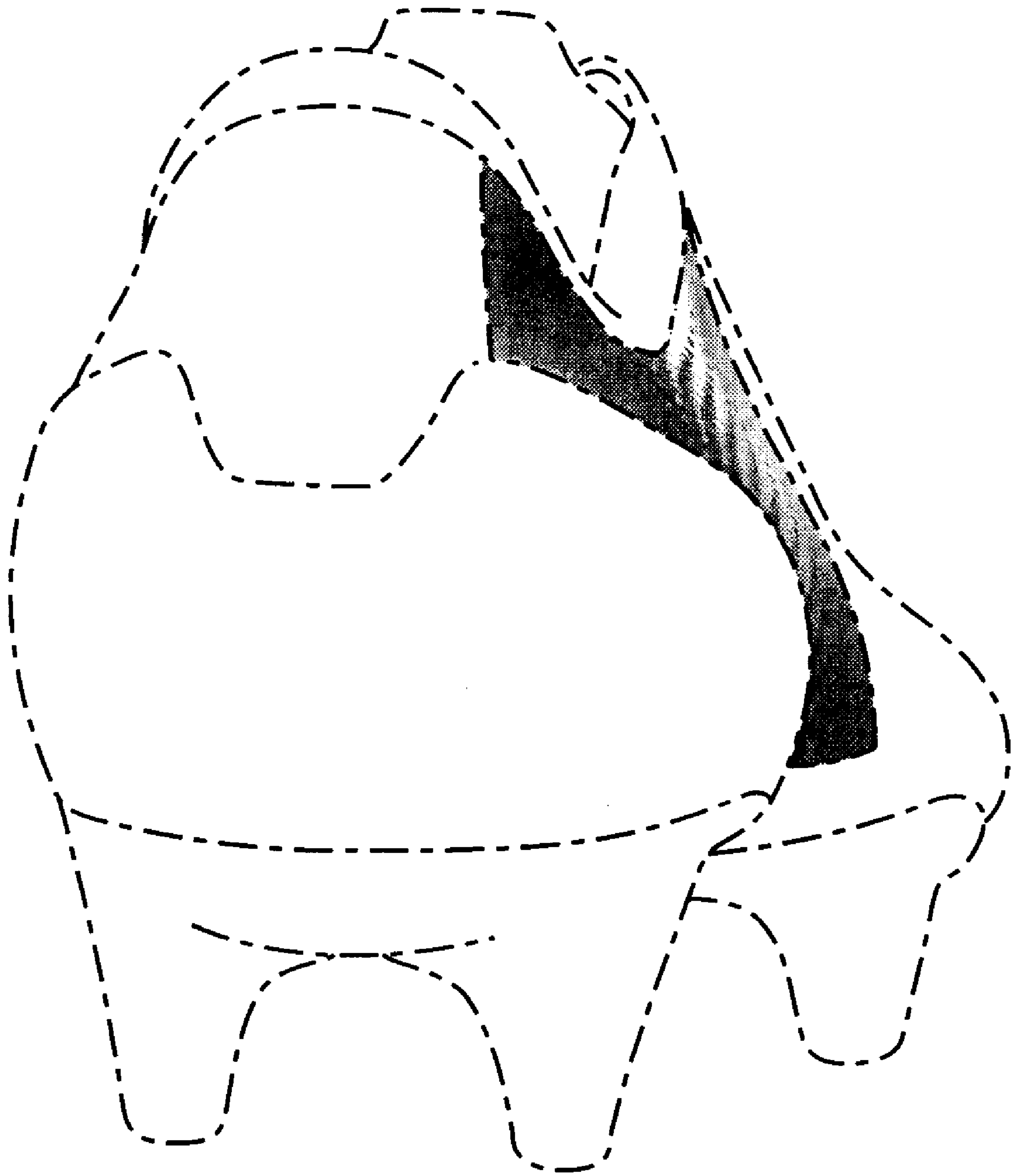
