(57) **CLAIM**

The ornamental design for a decorative rabbit paper roll holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of one embodiment of the invented design for a decorative rabbit paper roll holder.

FIG. 2 is a left side view of the embodiment shown in FIG. 1.

FIG. 3 is a front view of the embodiment shown in FIG. 1.

FIG. 4 is a right side view of the embodiment shown in FIG. 1.

FIG. 5 is a rear view of the embodiment shown in FIG. 1.

FIG. 6 is a top view of the embodiment shown in FIG. 1.

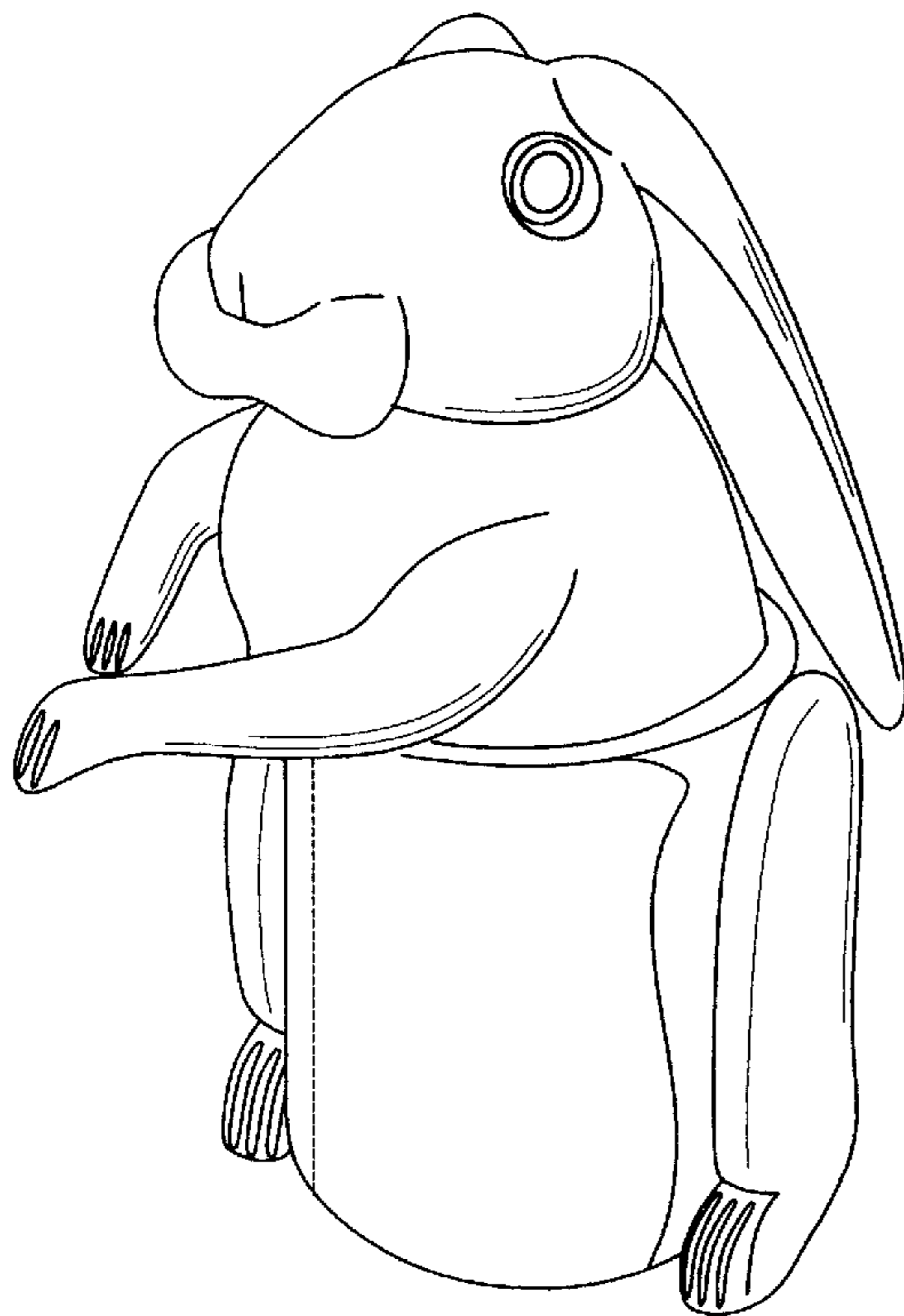
FIG. 7 is a bottom view of the embodiment shown in FIG. 1.

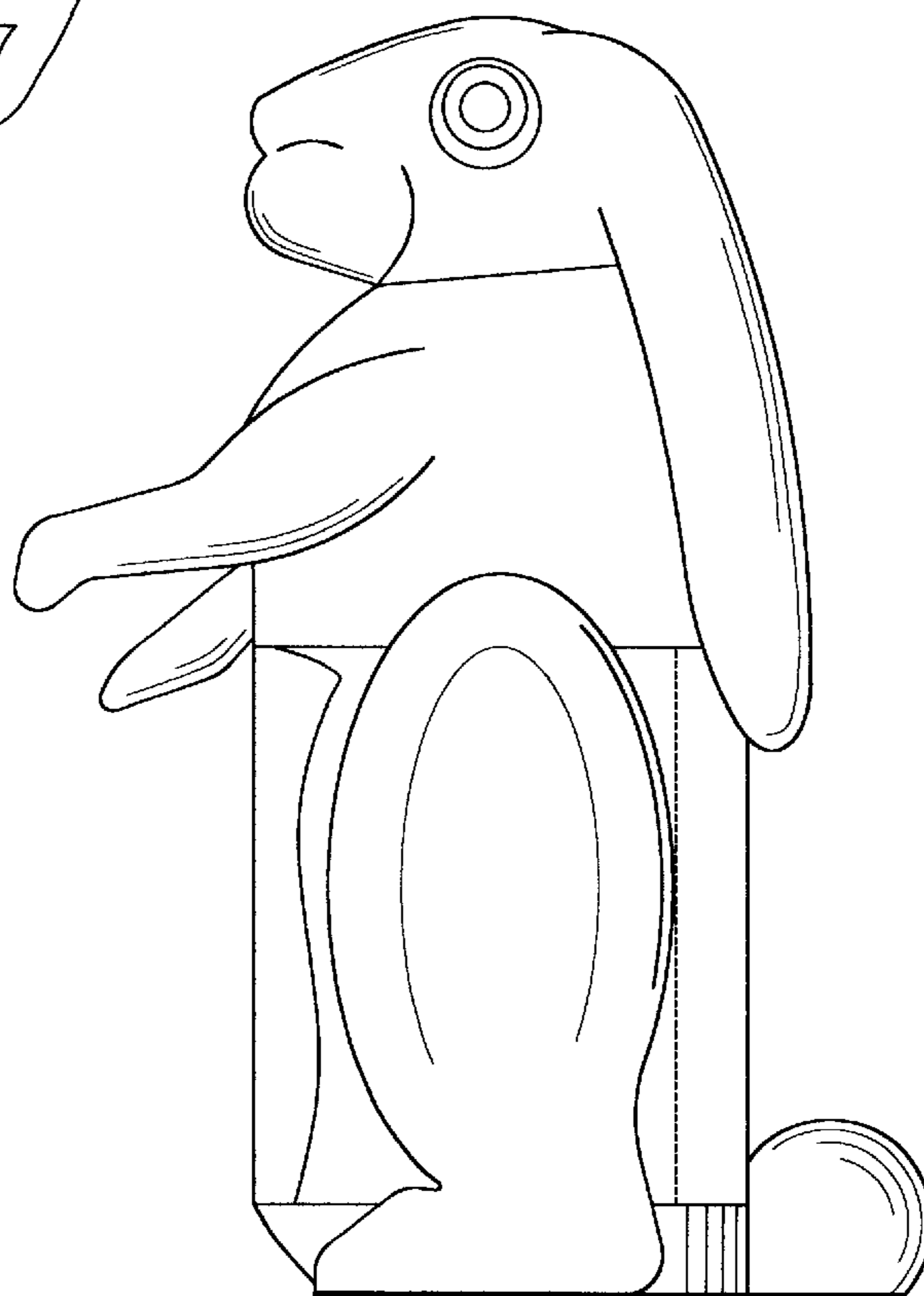

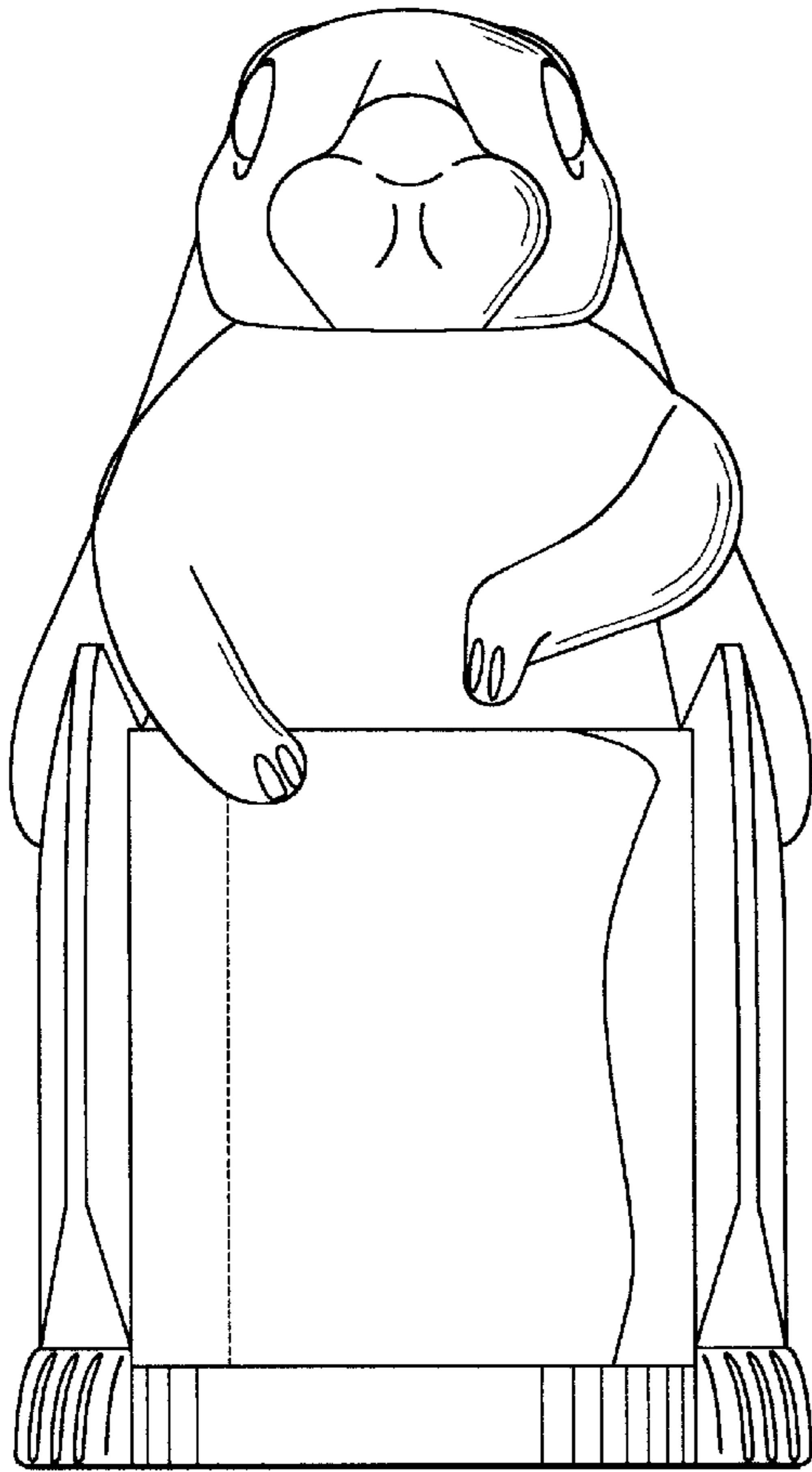




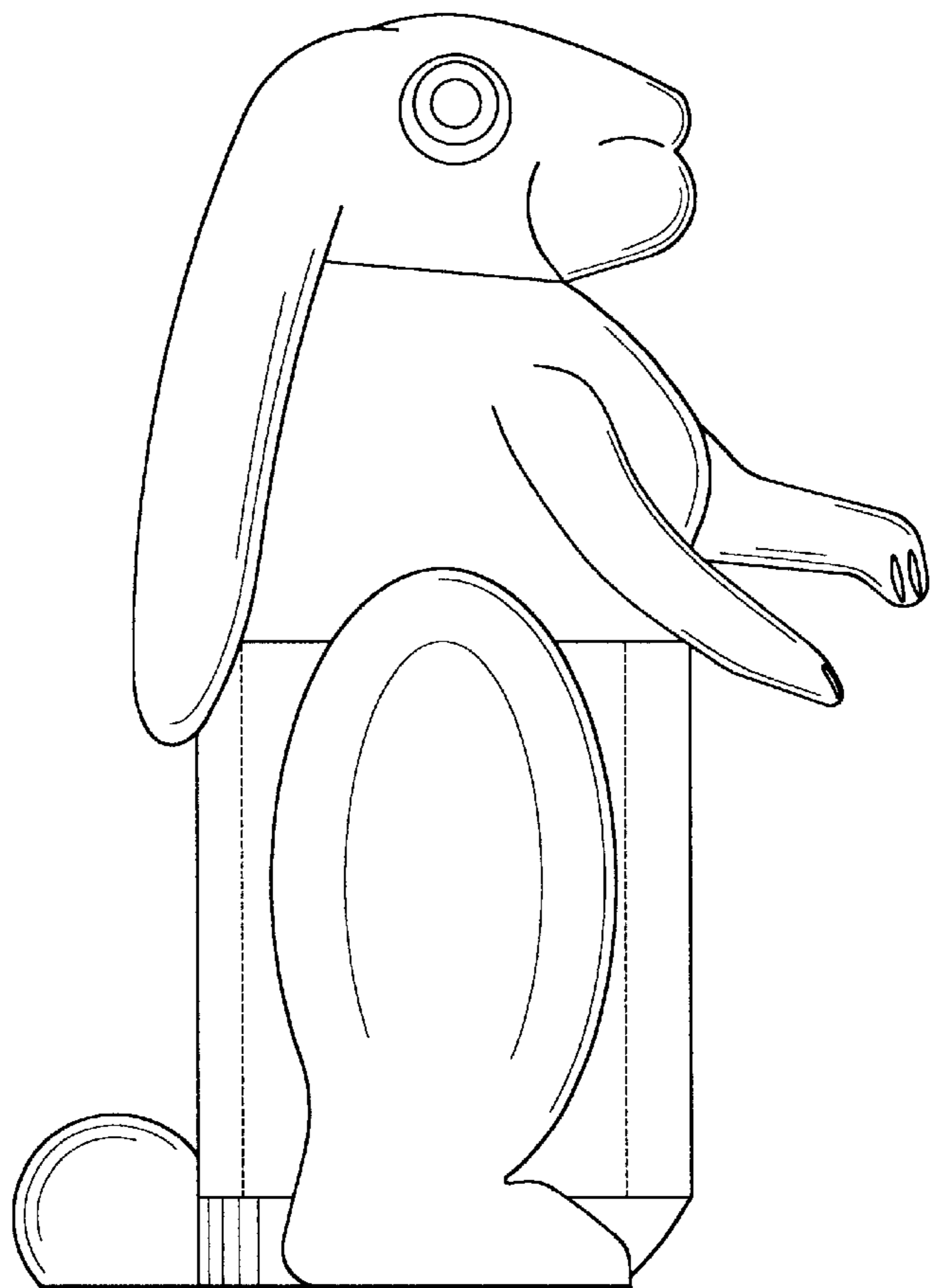

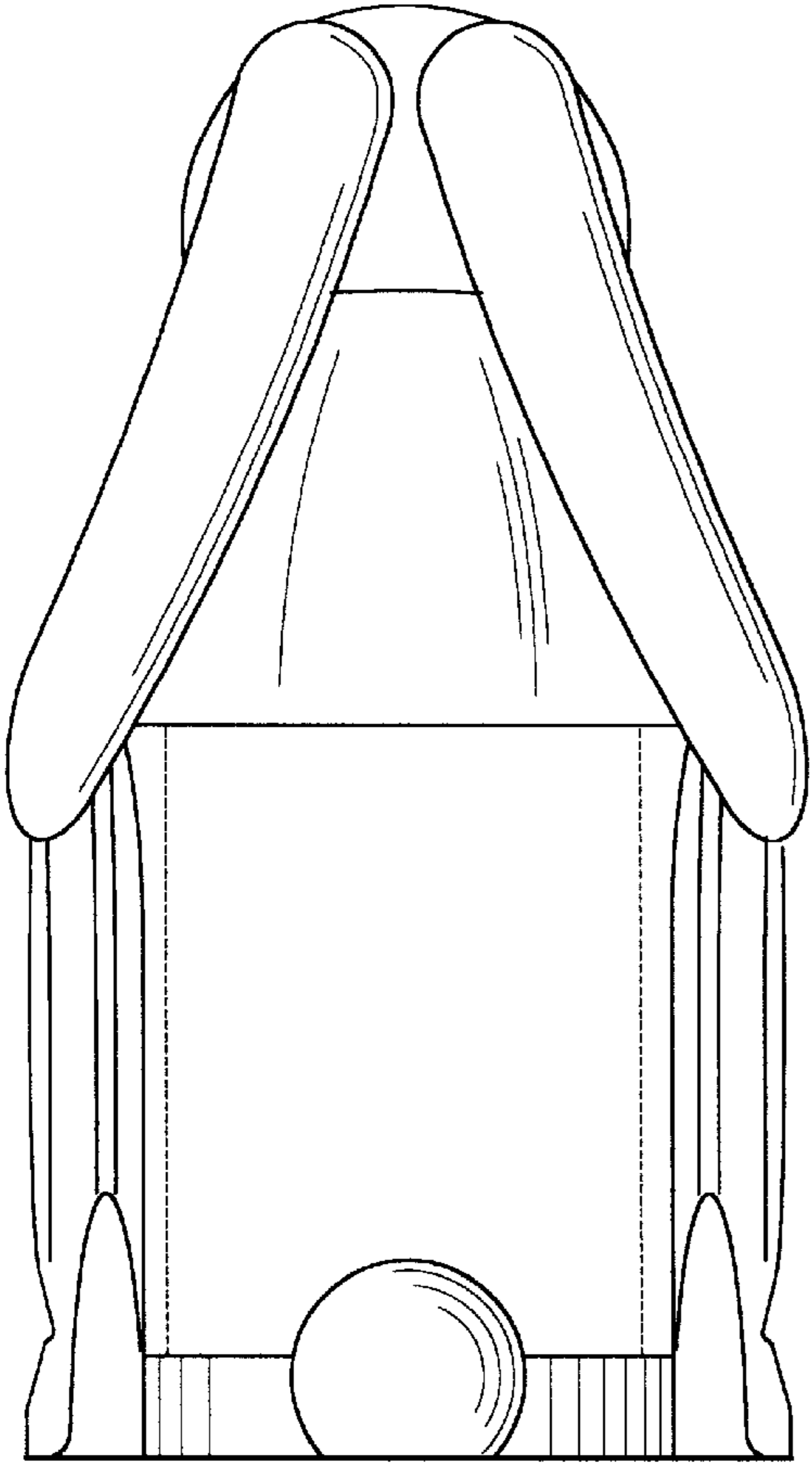

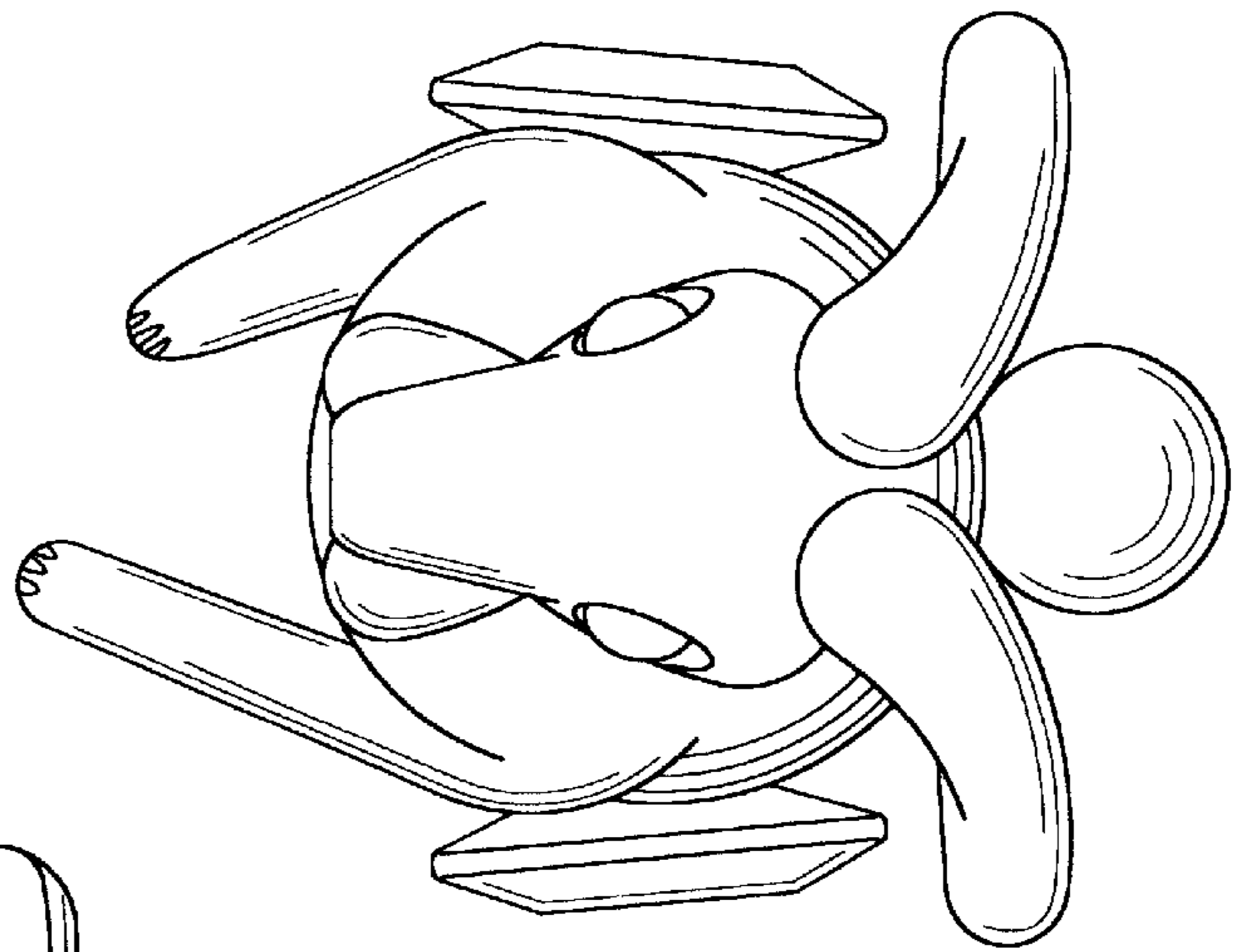

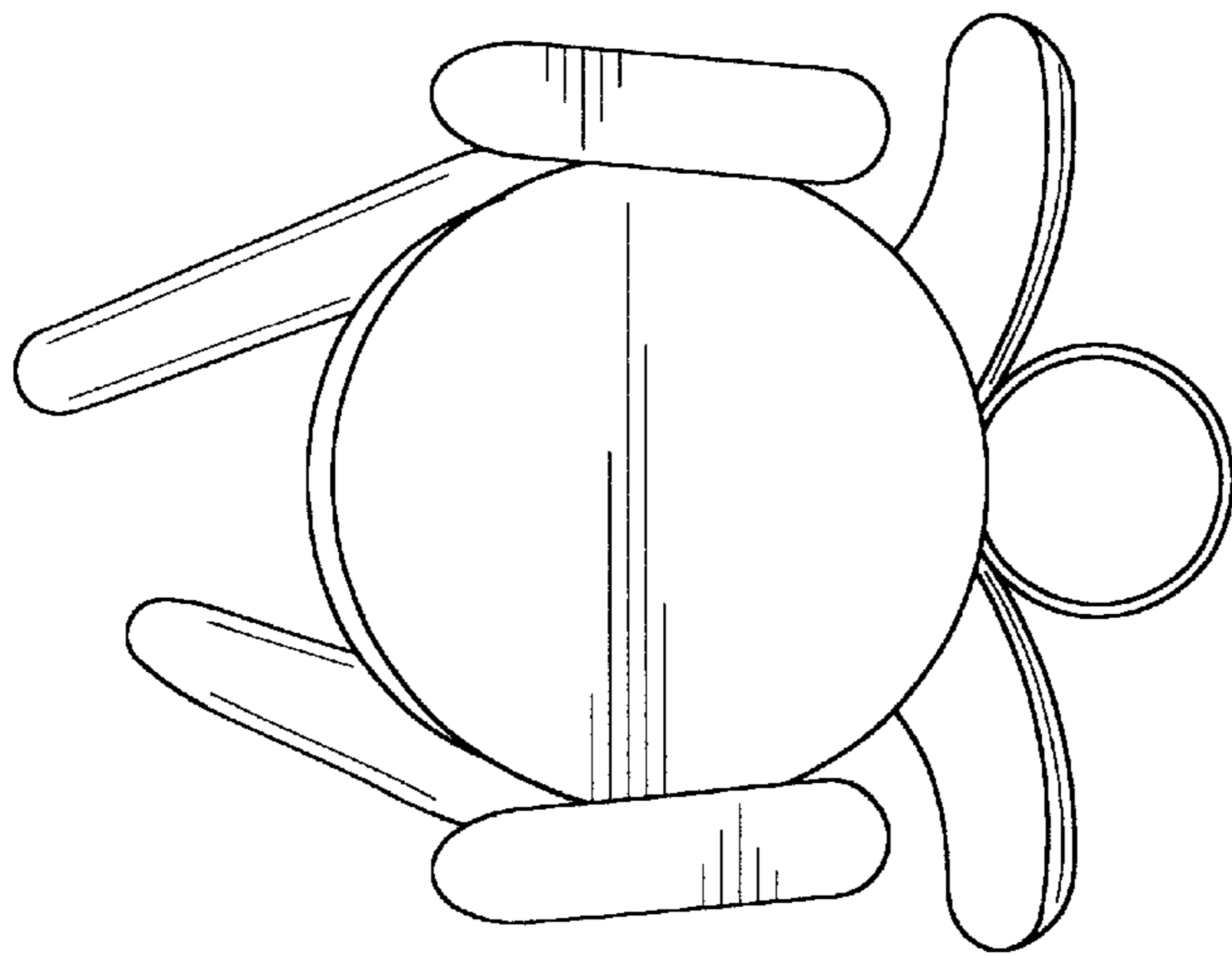

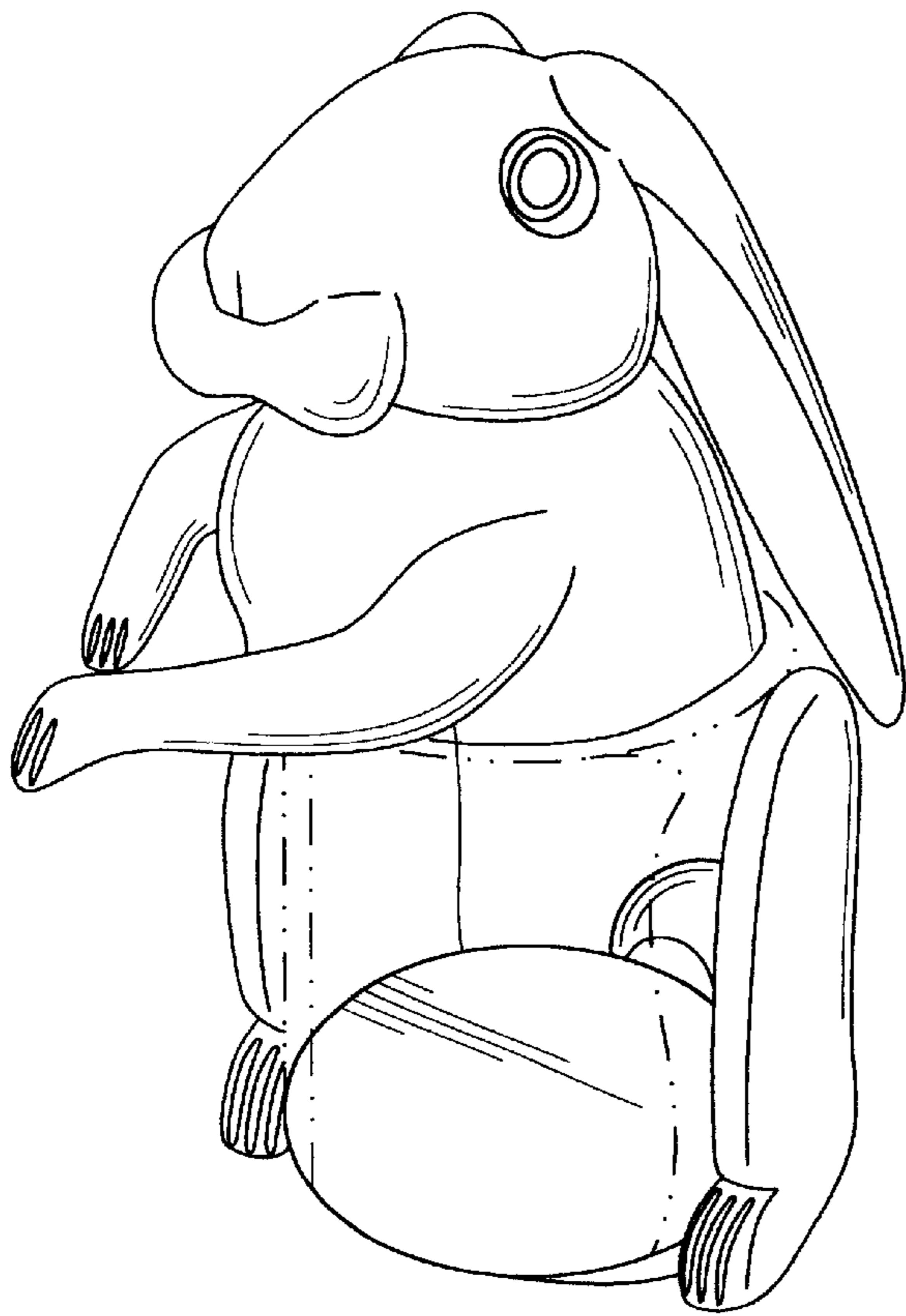

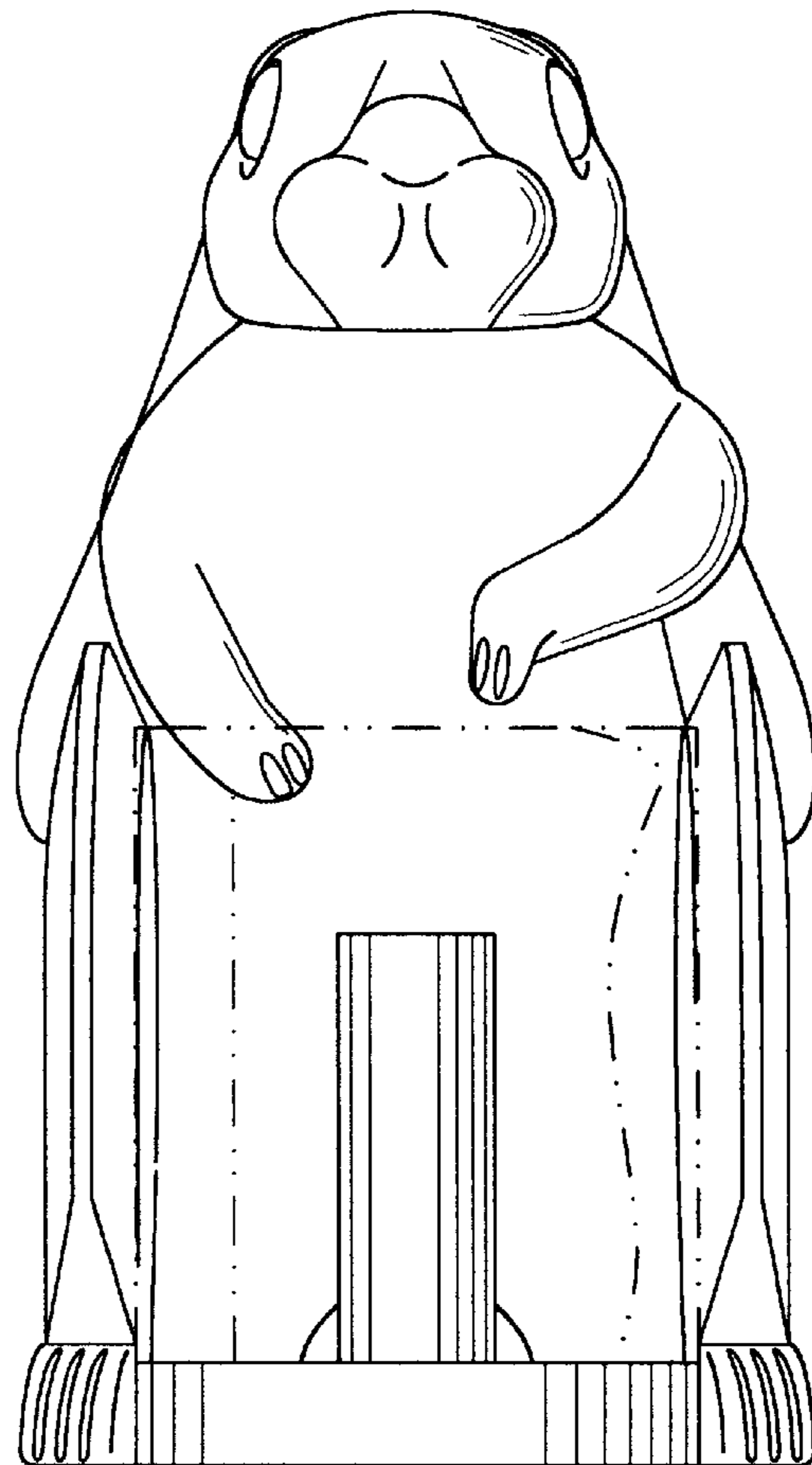
