FIG. 4 is a right side view of the container fitment from FIG. 1, the left side view being the same;

FIG. 5 is a cross-section of a sidewall of the dispensing aperture from FIG. 2 taken along line 5—5;

FIG. 6 is a bottom view of the container fitment from FIG. 1; and,

FIG. 7 is a perspective view of the container fitment from FIG. 1 mounted on a container.

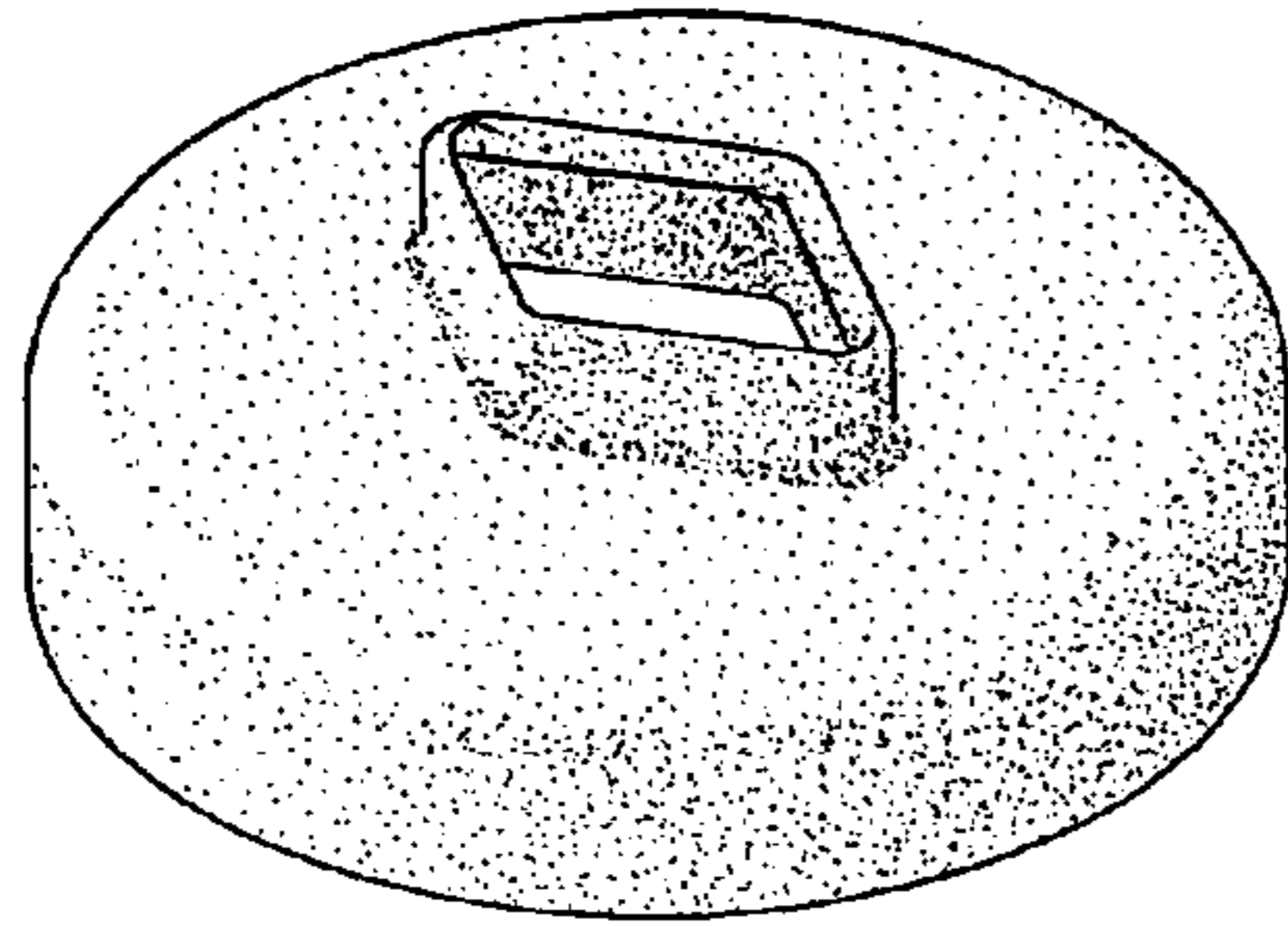

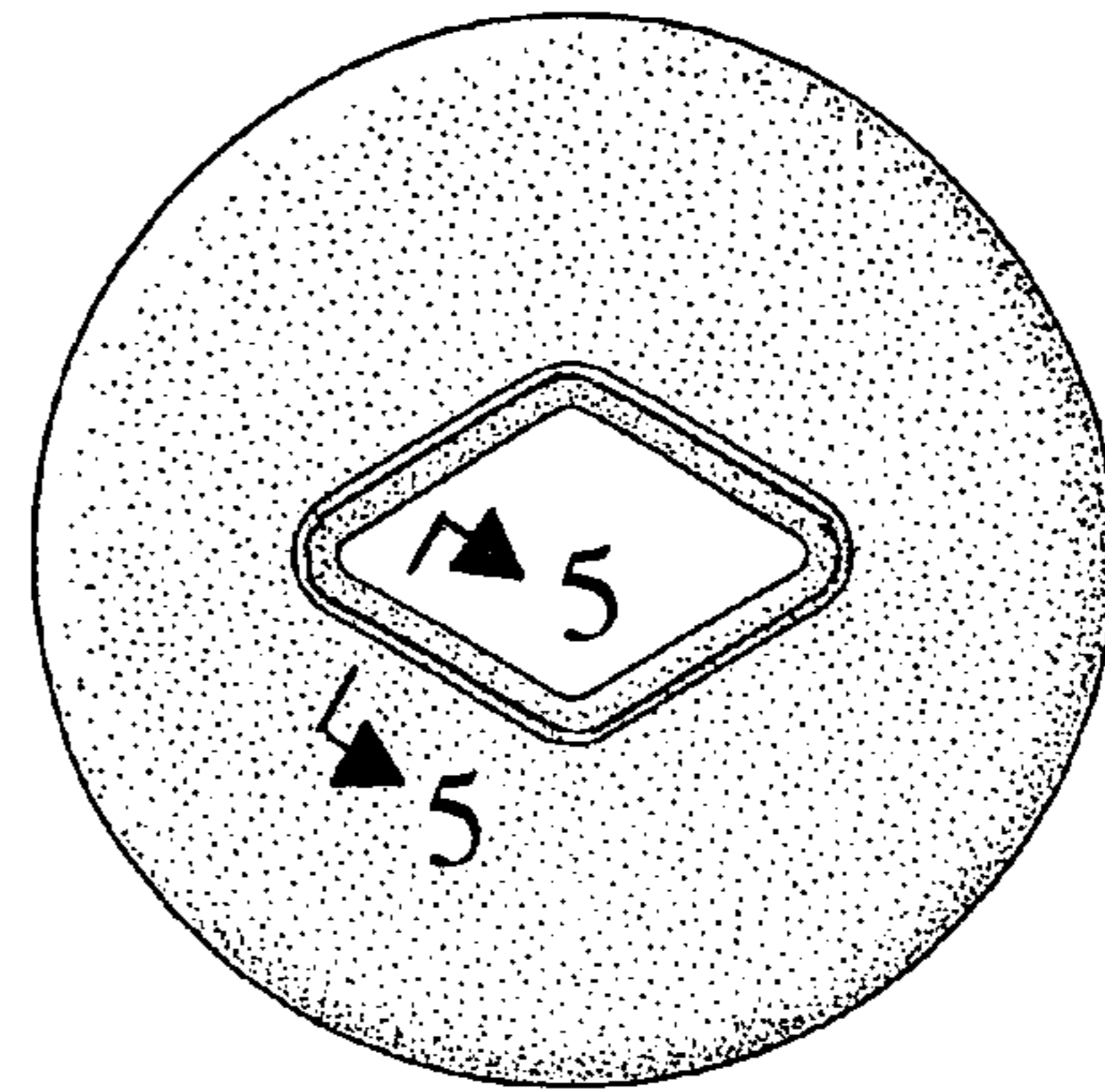

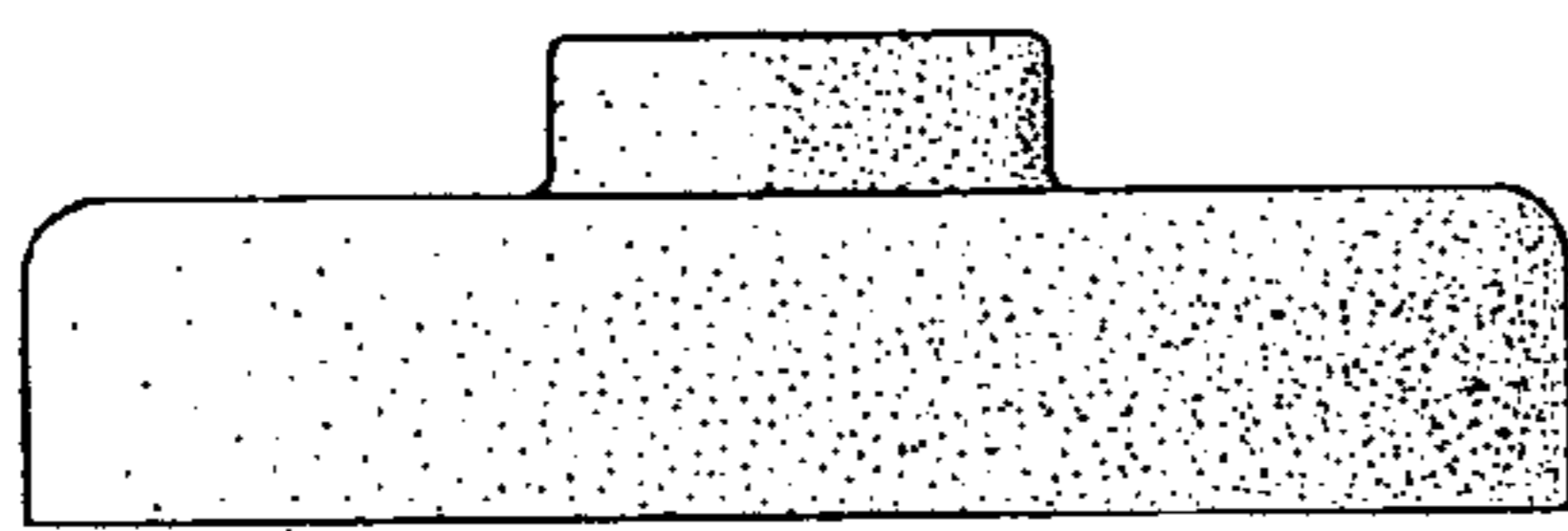

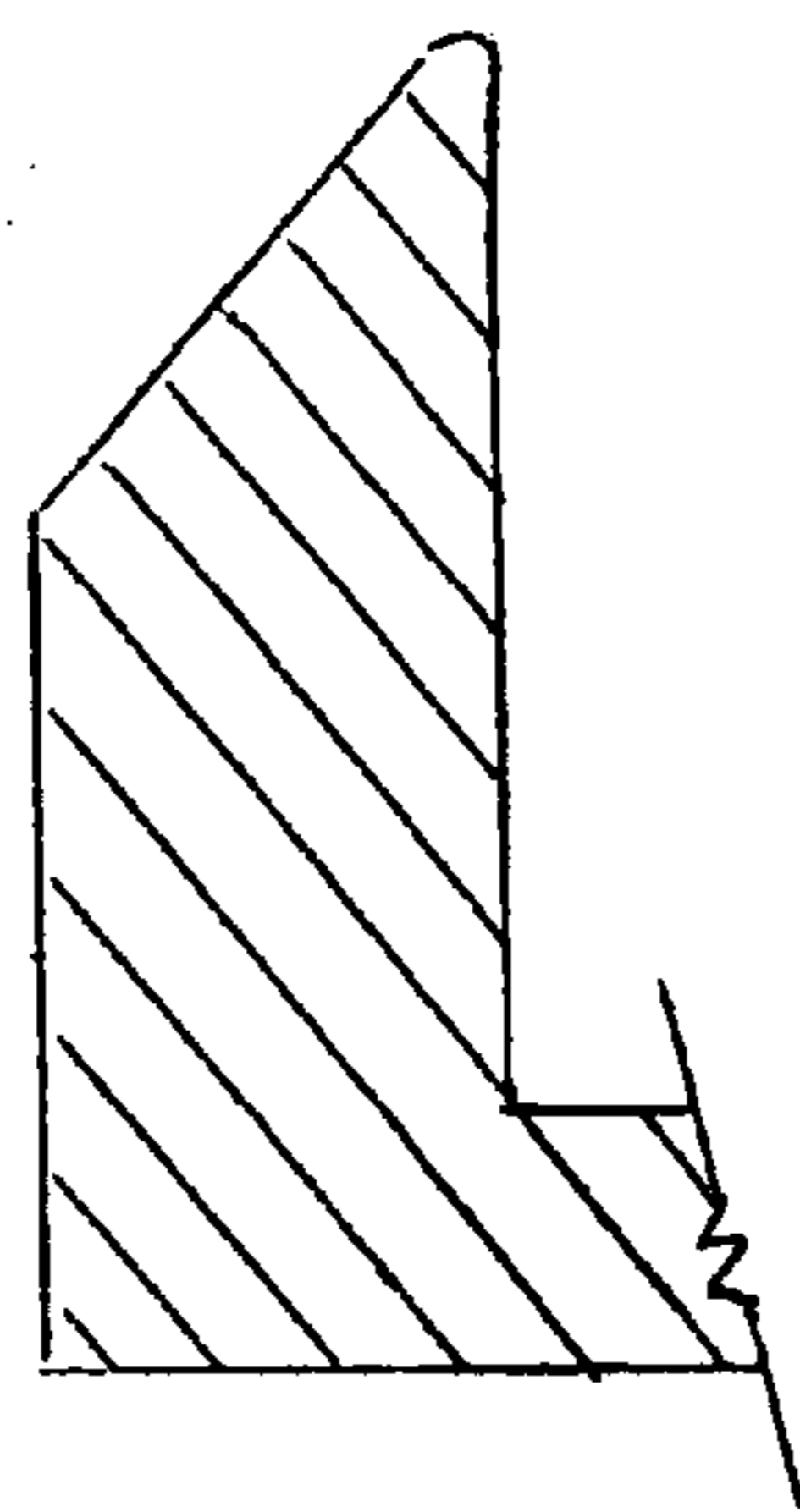

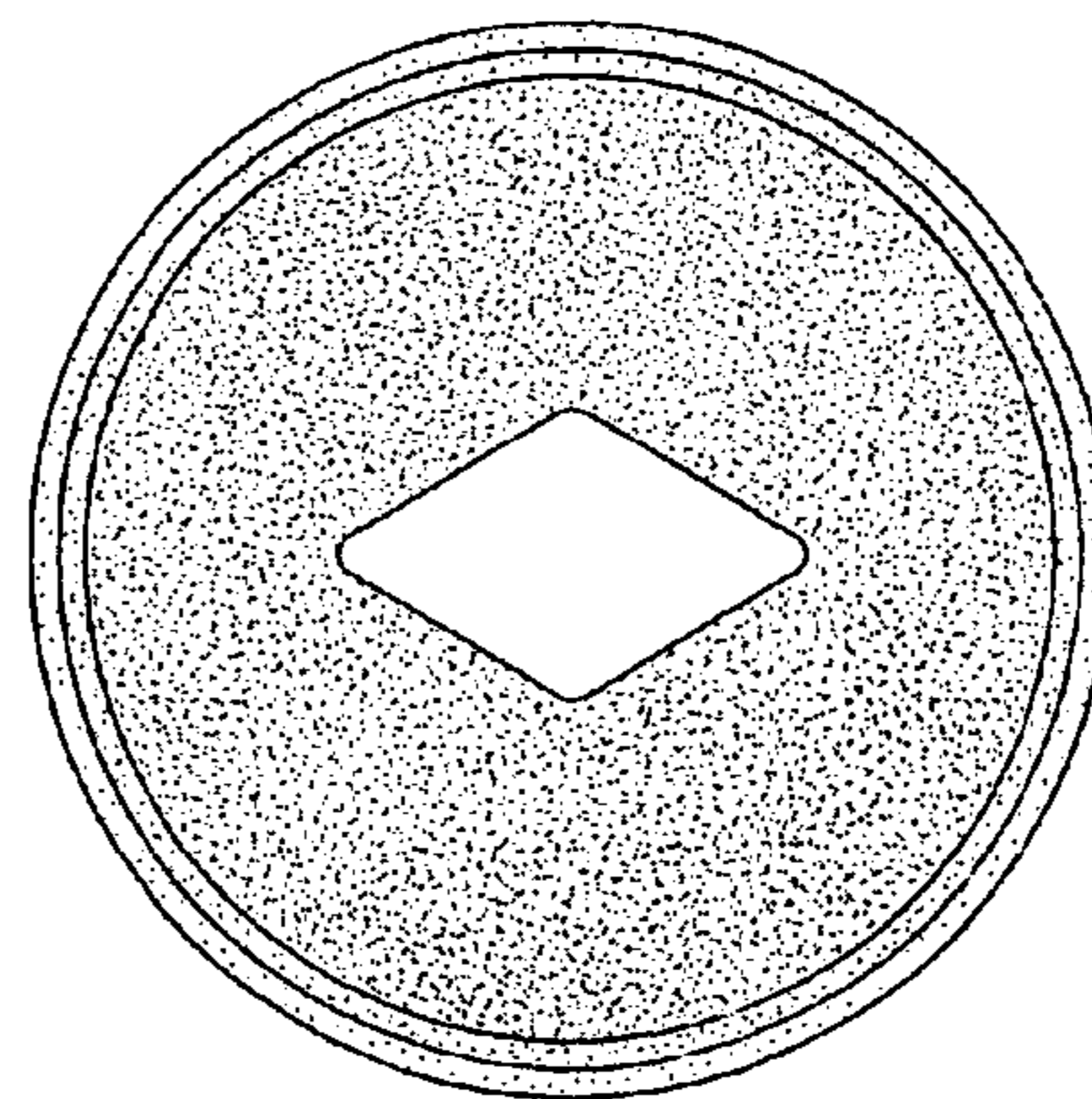

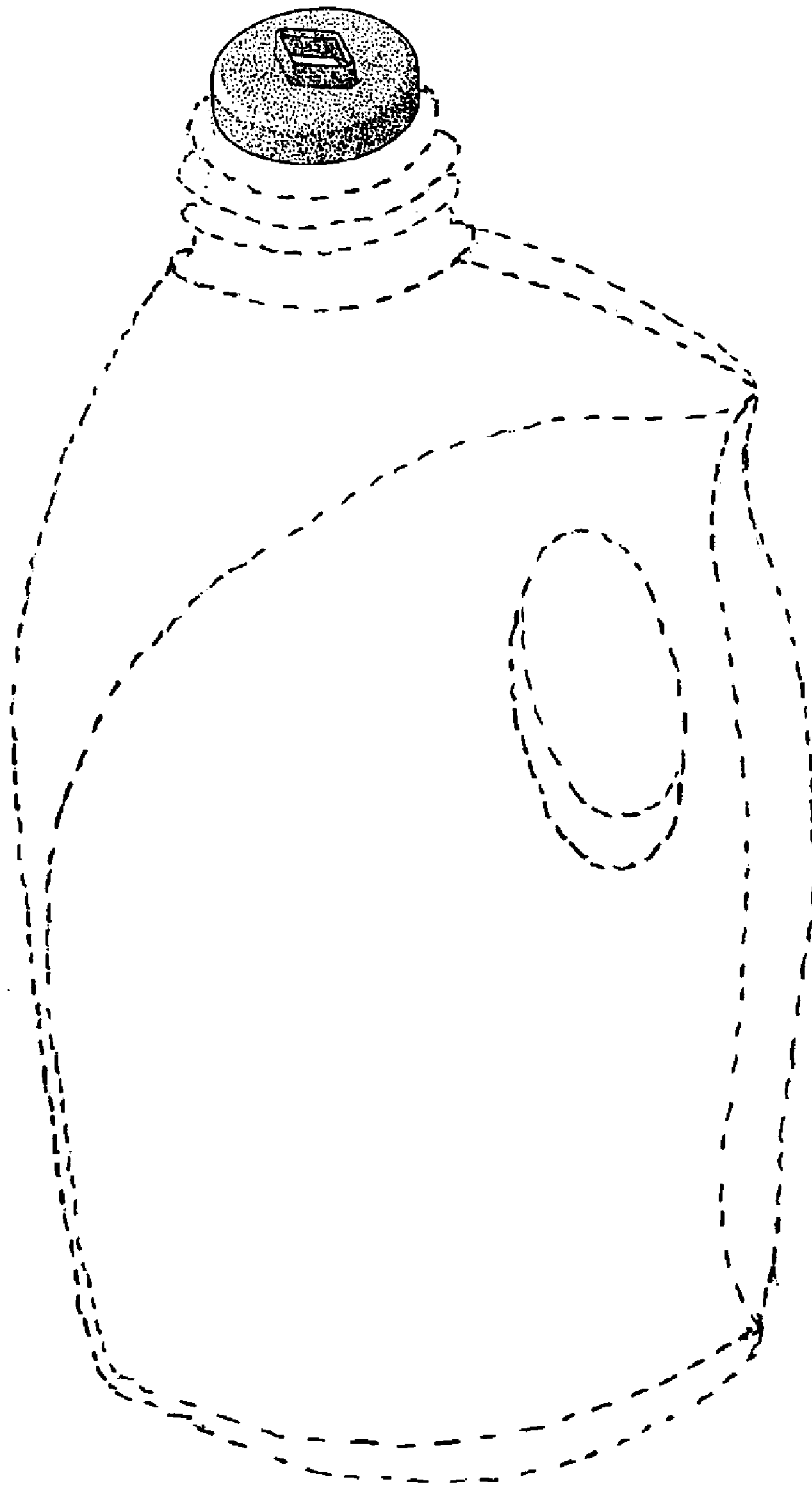
