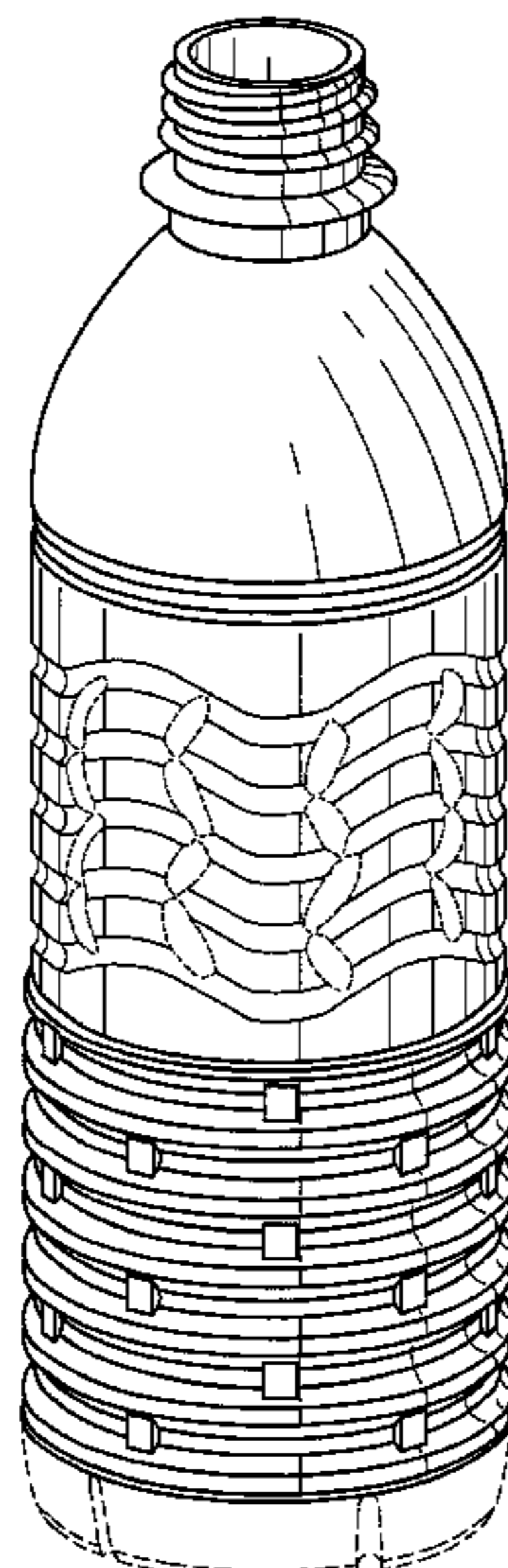
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of a bottle, showing the present invention.  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a top plan view thereof; and,  
FIG. 4 is a top, side perspective view thereof, taken from the opposite side of FIG. 1 and shown at an enlarged scale.  
The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

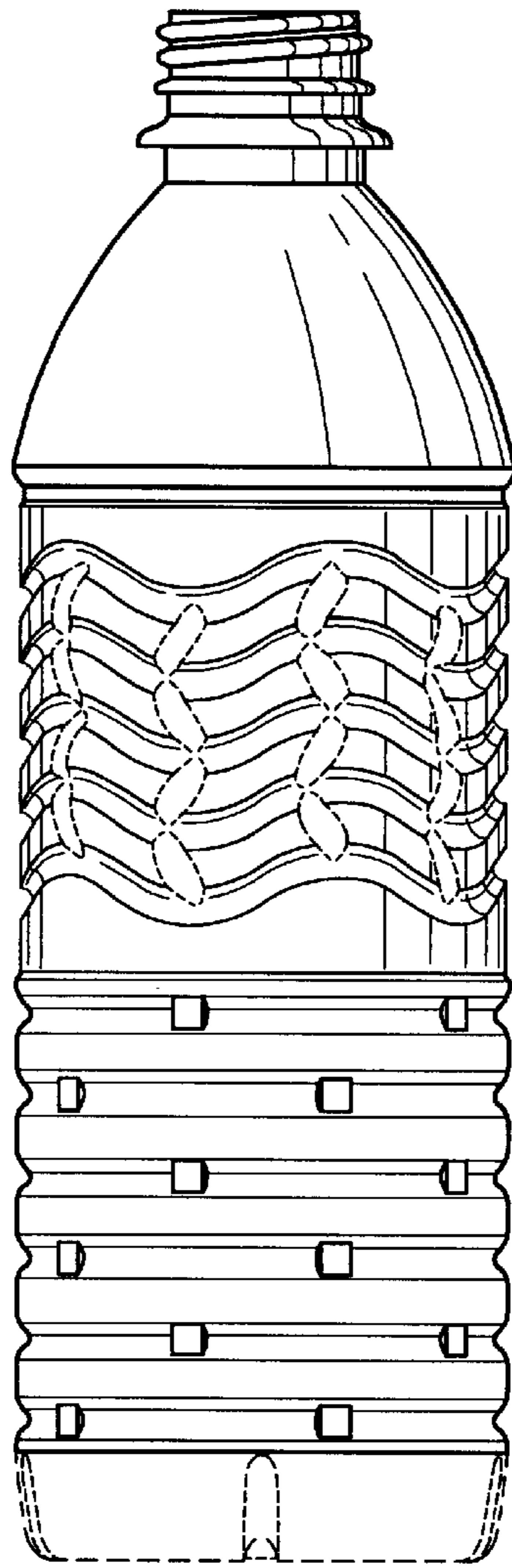

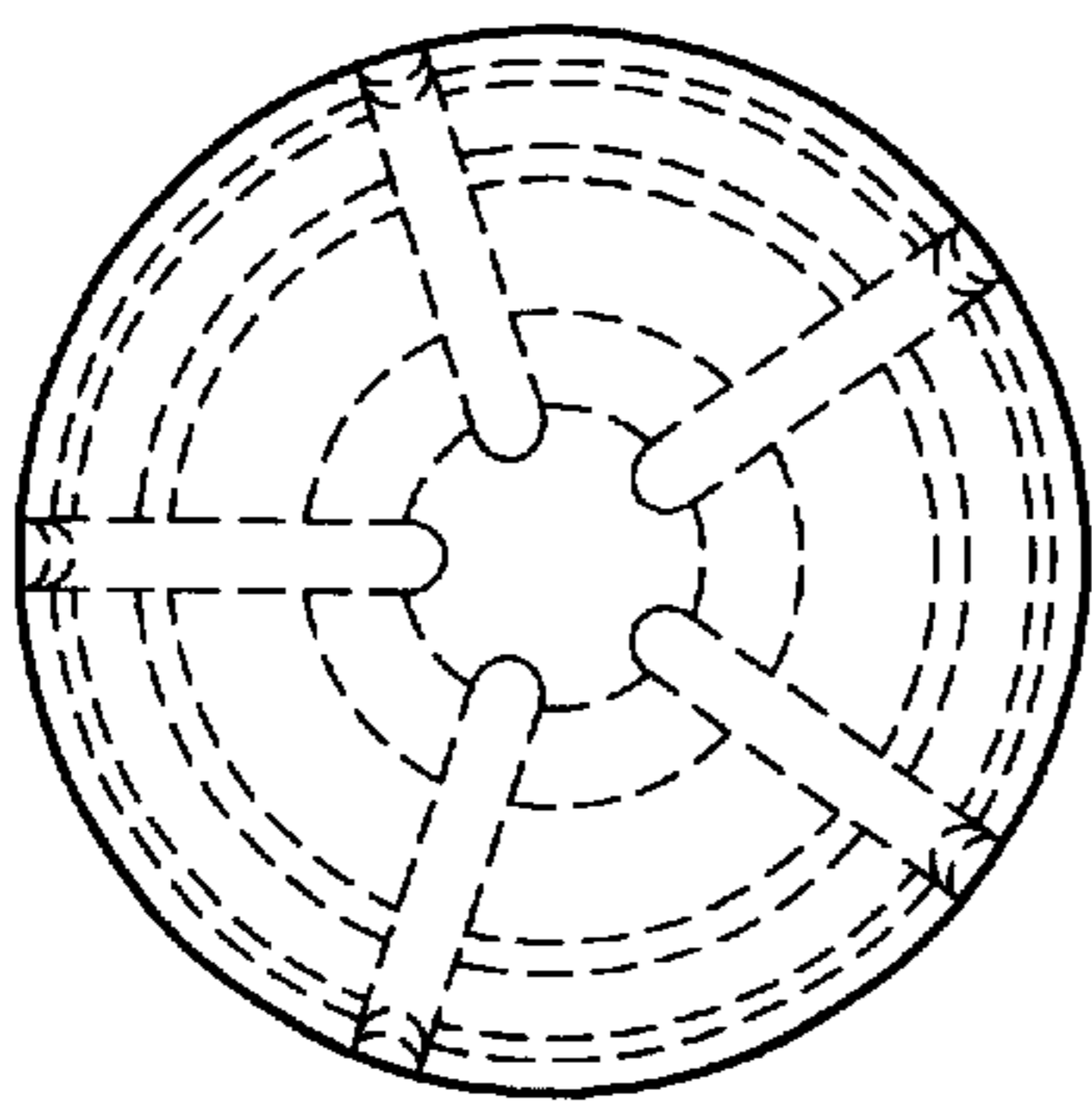

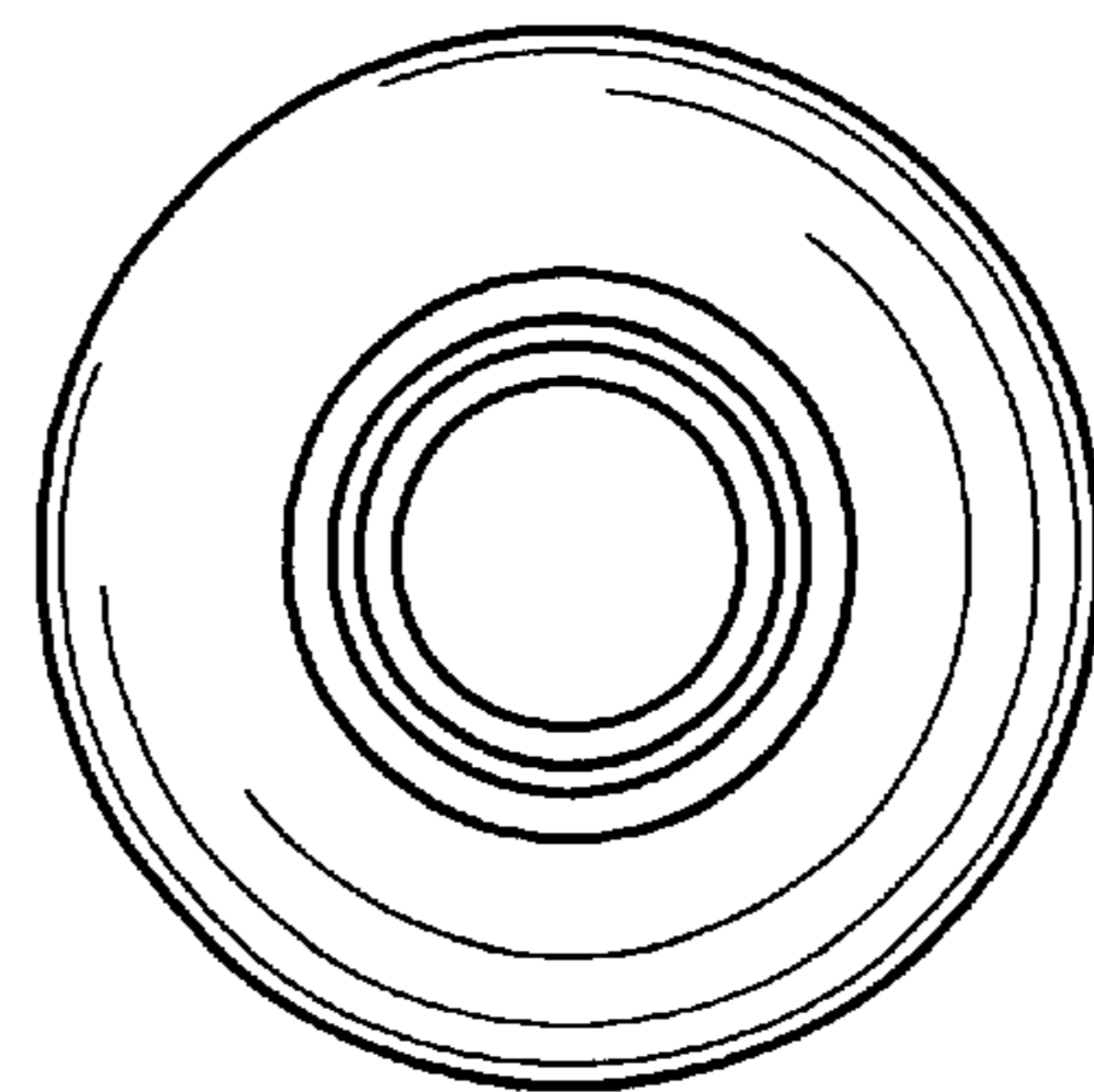

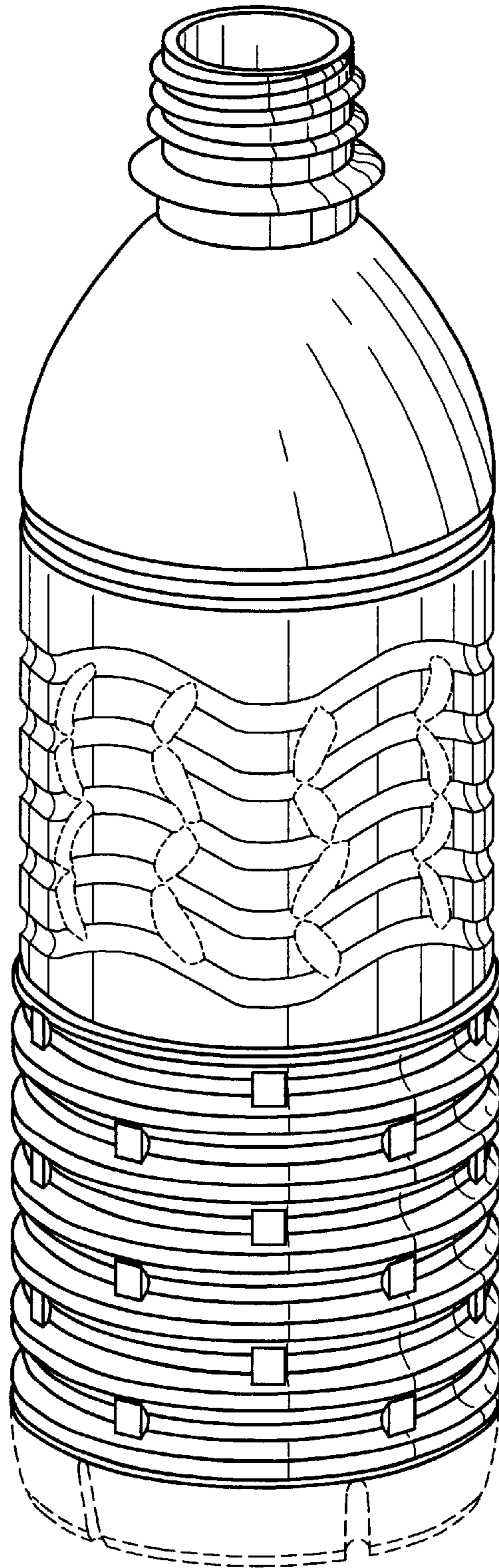
