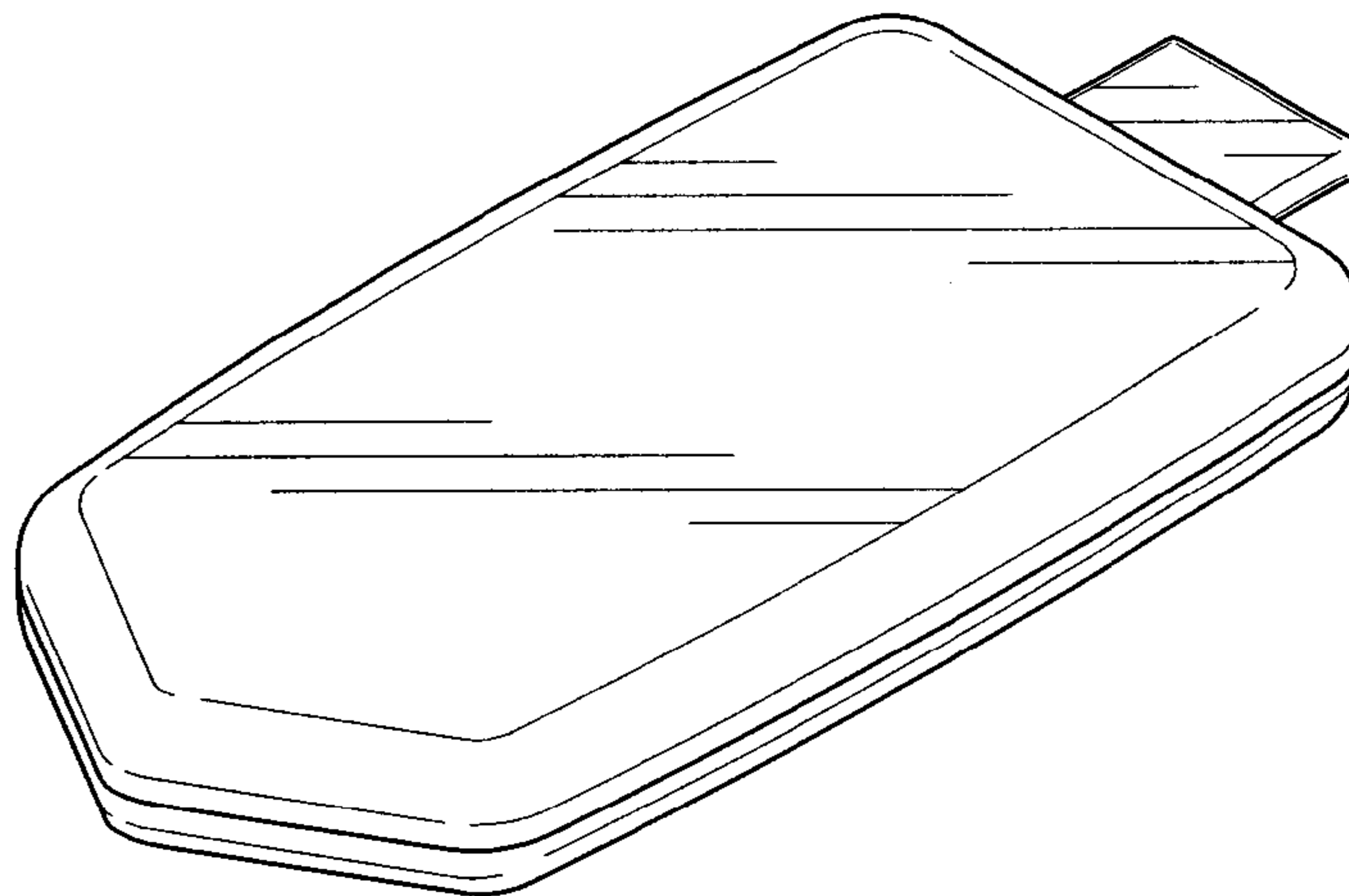
(57) **CLAIM**

The ornamental design for a breath mint dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, side perspective view of a breath mint dispenser showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereto;
 FIG. 5 is a front elevational view thereof; and,
 FIG. 6 is a rear elevational view thereof.

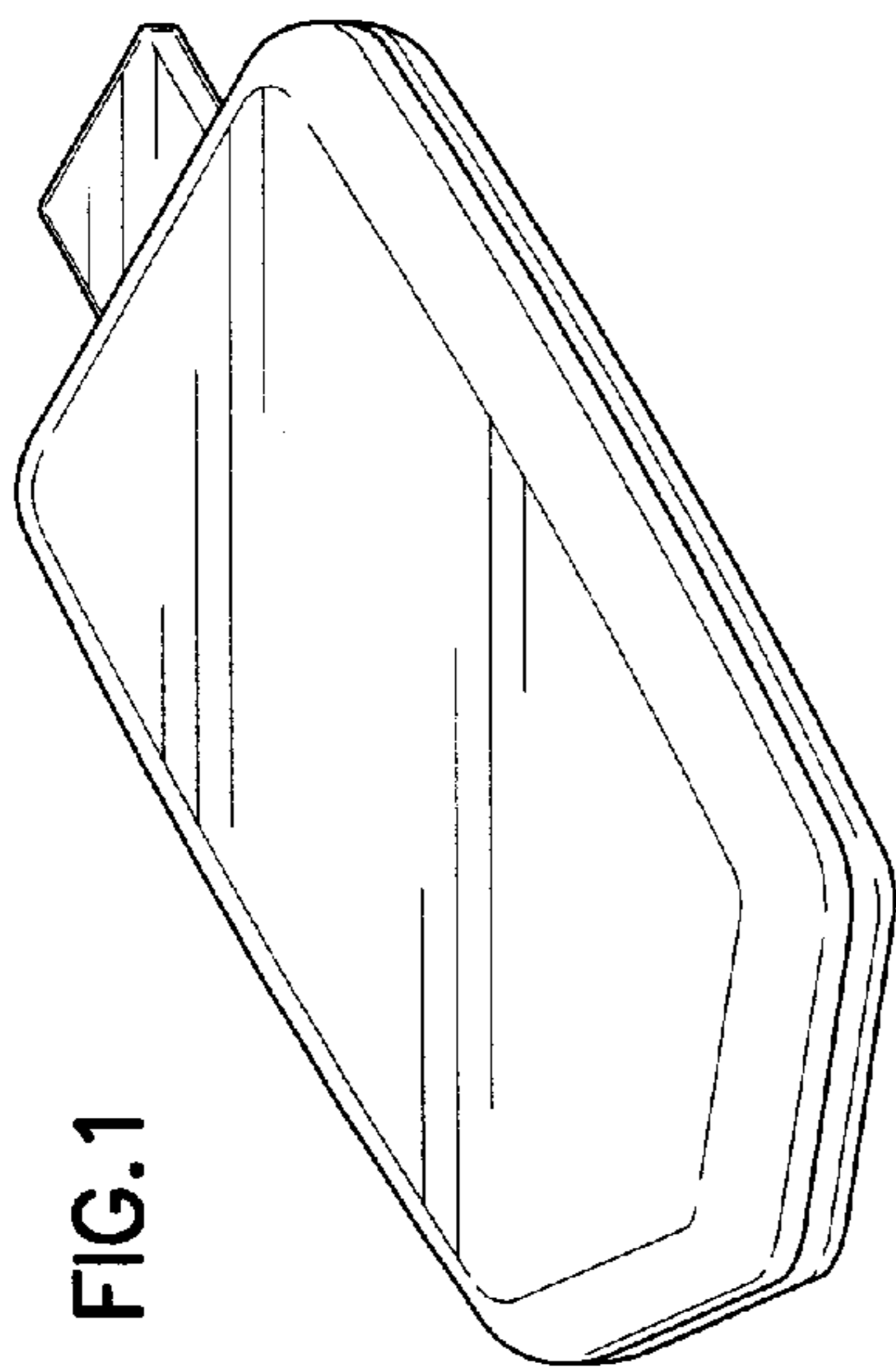

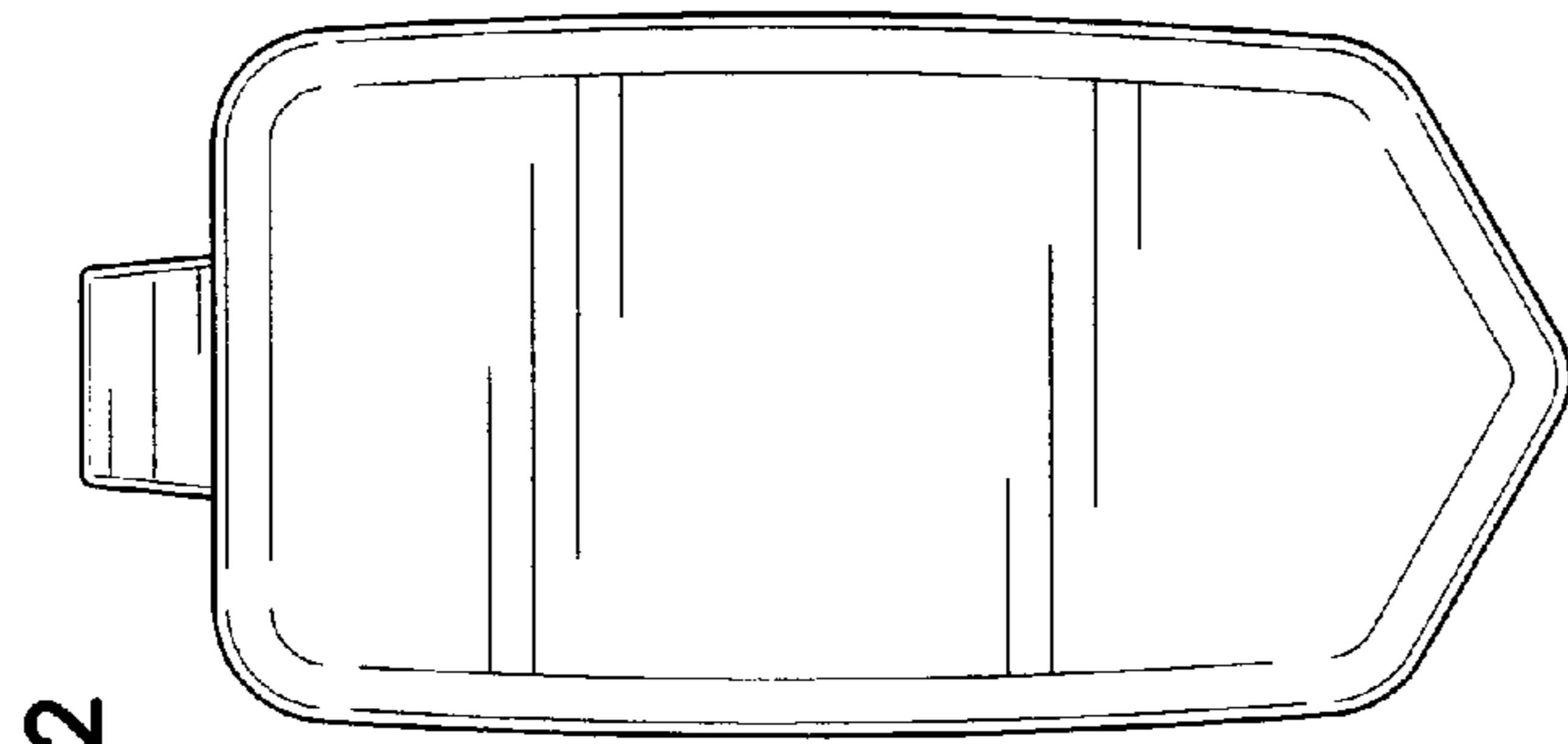

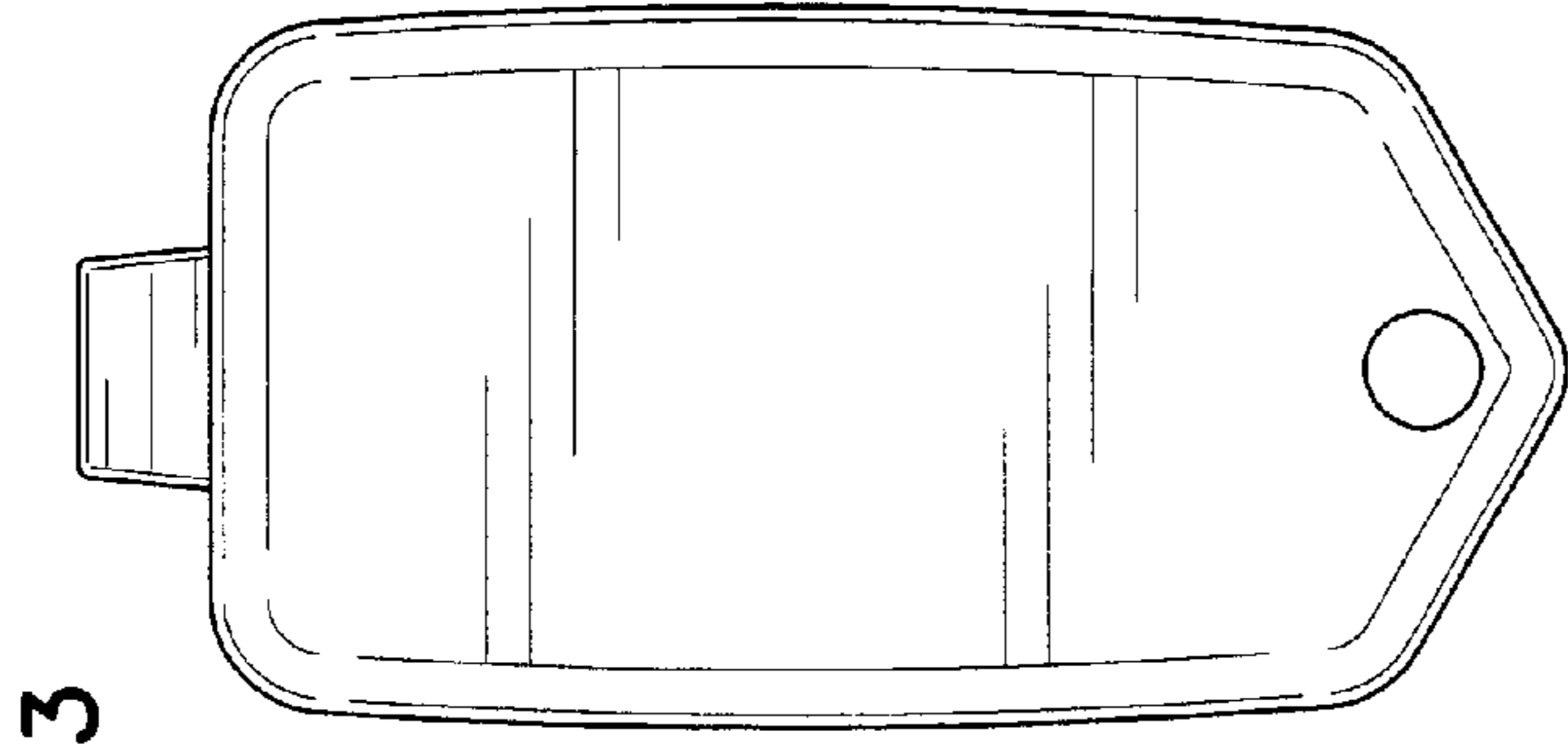

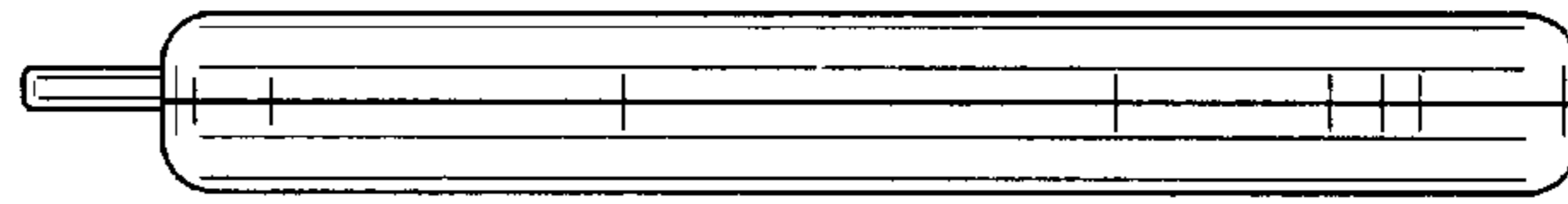

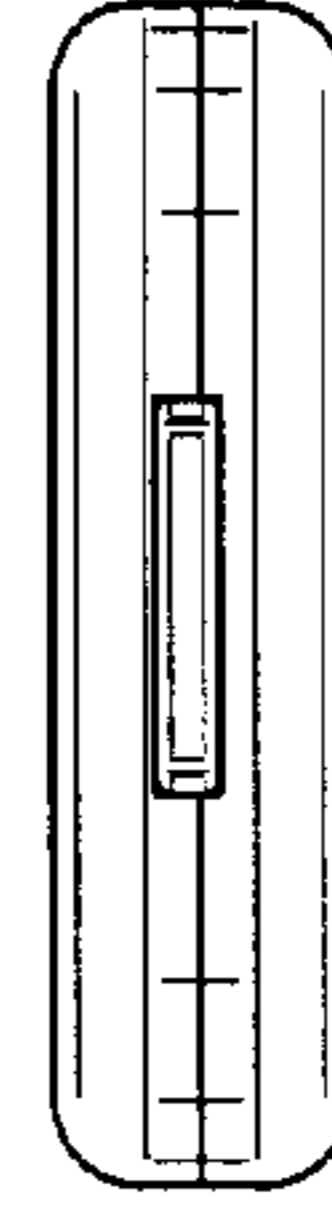

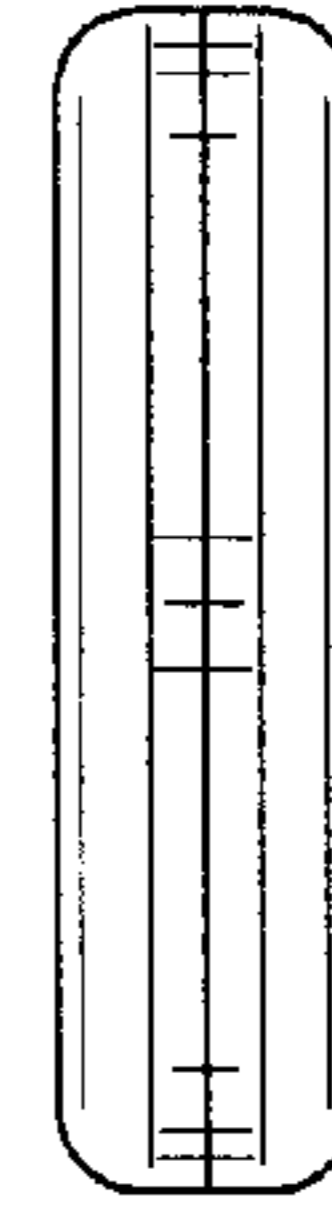
