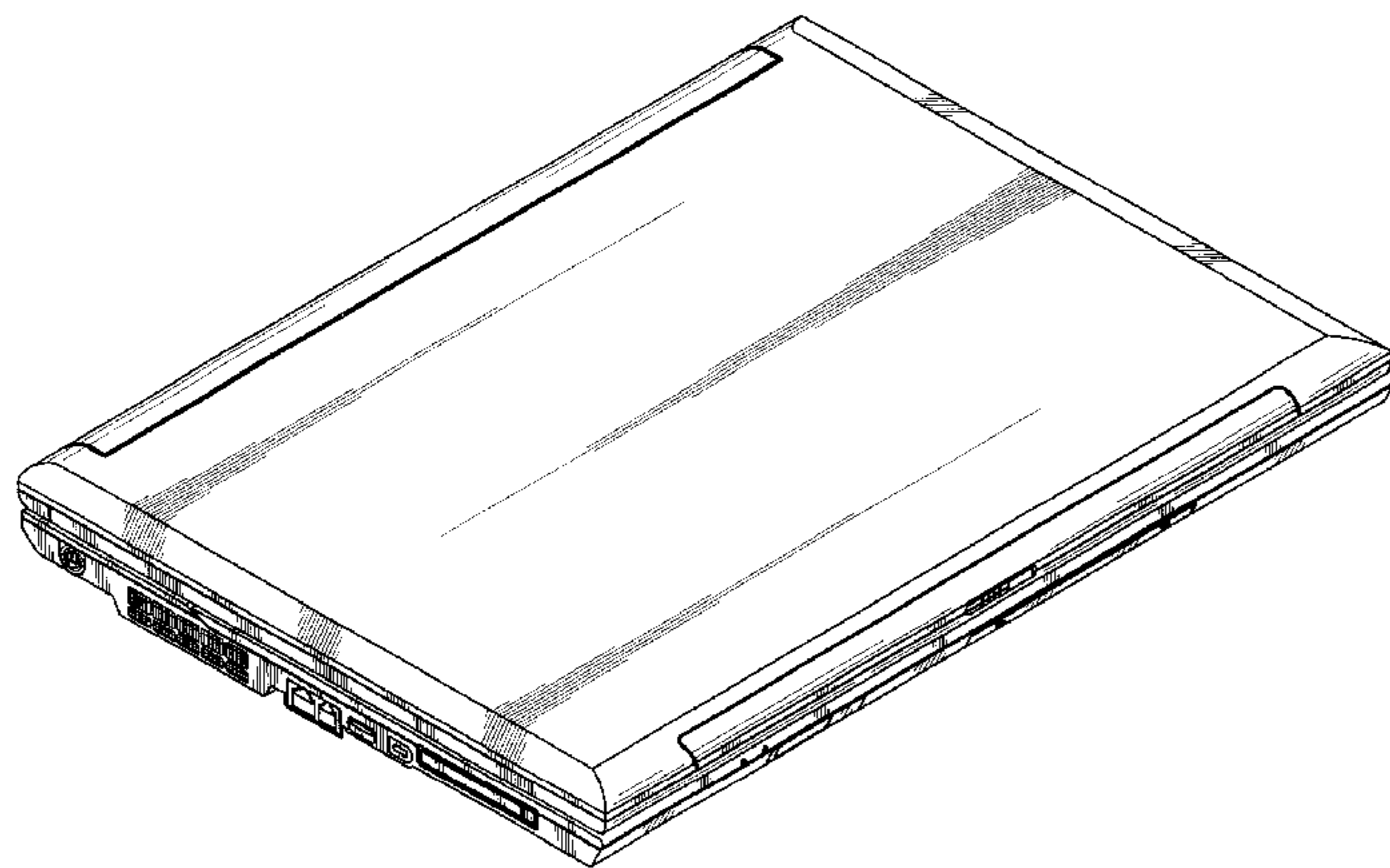
(57) **CLAIM**

**DESCRIPTION**

- FIG. 1. is a top front perspective view of a notebook computer showing our new design.
- FIG. 2. is a front elevational view thereof.
- FIG. 3. is a rear elevational view thereof.
- FIG. 4. is a left side elevational view thereof.
- FIG. 5. is a right side elevational view thereof.

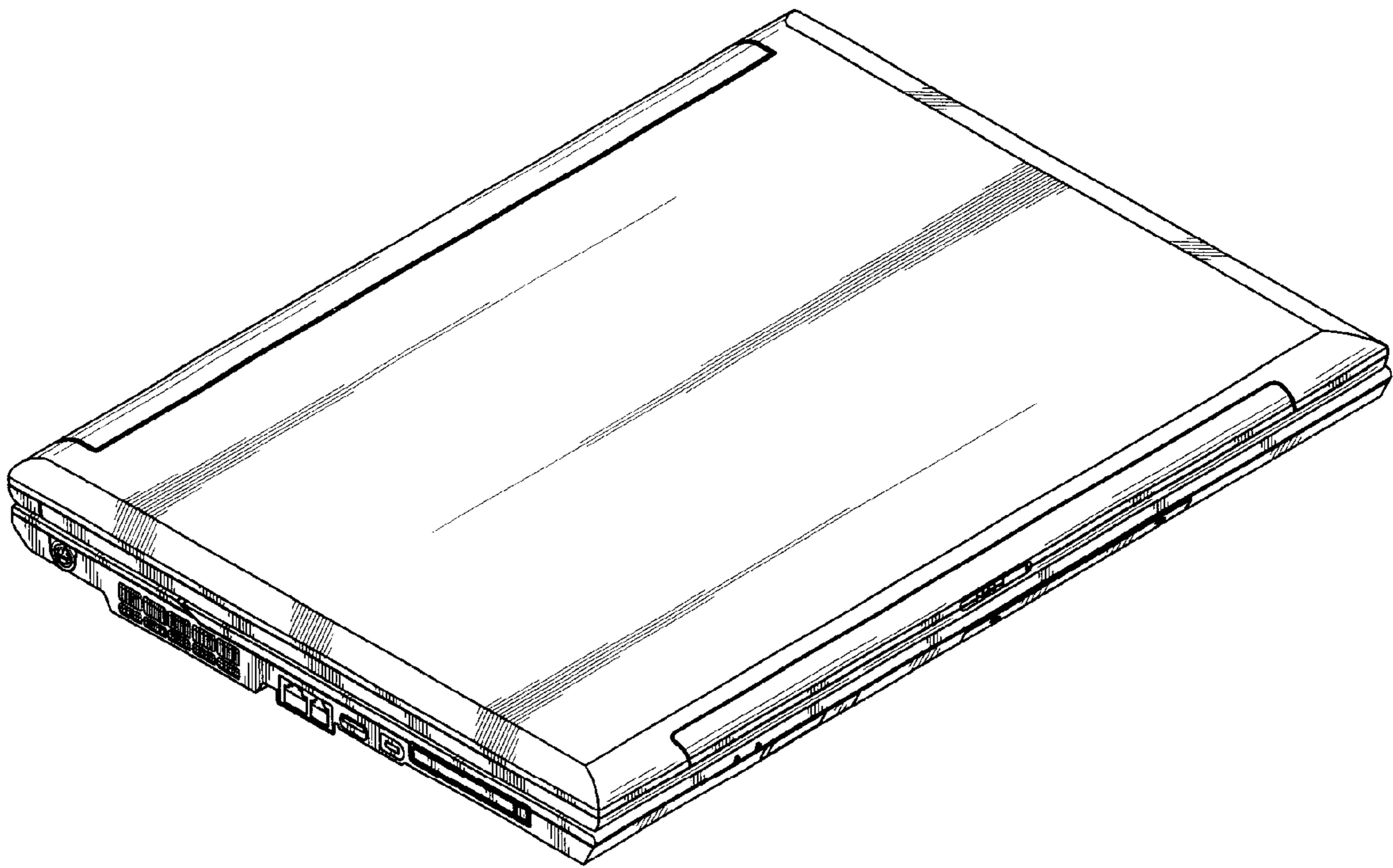

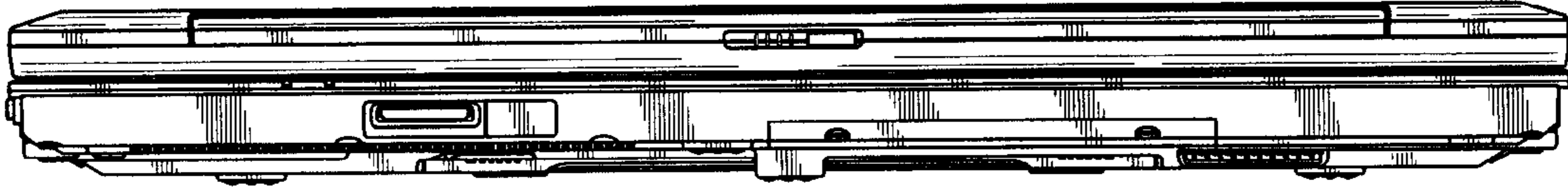

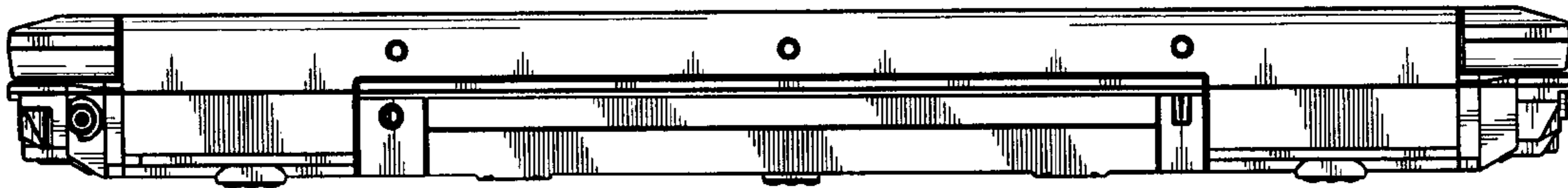

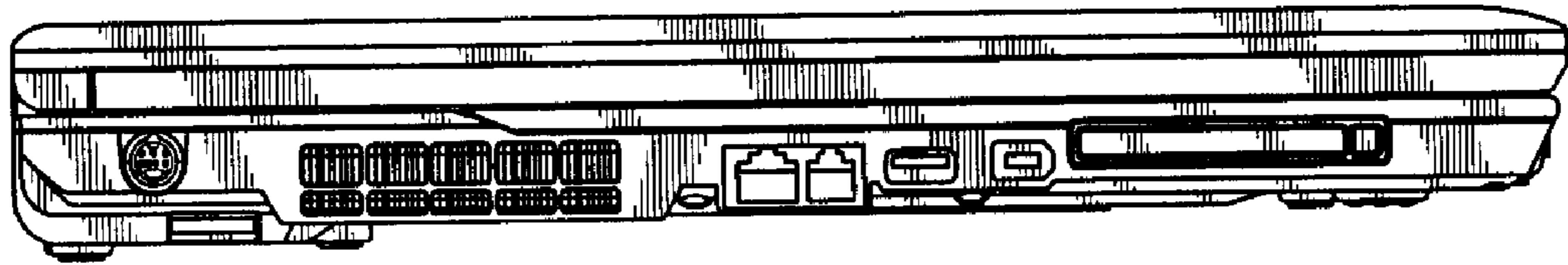

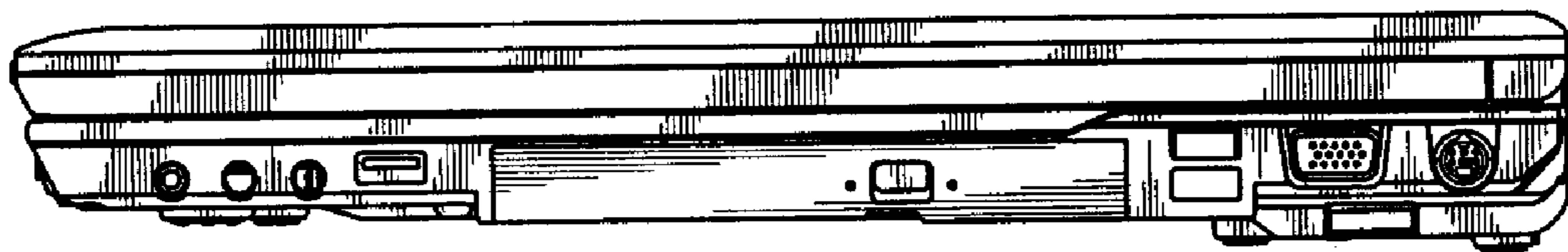

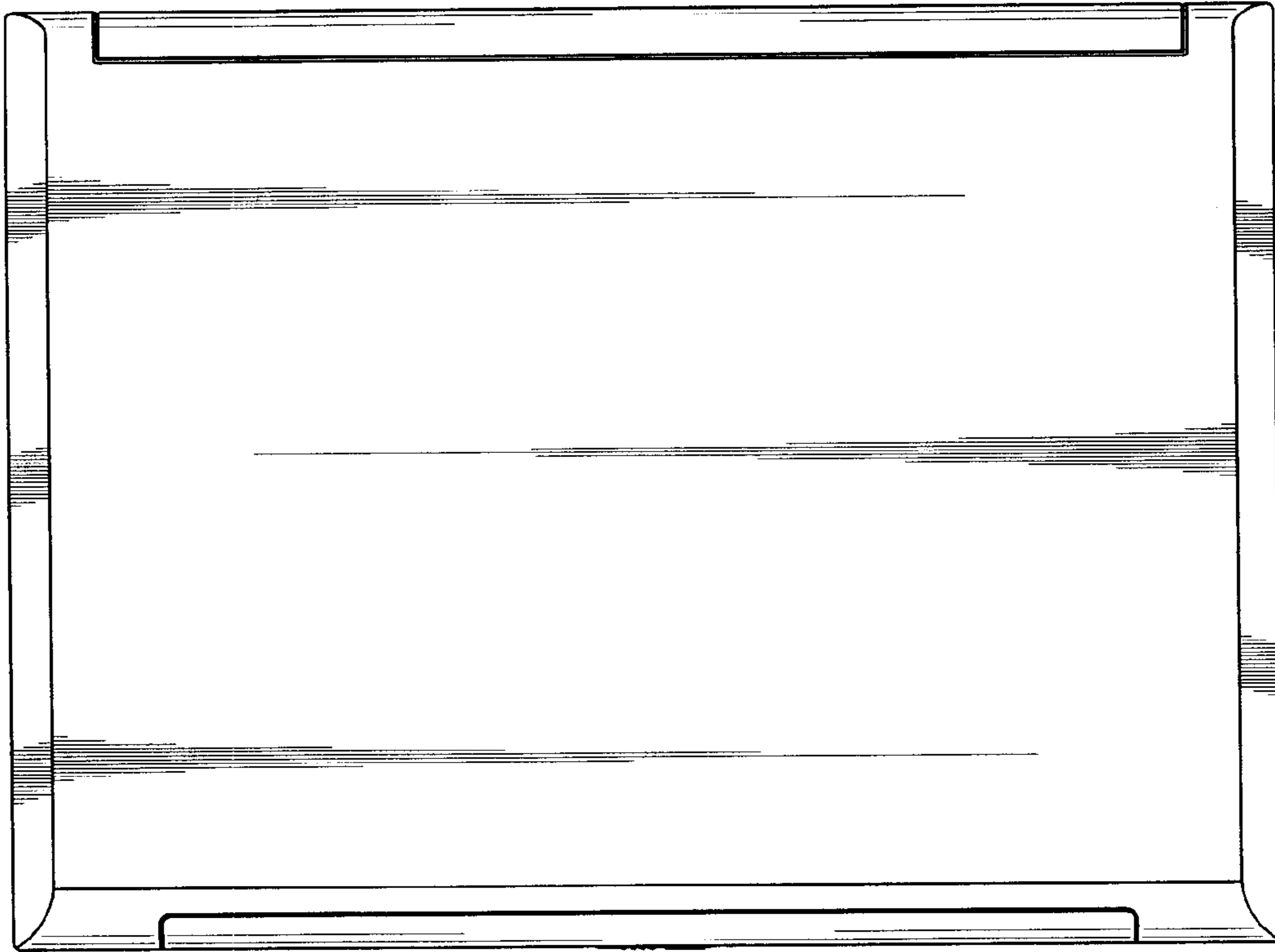

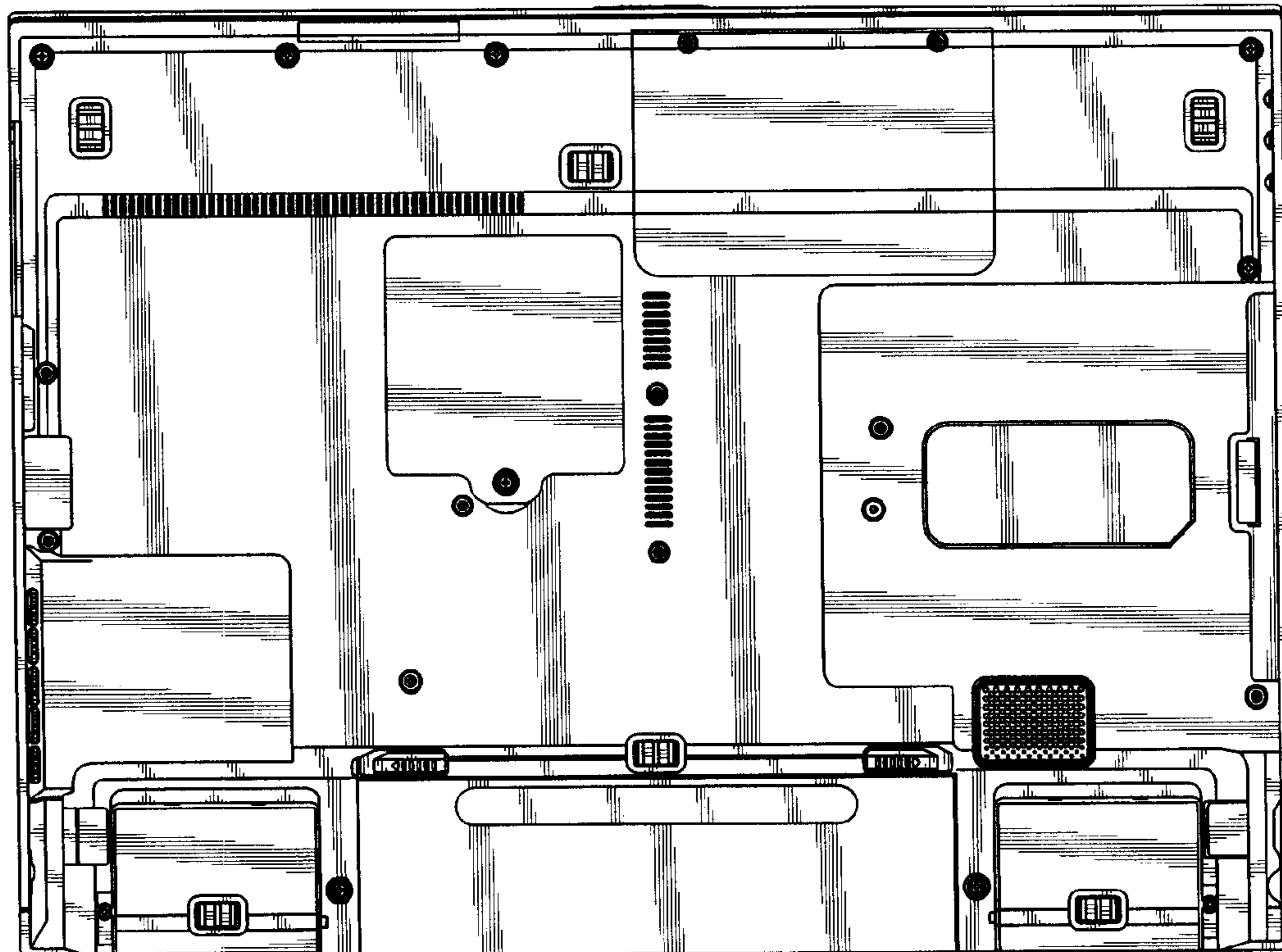
