(57) **CLAIM**

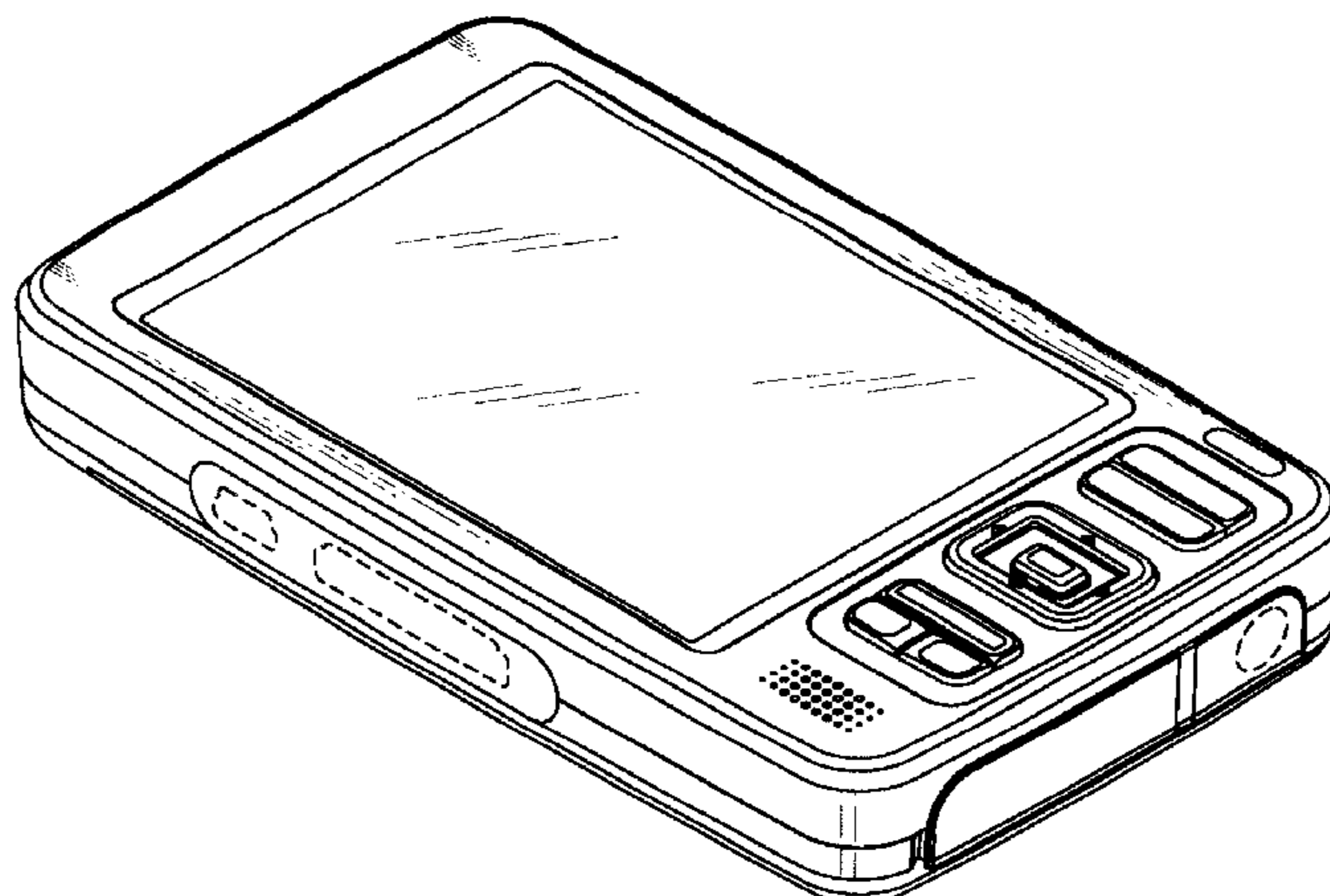
The ornamental design for a media player, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of a media player in accordance with the present design;  
FIG. 2 is a rear view of the media player shown in FIG. 1;  
FIG. 3 is a front view of the media player shown in FIG. 1;  
FIG. 4 is a top view of the media player shown in FIG. 1;  
FIG. 5 is a bottom view of the media player shown in FIG. 1;  
FIG. 6 is a left side view of the media player shown in FIG. 1; and,

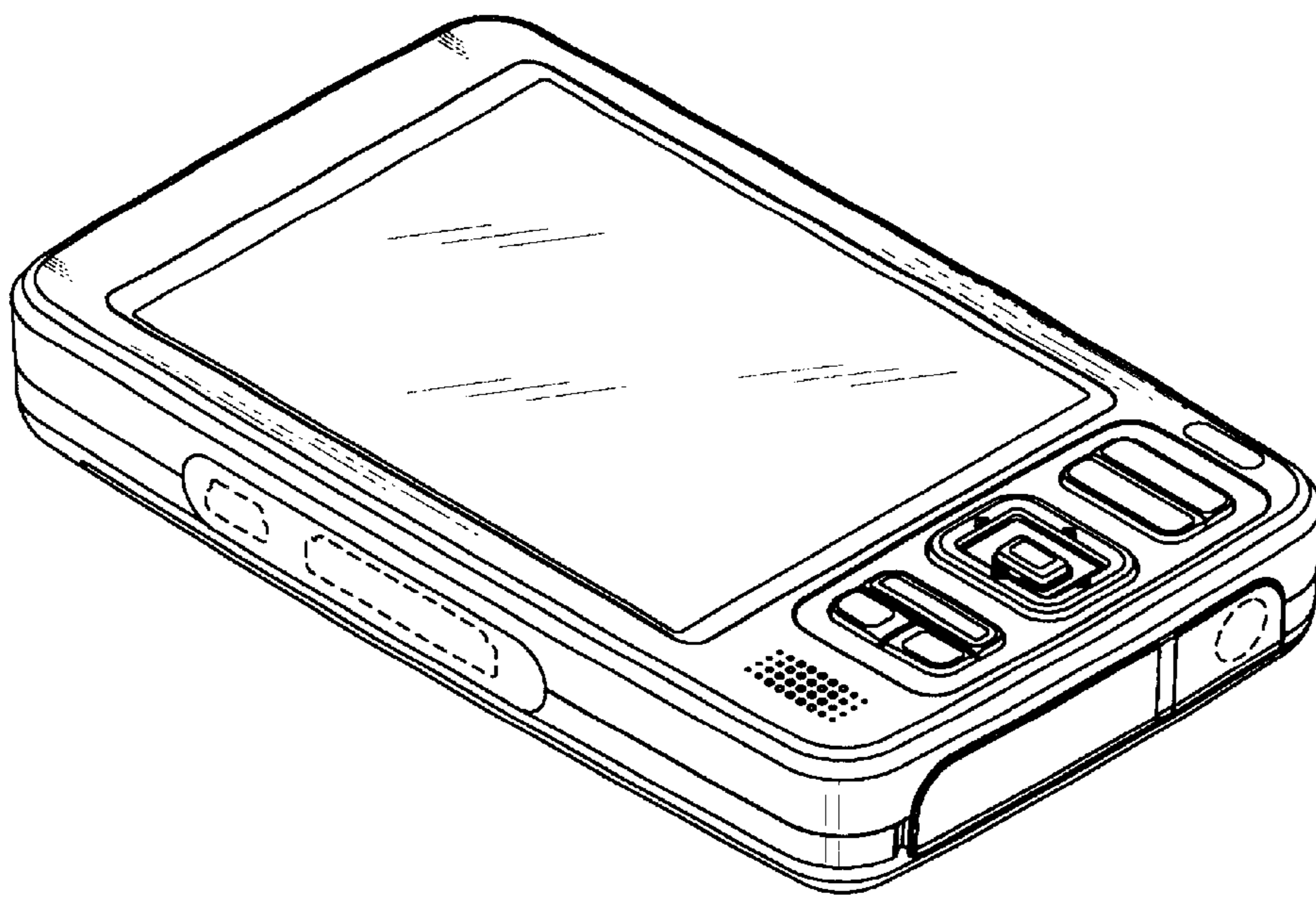

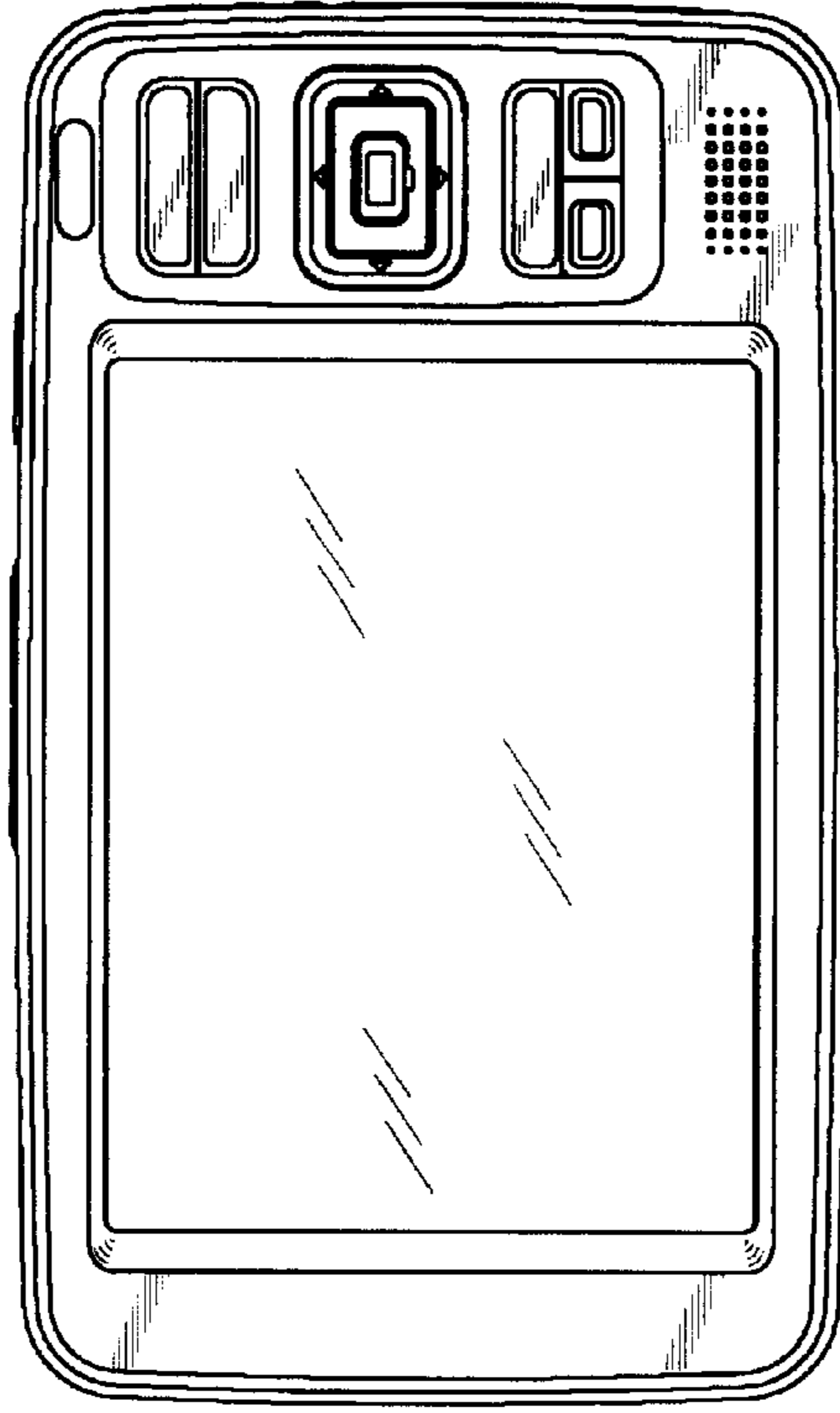

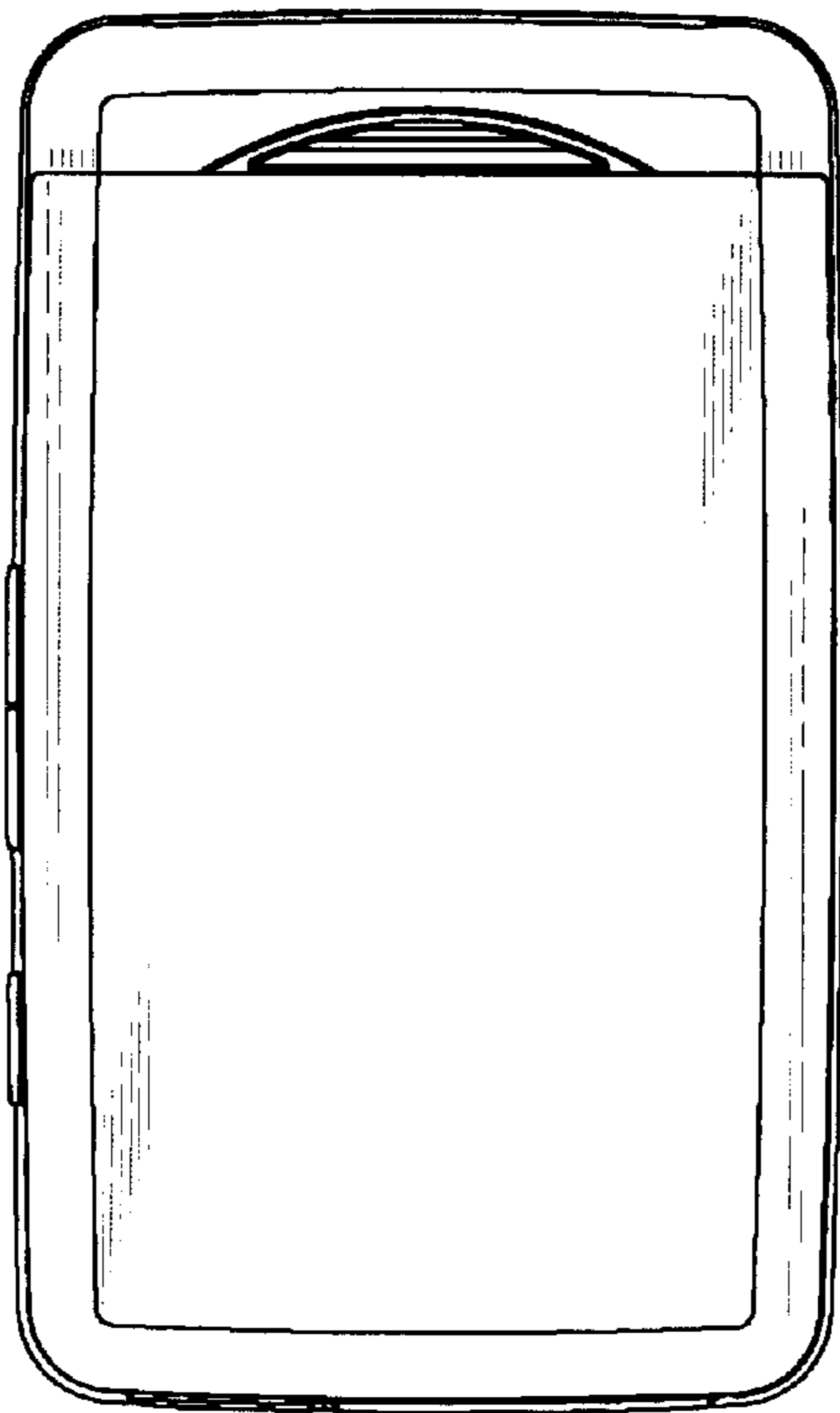

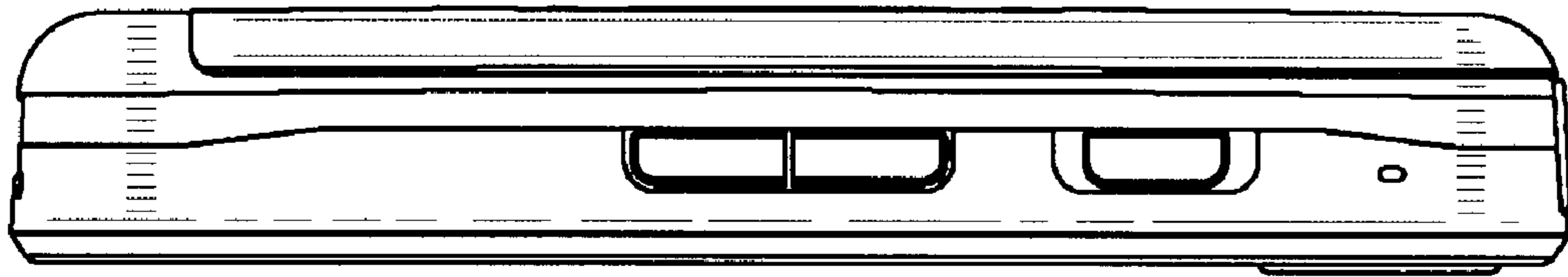

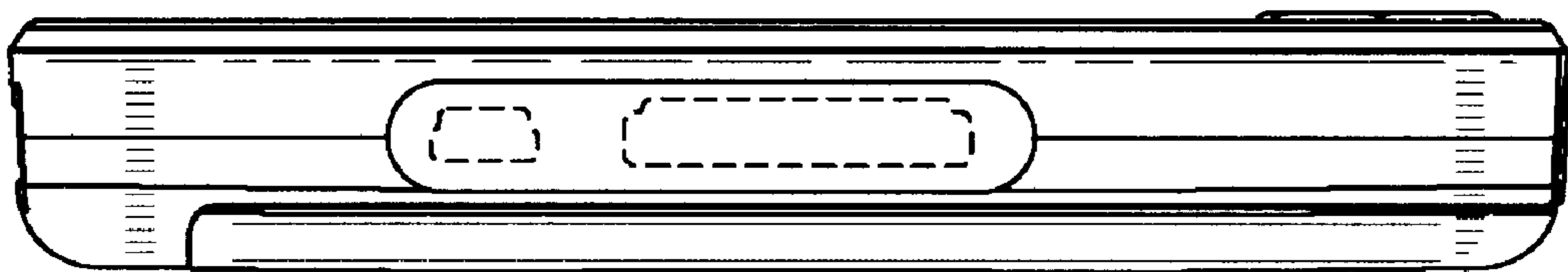

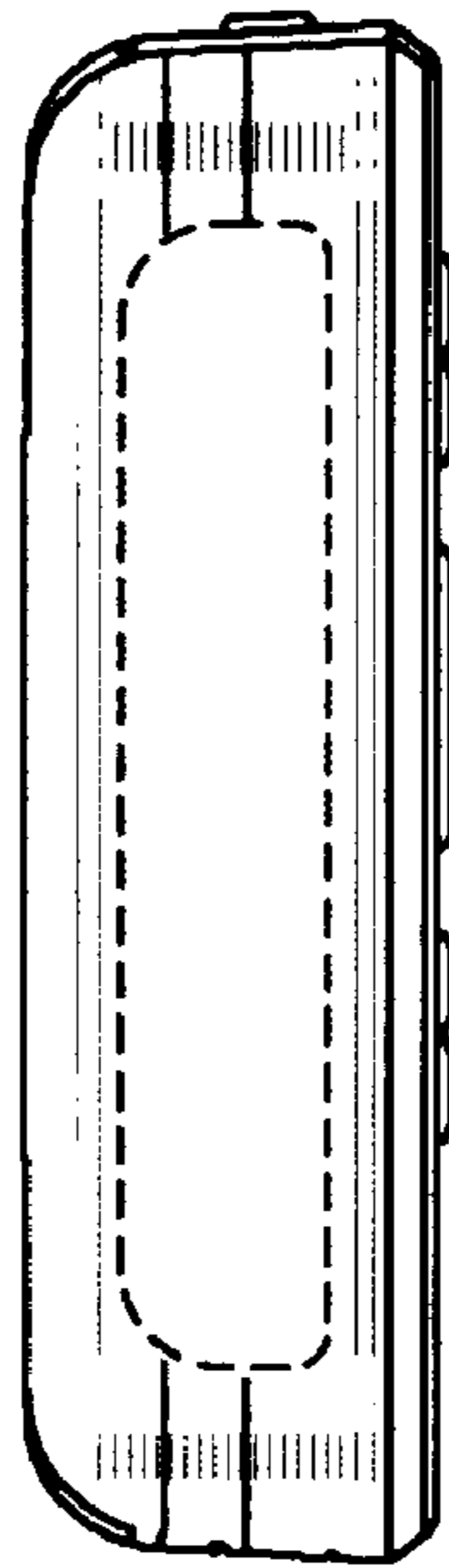

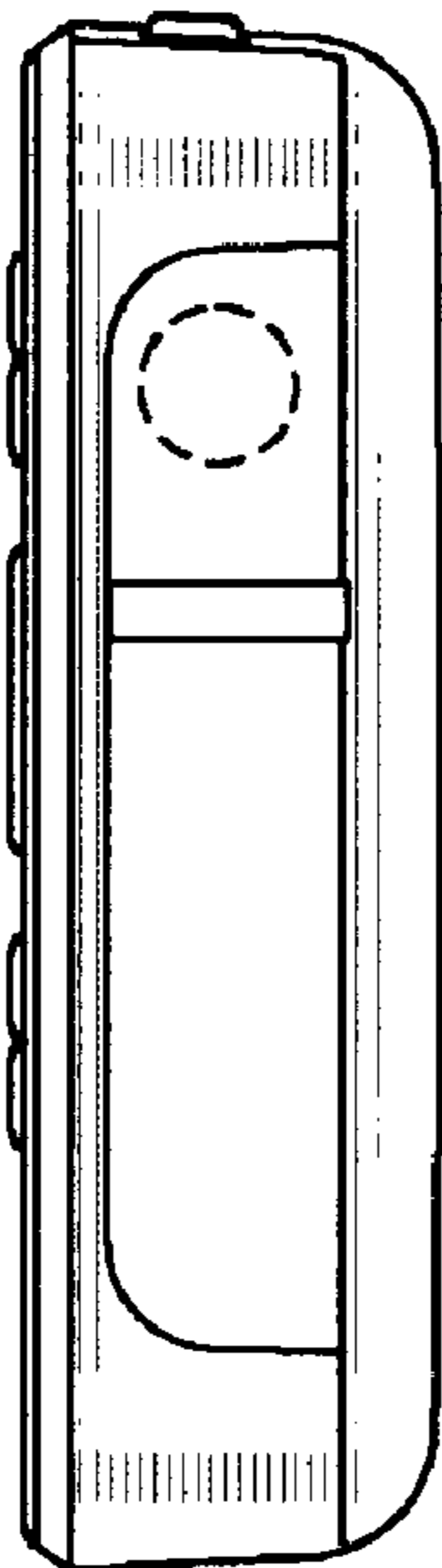
