FIG. 6 is a bottom plan view of FIG. 3; and,

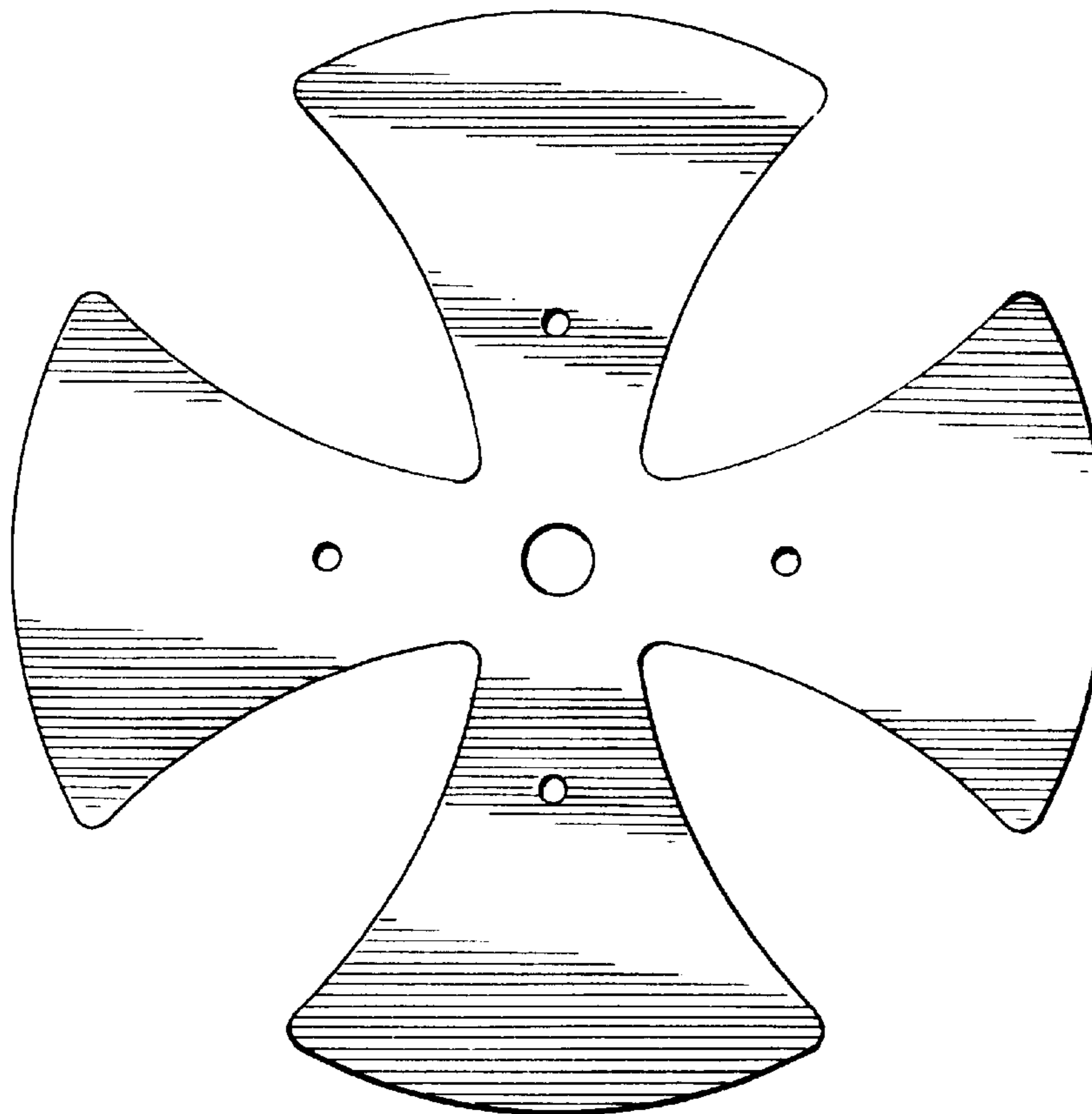
FIG. 7 is a front elevational view of a second embodiment

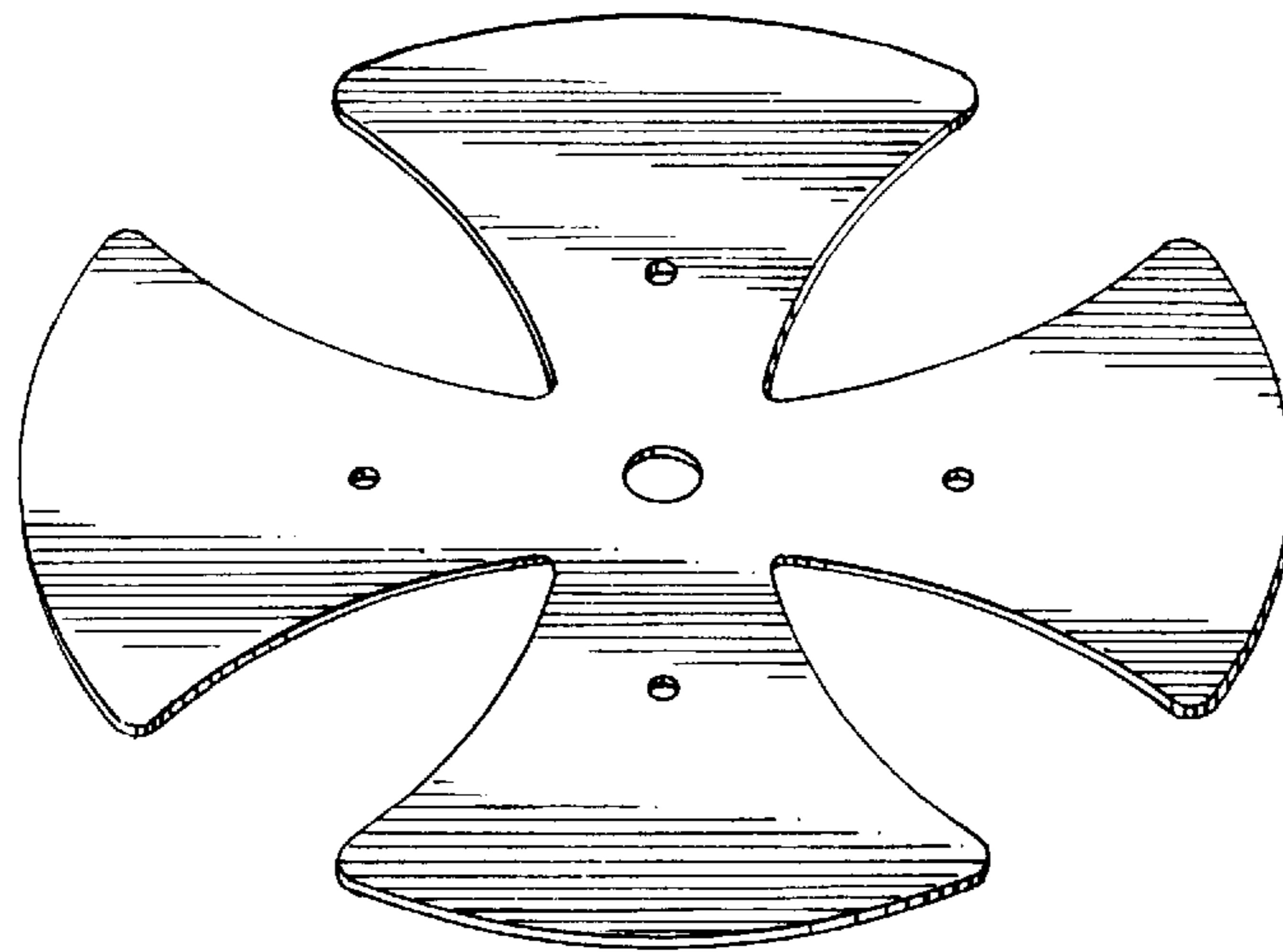

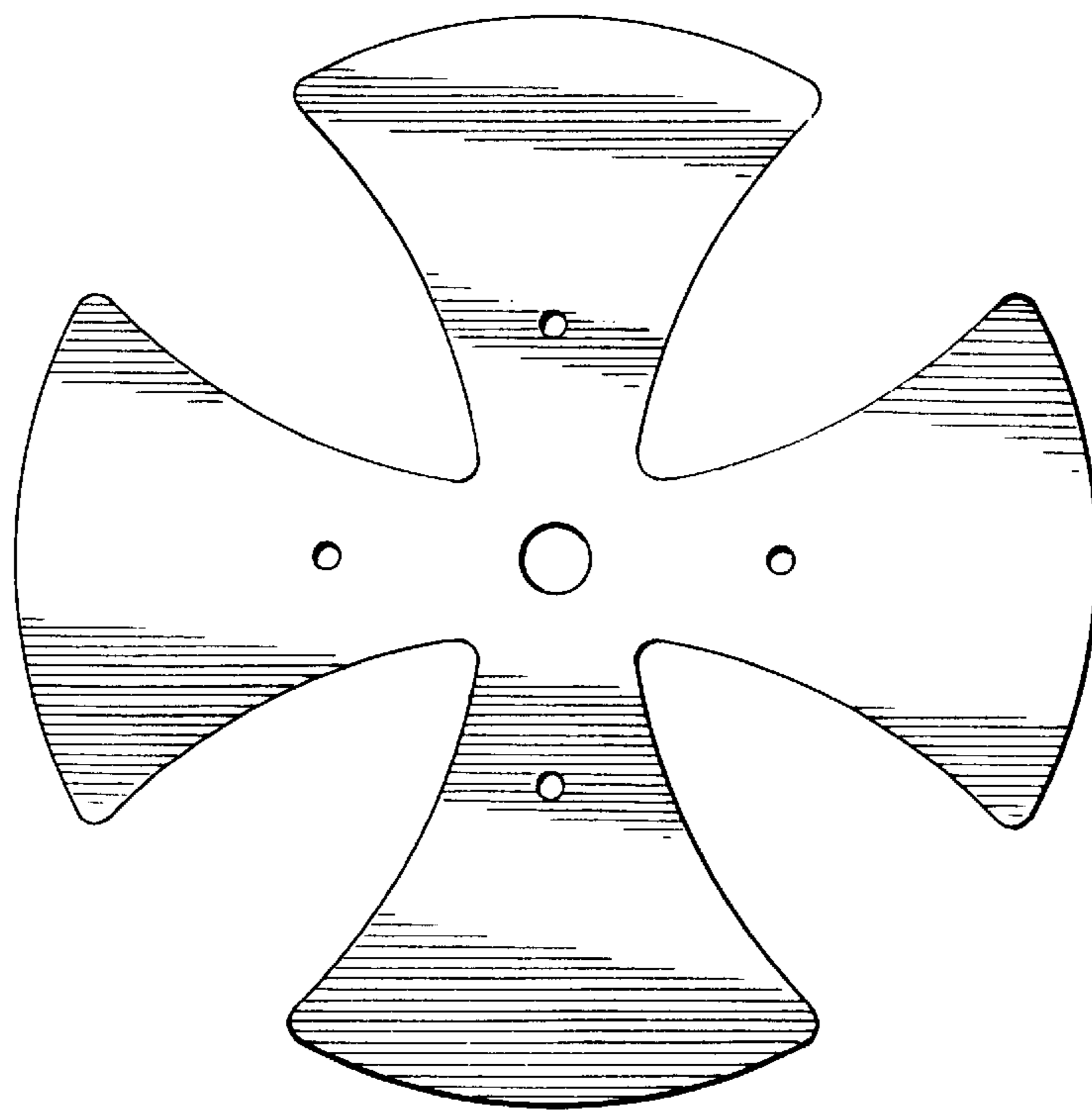
