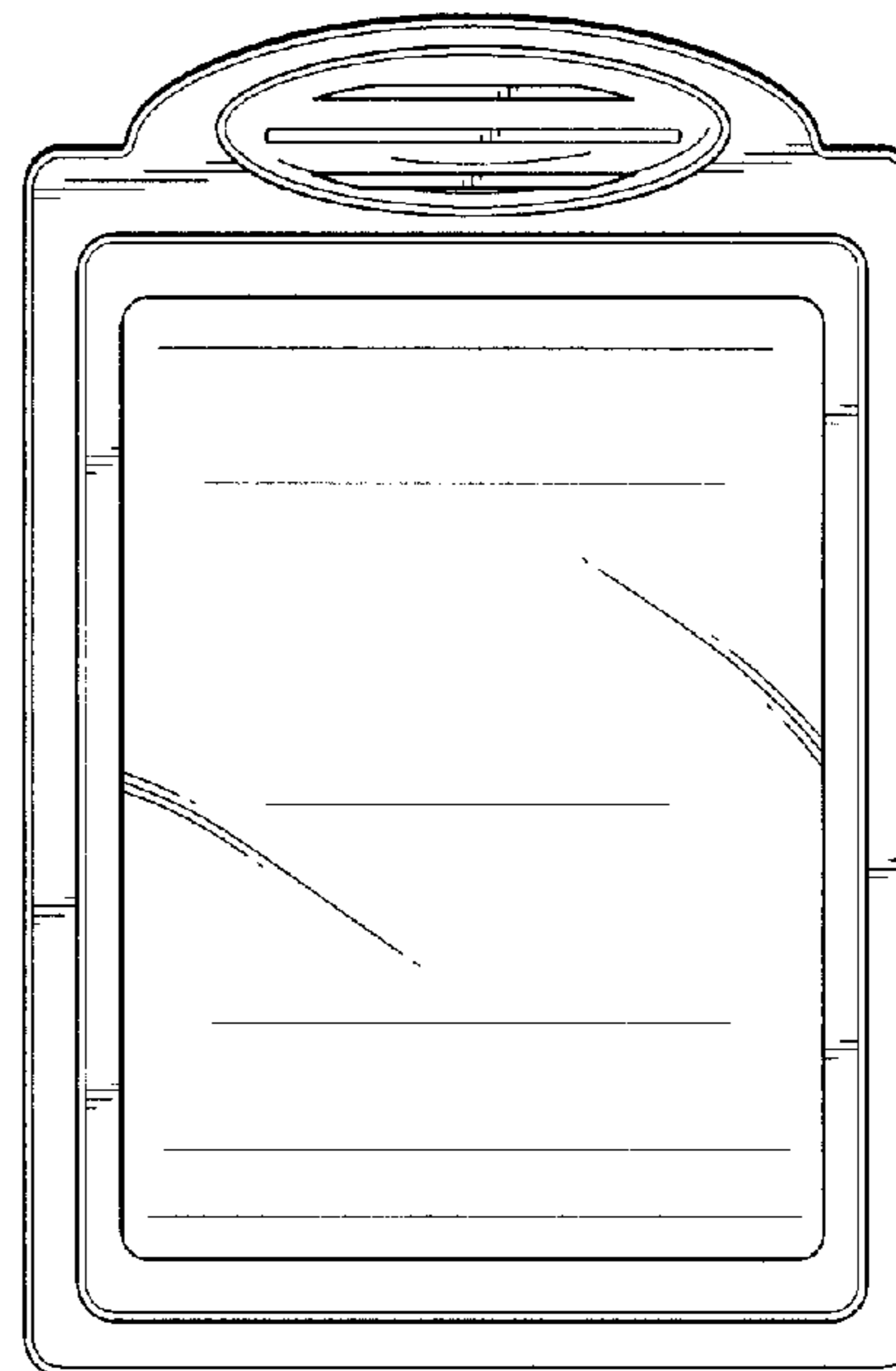
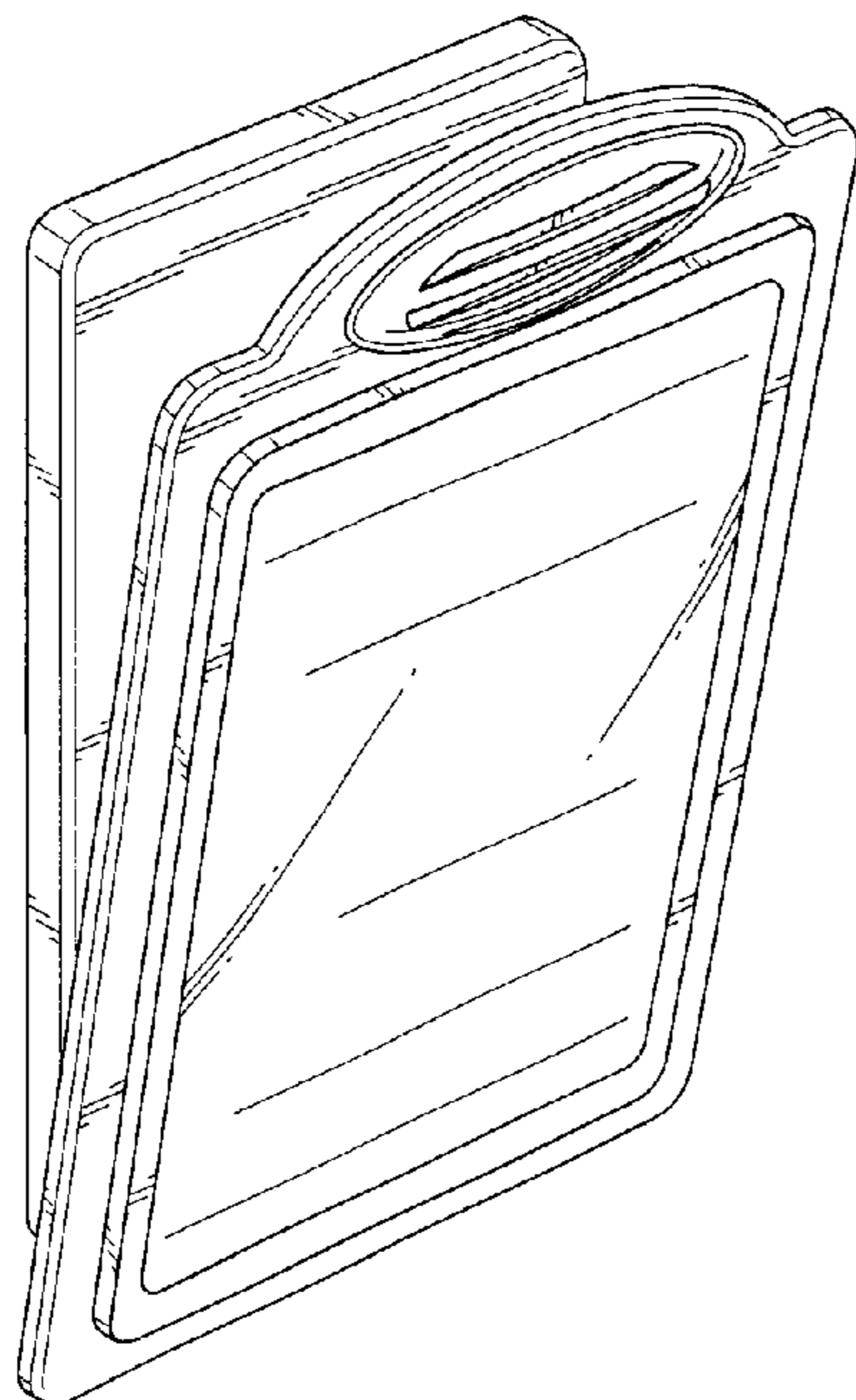

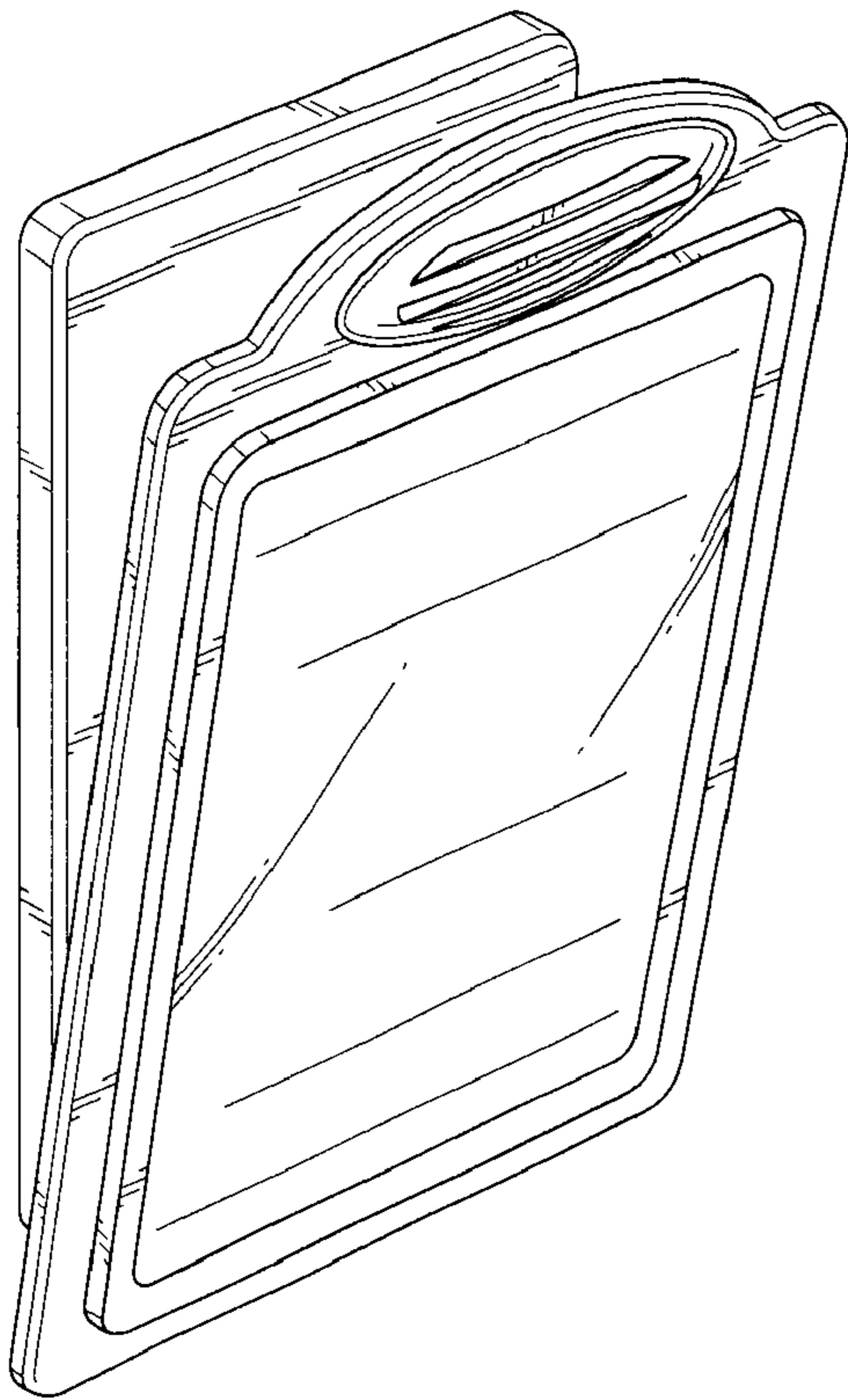
The ornamental design for a memo clip, as shown and described.

**DESCRIPTION**

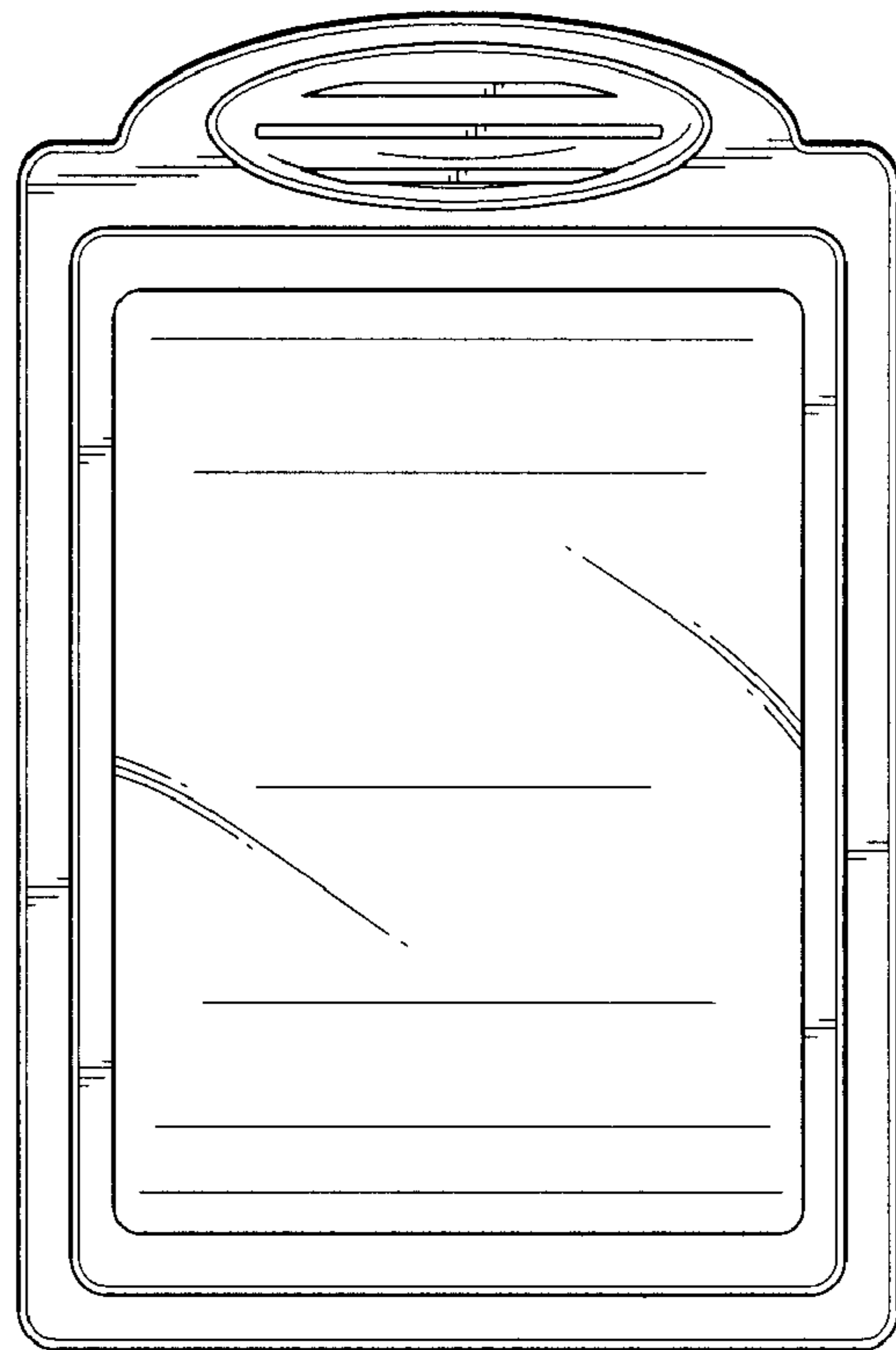

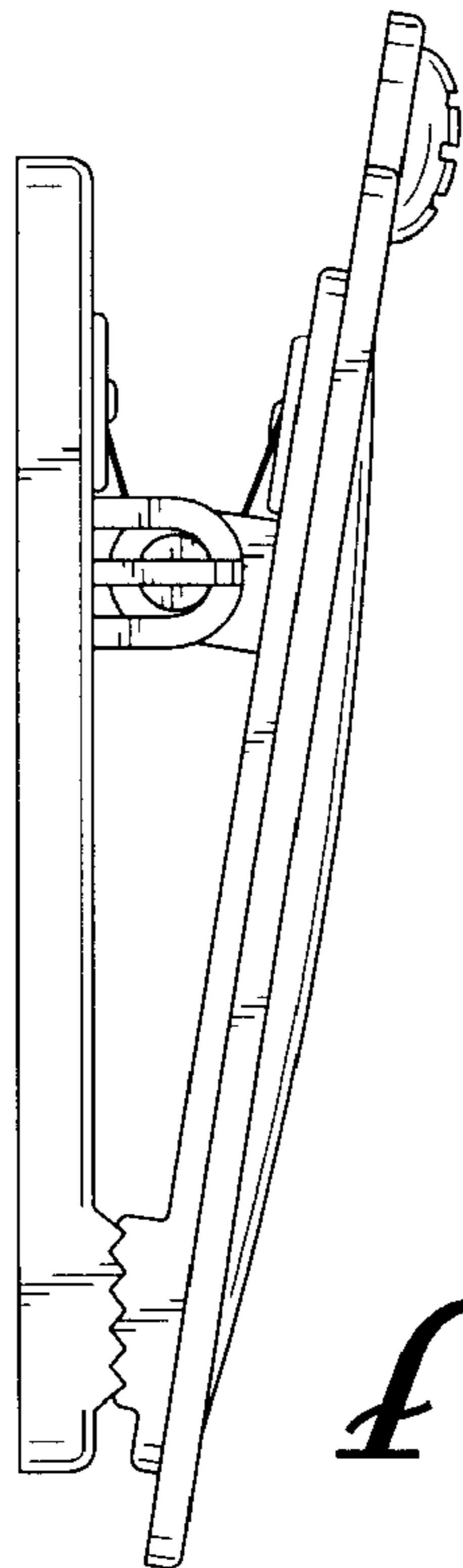




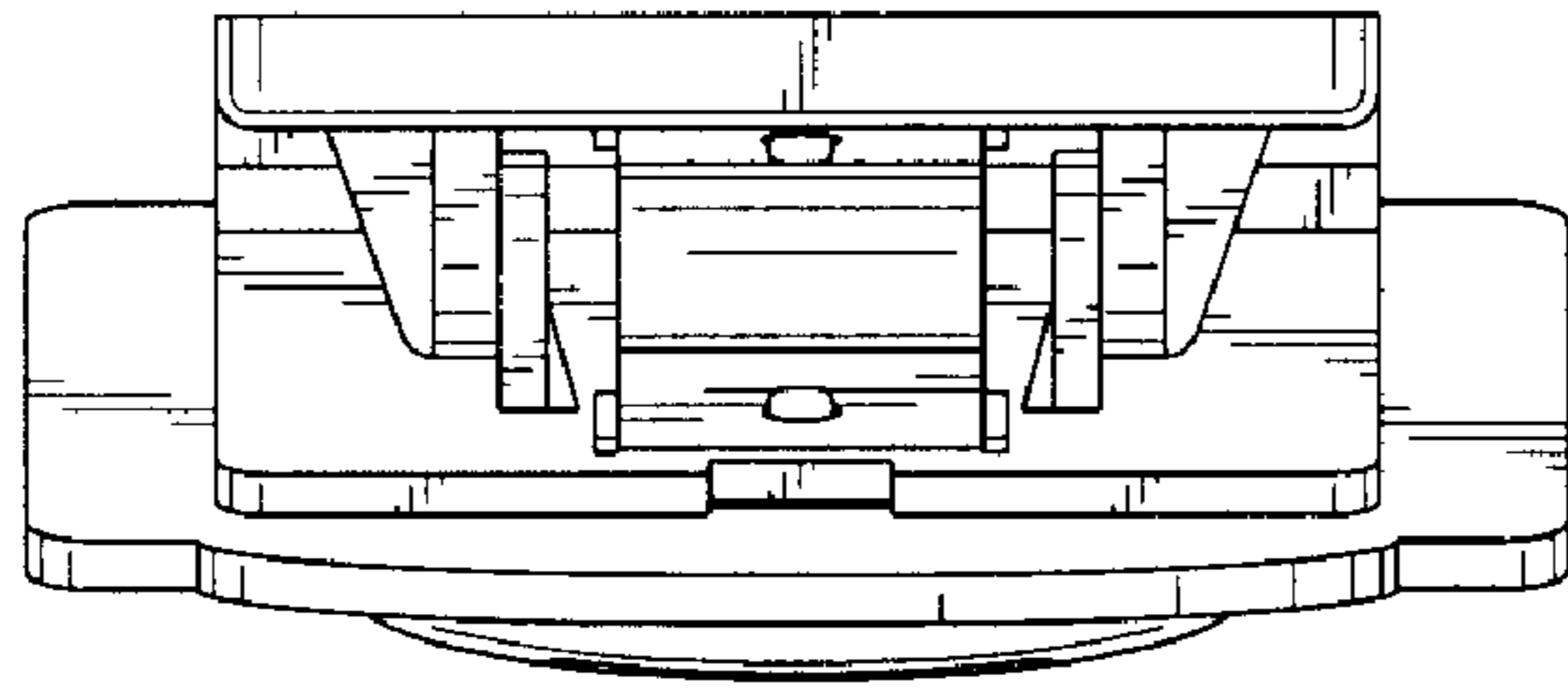

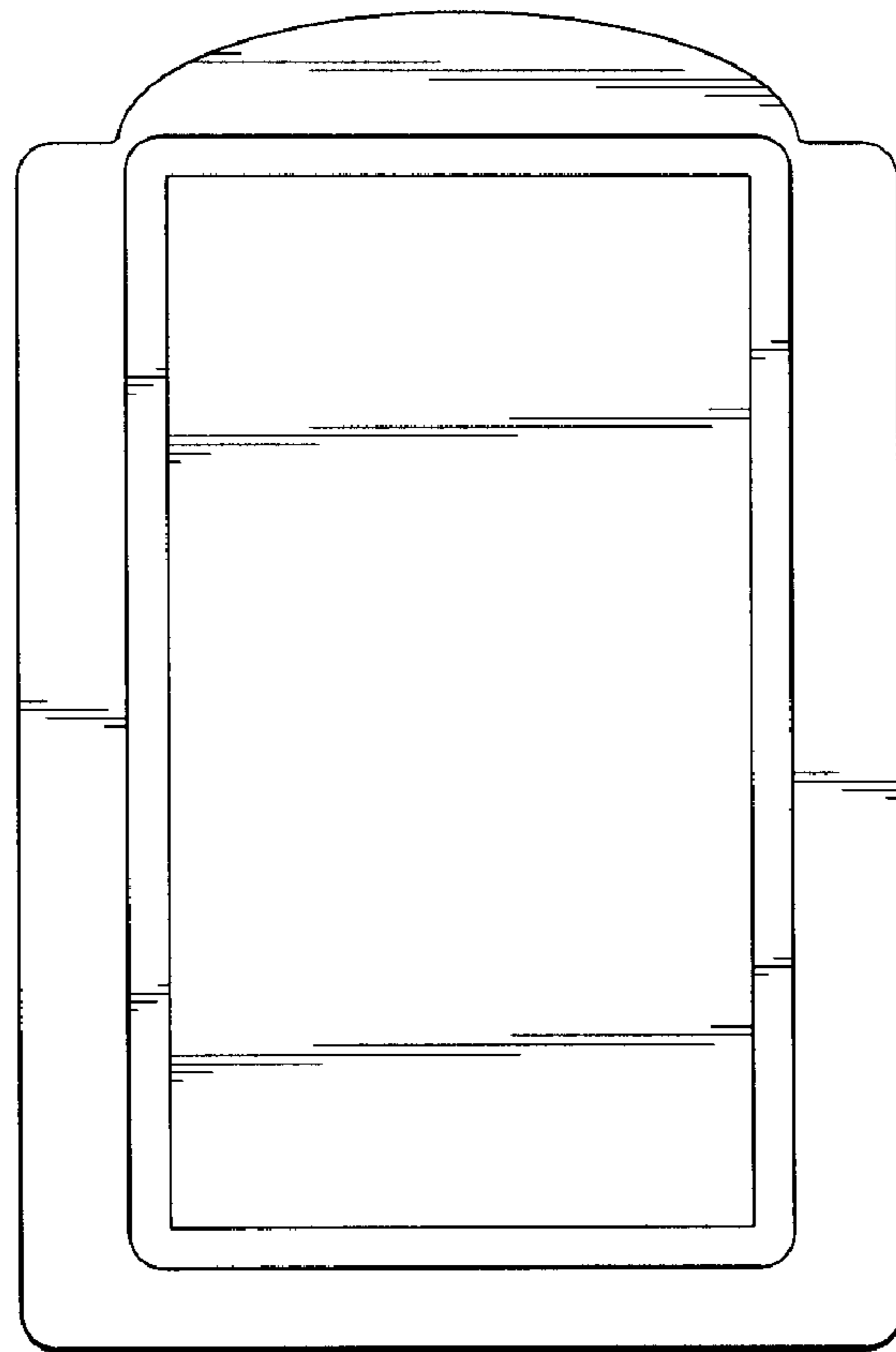
