**DESCRIPTION**

FIG. 1 is a perspective view of an envelope holder, showing  
our new design;

FIG. 2 is a top plan view thereof;

in FIG. 4;

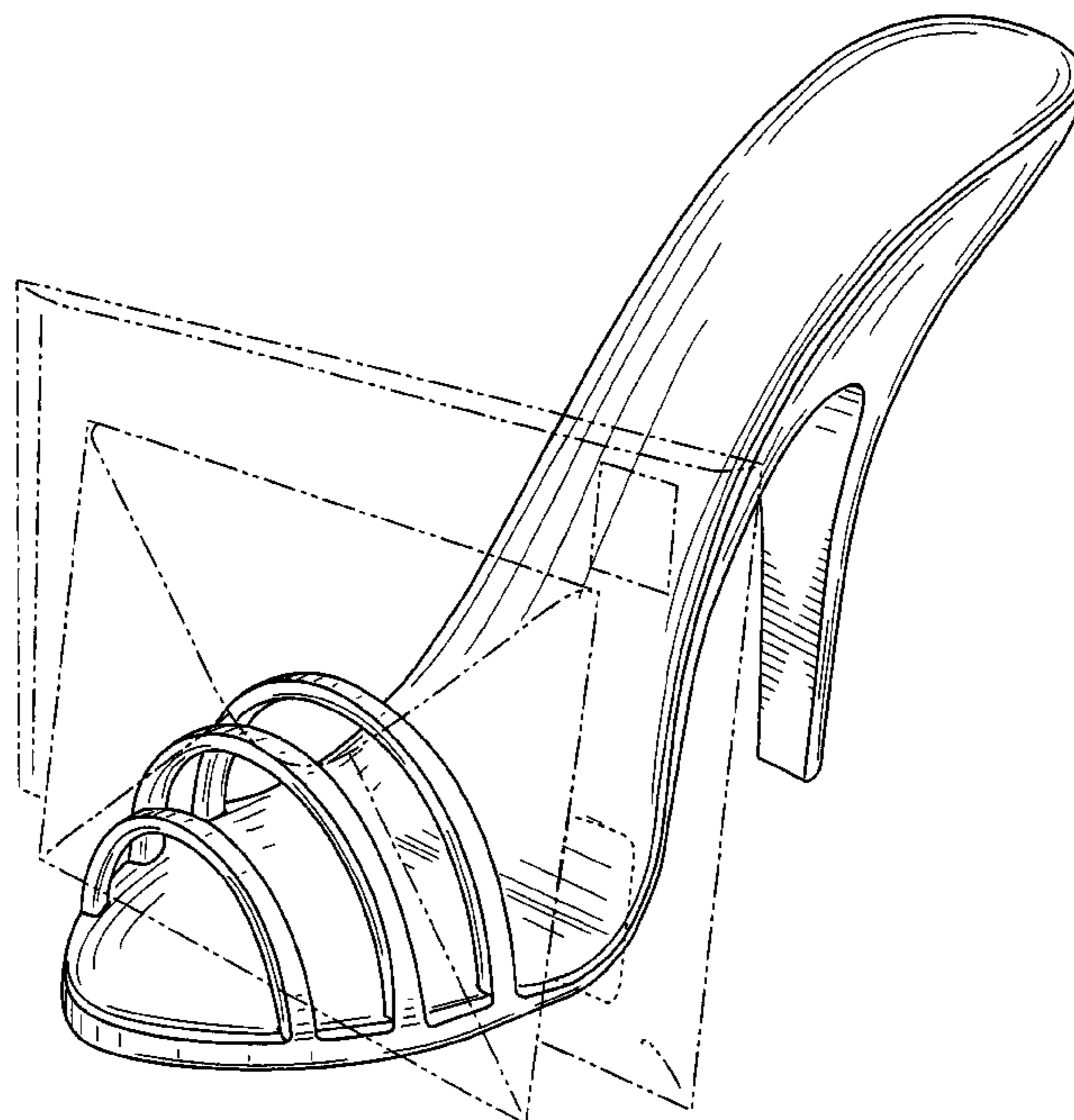
FIG. 6 is a front elevational view thereof;

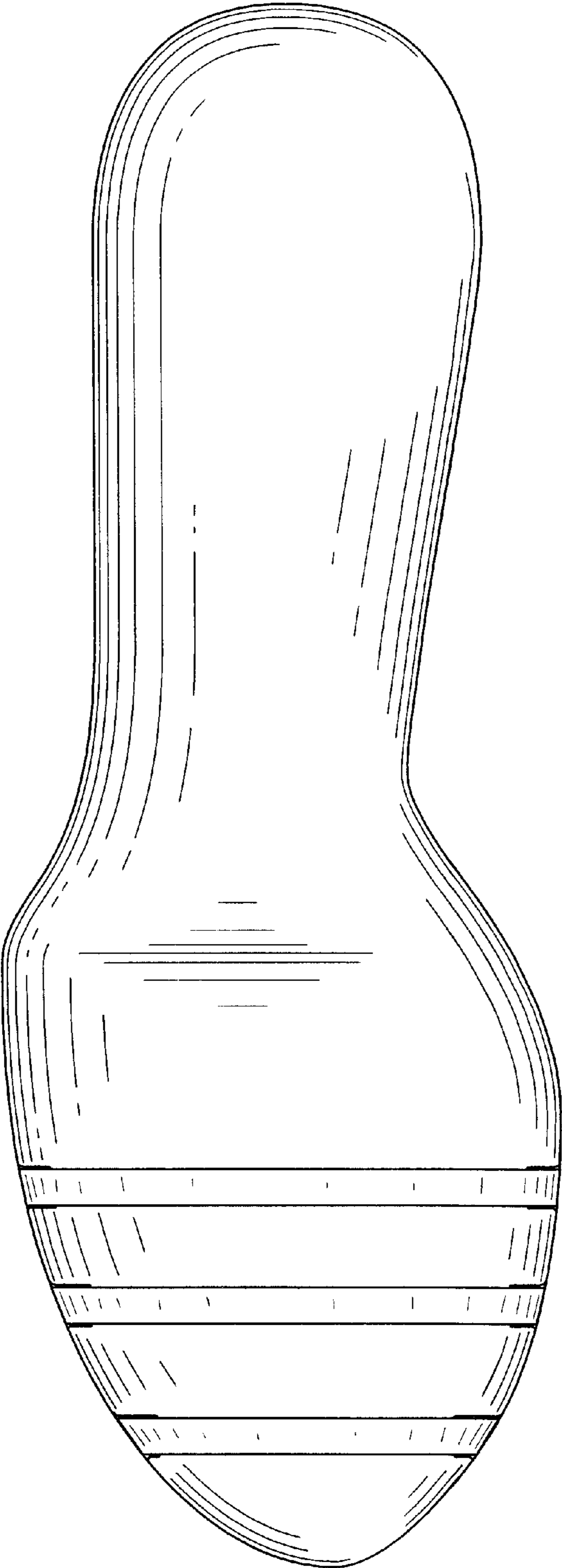

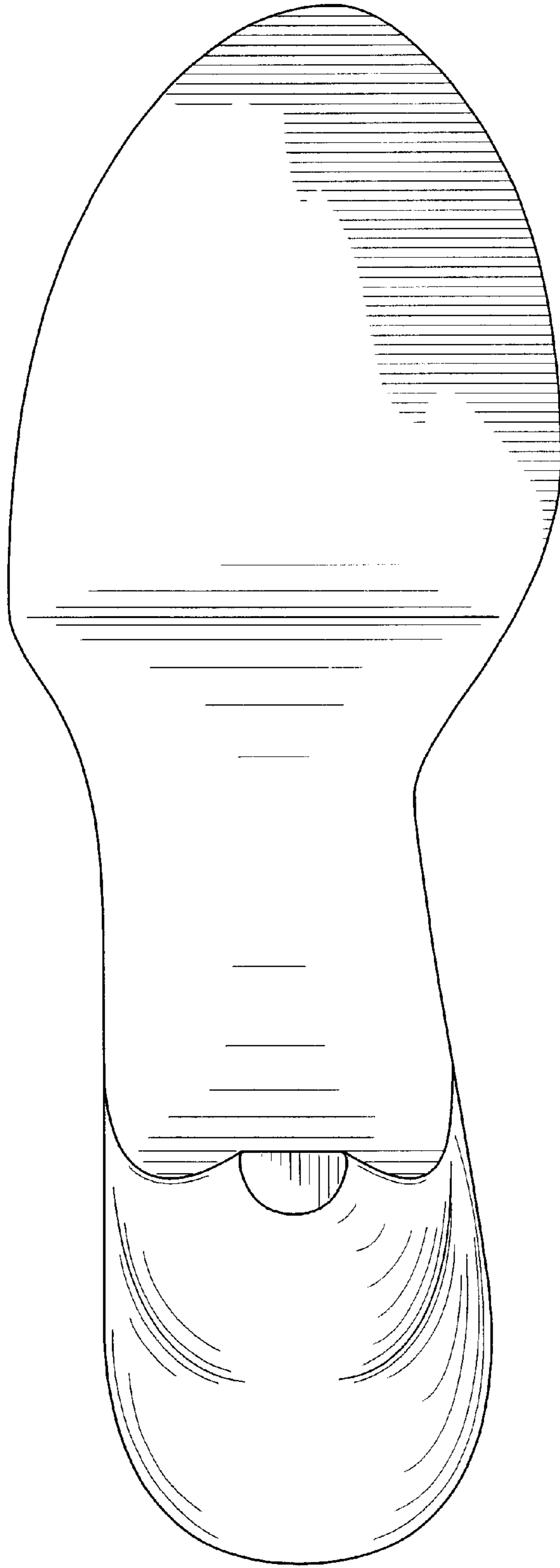

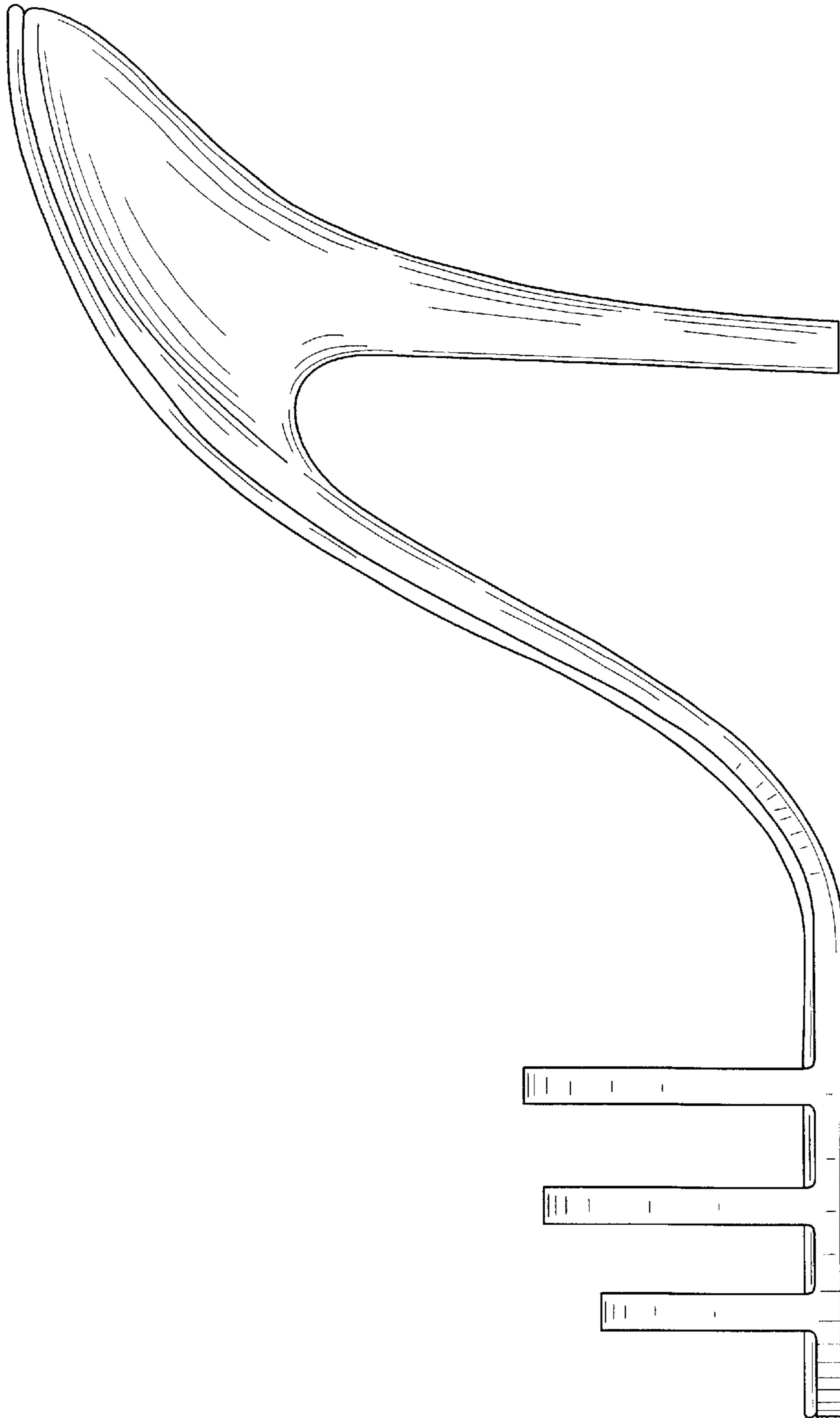

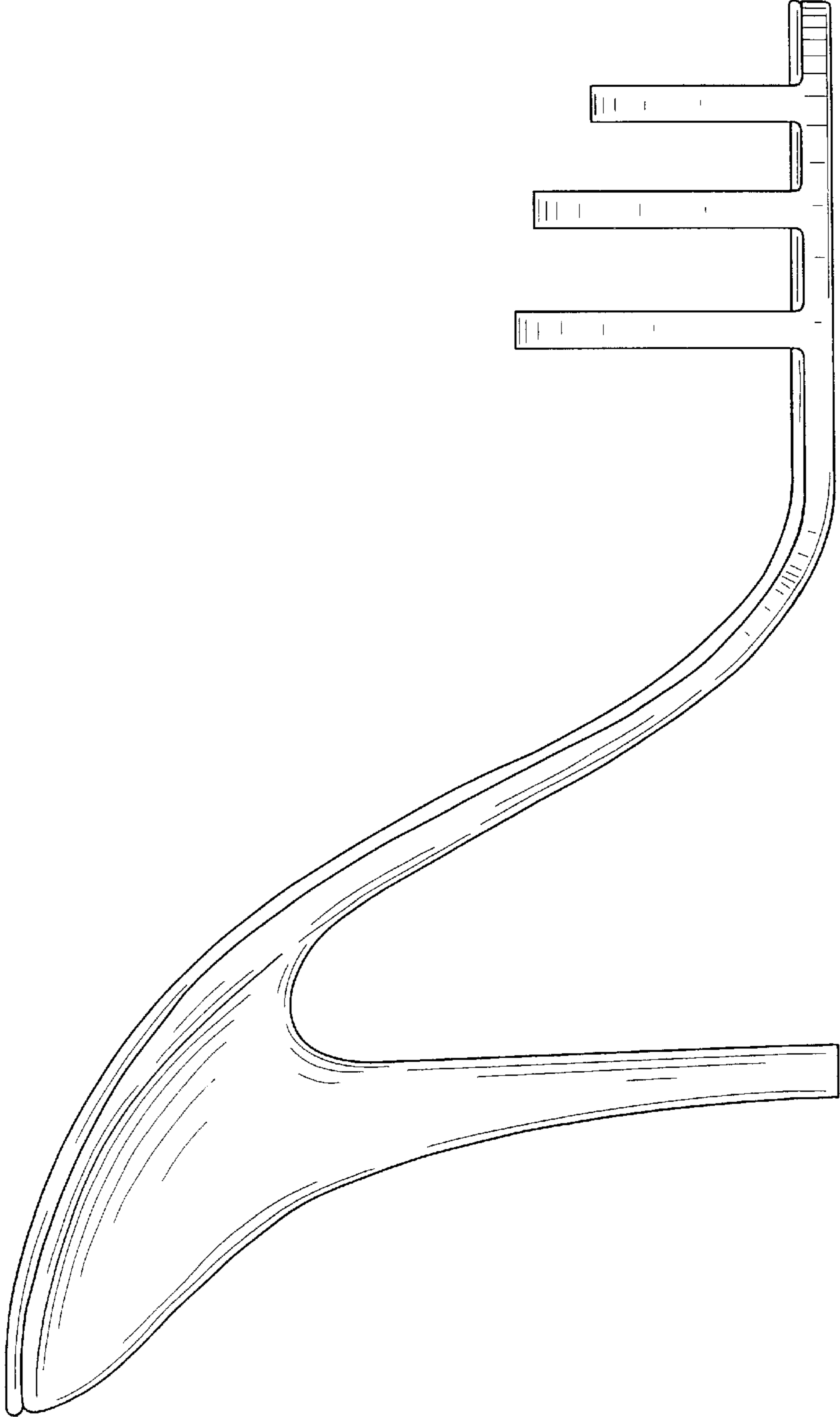
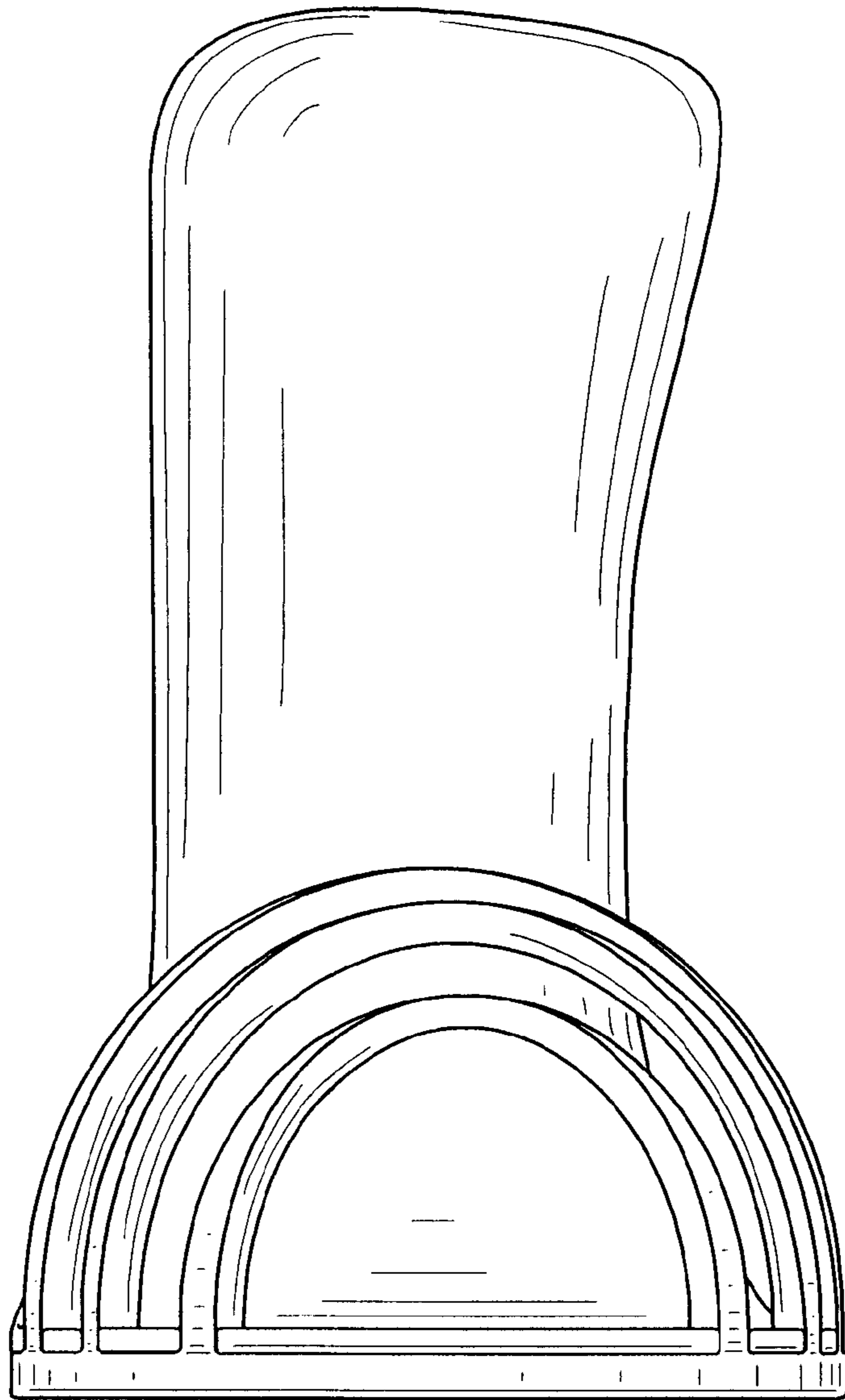
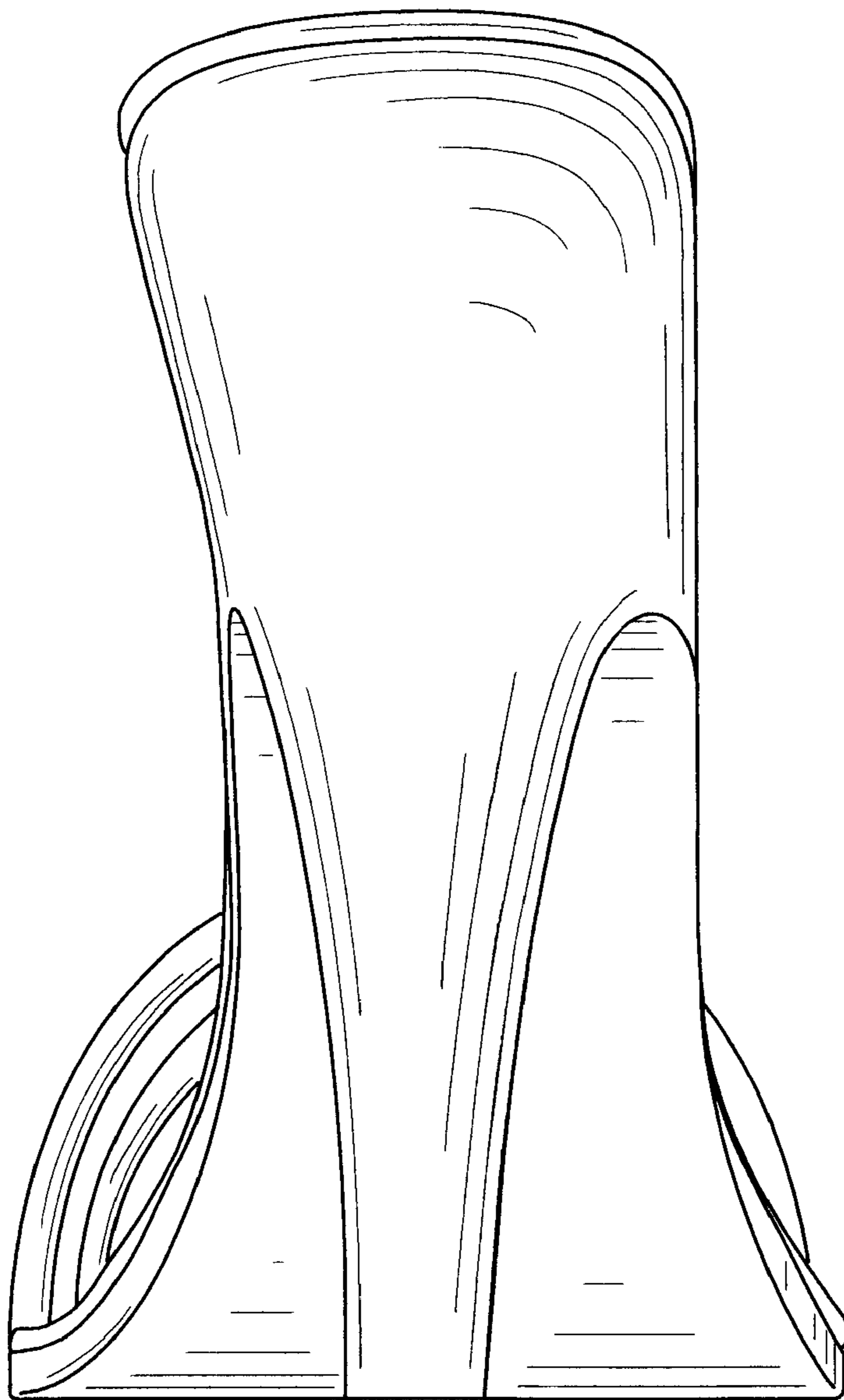

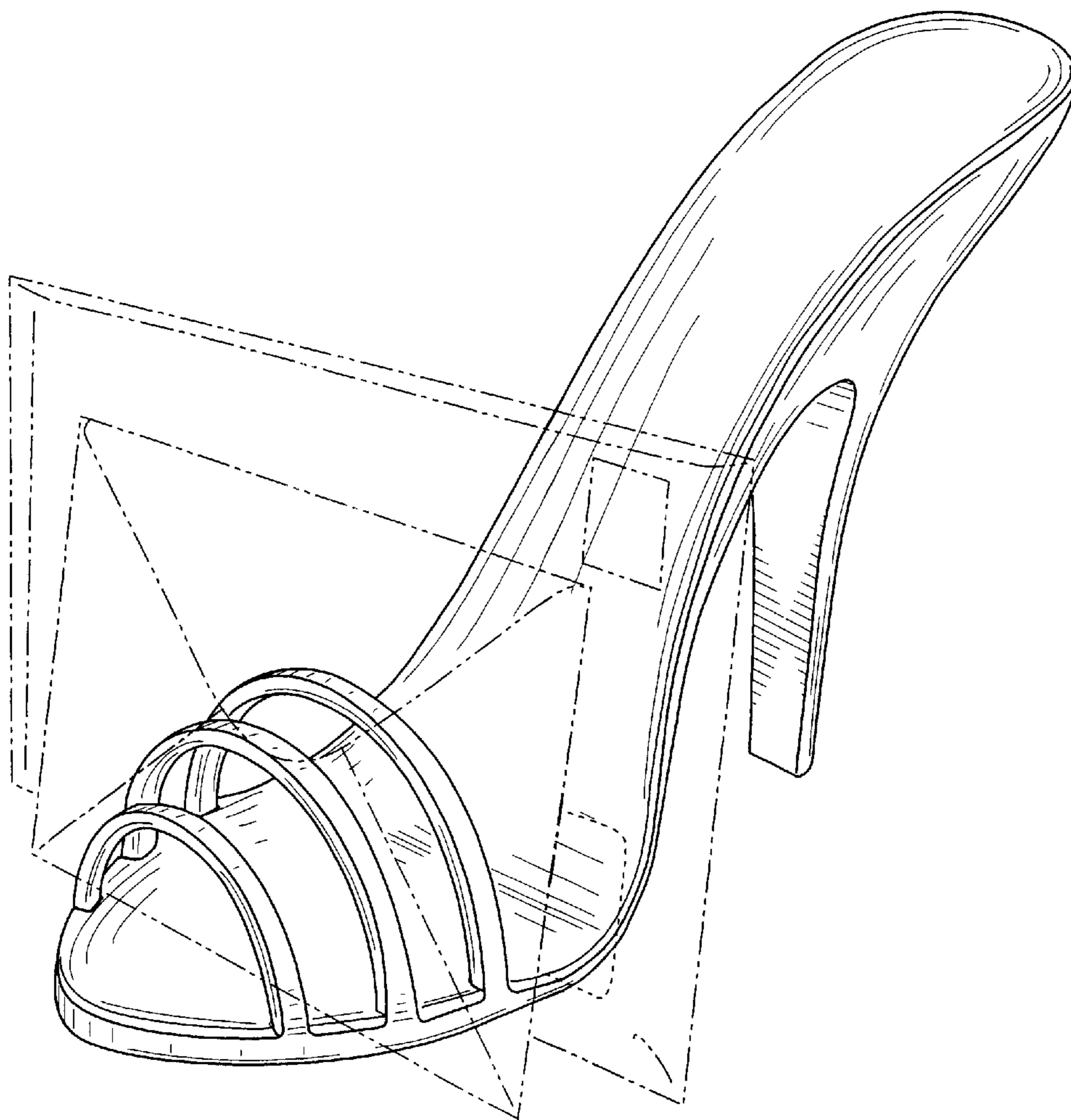
