**DESCRIPTION**

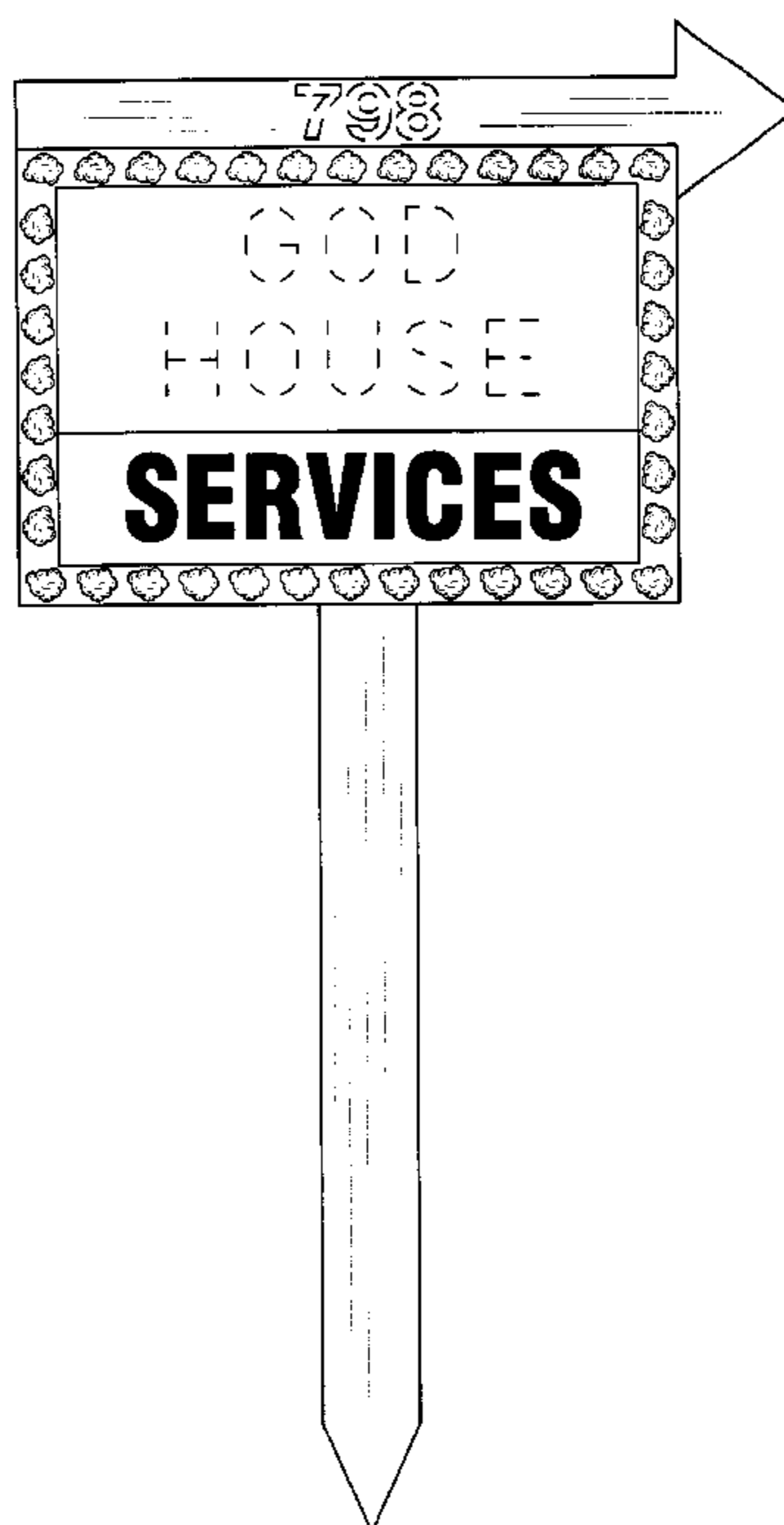
FIG. 1 is a front elevational view of a religious display sign showing my new design;

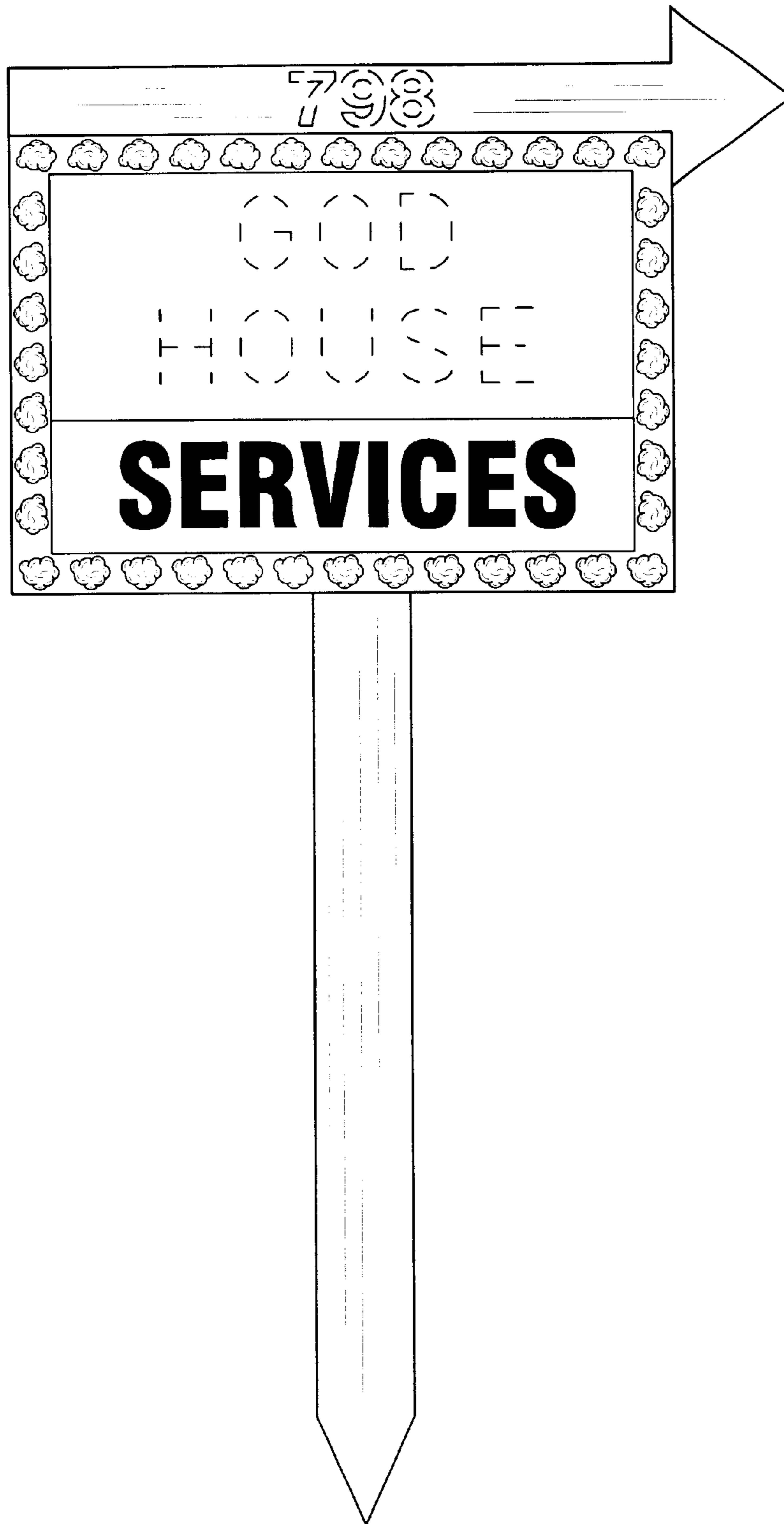

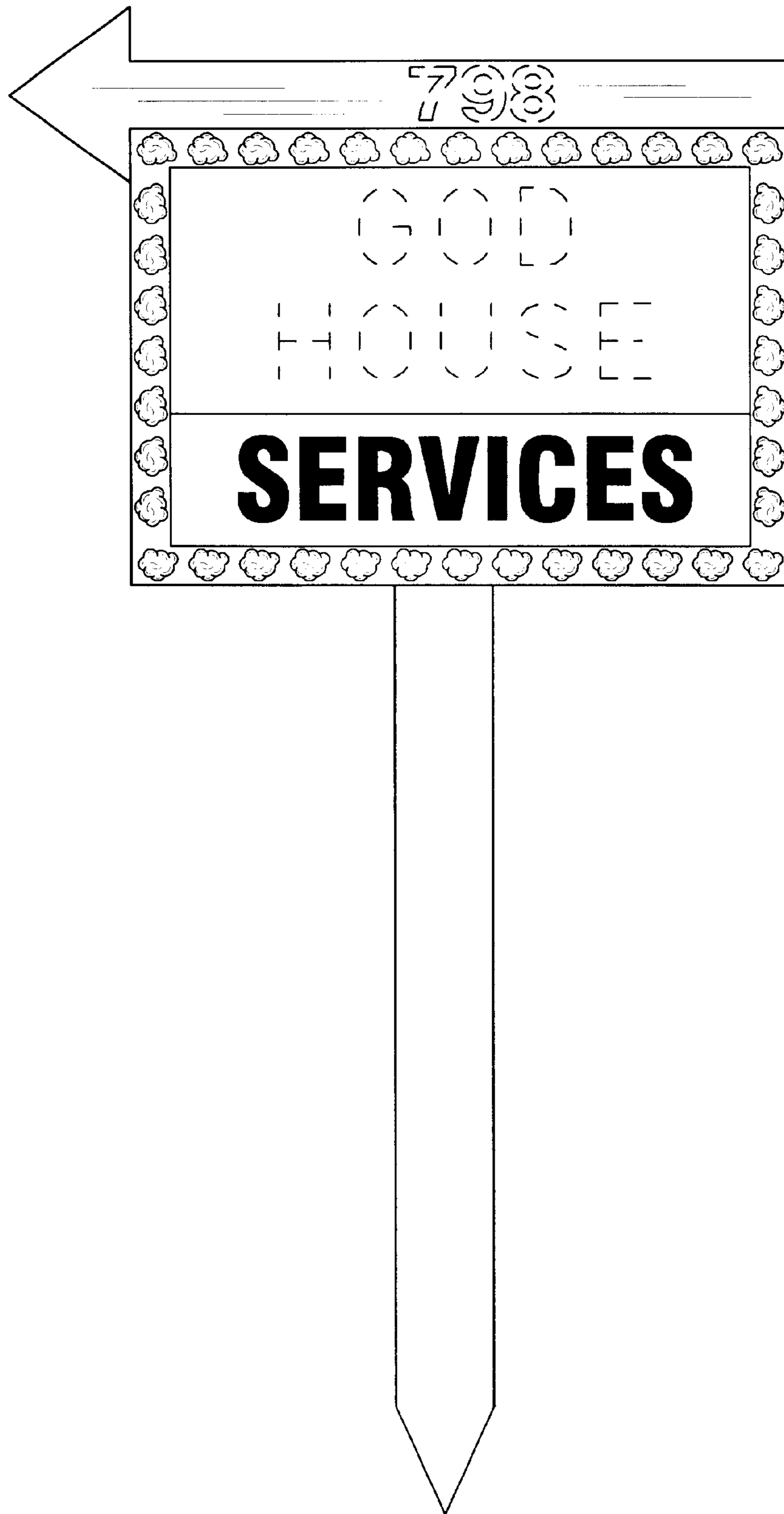

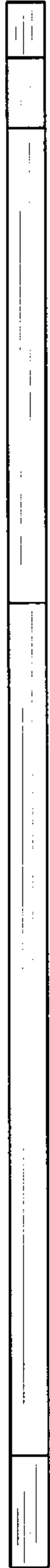

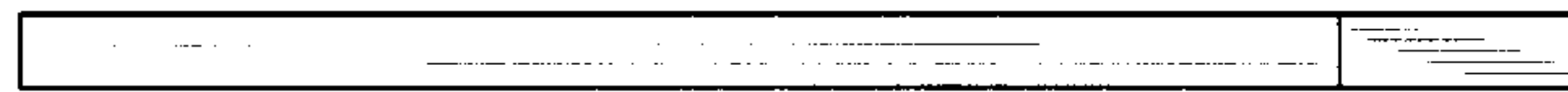

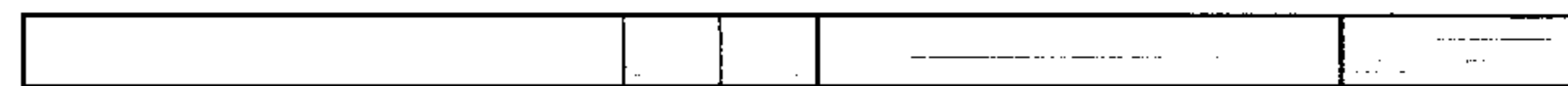
