The ornamental design for a stretching device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a stretching device showing my new design;

FIG. 2 is a left-side elevation view thereof, the right-side elevation view being a mirror image of FIG. 2;

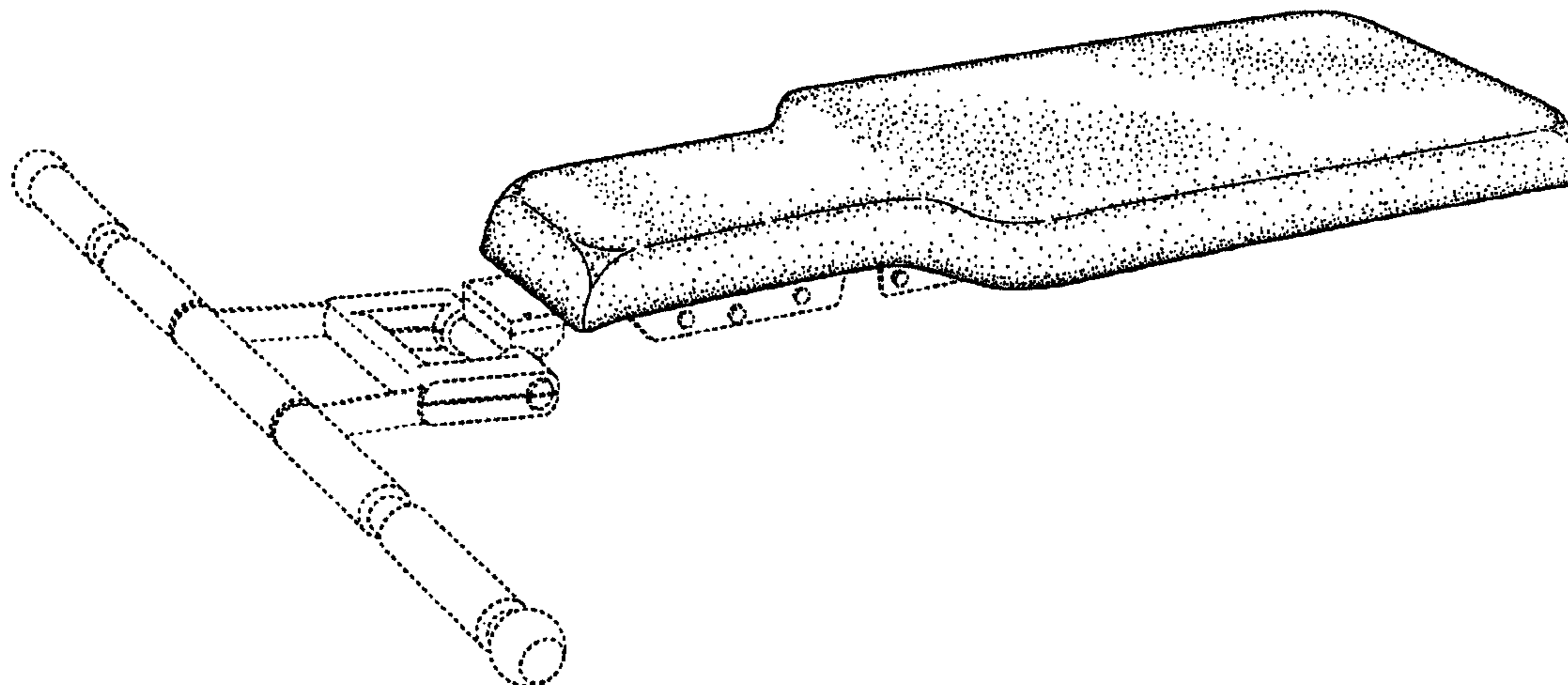
FIG. 3 is a top plan view thereof;

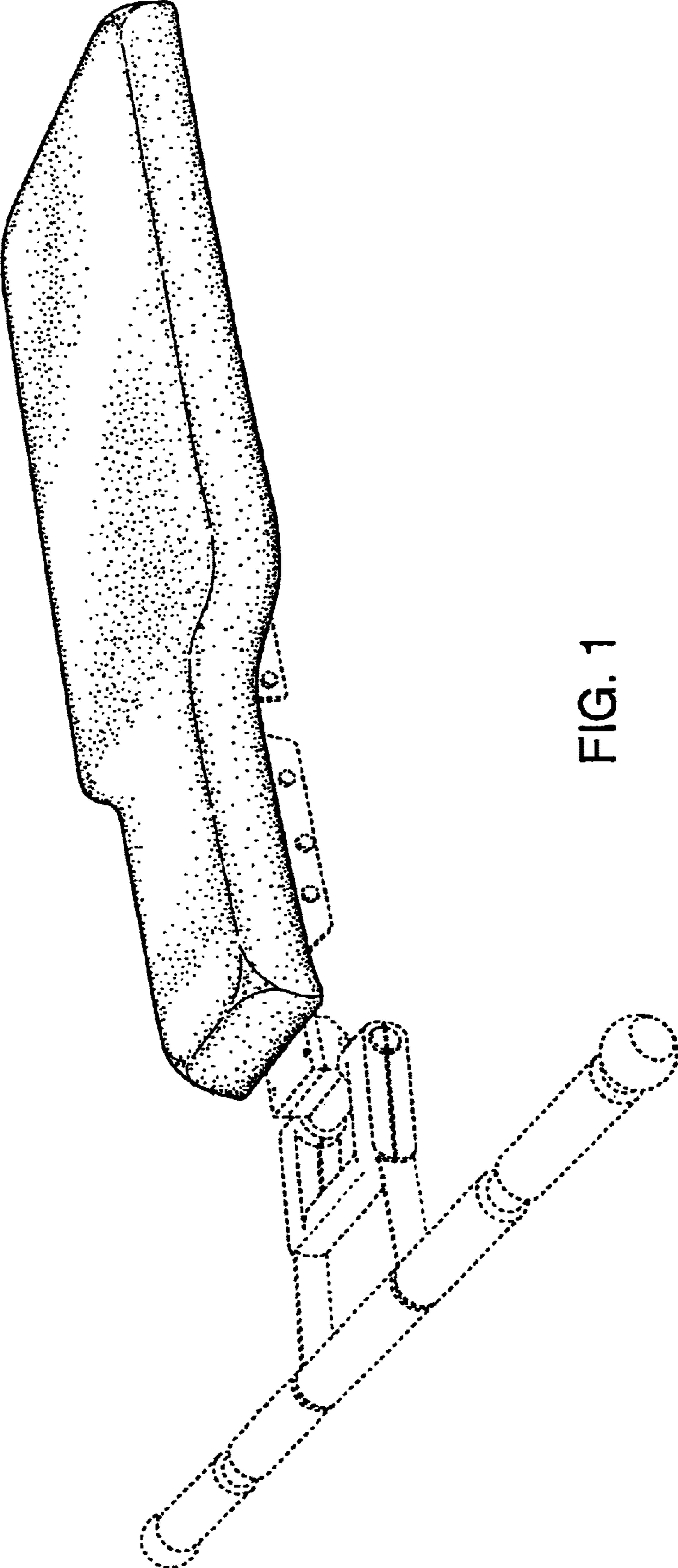

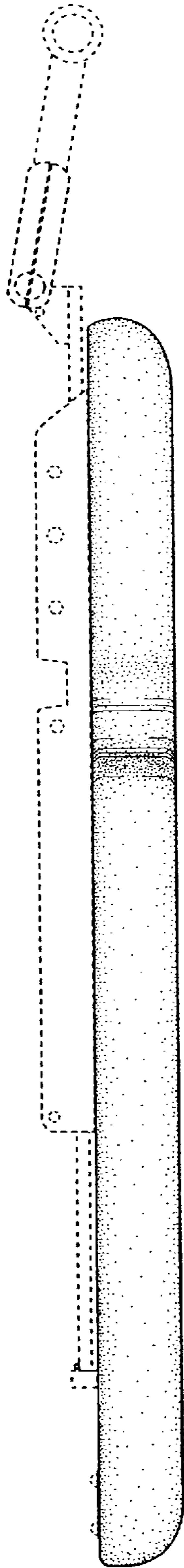

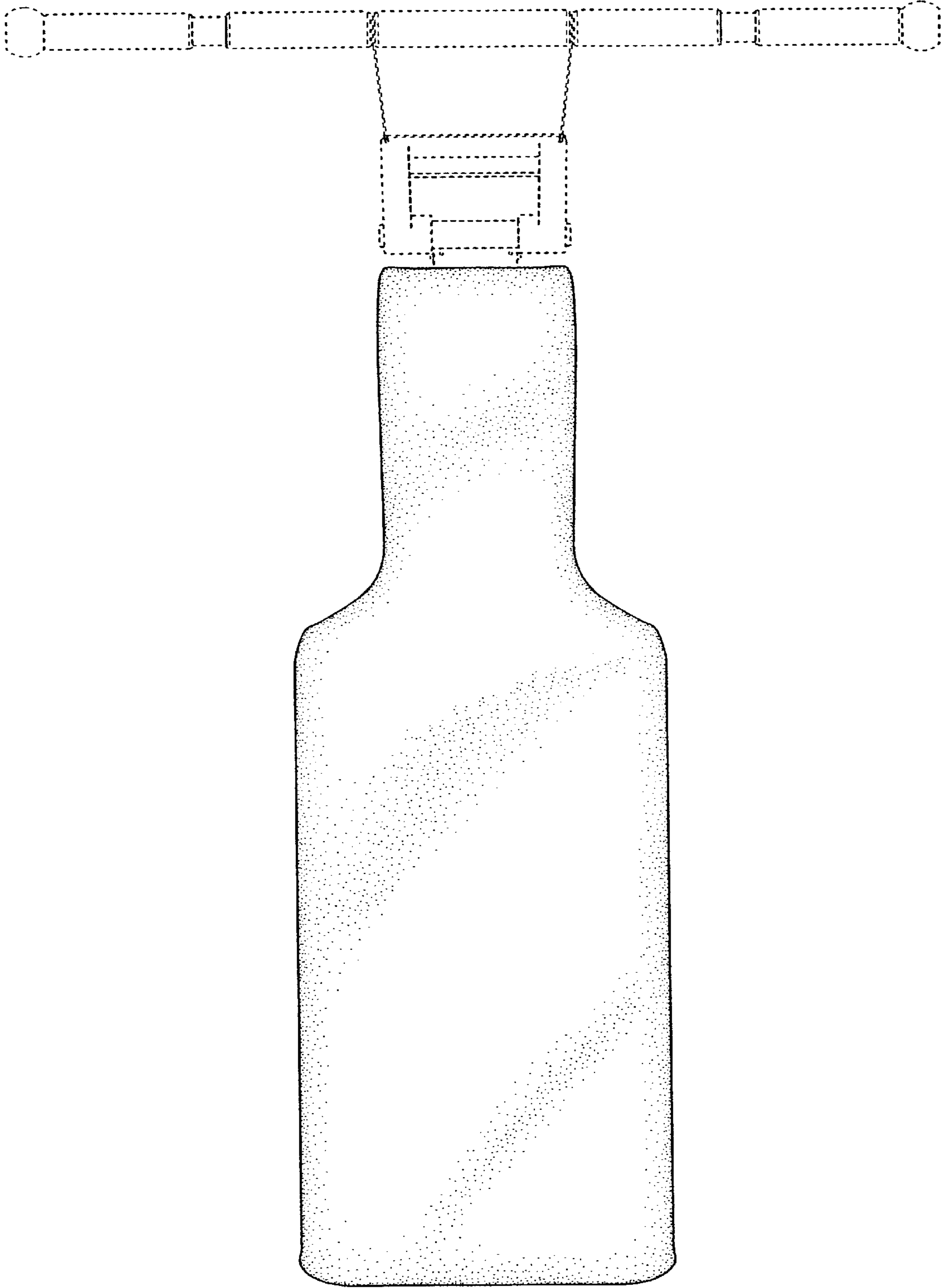

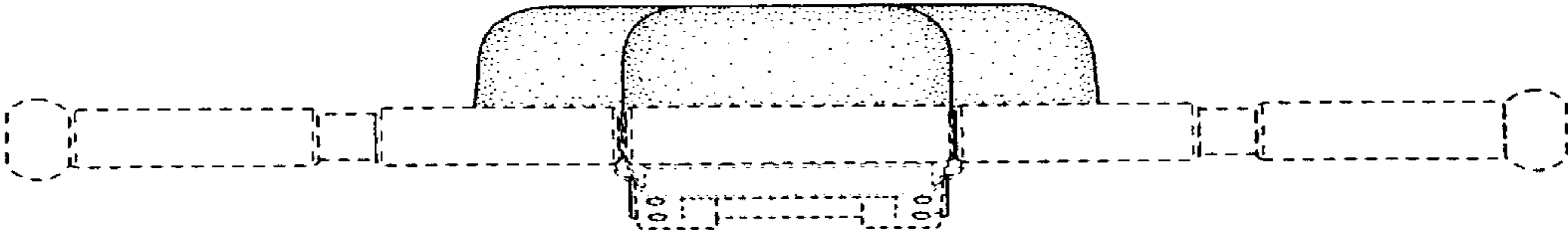

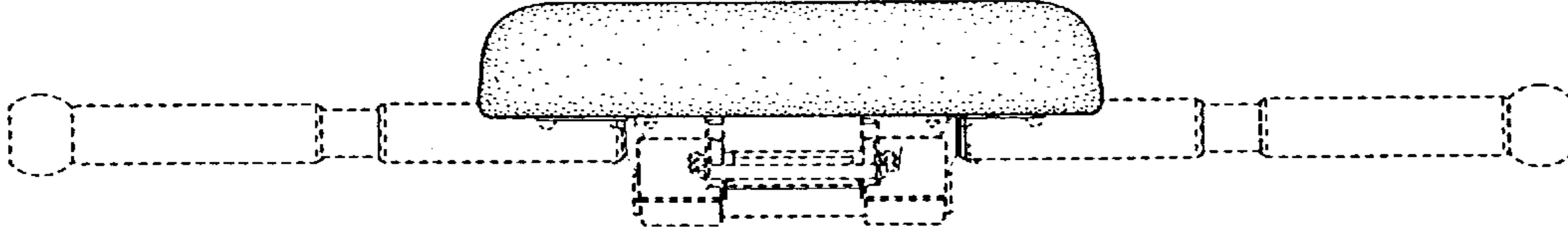
