(57) **CLAIM**

We claim the ornamental design for a golf driver head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf driver head showing

one embodiment of our new design;

FIG. 10 is a top plan view of the golf driver head shown in FIG. 8;

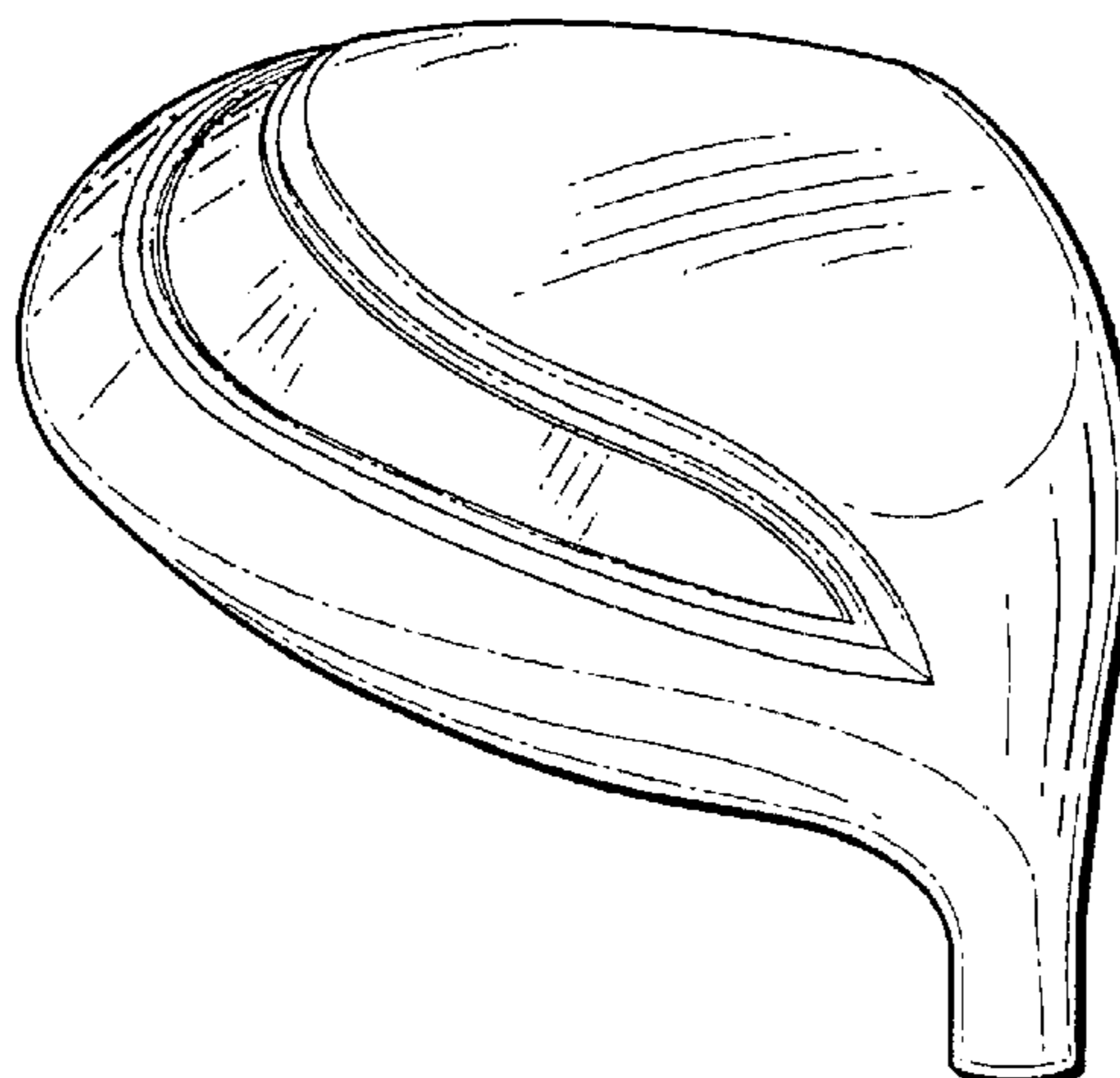
FIG. 11 is a rear elevational view of the golf driver head shown in FIG. 8;

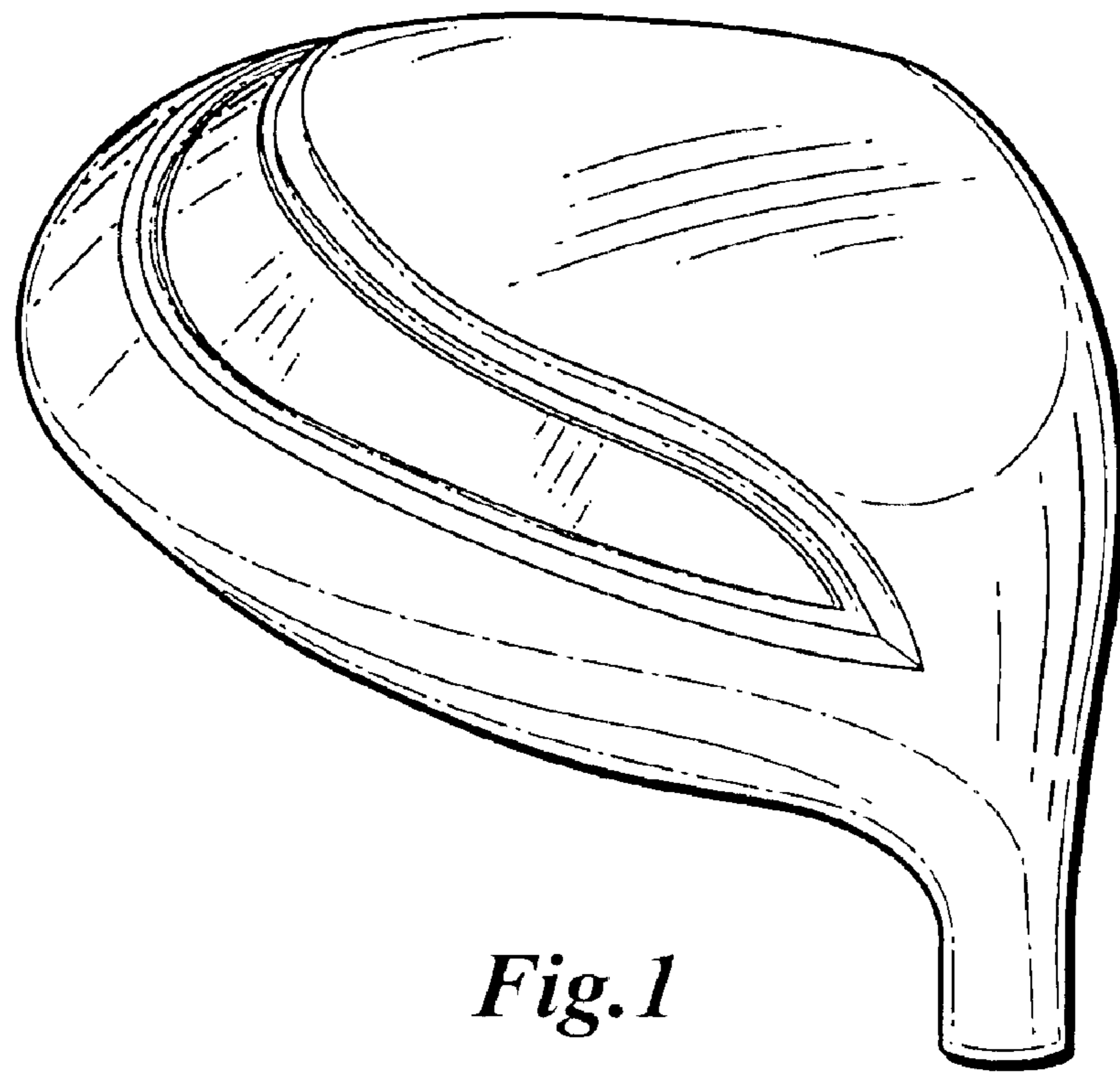
FIG. 12 is a heel end view of the golf driver head shown in FIG. 8;

FIG. 13 is a bottom view of the golf driver head shown in FIG. 8; and,

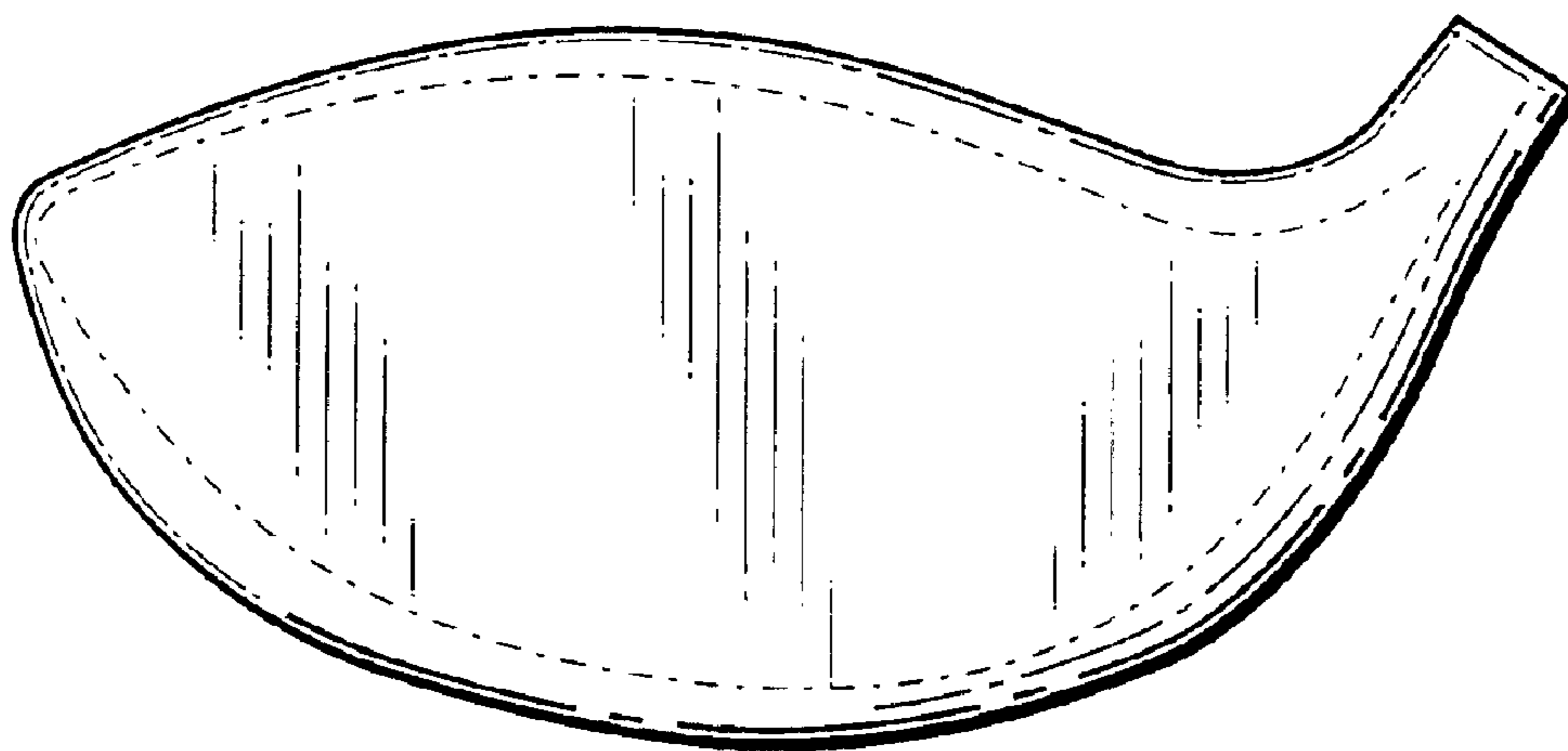
FIG. 14 is a toe end view of the golf driver head shown in FIG. 8.

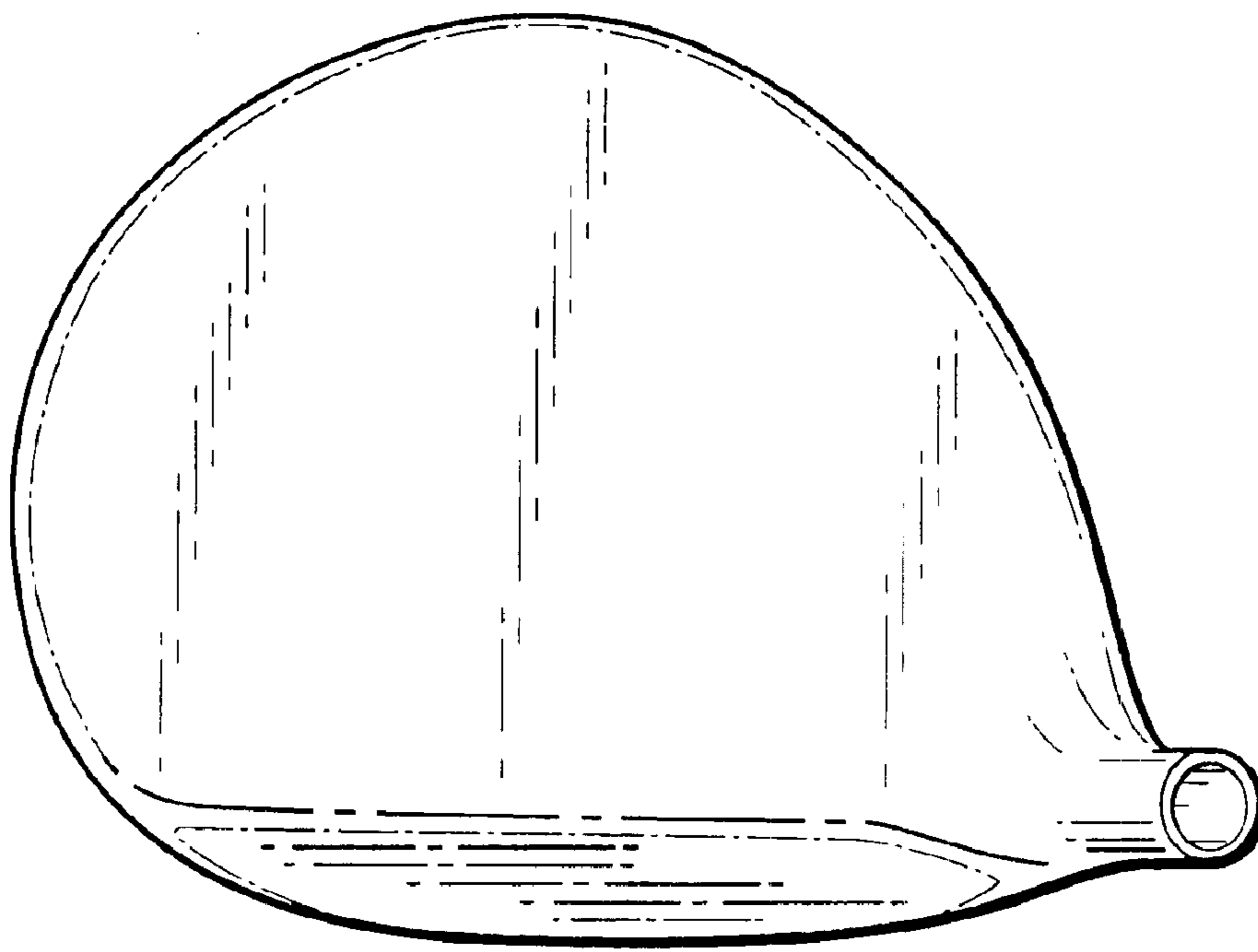




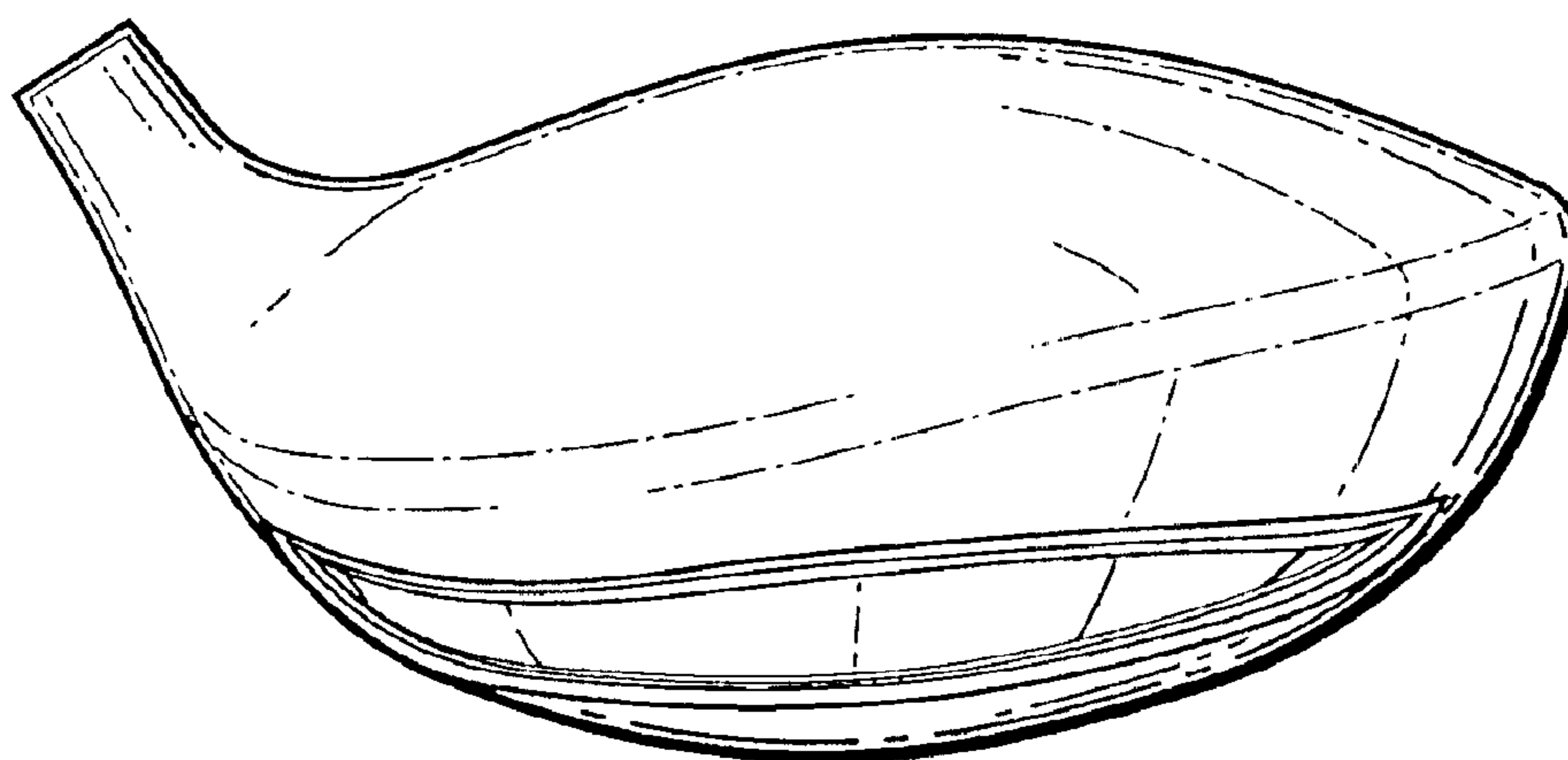

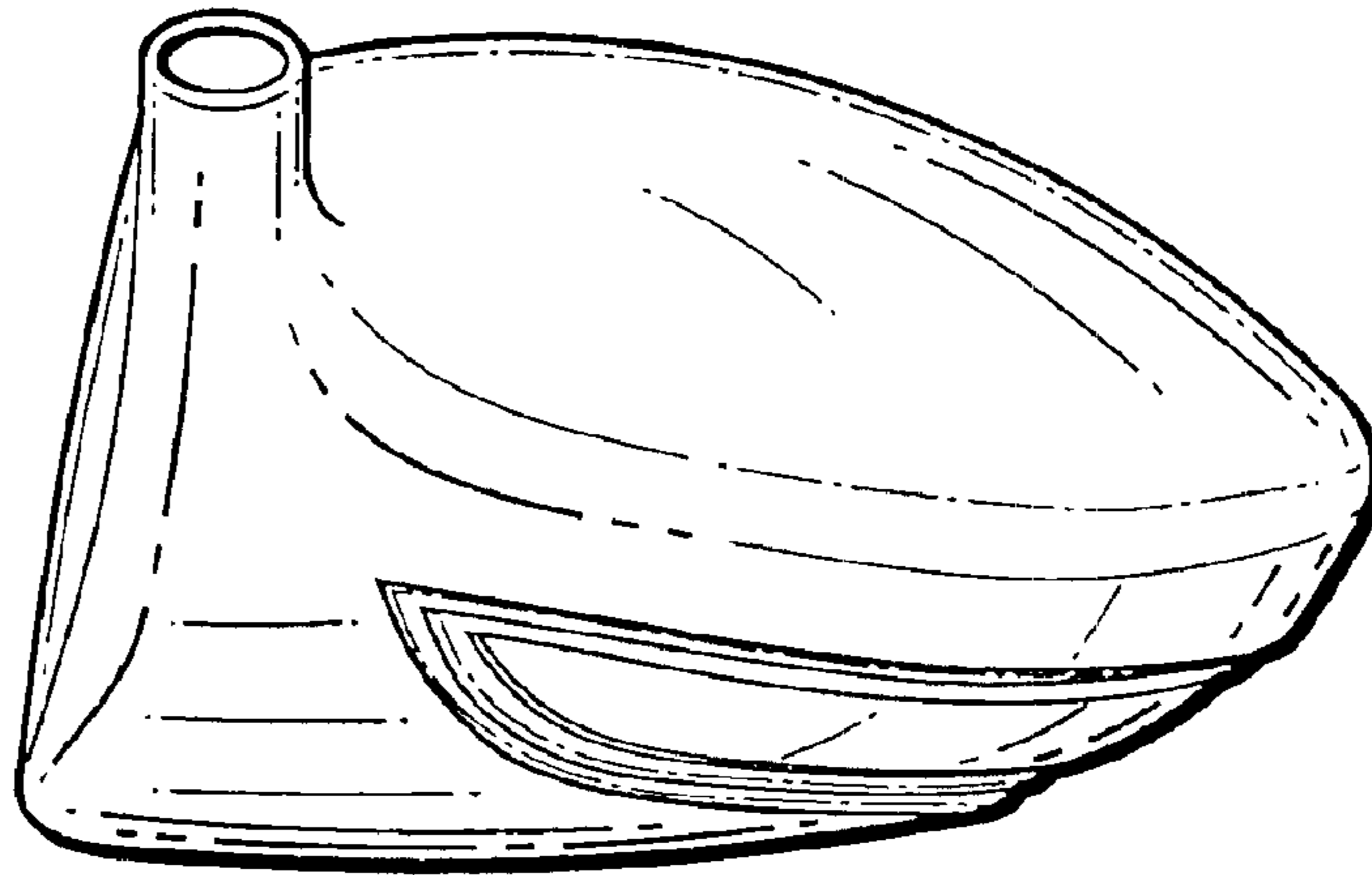

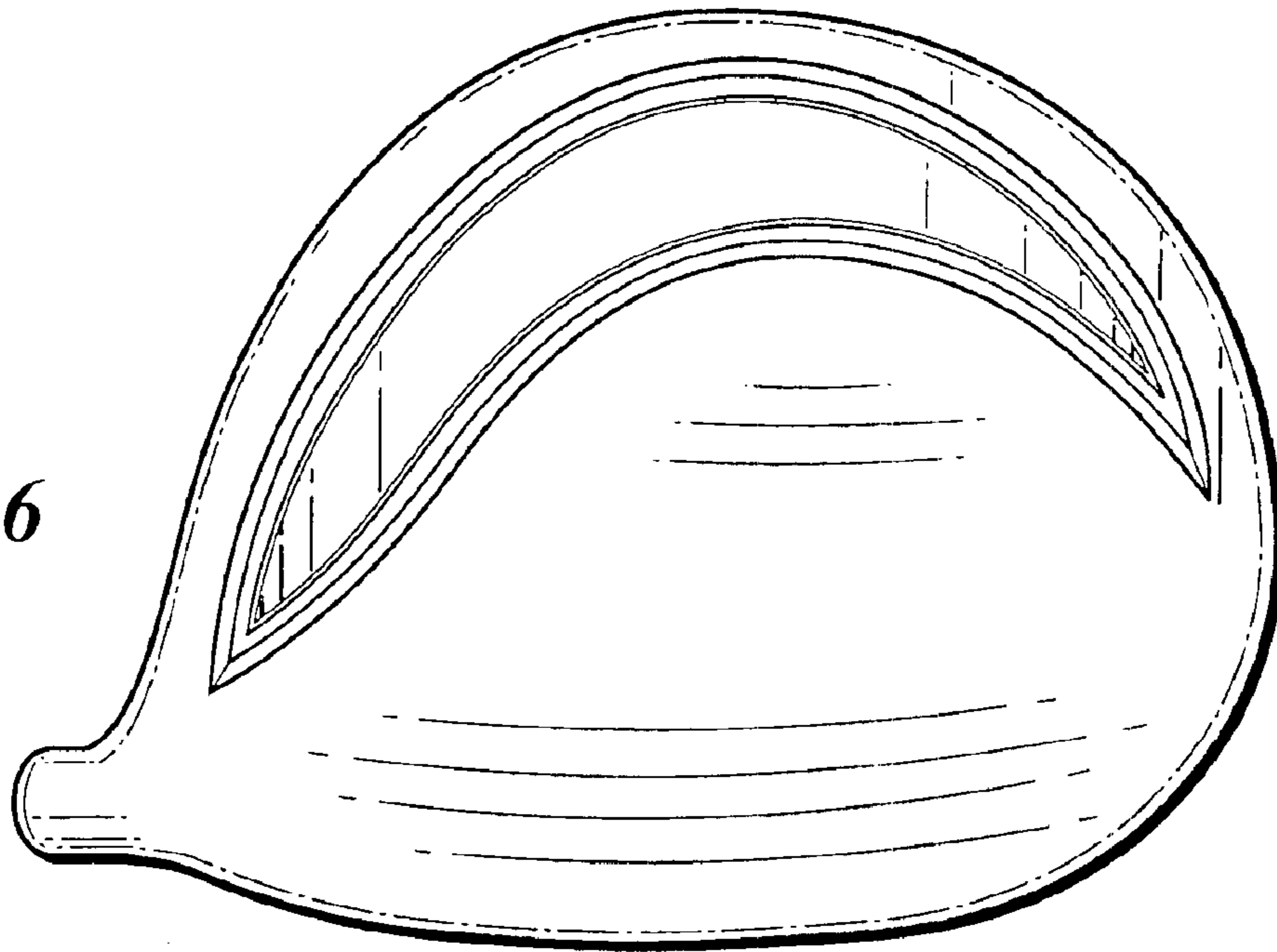

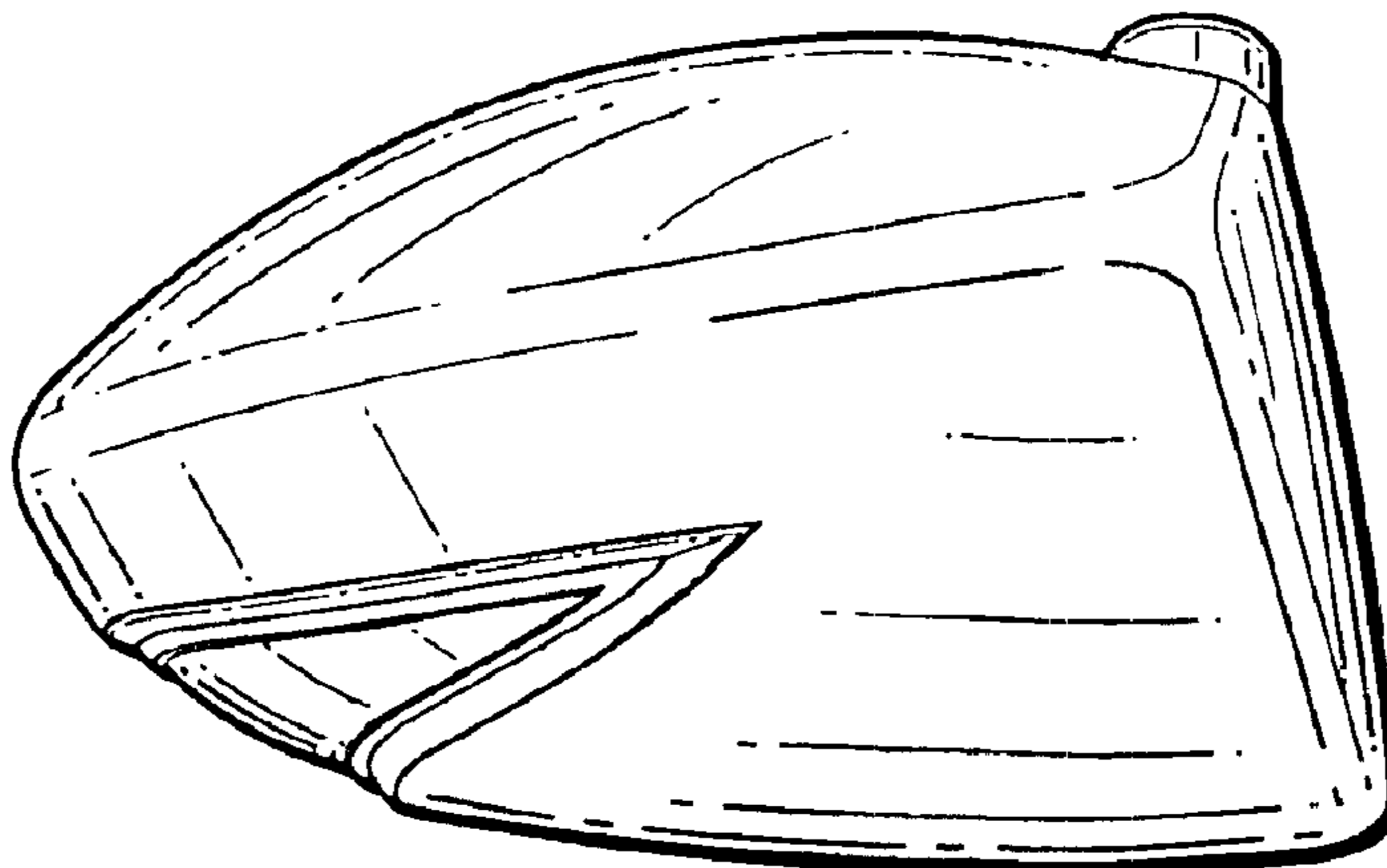

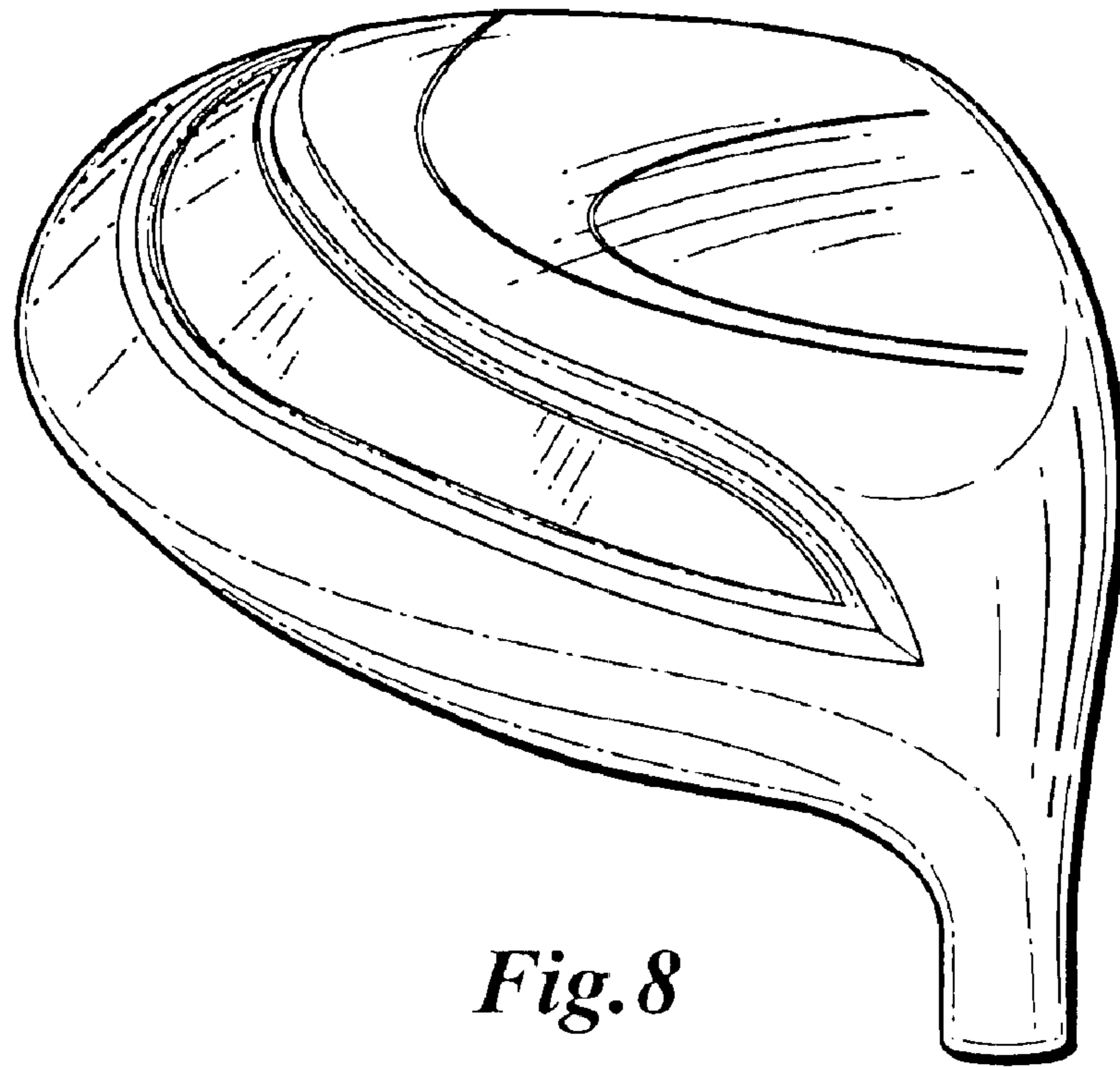

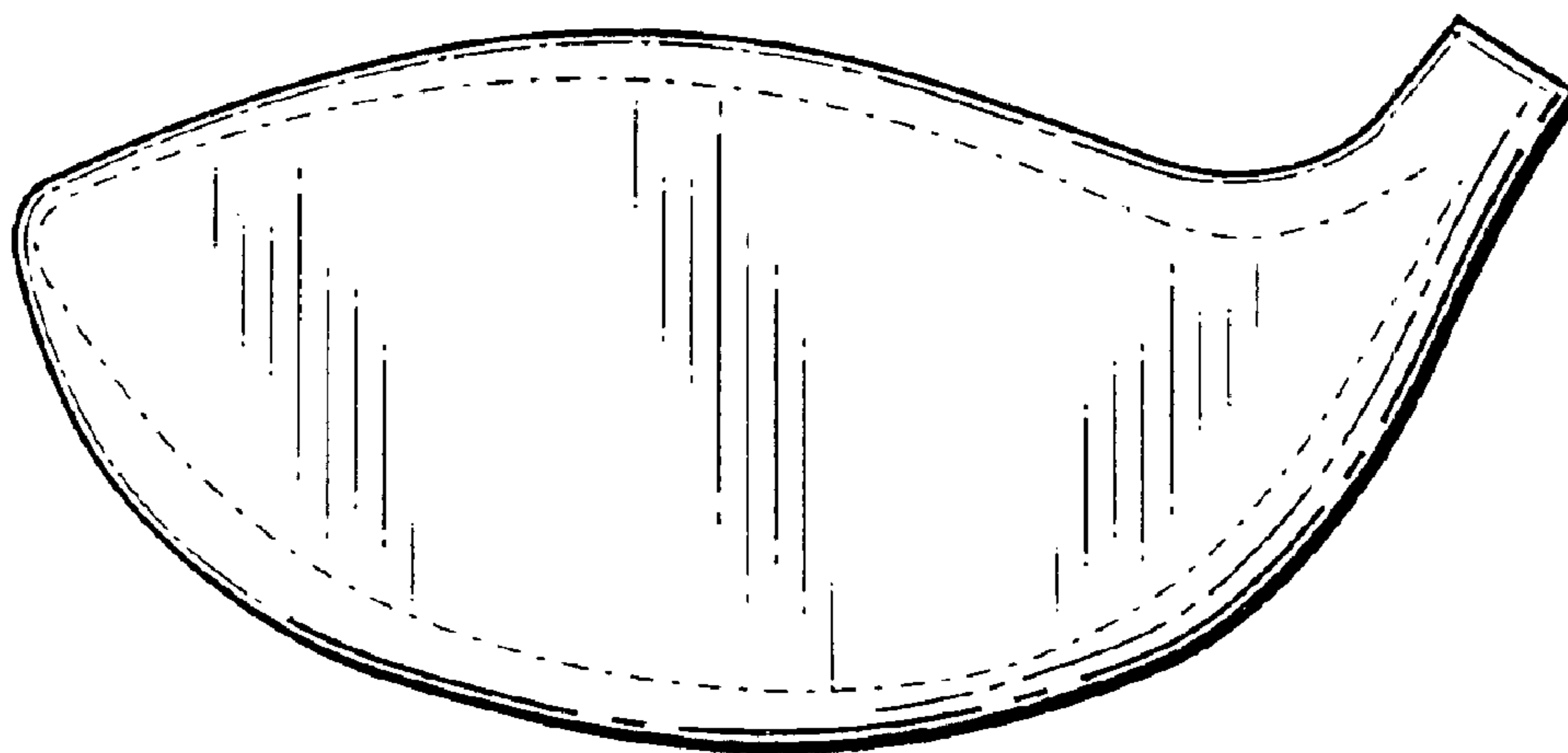

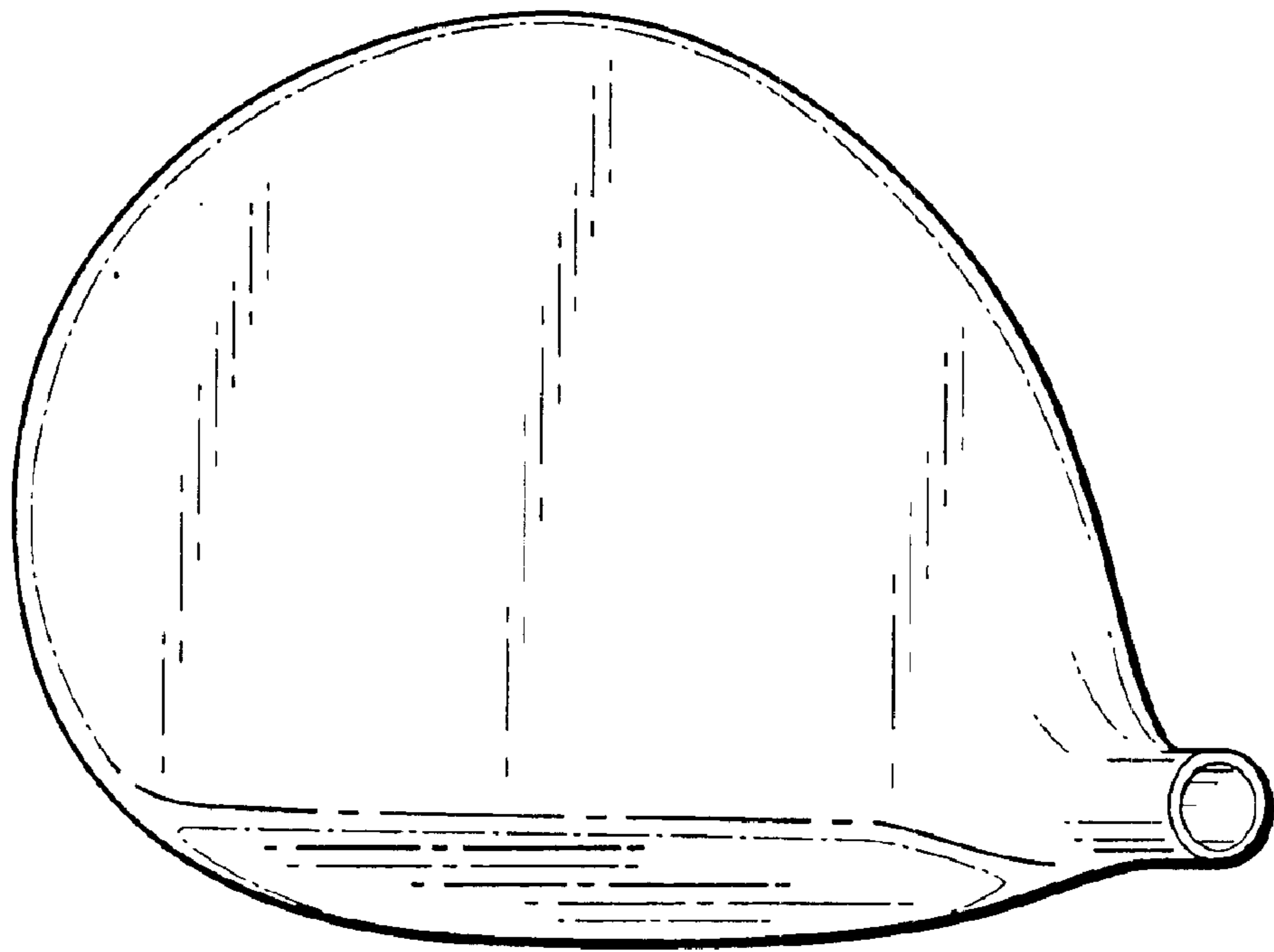




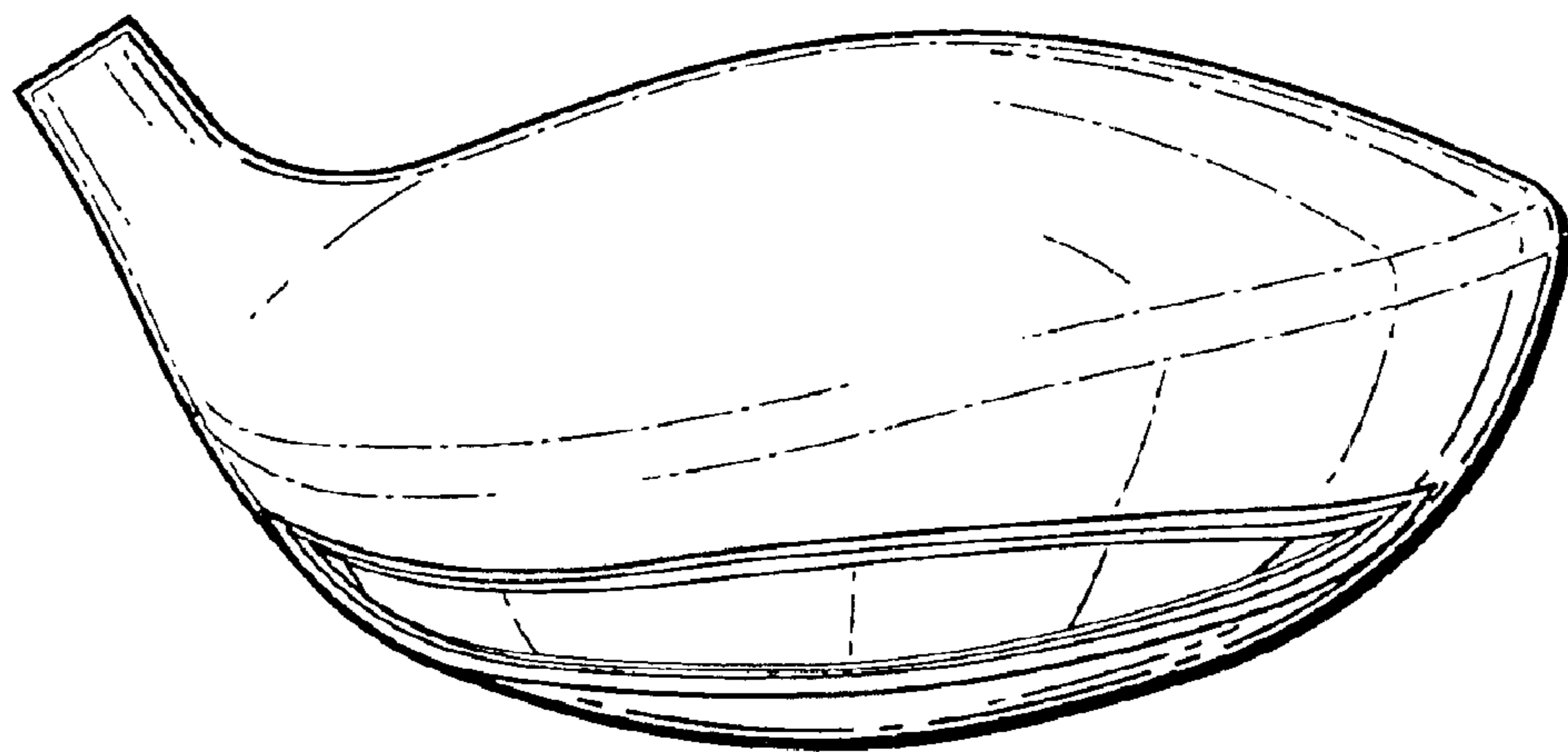

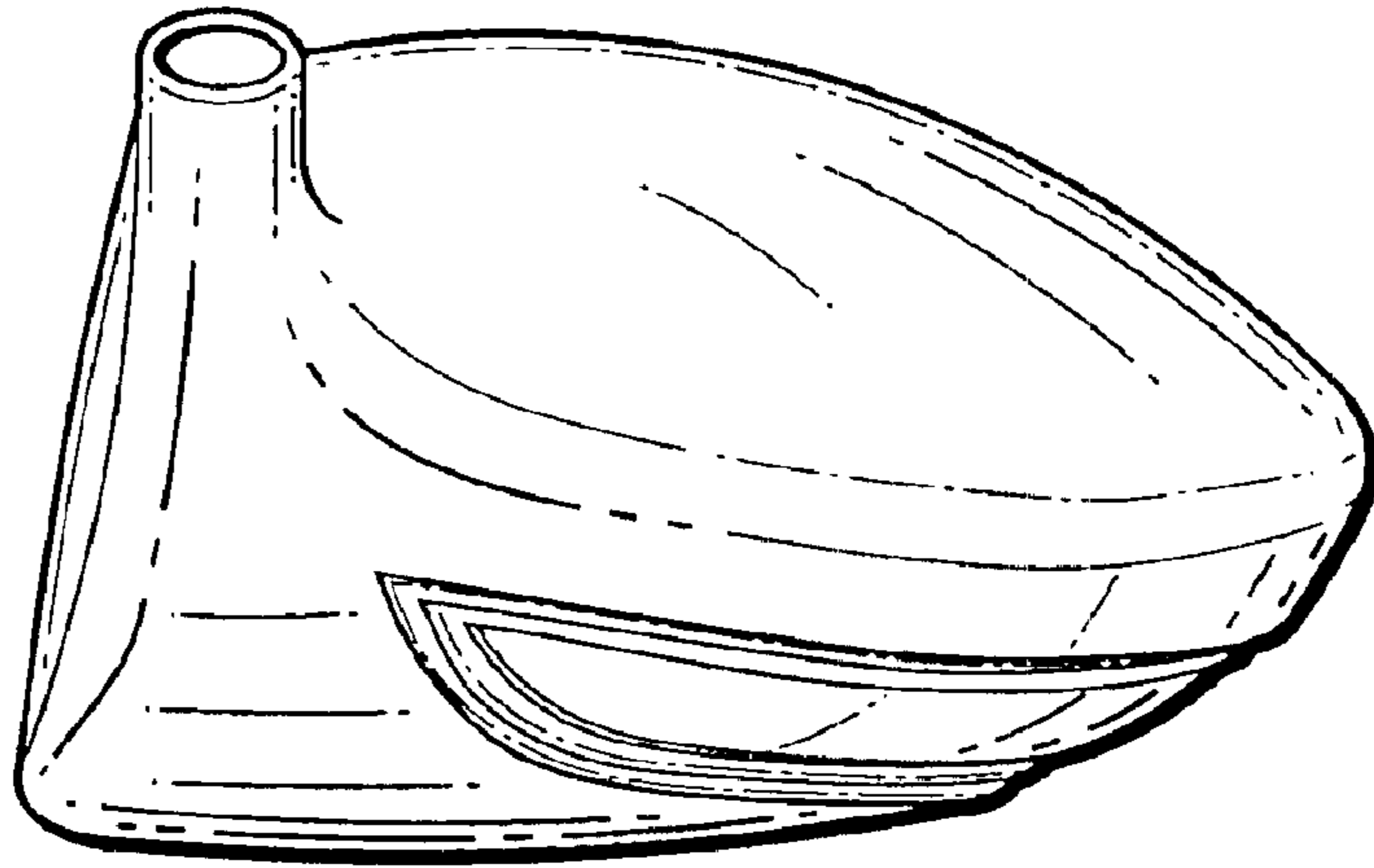

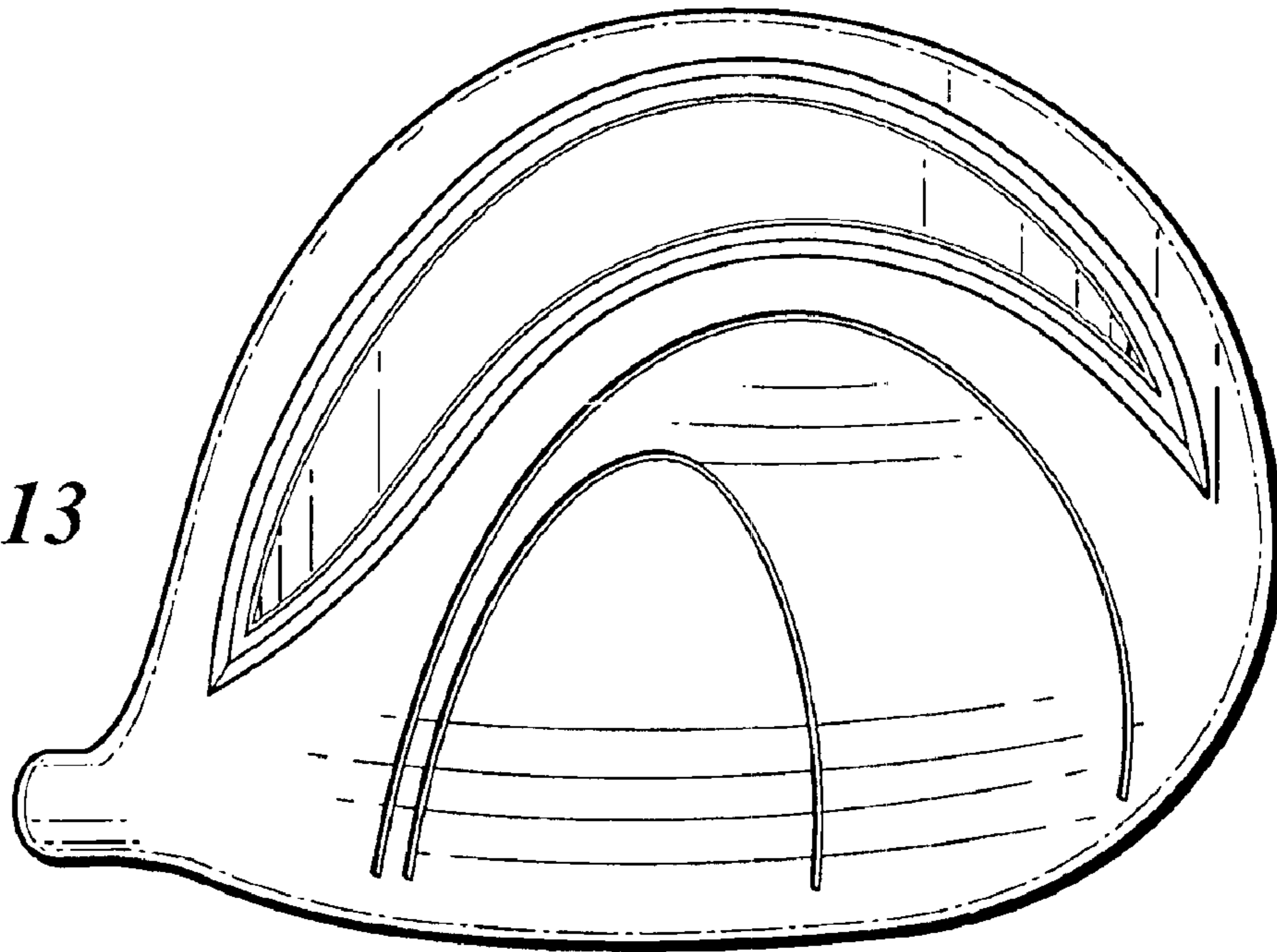
