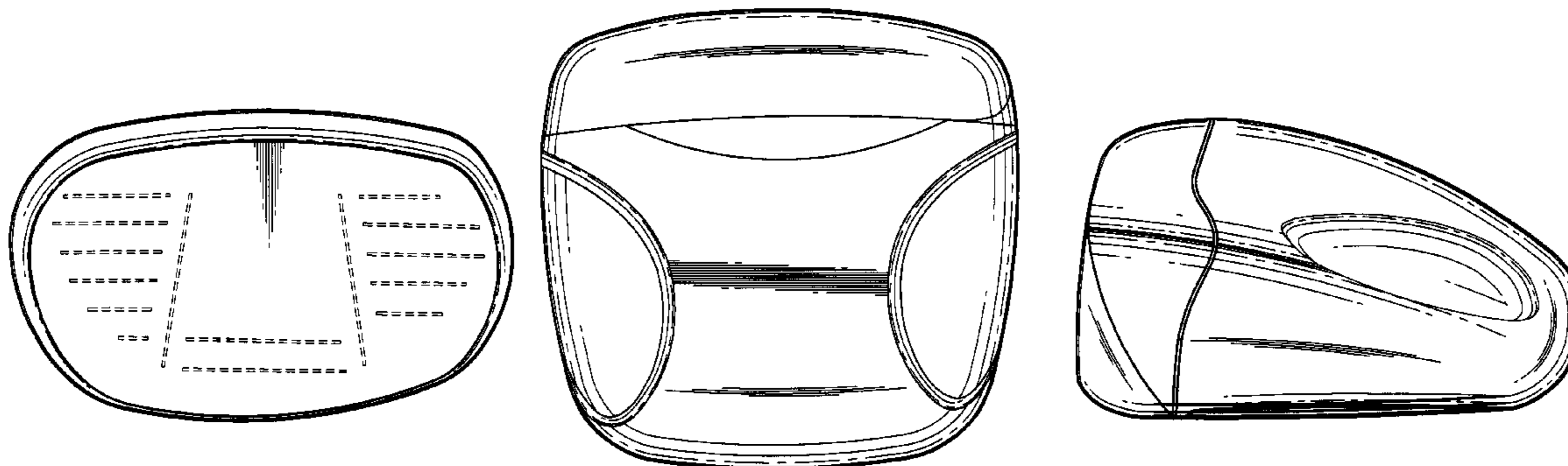

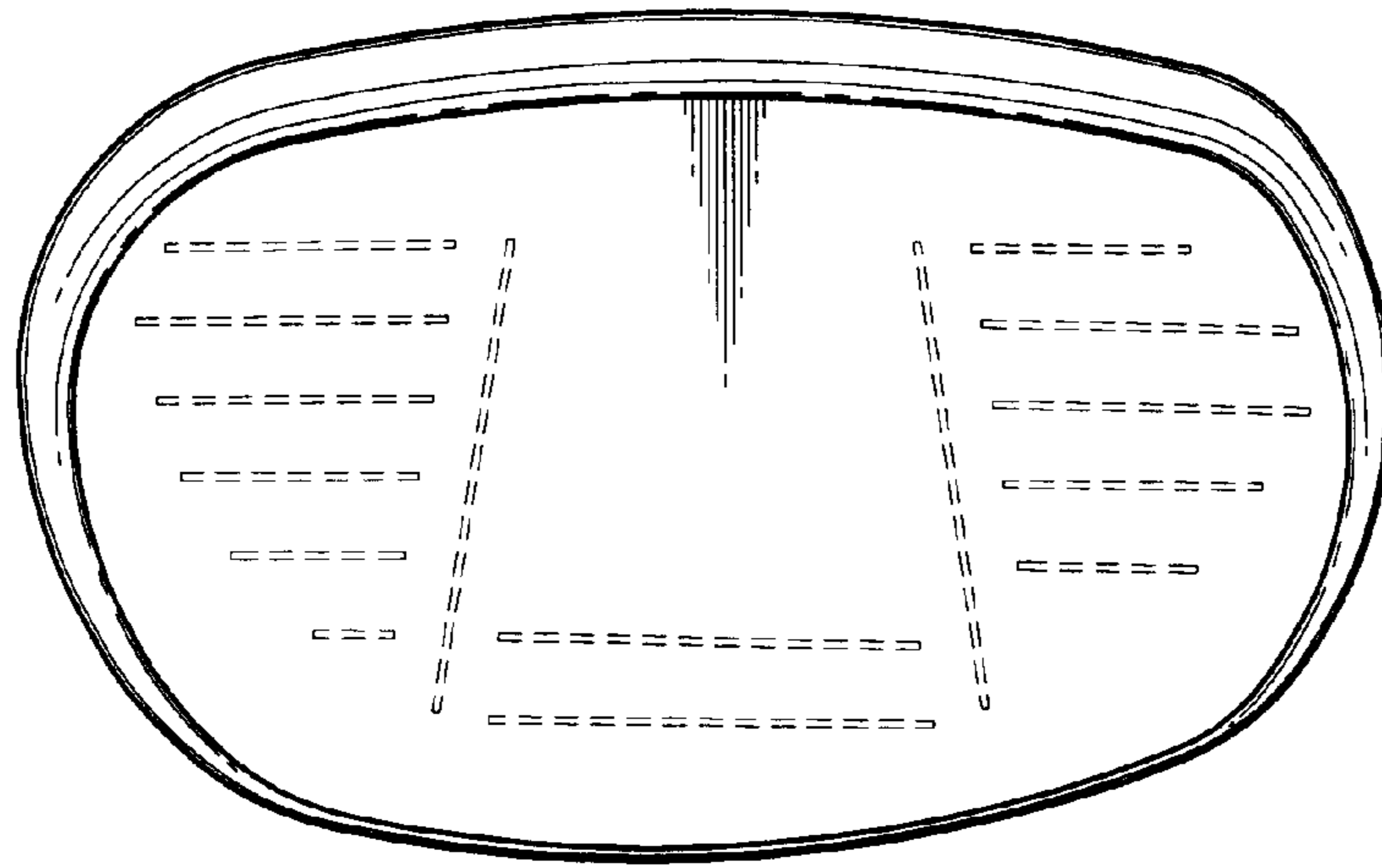
The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

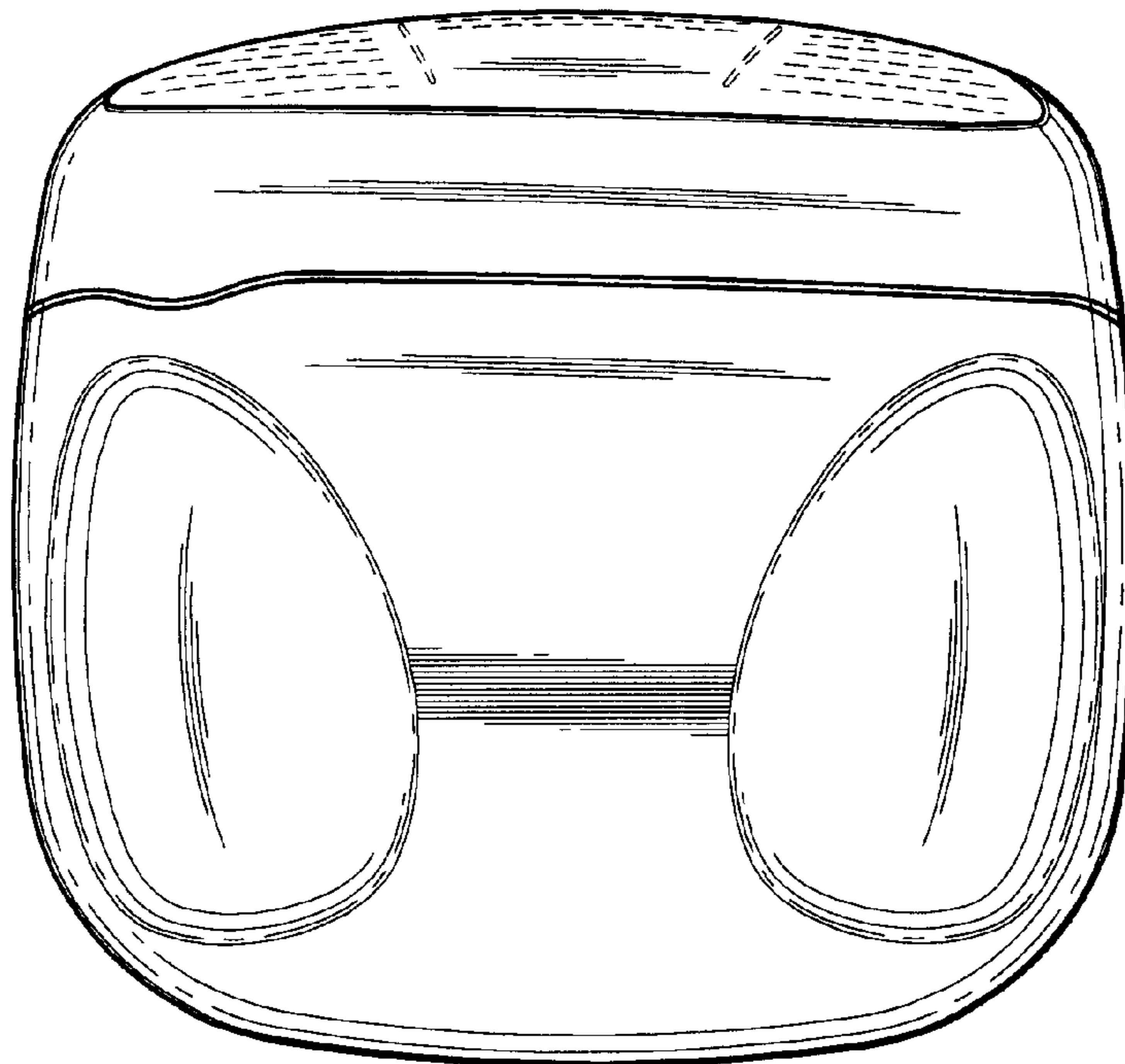
FIG. 1 is a front view thereof;

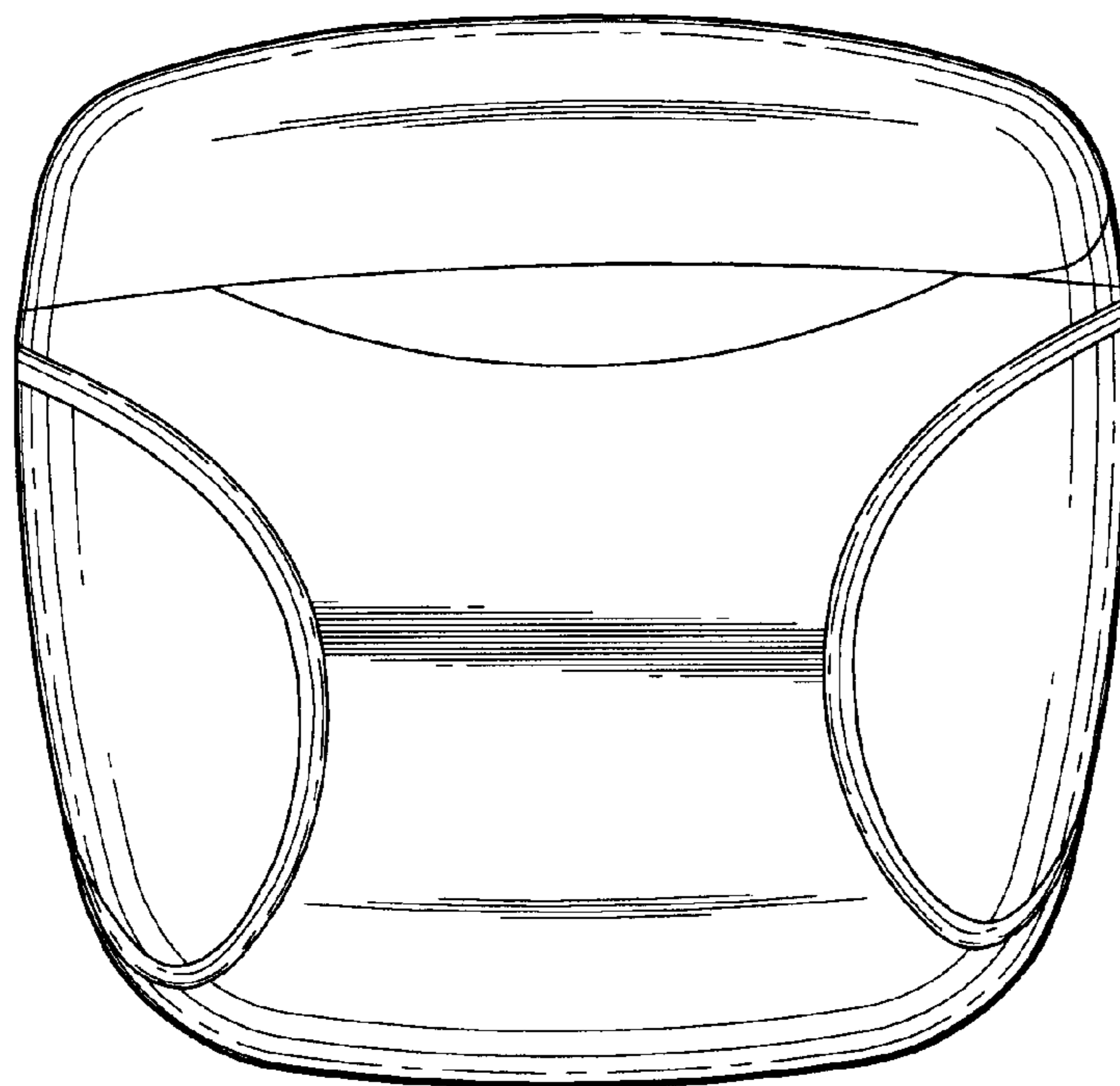




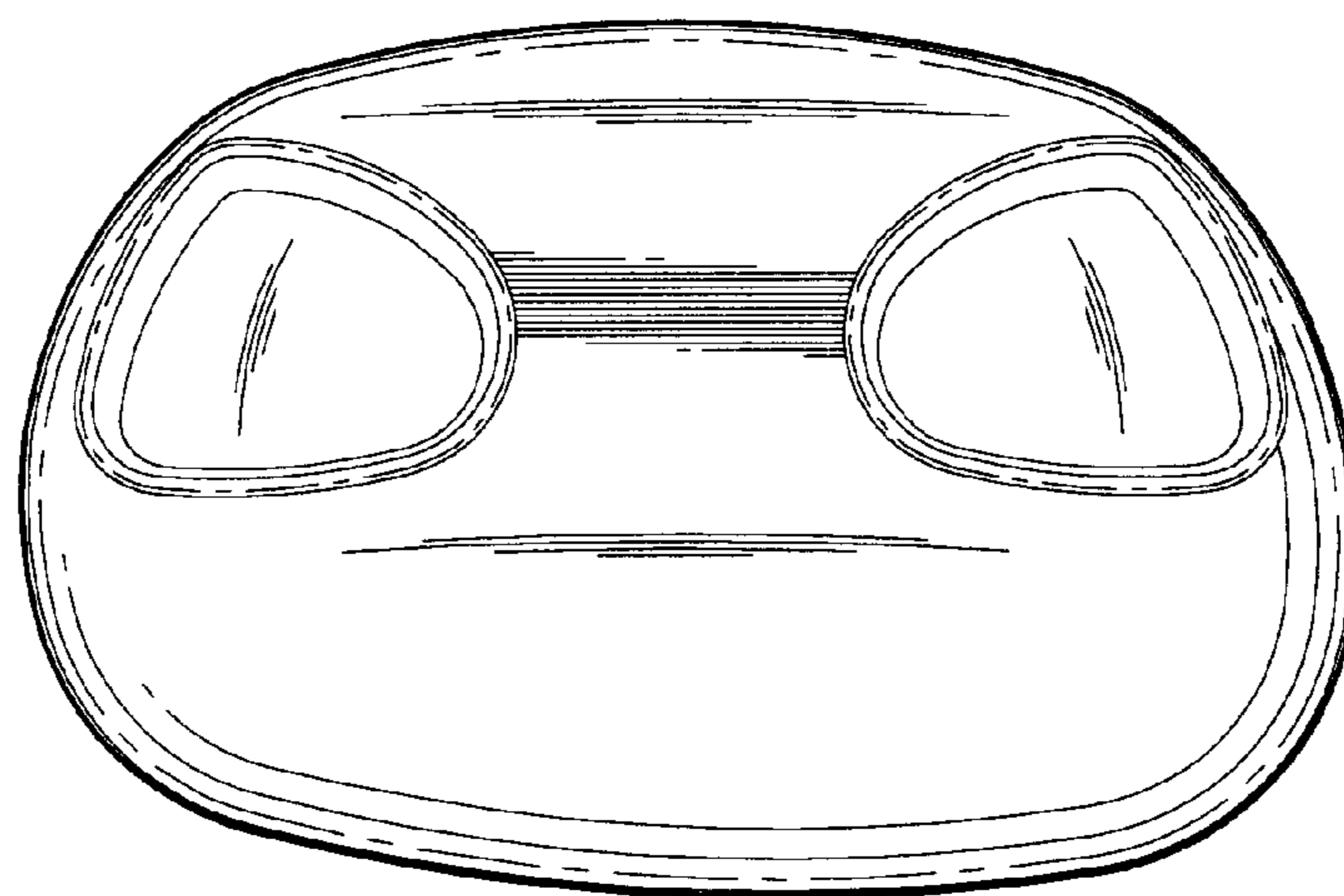

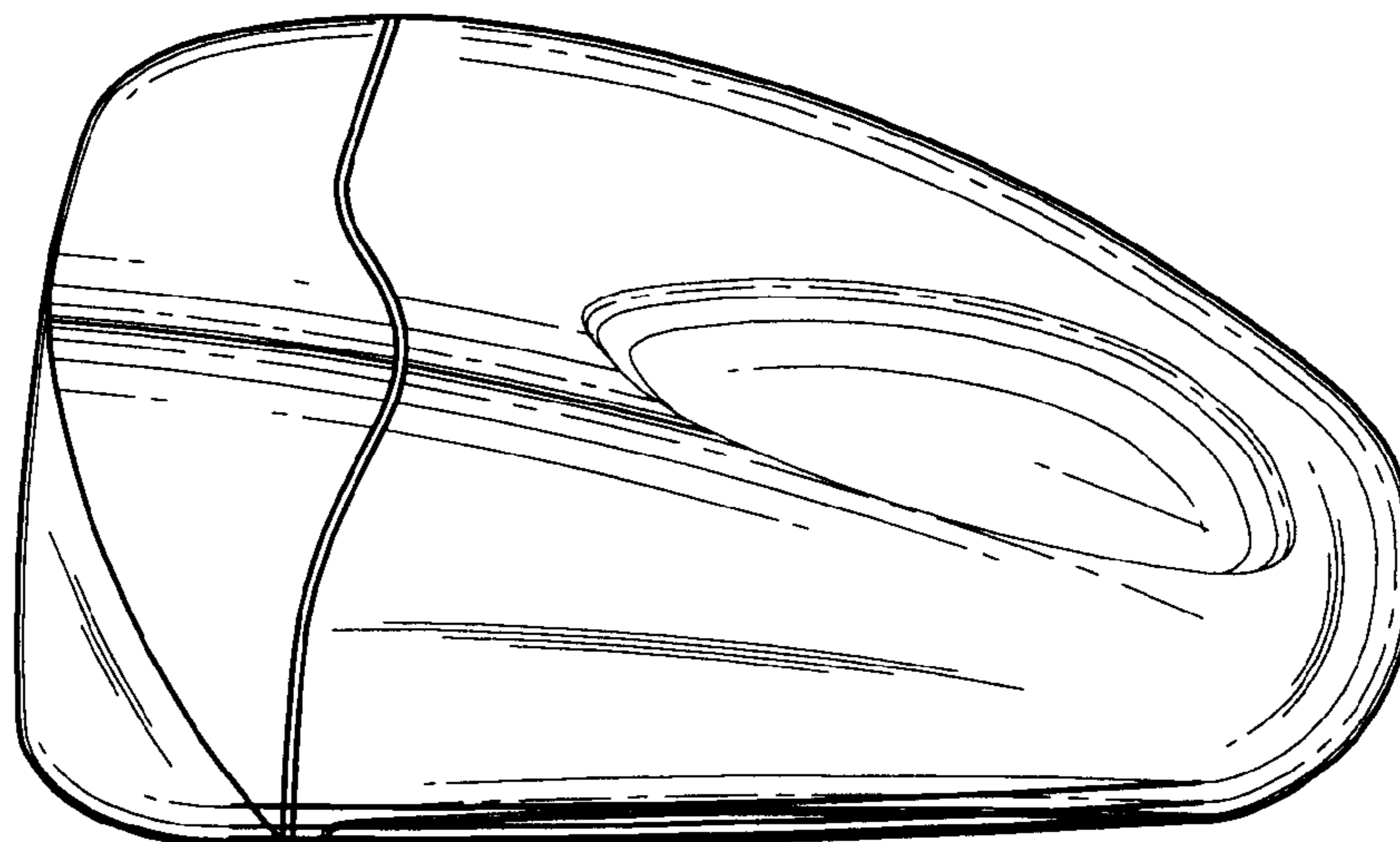

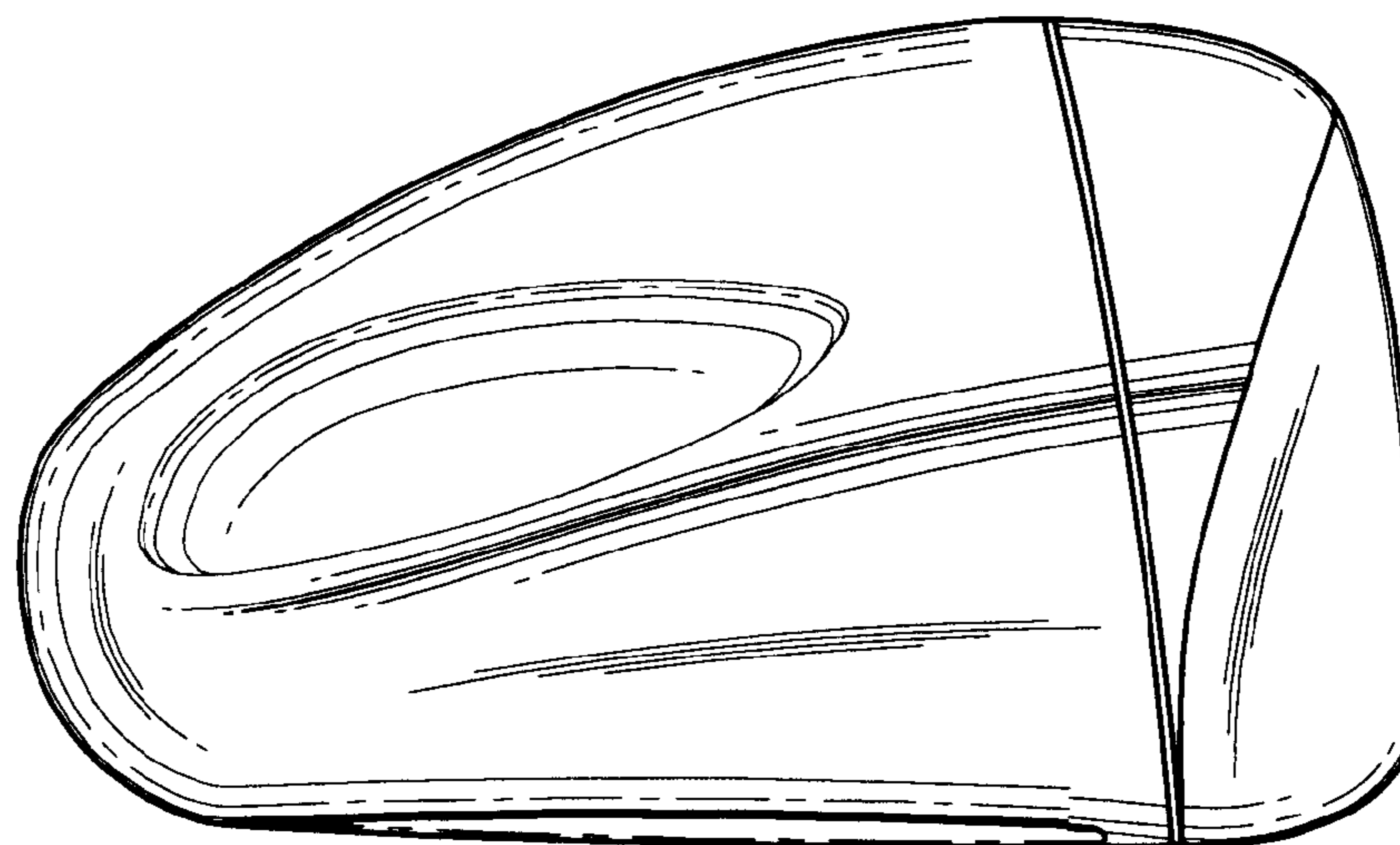
