DESCRIPTION

FIG. 3 is a top view of the new design for a faucet handle;

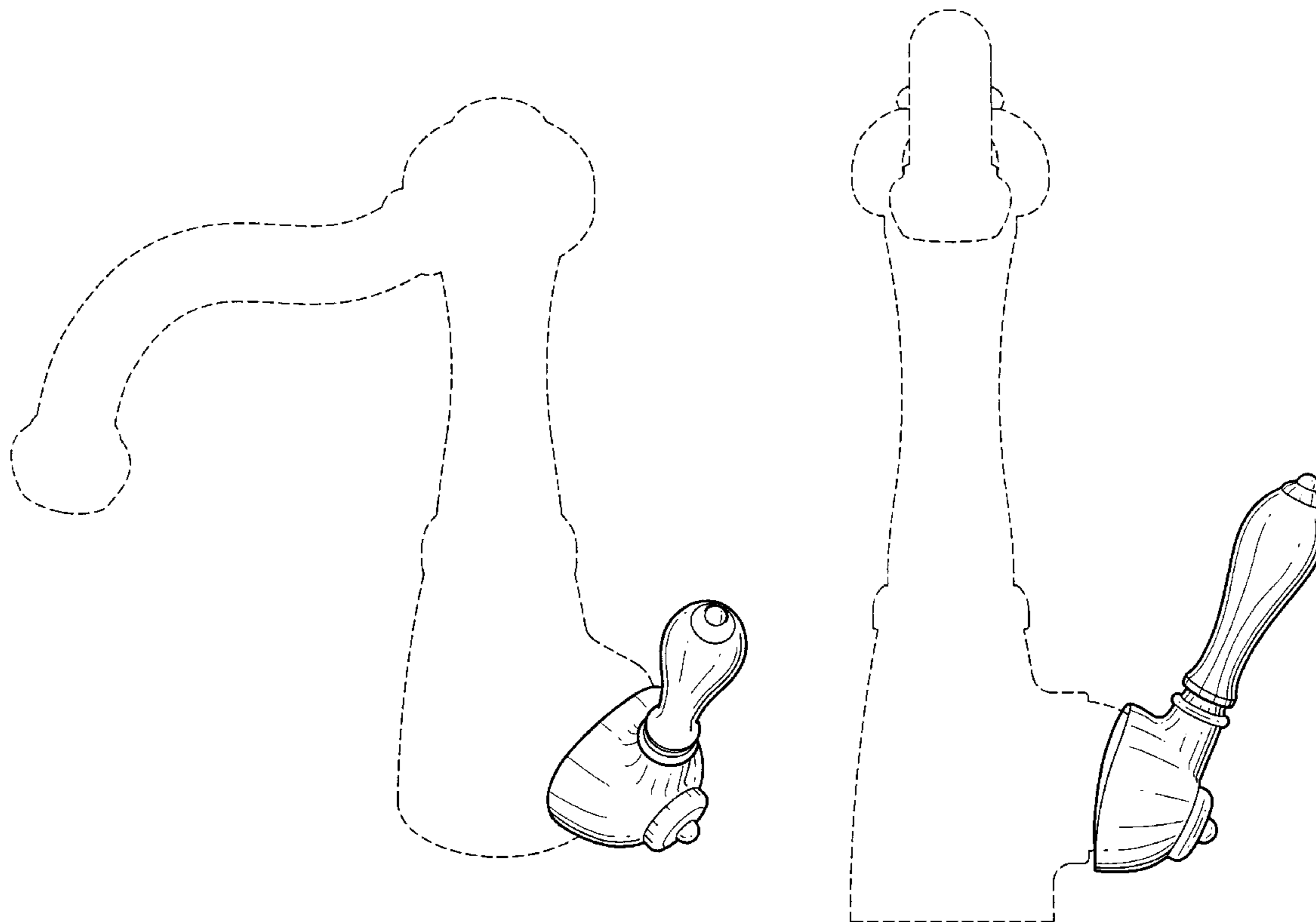
FIG. 4 is a bottom view of the new design for a faucet handle;

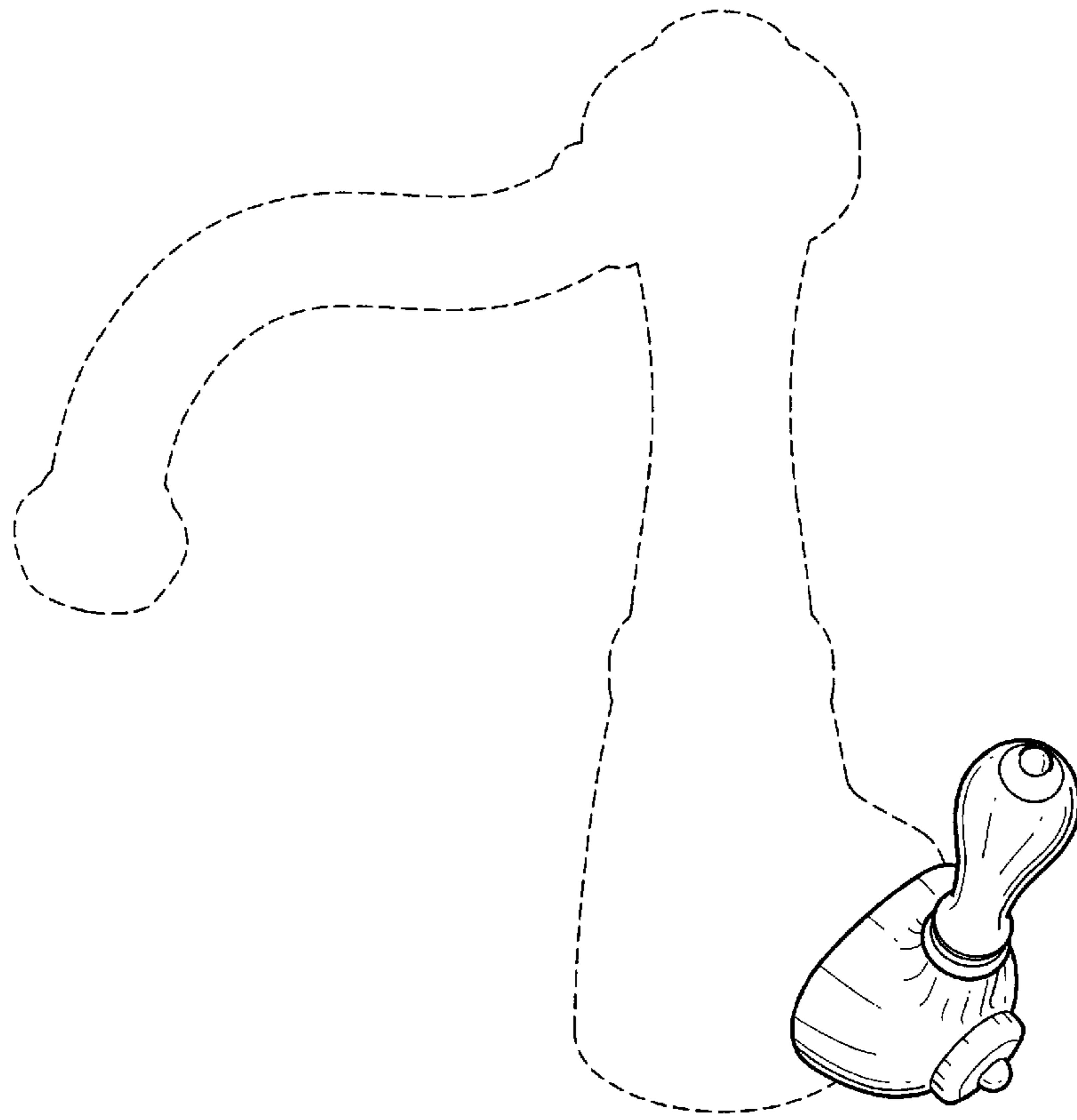

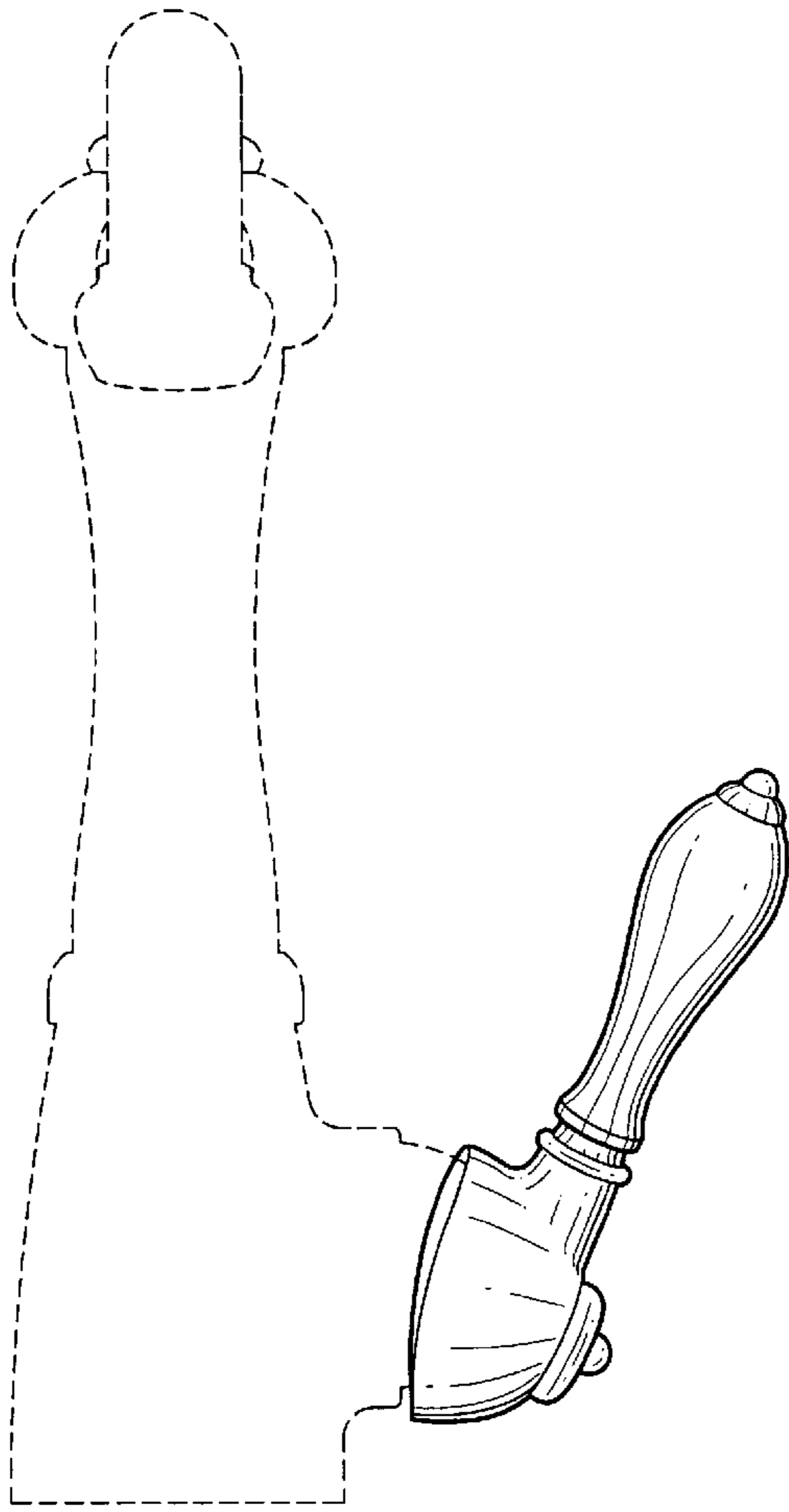

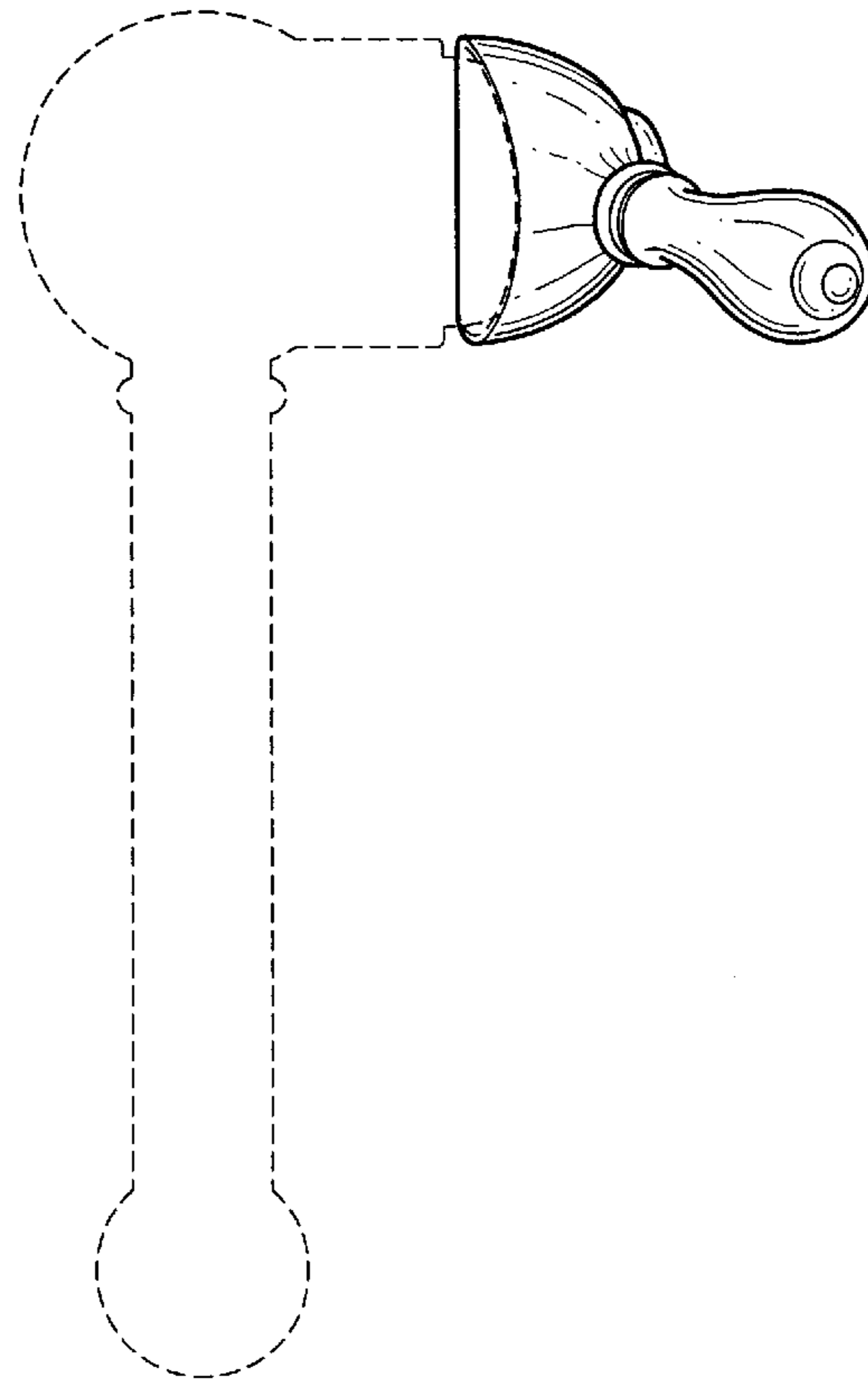

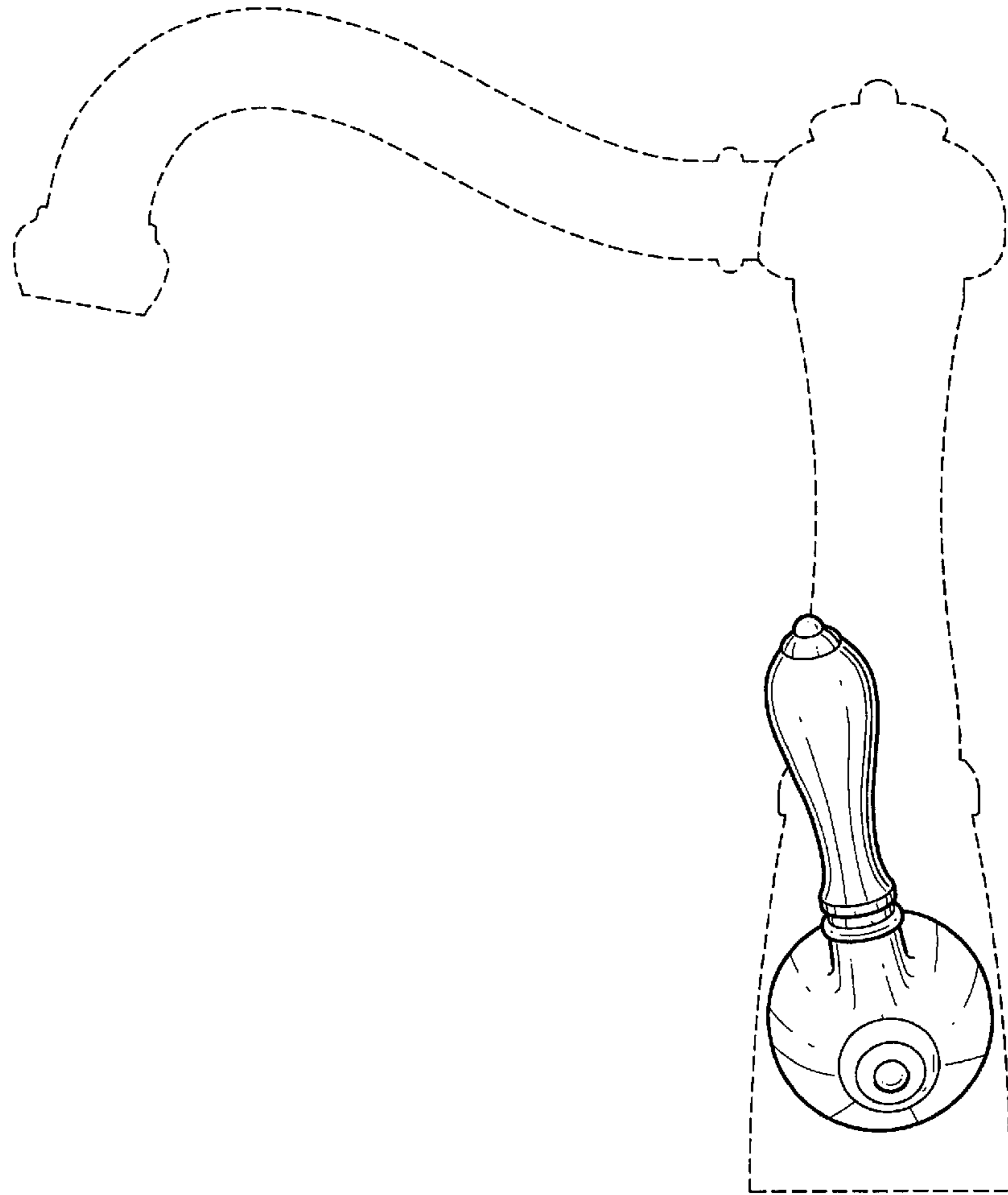

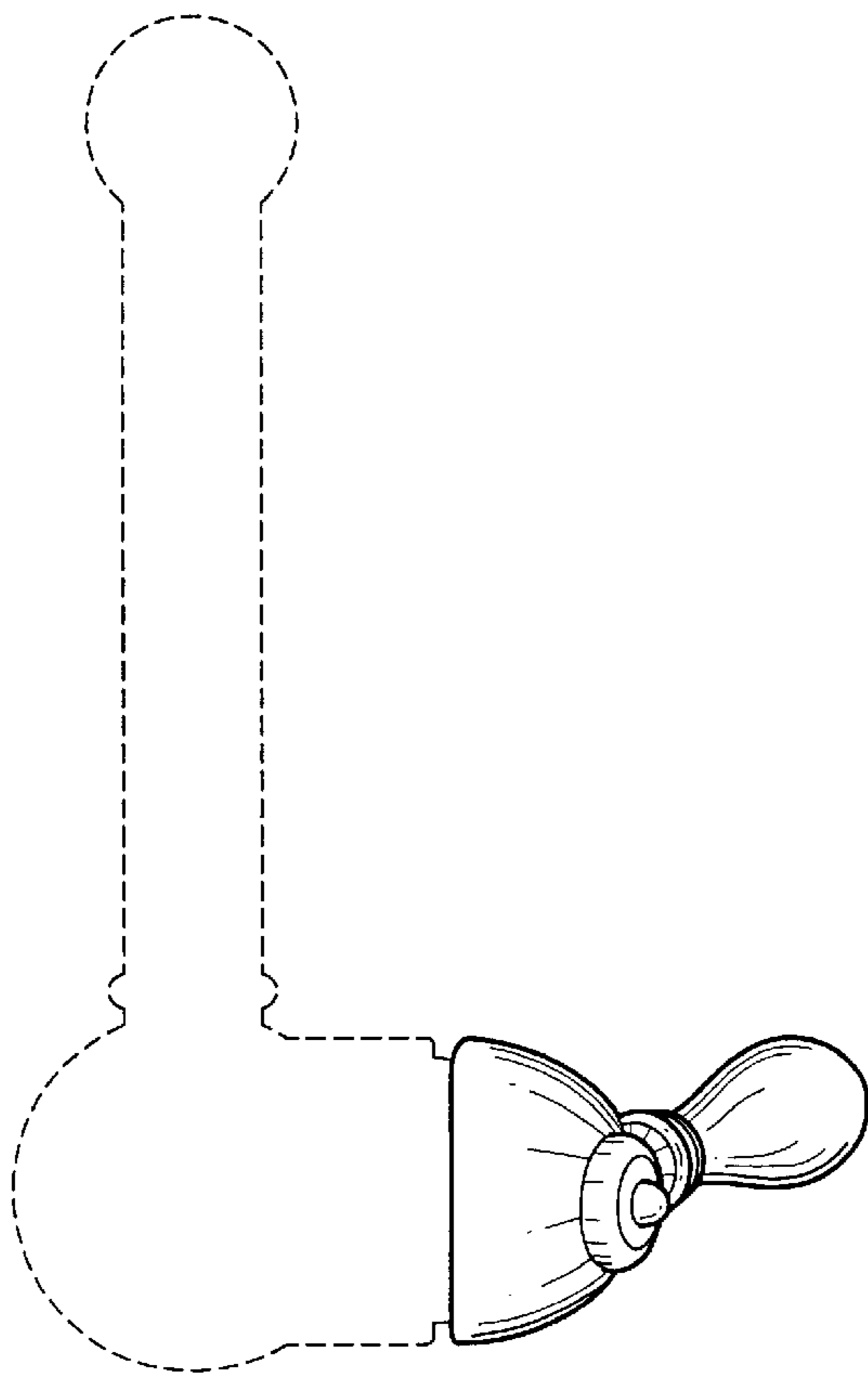

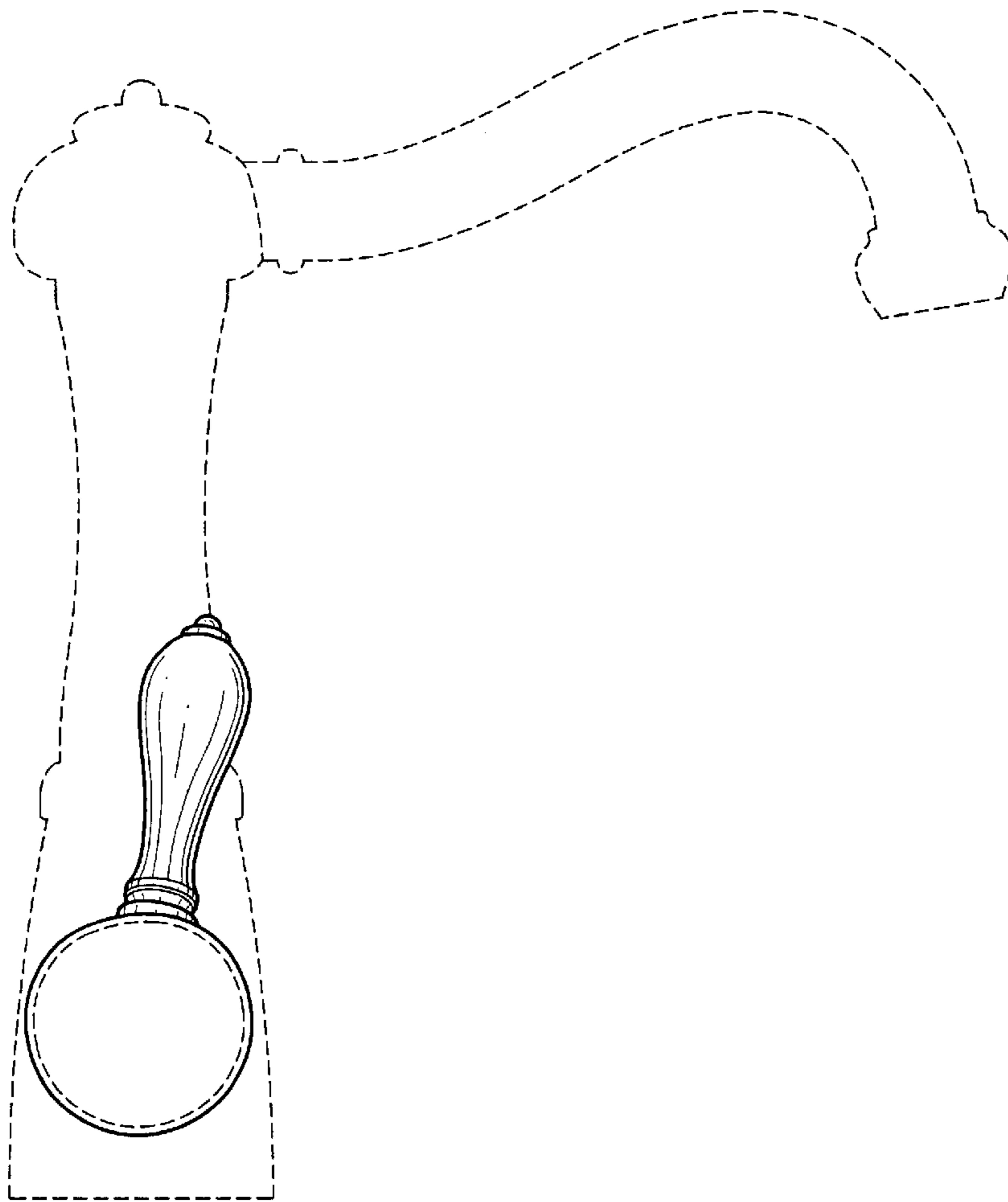
