(57) **CLAIM**

The ornamental design for a combination ceiling fan and light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of a combination ceiling fan and light fixture in accordance with my design; FIG. 2 is a top plan view of the combination ceiling fan and light fixture in accordance with my design;

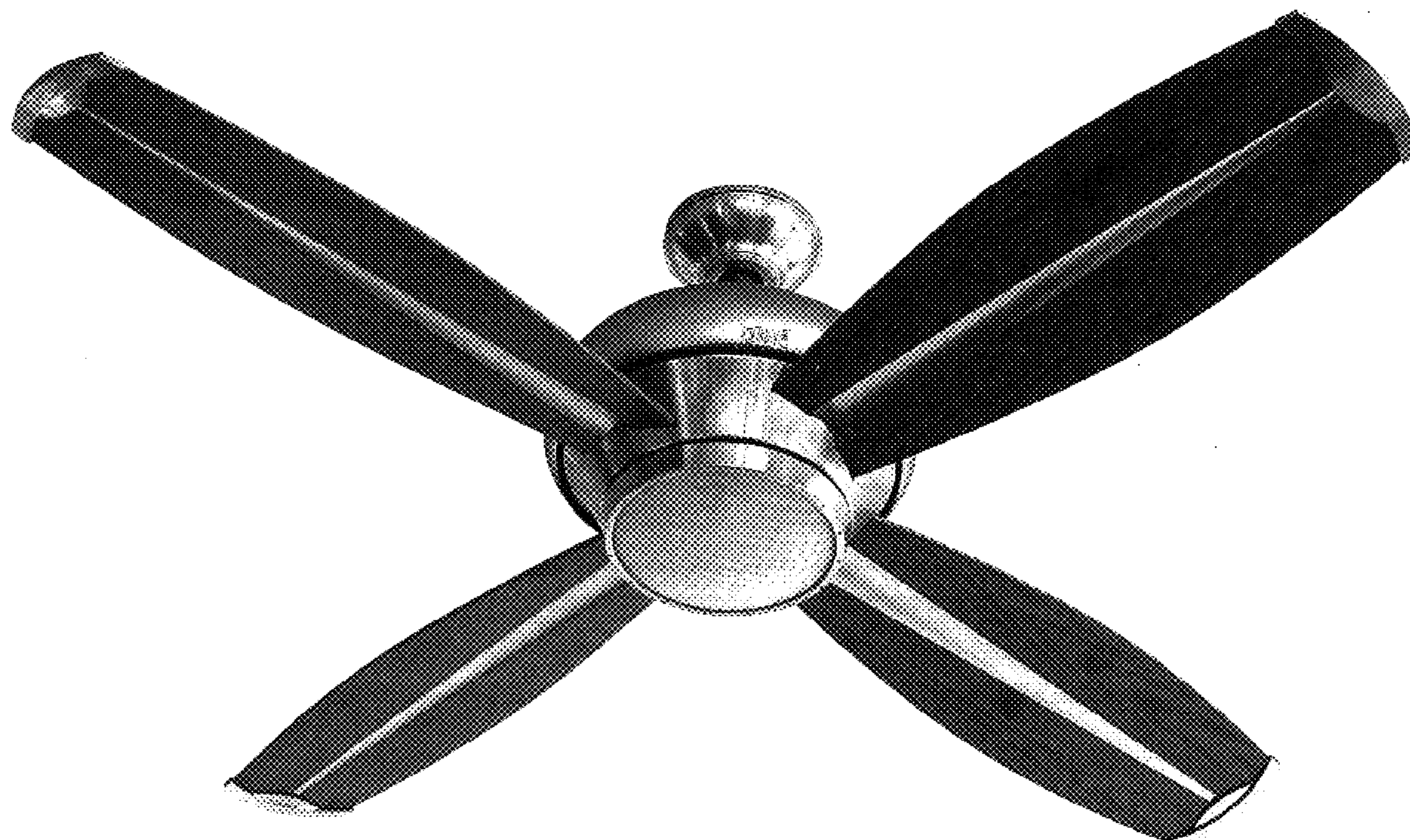
FIG. 3 is a bottom plan view of the combination ceiling fan and light fixture in accordance with my design;

FIG. 4 is a front elevation view of the combination ceiling fan and light fixture in accordance with my design; and,

FIG. 5 is an enlarged side elevation view of the combination ceiling fan and light fixture in accordance with my design the opposite side being substantially identical to that shown except for the position of the fan blades.

FIGS. 4 and 5 are identical except for the positioning of the fan blades.

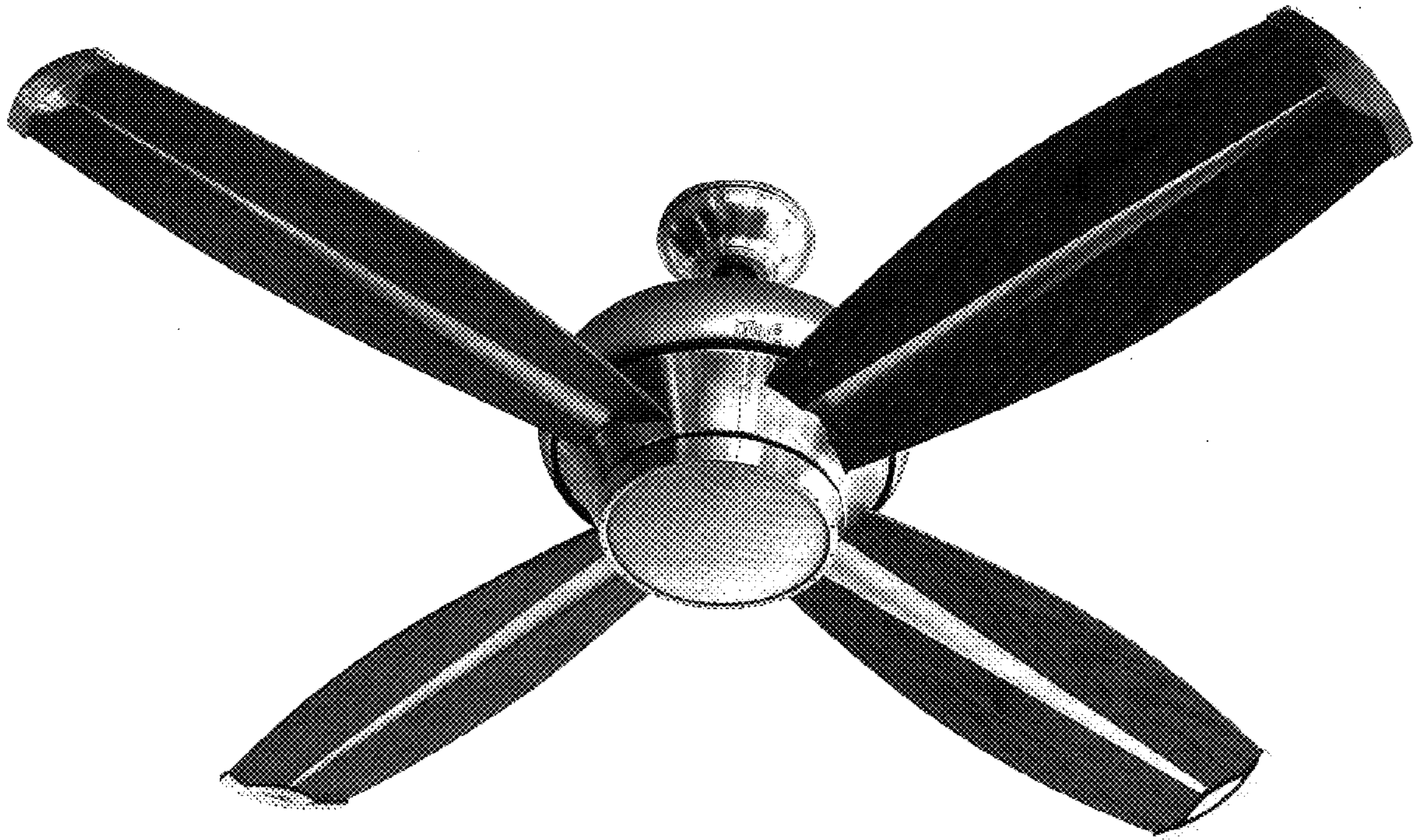

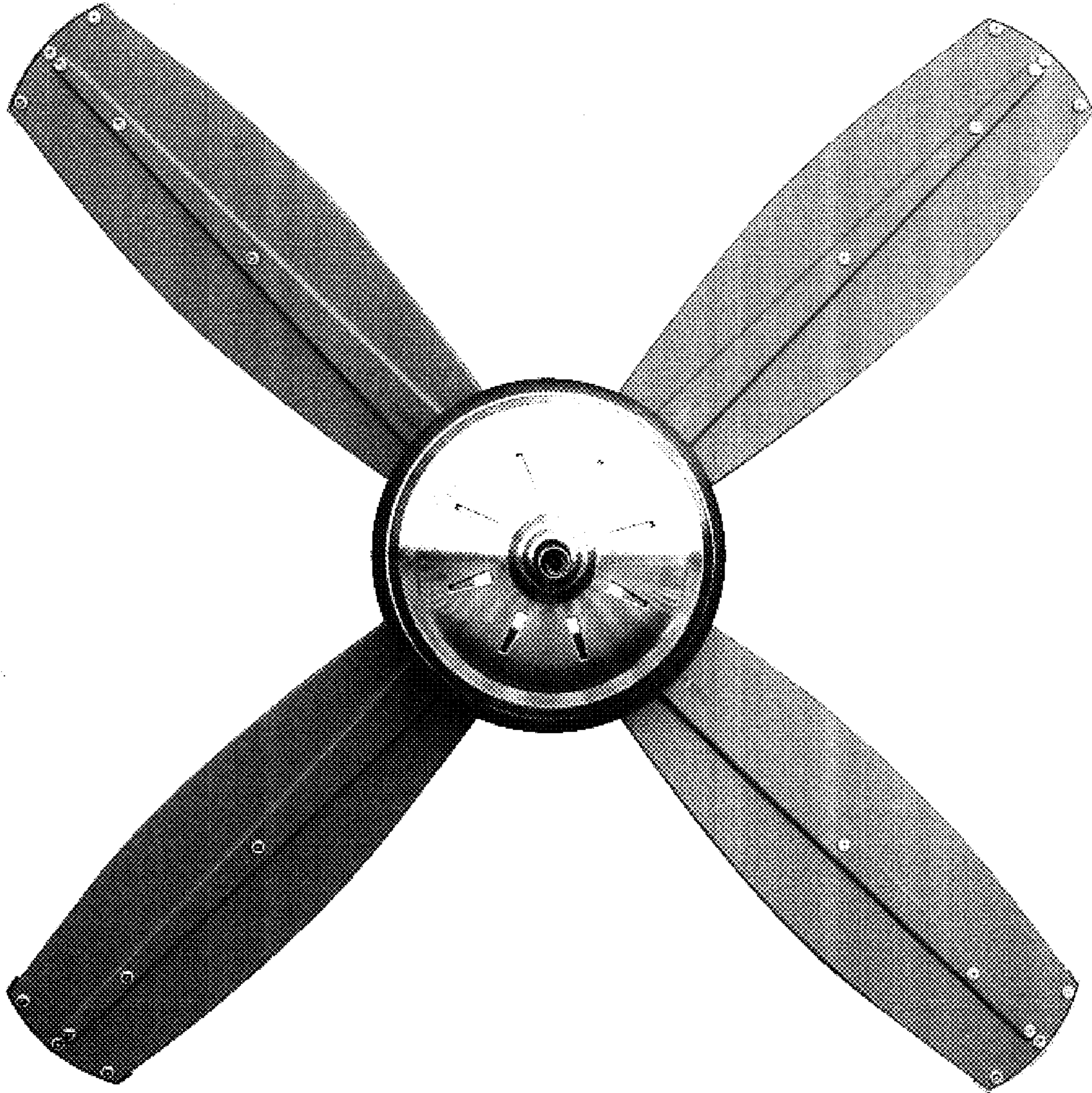

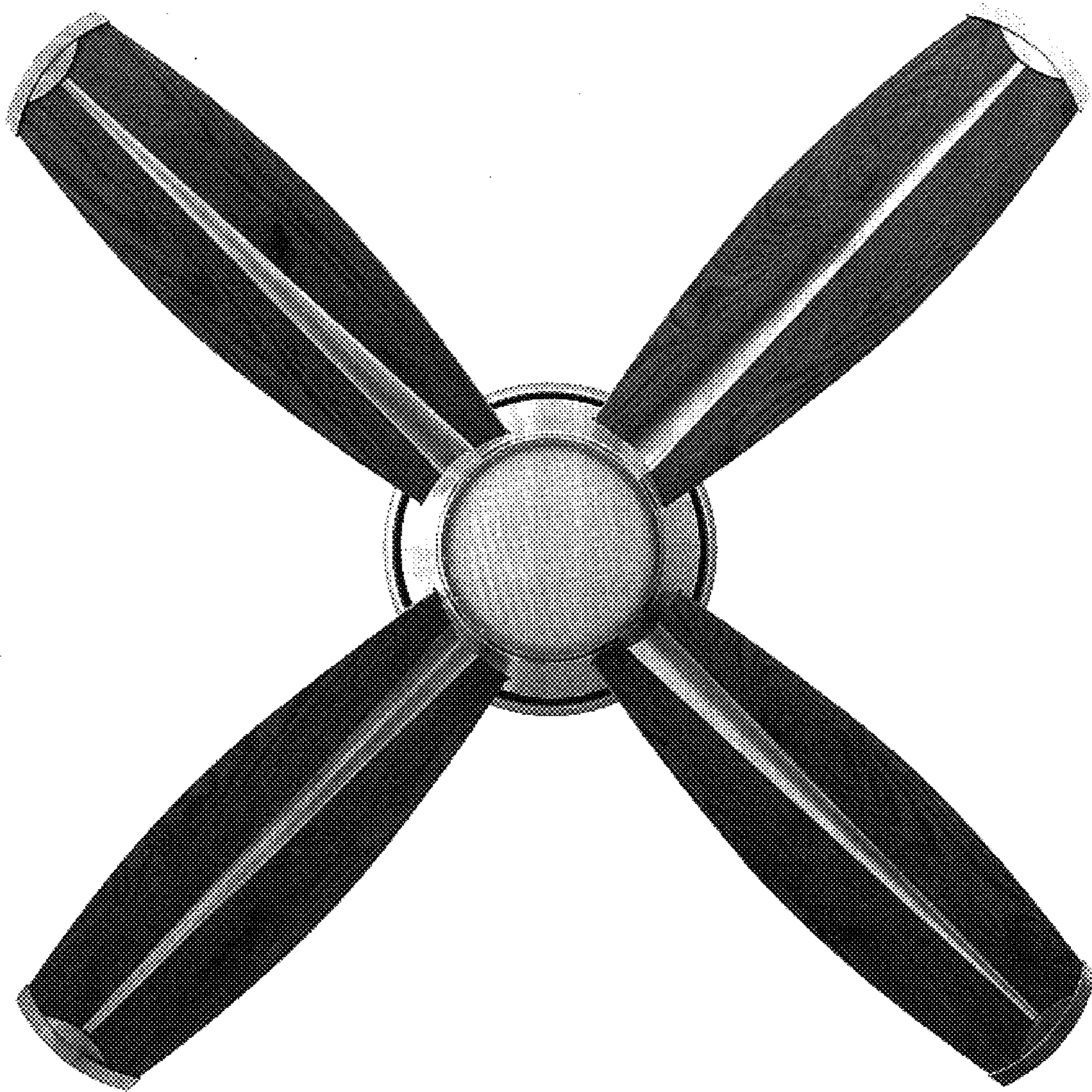

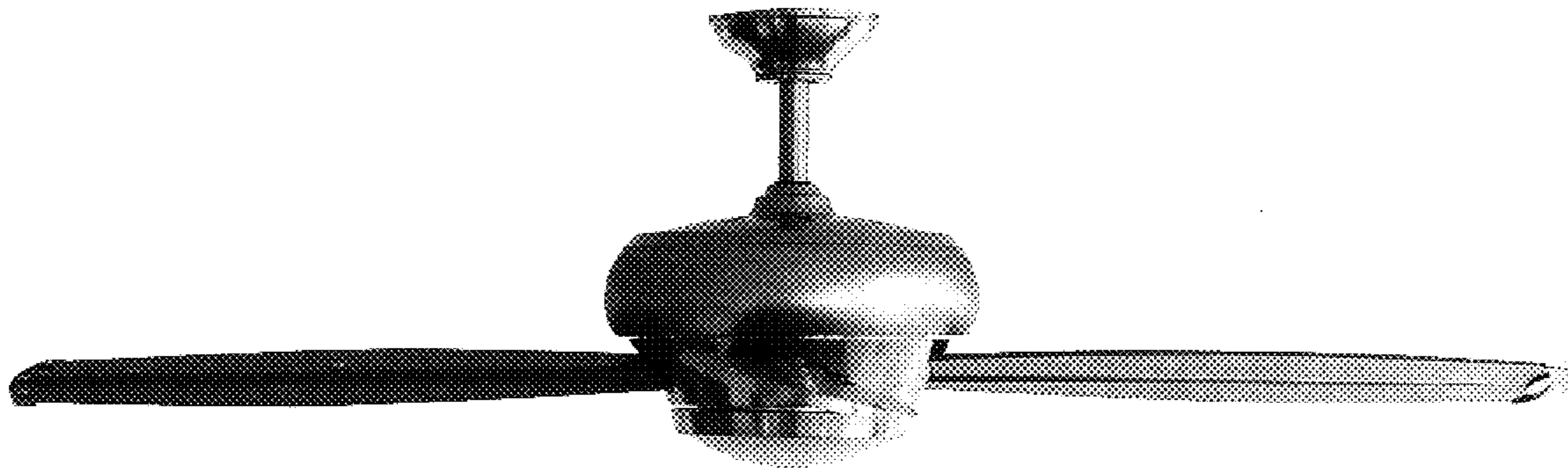

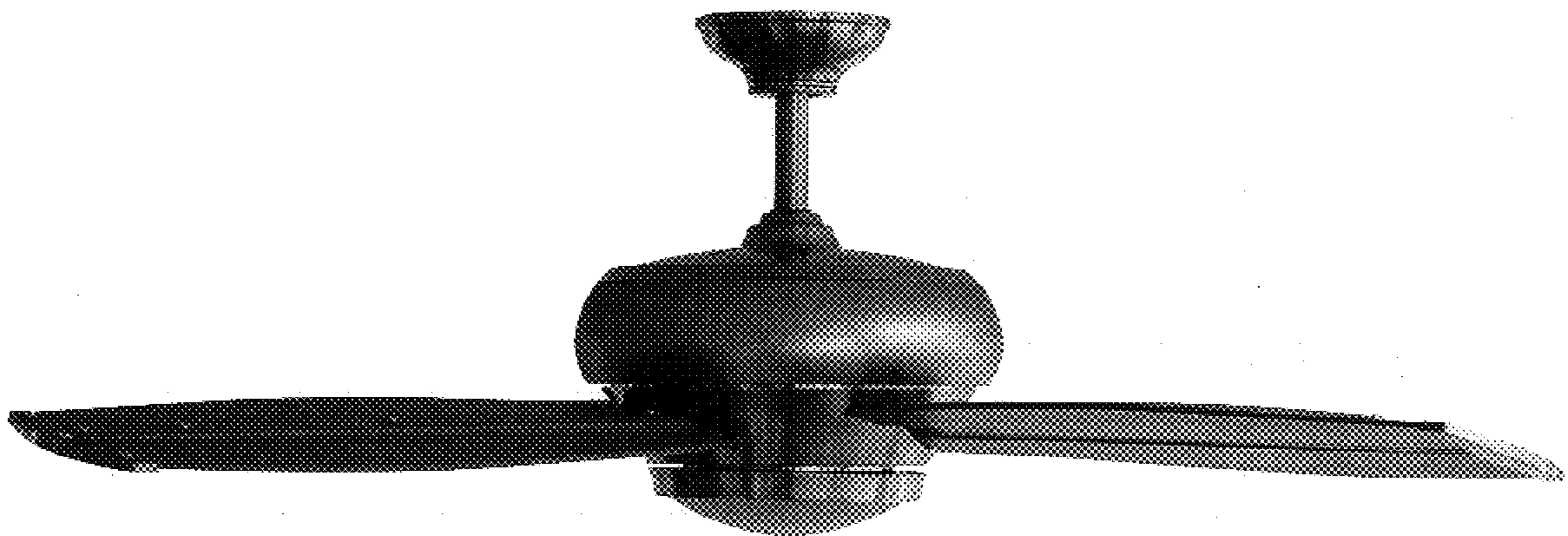
