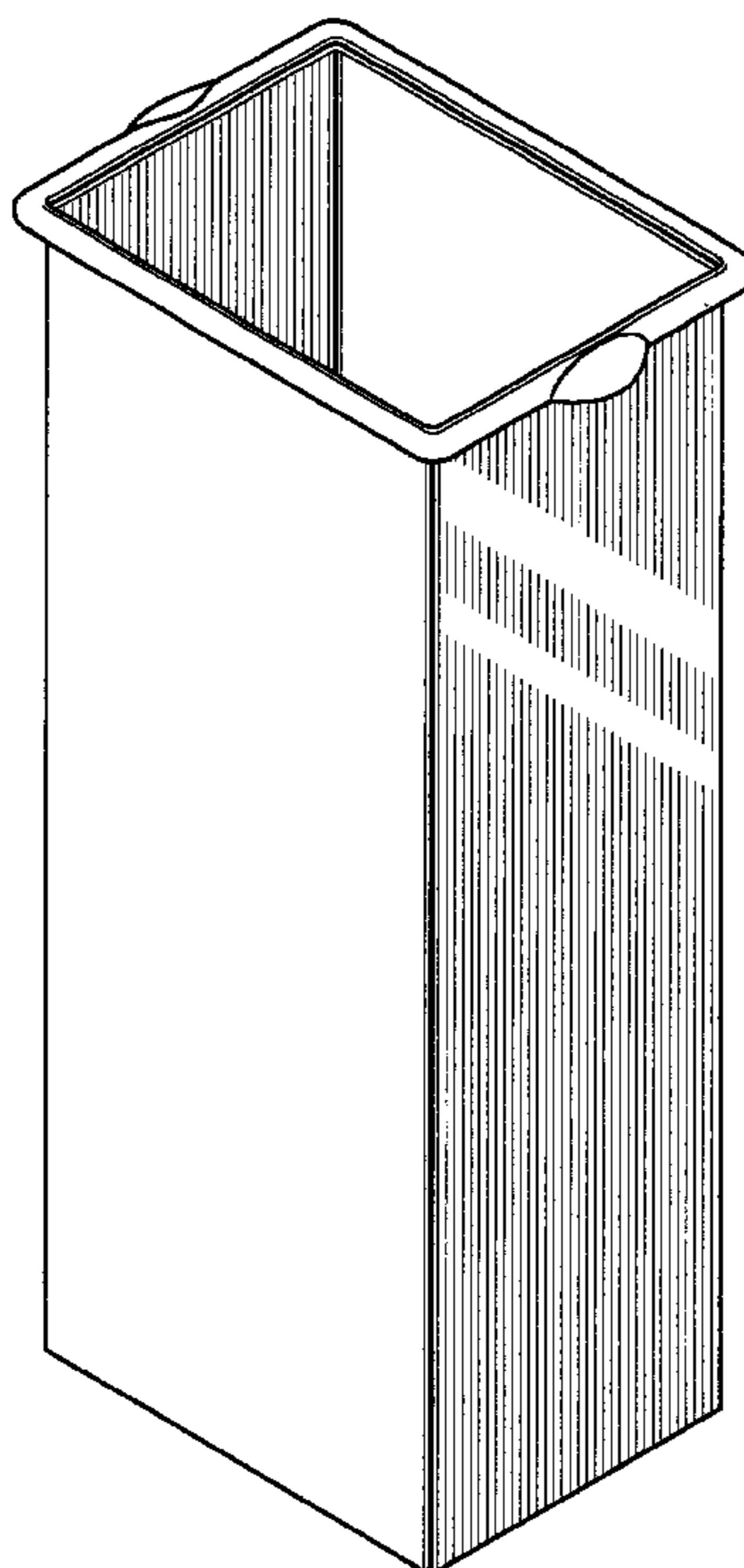
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view for a bottomless bag insert
showing my new design;
FIG. 2 is a top side view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front view thereof, the back side view thereof
being a mirror image of that which is shown; and,
FIG. 5 is a left side view thereof, the right side view thereof
being a mirror image of that which is shown.

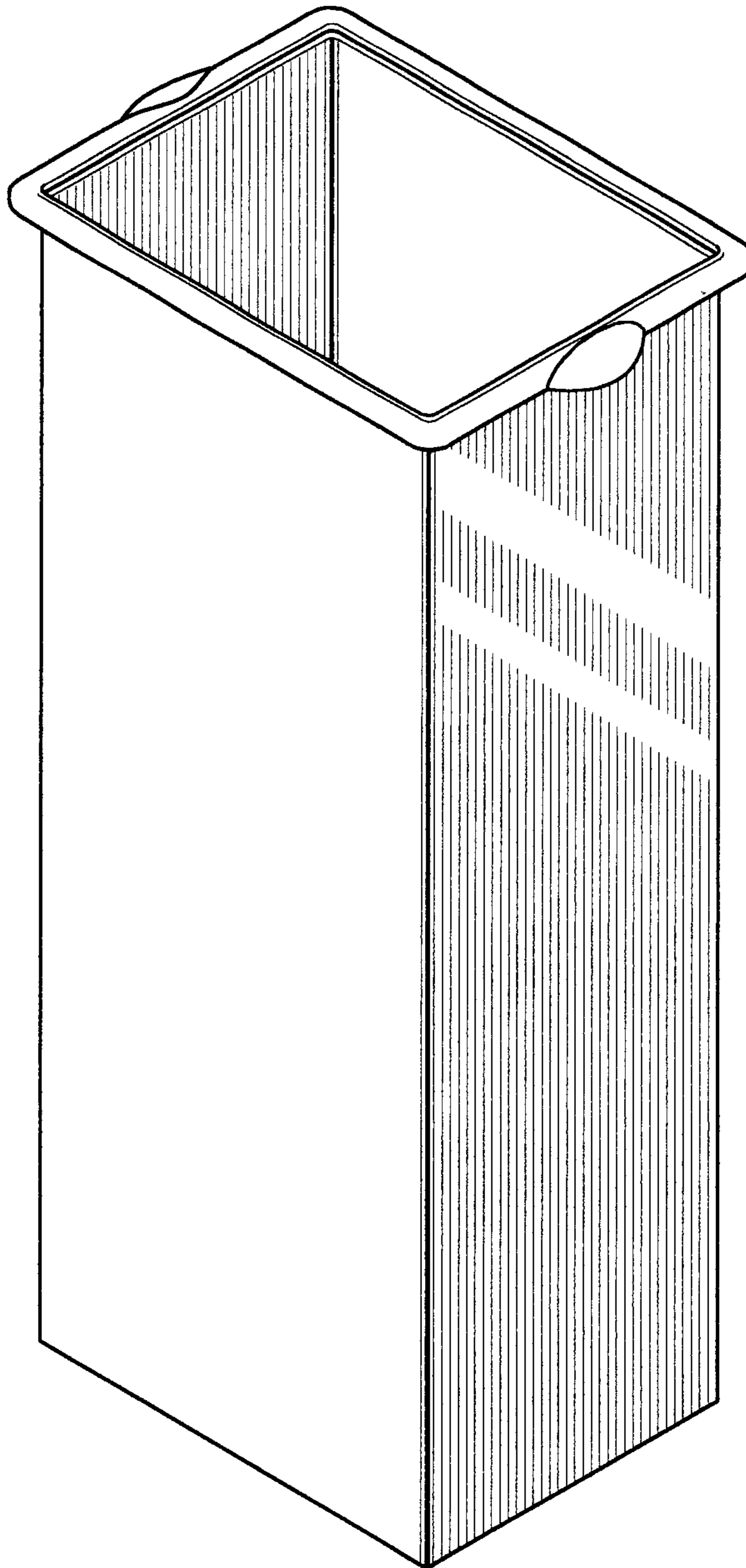

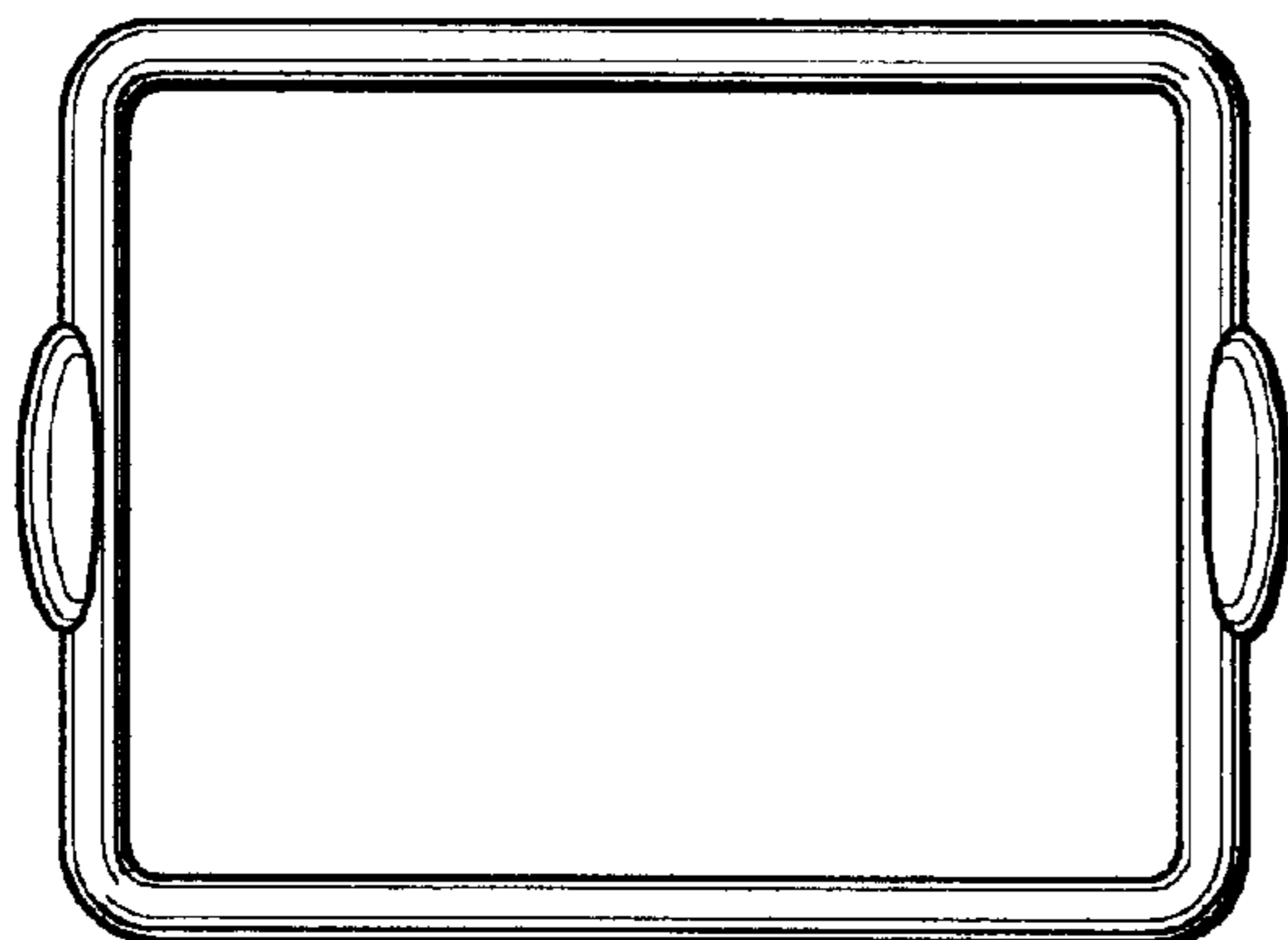

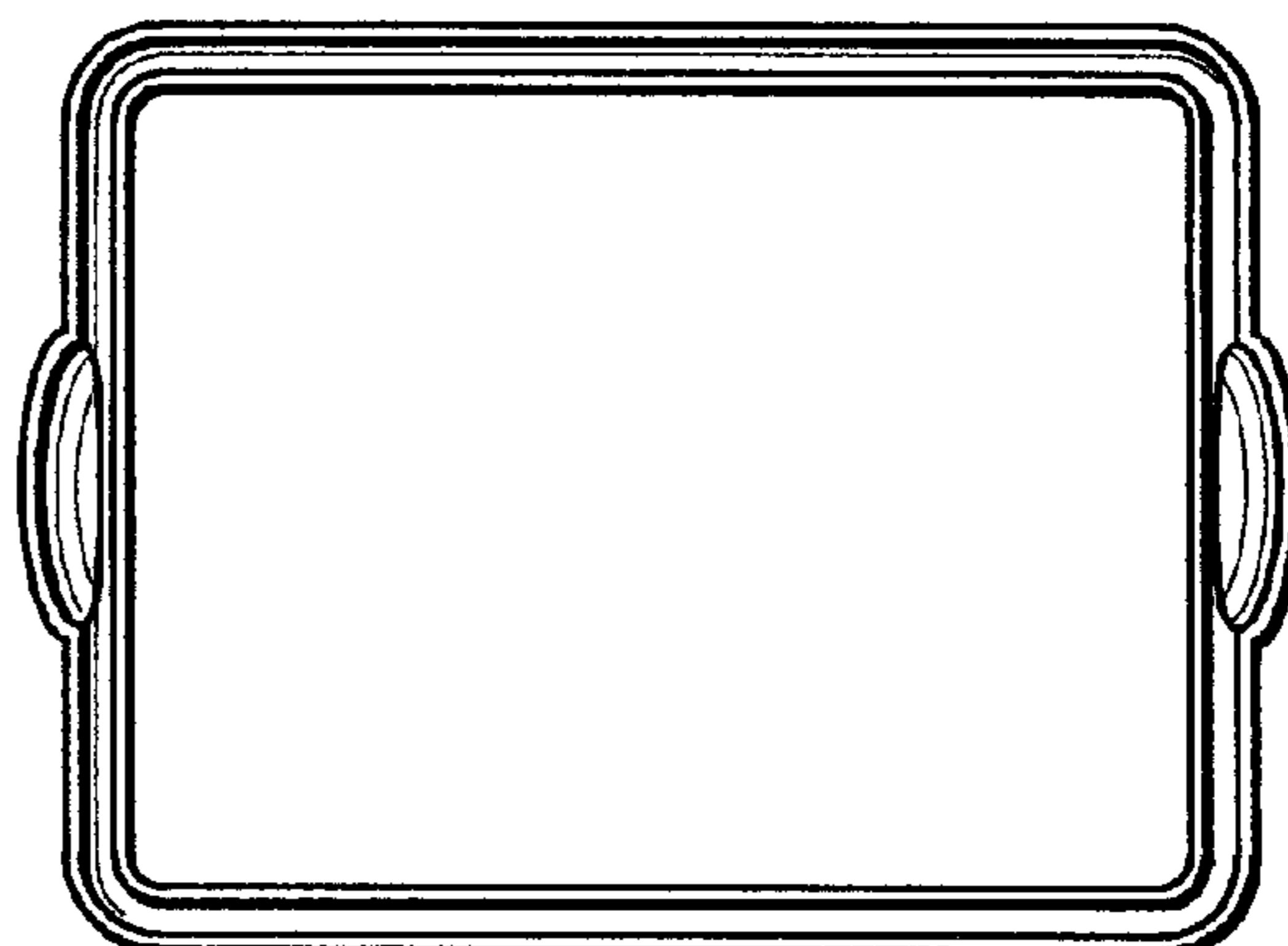

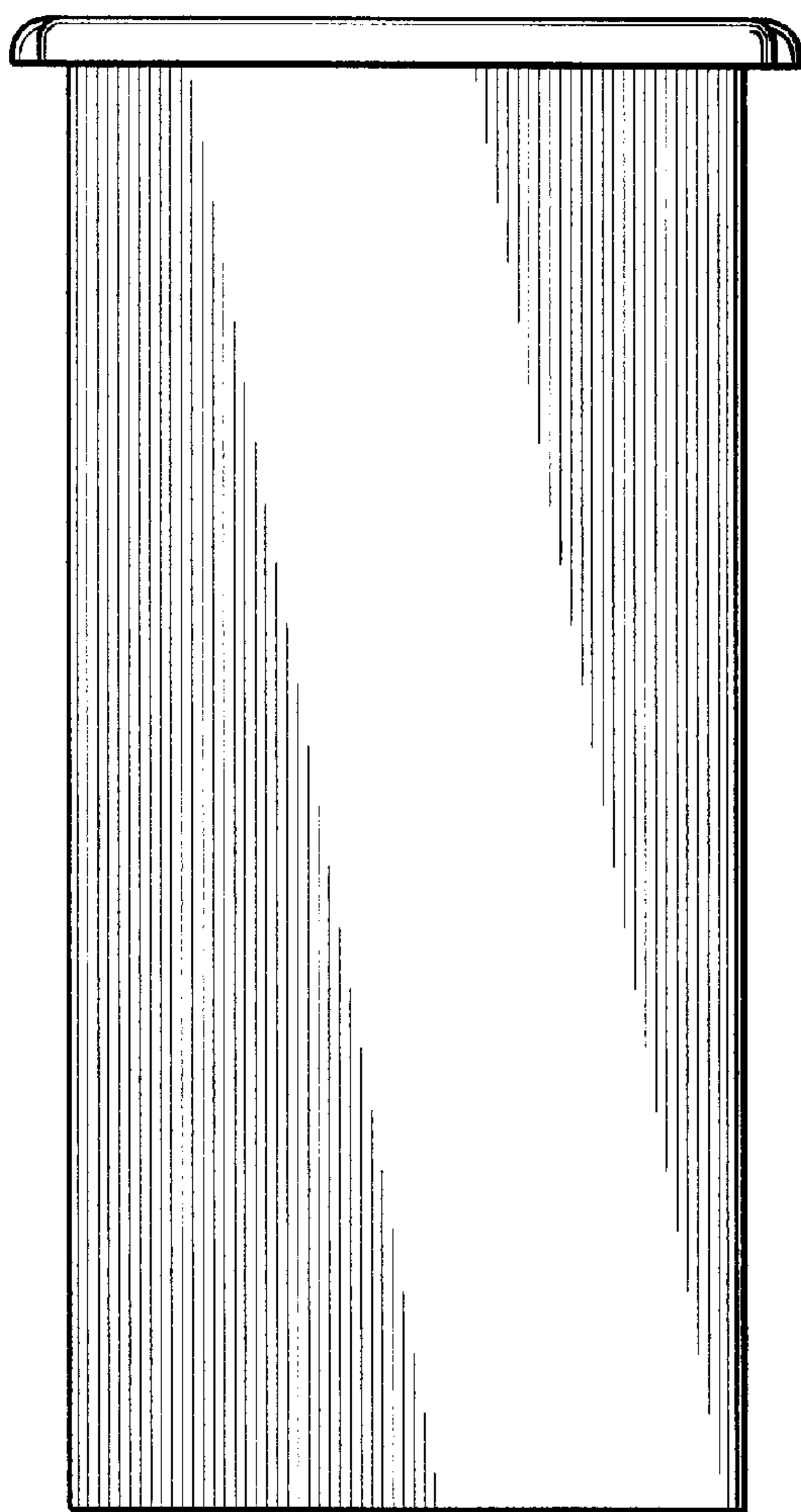

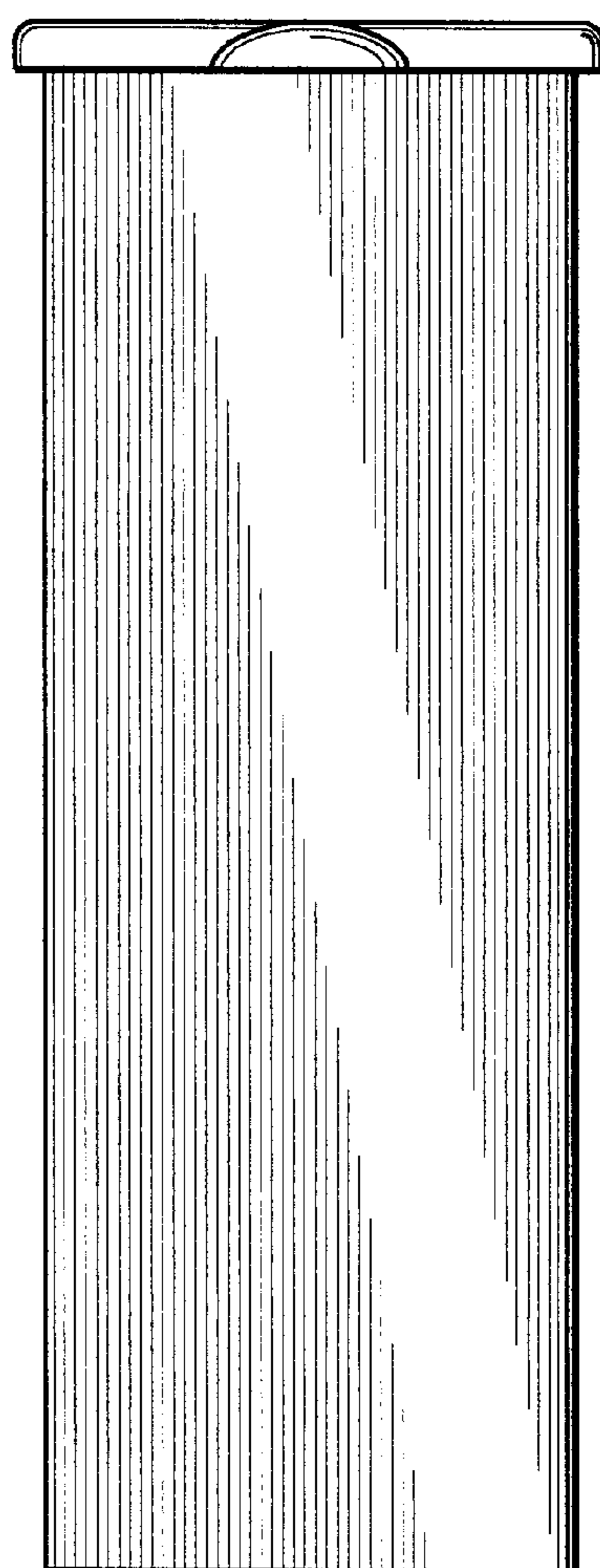
