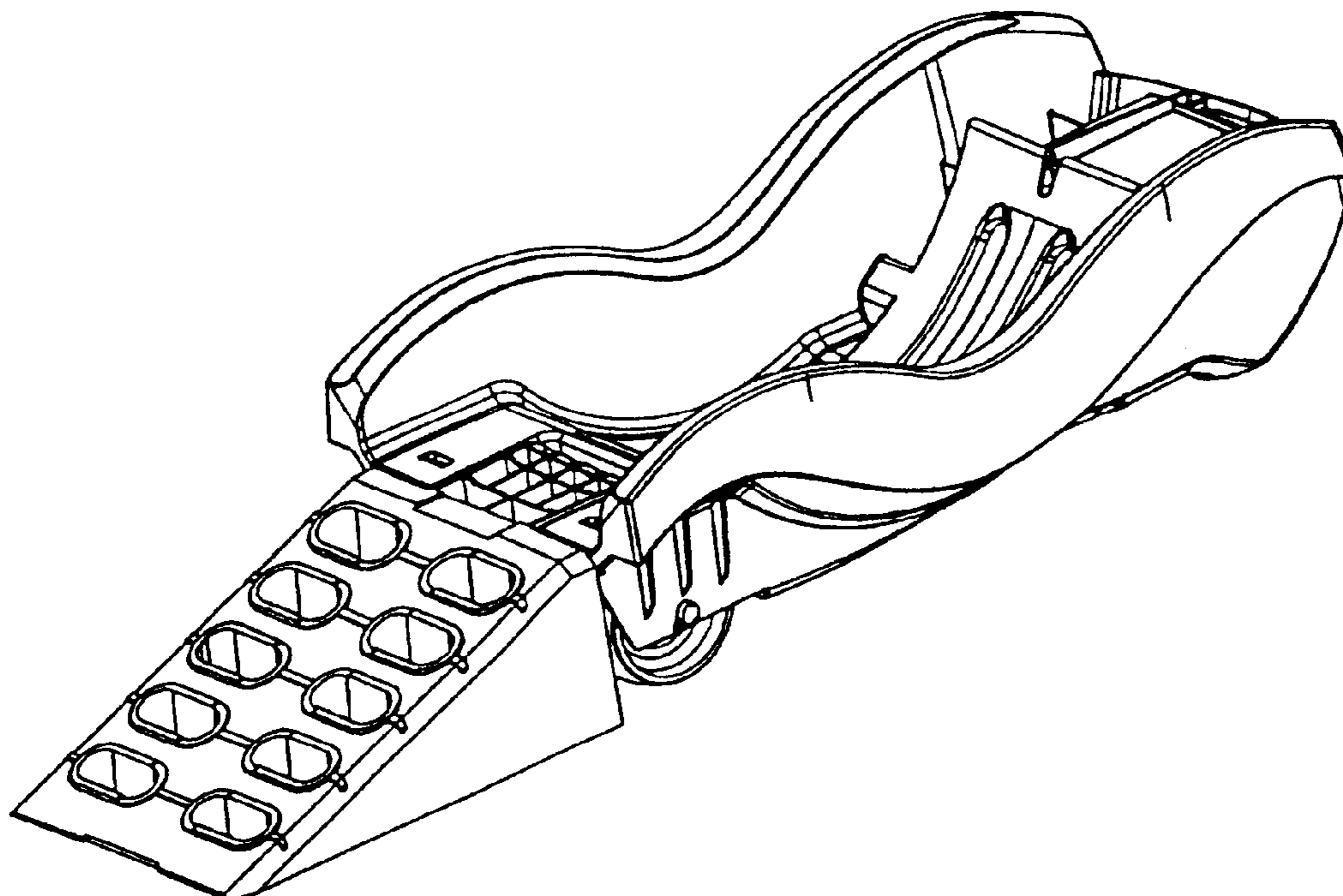
(57) **CLAIM**

The ornamental design for a rolling device for motor vehicles, as shown.

DESCRIPTION

FIG. 1 is a perspective view of my rolling device for motor vehicles;
 FIG. 2 is a right side view of my rolling device for motor vehicles, the other side a mirror image thereof;
 FIG. 3 is a front view of my rolling device for motor vehicles;
 FIG. 4 is a rear view of my rolling device for motor vehicles;
 FIG. 5 is a top plan view of my rolling device for motor vehicles; and,
 FIG. 6 is a bottom plan view of my rolling device for motor vehicles.

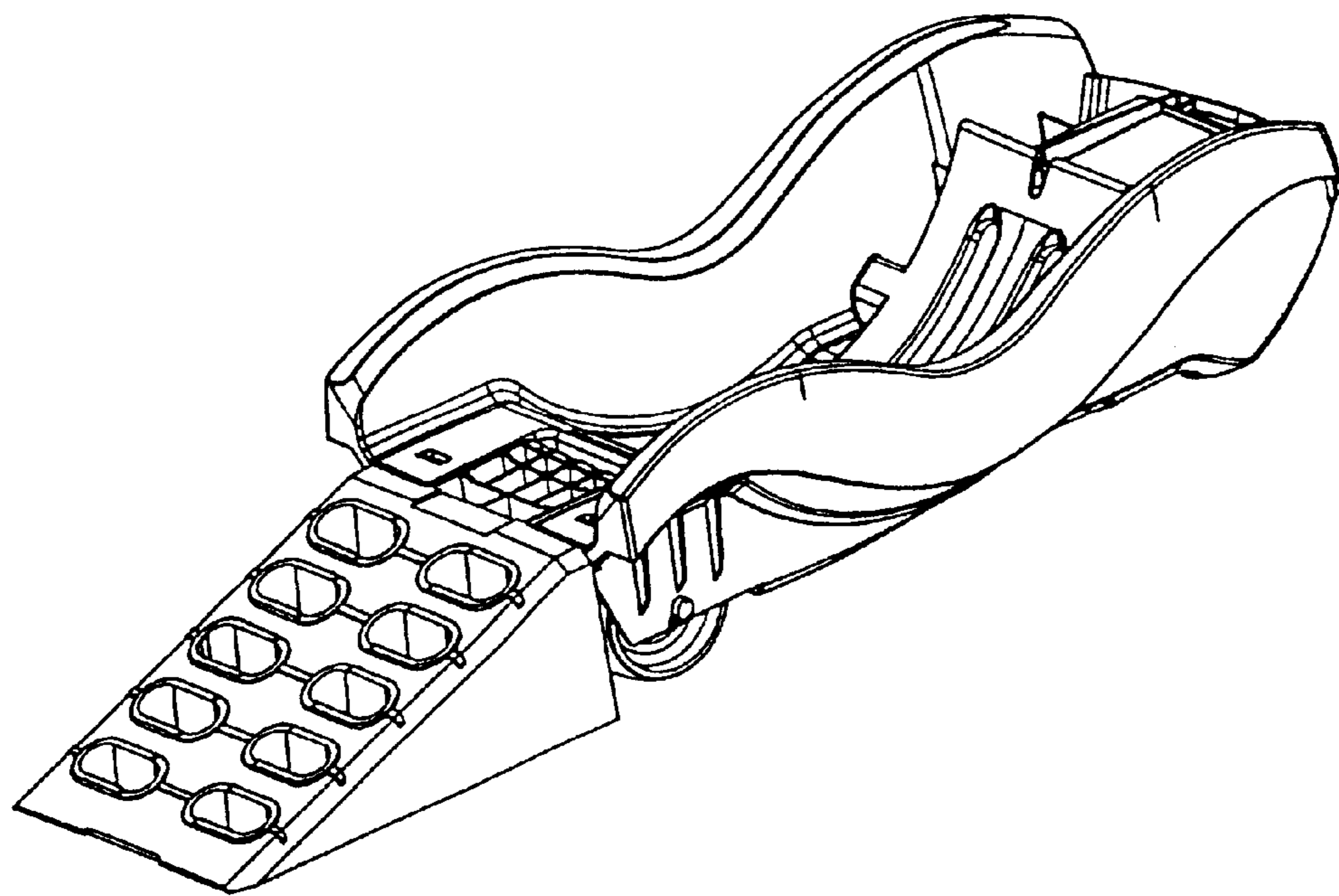

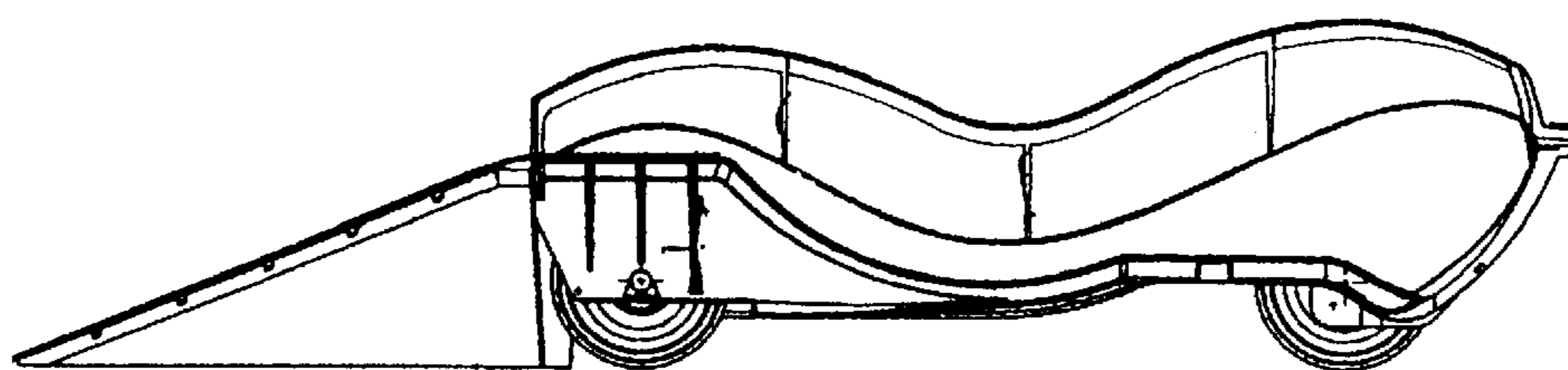

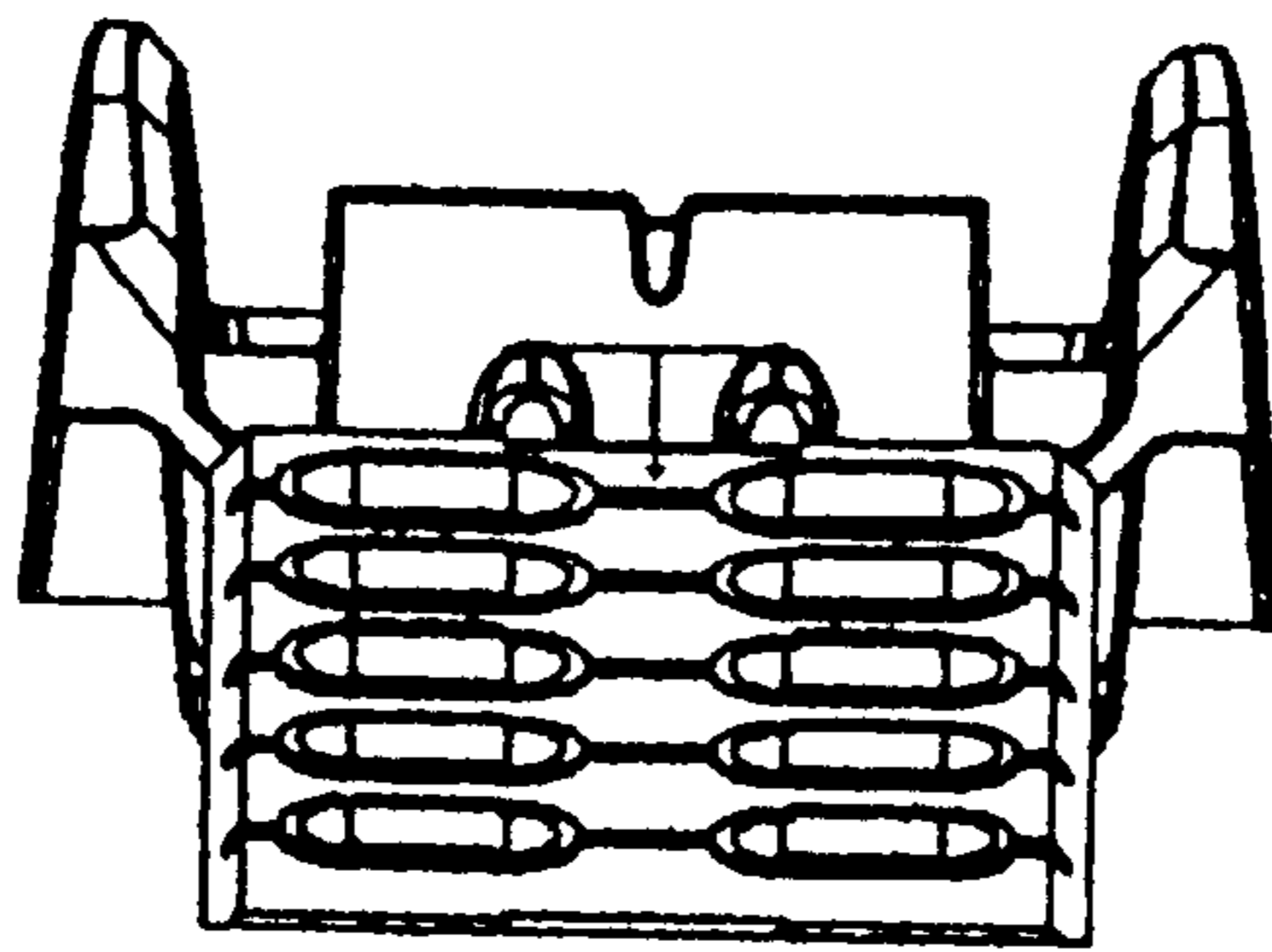

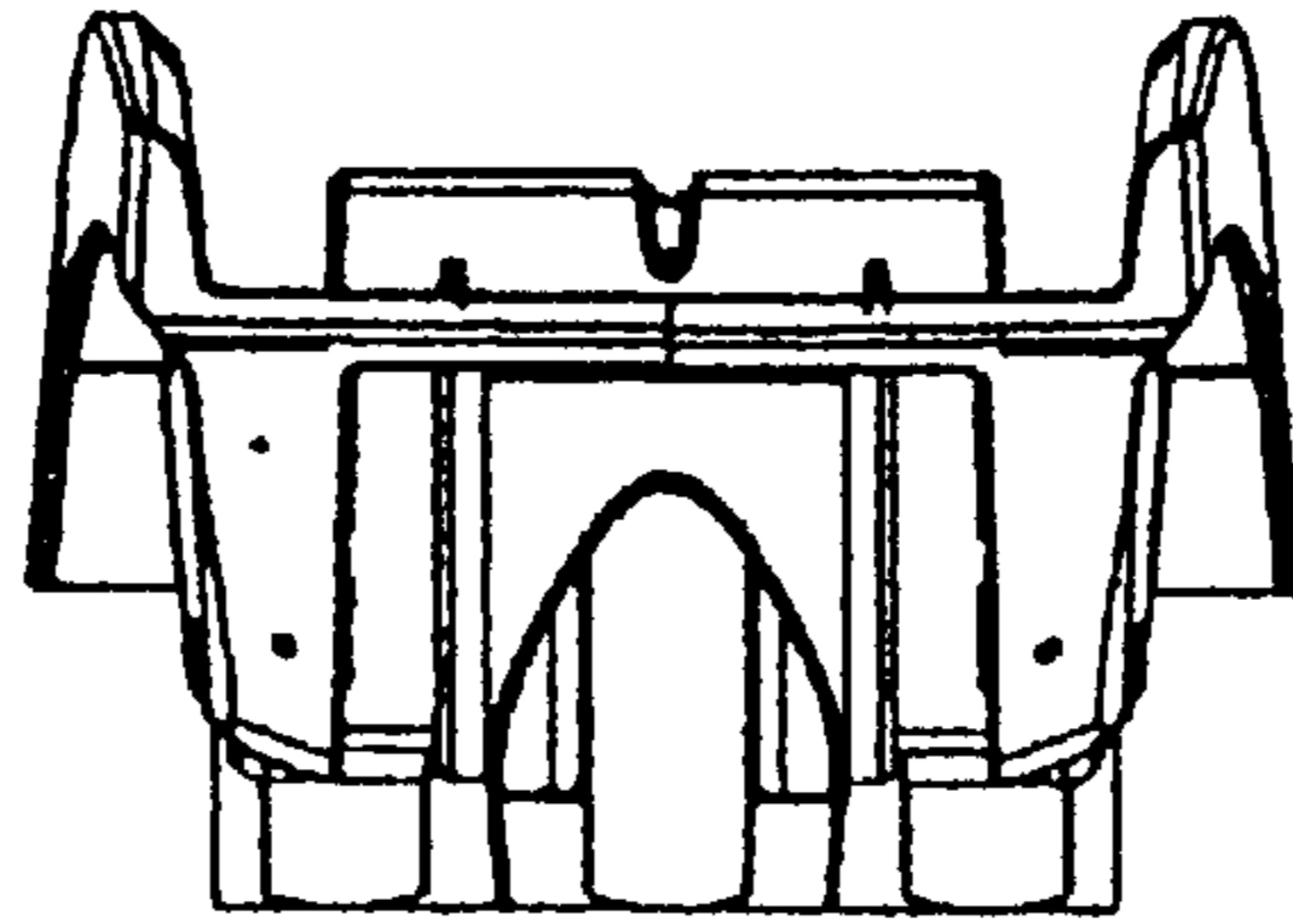

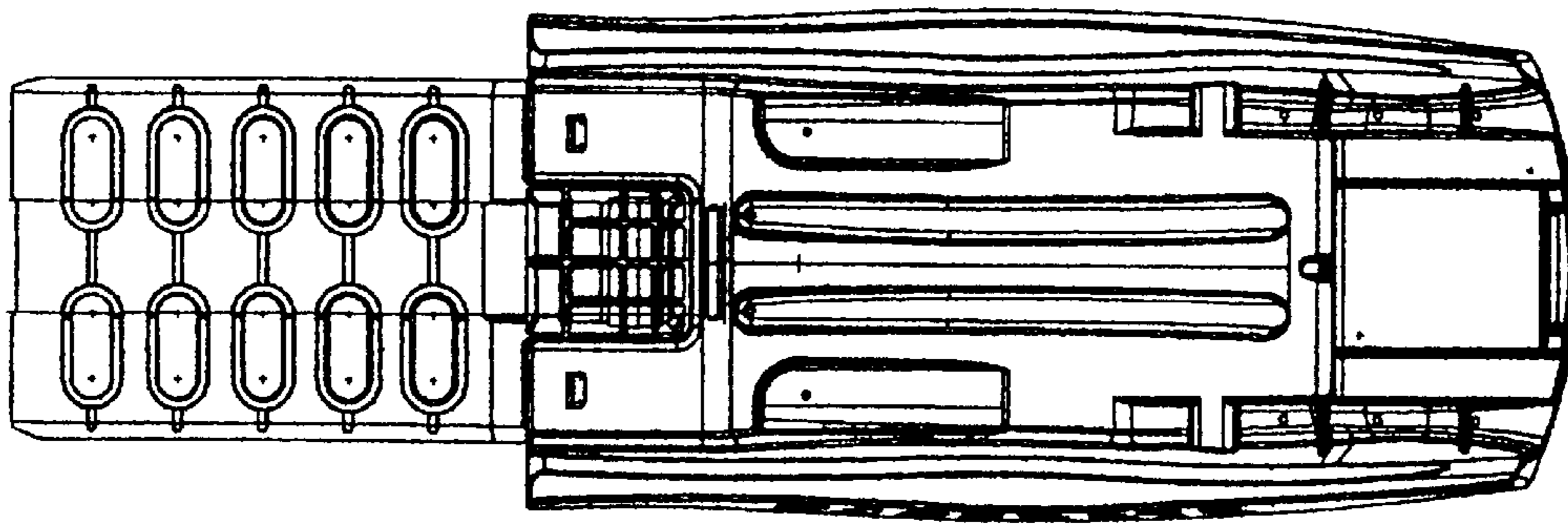

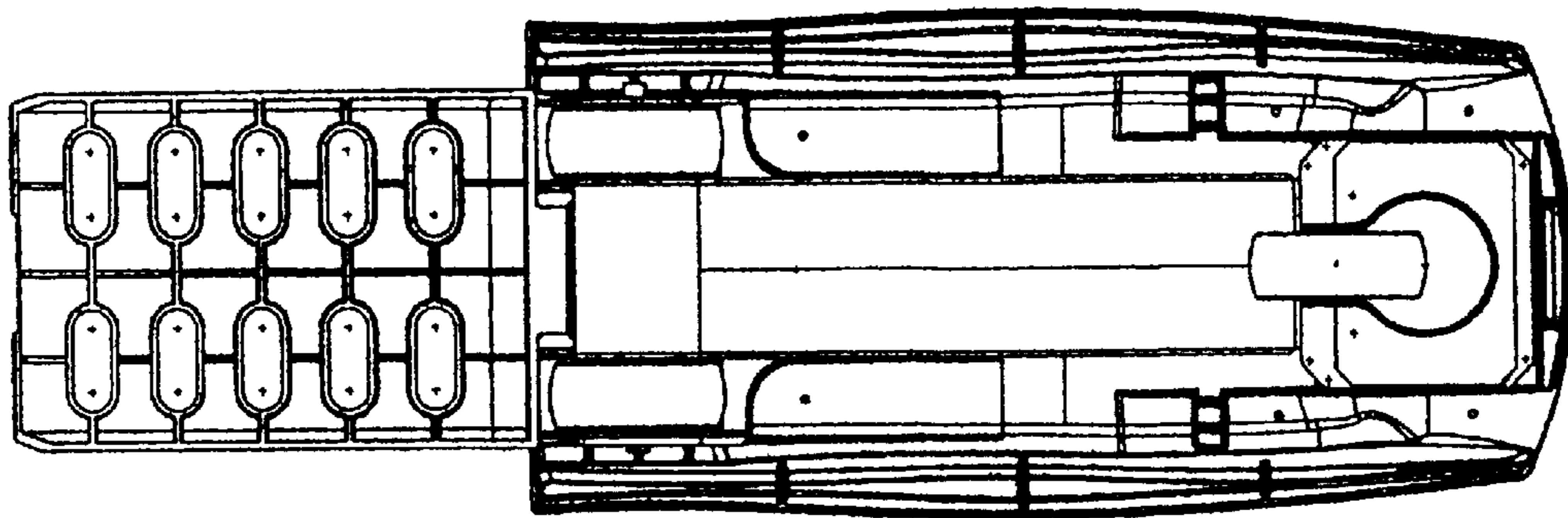
