FIG. 9 is an additional front, right quarter perspective view thereof.

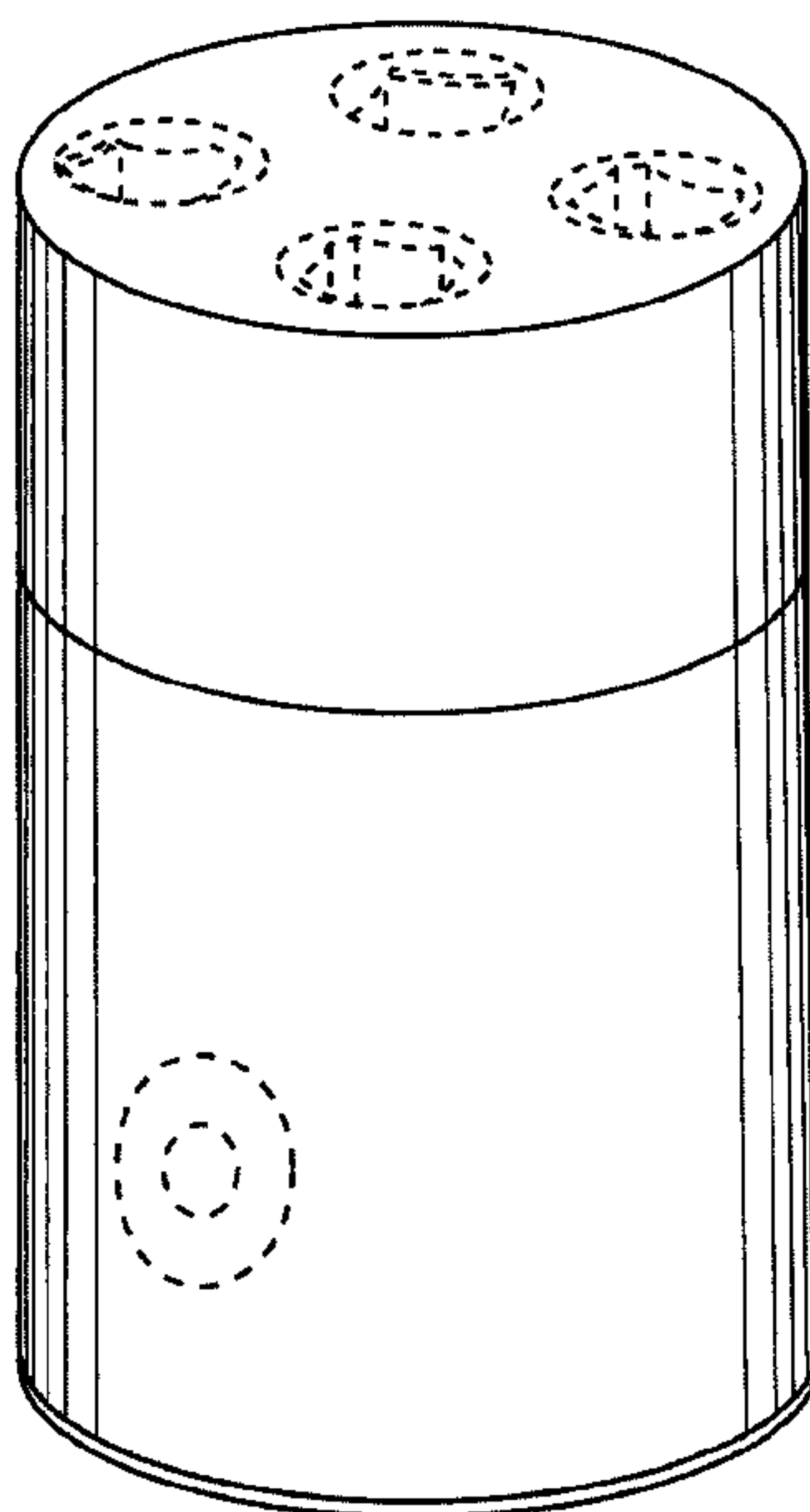

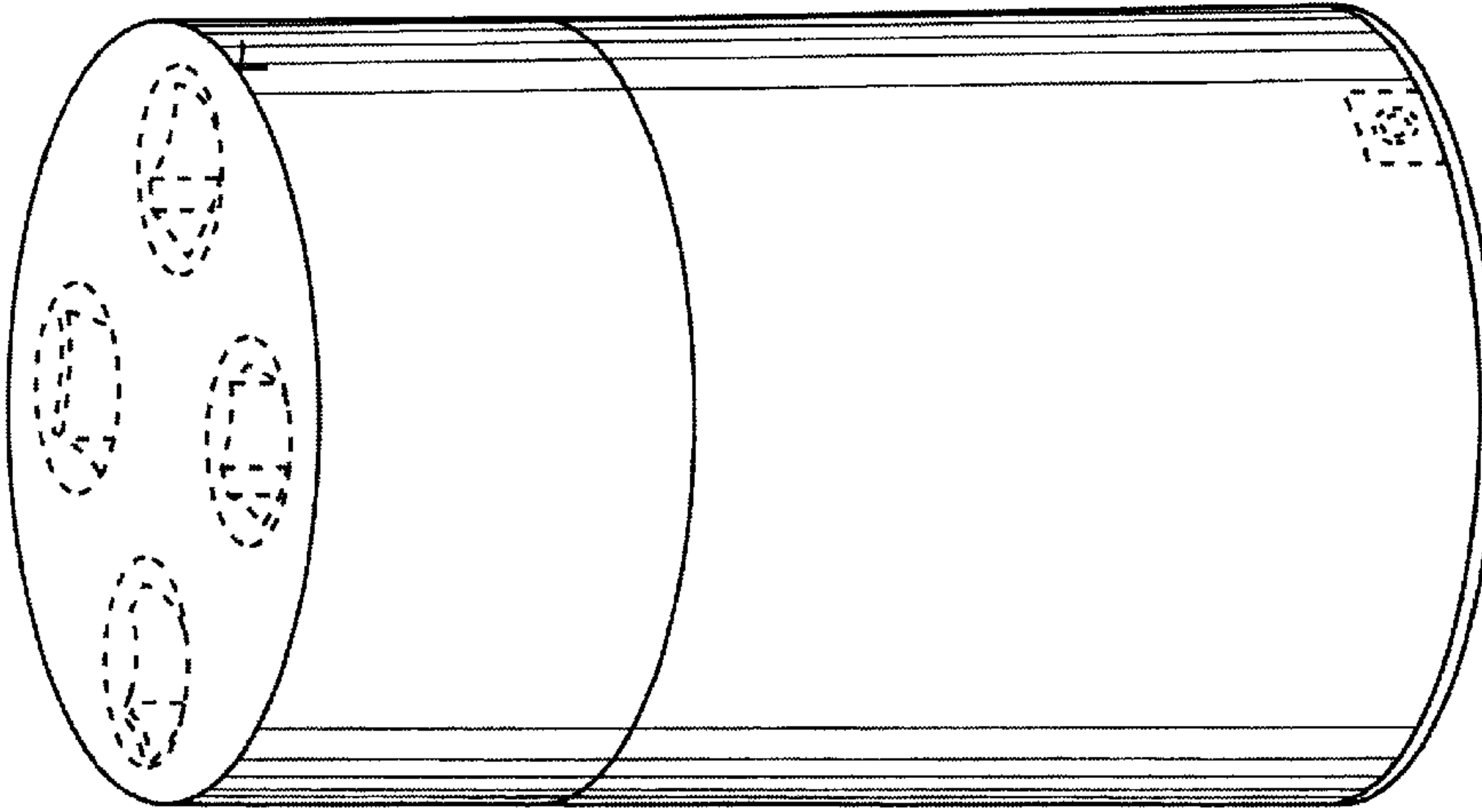

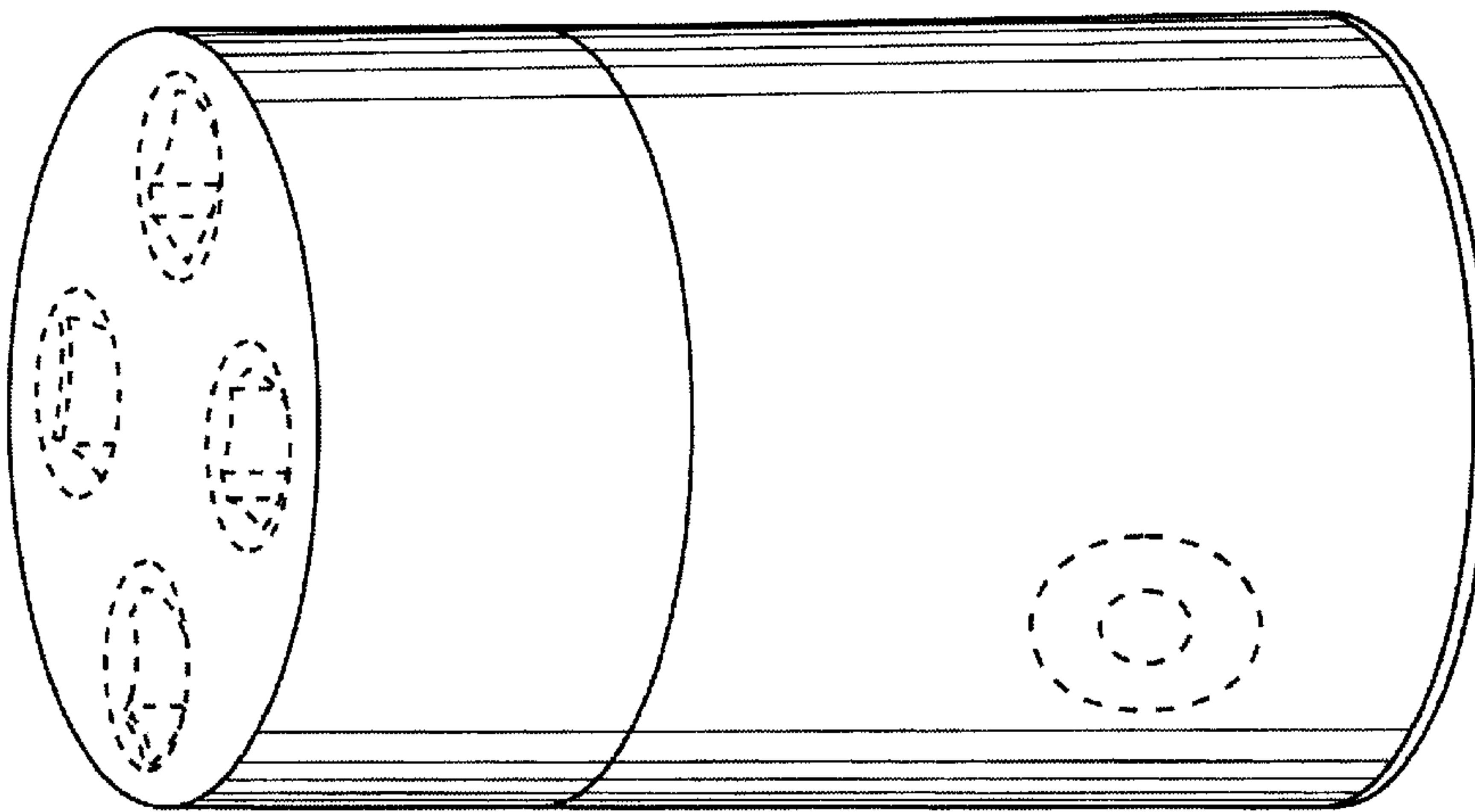

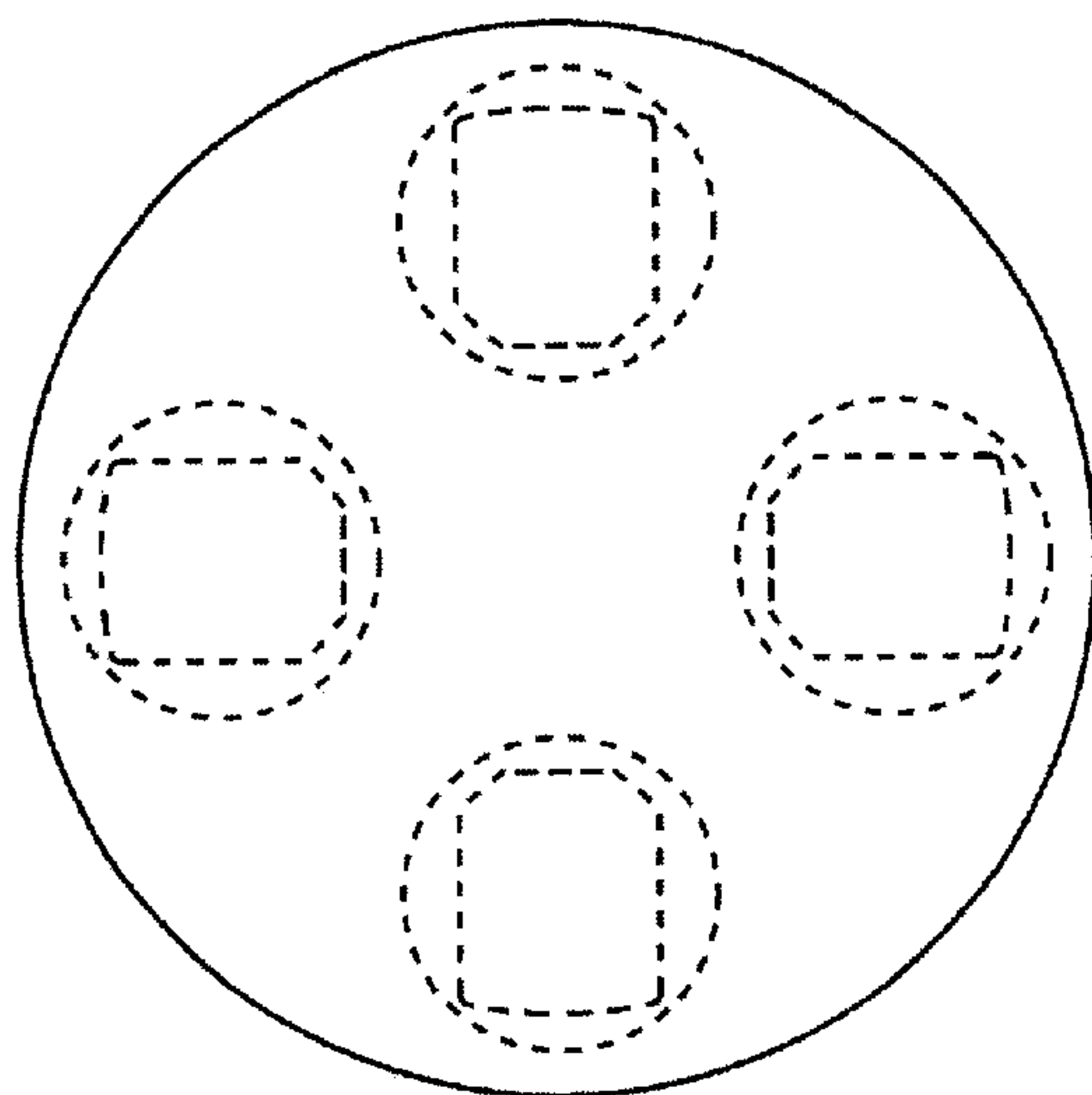

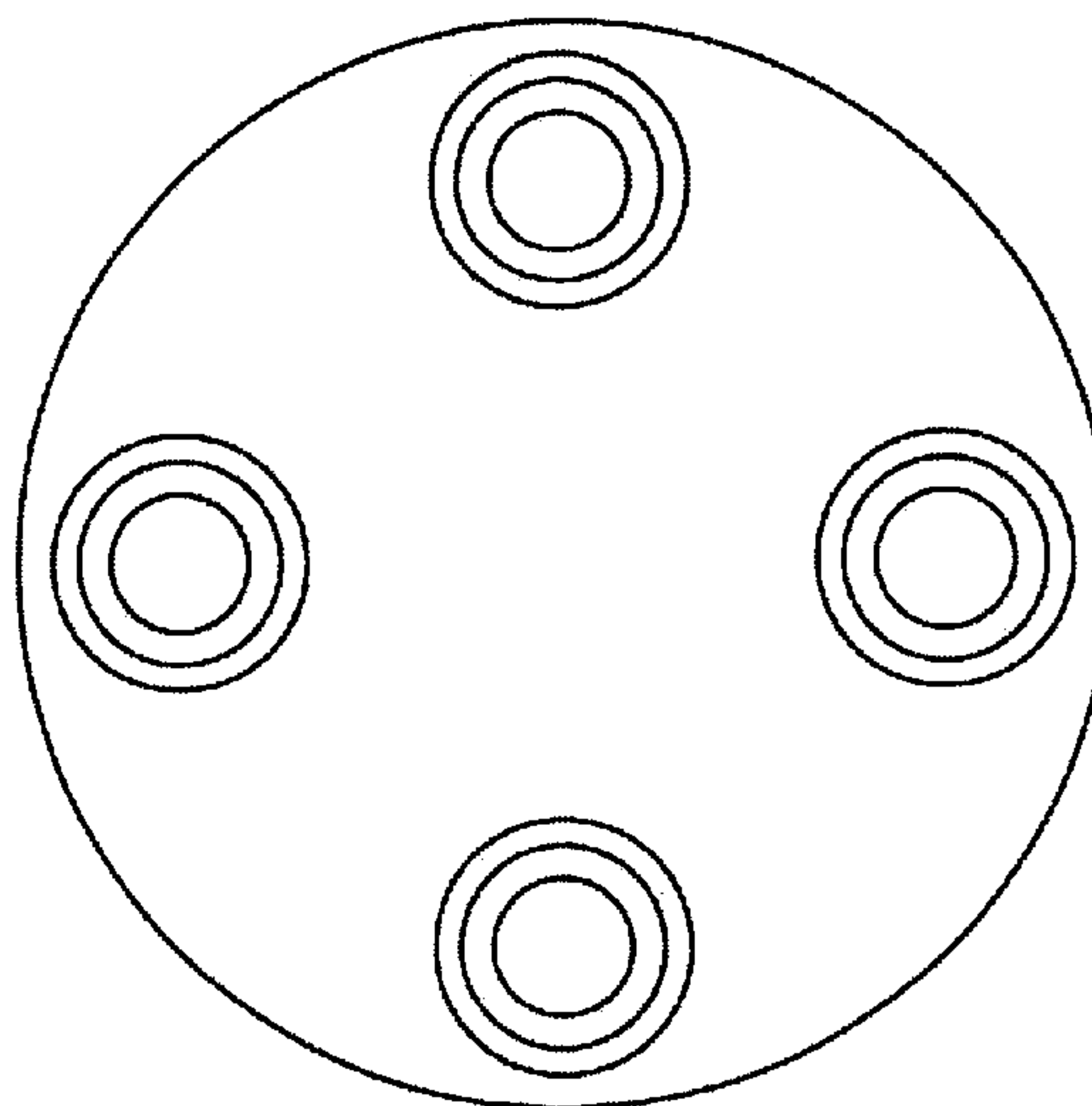

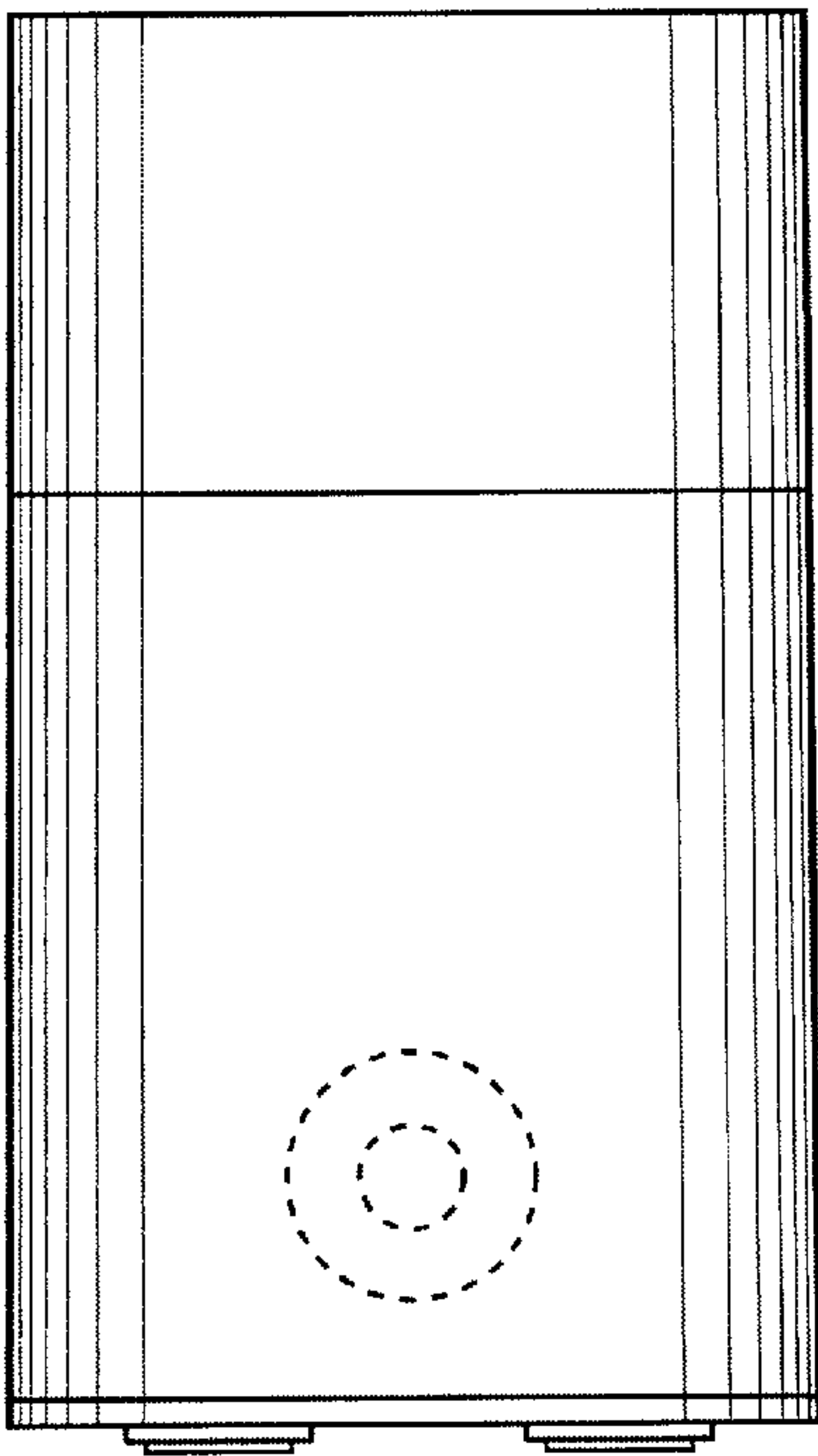

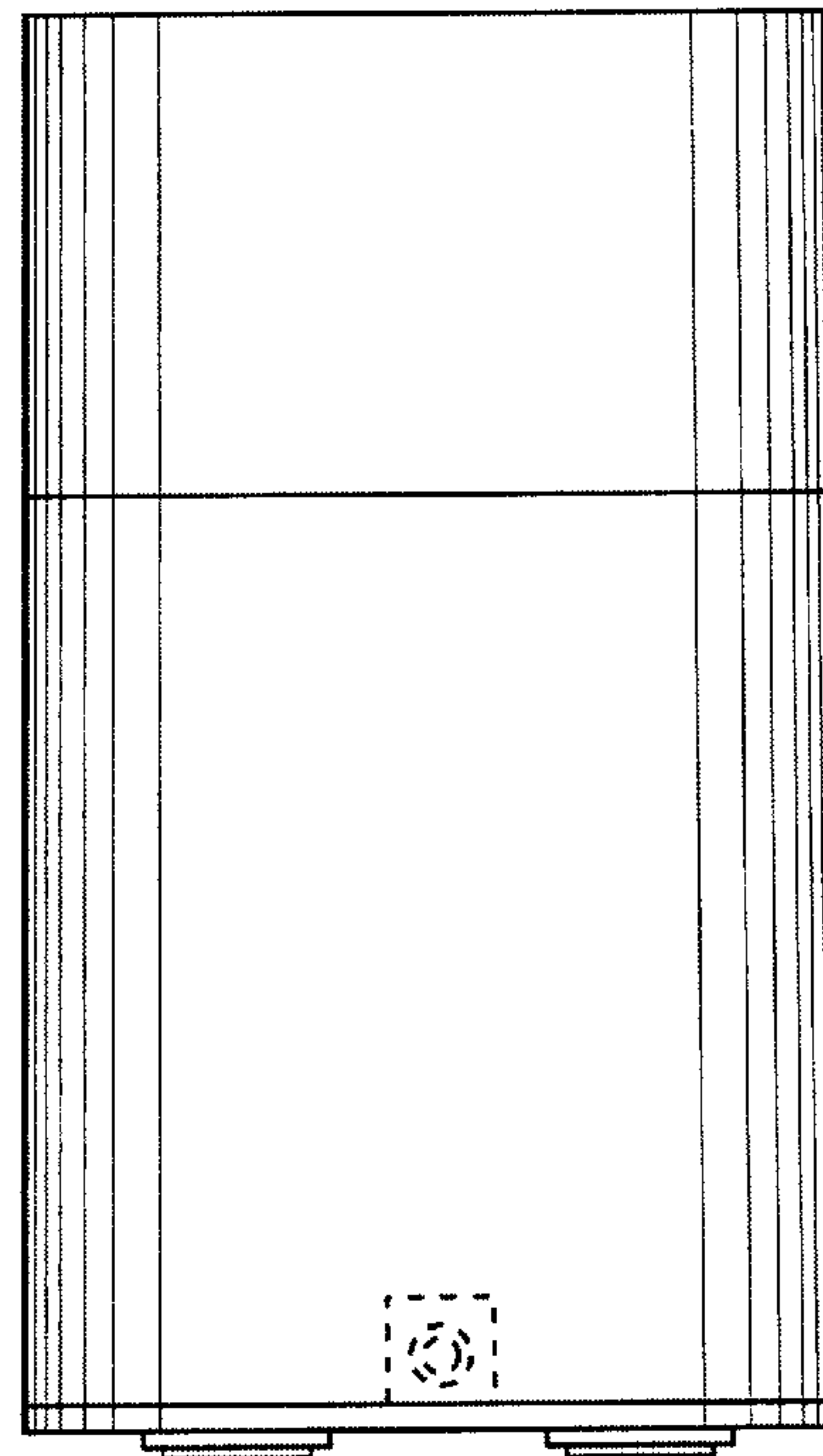

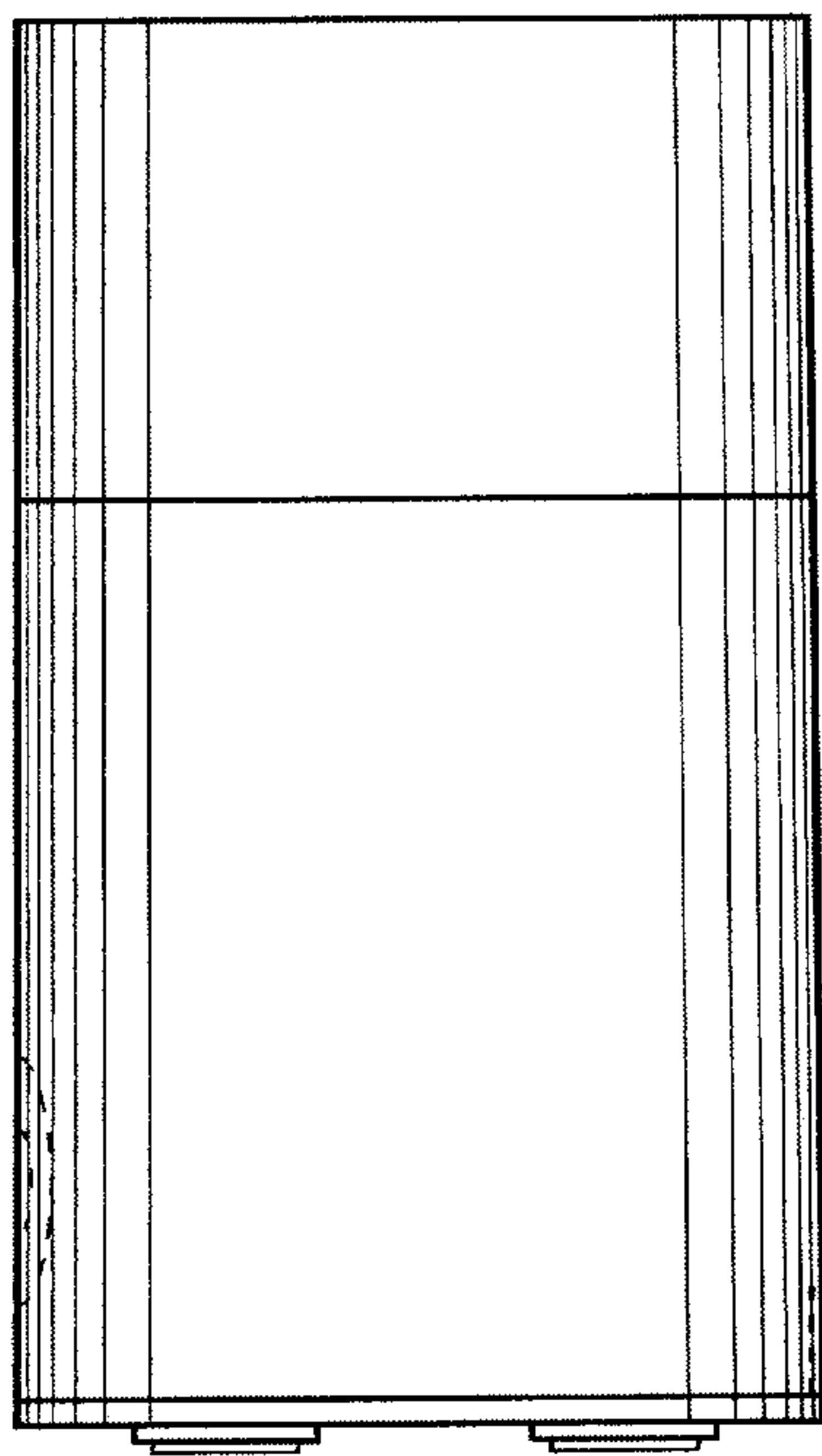

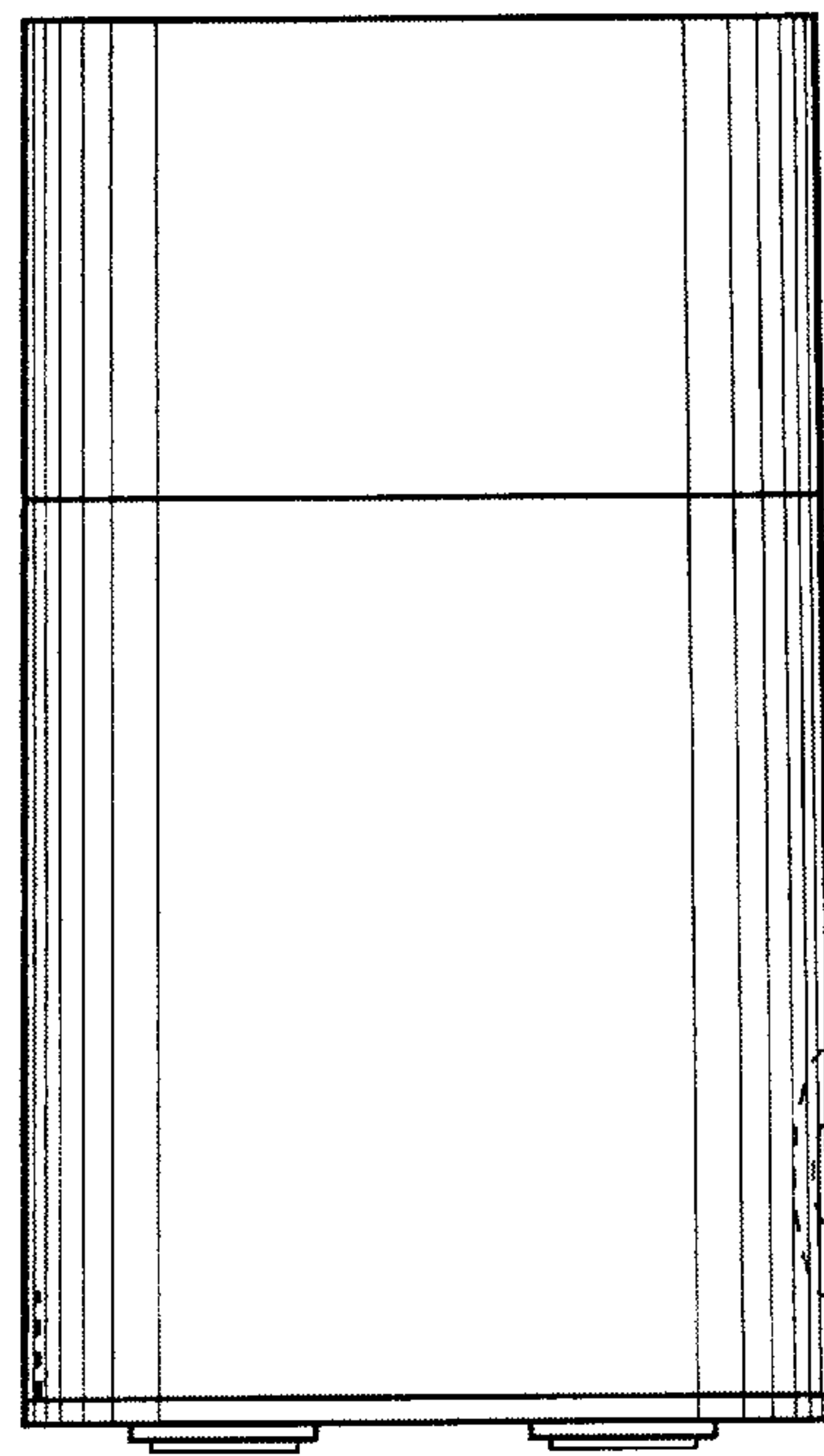

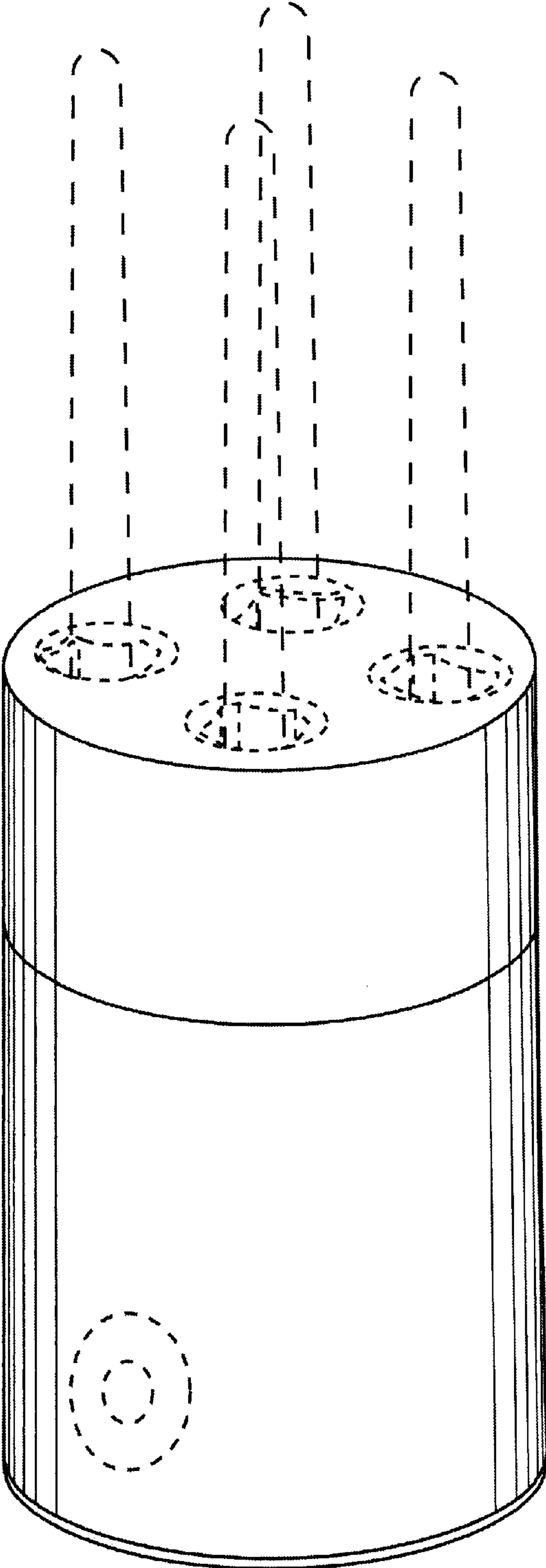
