(57) **CLAIM**

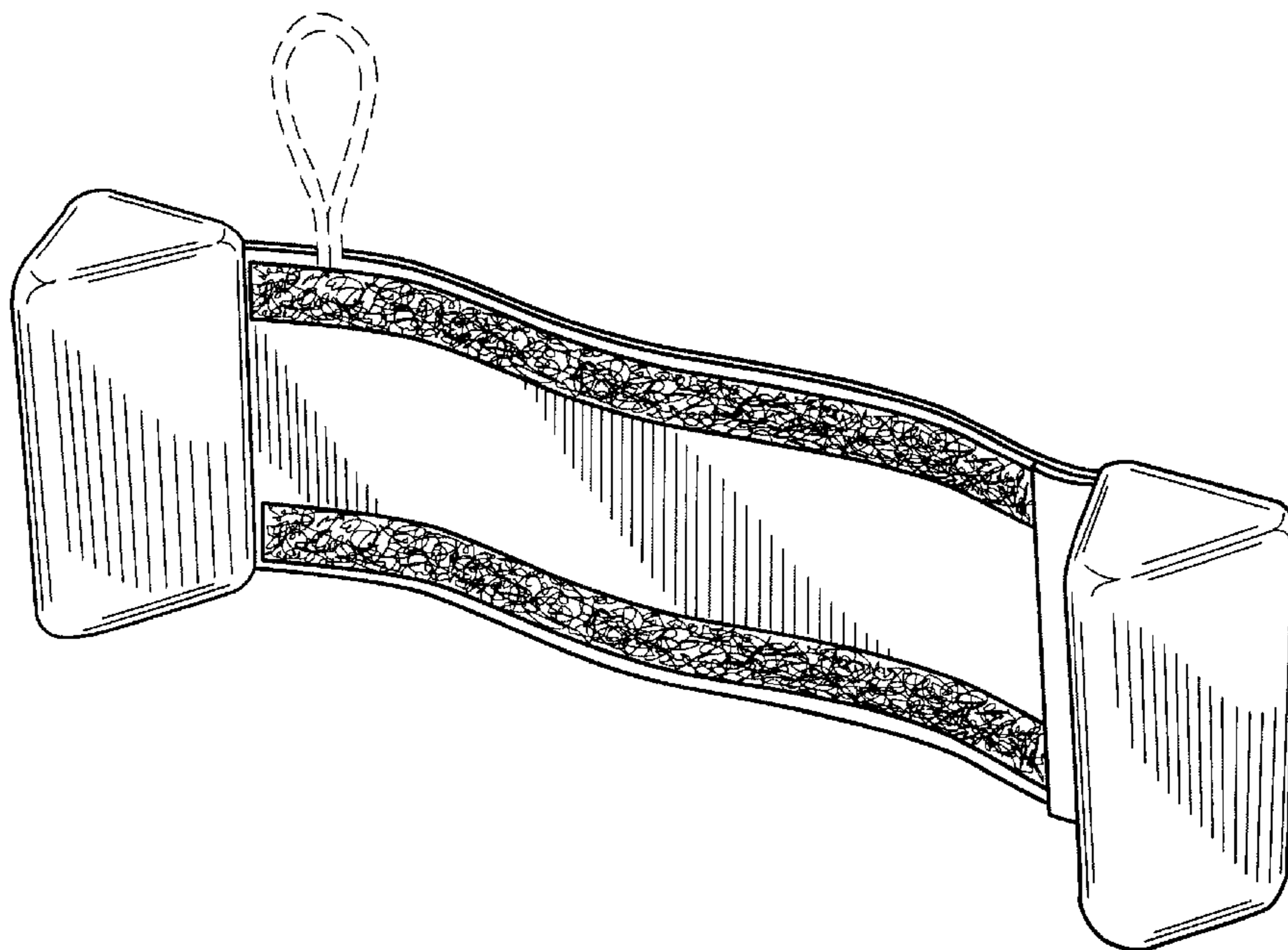
The ornamental design for an adjustable travel pillow, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an adjustable travel pillow. FIG. 2 is a front plan view of the adjustable travel pillow. FIG. 3 is a top plan view of the adjustable travel pillow. FIG. 4 is a rear plan view of the adjustable travel pillow. FIG. 5 is a bottom plan view of the adjustable travel pillow. FIG. 6 is a left end view of the adjustable travel pillow. FIG. 7 is a right end view of the adjustable travel pillow. FIG. 8 is a perspective view of the adjustable travel pillow showing an alternative placement of a pillow support member along a panel of the adjustable travel pillow; and, FIG. 9 is an upper perspective view of the adjustable travel pillow in a folded configuration.

The broken lines showing a loop handle in FIGS. 1 through 9 are for illustrative purposes only and form no part of the claimed design.

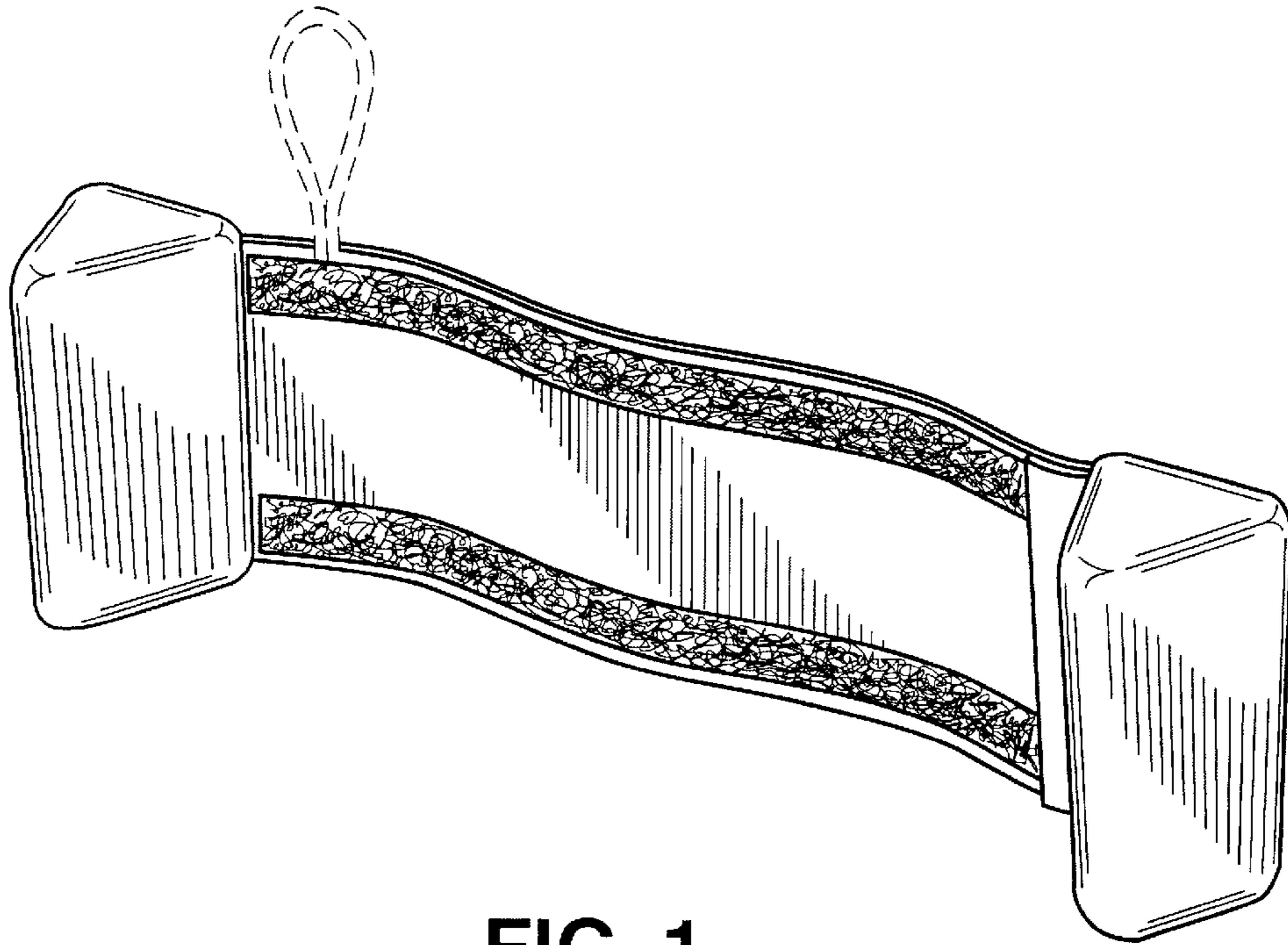

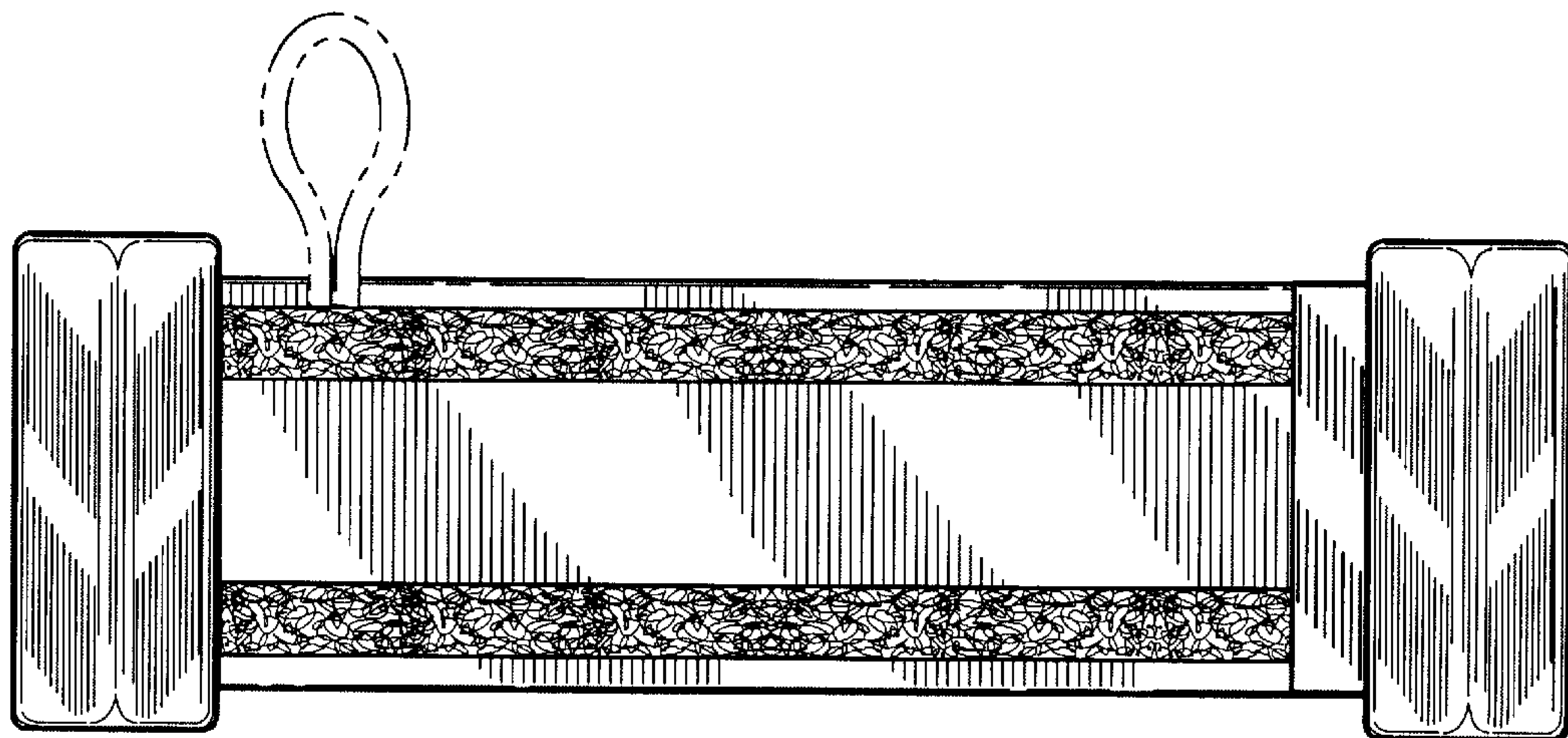

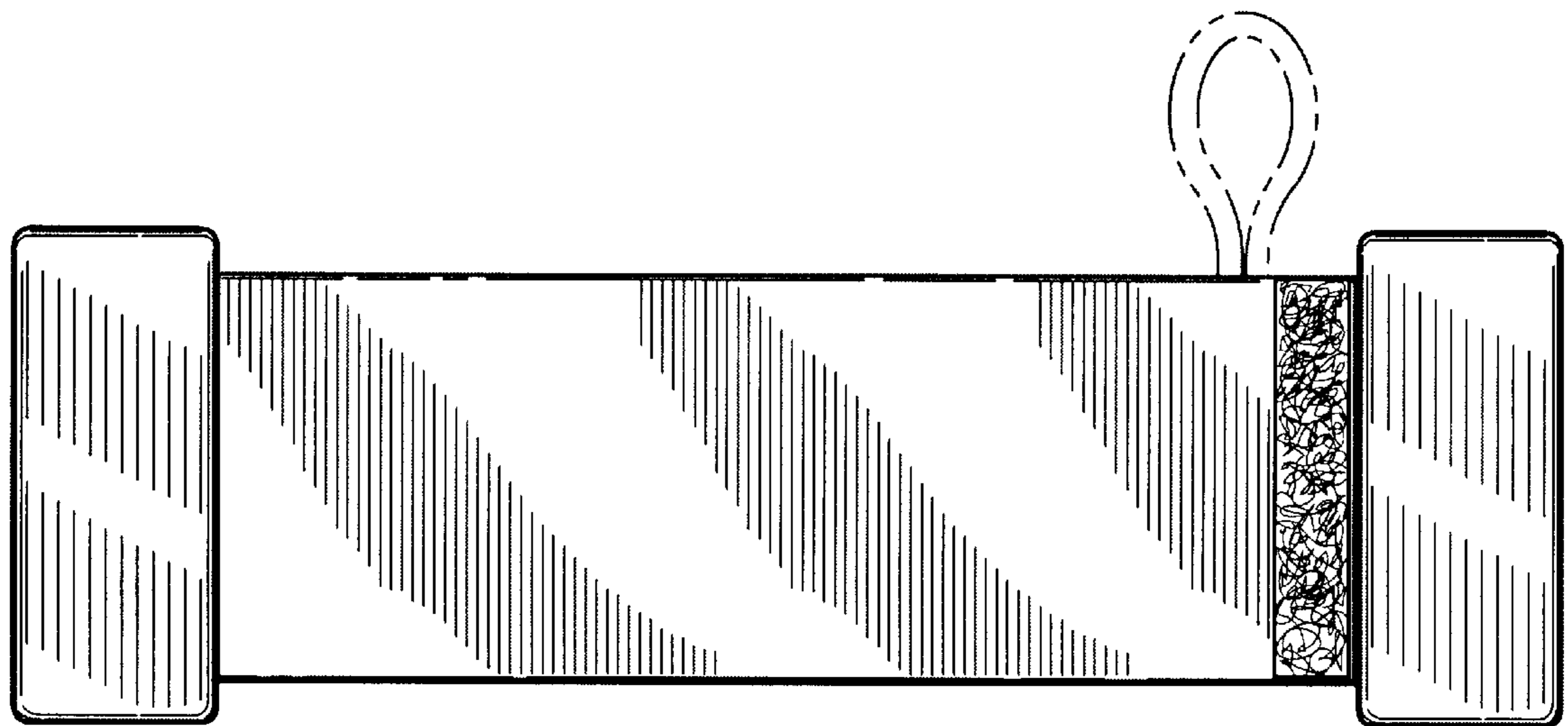
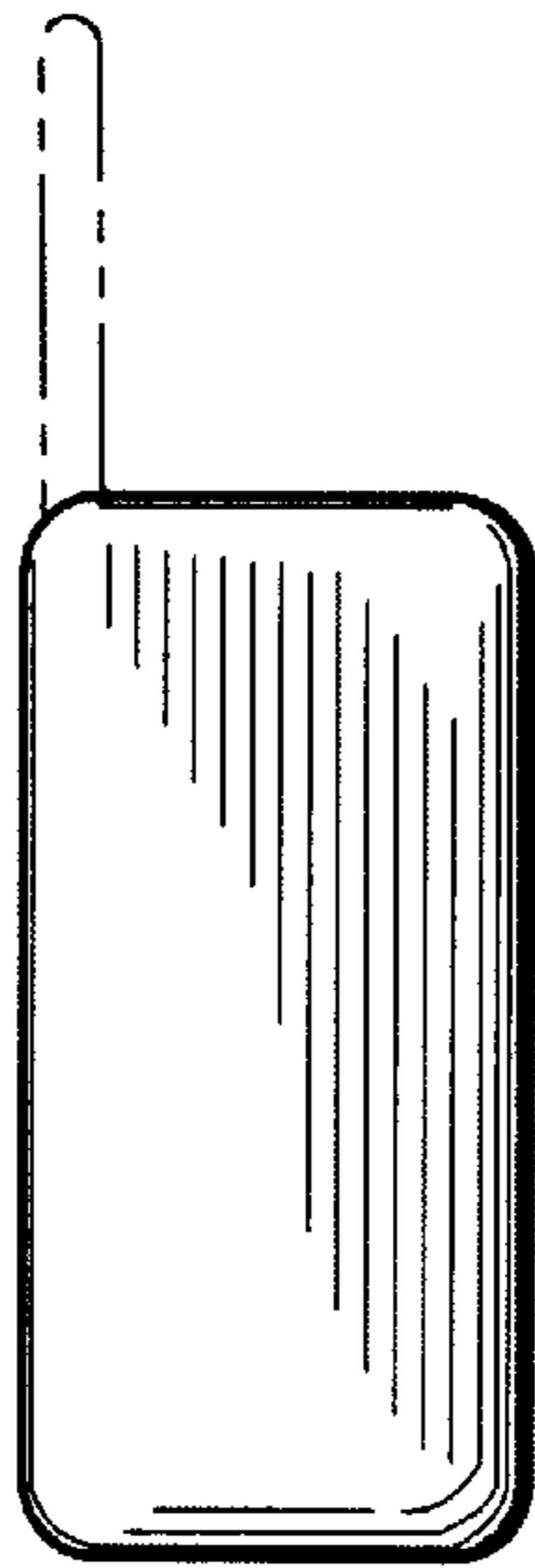

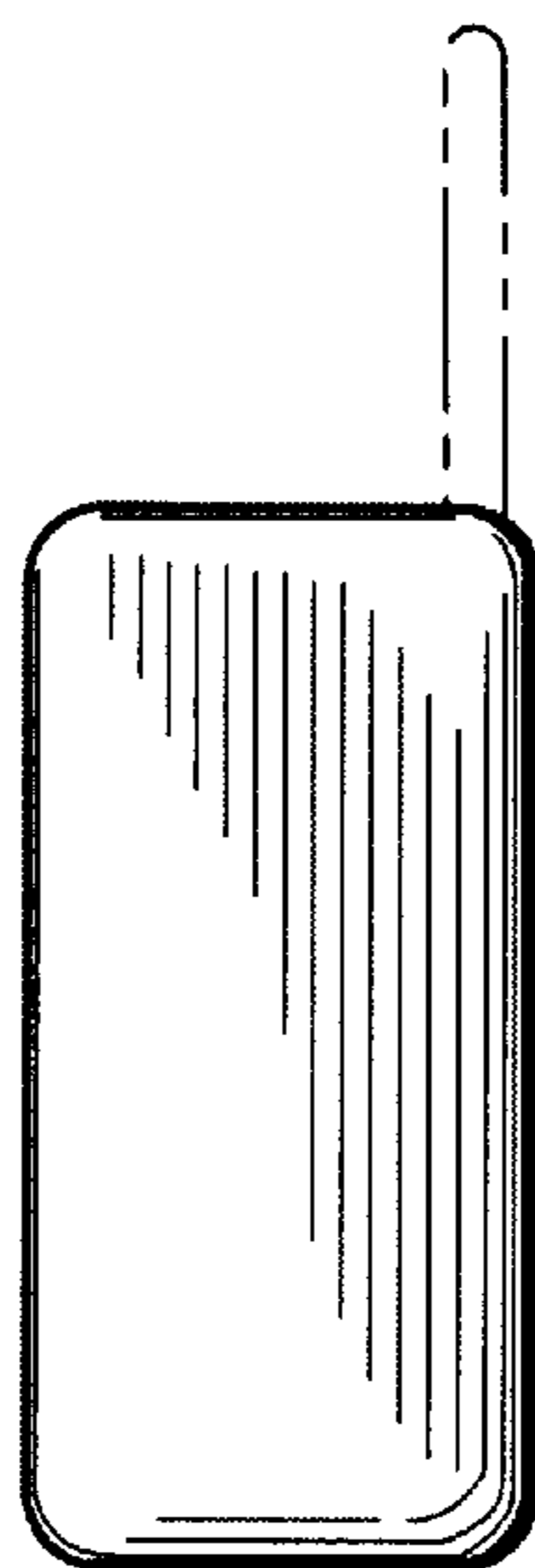

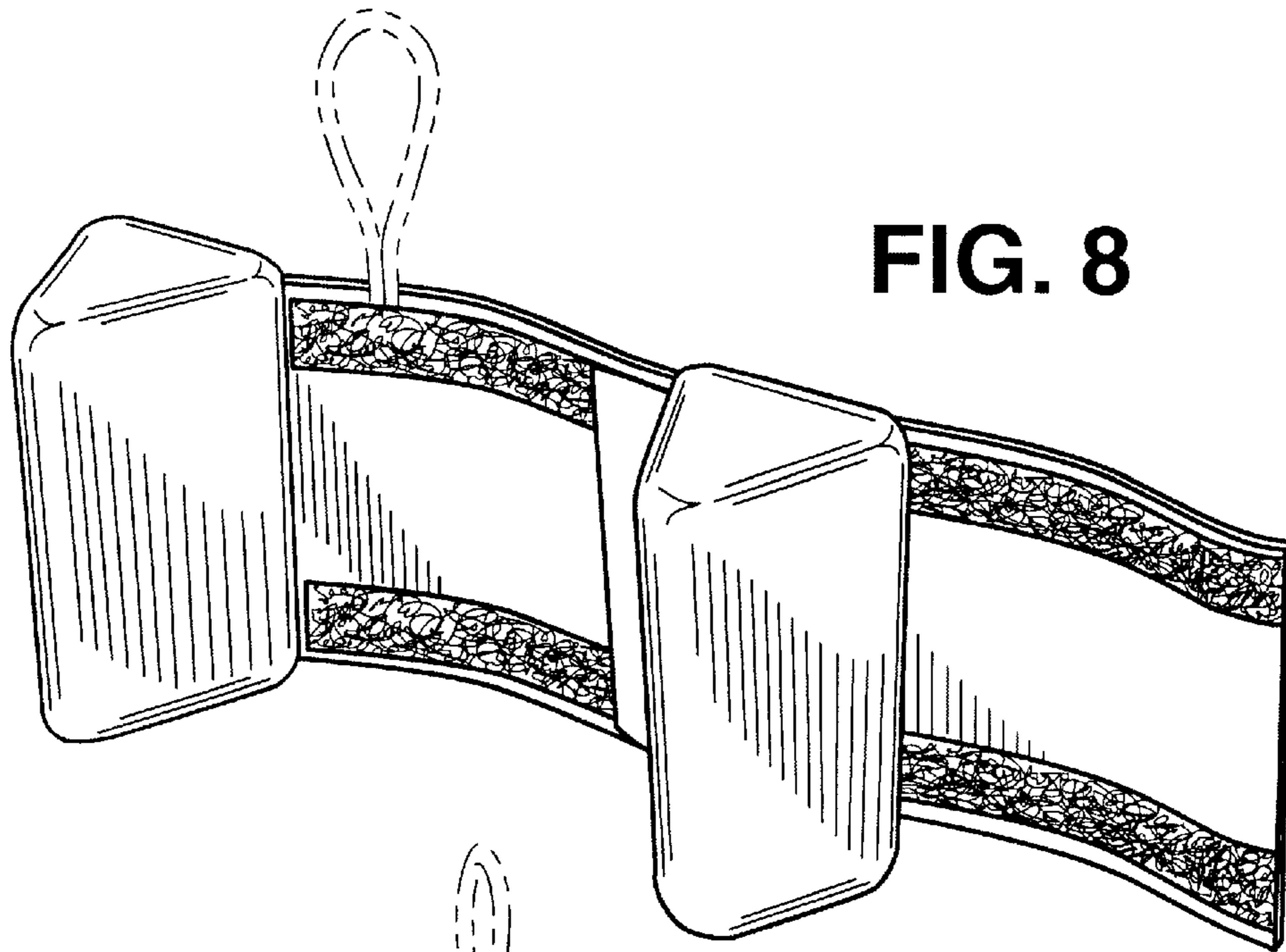
