(57) **CLAIM**

The ornamental design for a pillow having a spoon-shaped head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pillow having a spoon-shaped head showing my new design;

FIG. 2 is a front elevation view of the pillow of FIG. 1;

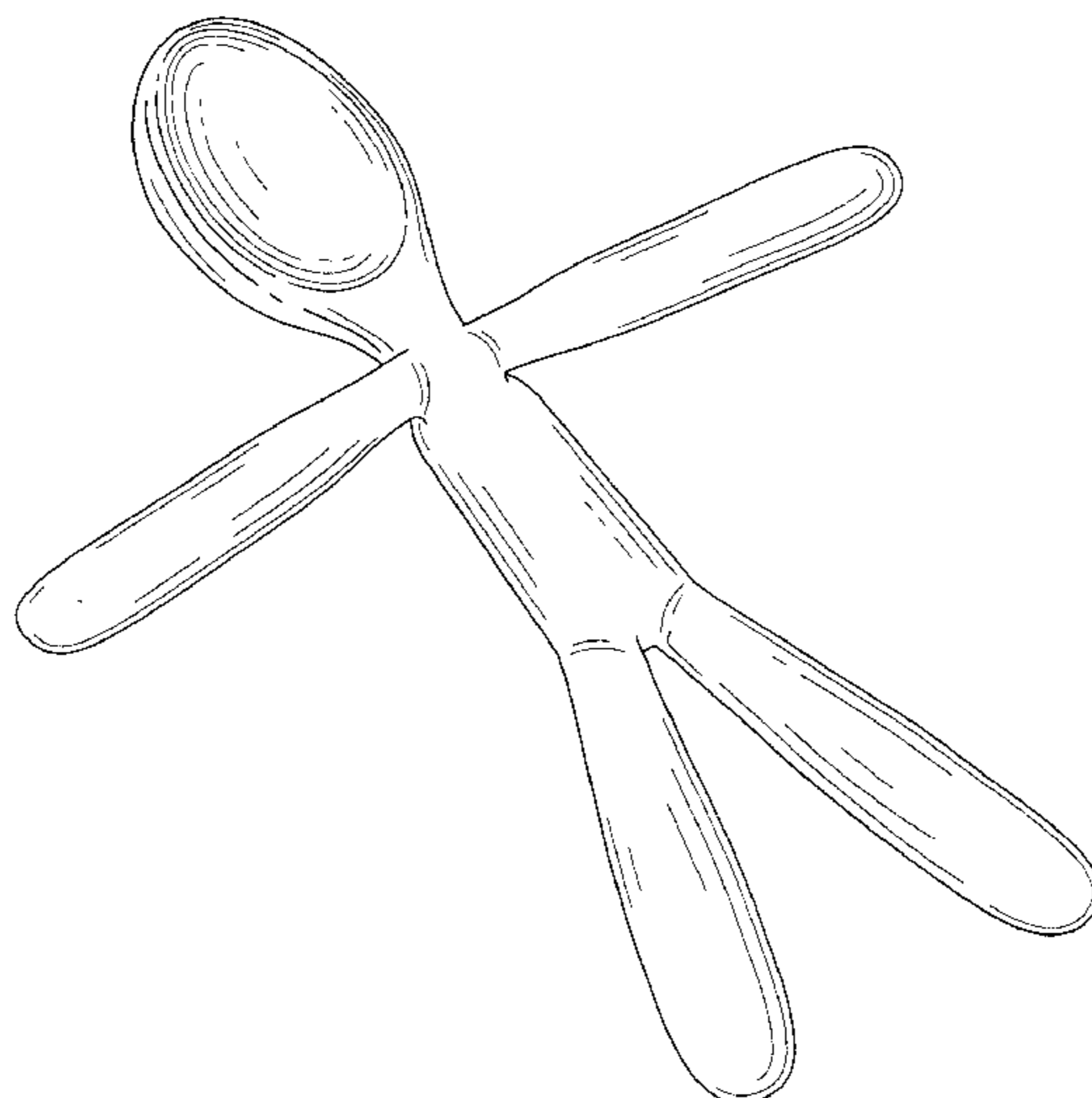
FIG. 3 is a back elevation view of the pillow of FIG. 1;

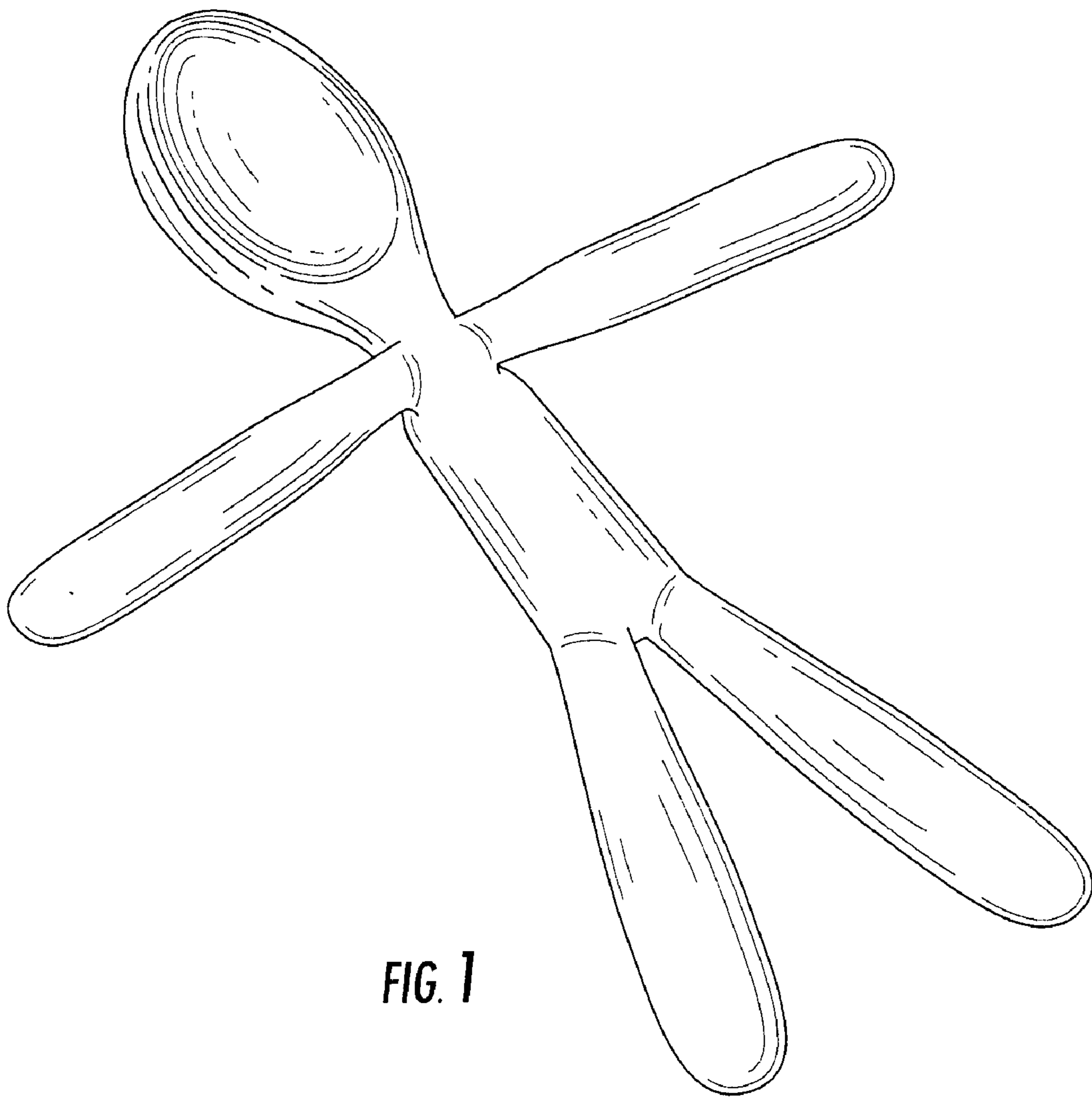
FIG. 4 is a side elevation view of the pillow of FIG. 1, the other side being a mirror image thereof.

FIG. 5 is a top elevation view of the pillow of FIG. 1; and,

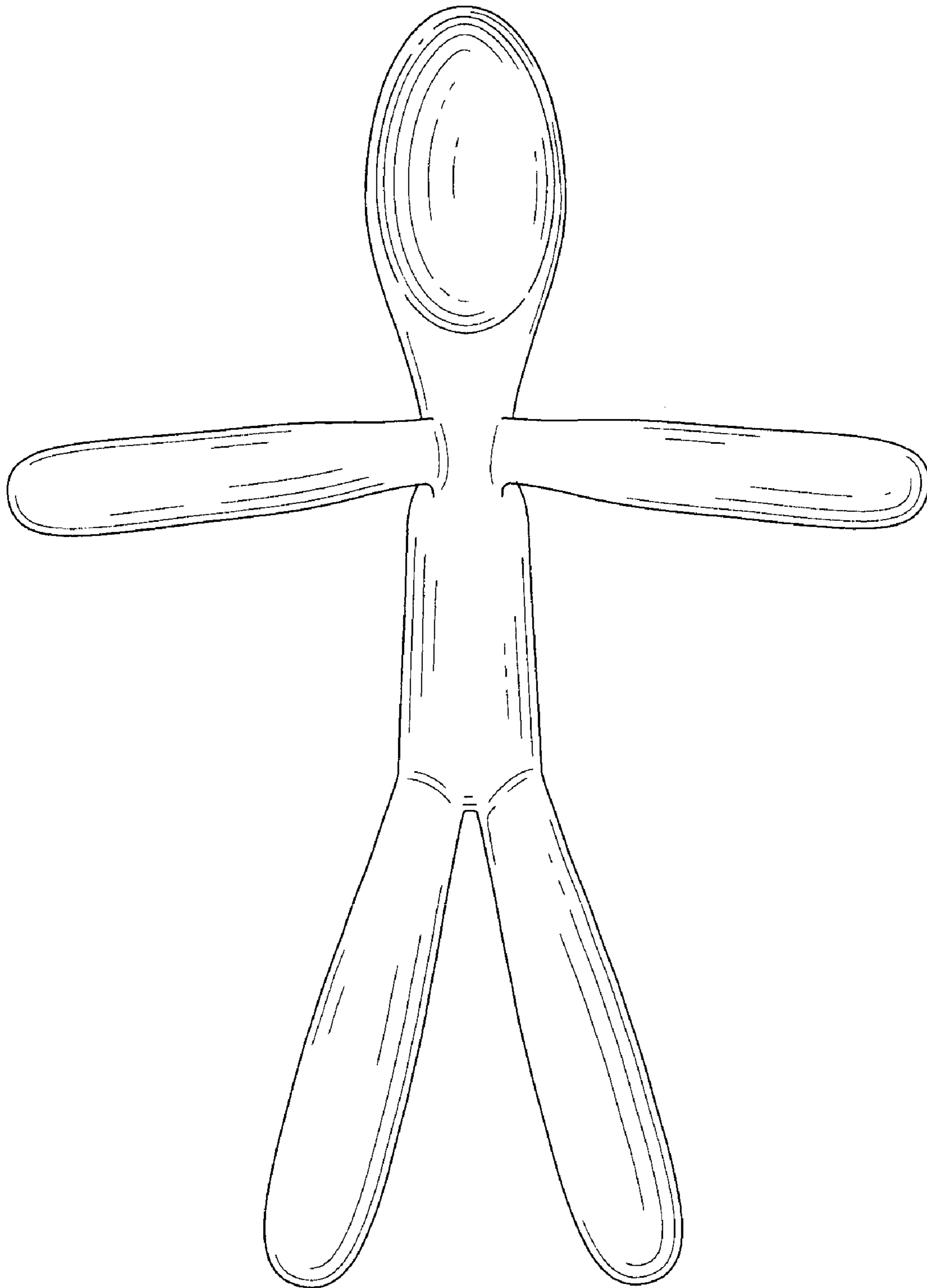
FIG. 6 is a bottom elevation view of the pillow of FIG. 1.

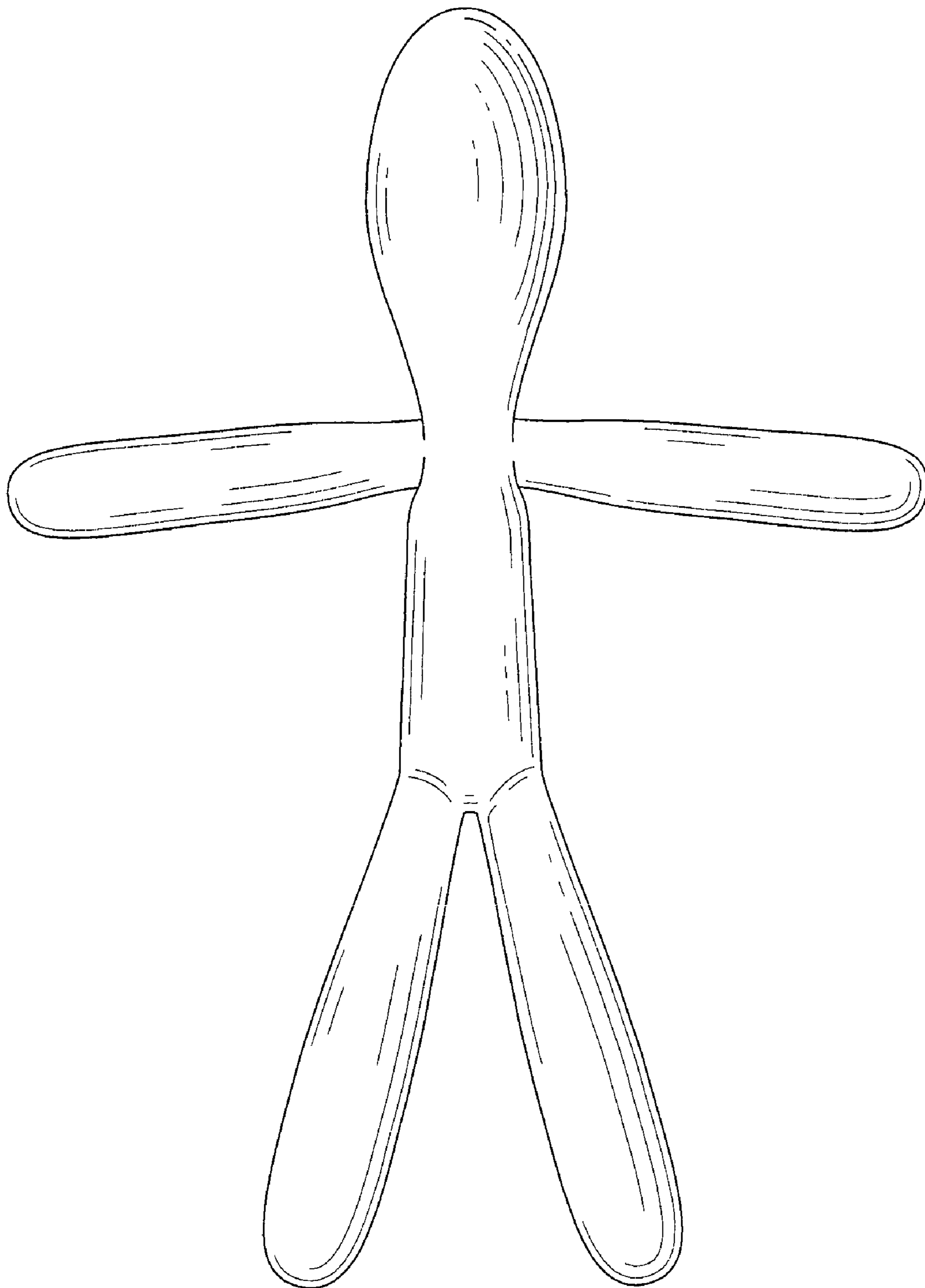

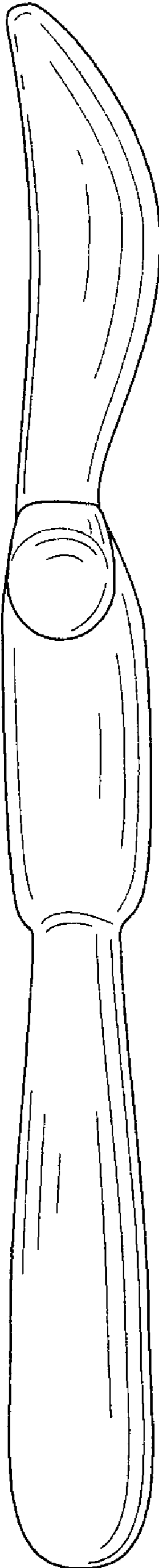

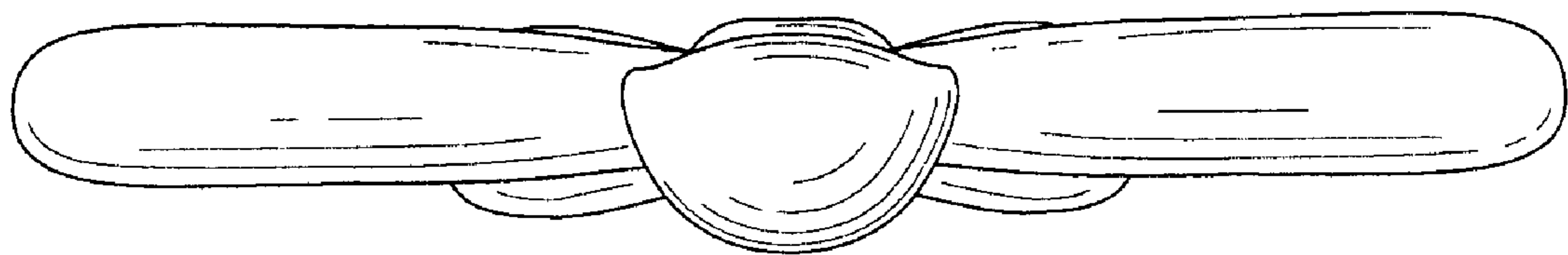

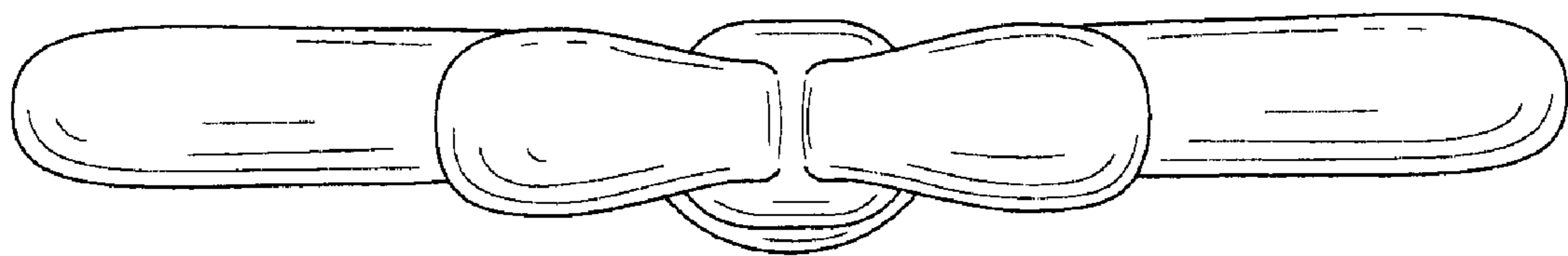
