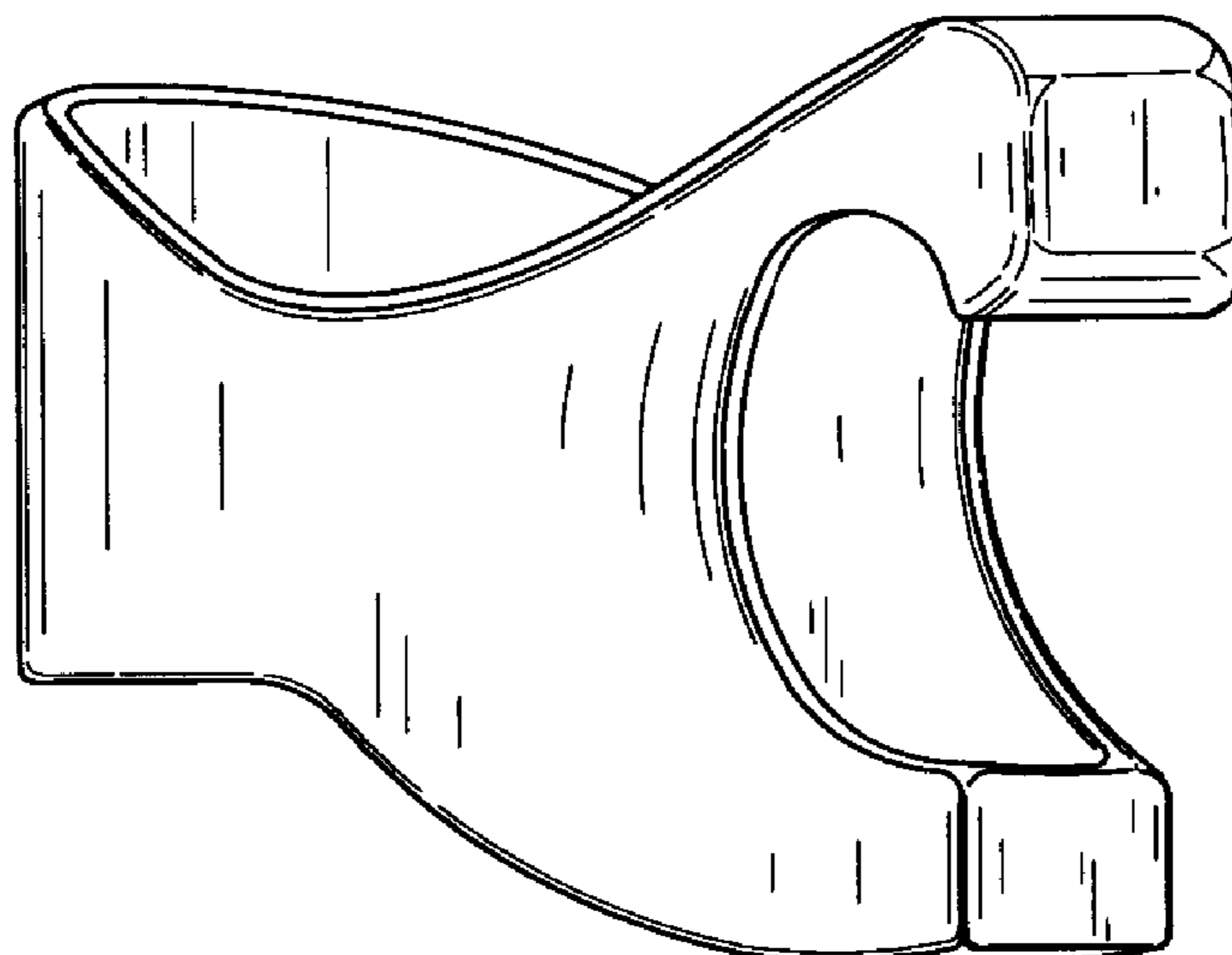
(57) **CLAIM**

The ornamental design for a bottle opener ring, as shown
and described.

DESCRIPTION

FIG. 1 is front elevation view of a bottle opener ring
showing our new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a side elevation view thereof, the opposite side
view being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a perspective view thereof.

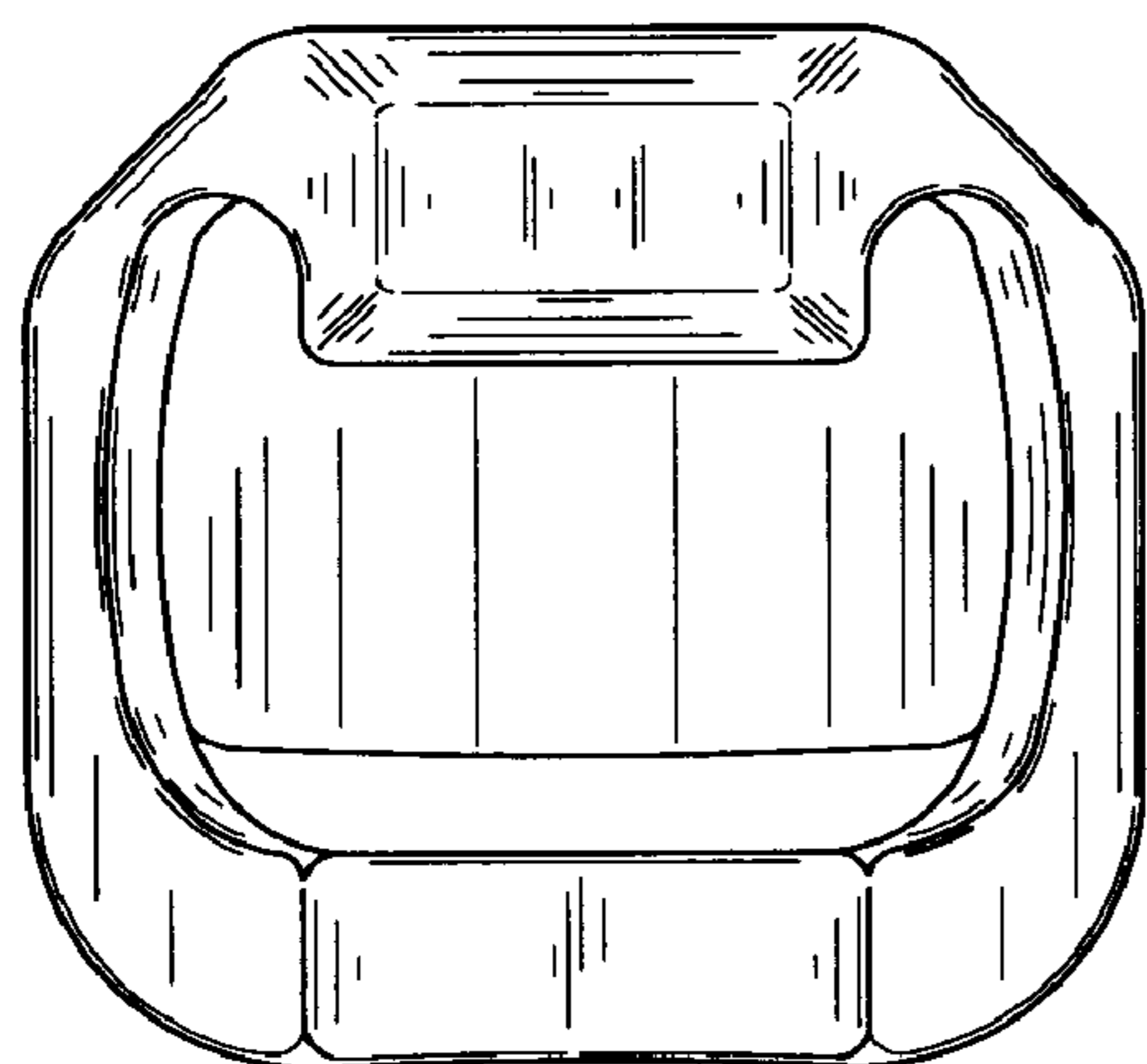

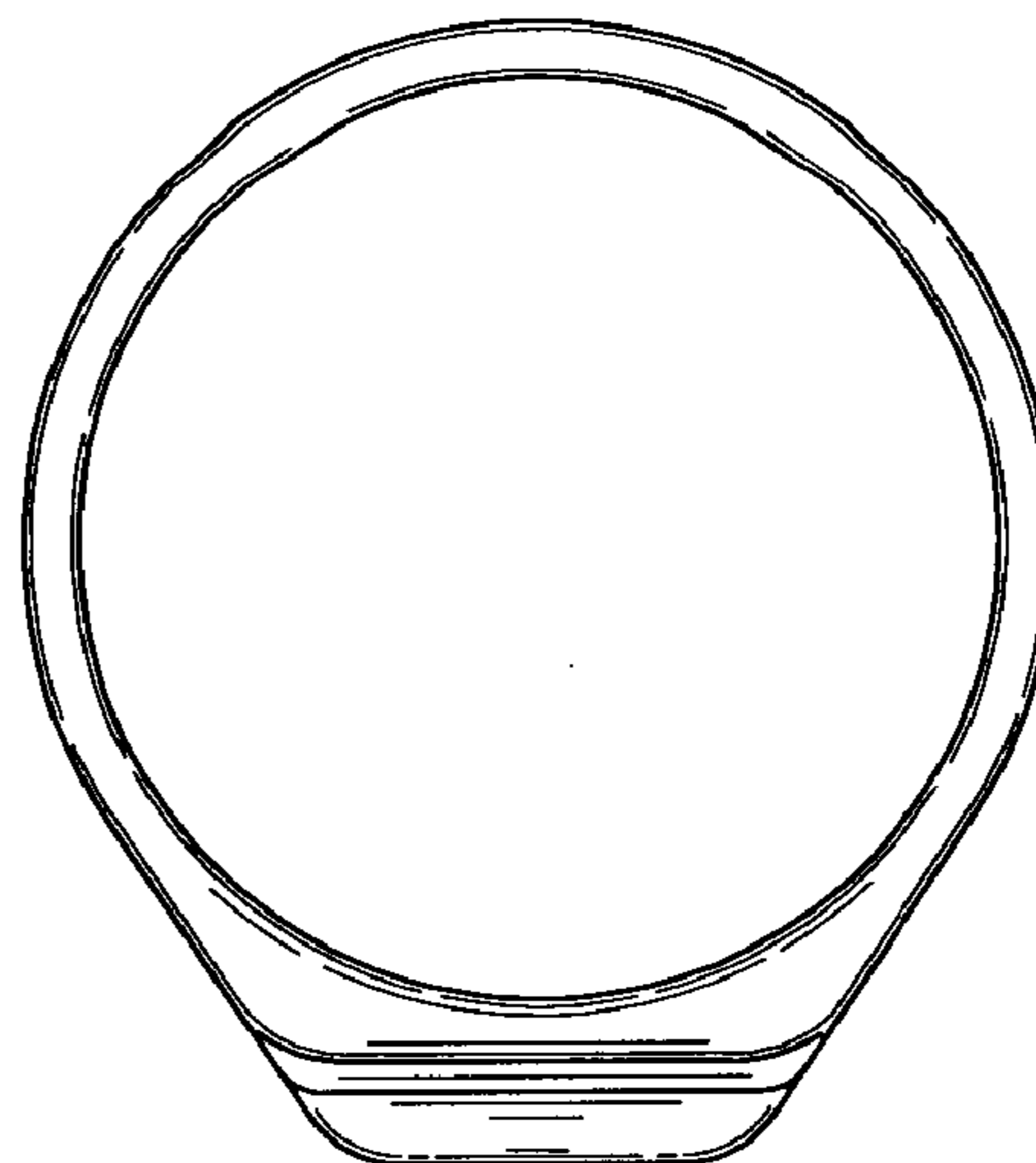

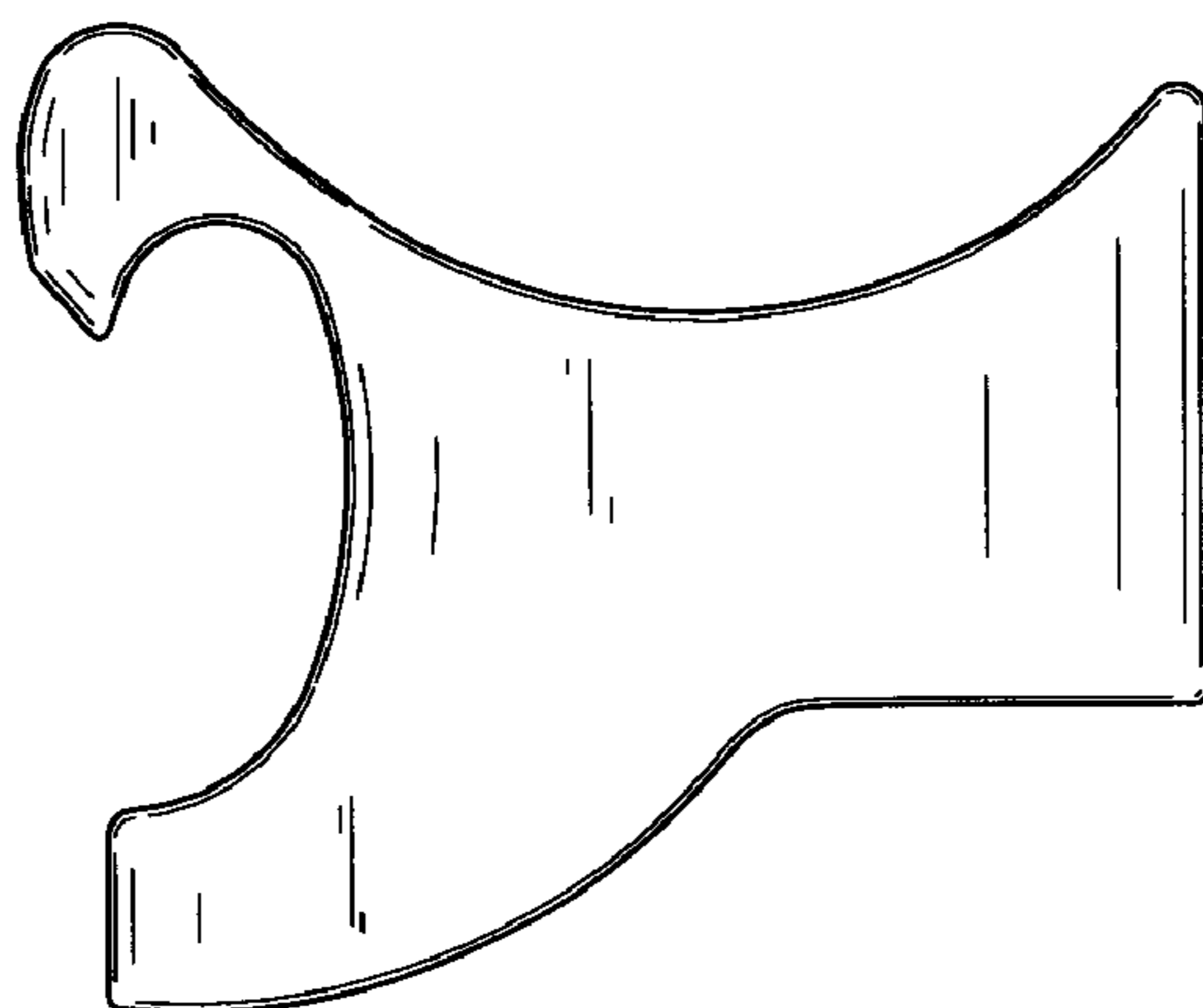

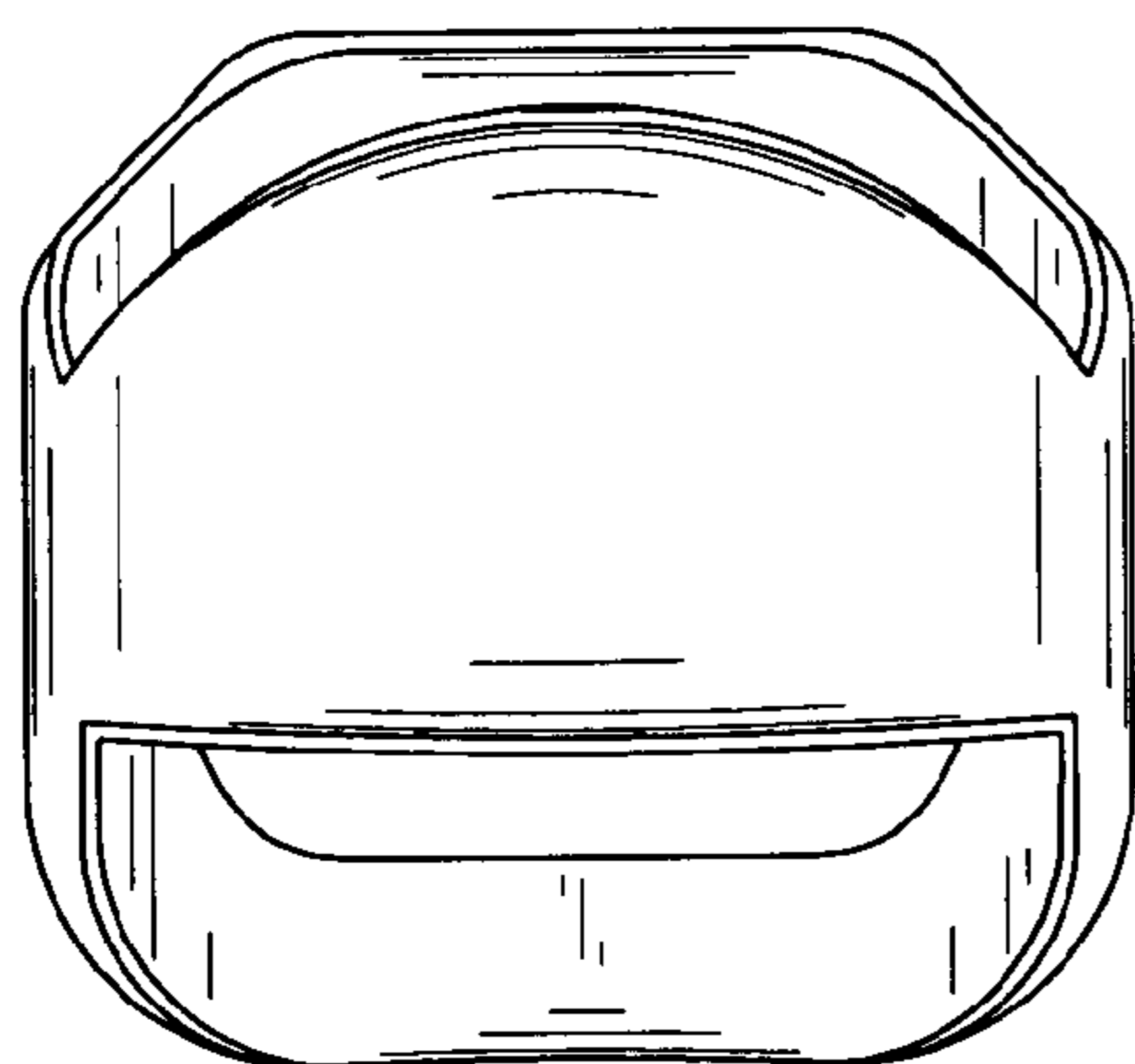

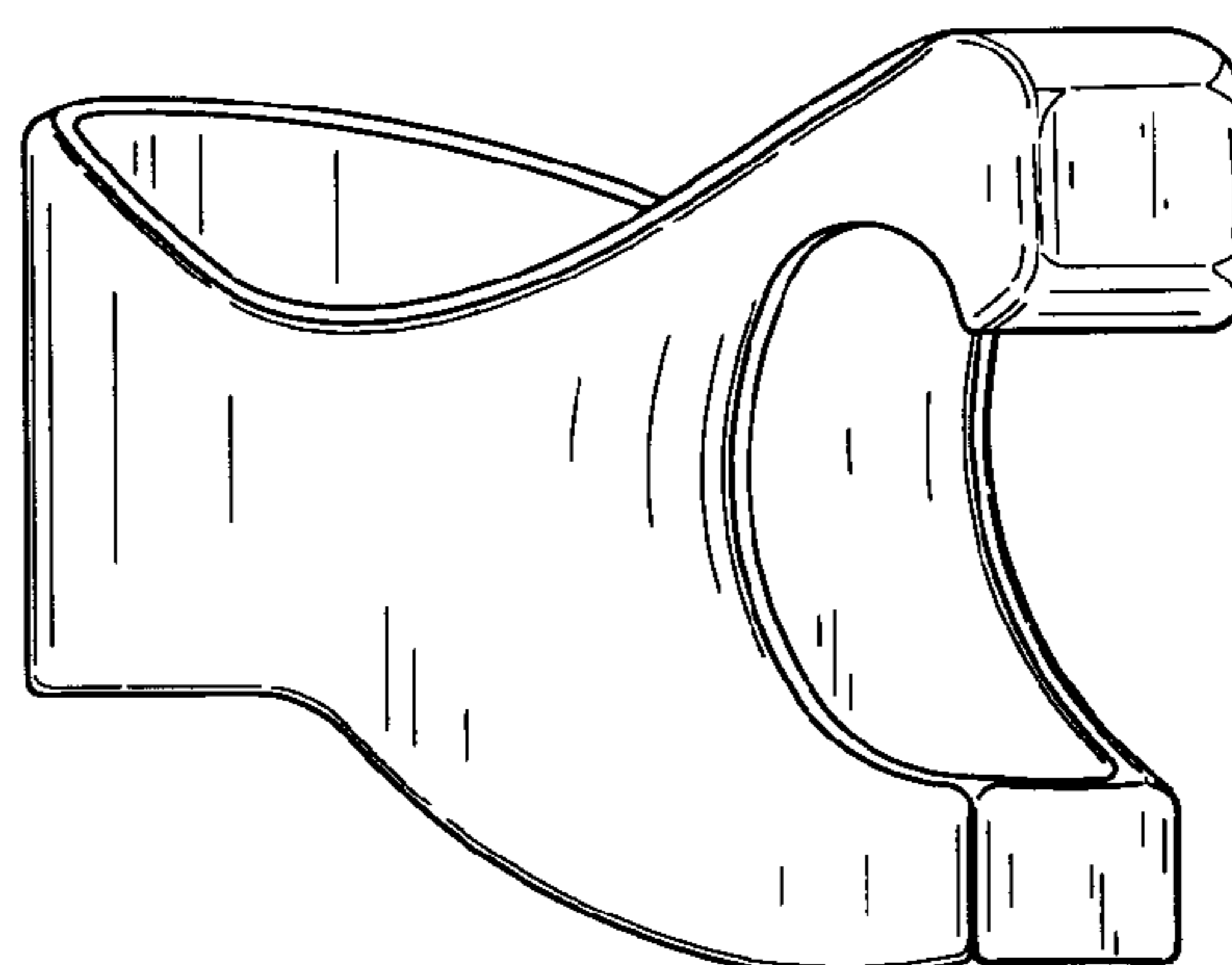

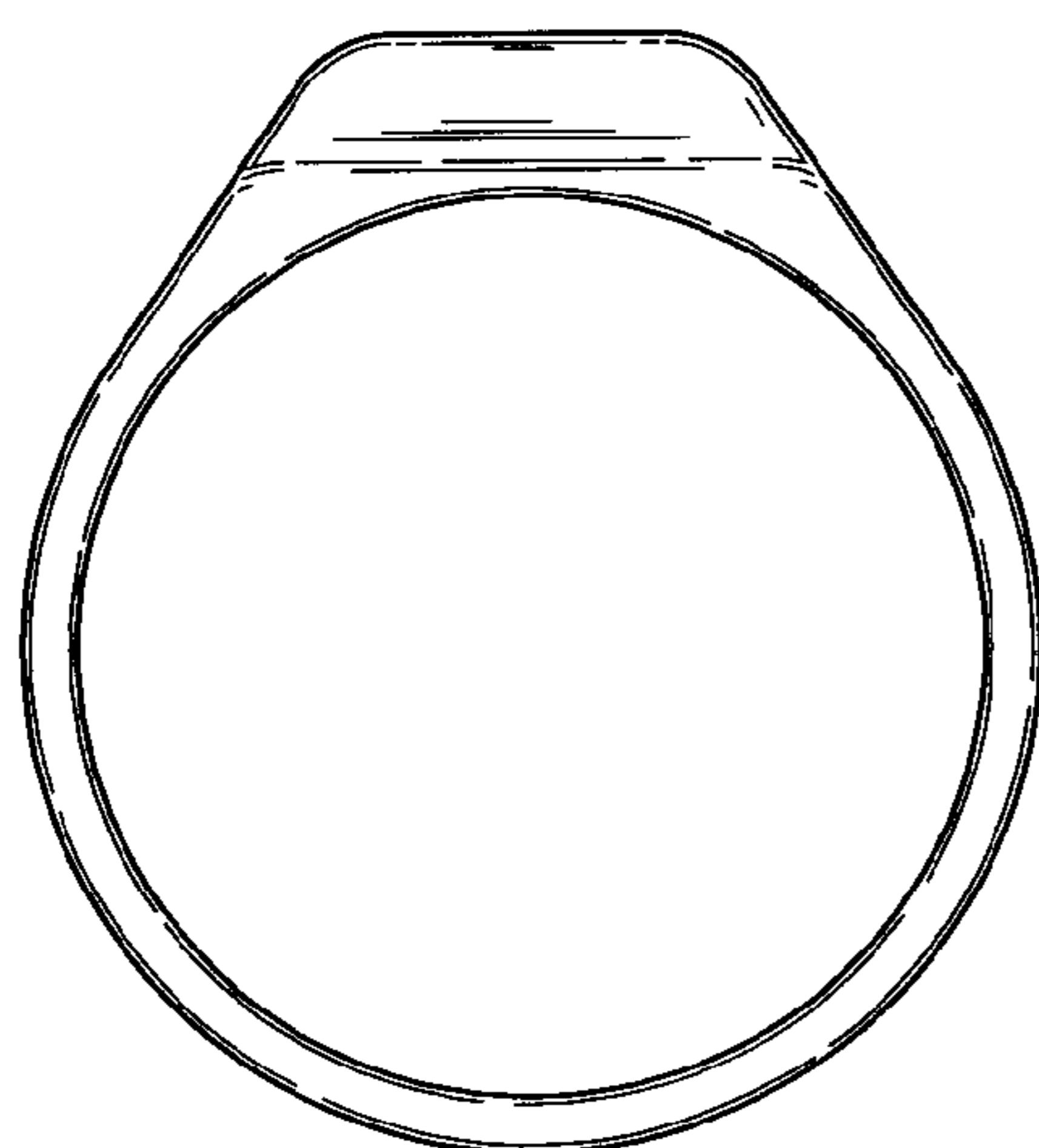
