We claim the ornamental design for a container with lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container with lid showing our new design;
FIG. 2 is a front elevational view thereof, the rear, left and right views being identical thereto;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is an exploded perspective view of FIG. 1;
FIG. 6 is an exploded front elevational view of FIG. 1, the rear, left and right views being identical thereto;
FIG. 7 is top plan view of FIG. 1 with the lid removed; and,
FIG. 8 is bottom plan view of the lid of FIG. 1.

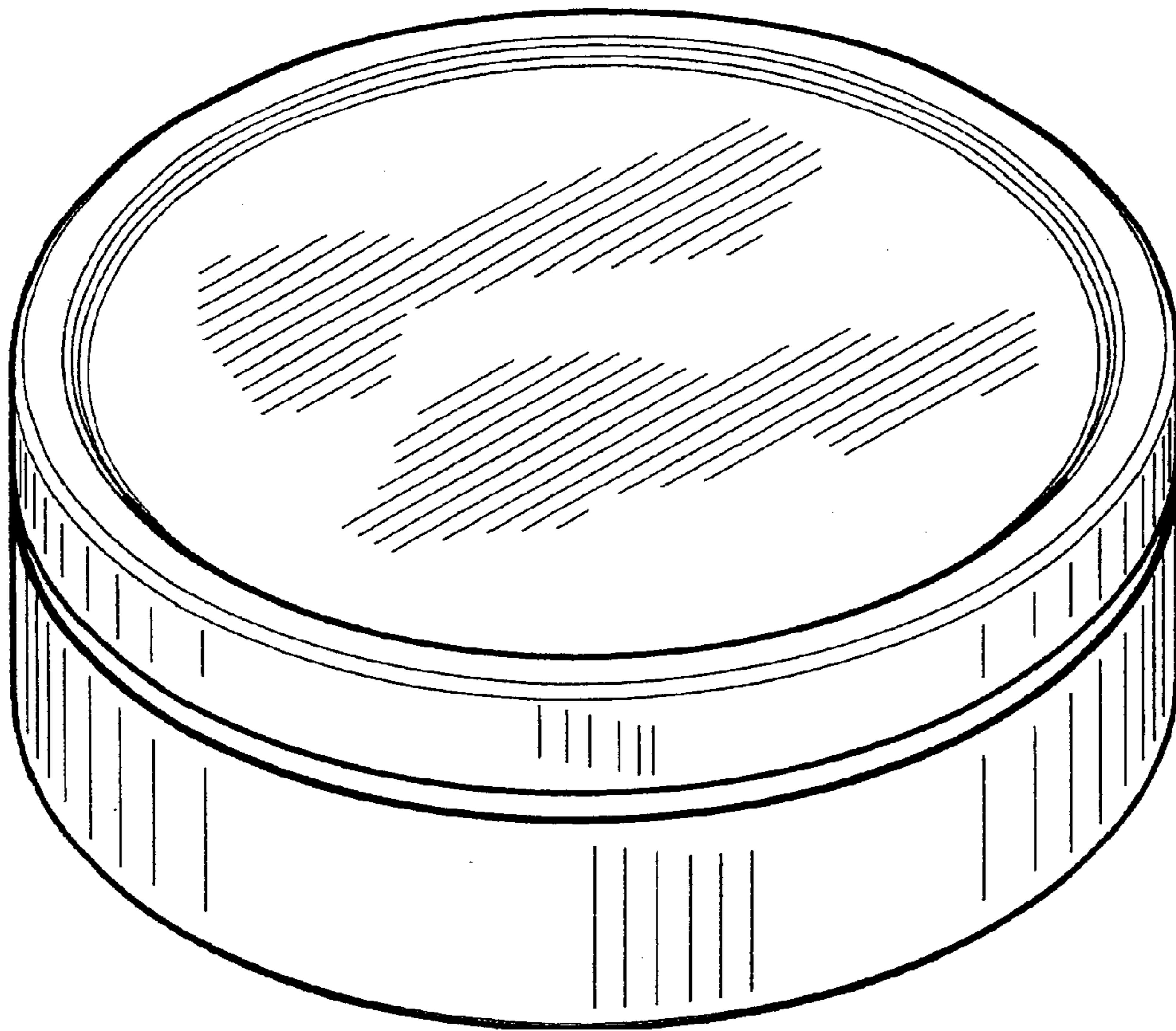

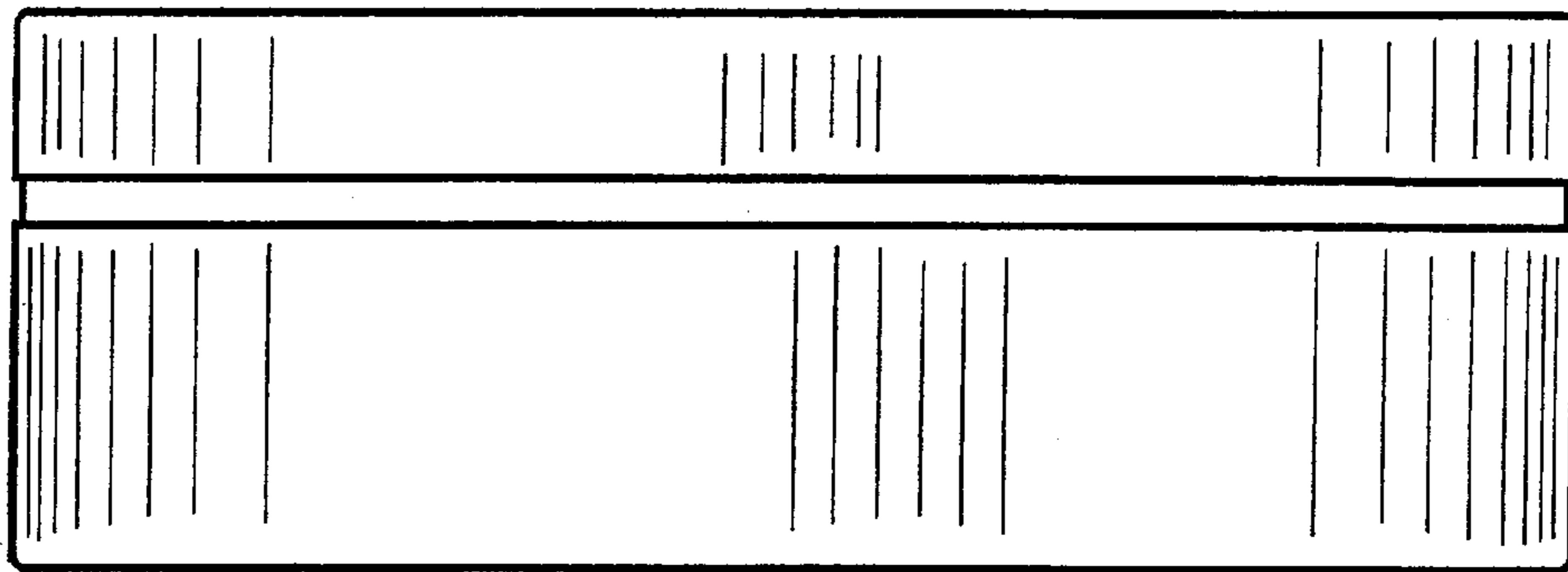

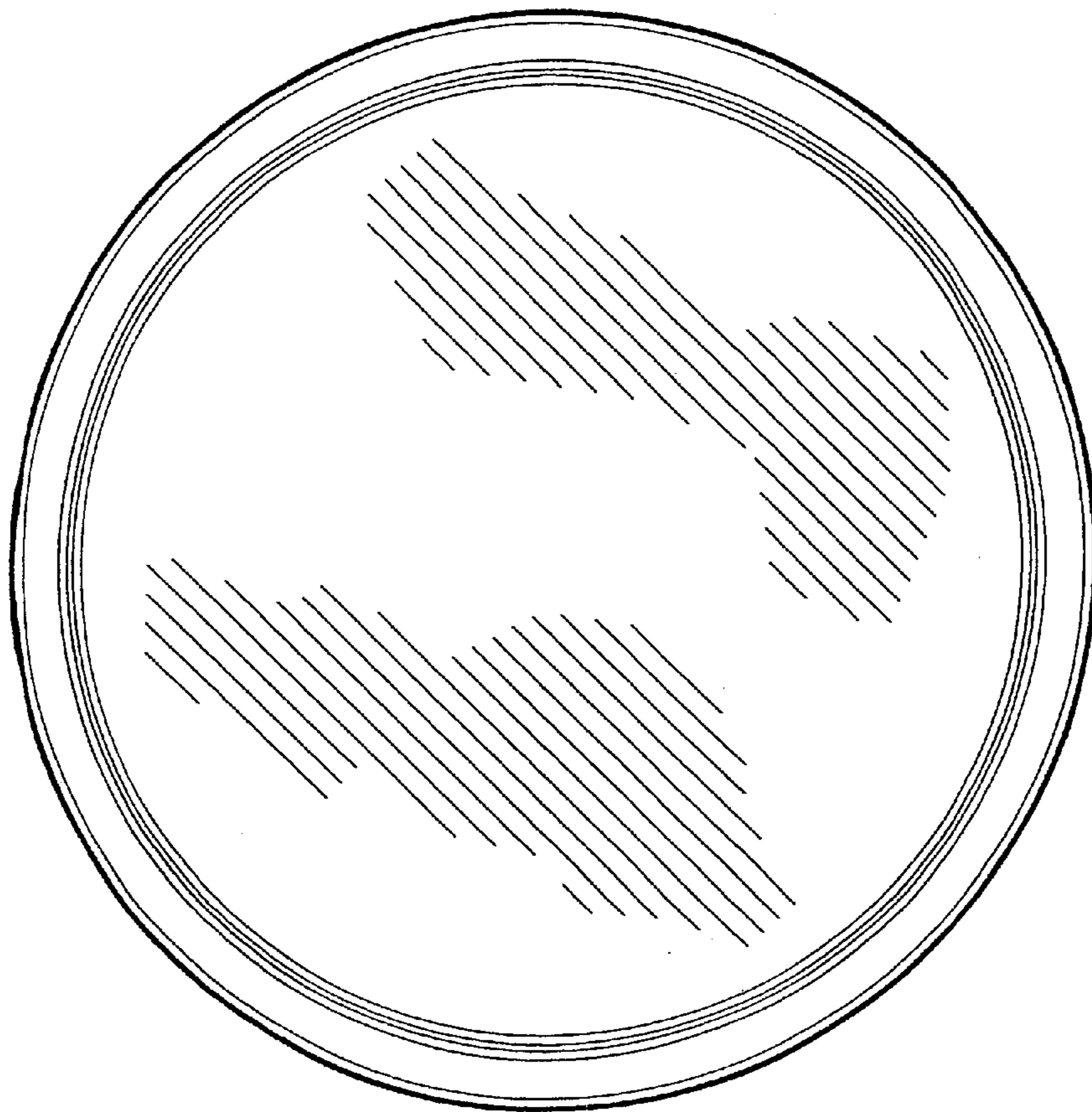

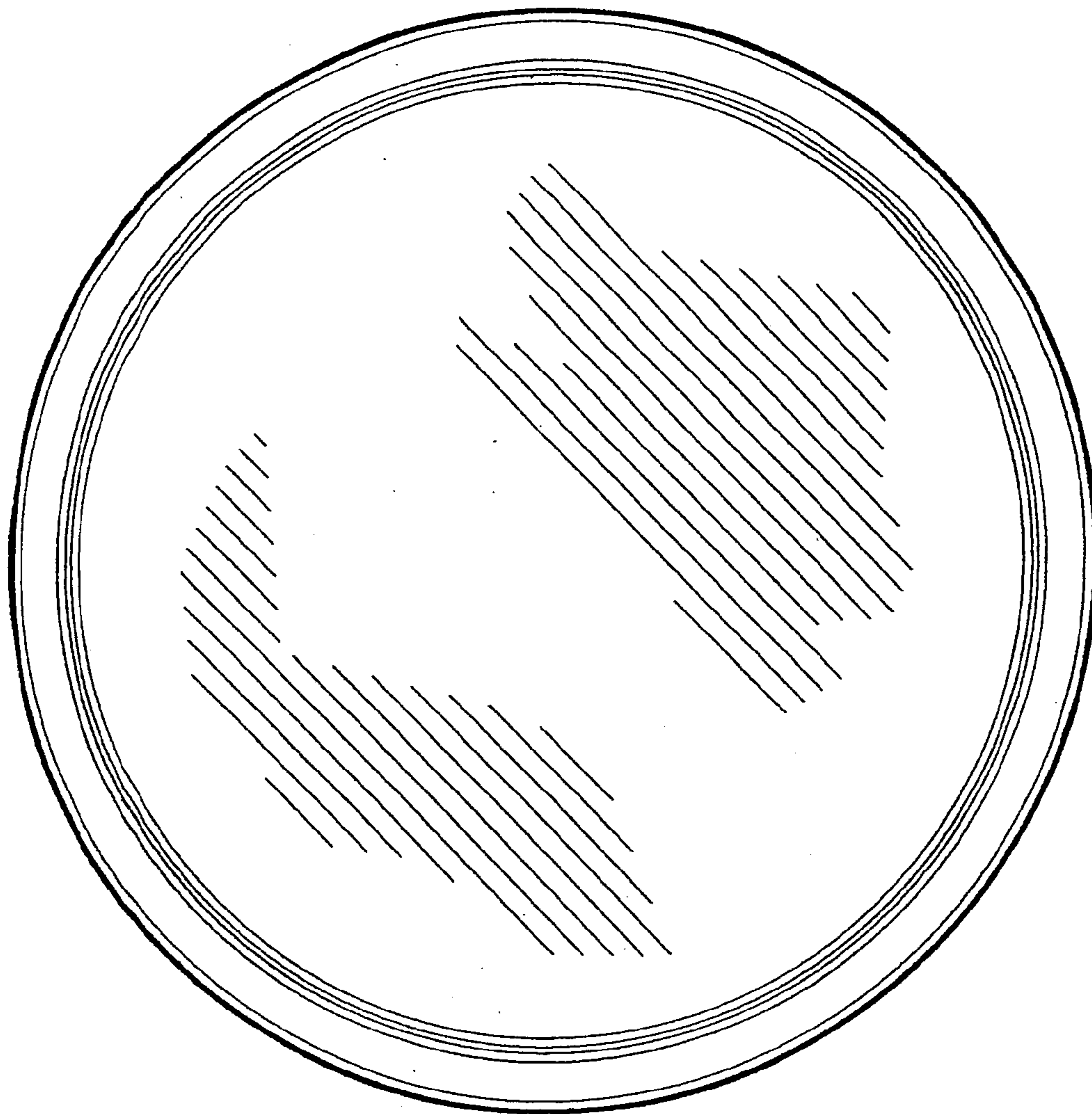

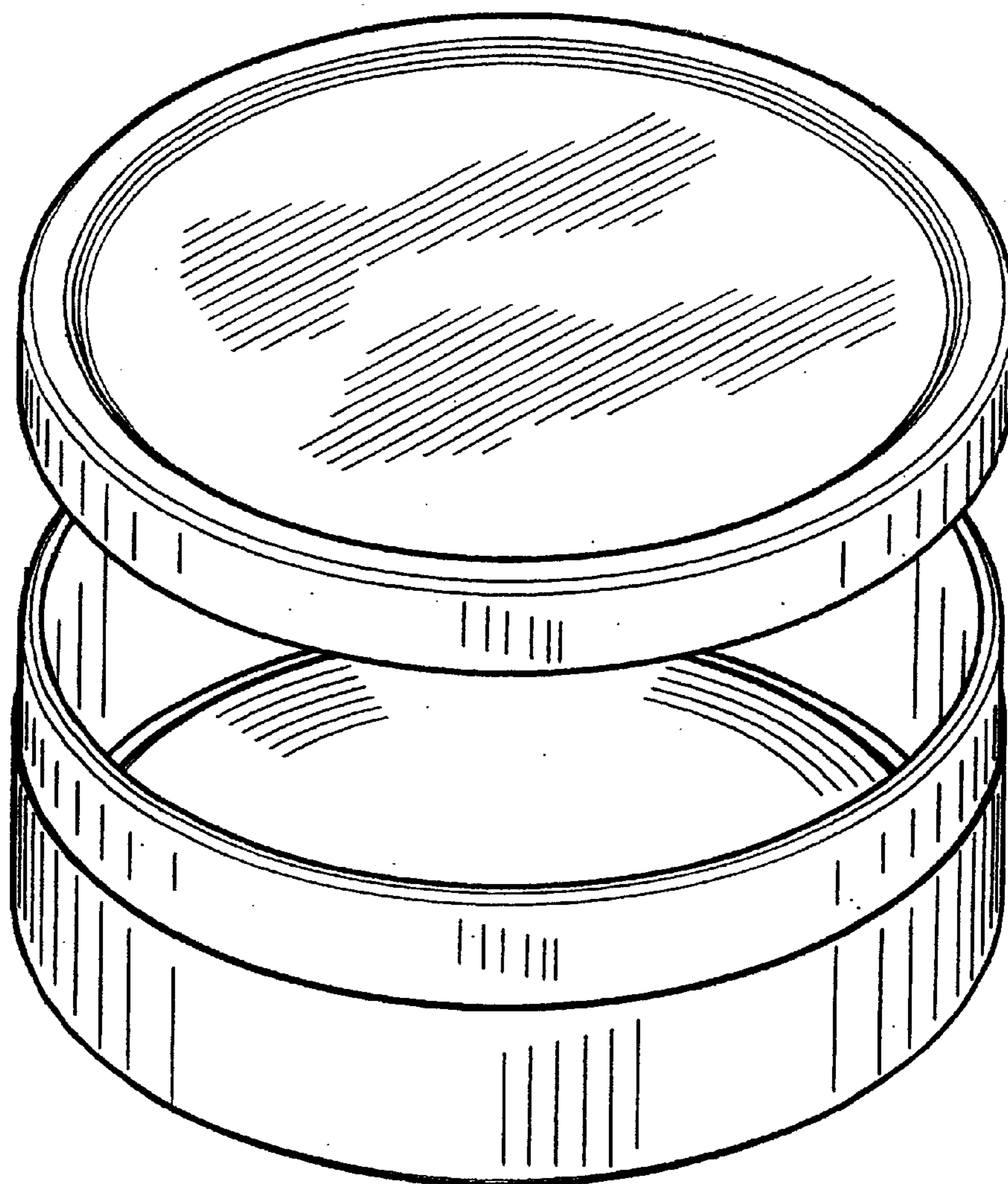

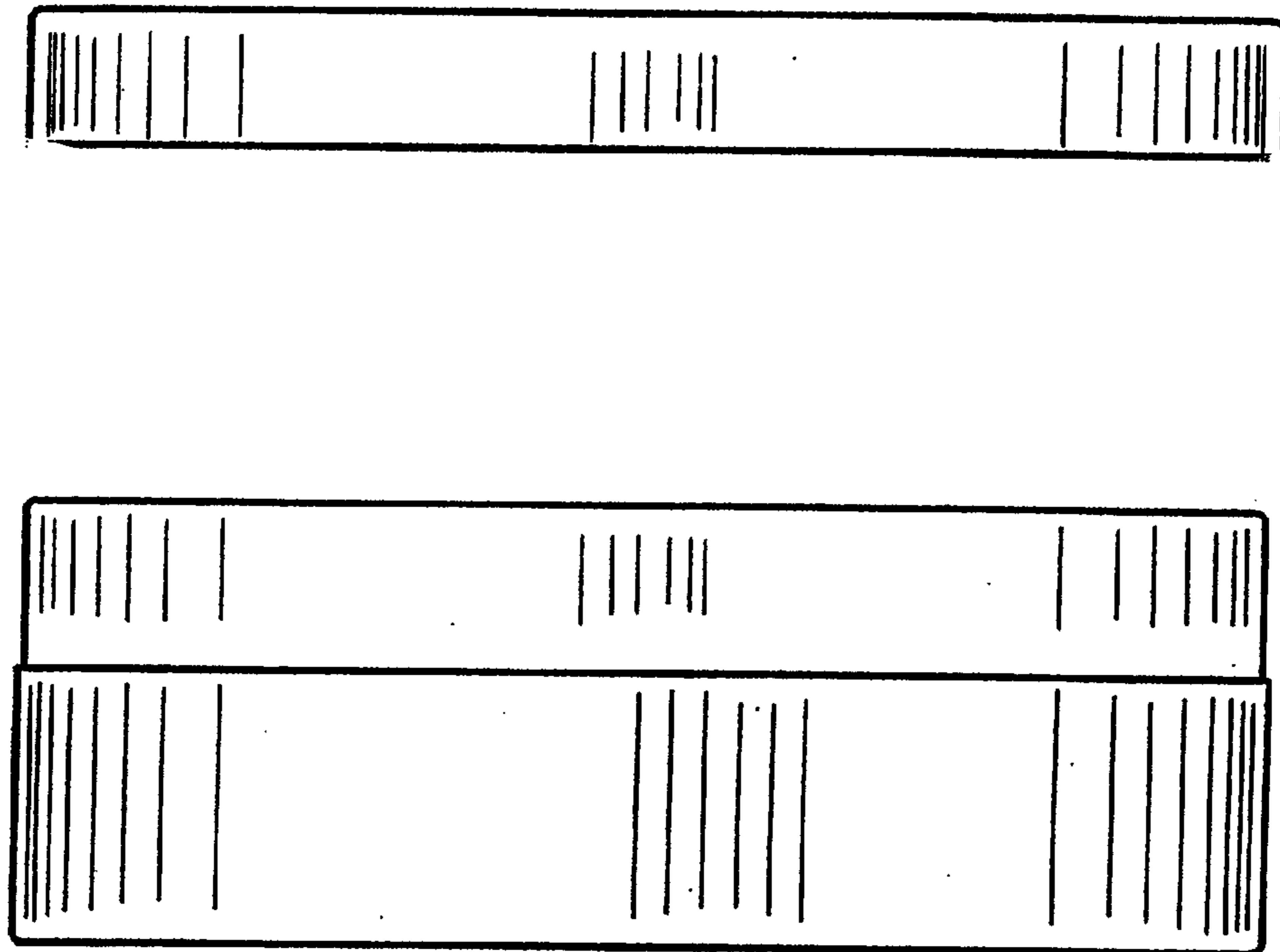

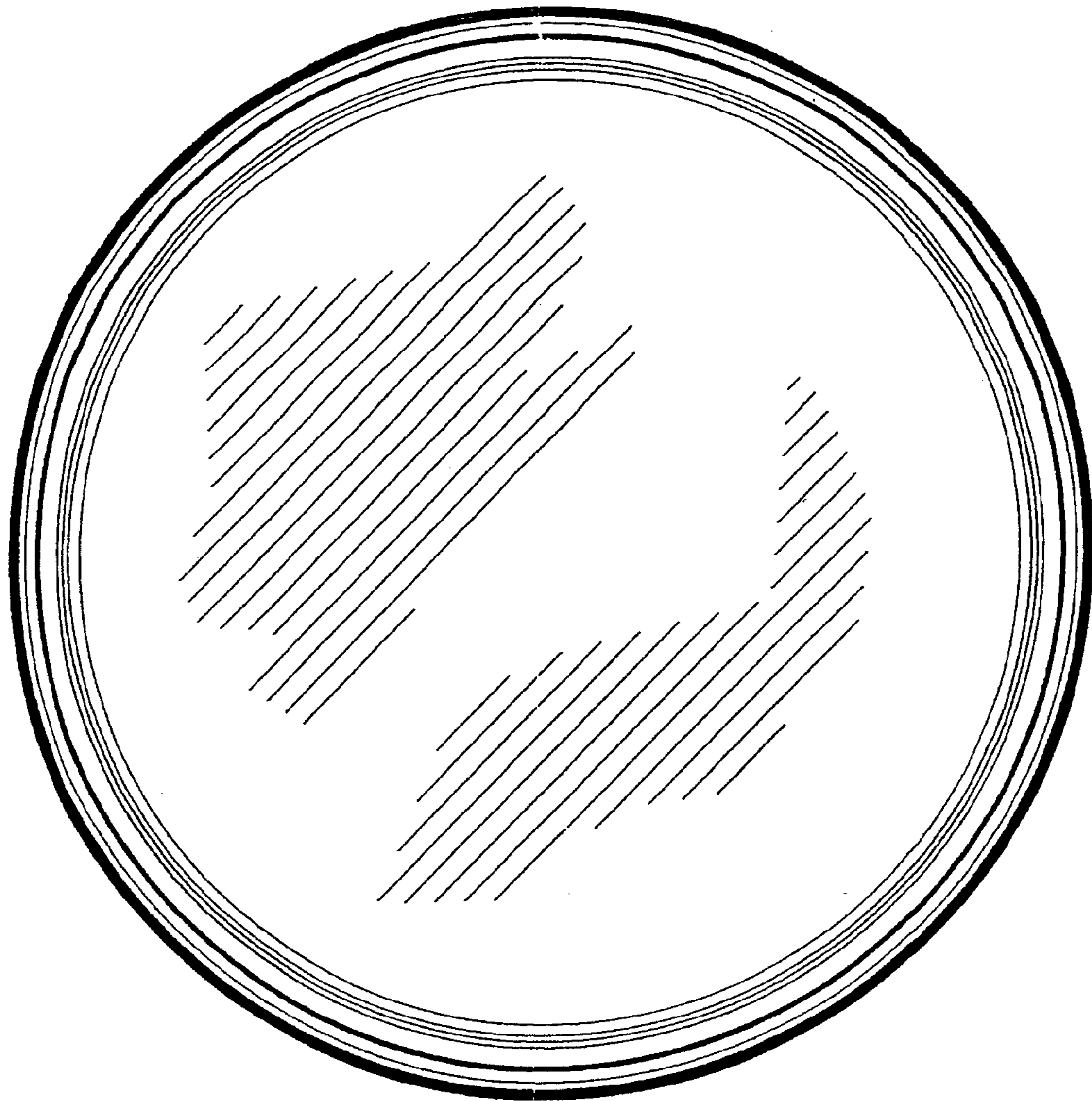

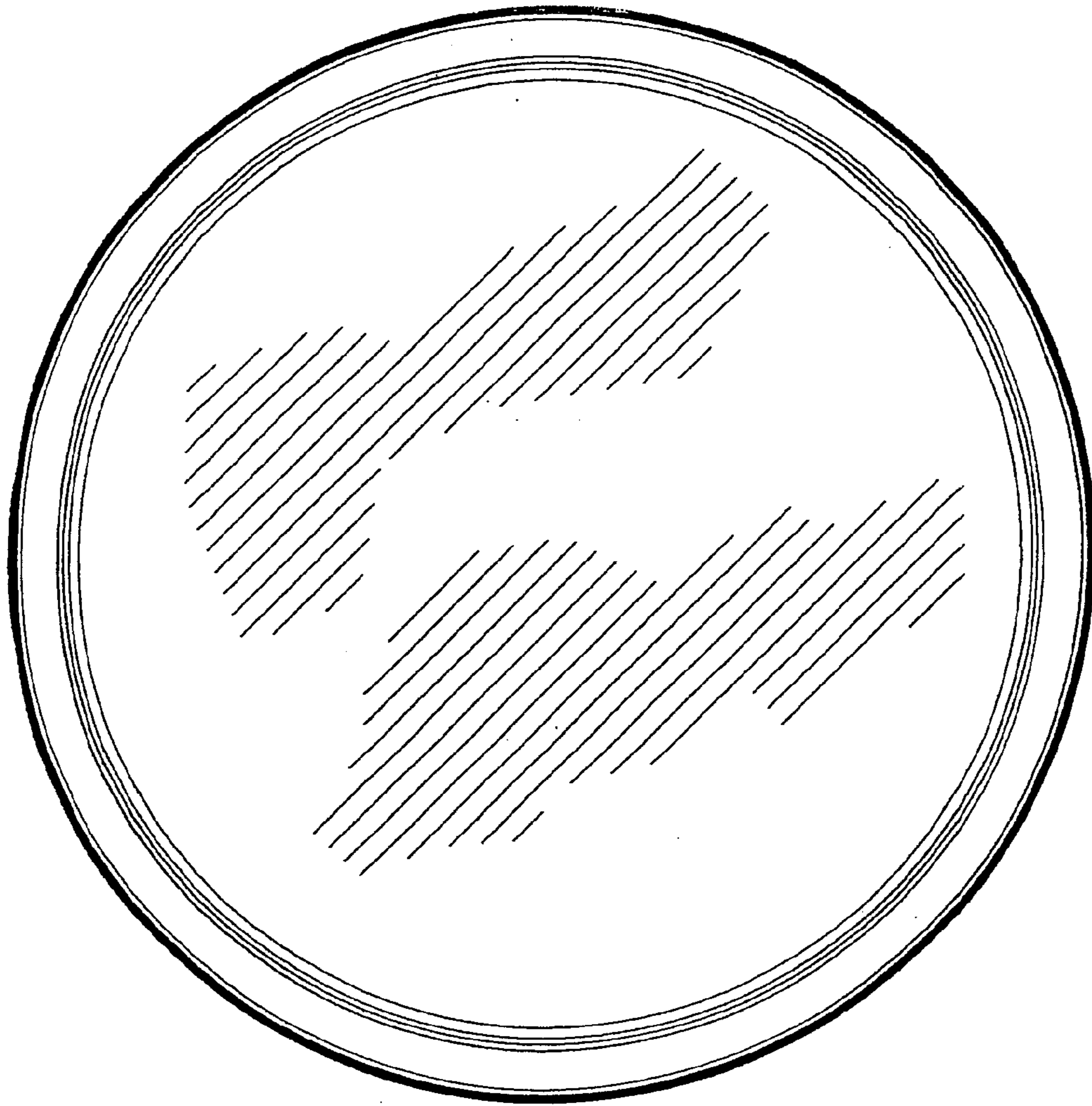
