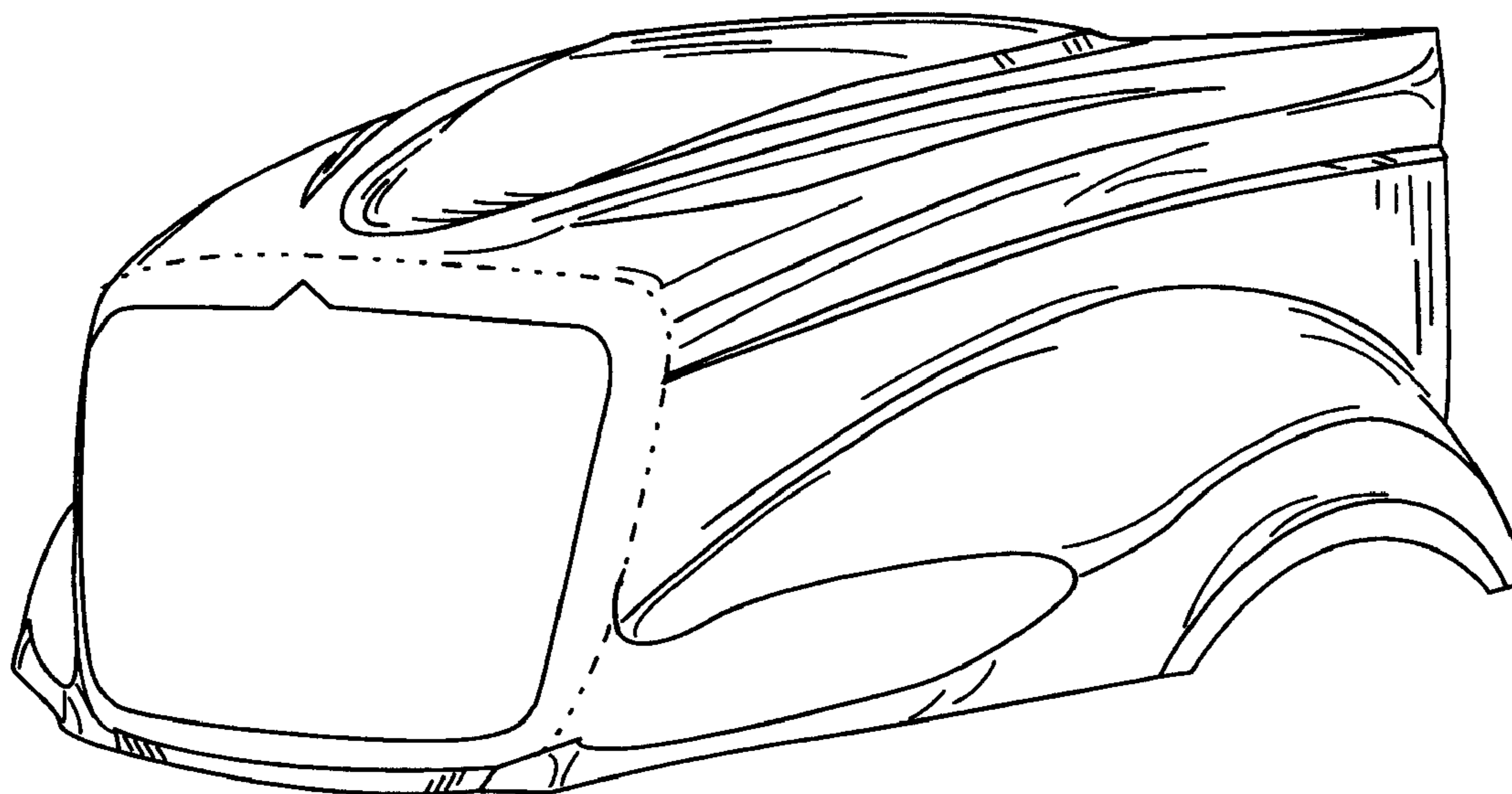
The ornamental design for a hood of a truck vehicle, as shown and described.

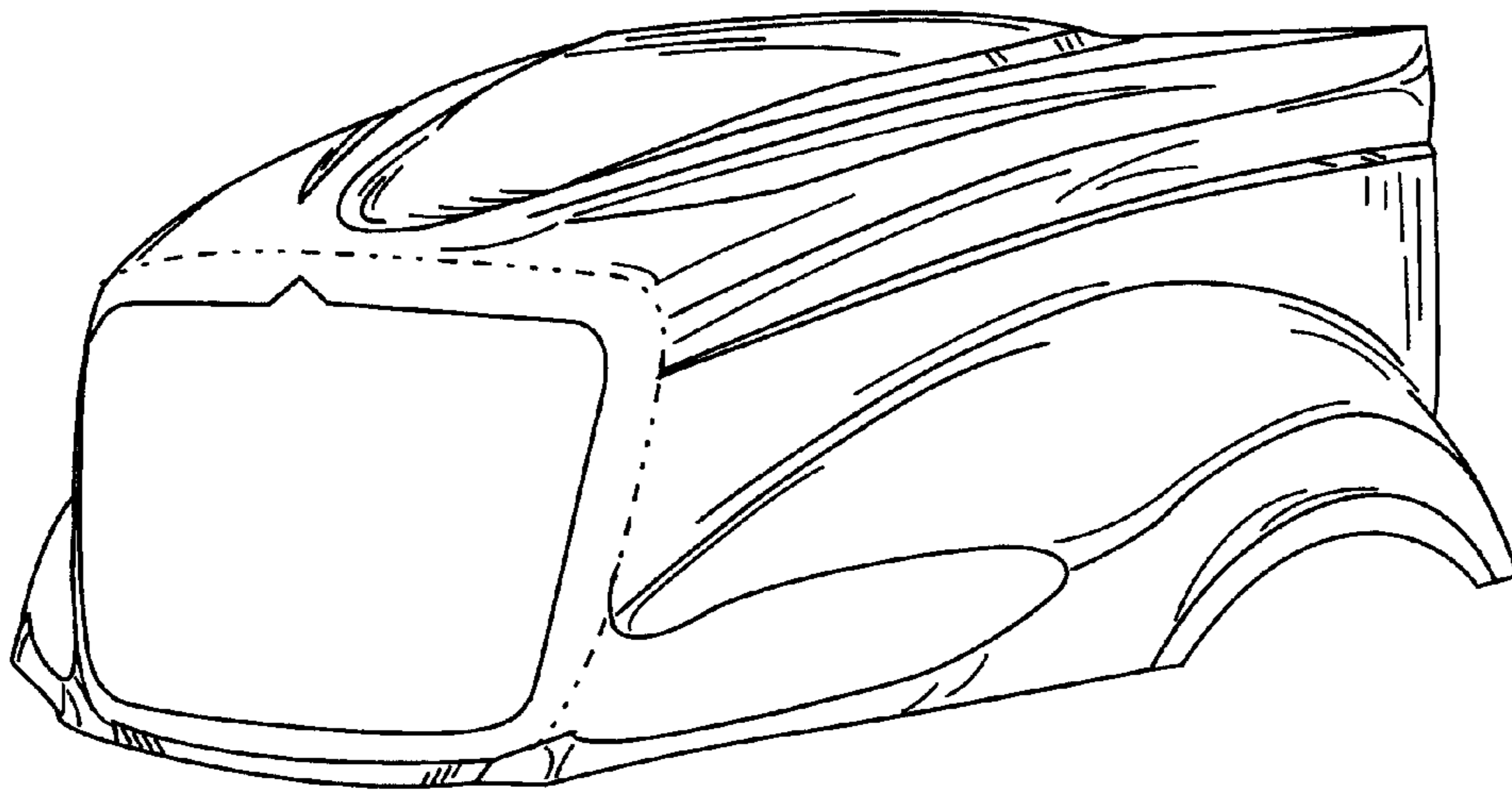
**DESCRIPTION**

FIG. 5 is a top plan view thereof.

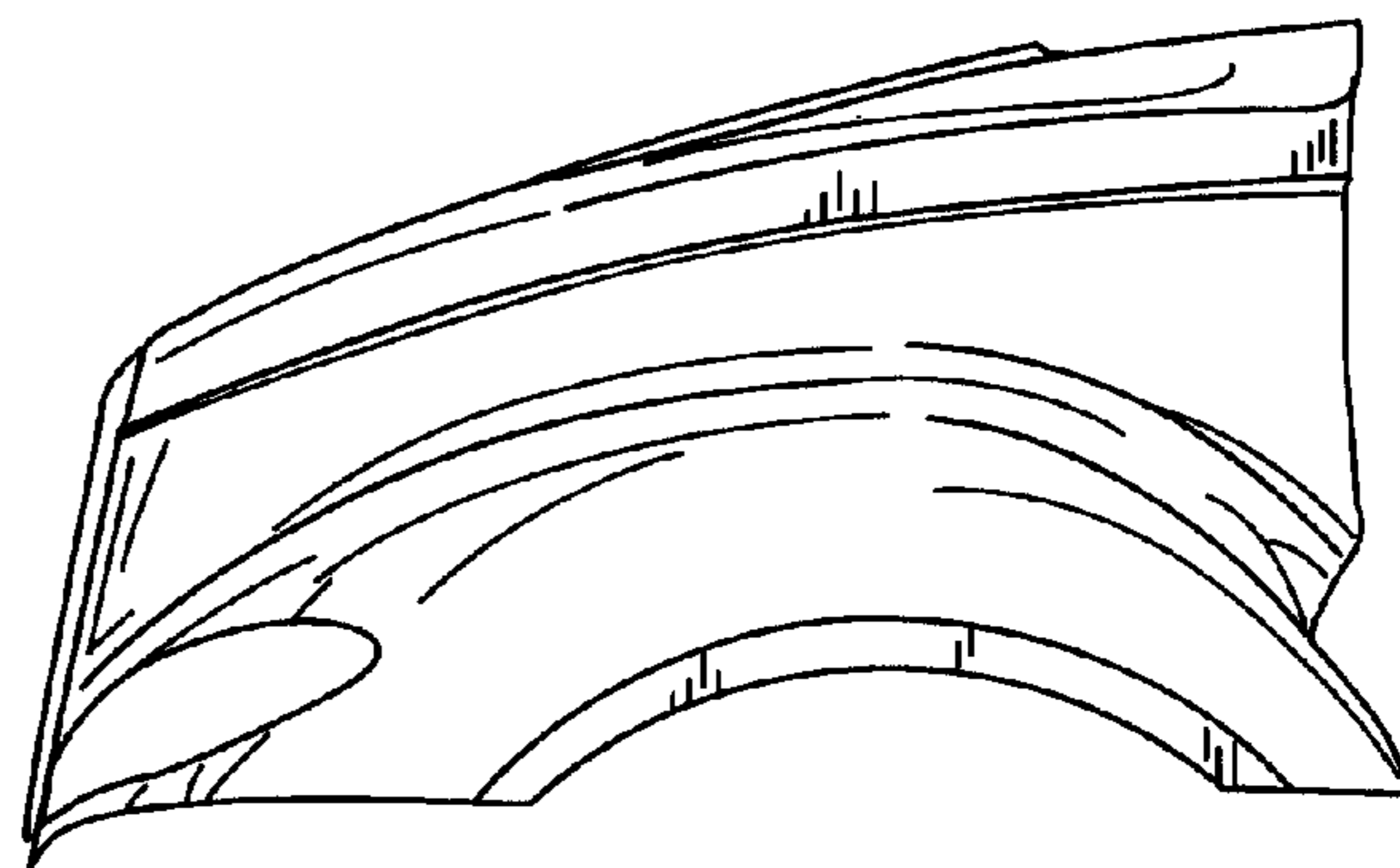

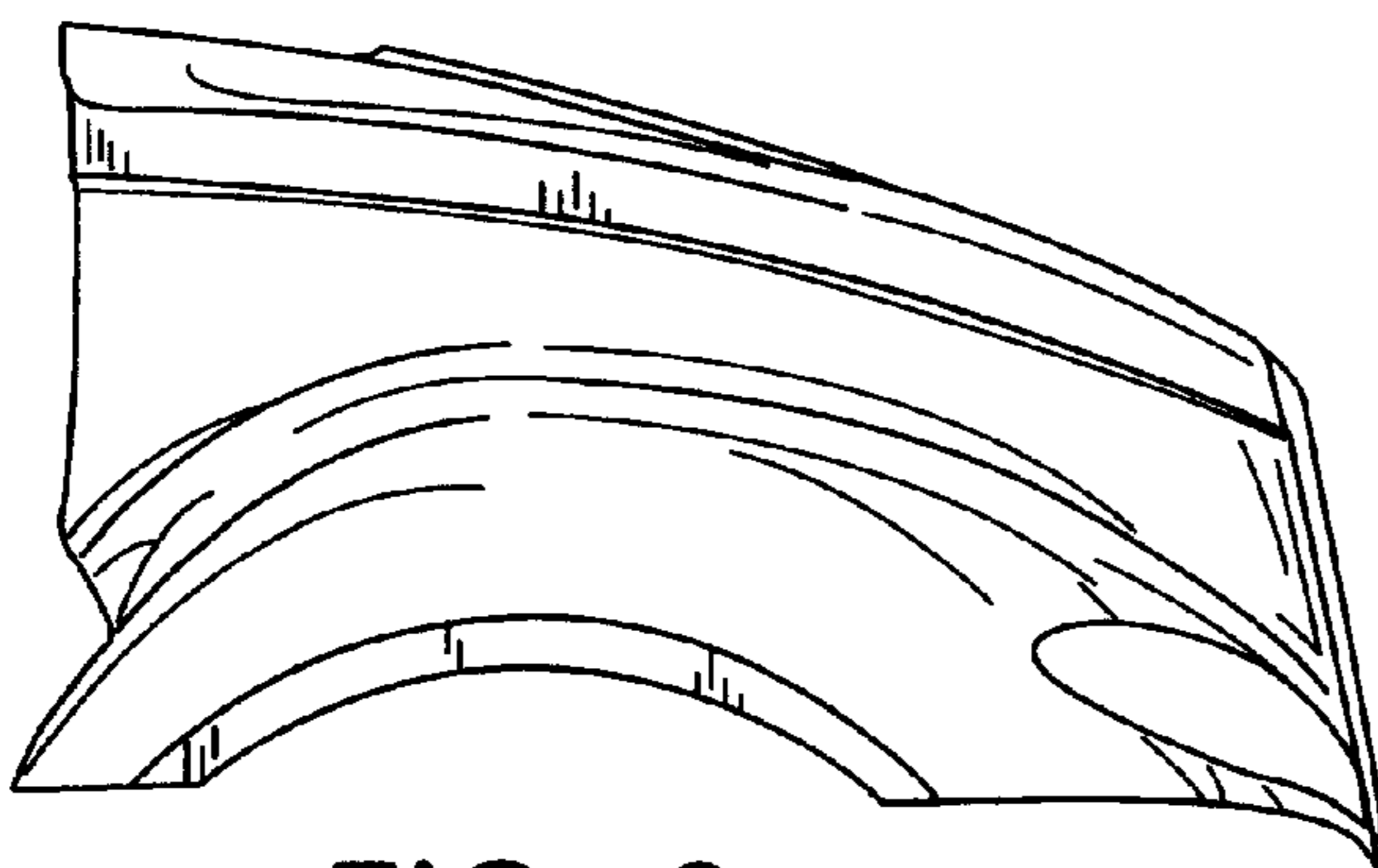

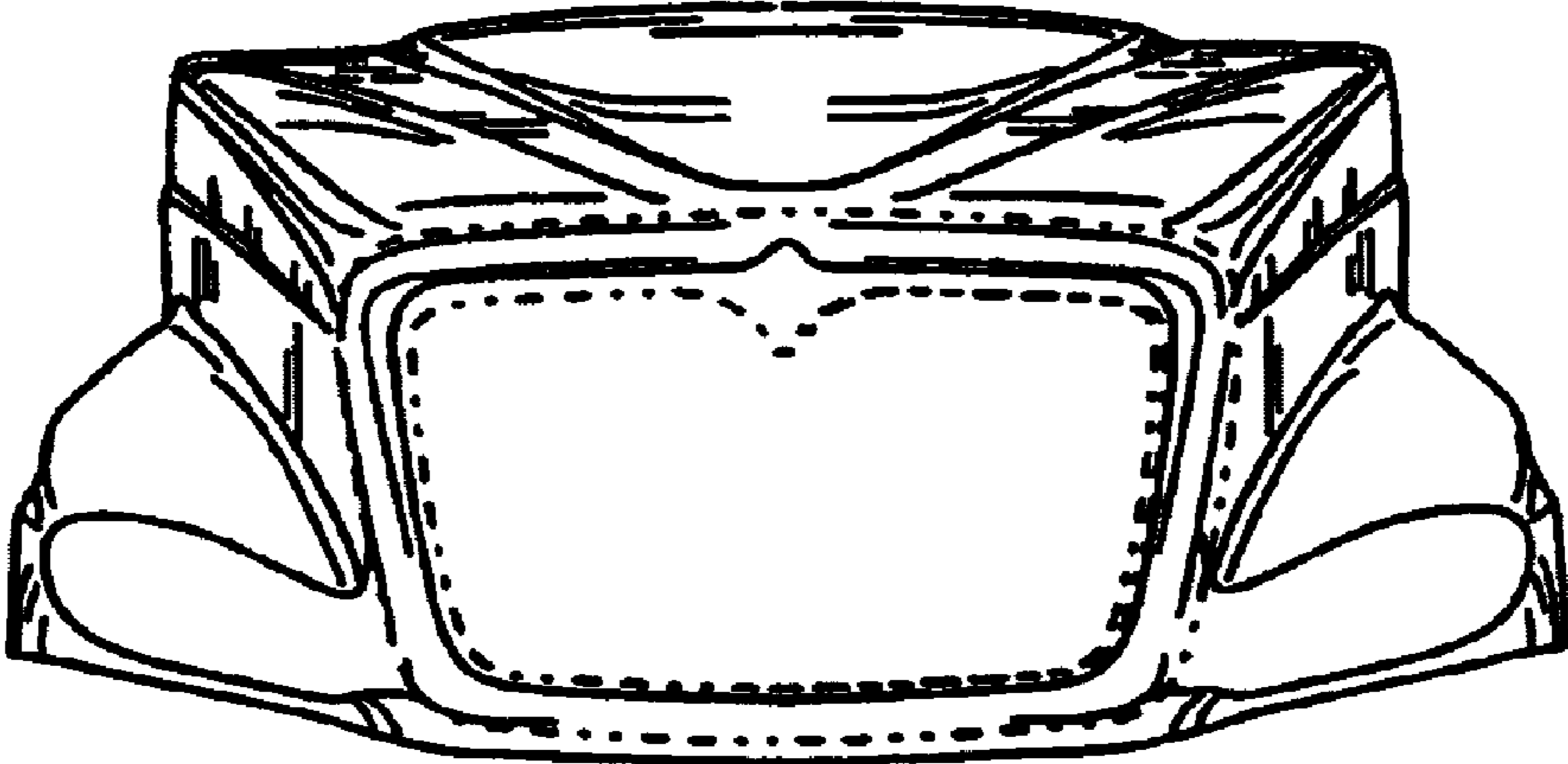

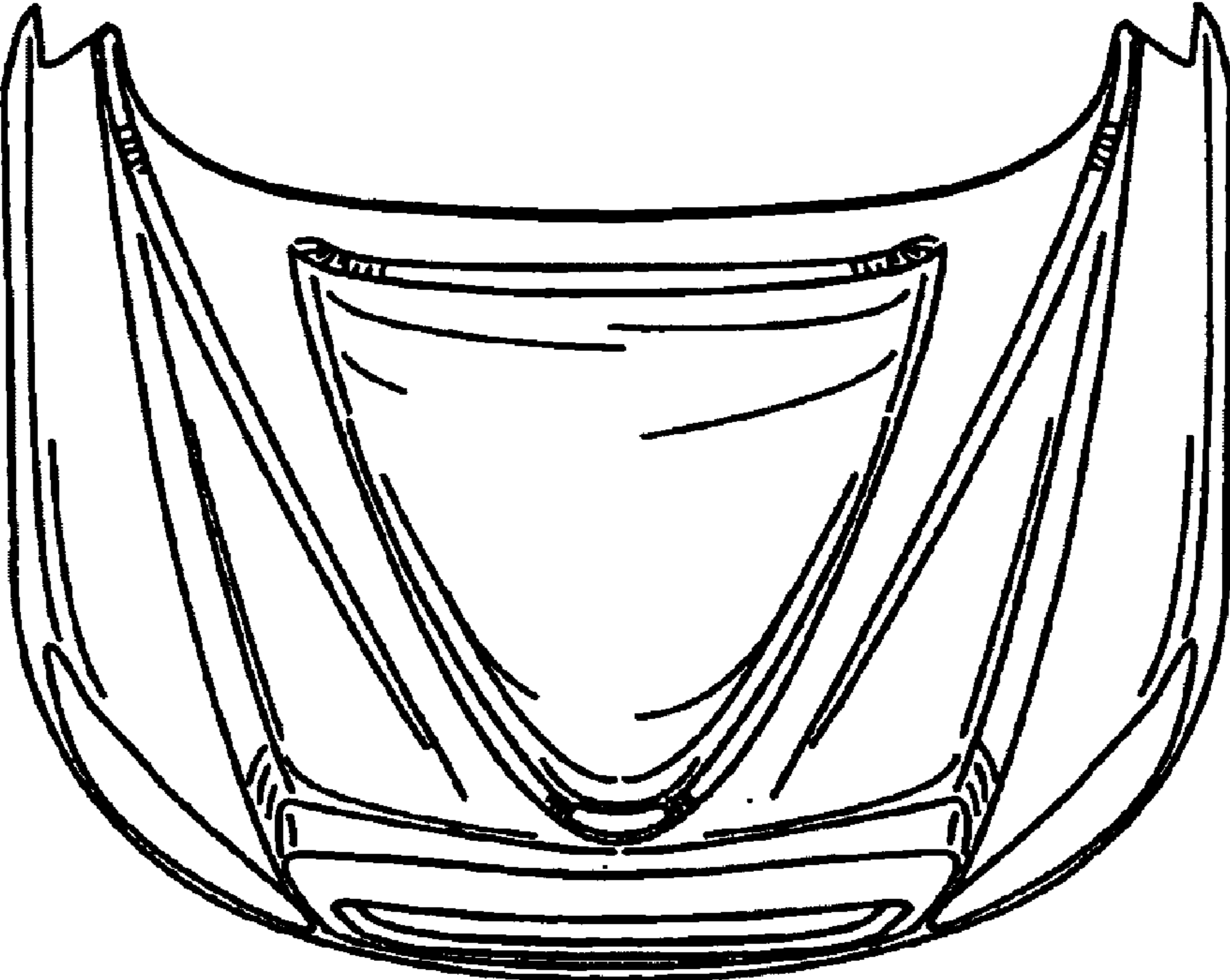
