FIG. 2 shows a side view thereof;

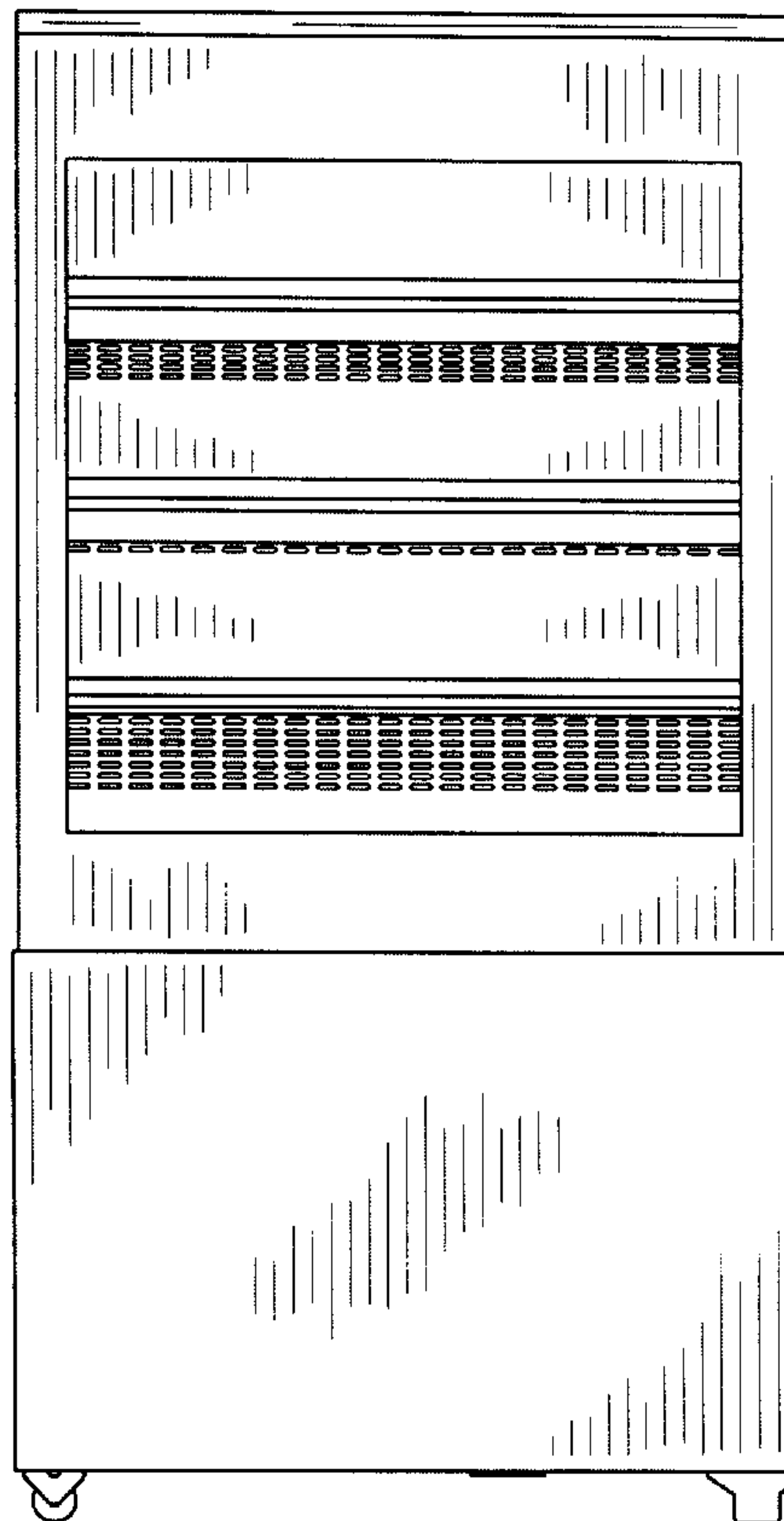
FIG. 3 shows an opposite side view thereof;

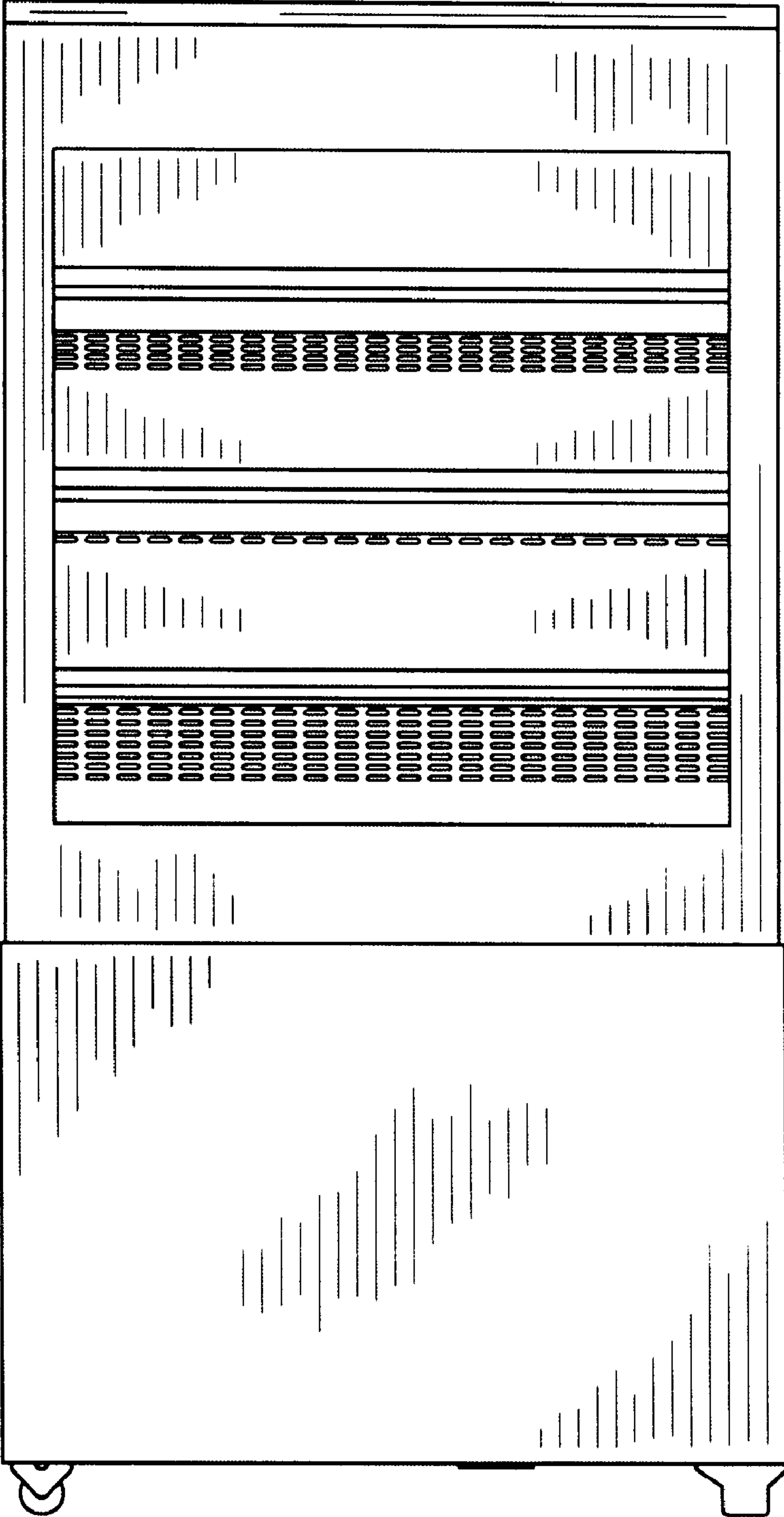

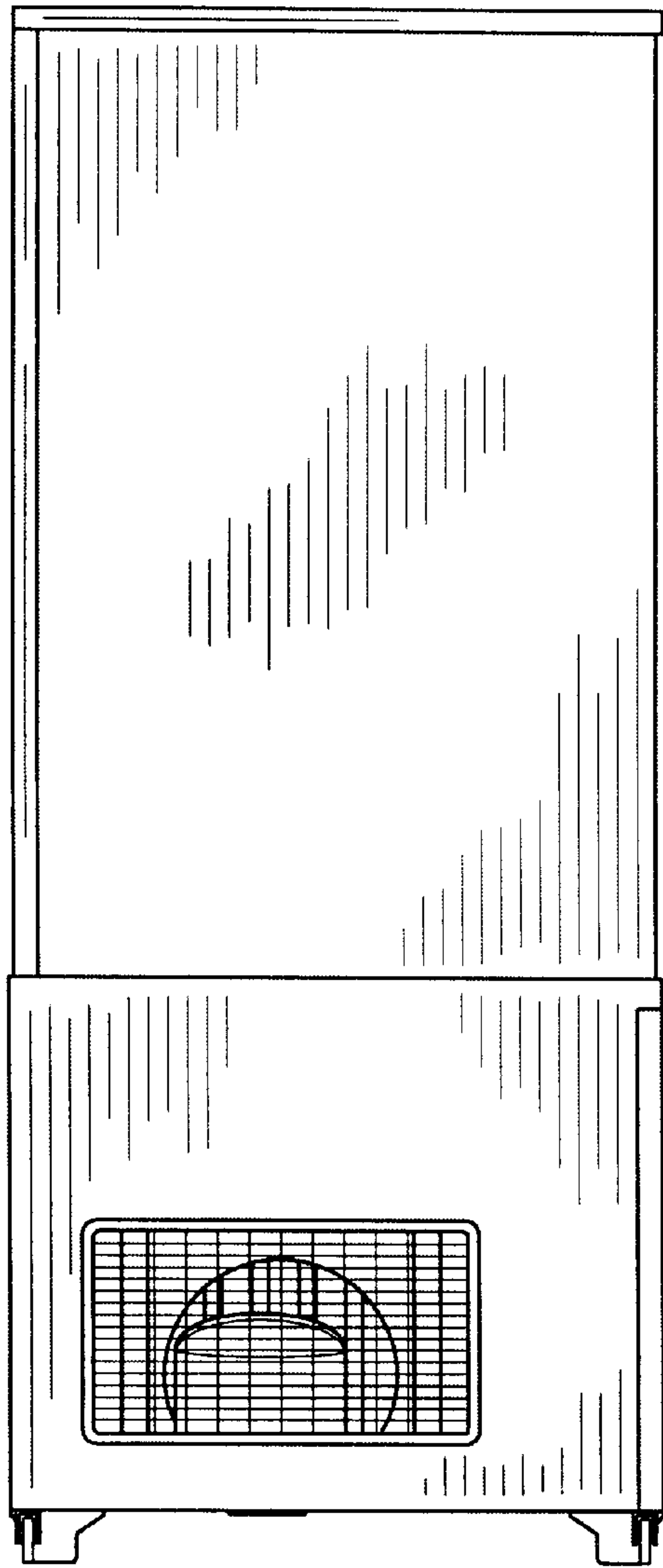

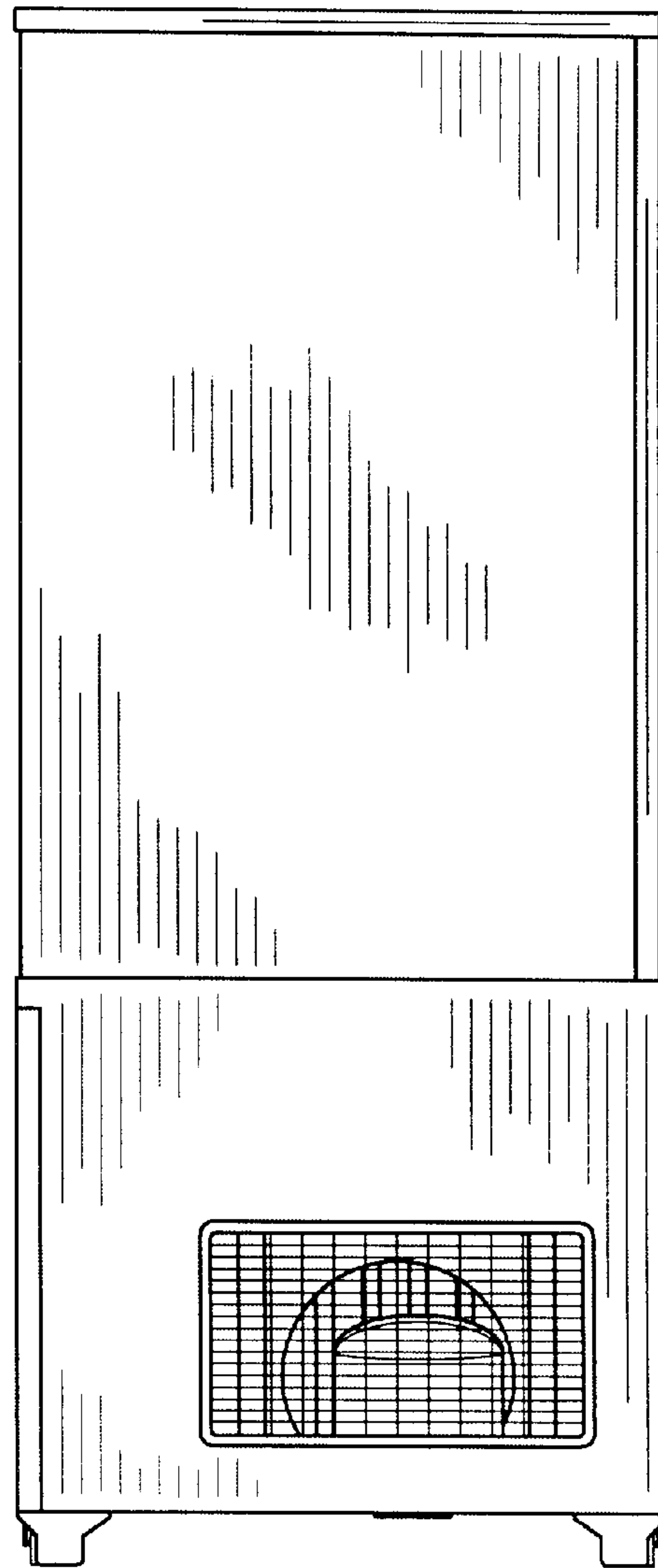

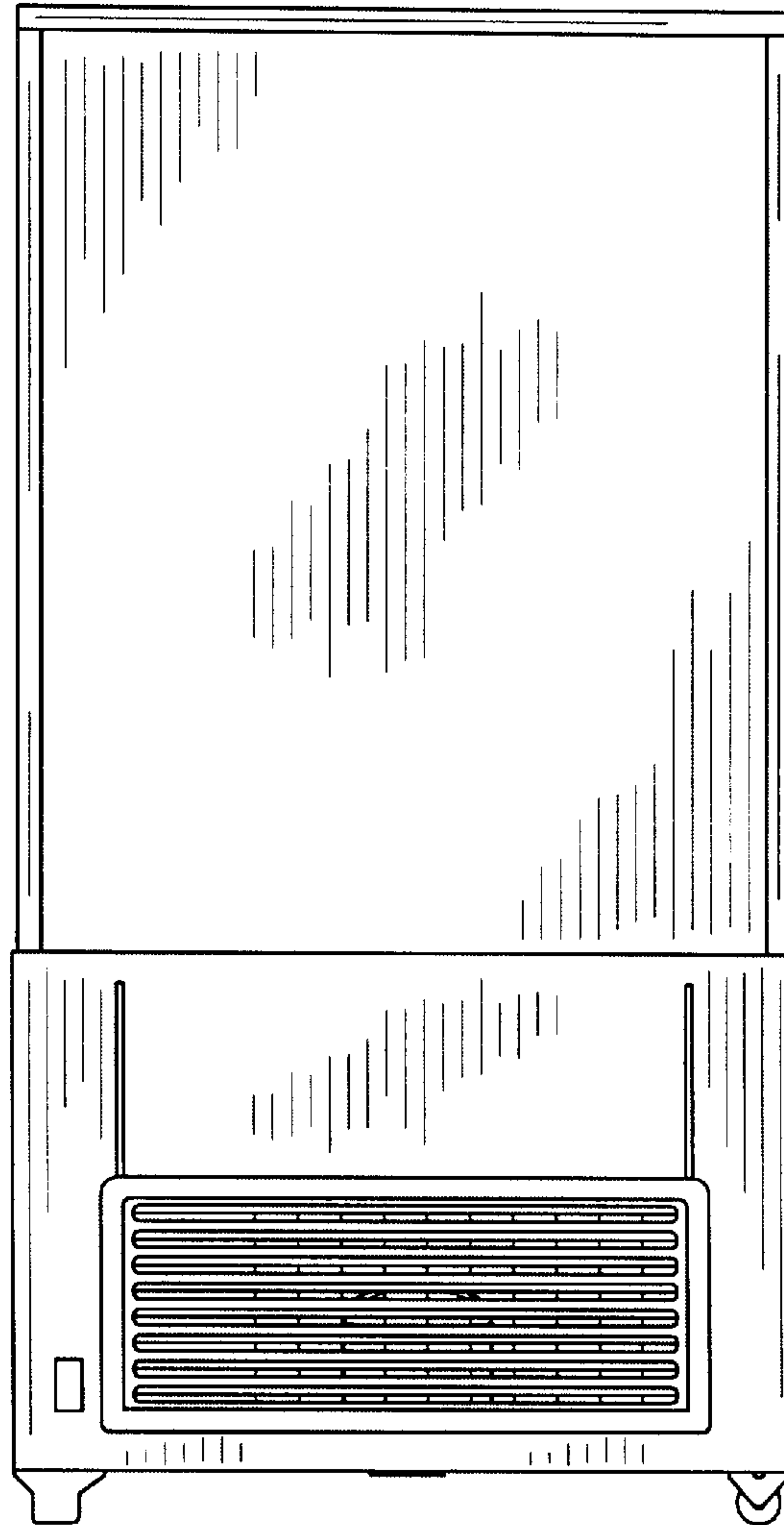

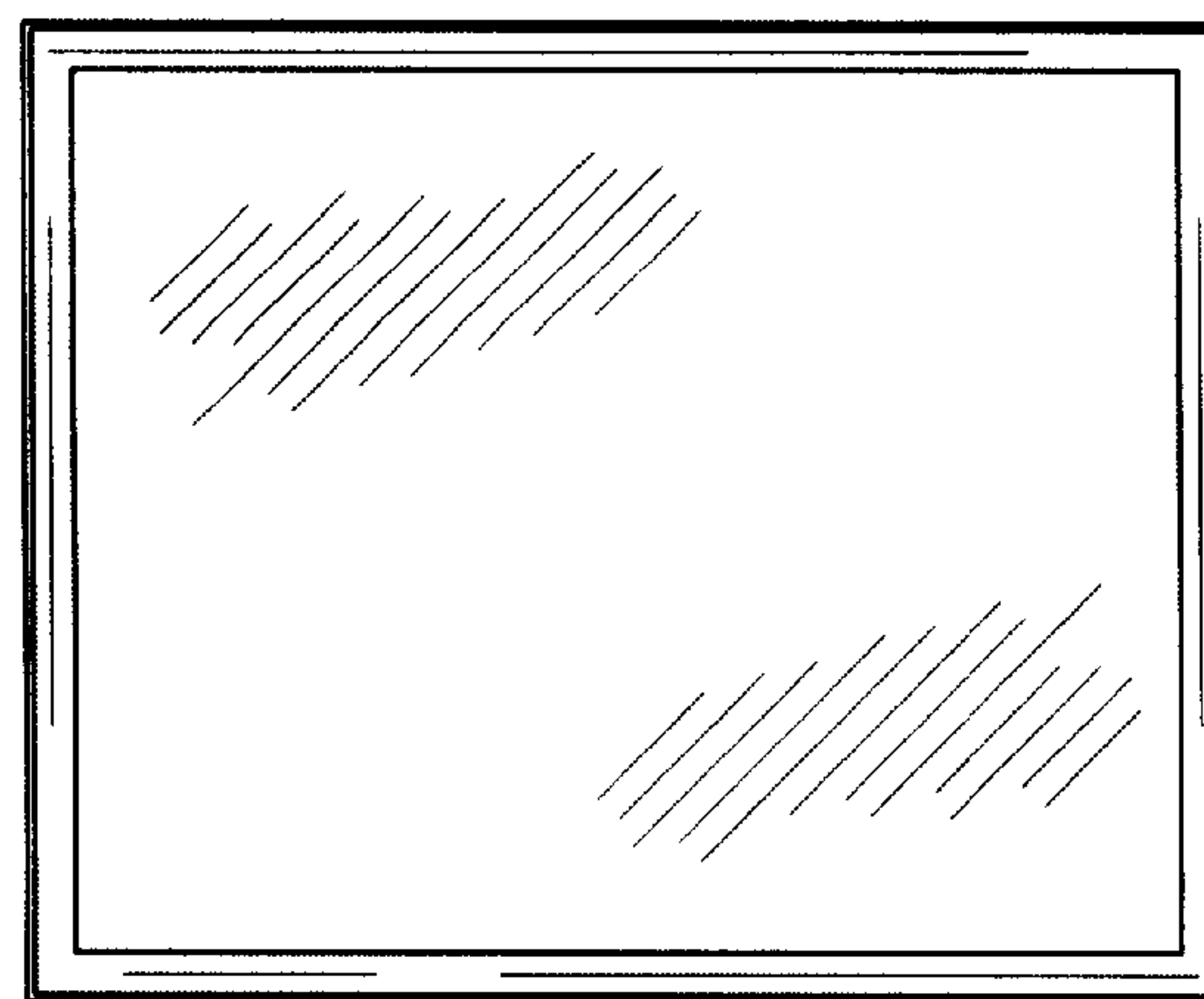
