(57) **CLAIM**

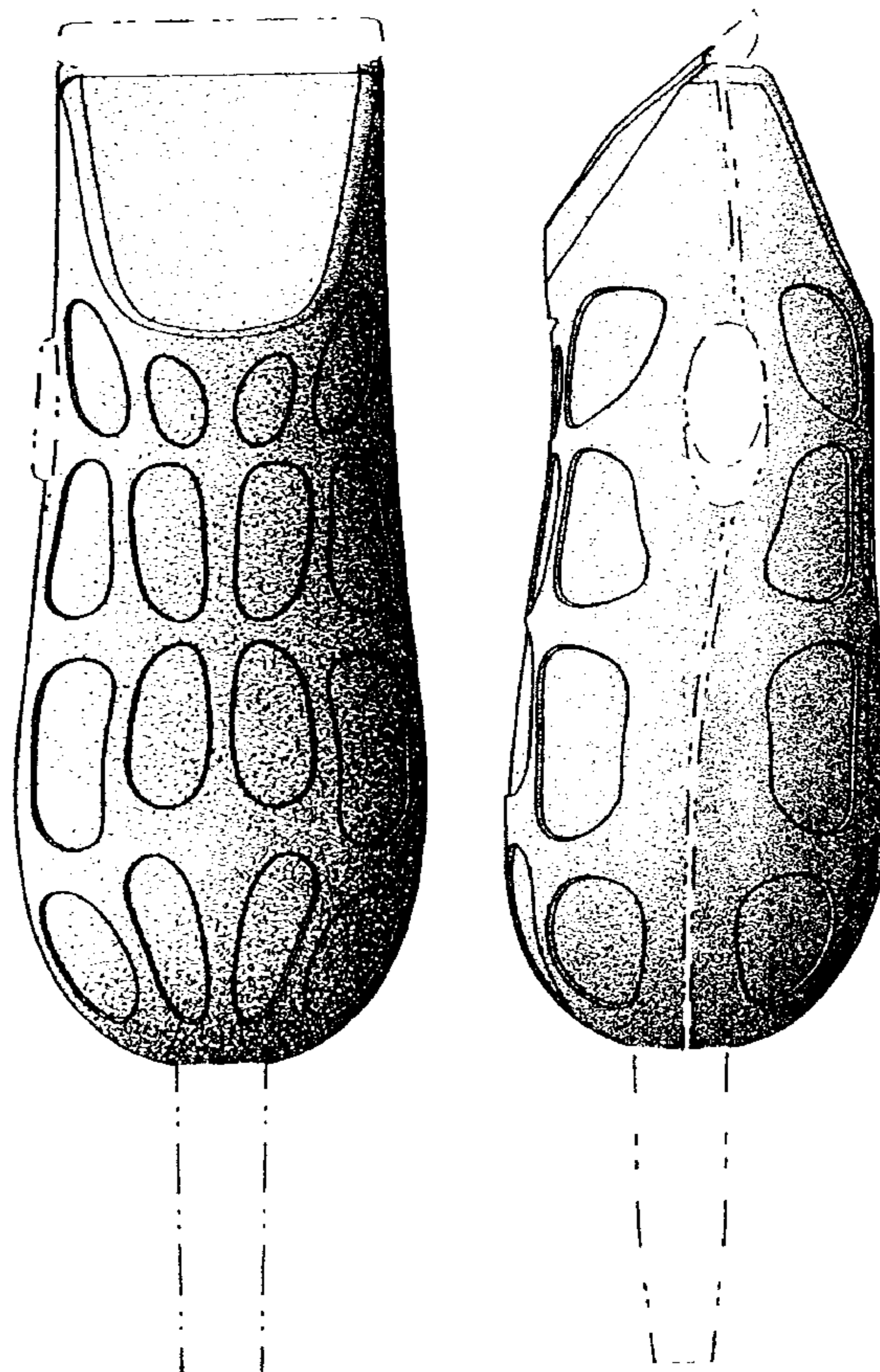
The ornamental design for a miniature hair trimmer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the present hair trimmer; FIG. 2 is a top view of same; FIG. 3 is a right side view of same; FIG. 4 is a bottom view of the hair trimmer of FIG. 1; FIG. 5 is a left side view of the hair trimmer of FIG. 1; FIG. 6 is a front view of same; and, FIG. 7 is a rear view of same.

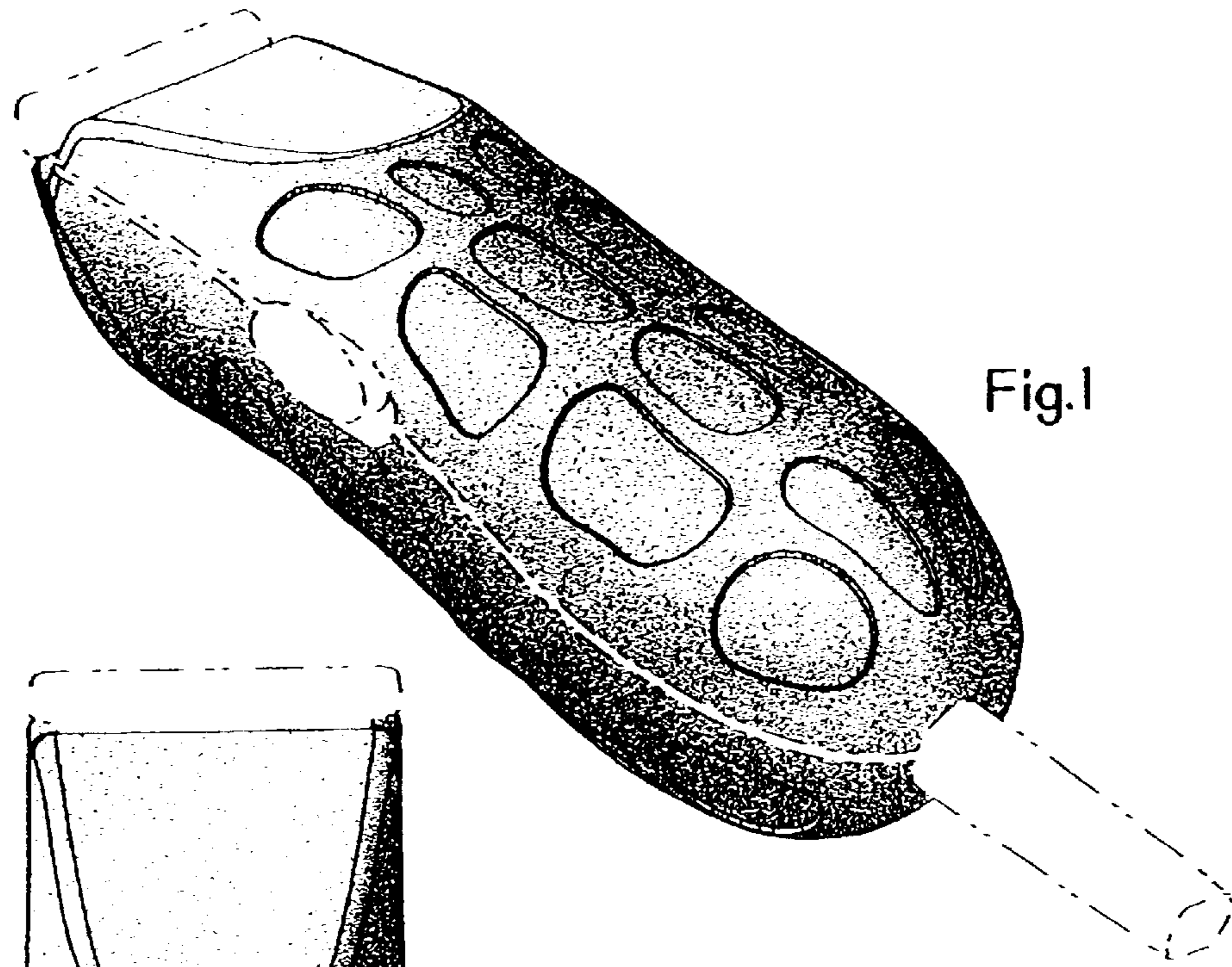

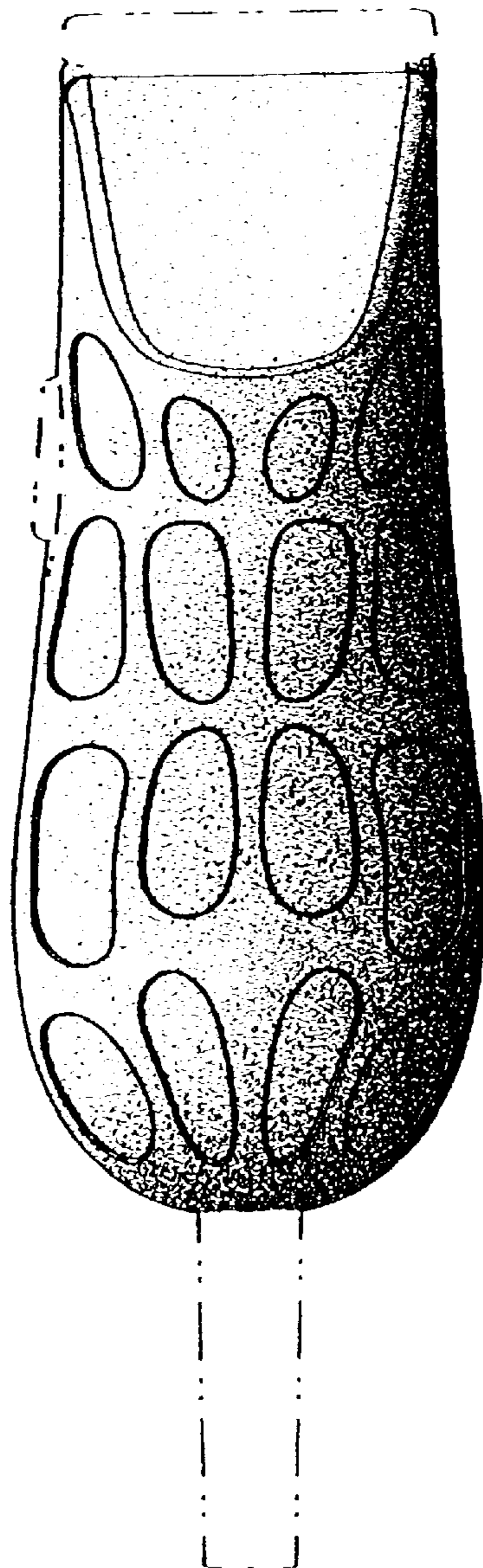

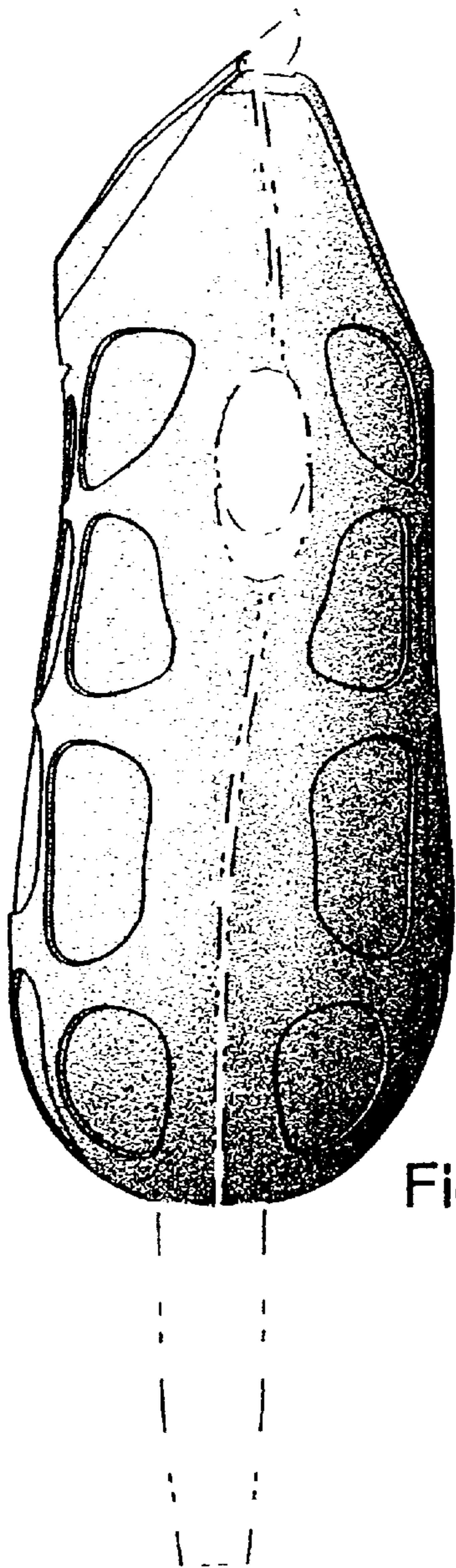

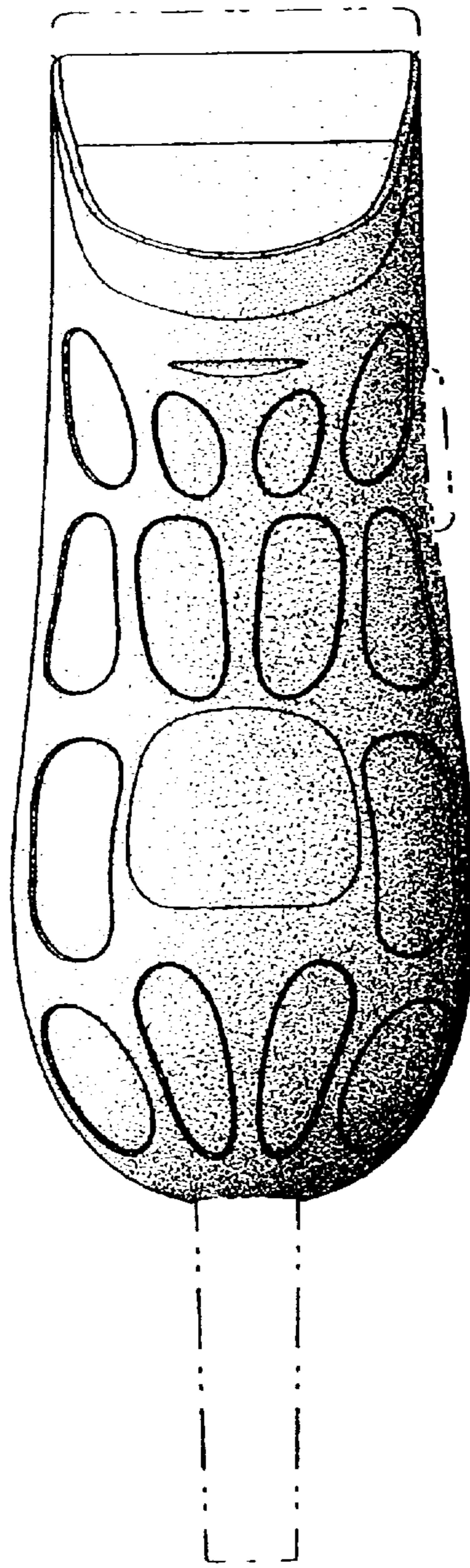

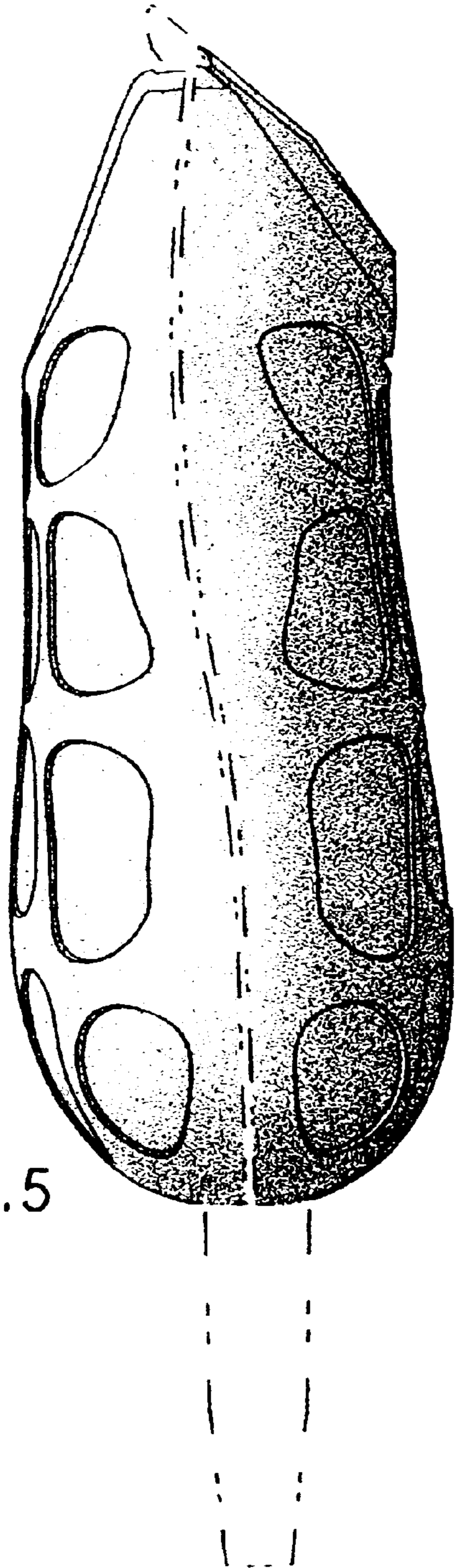

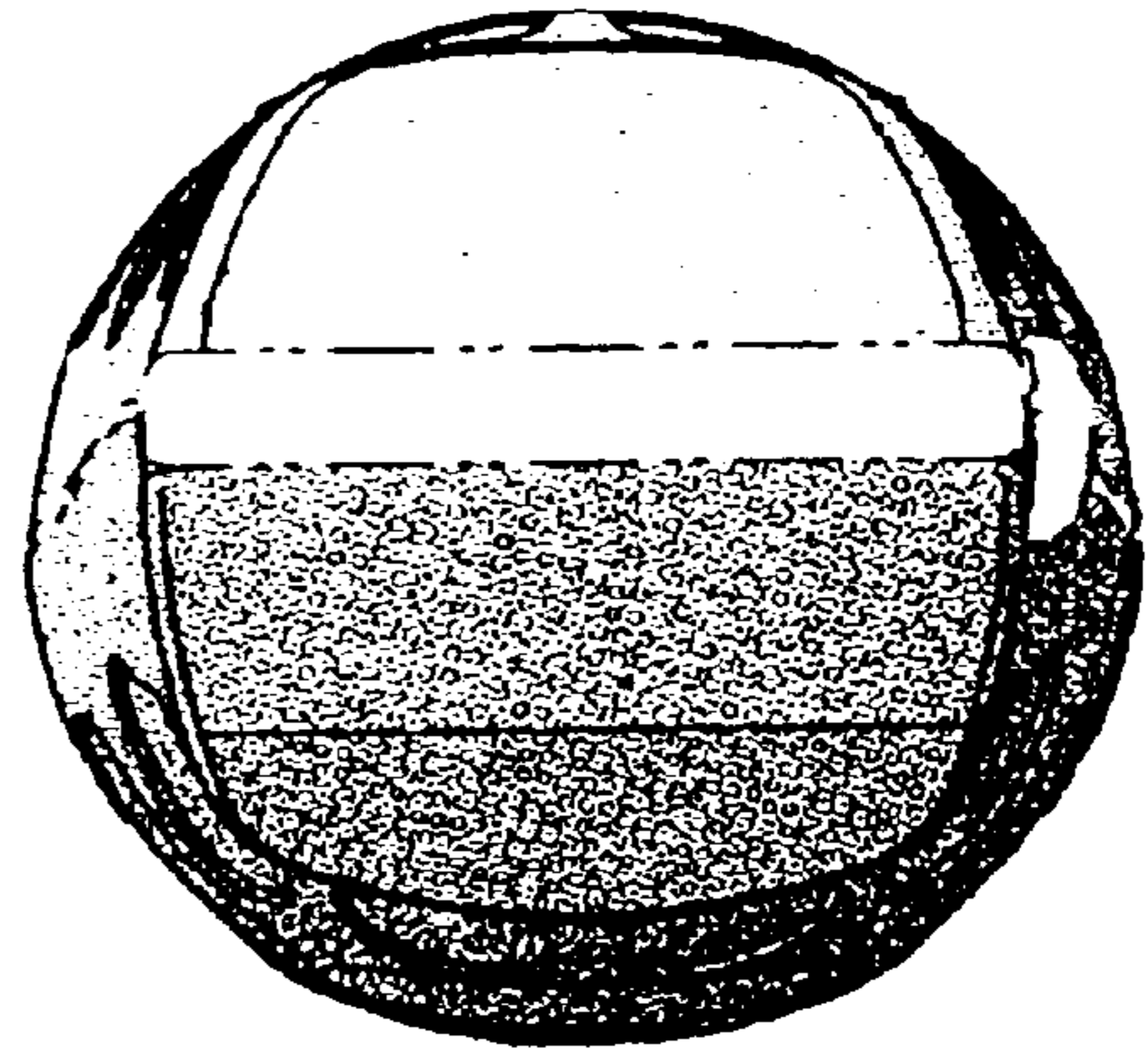

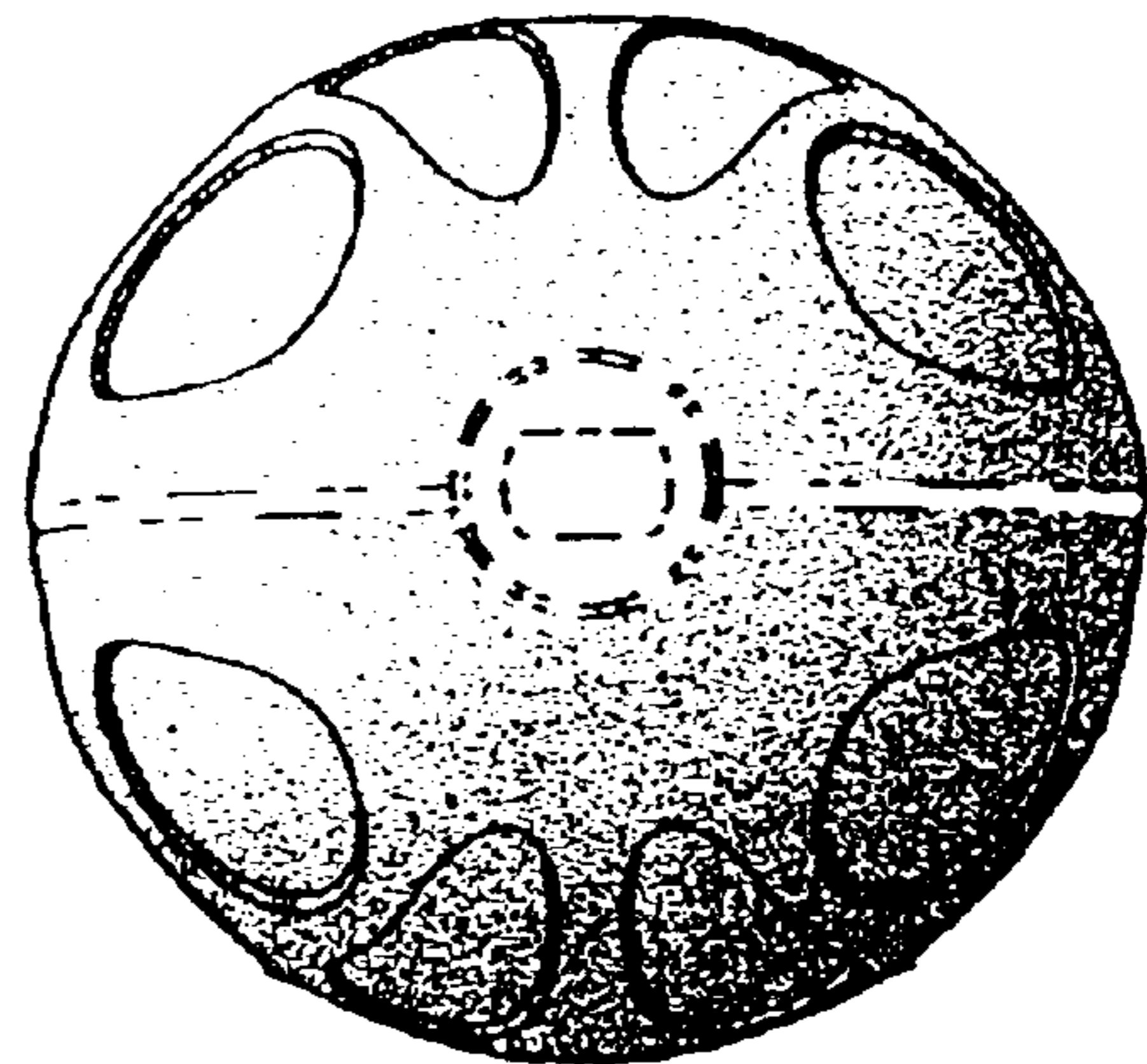
