(57) **CLAIM**

We claim the ornamental design for a wireless collar mounted animal receiver unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wireless collar mounted animal receiver unit showing our new design, the portion in phantom lines representing a collar forming no part of the claimed invention;

FIG. 3 is a bottom view thereof;

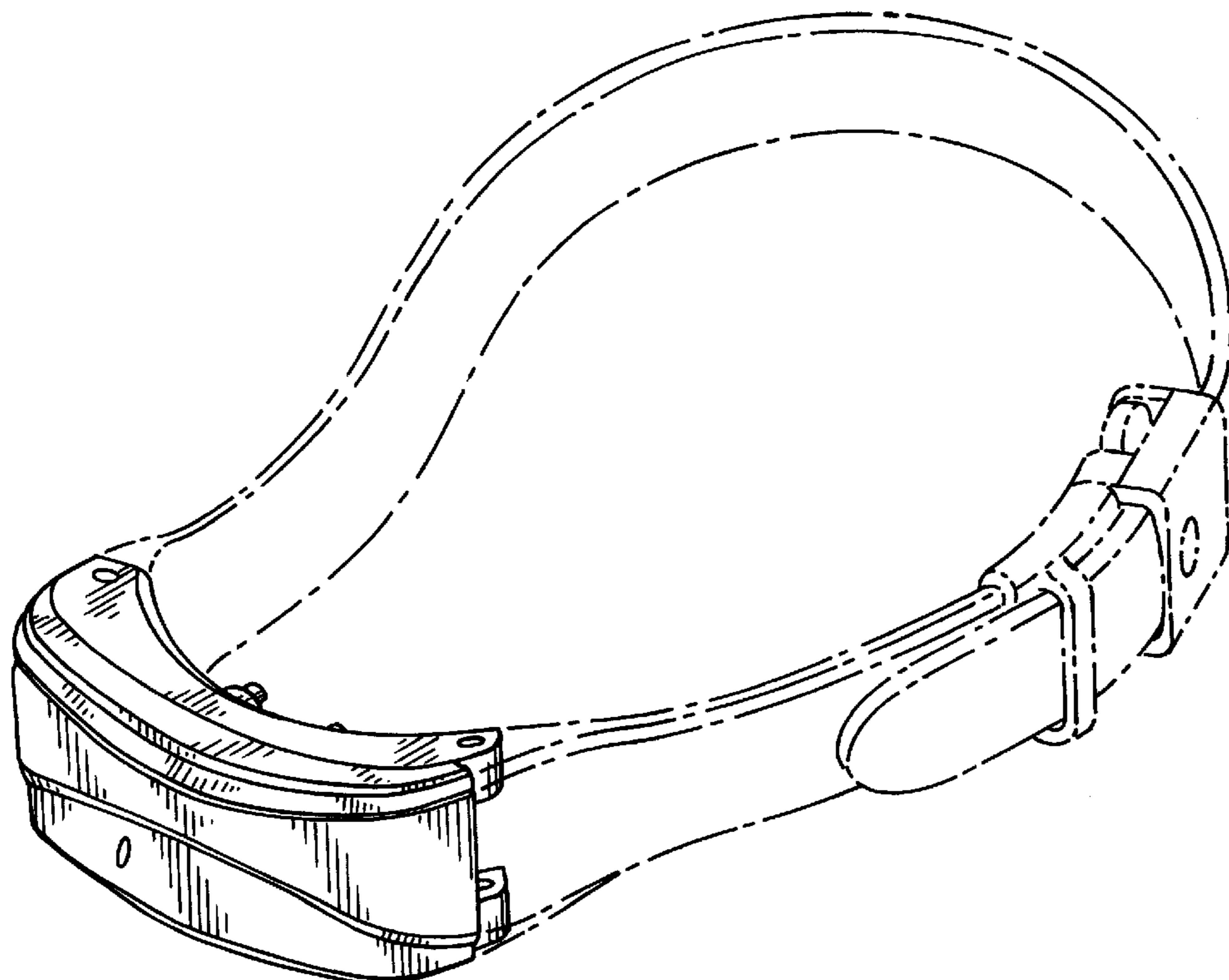
FIG. 4 is a side view thereof;

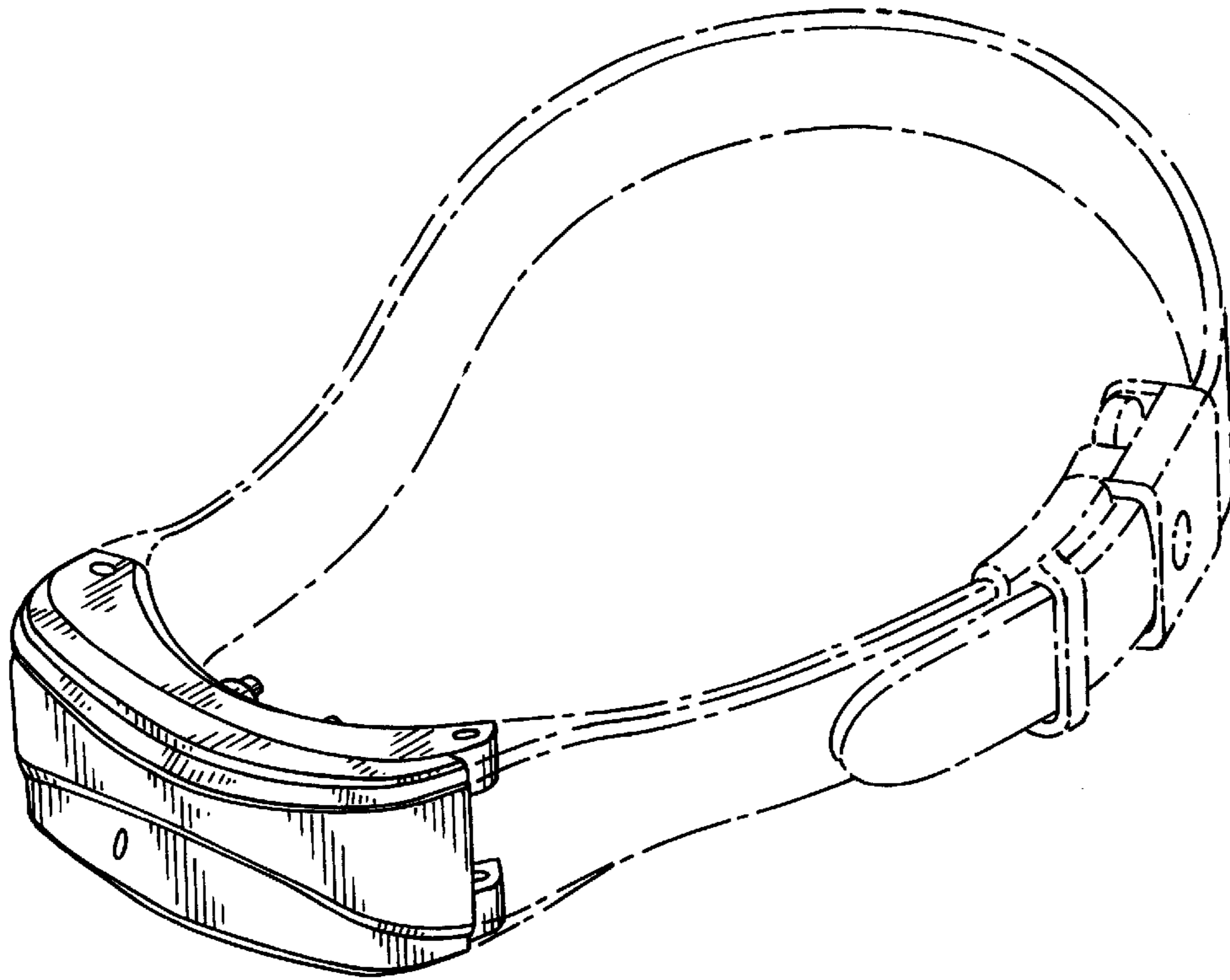

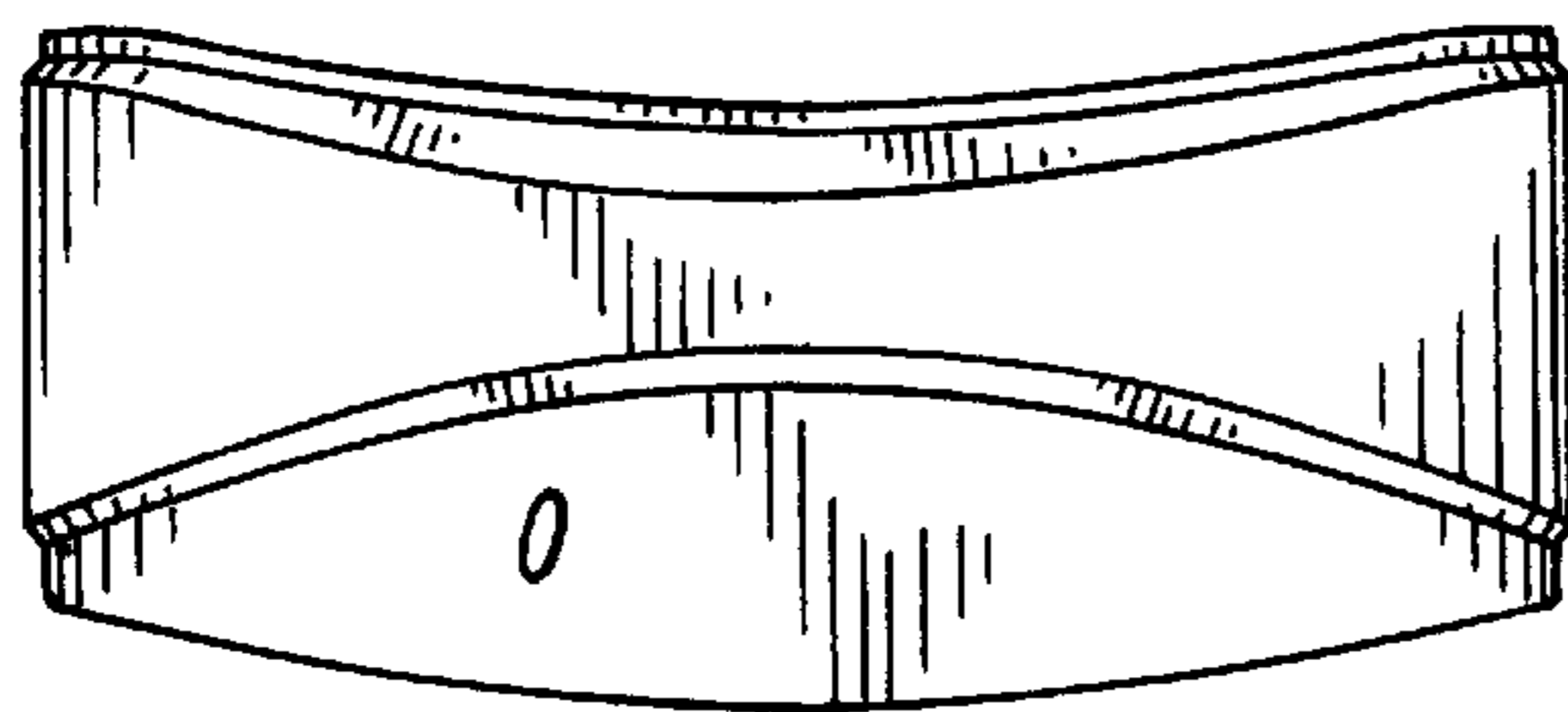

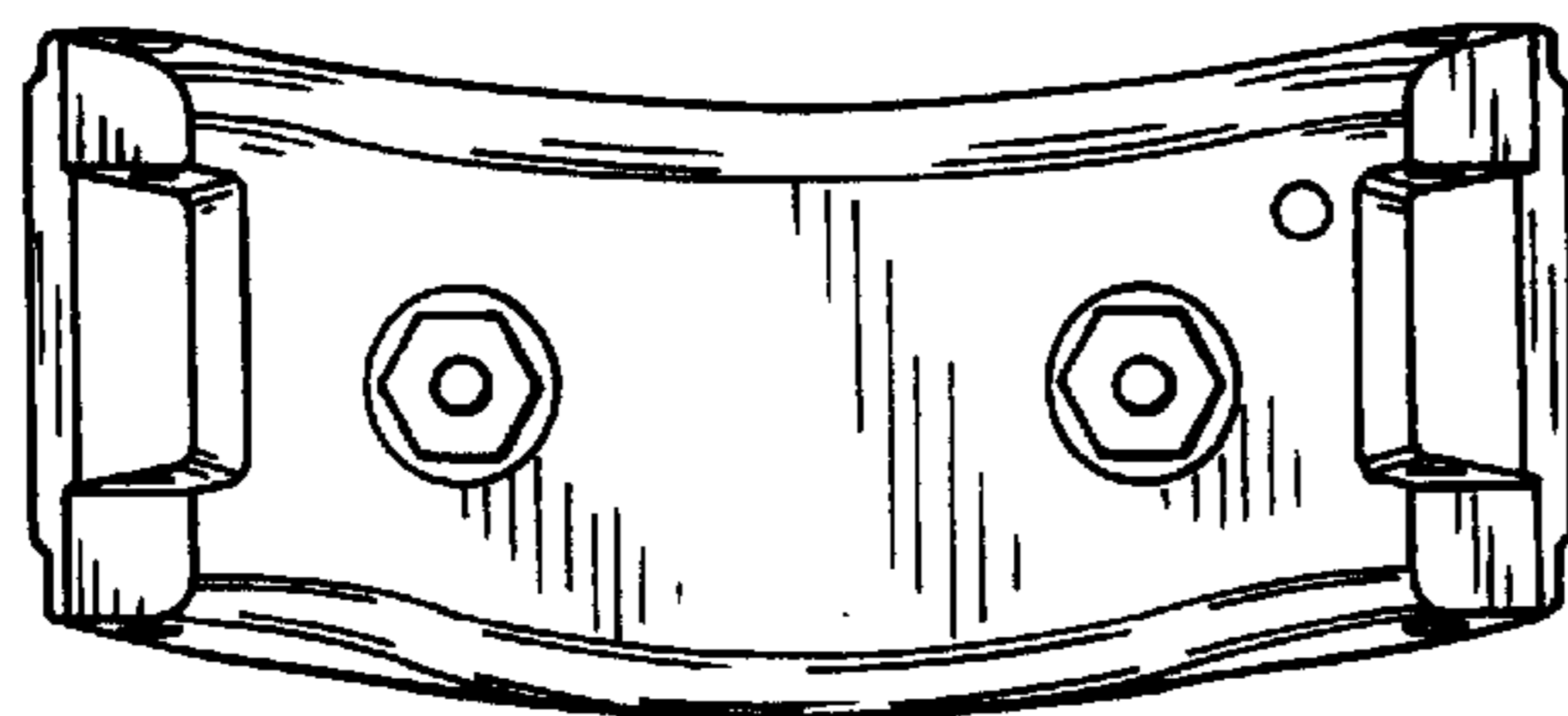

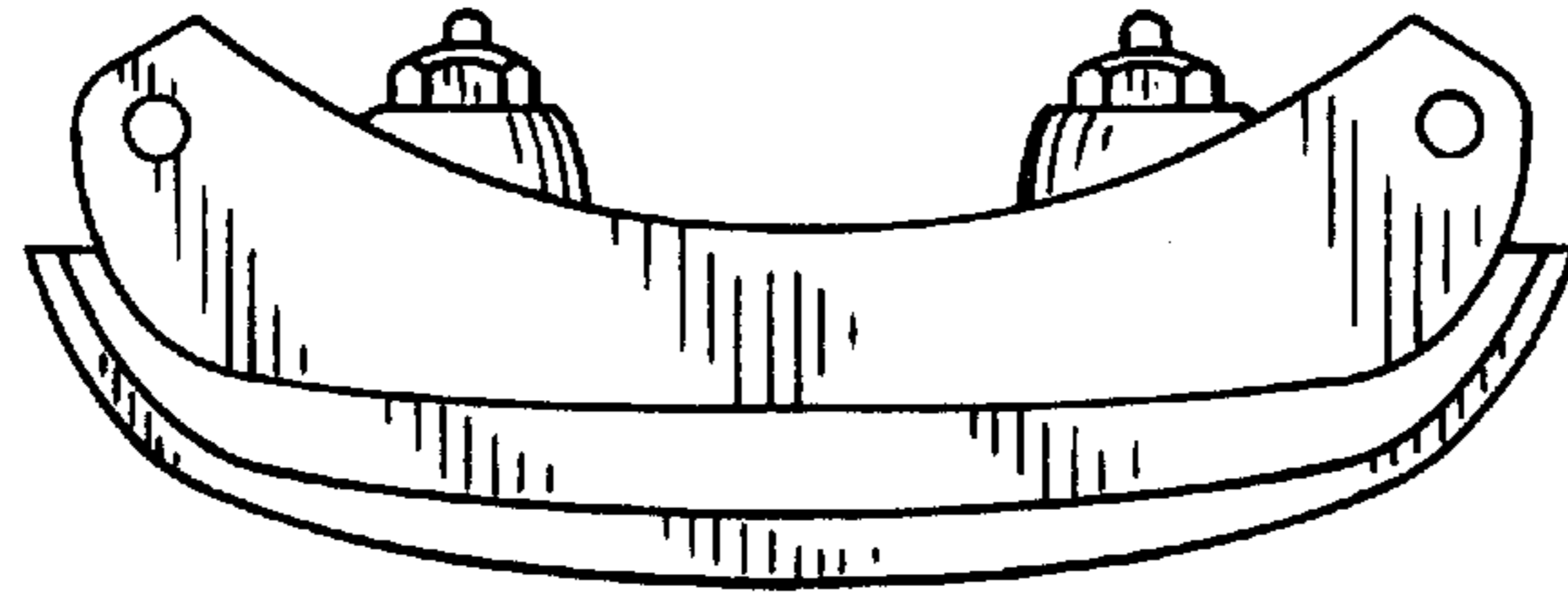

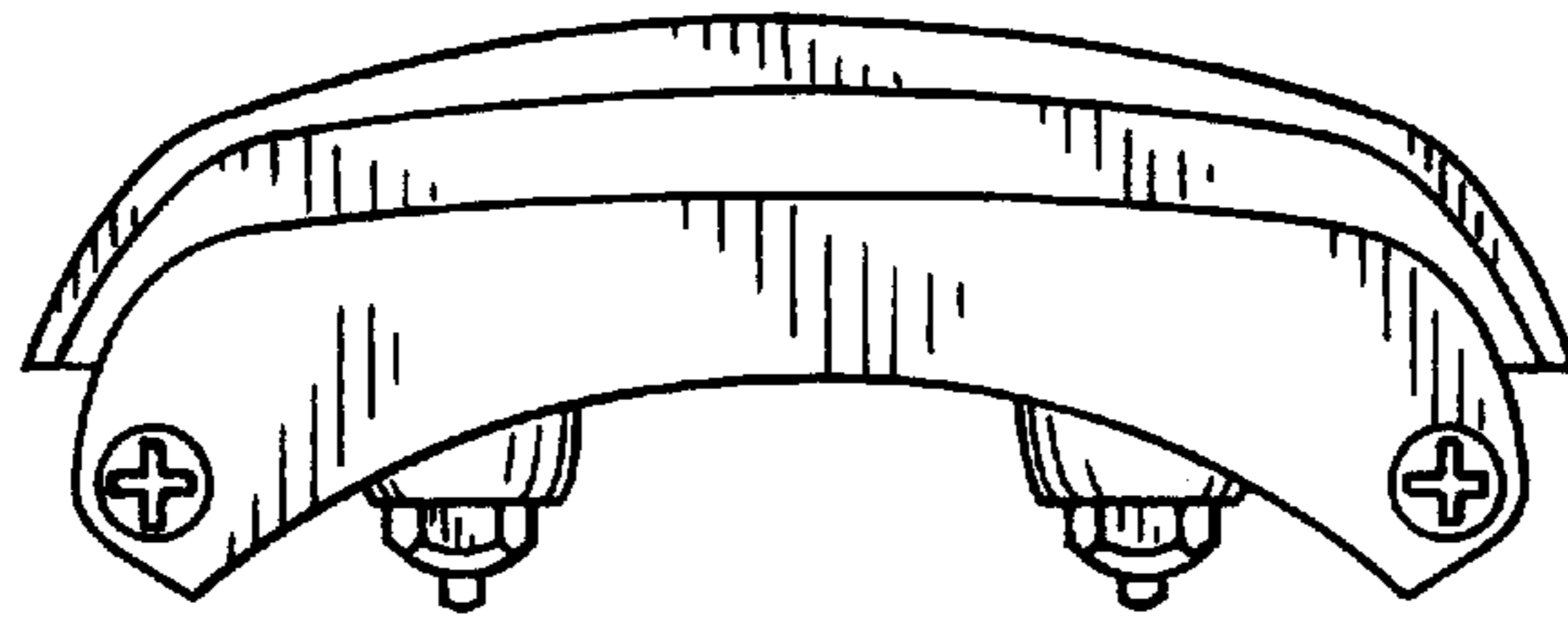

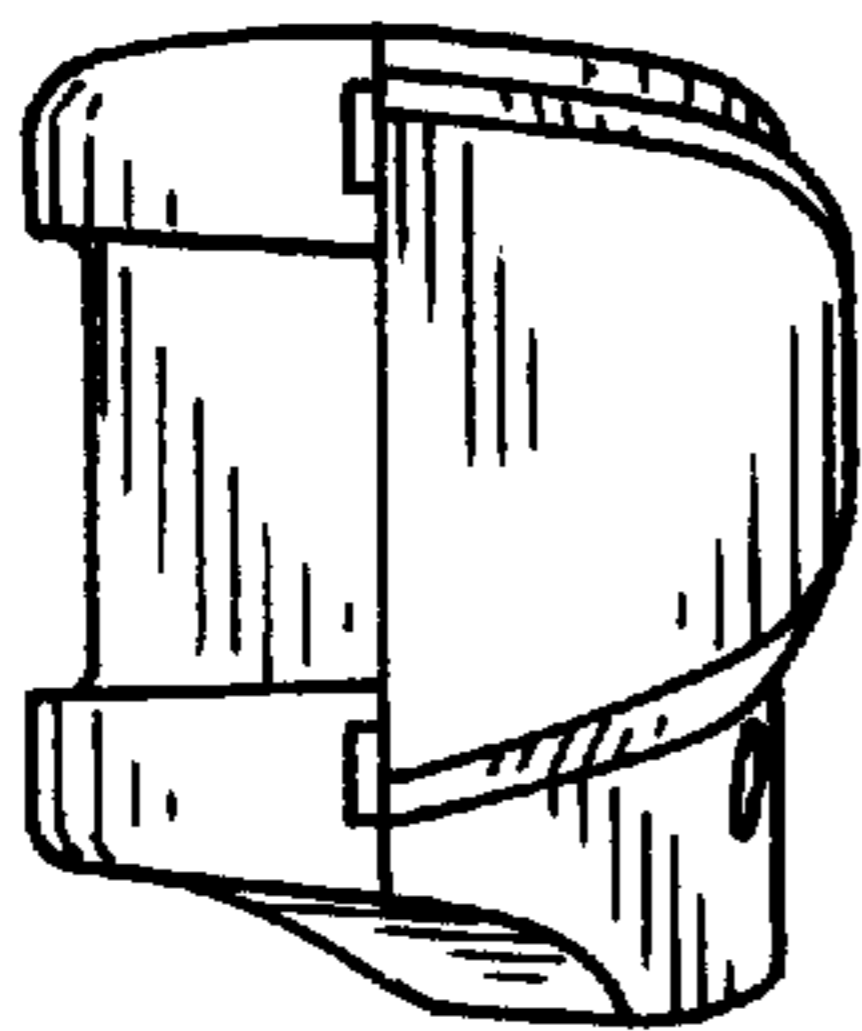

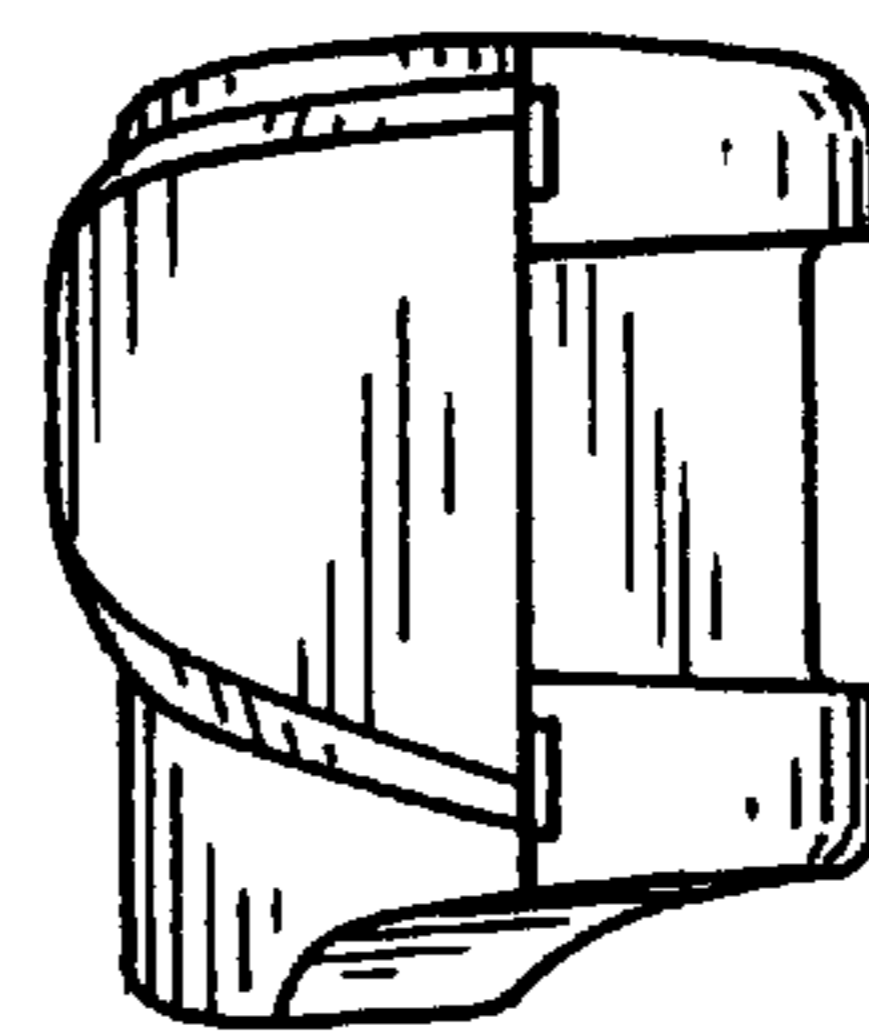
