DESCRIPTION

FIG. 1 is a top plan view of the knee cart according to the present design;

FIG. 2 is a left side elevational view thereof;

FIG. 4 is a right side elevational view of FIG. 1;

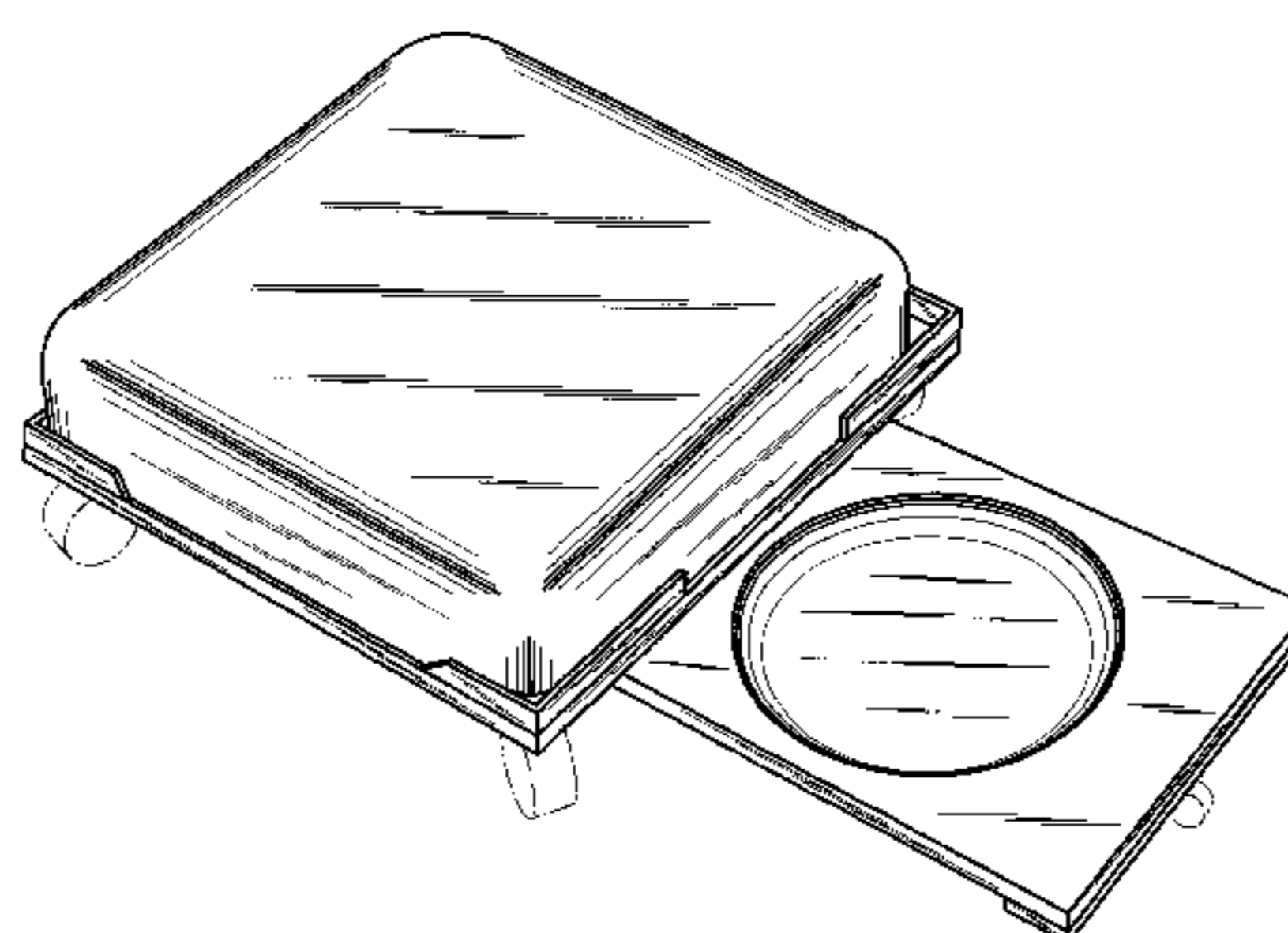
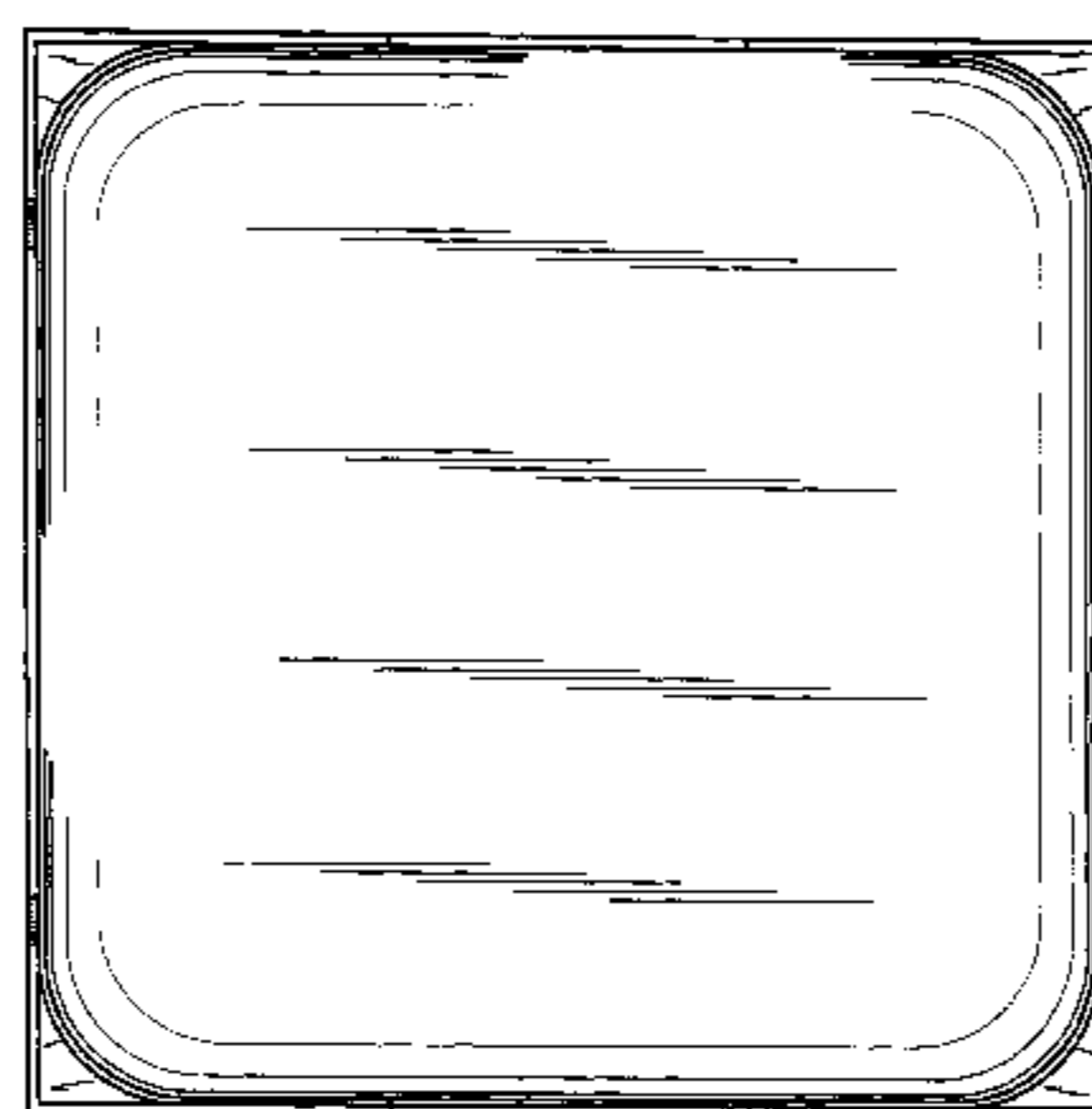
FIG. 5 is a backside elevational view of FIG. 1;

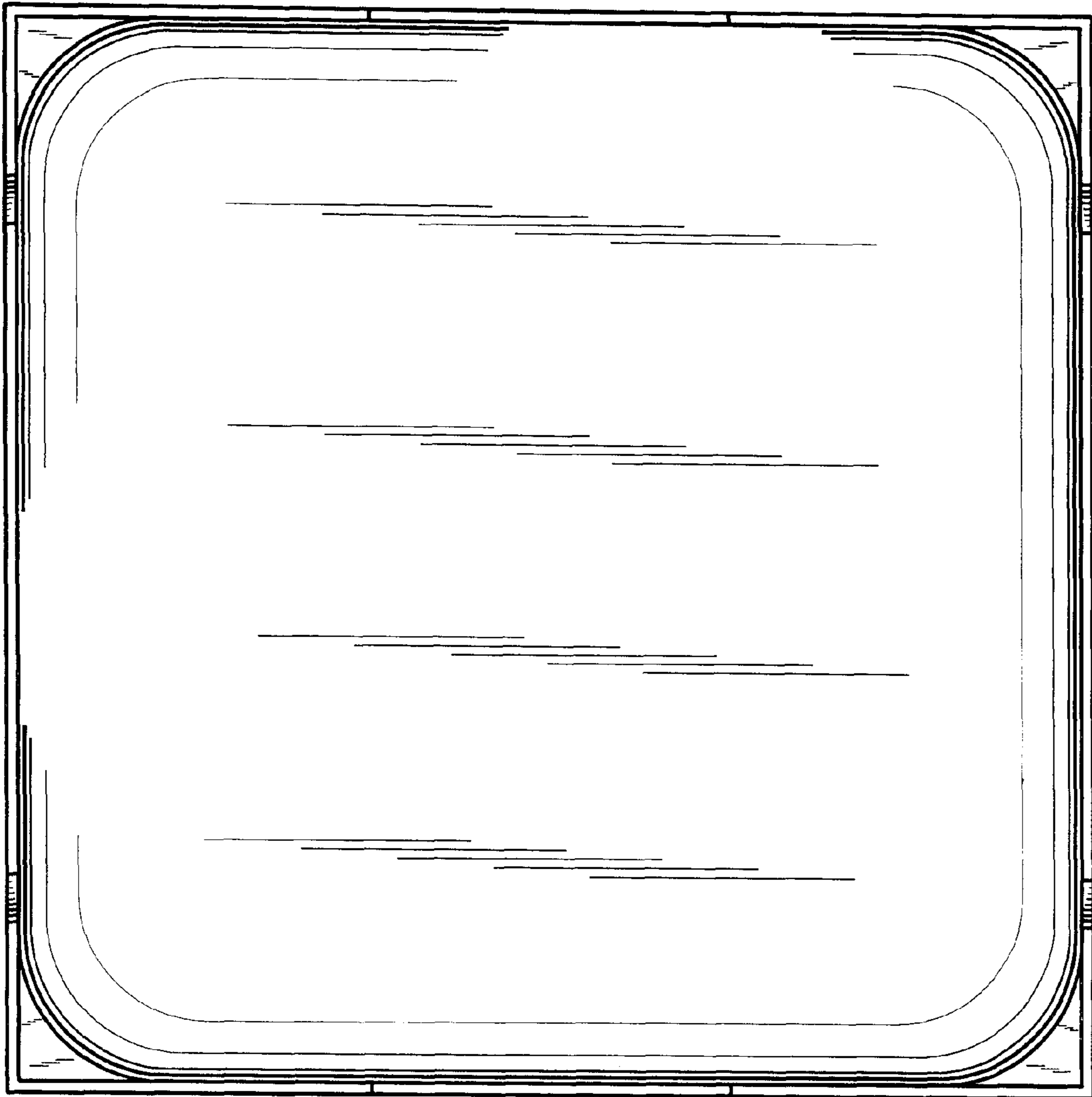

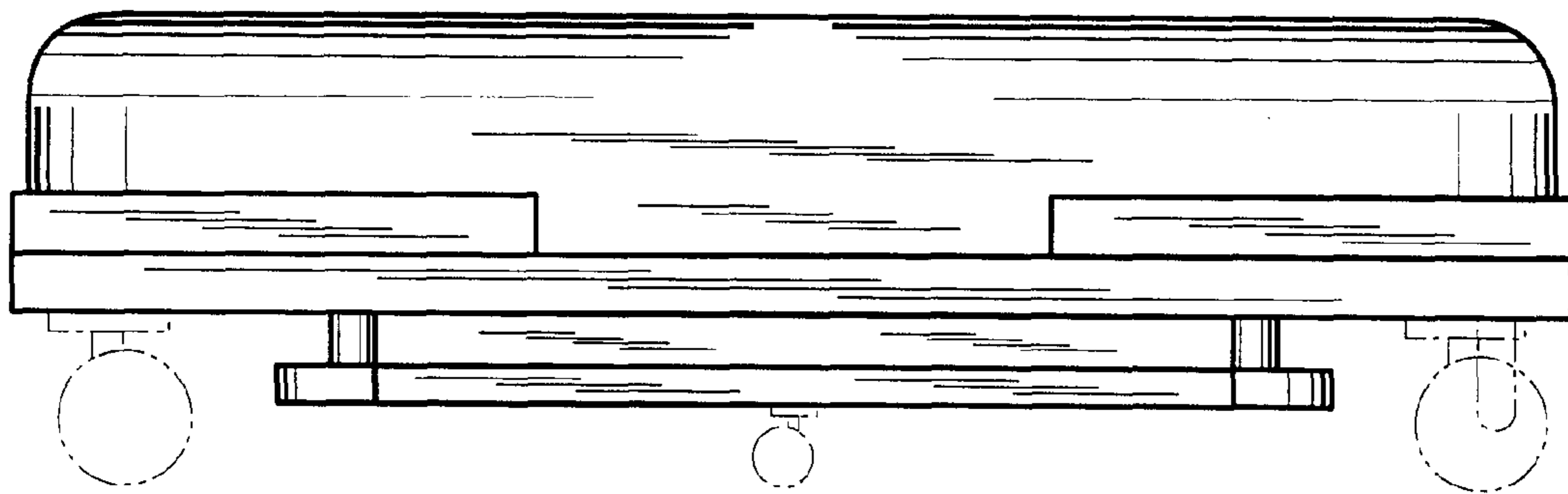
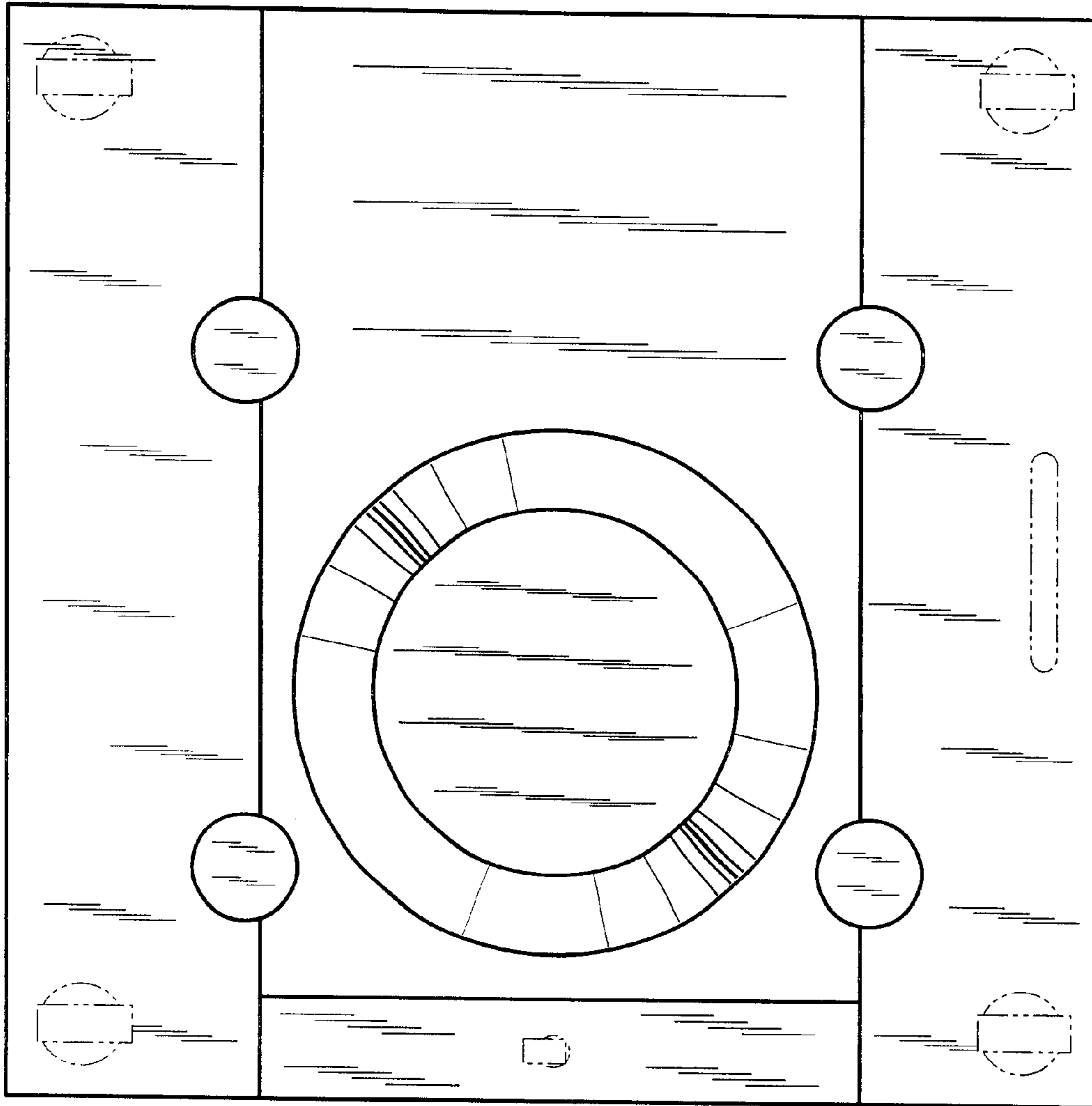
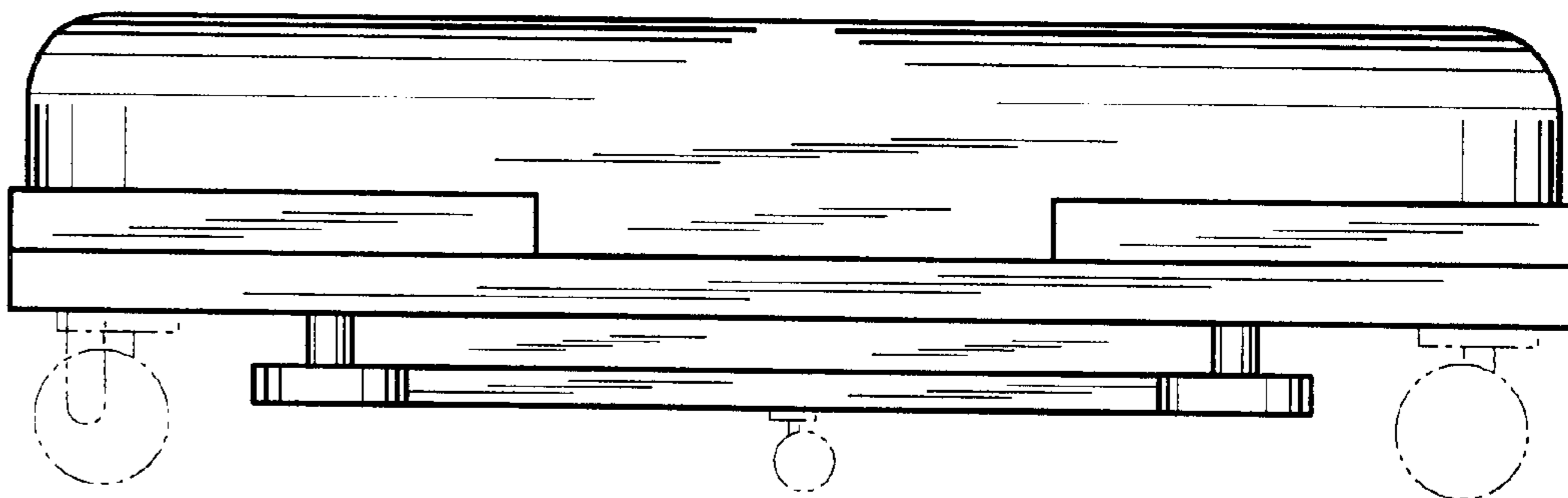


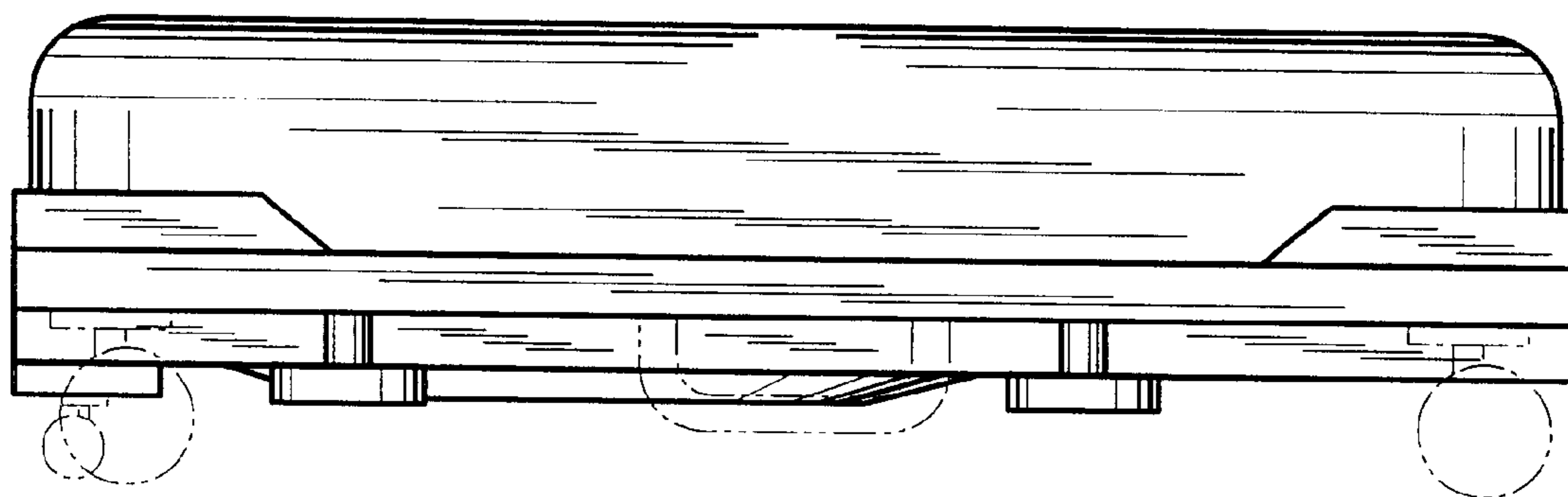

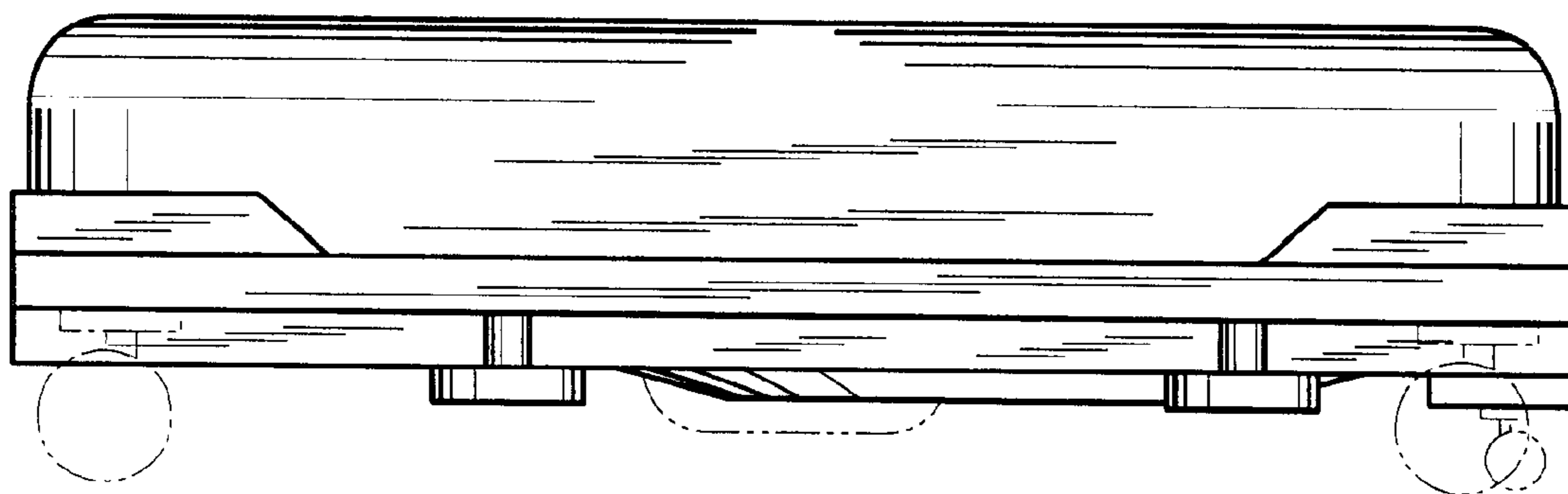

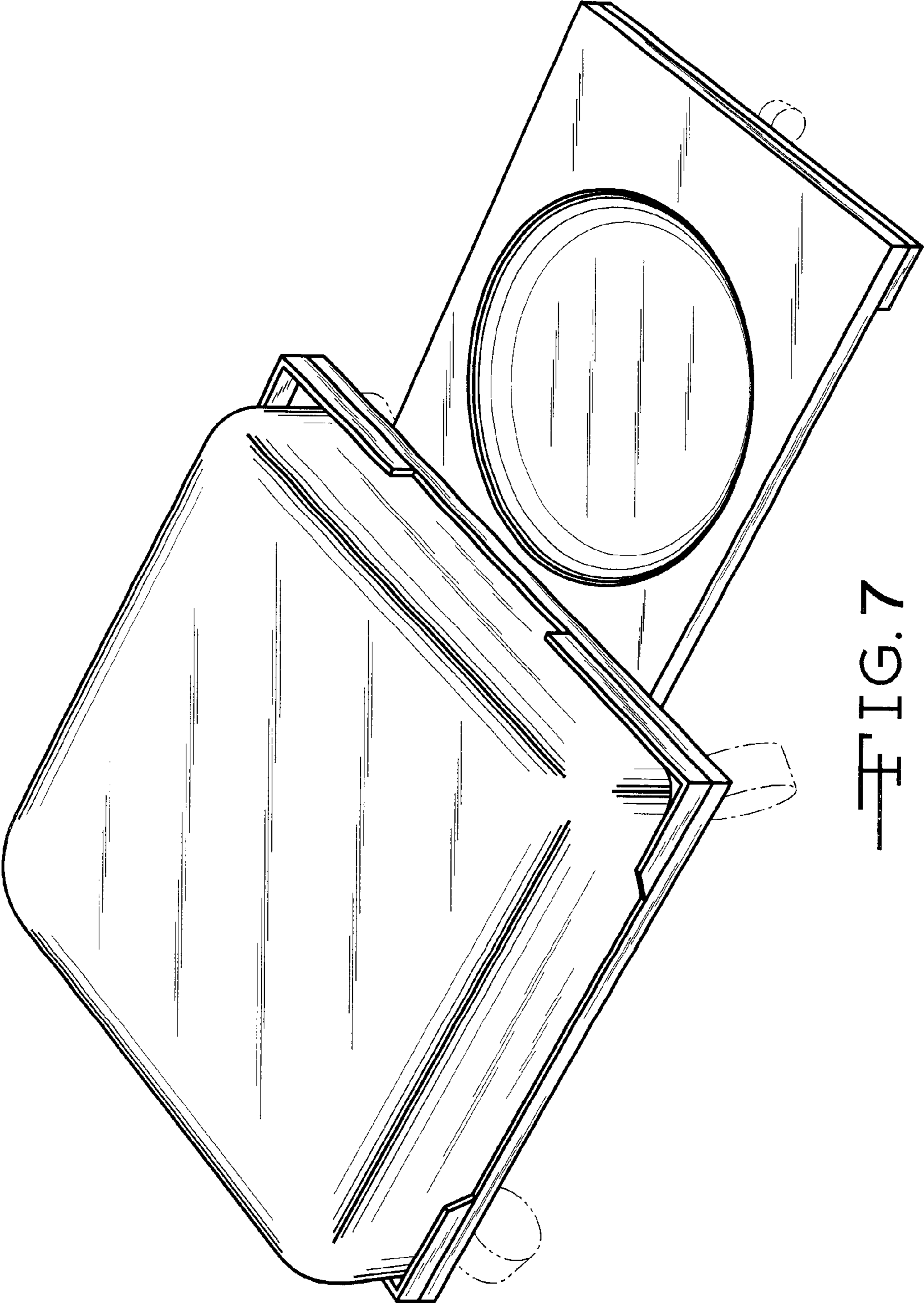
