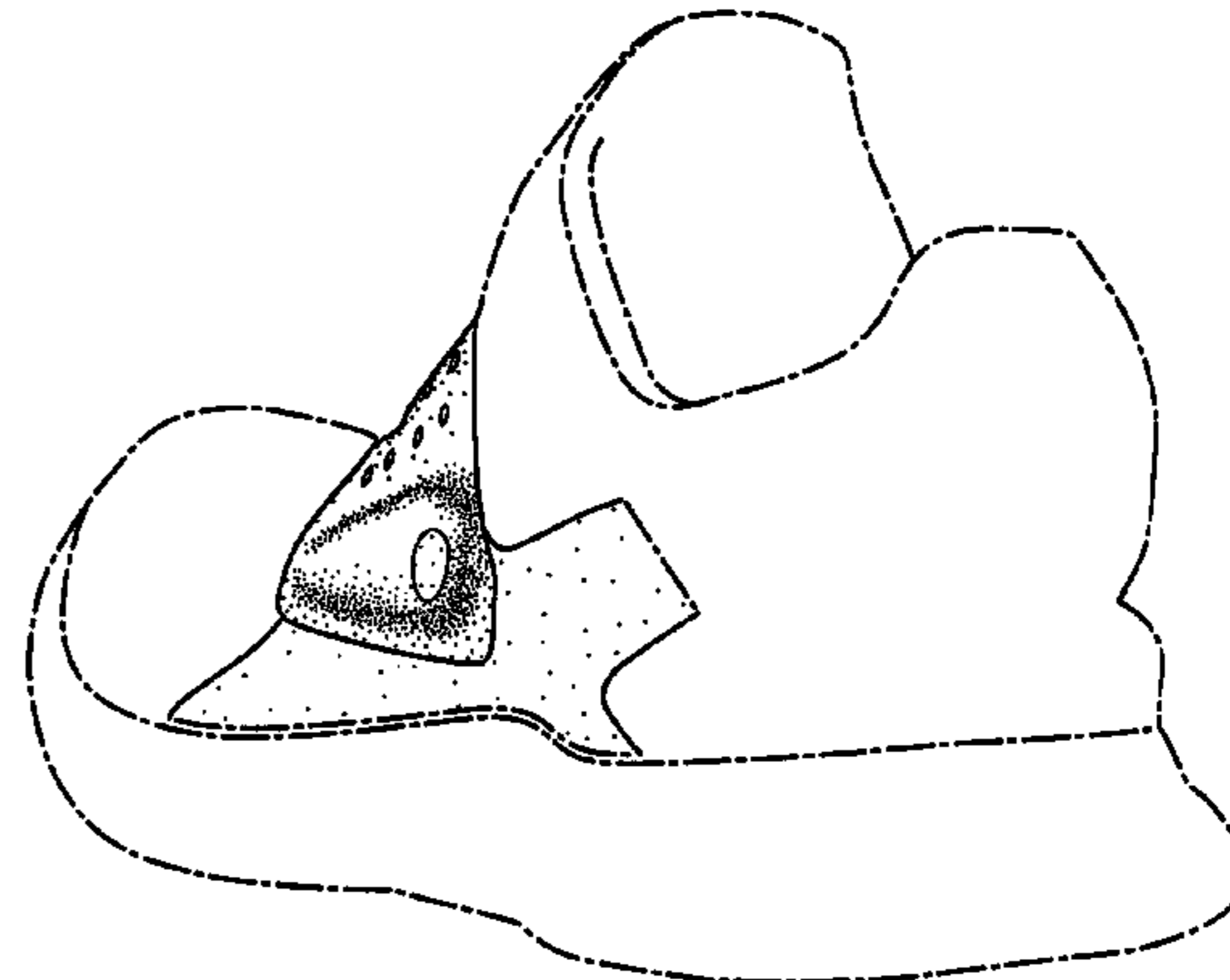
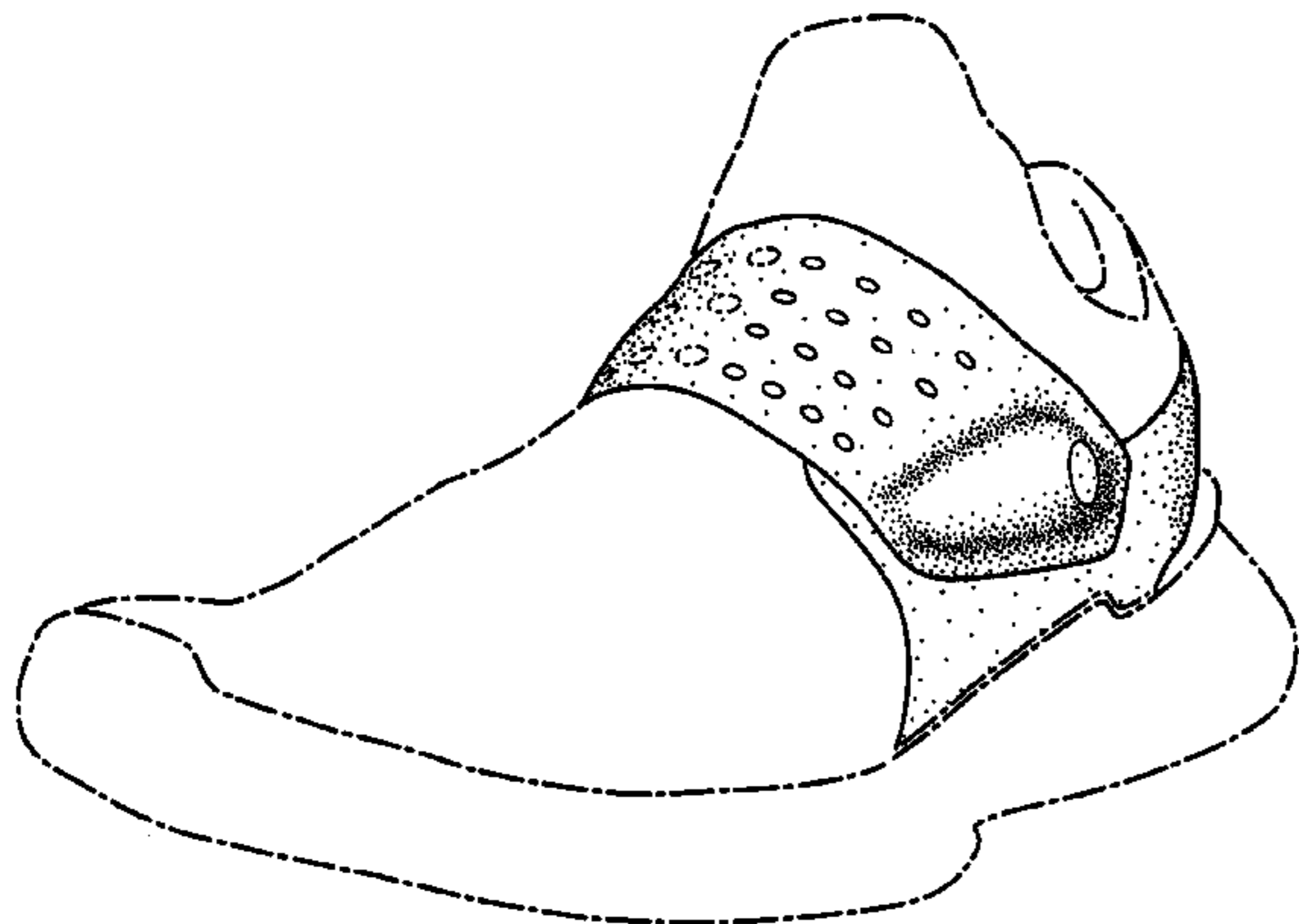
The ornamental design for a portion of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a portion of a shoe upper showing my new design;  
 FIG. 2 is a second perspective view thereof;  
 FIG. 3 is a side view thereof; and,  
 FIG. 4 is a top view thereof.

The uneven broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. 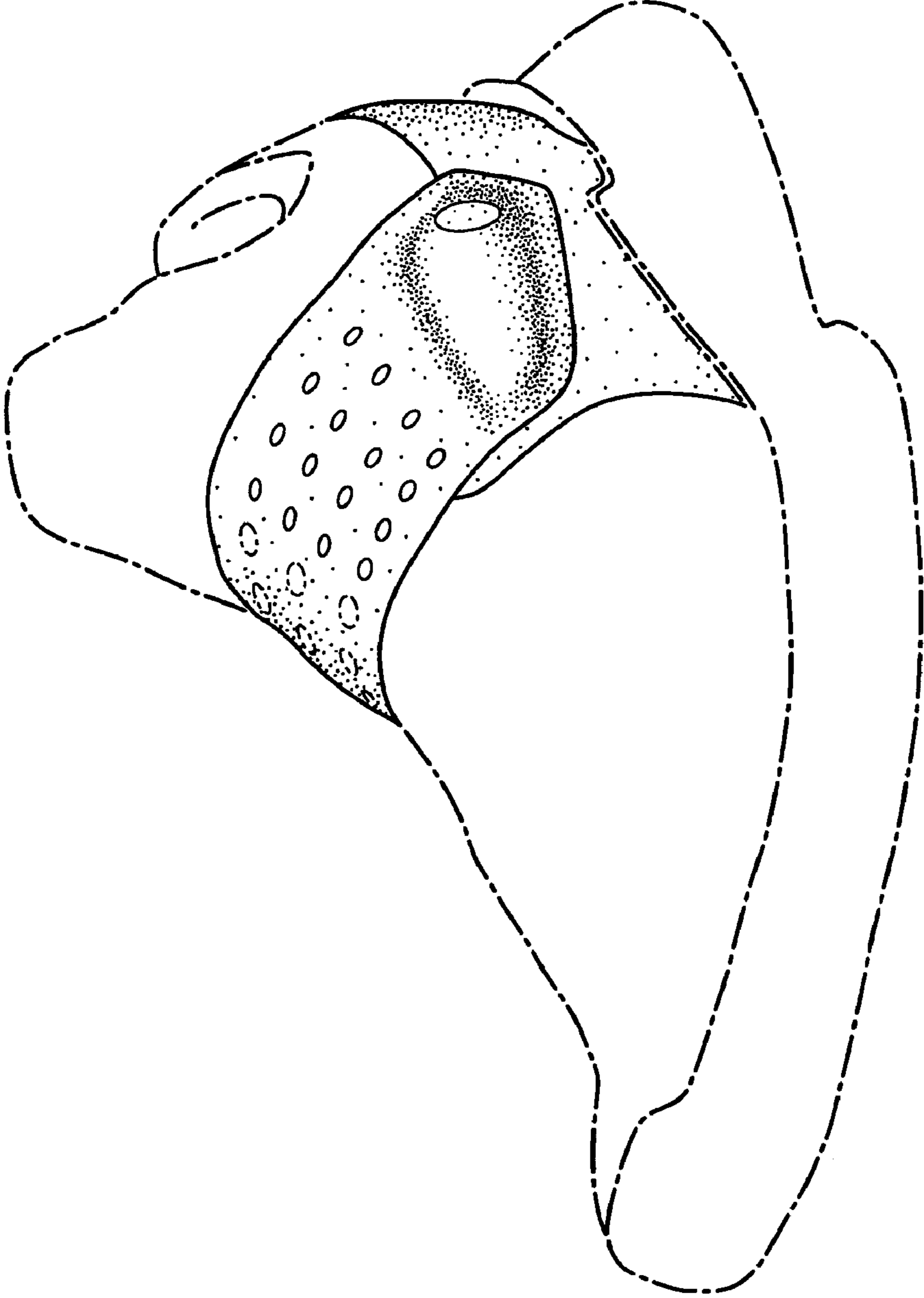

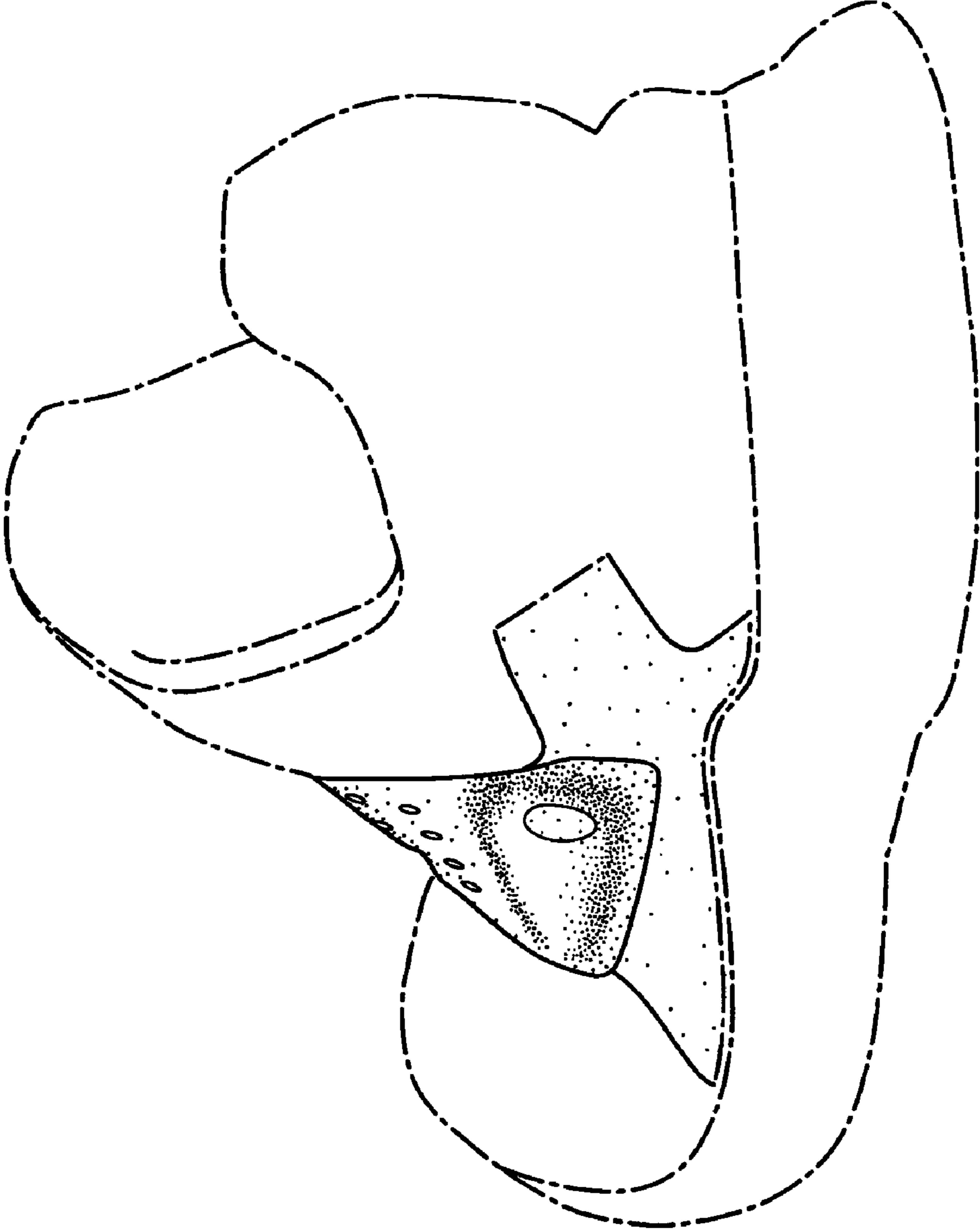

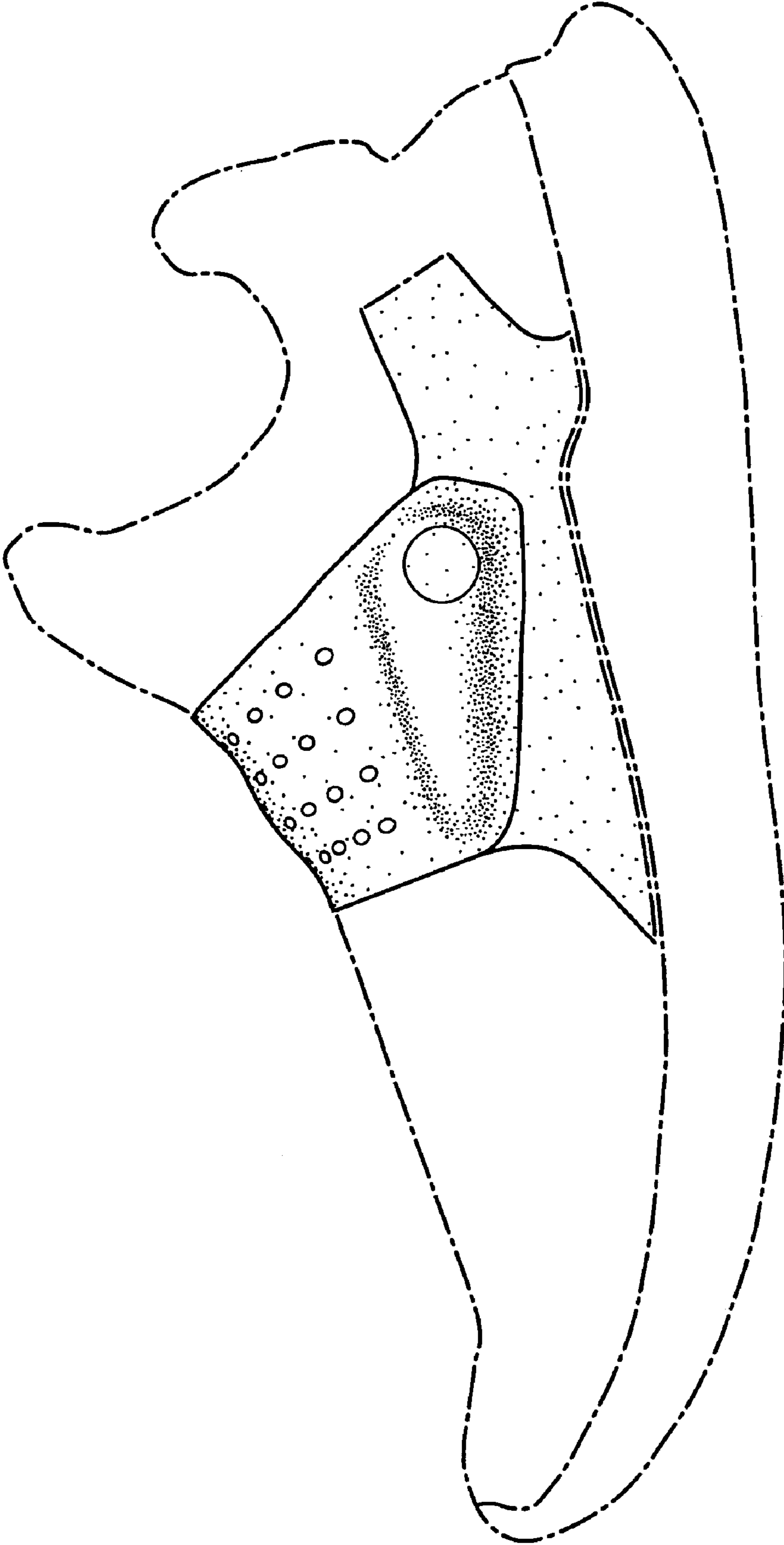
